DESCRIPTION

FIG. 1 is a perspective view of a hurricane and tornado resistant structure, showing my new design with storm doors in a raised position;

FIG. 2 is a front elevational view of FIG. 1;

FIG. 3 is a rear elevational view of FIG. 1;

FIG. 4 is a left-side elevational view of FIG. 1, the right-side elevational view being a mirror image thereof;

FIG. 5 is a top plan view of FIG. 1;

FIG. 6 is a perspective view thereof;

FIG. 7 is a front elevational view of FIG. 6, the rear elevational view being a mirror image thereof;

FIG. 8 is a left-side elevational view of FIG. 6, the right-side elevational view being a mirror image thereof; and,

FIG. 9 is a top plan view thereof.

The bottom plan view forms no part of the claimed design.

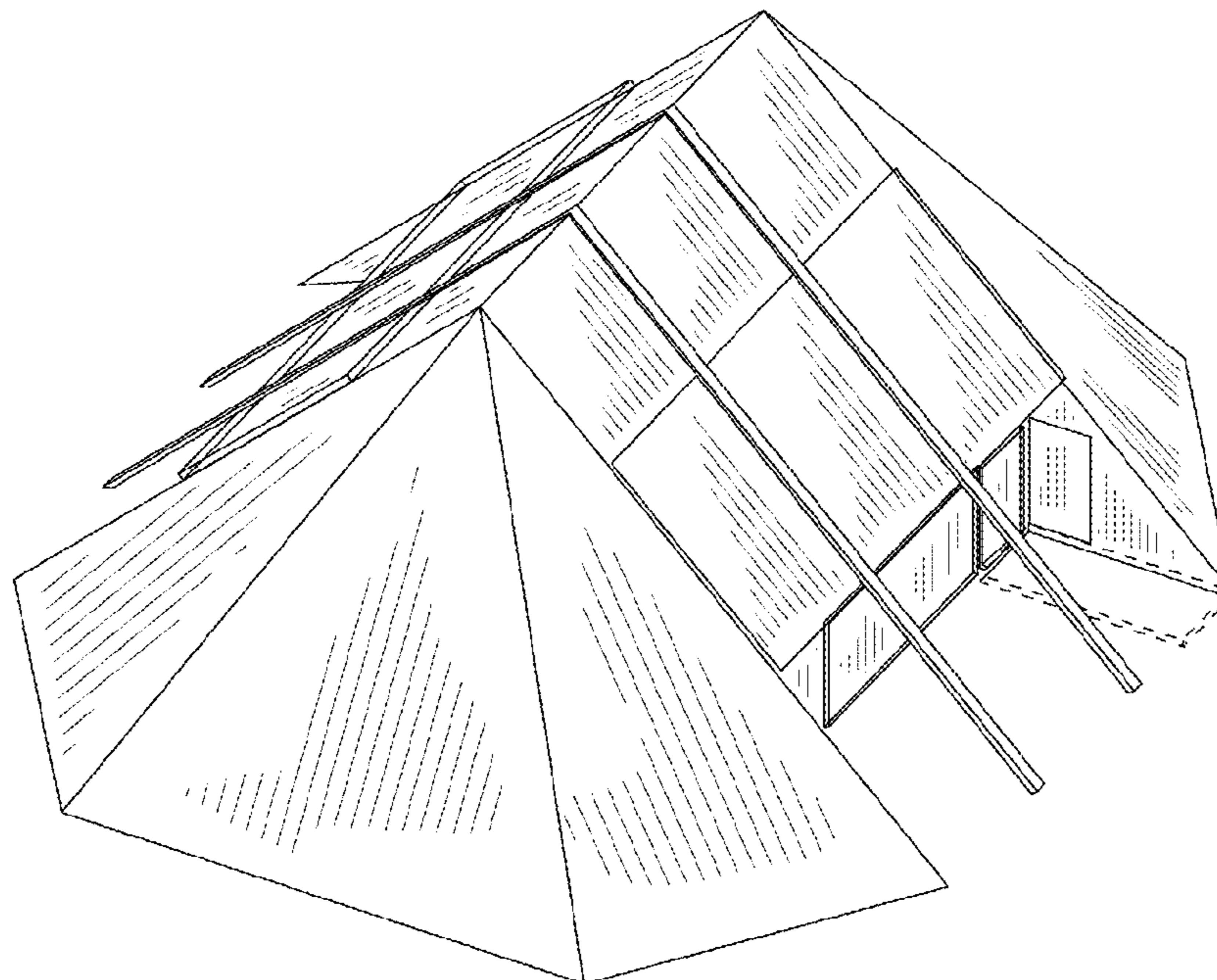
The broken lines in the figures depict environmental structure that forms no part of the claimed design.

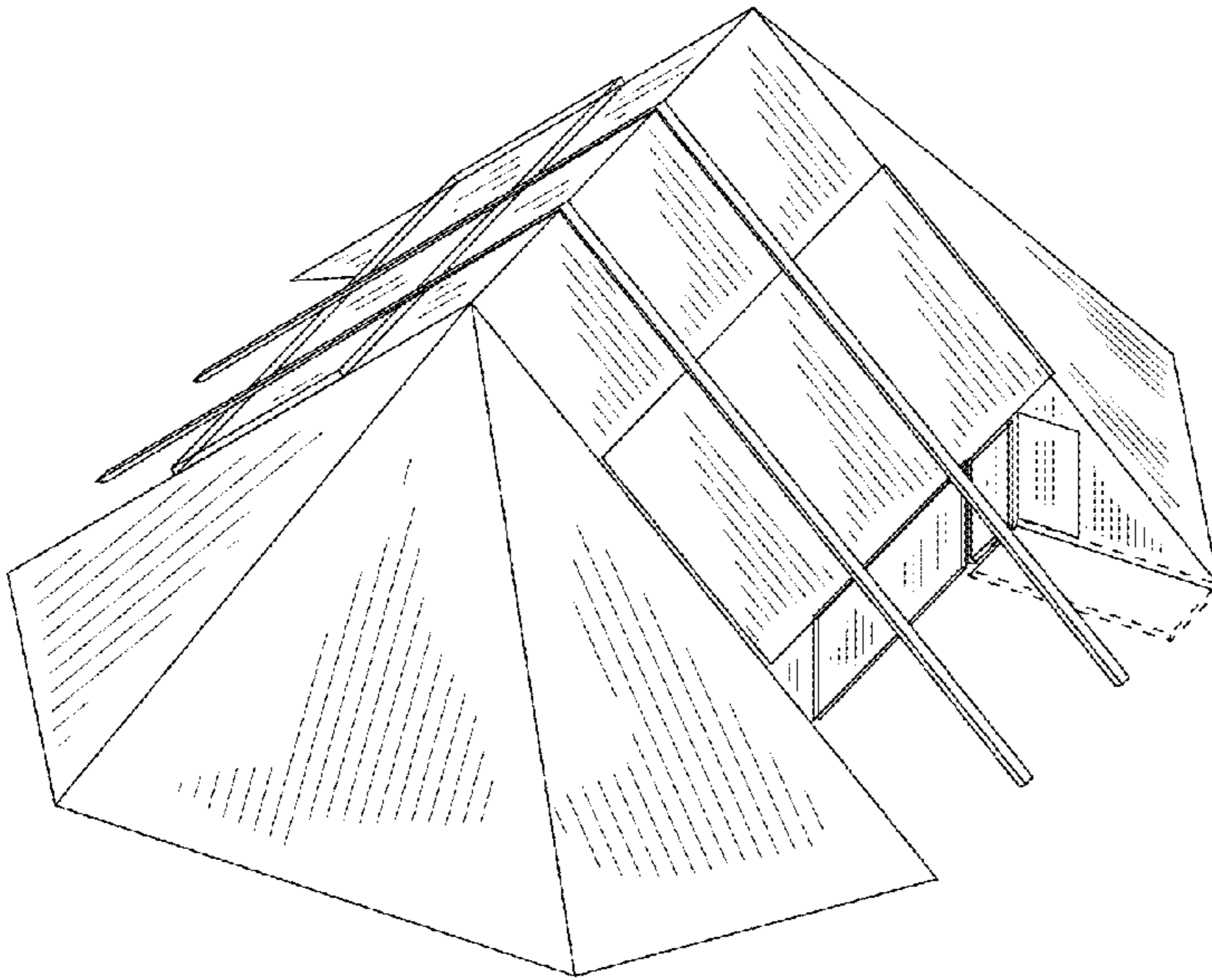

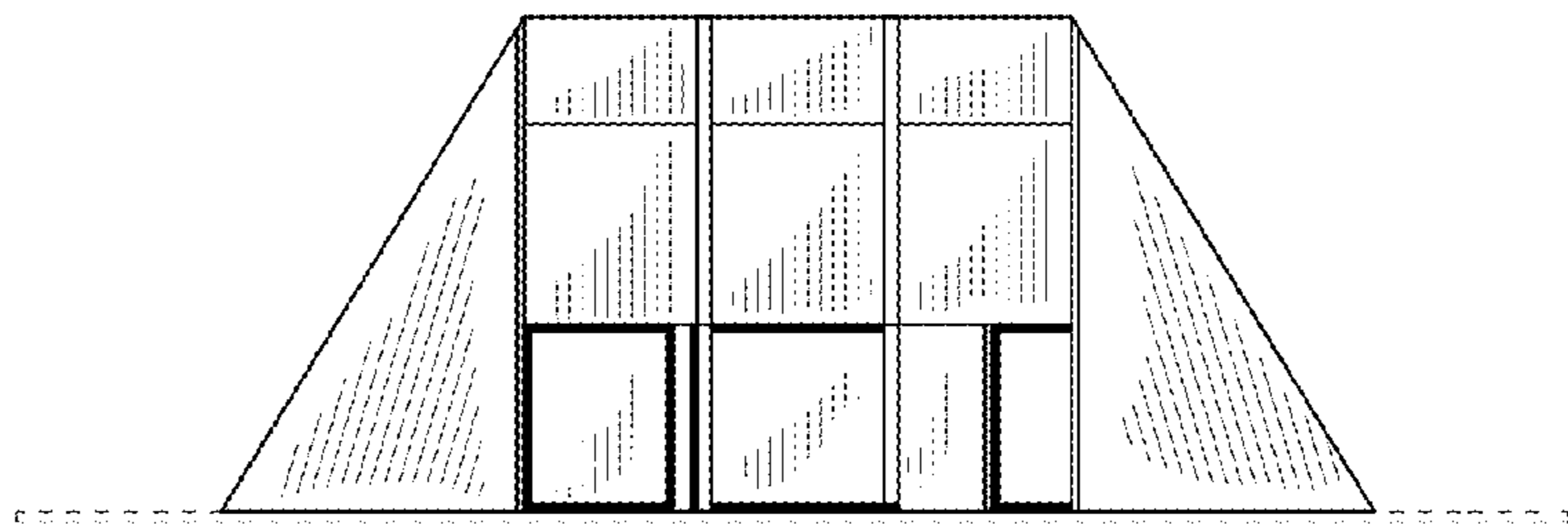

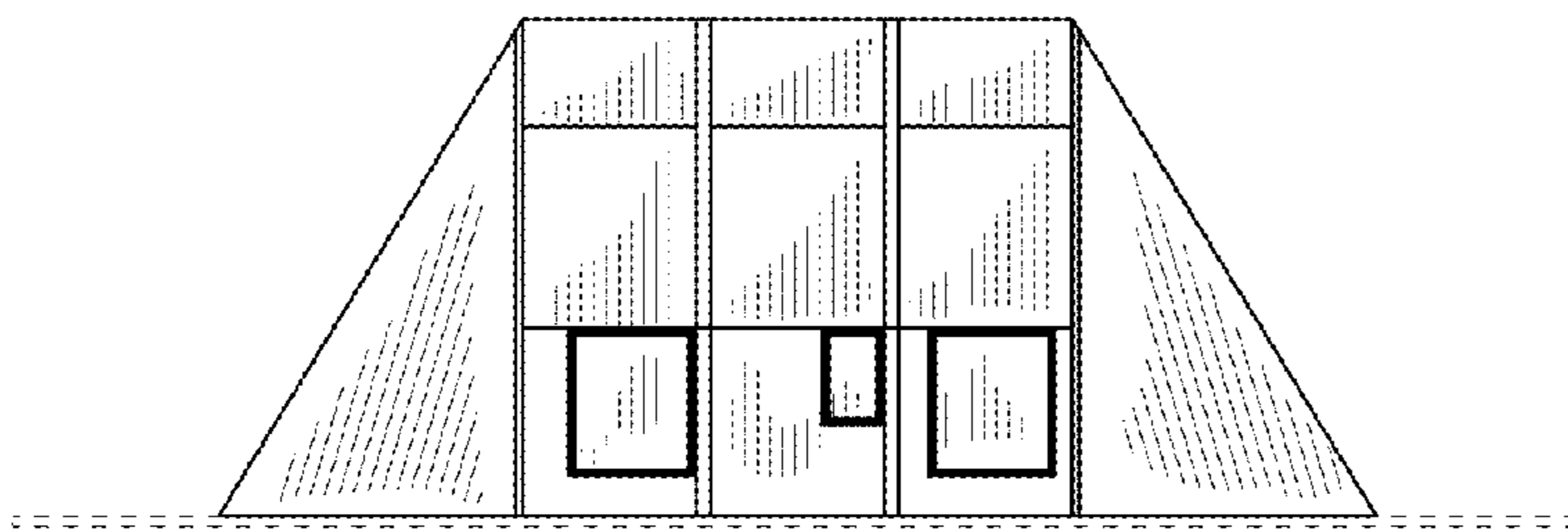

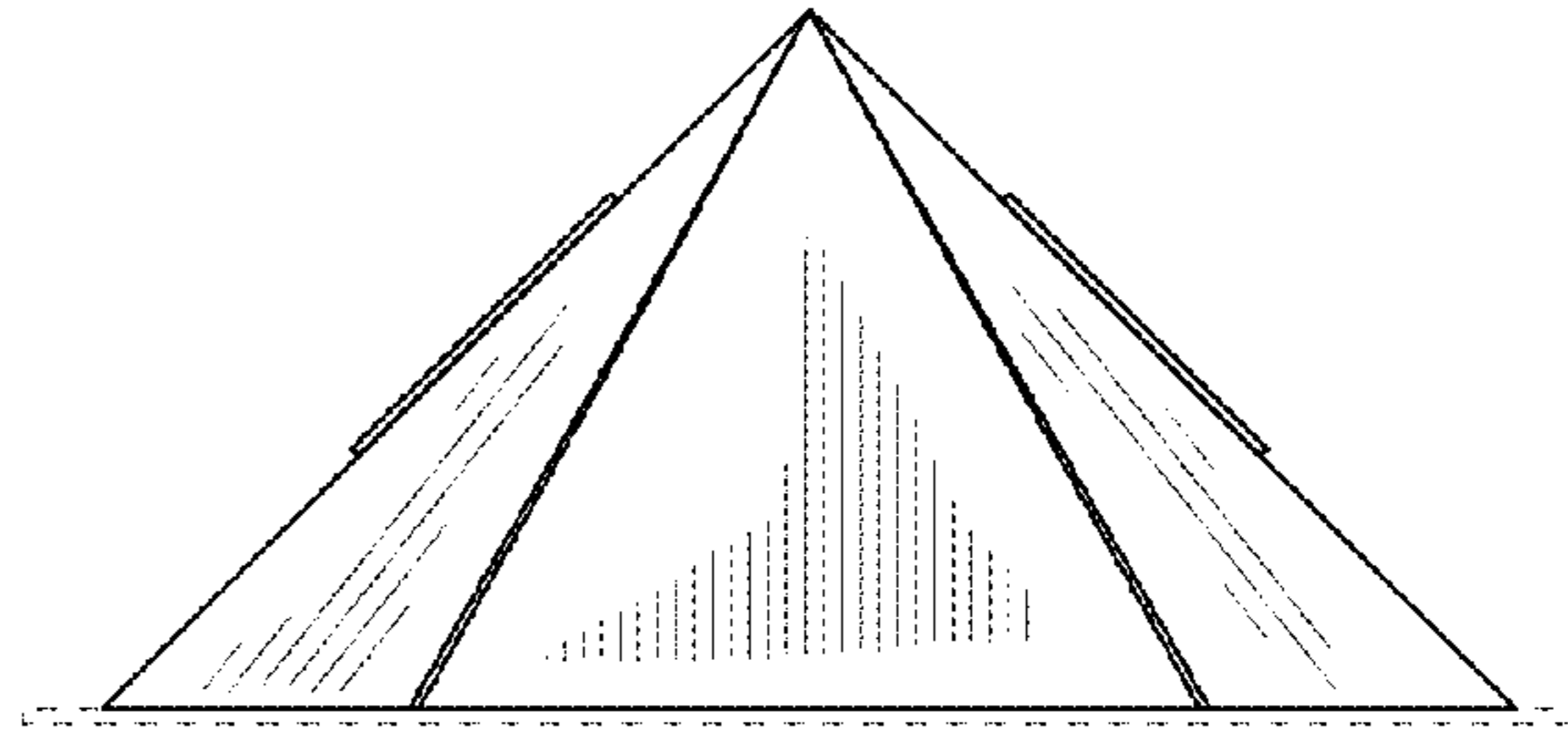

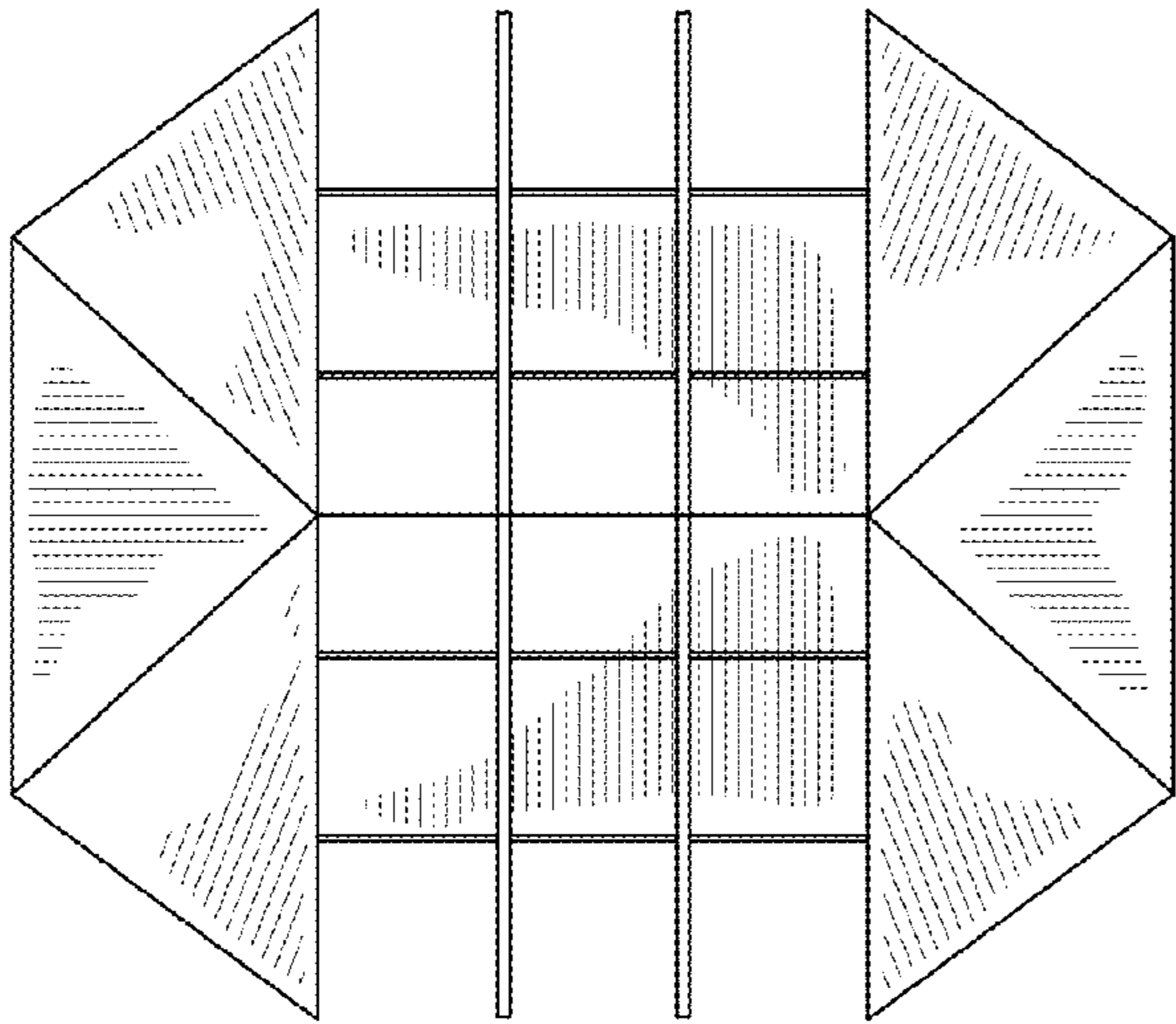

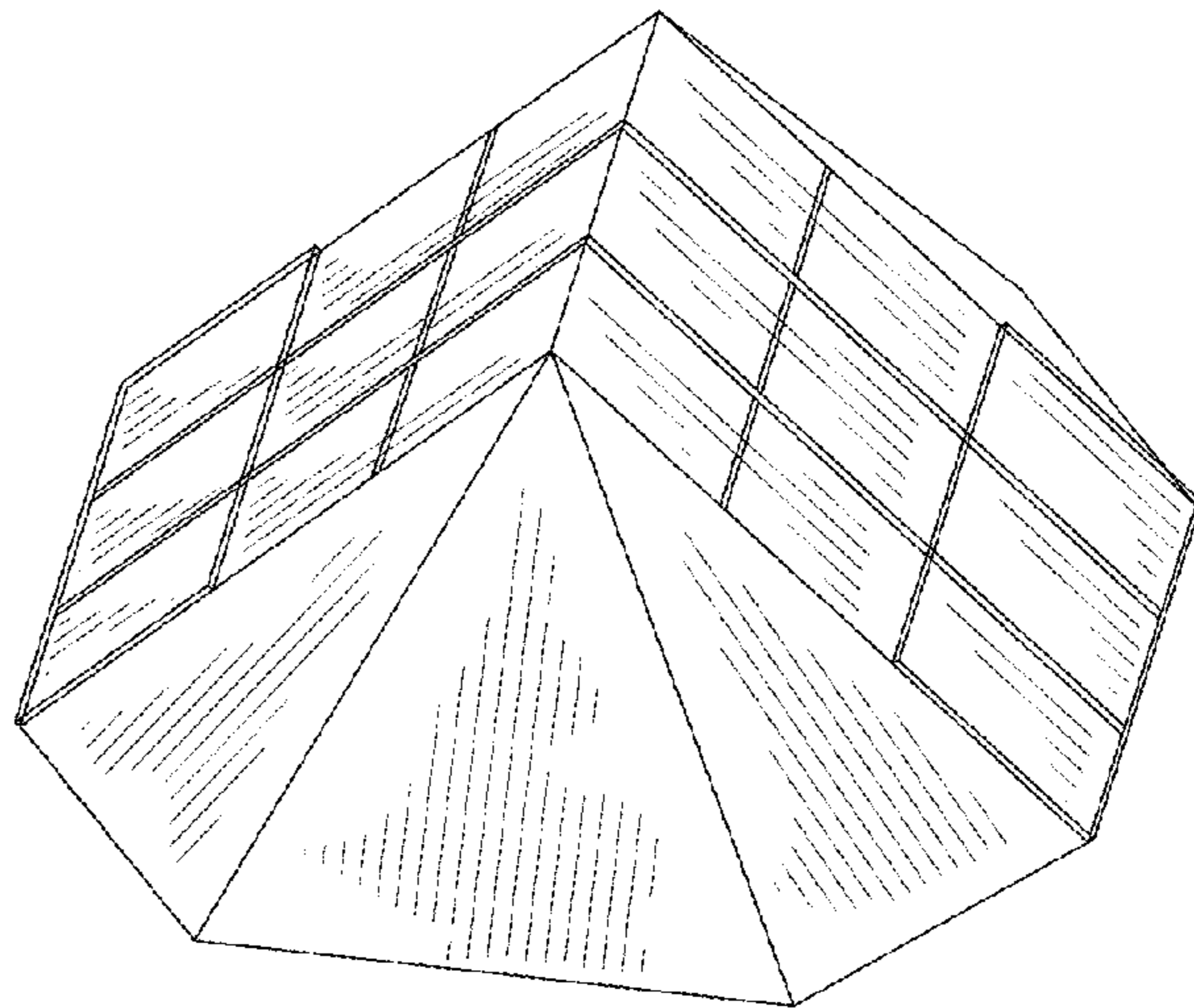

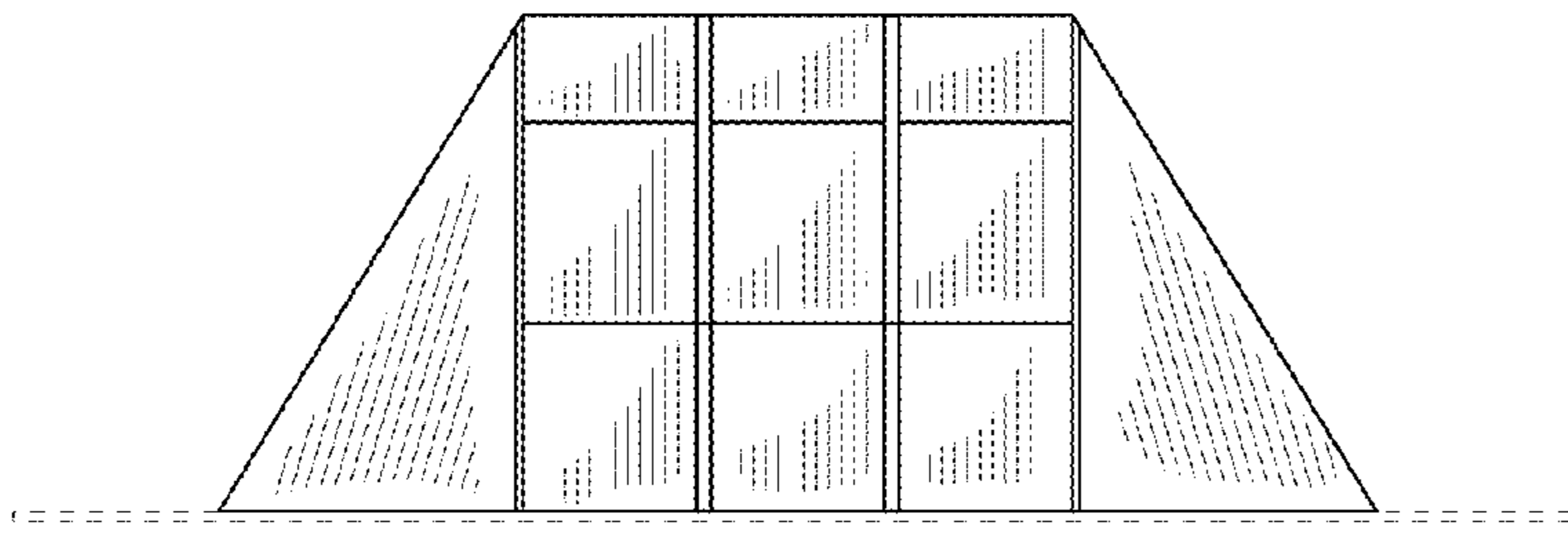

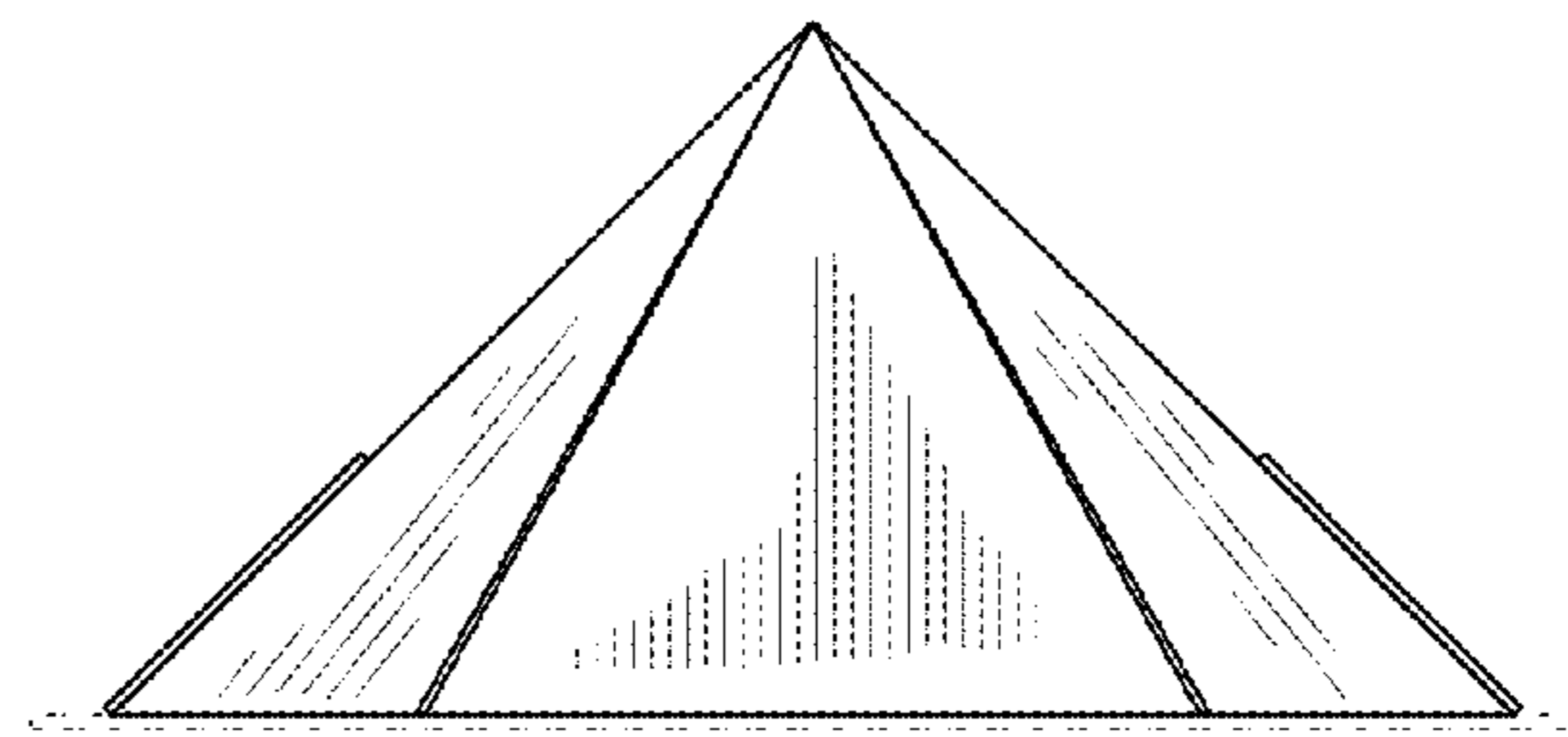

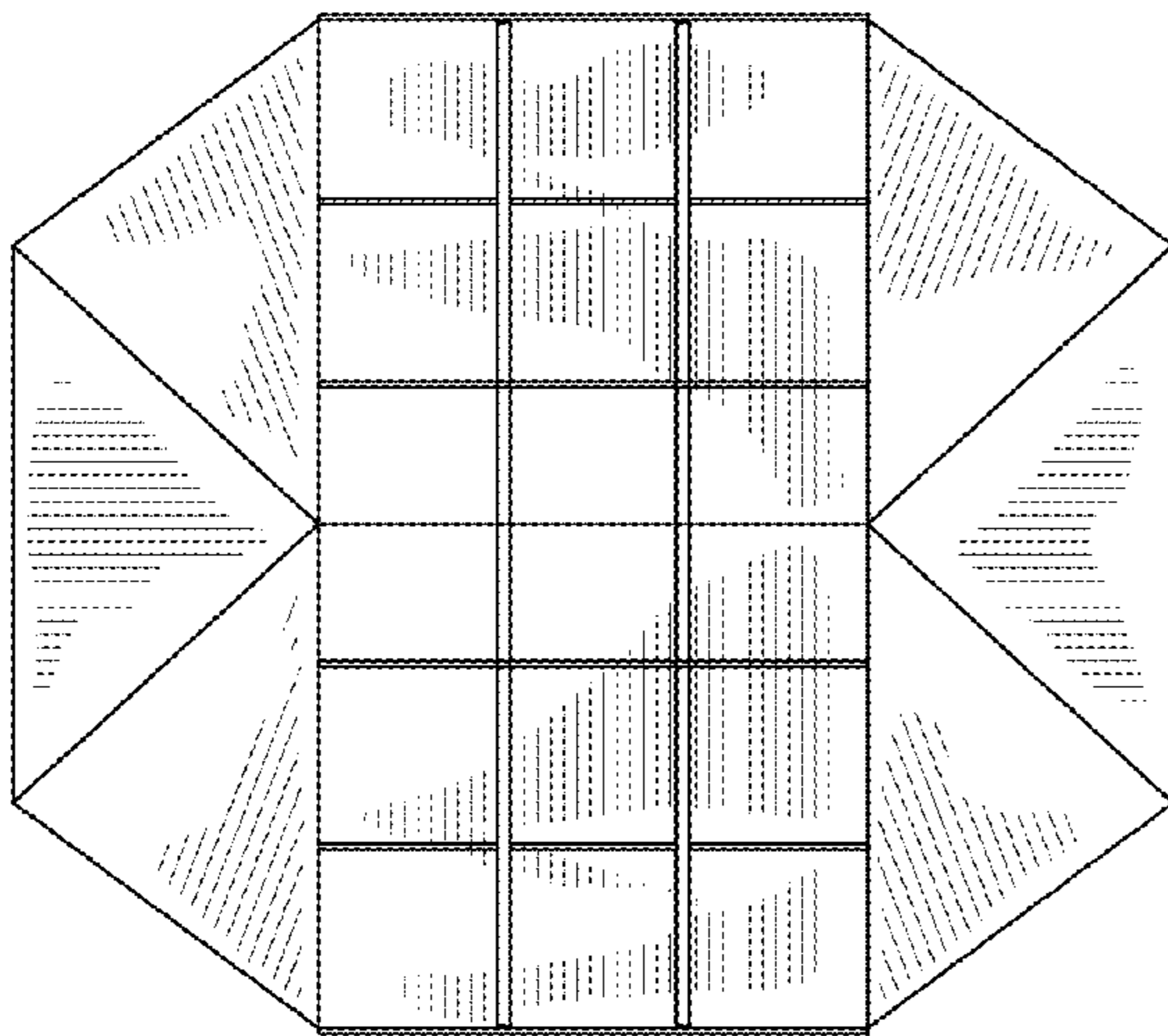
