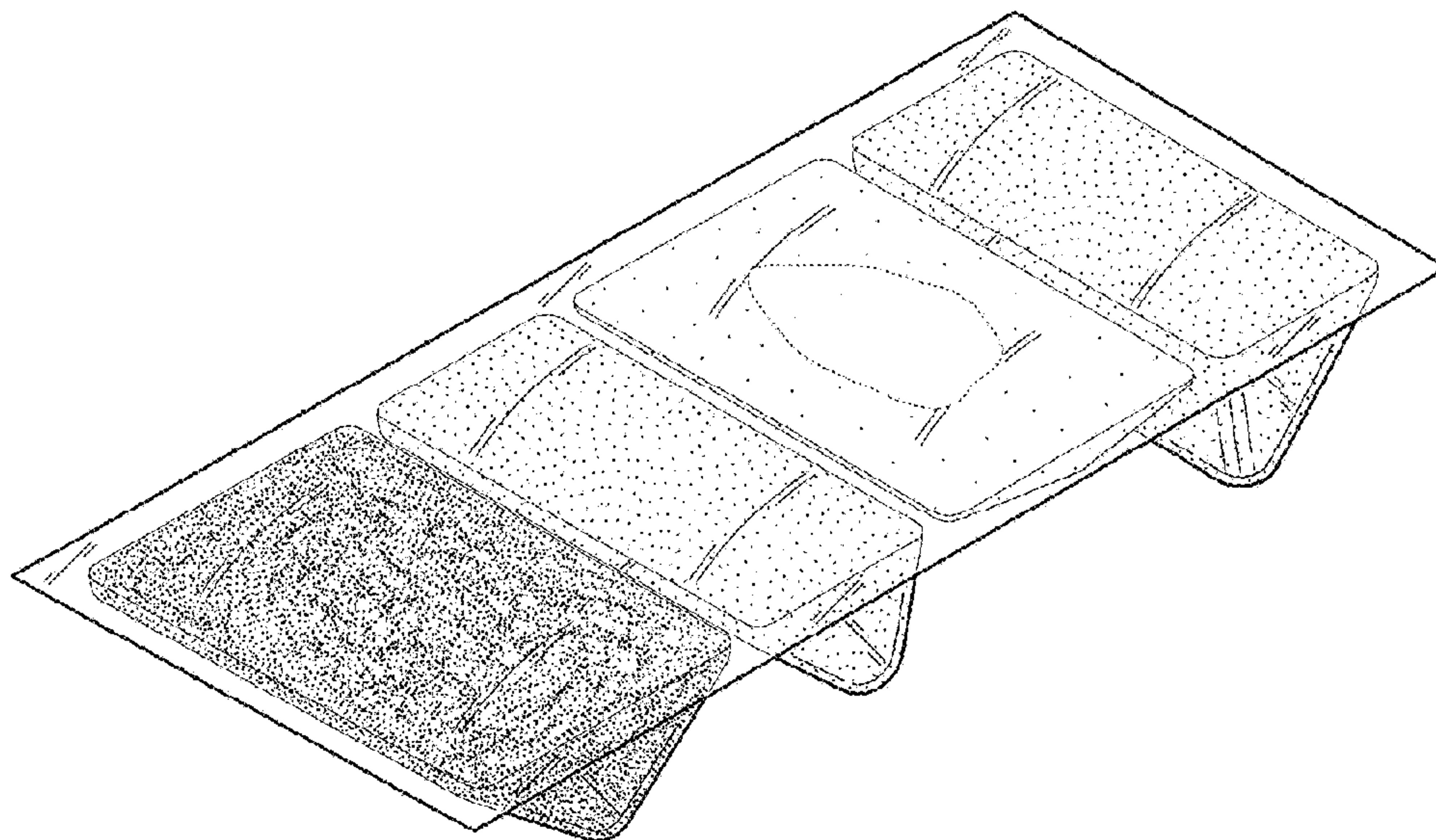
(57) **CLAIM**

The ornamental design for set of capsules containing washing products, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of our set of capsules containing washing products;  
FIG. 2 is a left side elevational view thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a rear elevational view thereof;  
FIG. 6 is a top plan view thereof; and,

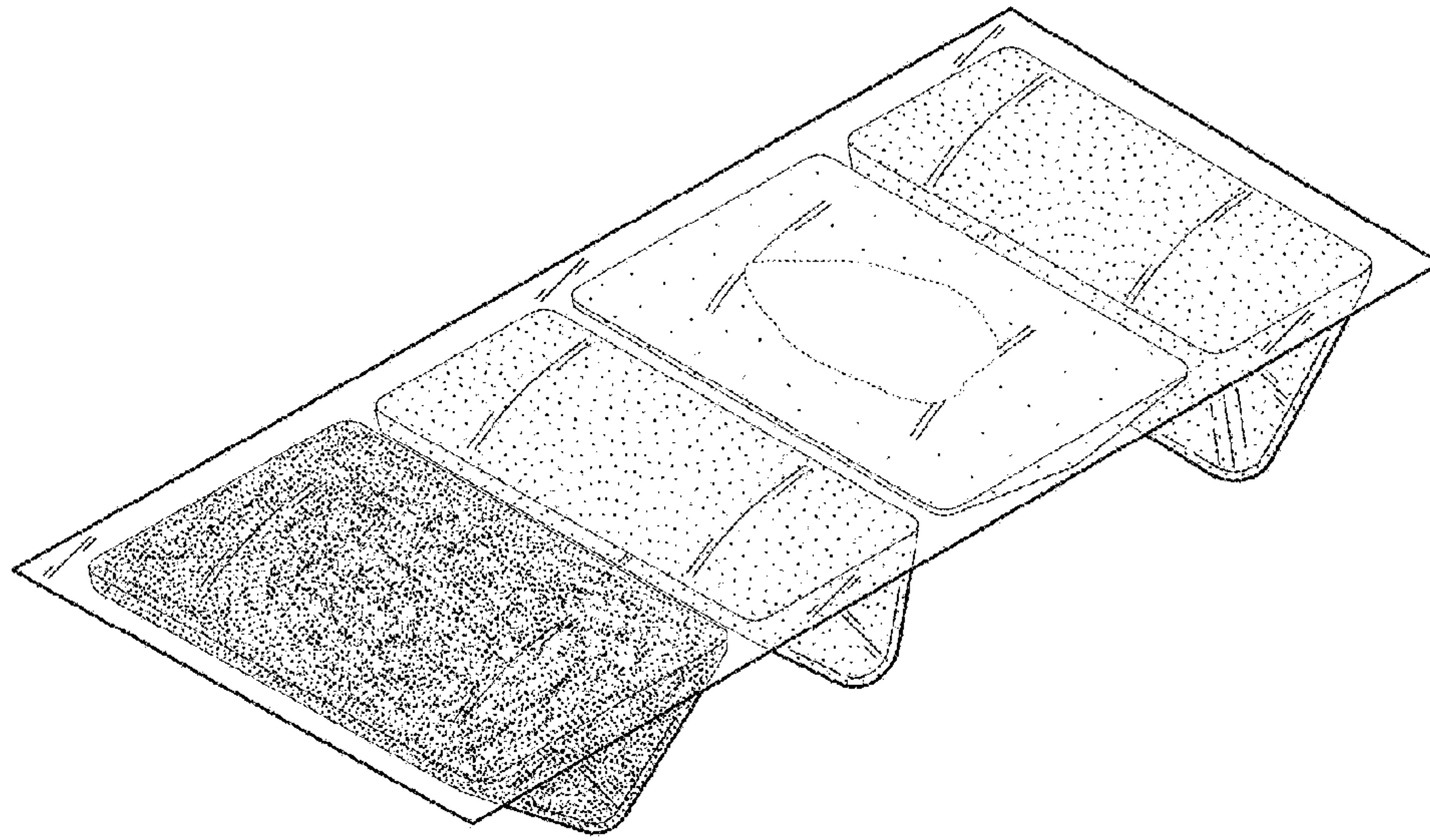

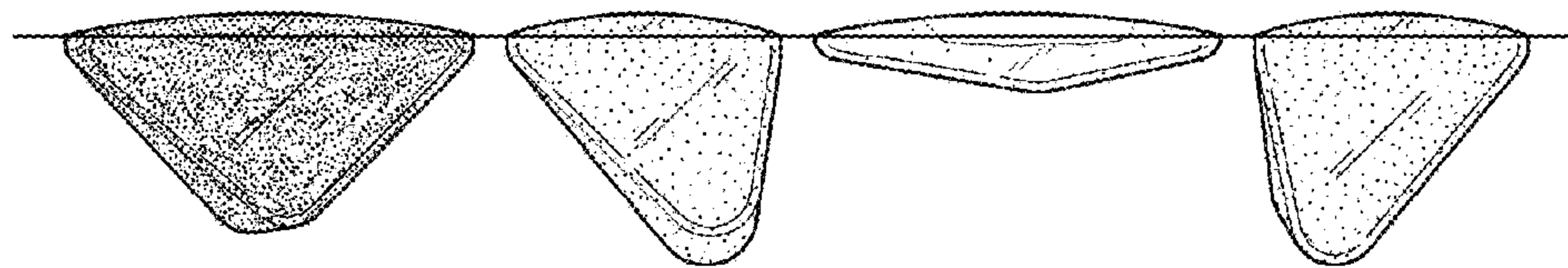

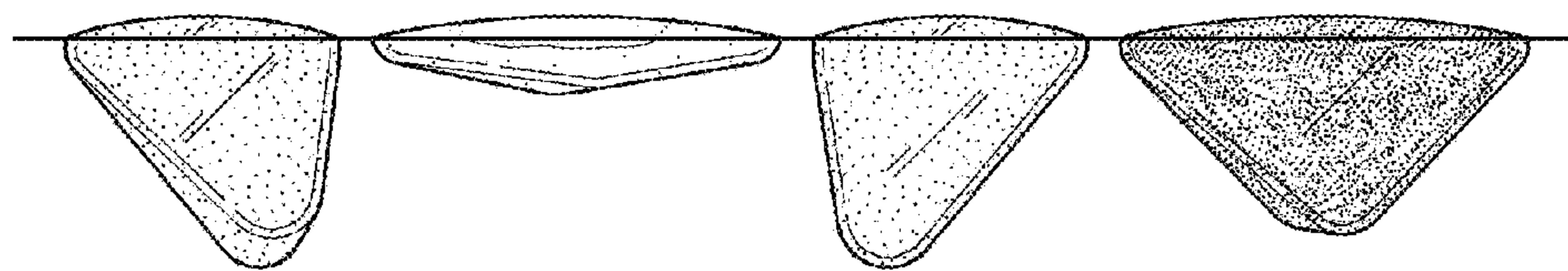

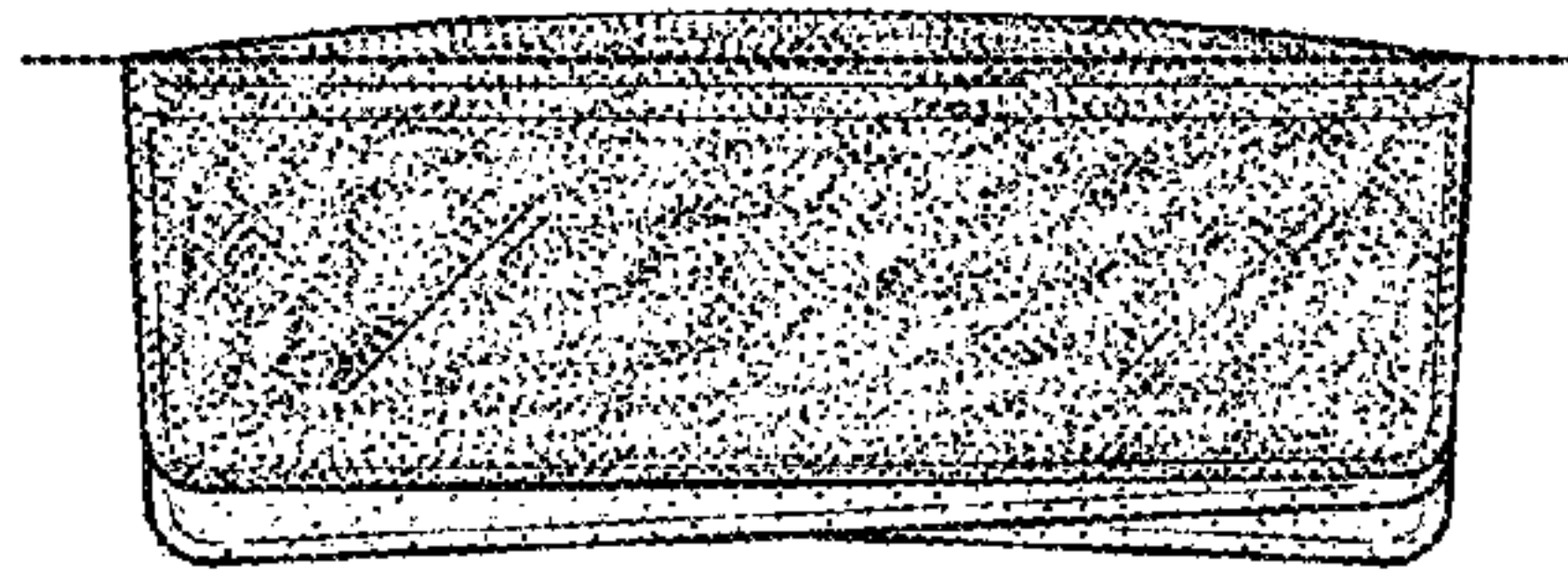

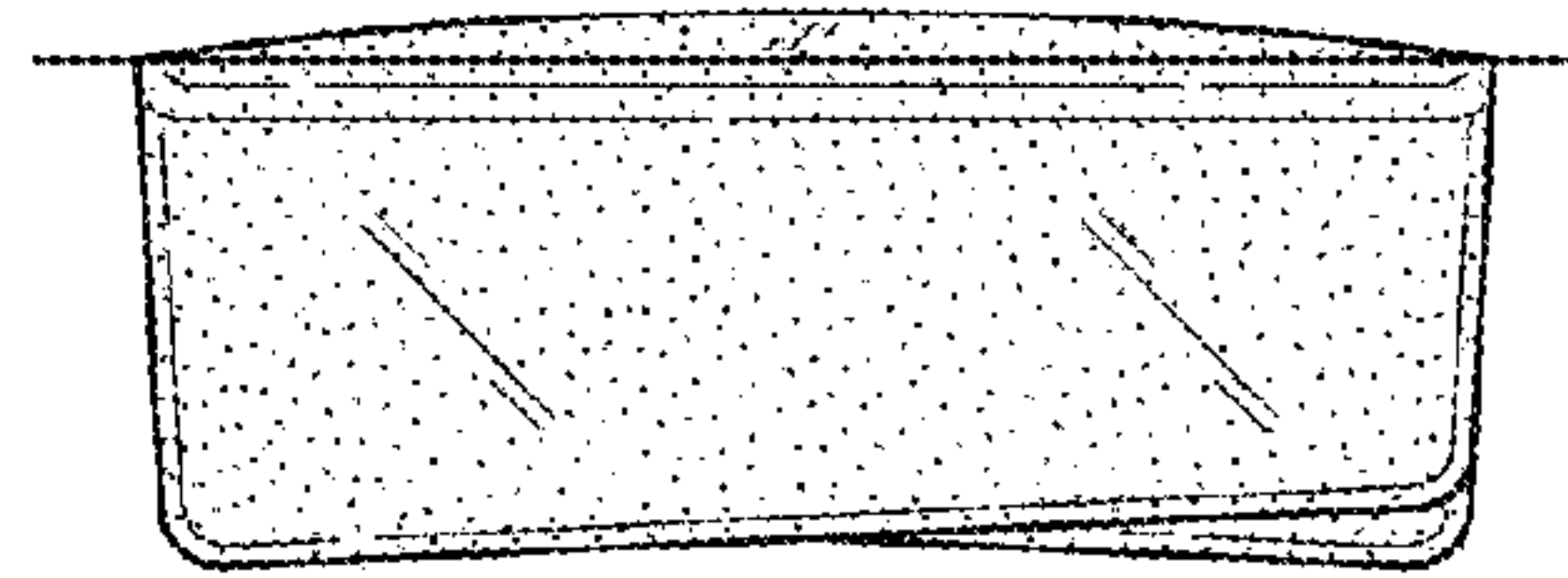

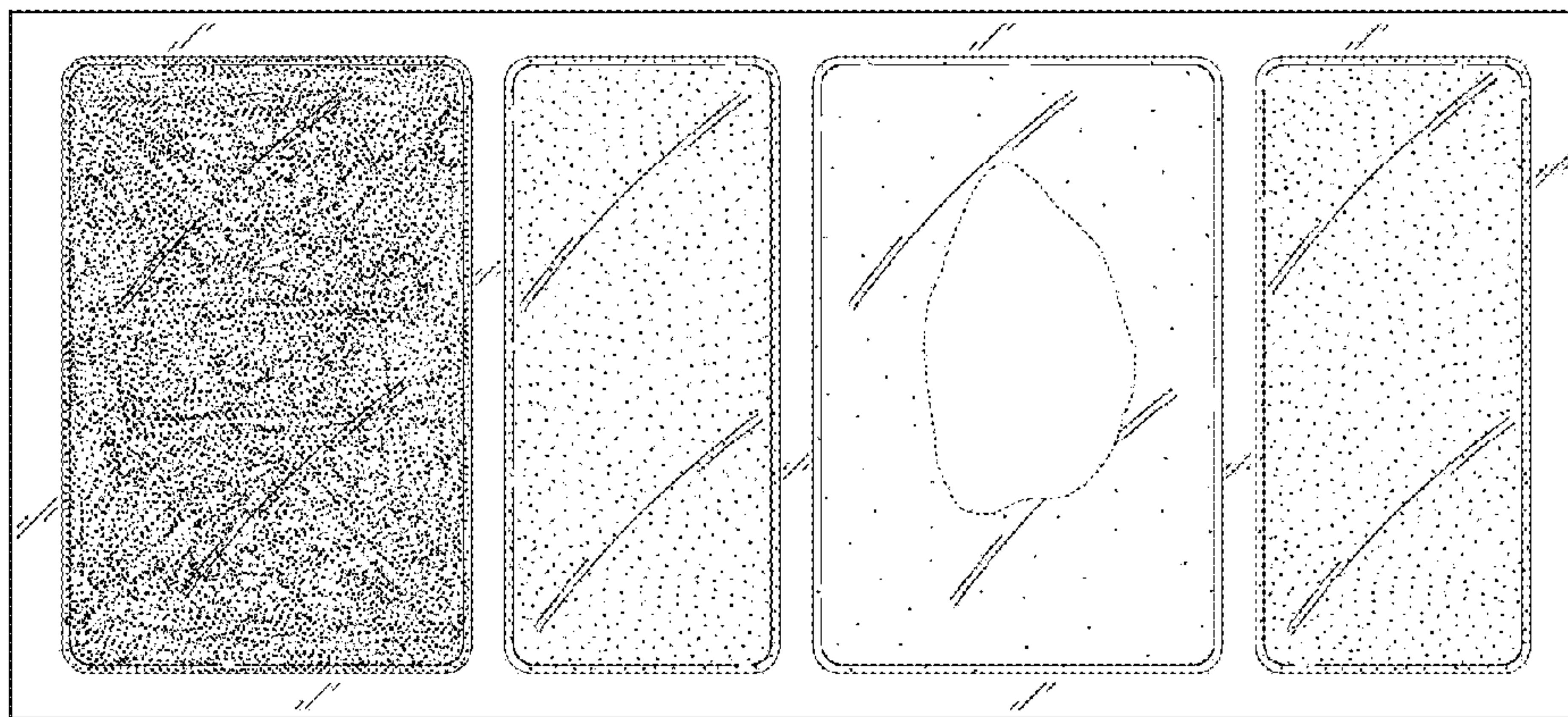

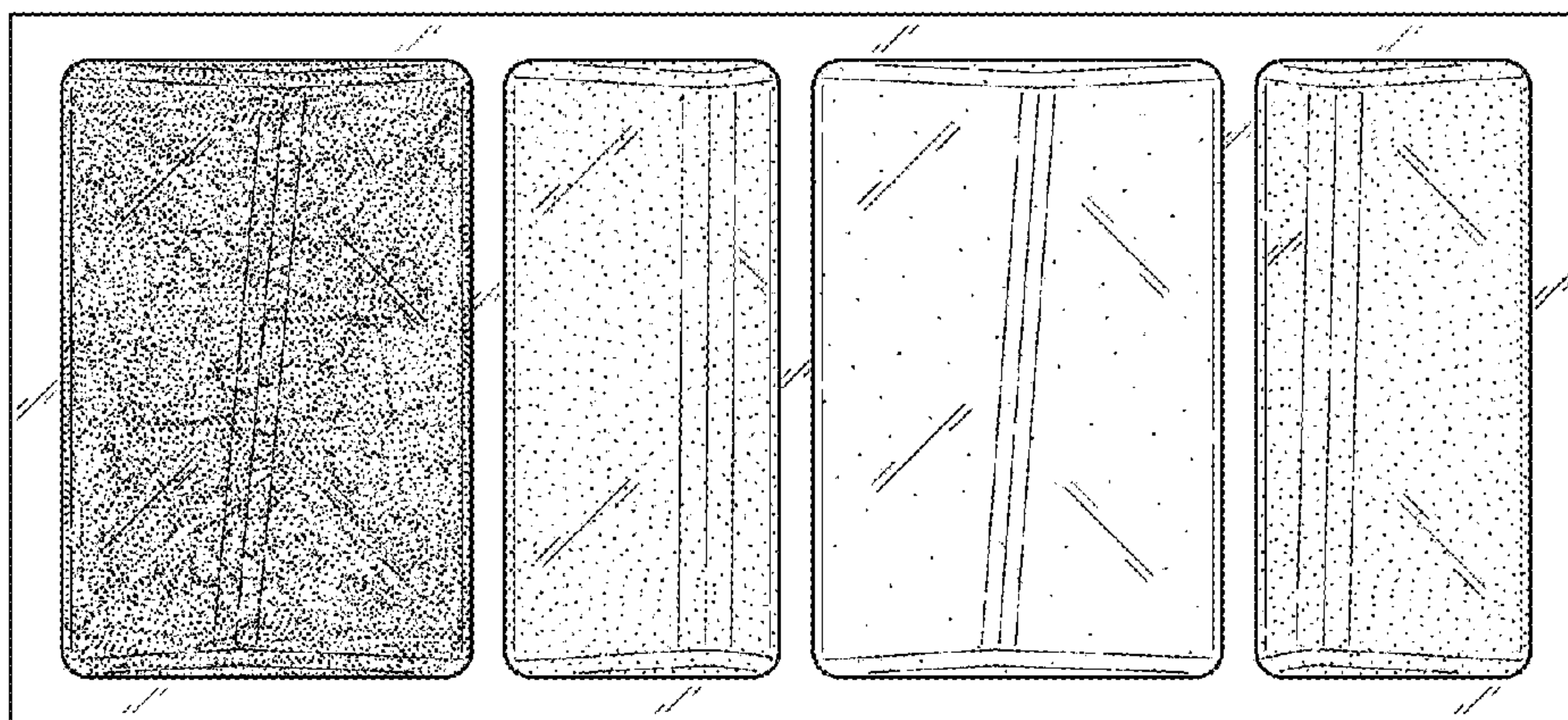
