The ornamental design for a trash bin, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view generally taken from one side of the trash bin;

FIG. 2 is a left elevational view thereof;

FIG. 3 is a right elevational view thereof;

FIG. 4 is a front elevational view thereof;

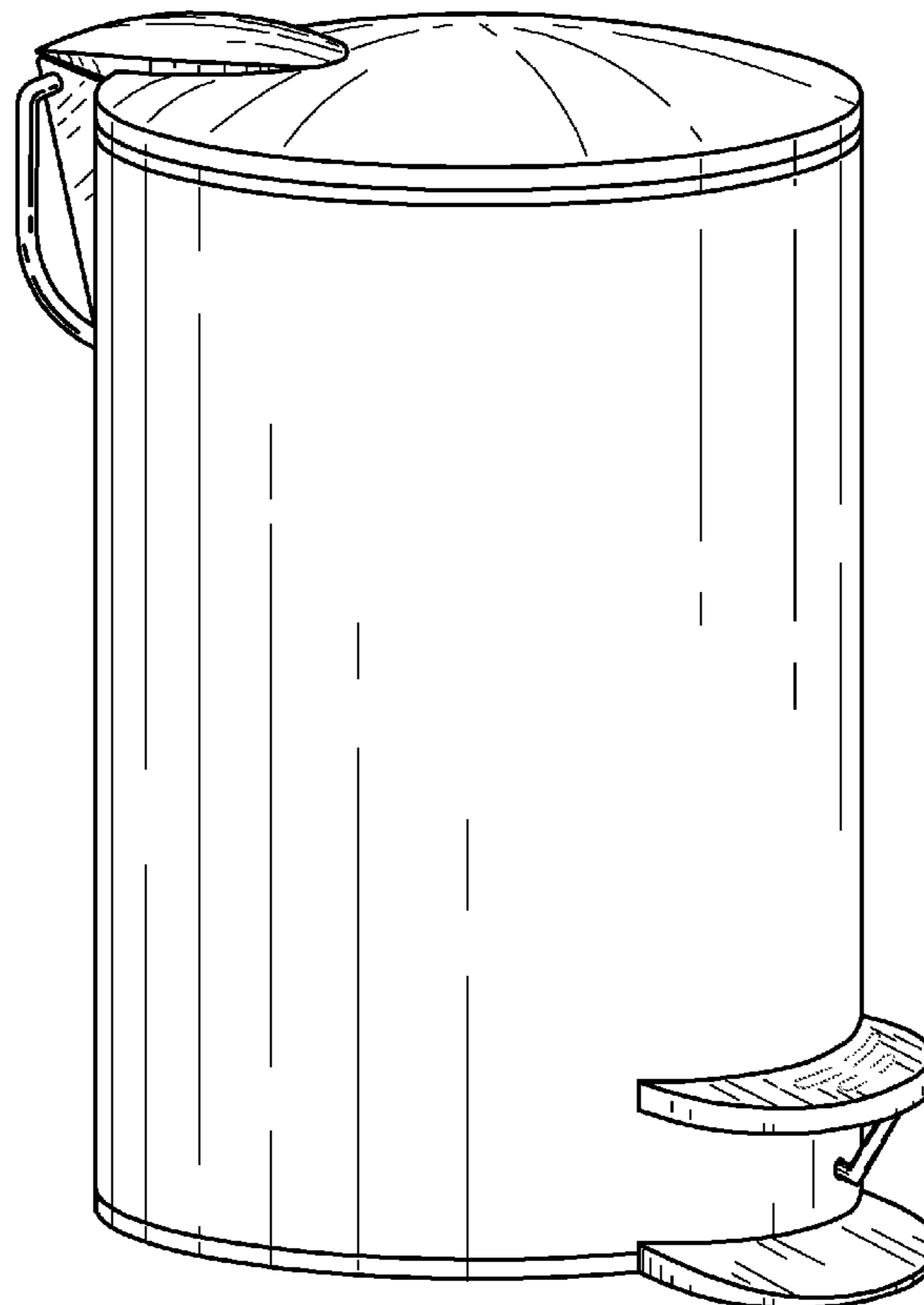
FIG. 5 is a rear elevational view thereof; and,

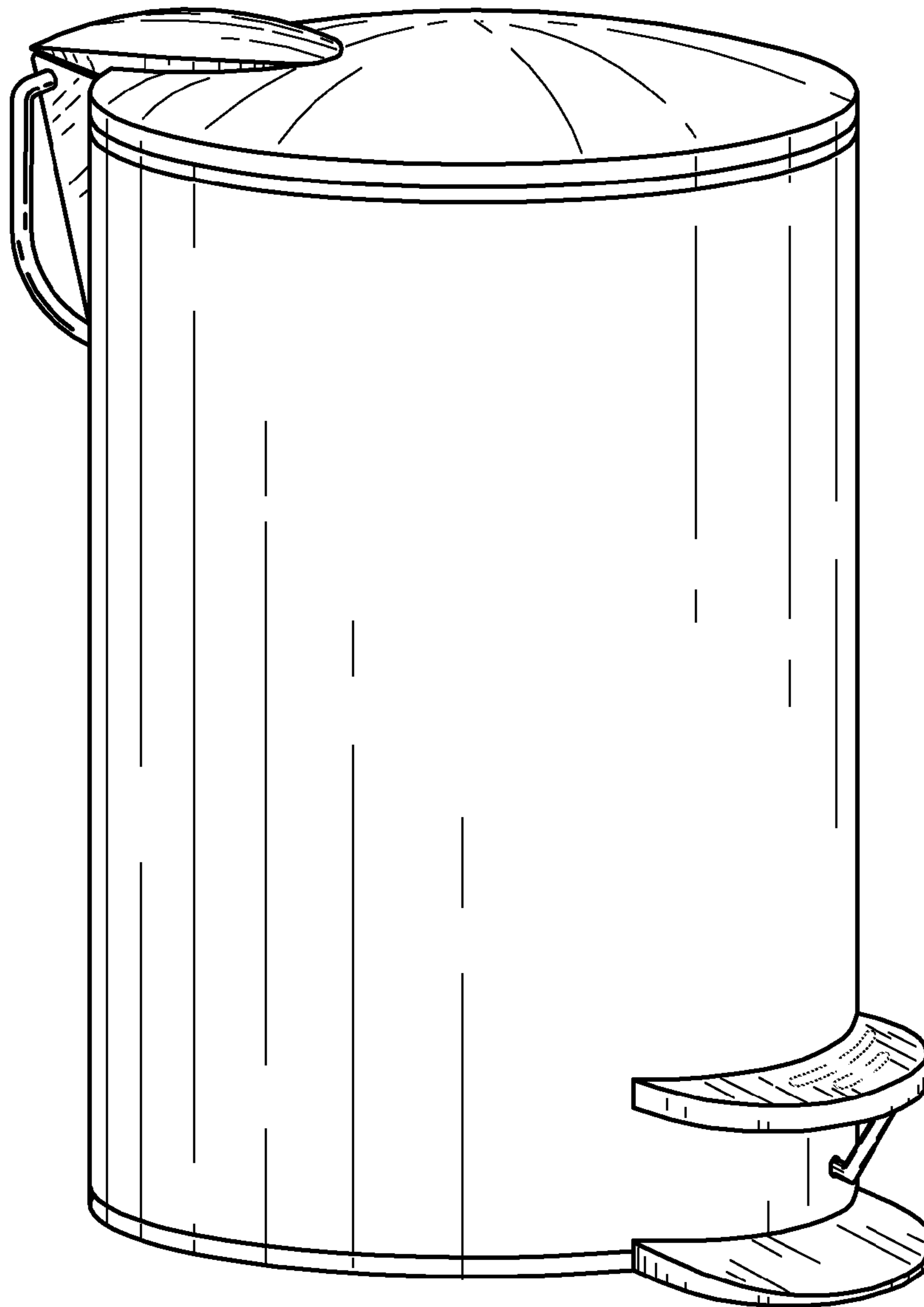

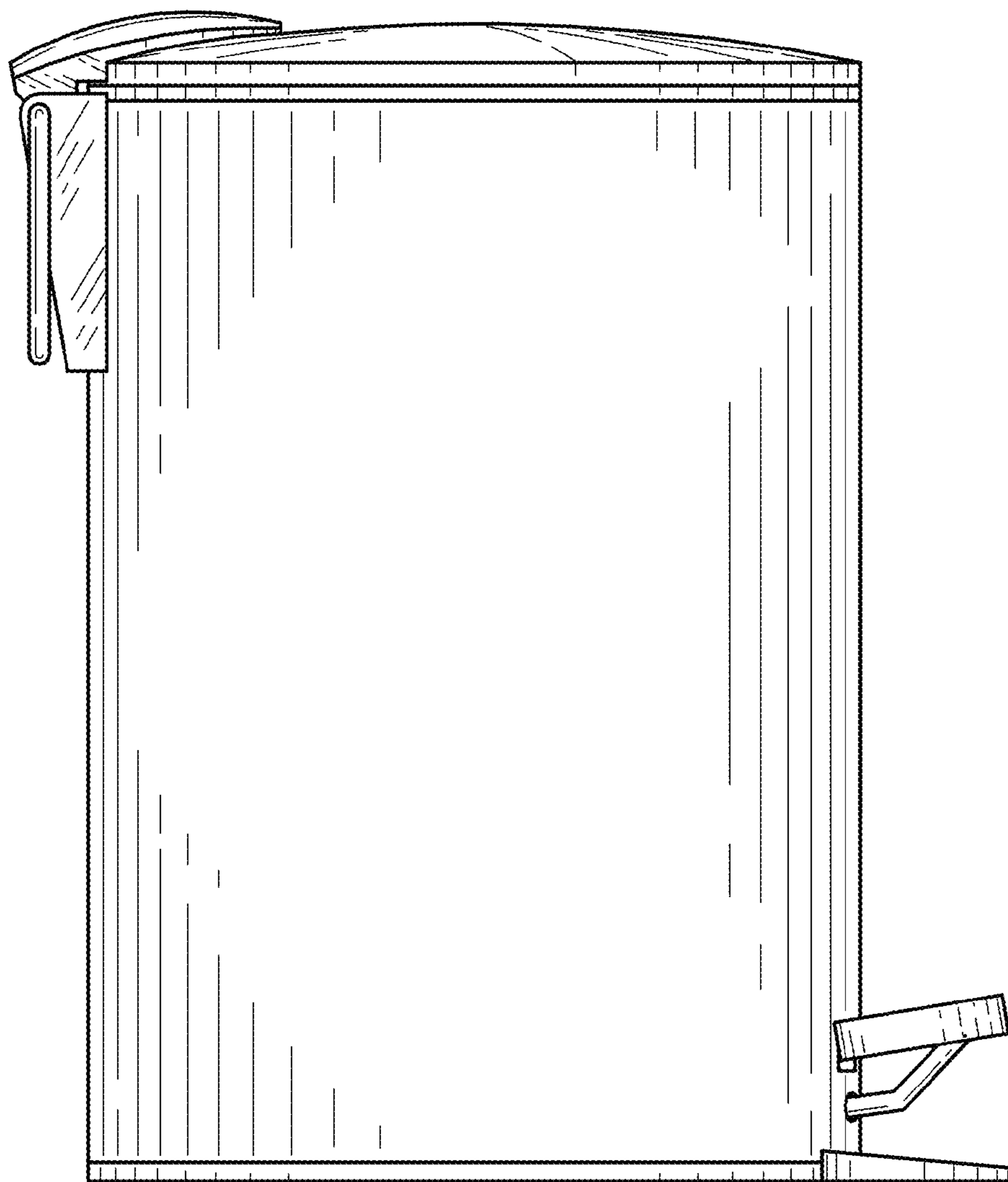

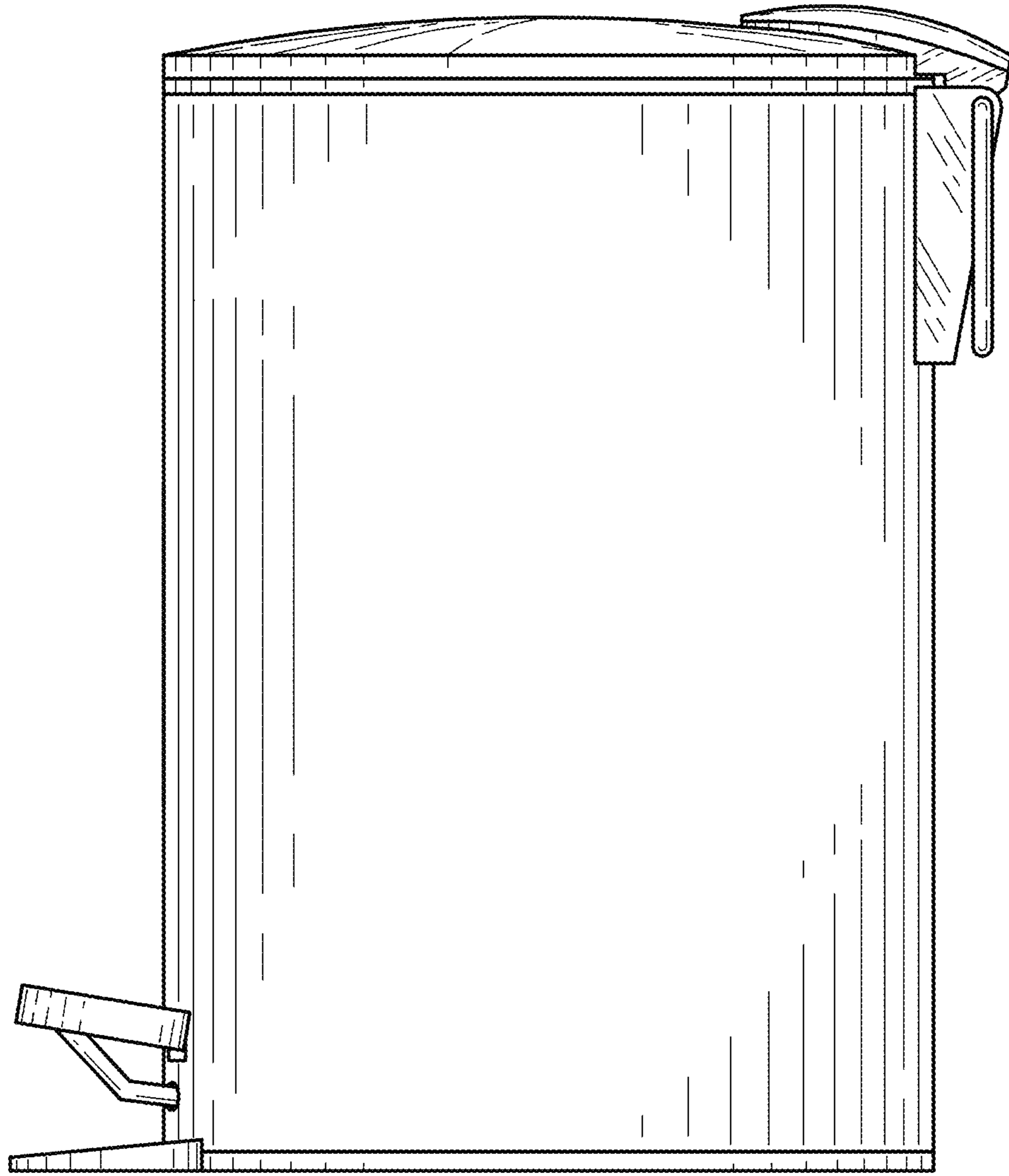

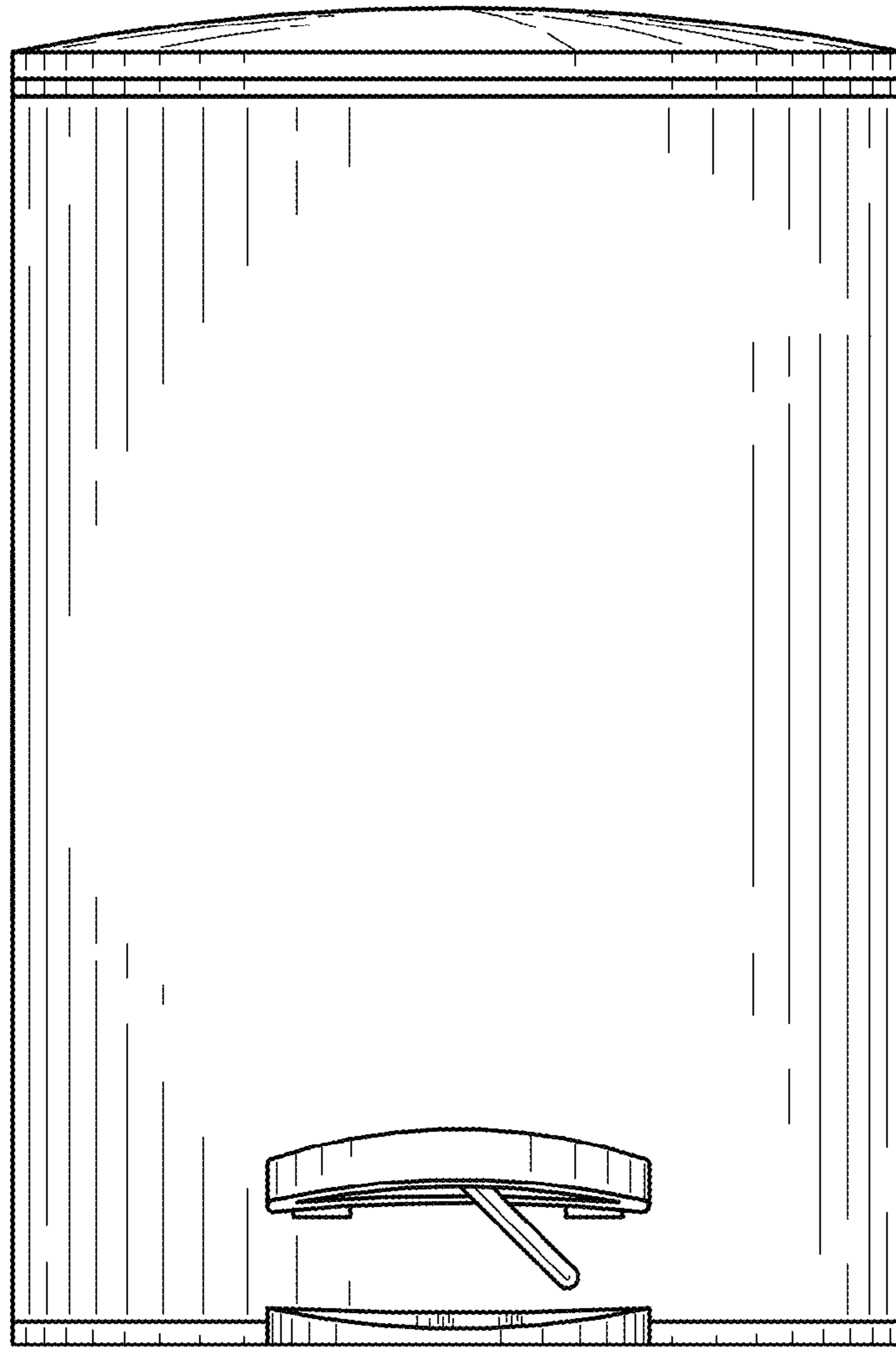

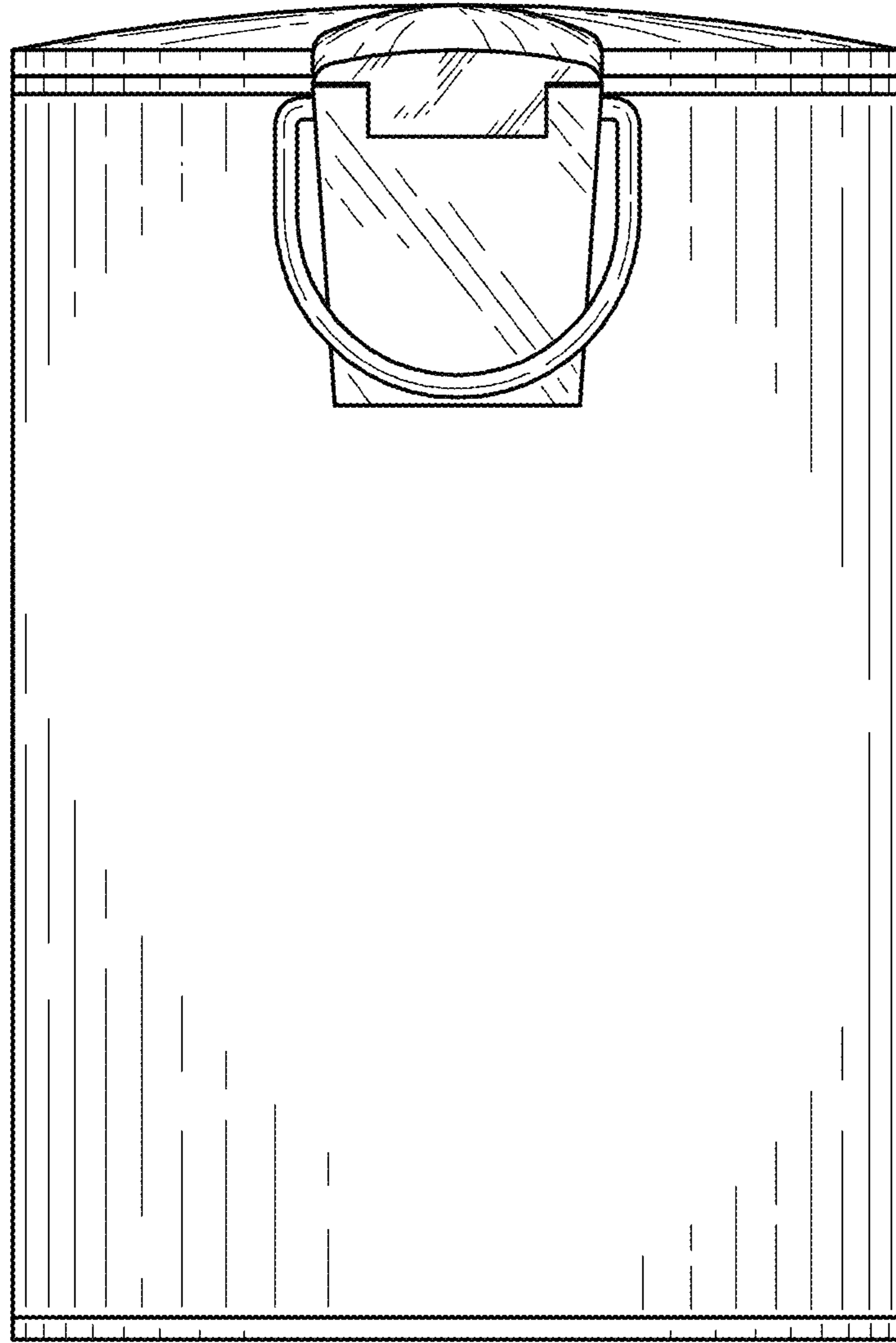

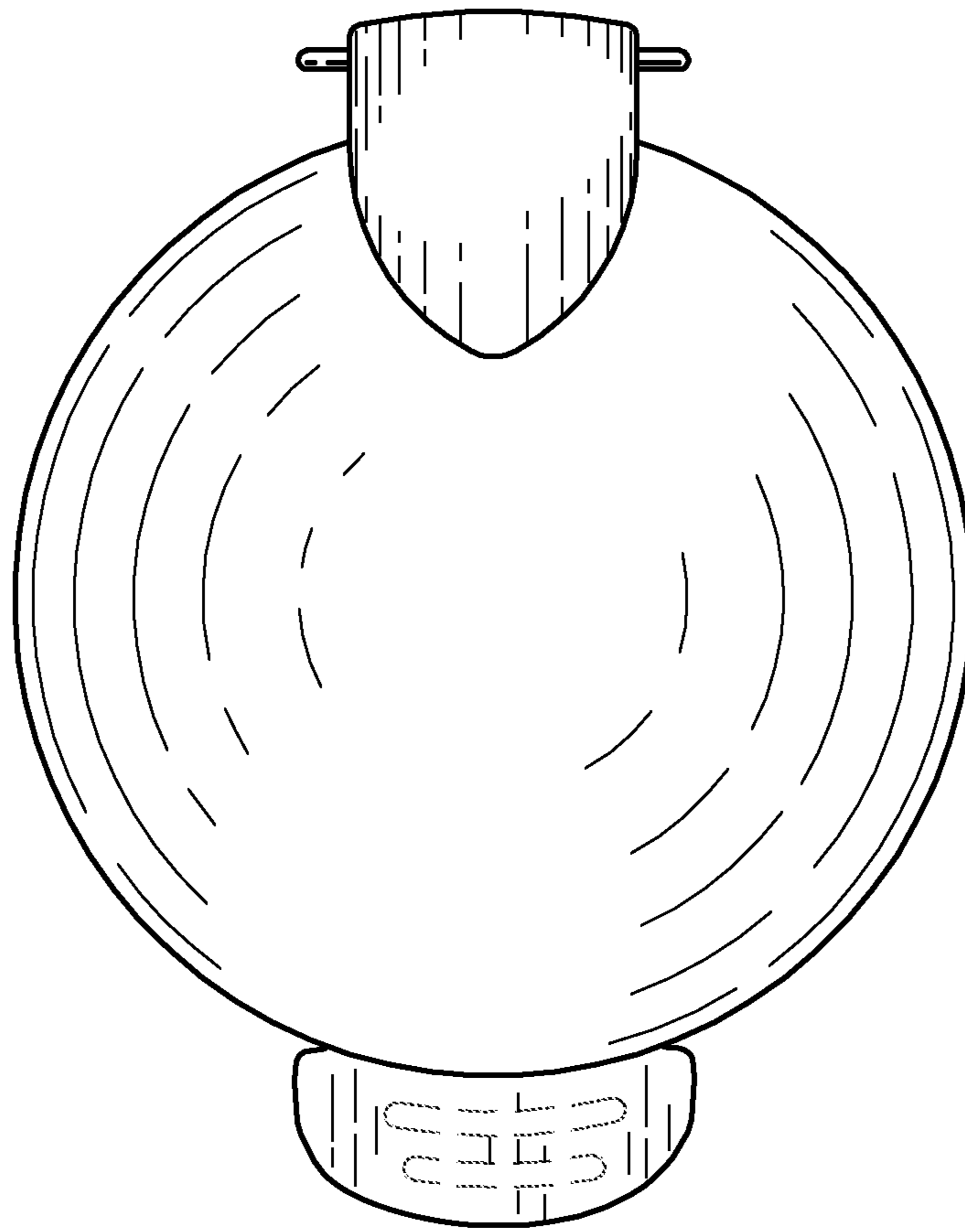
