(57) **CLAIM**

The ornamental design for a shoe midsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe midsole showing my new design;
 FIG. 2 is a plan view thereof;
 FIG. 3 is a rear perspective view thereof;
 FIG. 4 is an enlarged view of the claimed region in FIGS. 1-3, shown in isolation;
 FIG. 5 is a front perspective view of a shoe midsole showing a second embodiment of my new design;
 FIG. 6 is a plan view thereof;
 FIG. 7 is a rear perspective view thereof; and,
 FIG. 8 is an enlarged view of the claimed region in FIGS. 5-7, shown in isolation.

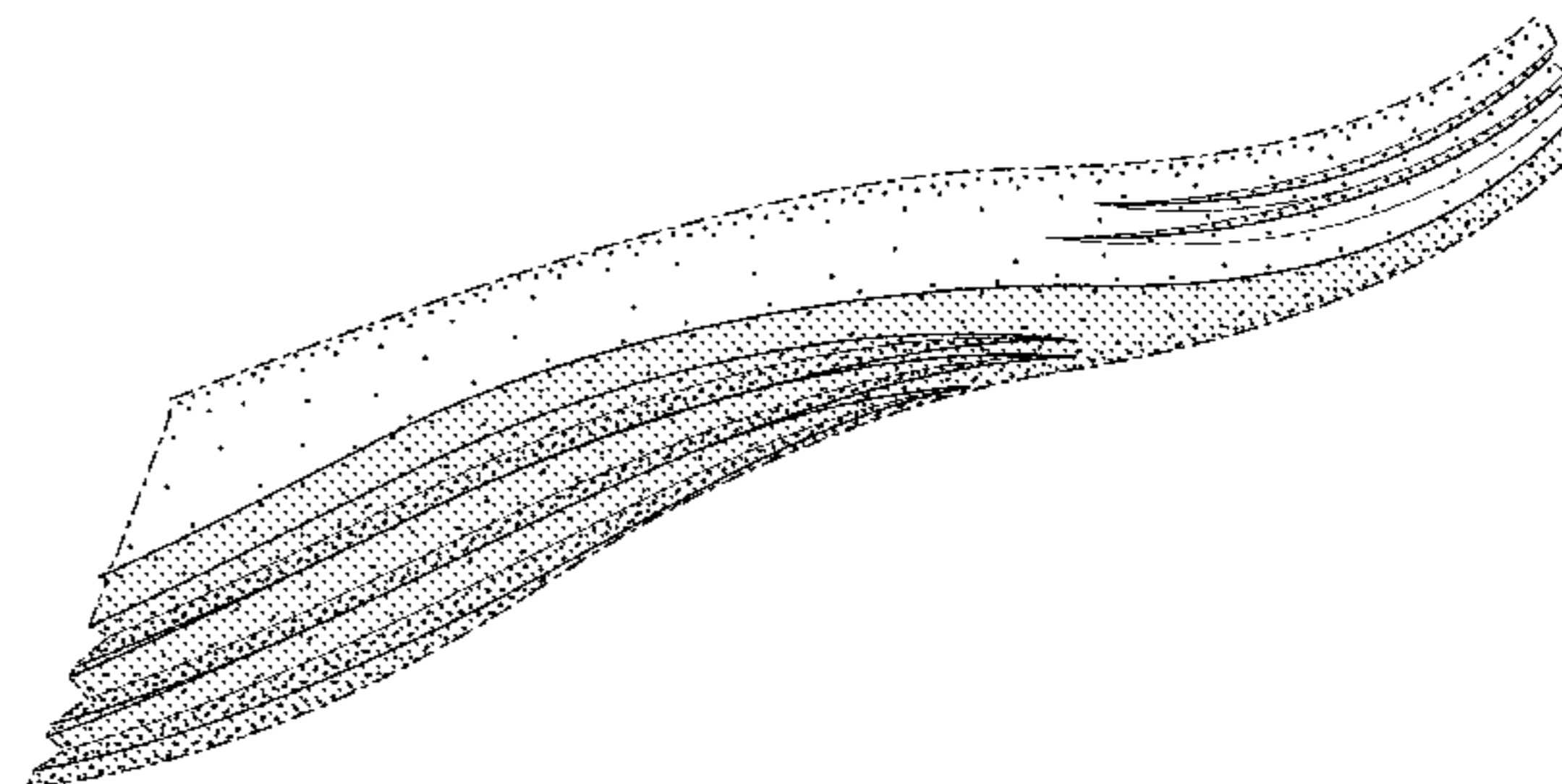
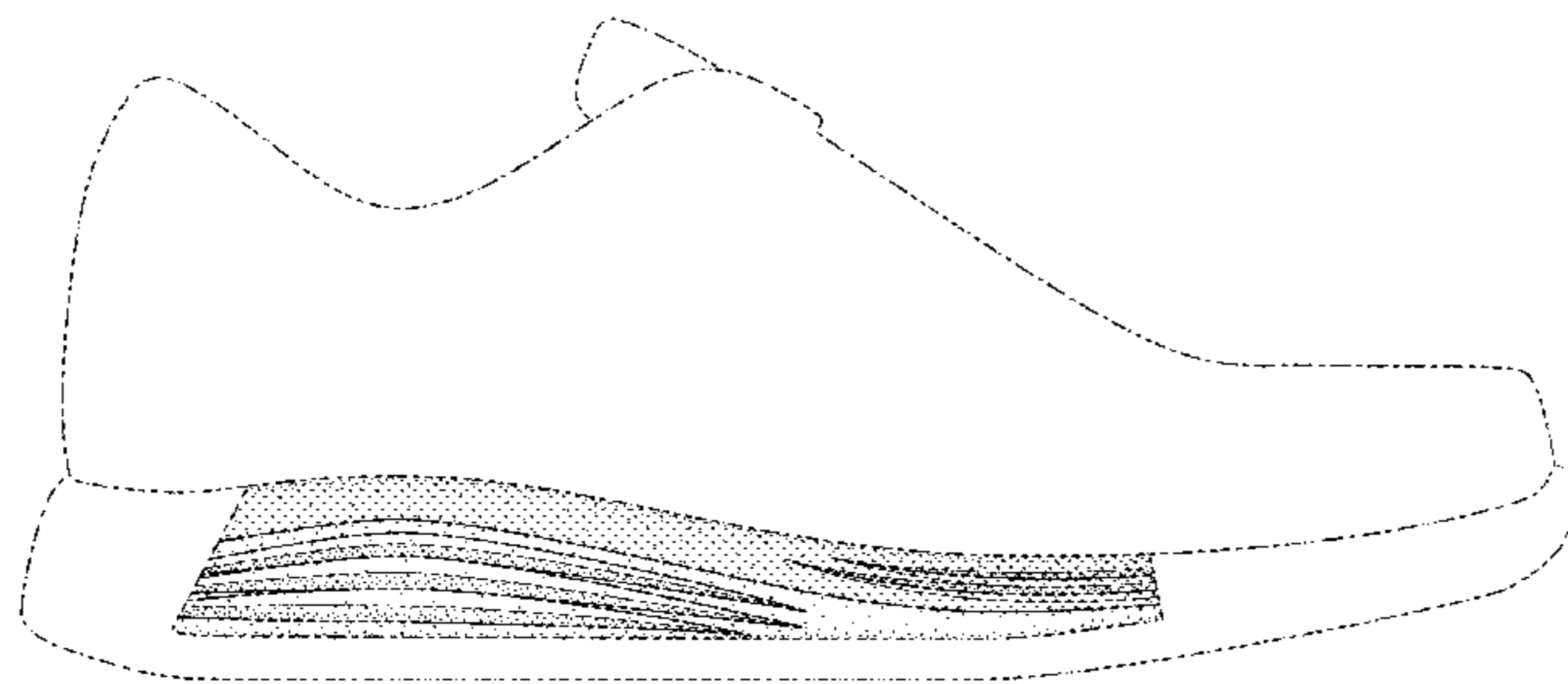

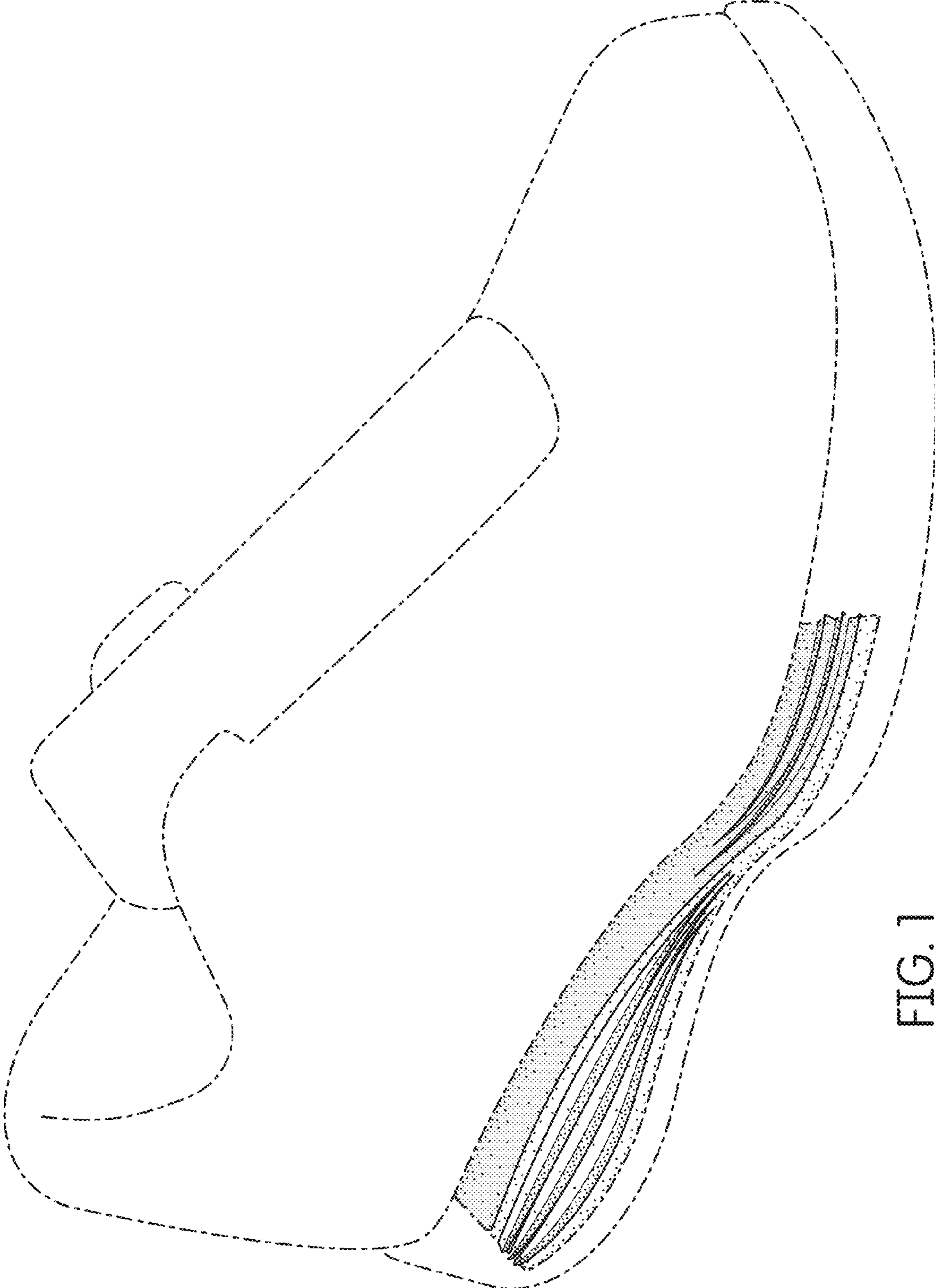

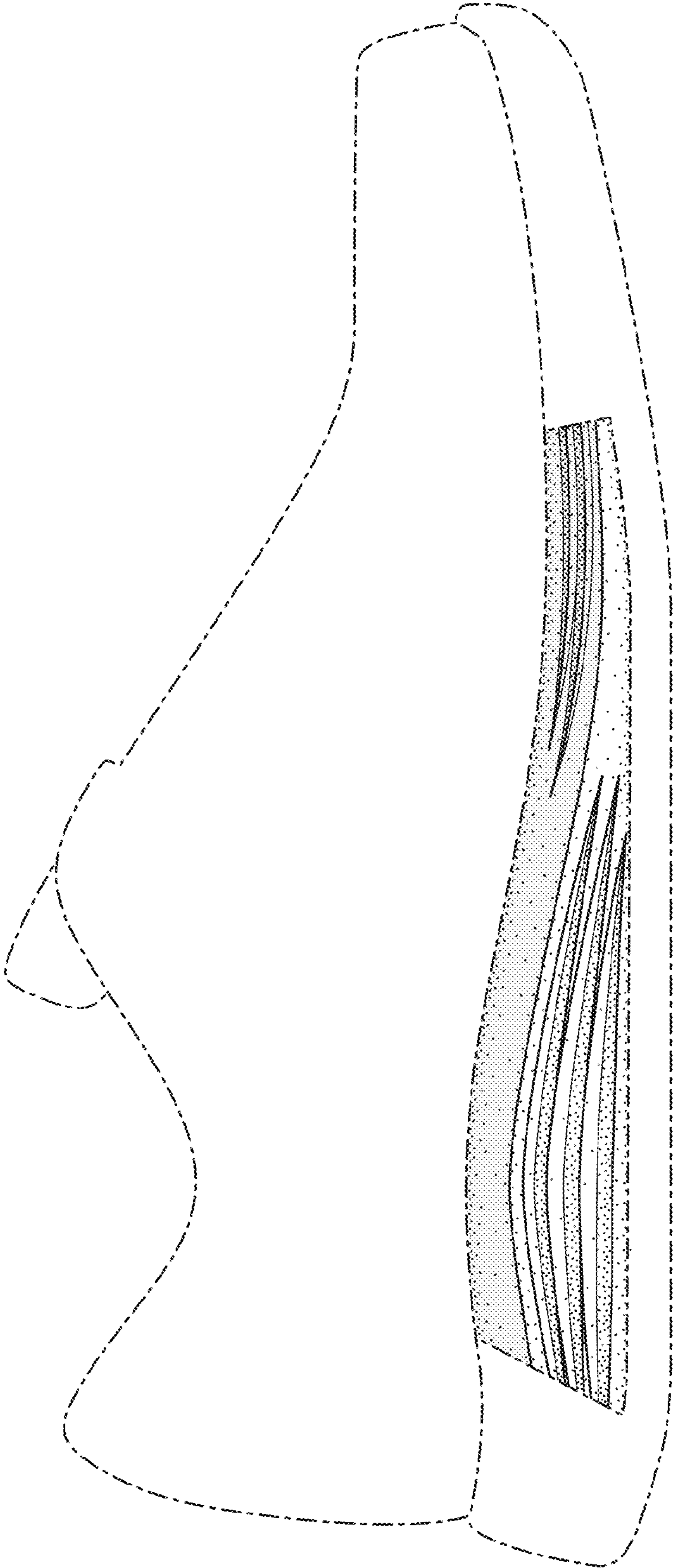

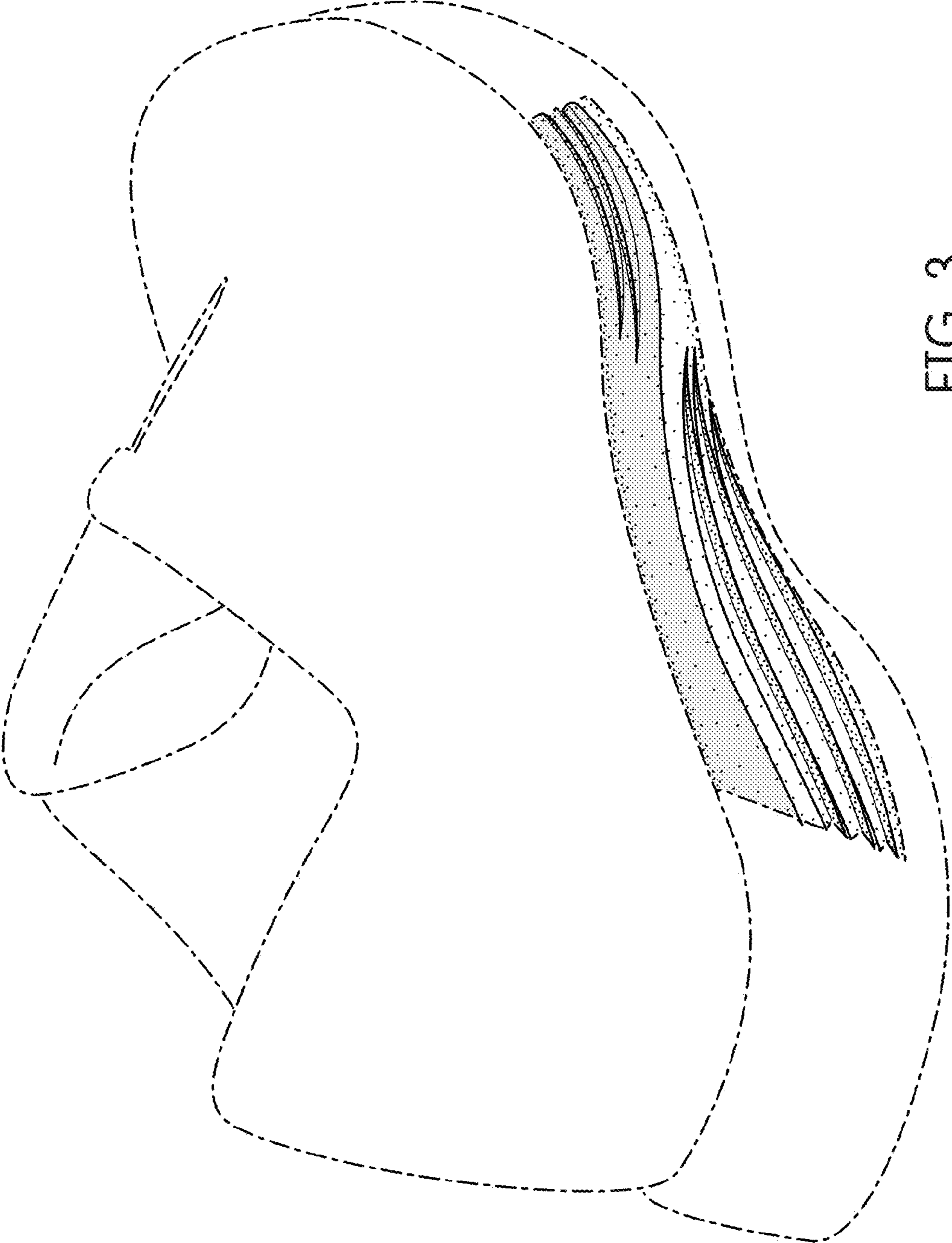

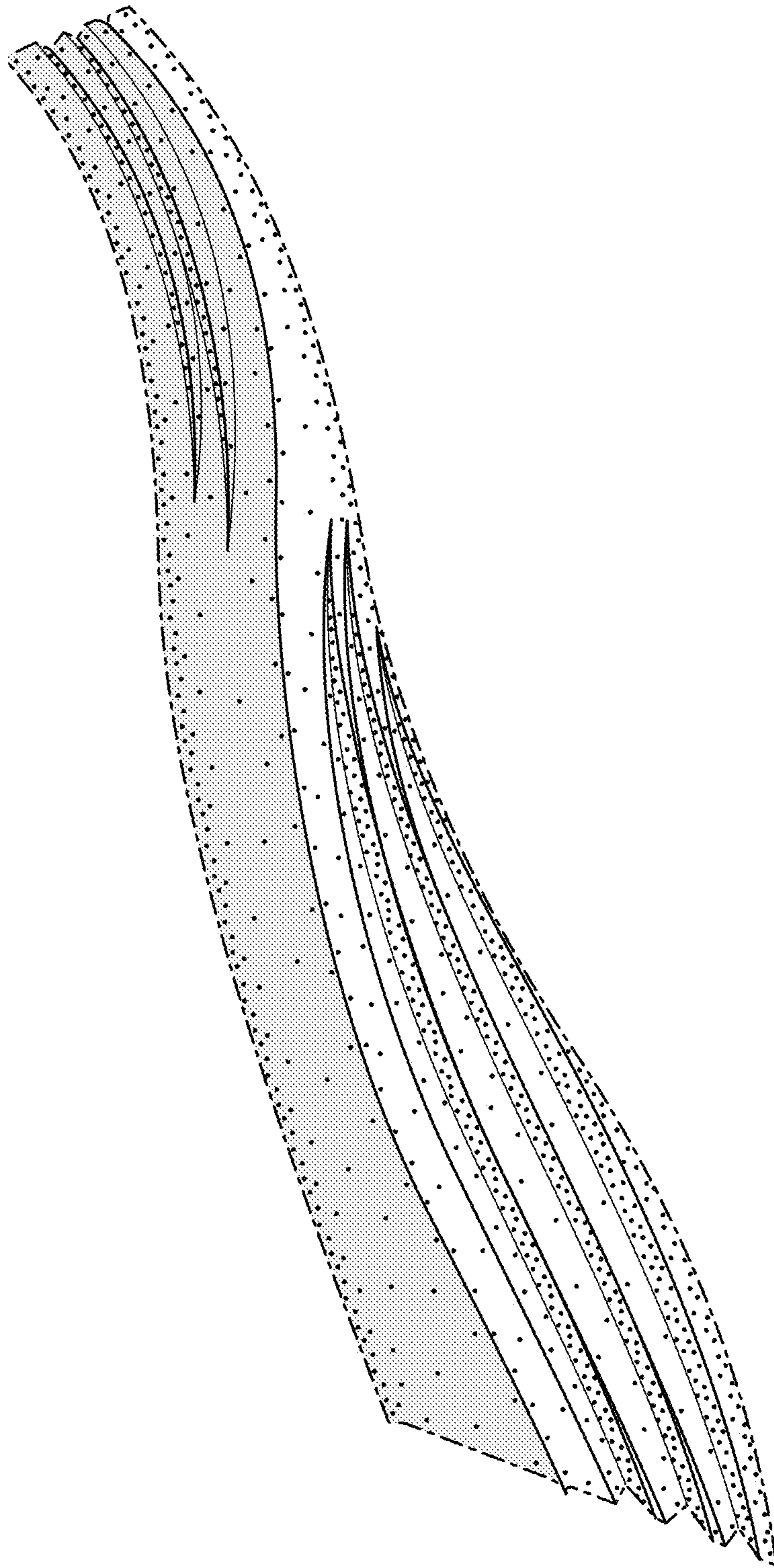

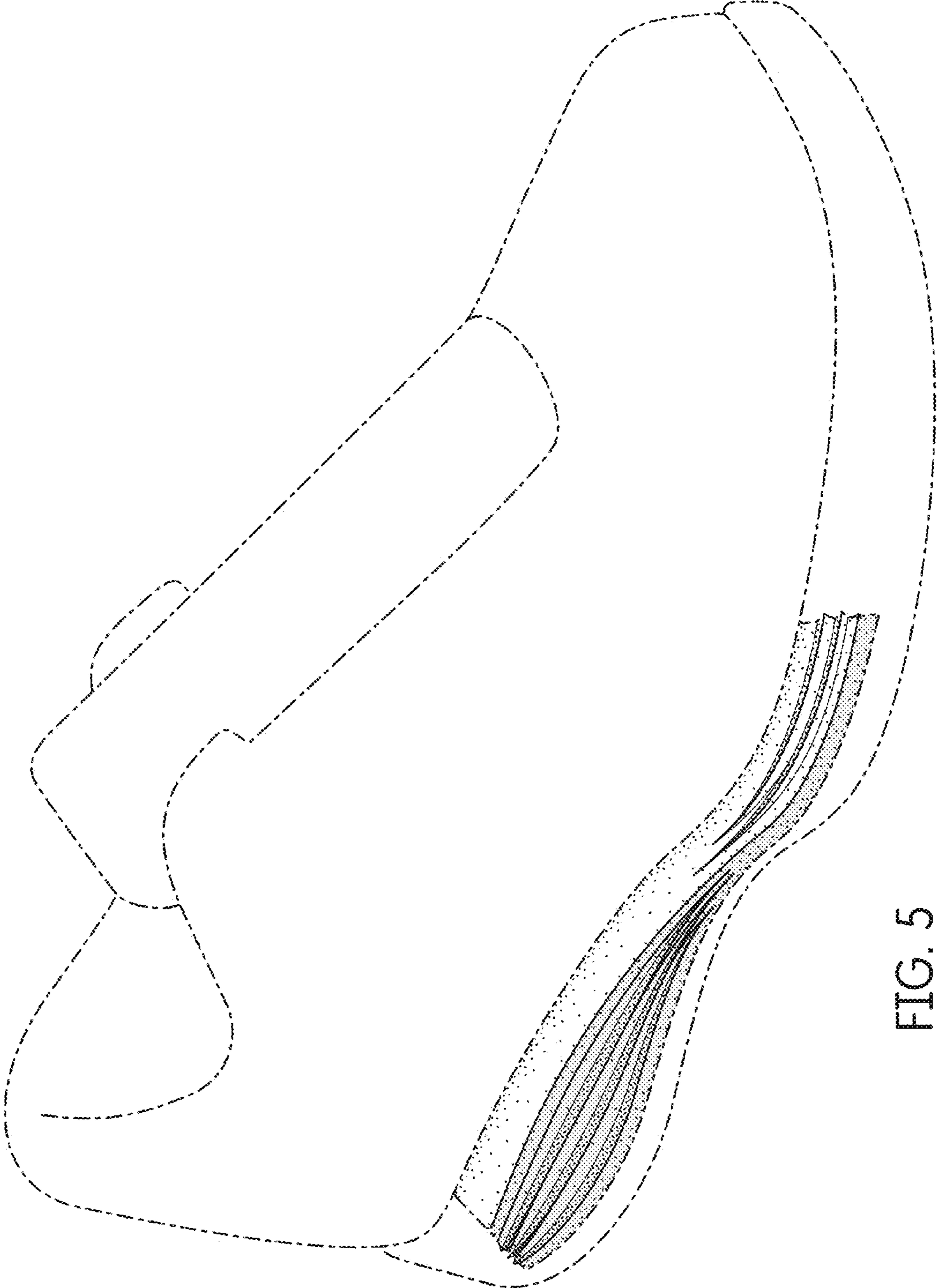

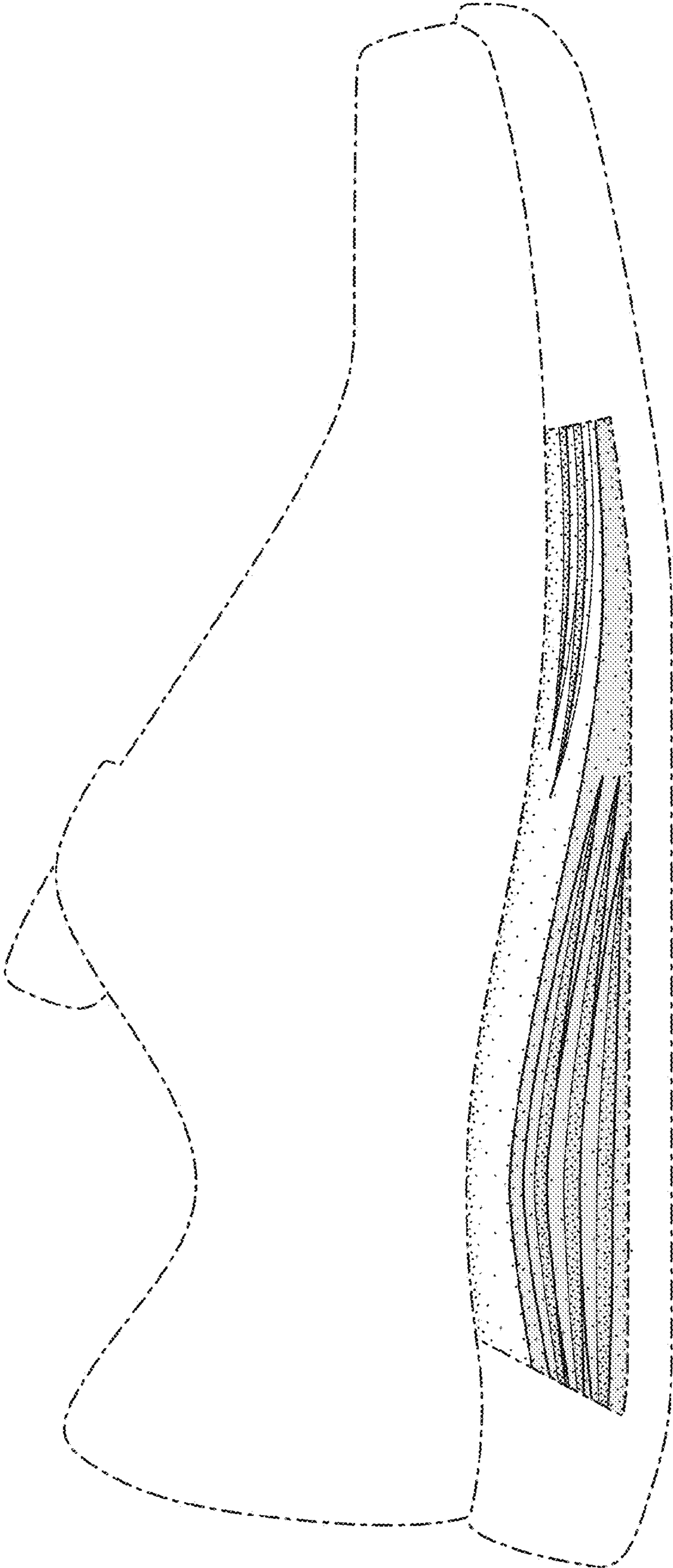

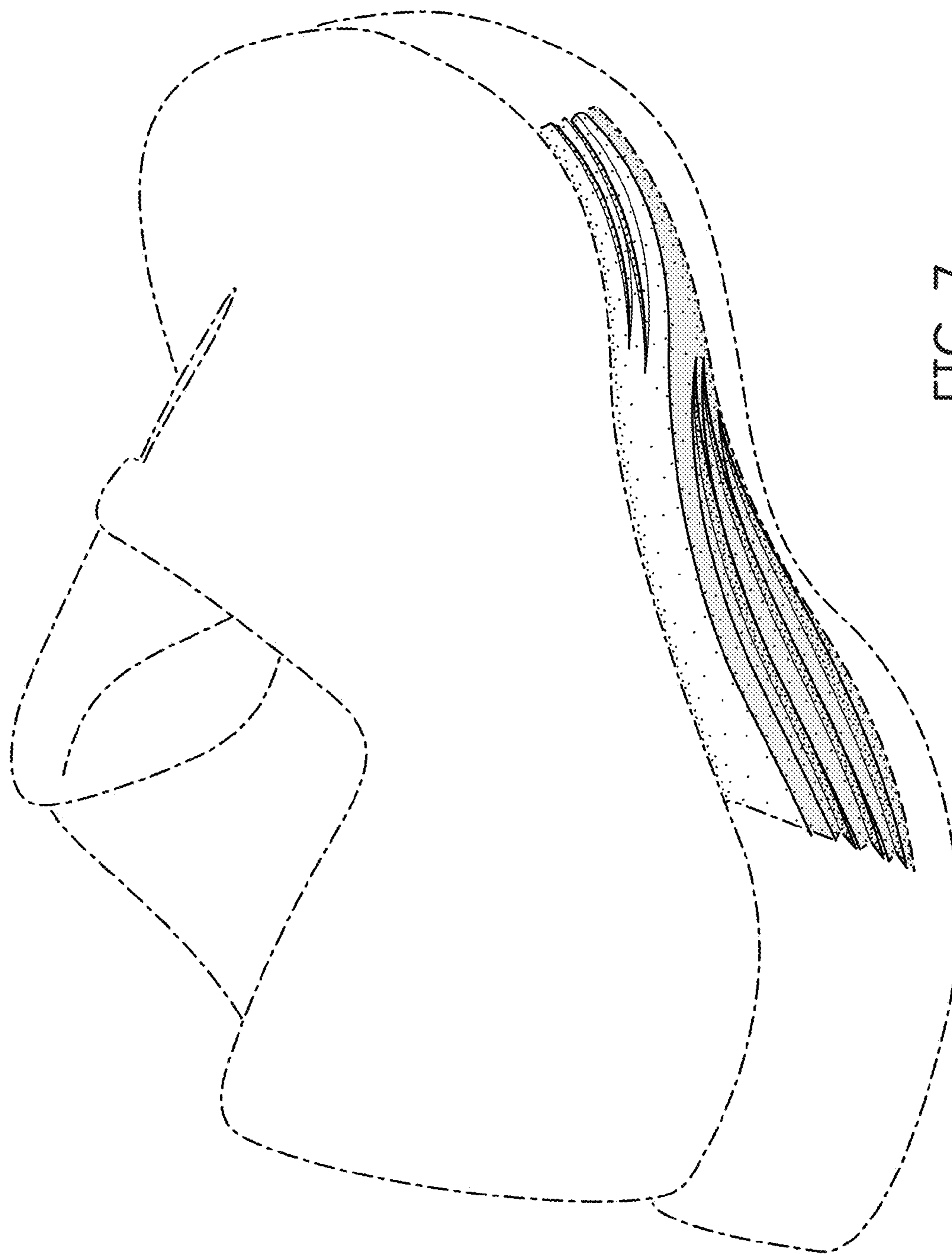

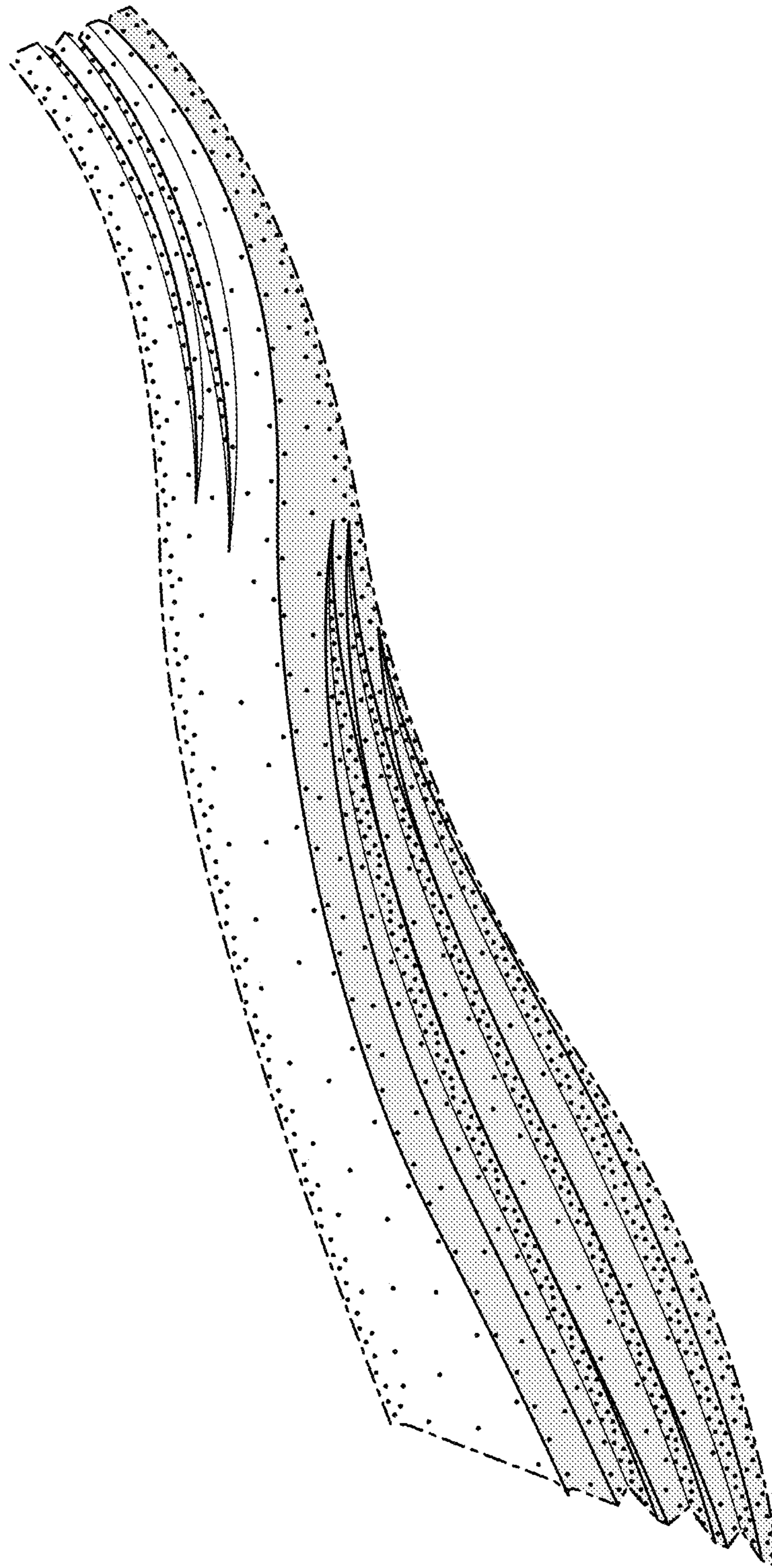
