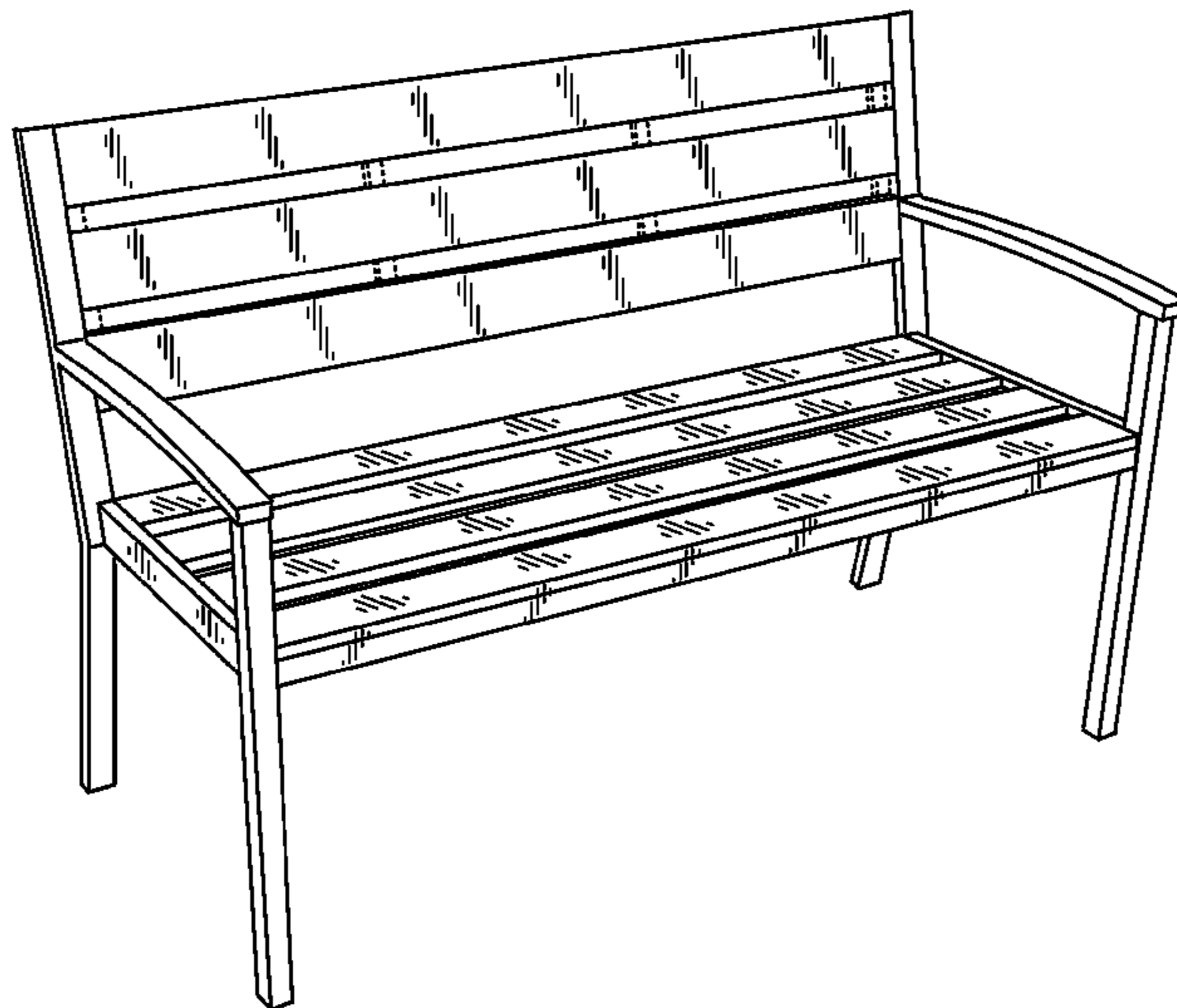
The ornamental design for a bench, as shown and described.

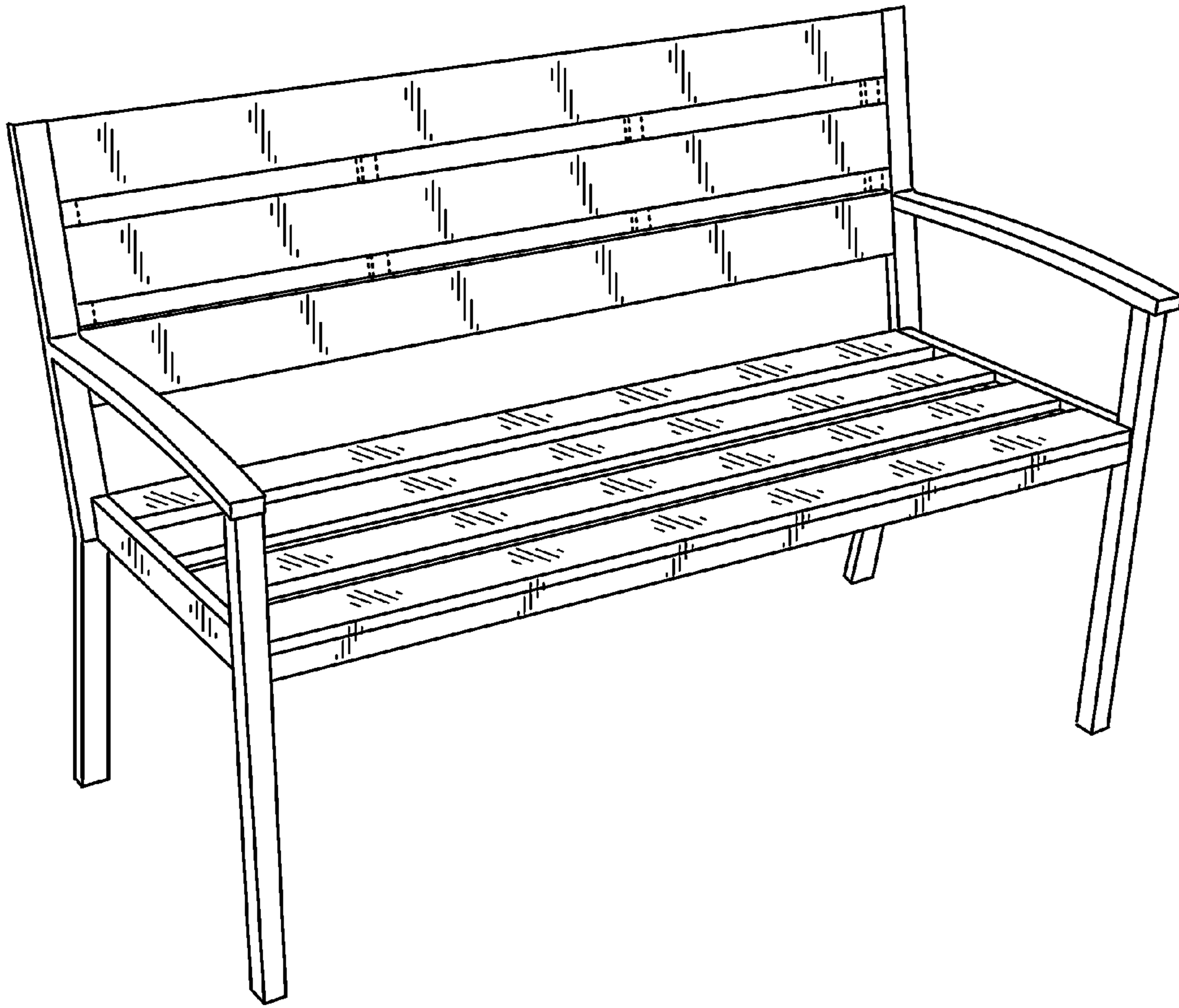

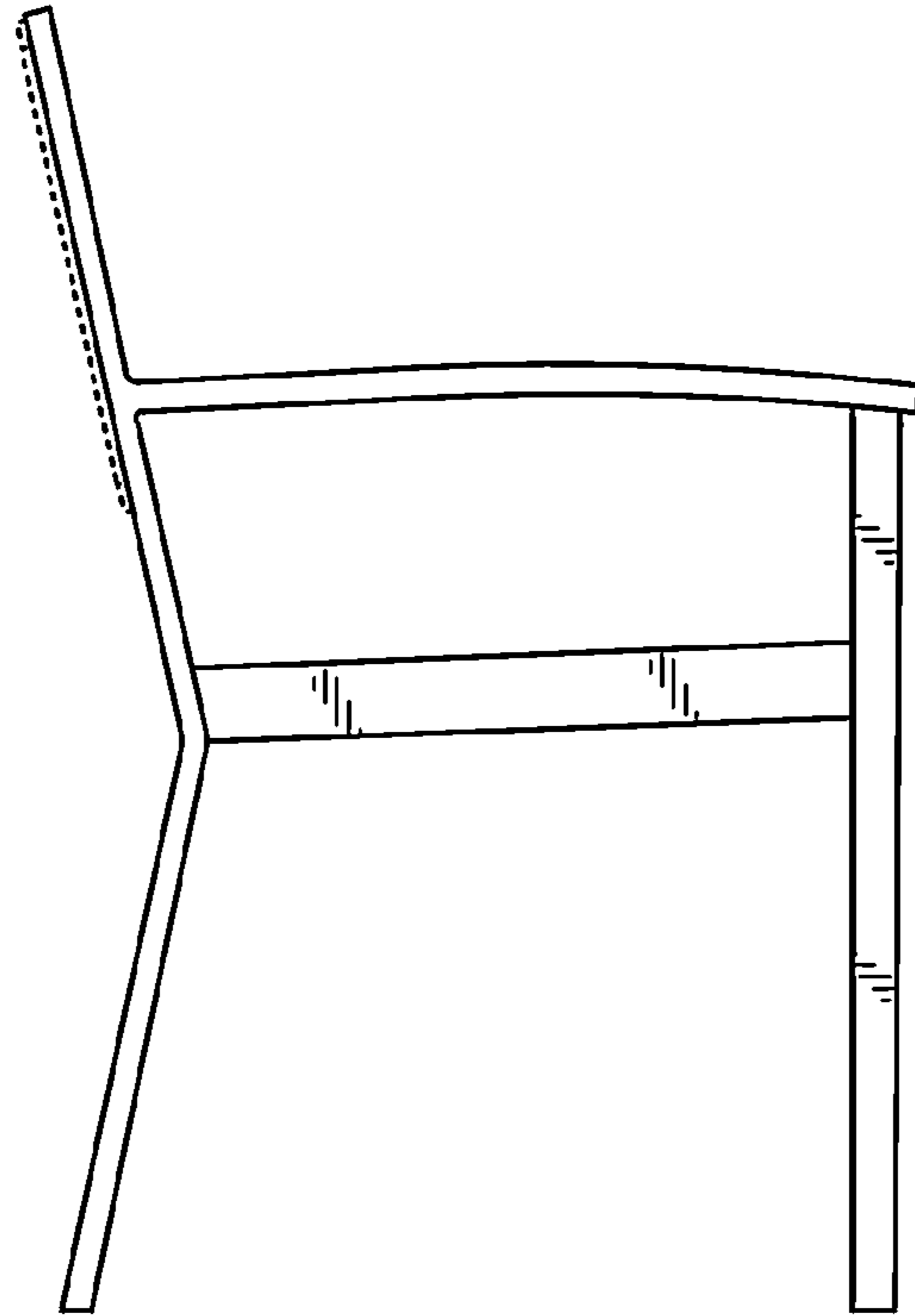

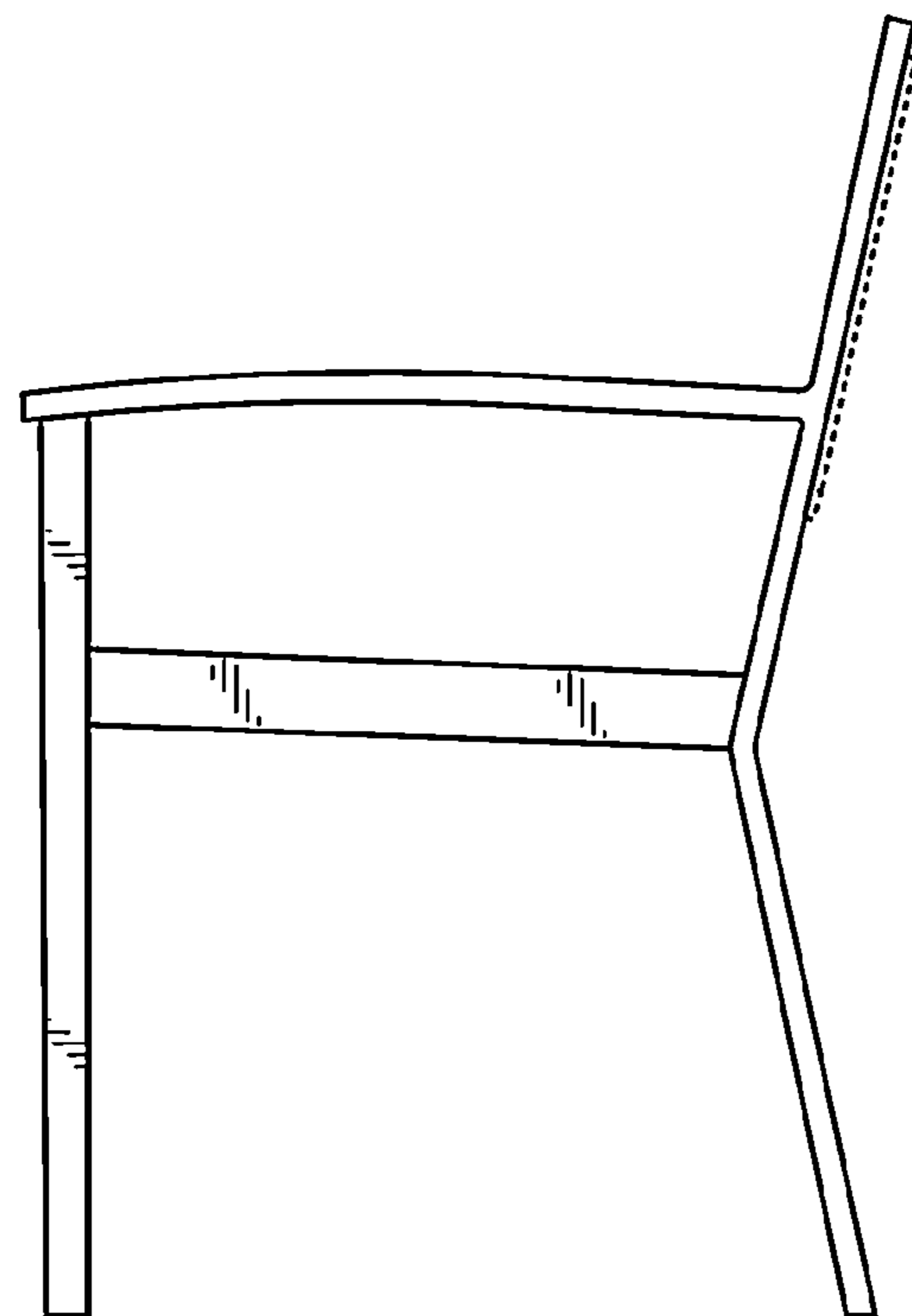

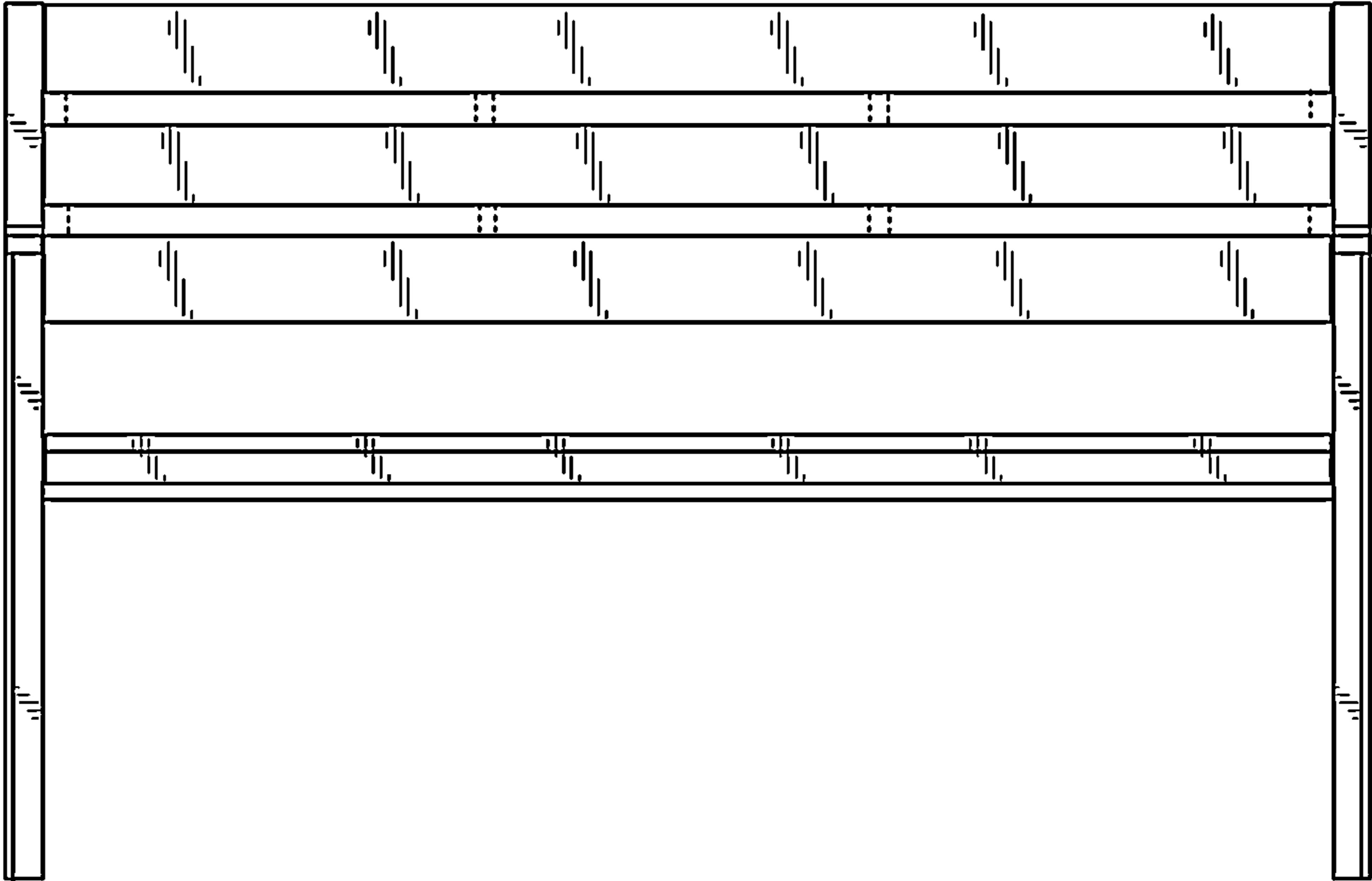

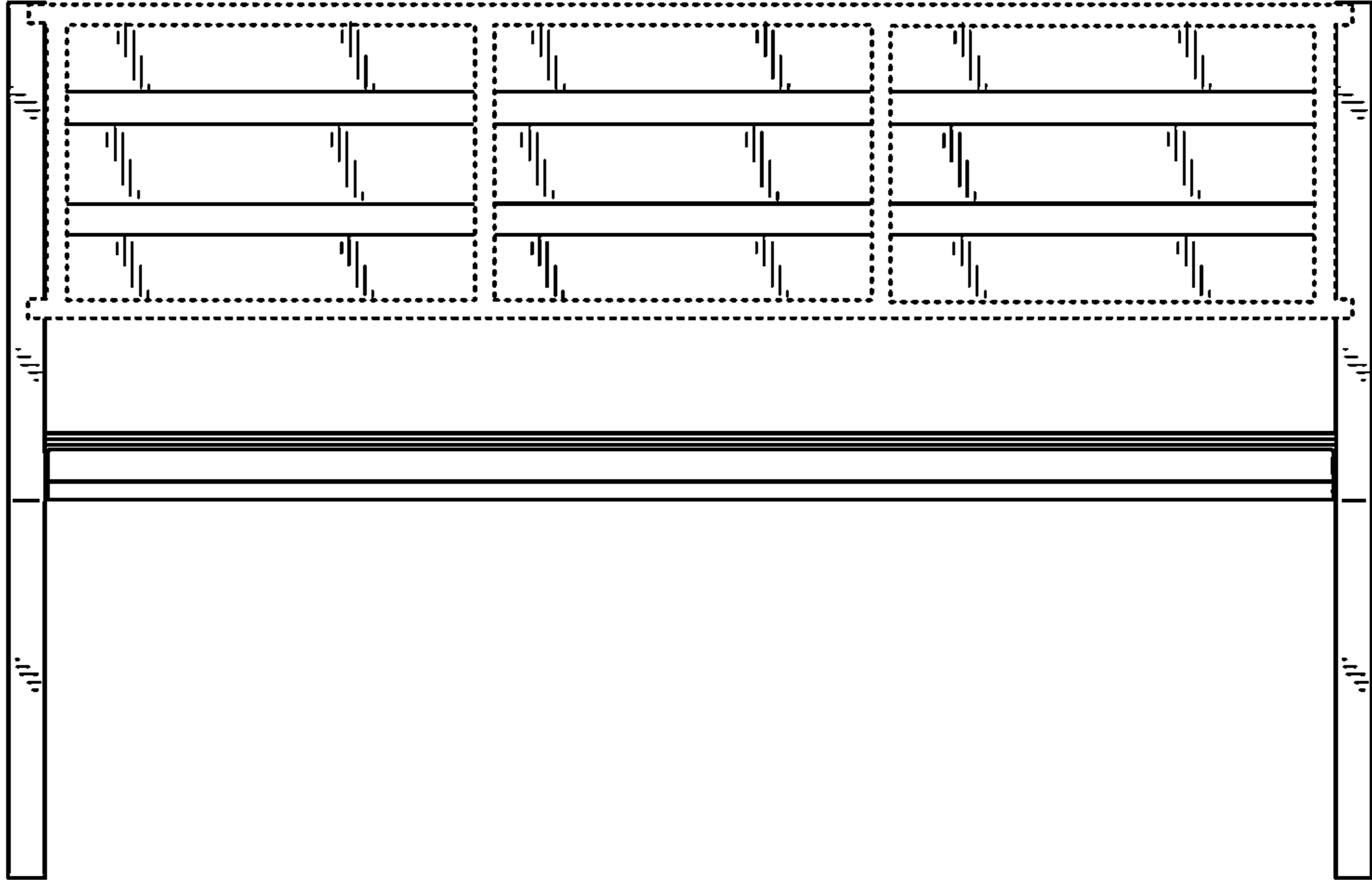

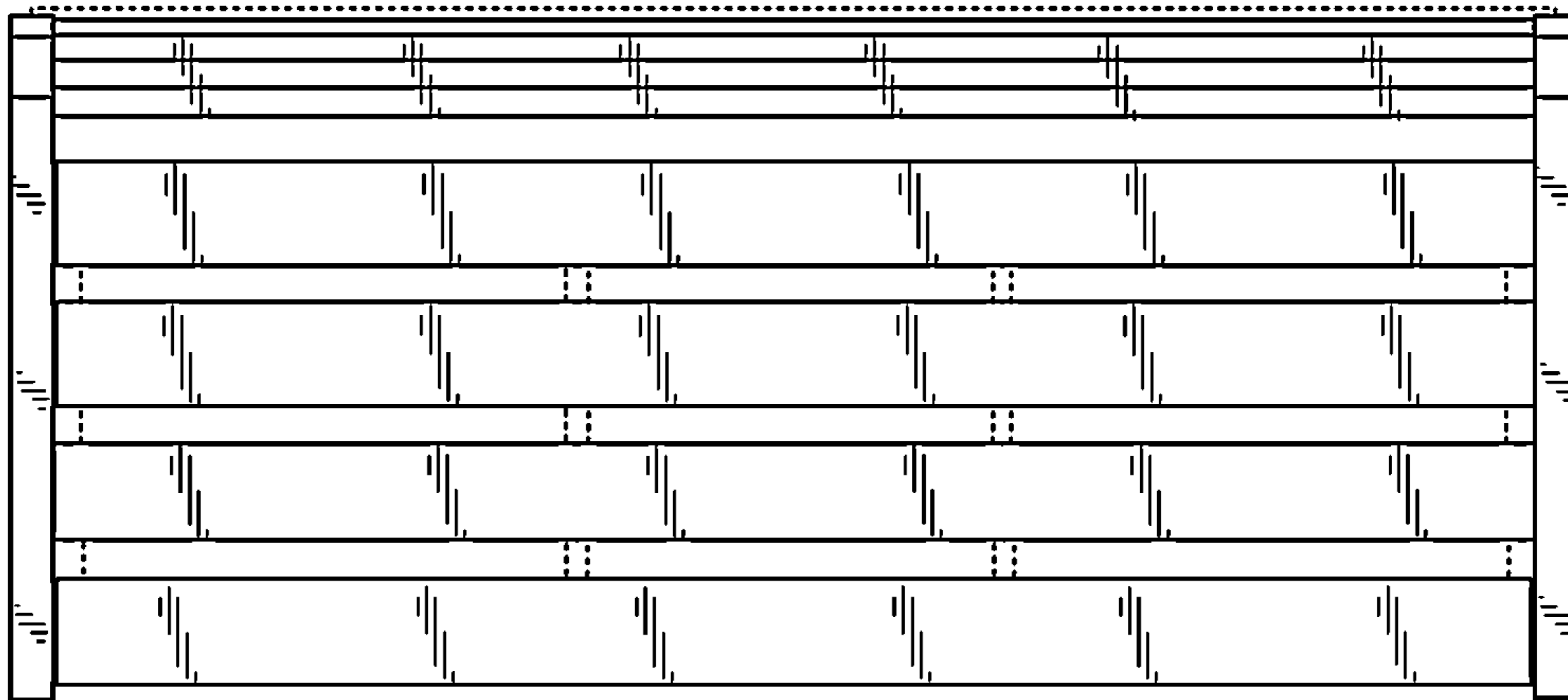

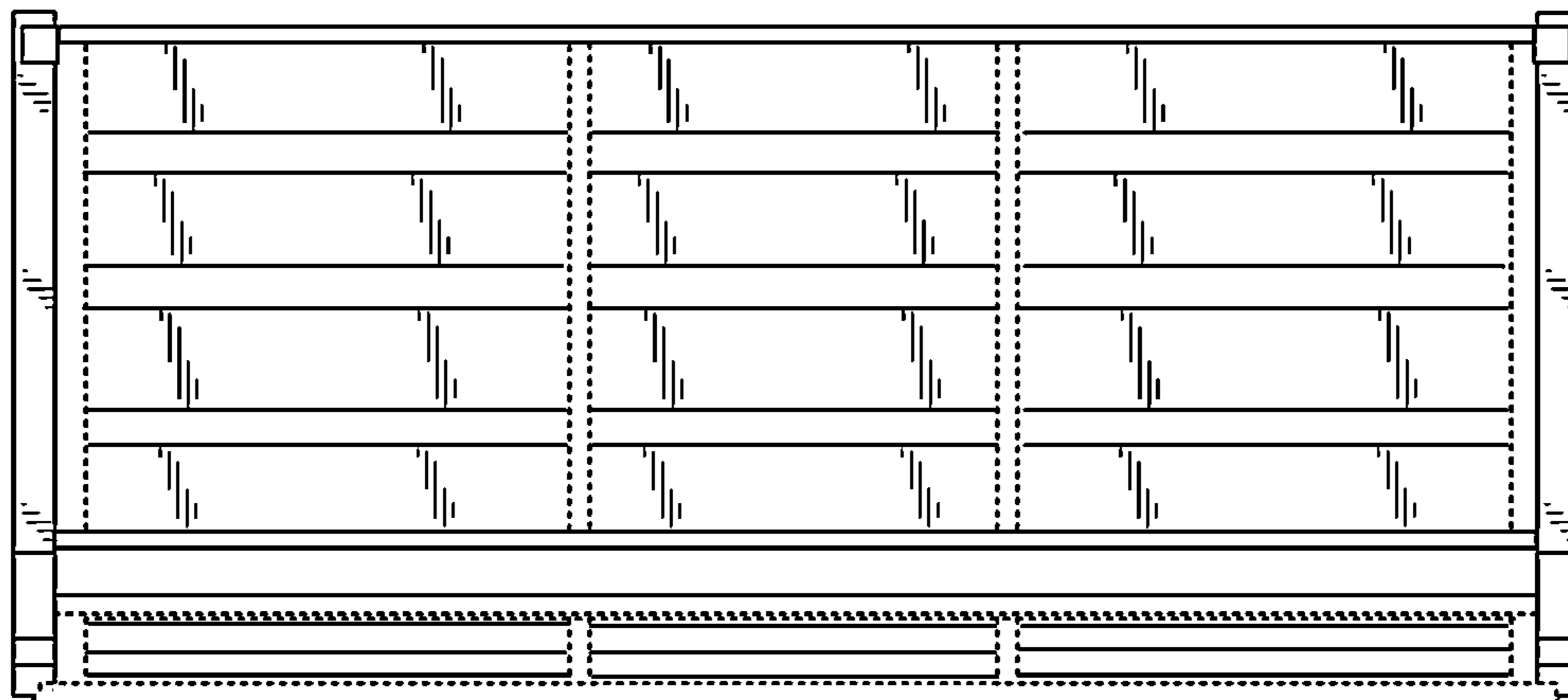
