**DESCRIPTION**

FIG. 1 is a perspective view of a barbecue grill, showing my new design;

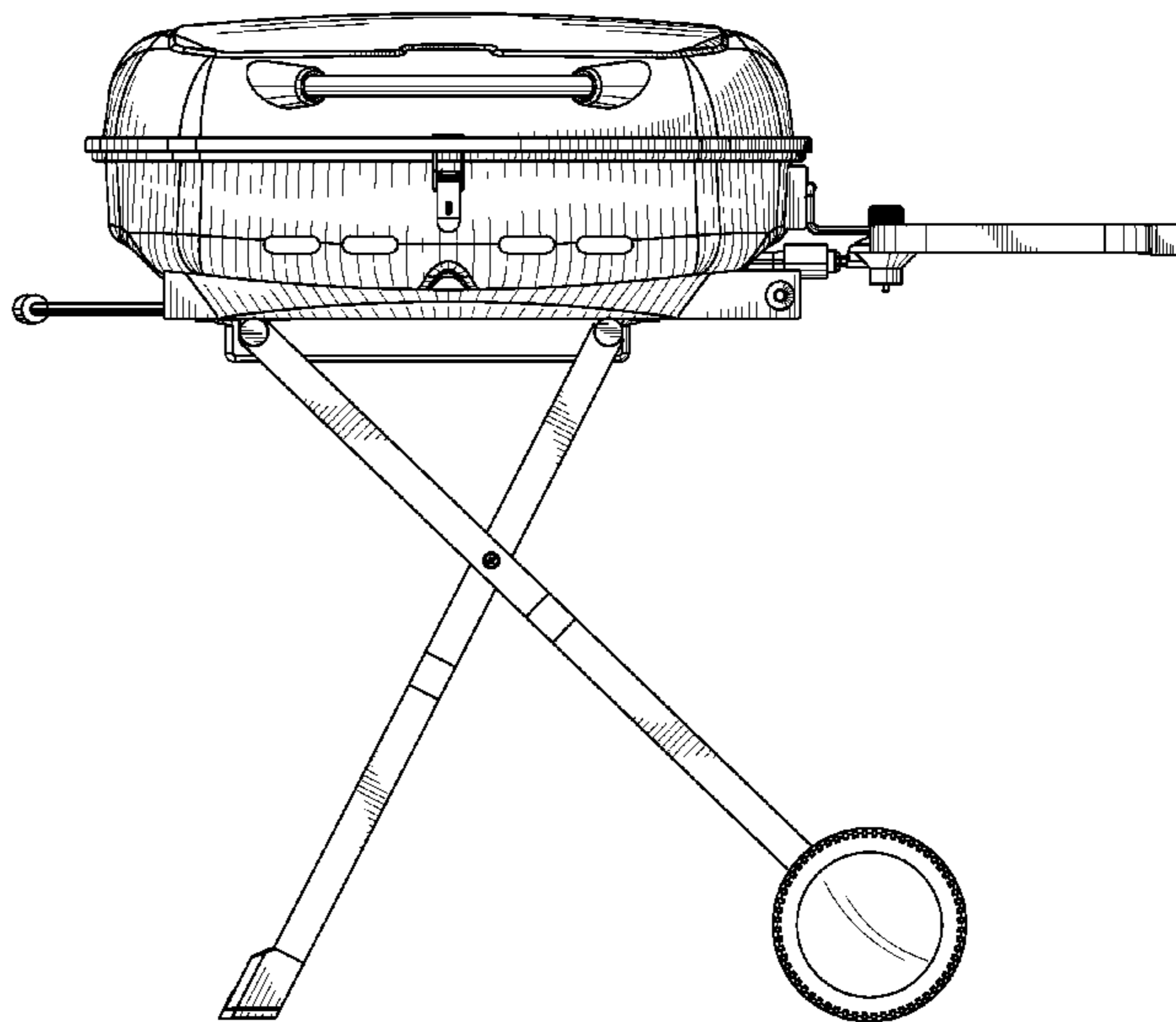

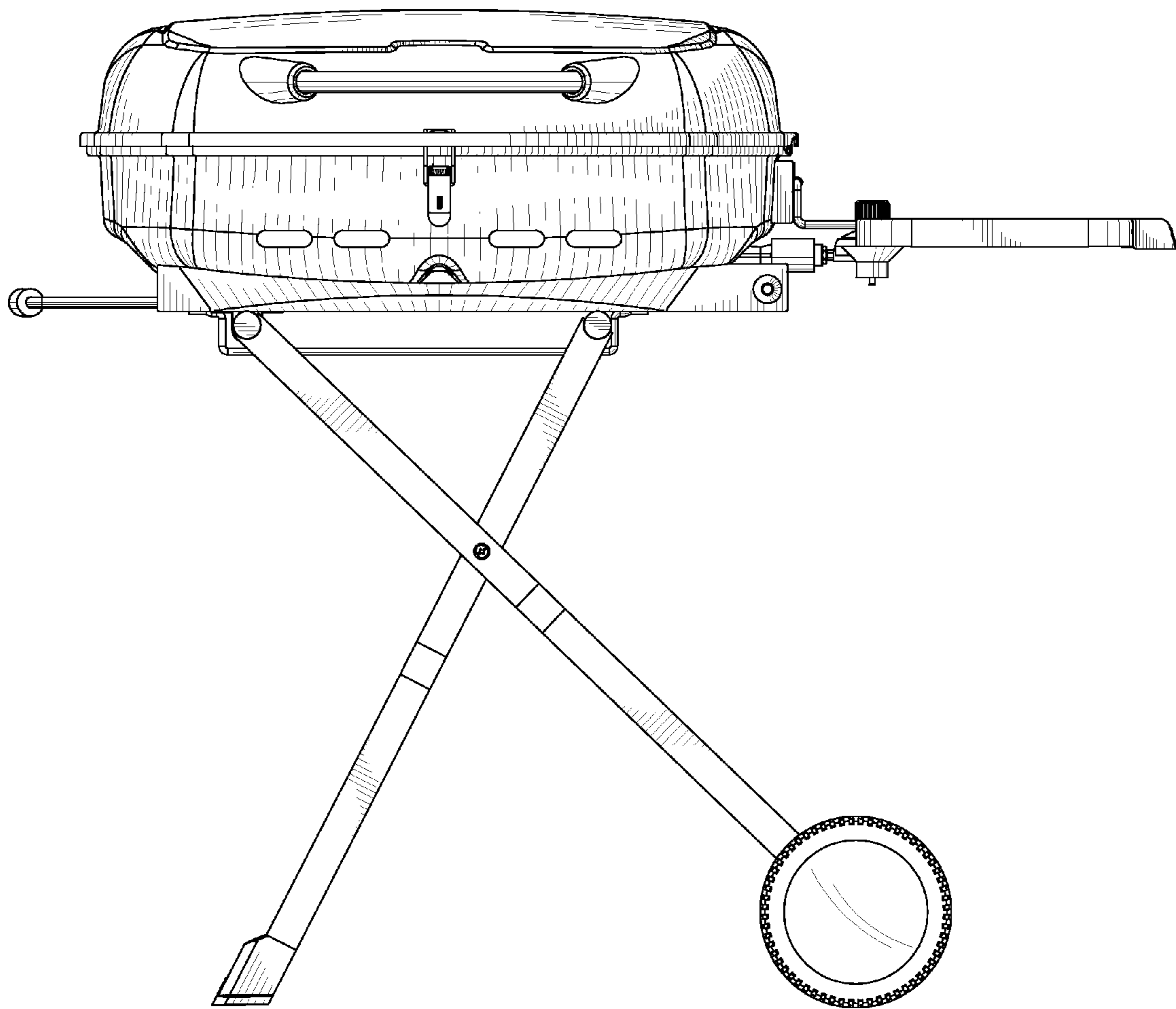

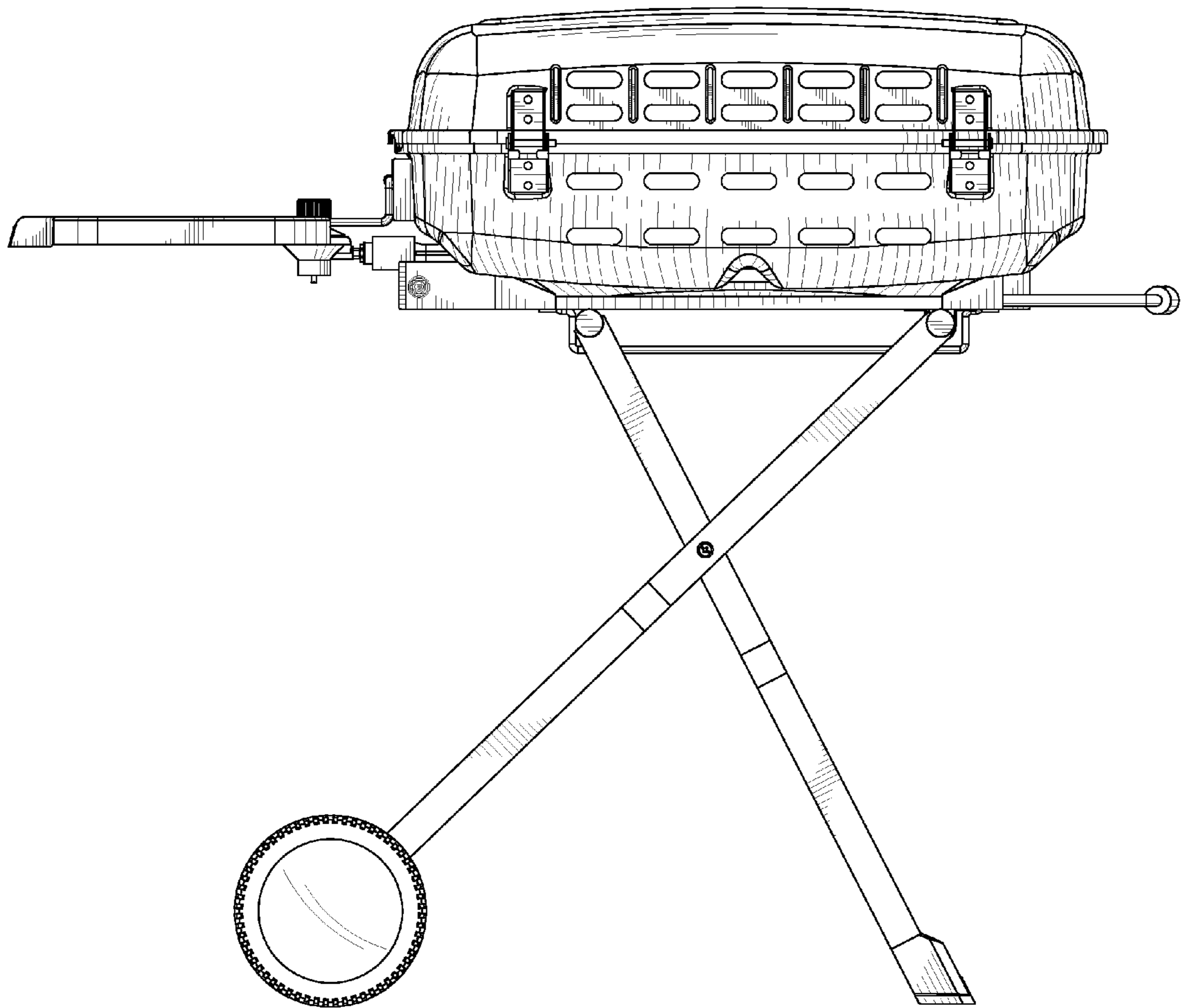

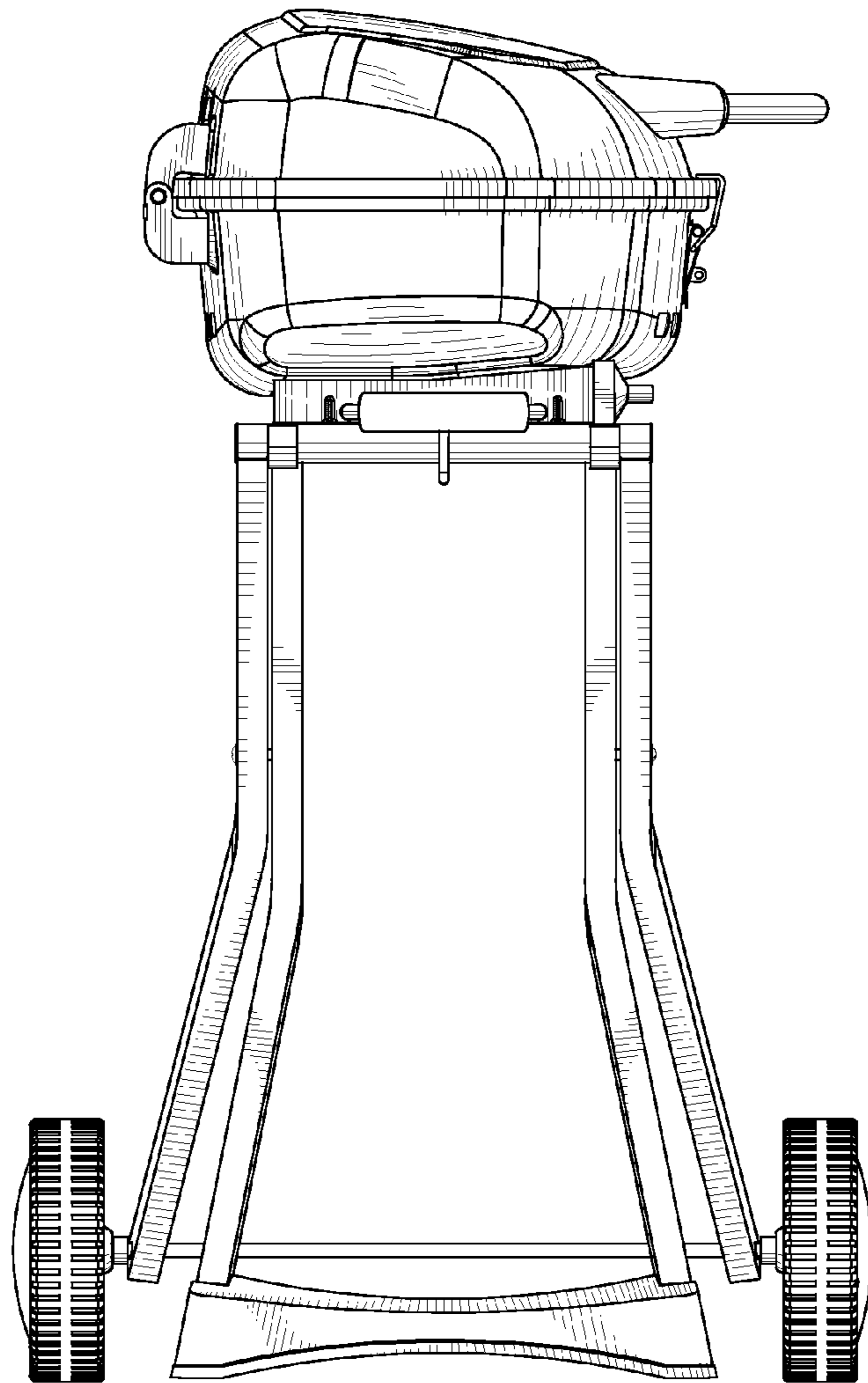

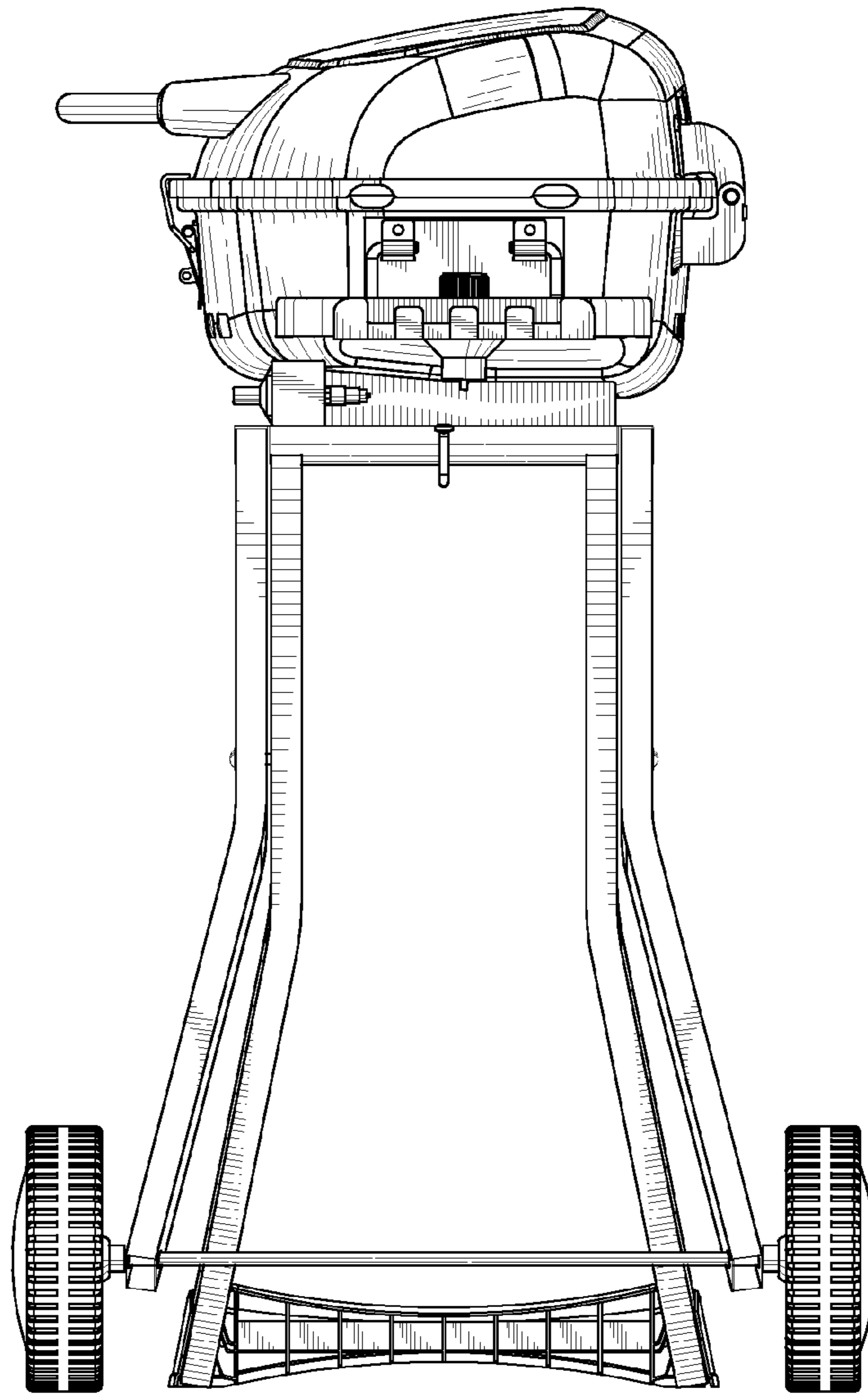

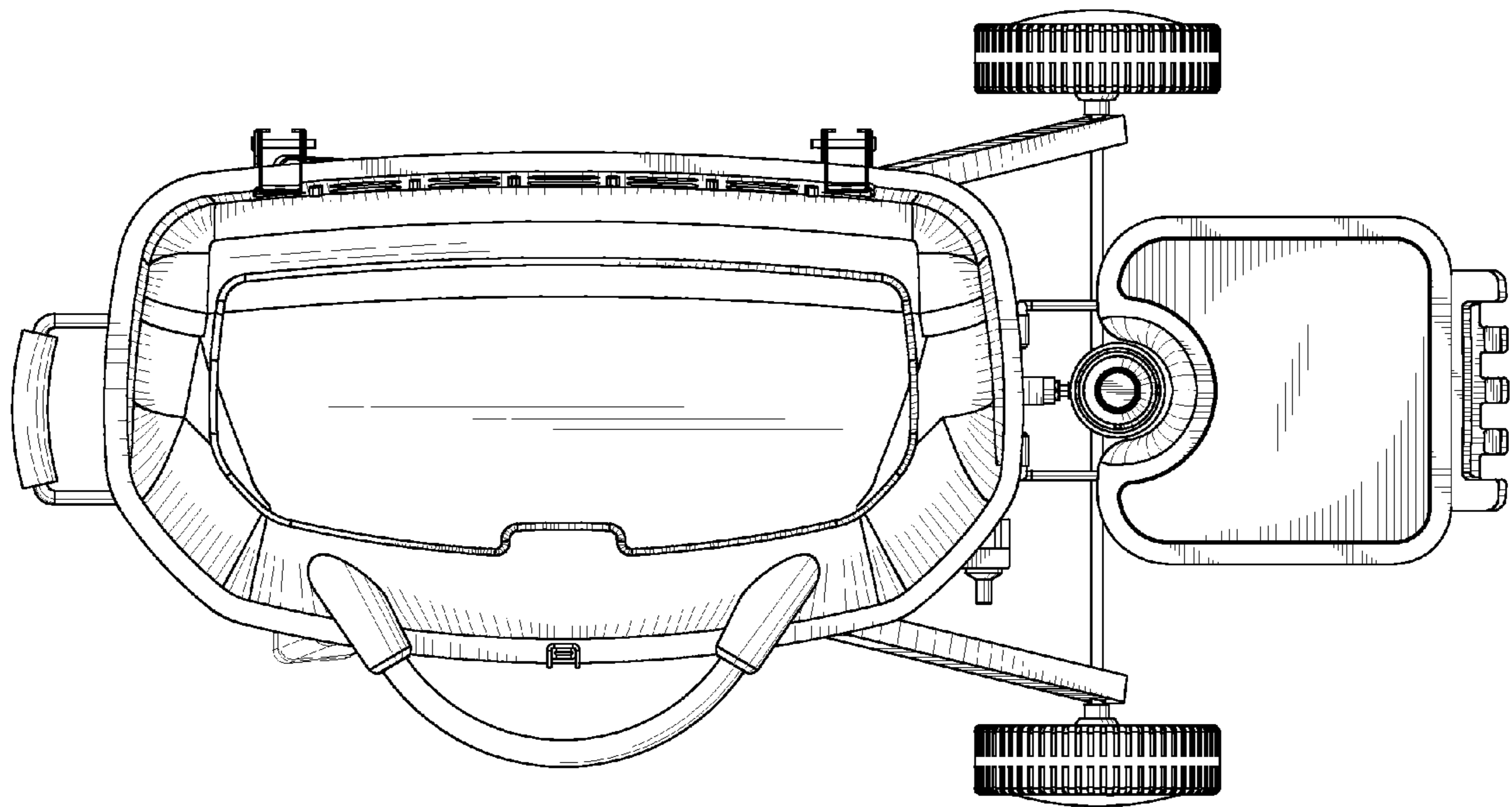

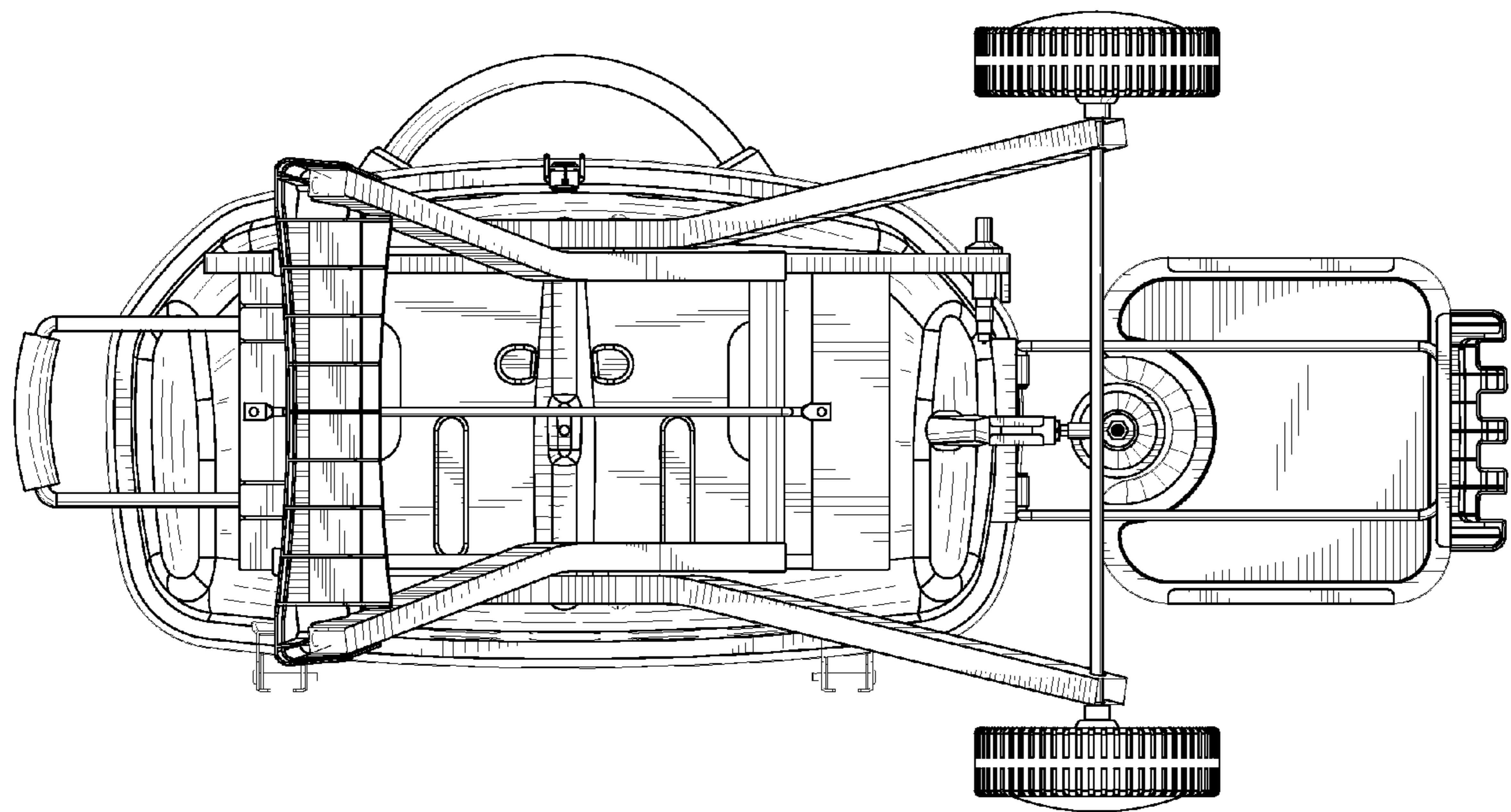
