CLAIM

The ornamental design for a wine carrier, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of a wine carrier showing my new design;

FIG. 2 is an alternate perspective view of the wine carrier of FIG. 1;

FIG. 3 is a front view of the wine carrier of FIG. 1 showing a pocket on a front panel of the wine carrier;

FIG. 4 is a rear view of the wine carrier of FIG. 1 showing a pocket on a rear panel of the wine carrier;

FIG. 5 is a right side view of the wine carrier of FIG. 1;

FIG. 6 is a left side view of the wine carrier of FIG. 1;

FIG. 7 is a bottom view of the wine carrier of FIG. 1;

FIG. 8 is a top view of the wine carrier of FIG. 1 with handles of the wine carrier extended outward to show additional detail of a closure mechanism for the wine carrier; and,

FIG. 9 is a top view of the wine carrier of FIG. 1 with the handles placed adjacent to the front and rear panels of the wine carrier, thereby fully exposing the opening of the wine carrier to show additional detail of the wine carrier and a divider for the wine carrier.










