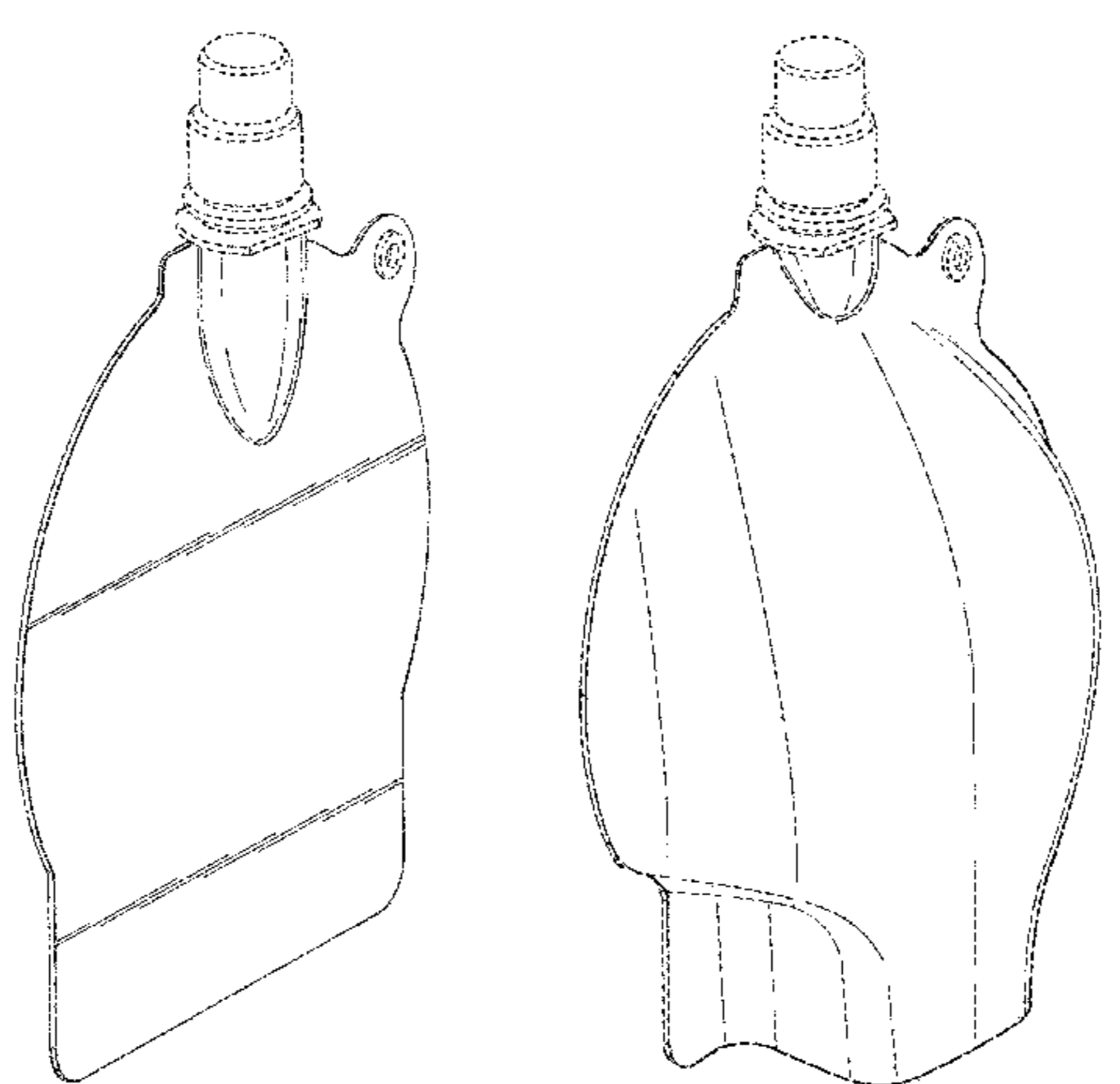

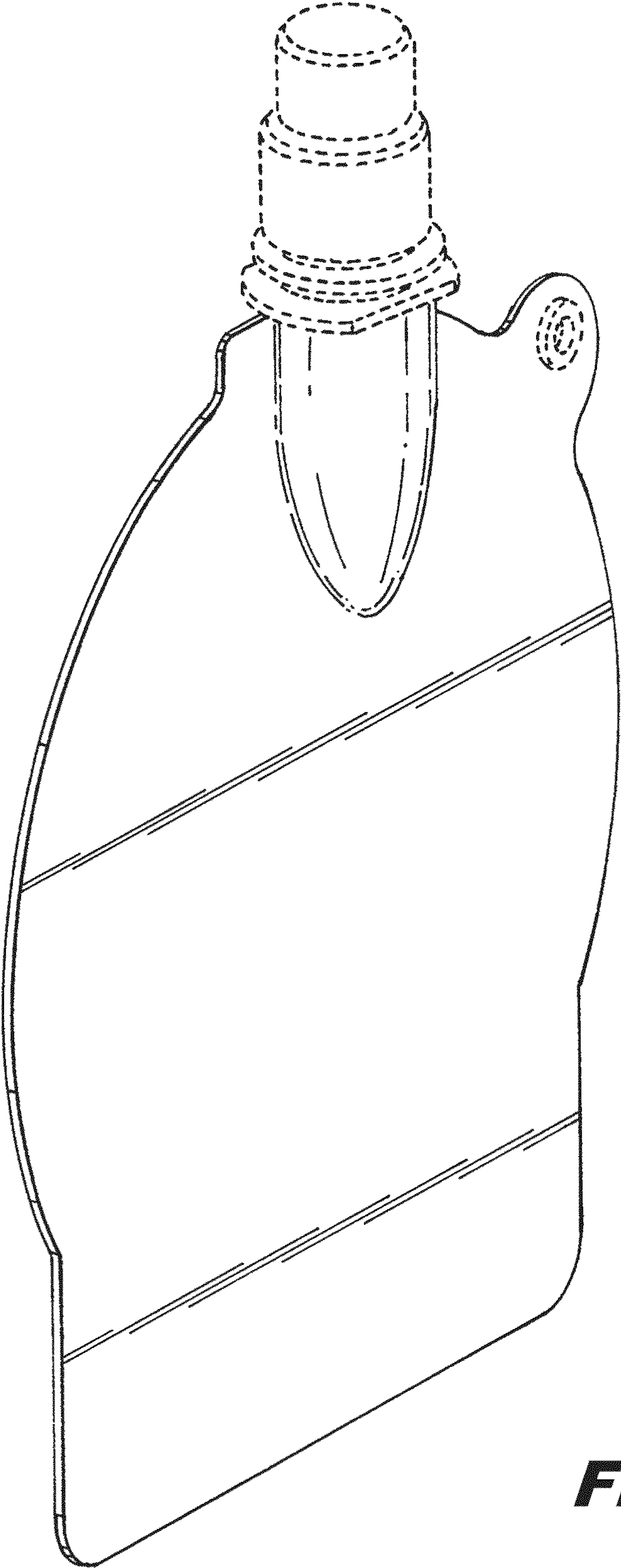
The ornamental design for a beverage pouch, as shown and described.

**DESCRIPTION**

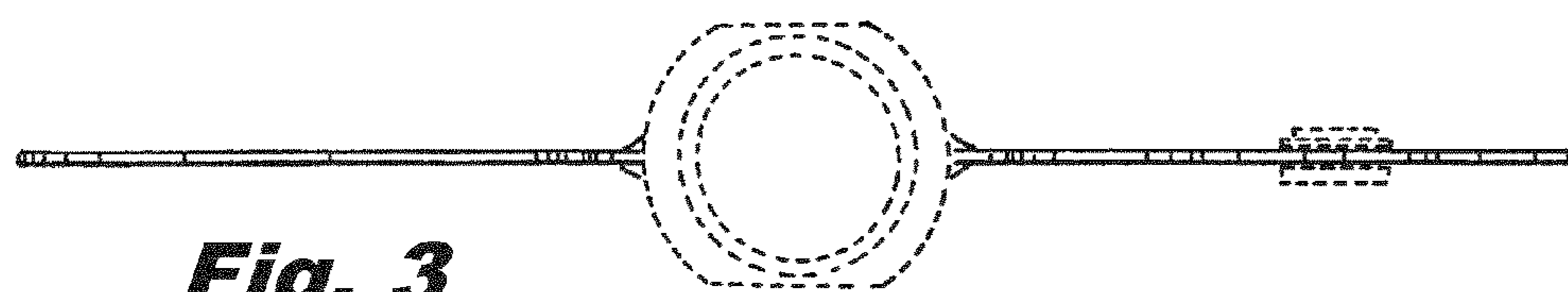
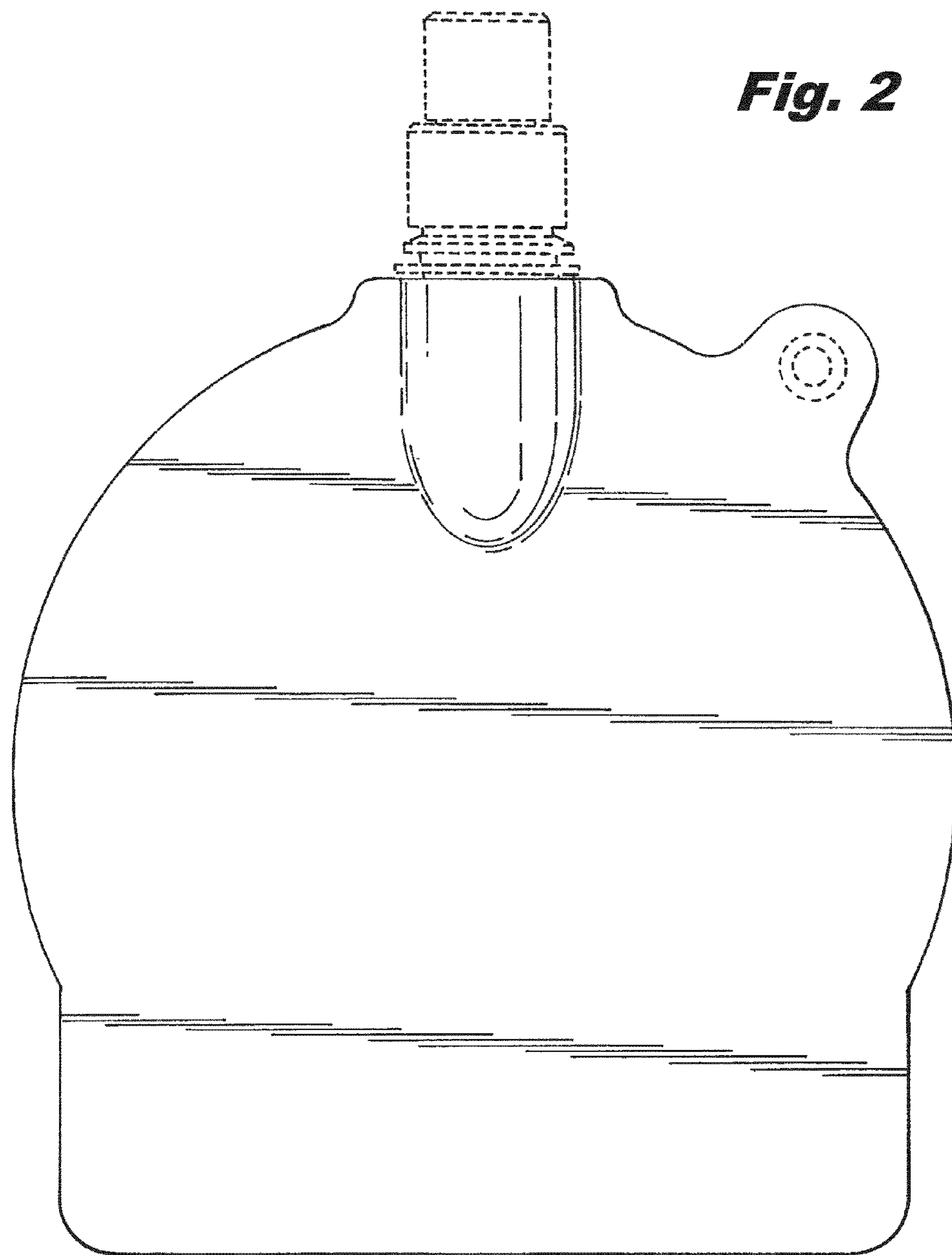
FIG. 1 is a perspective view of a first embodiment of the beverage pouch of the subject invention in an empty condition;

FIG. 12 is a bottom view of the beverage pouch in the condition shown in FIG. 8;

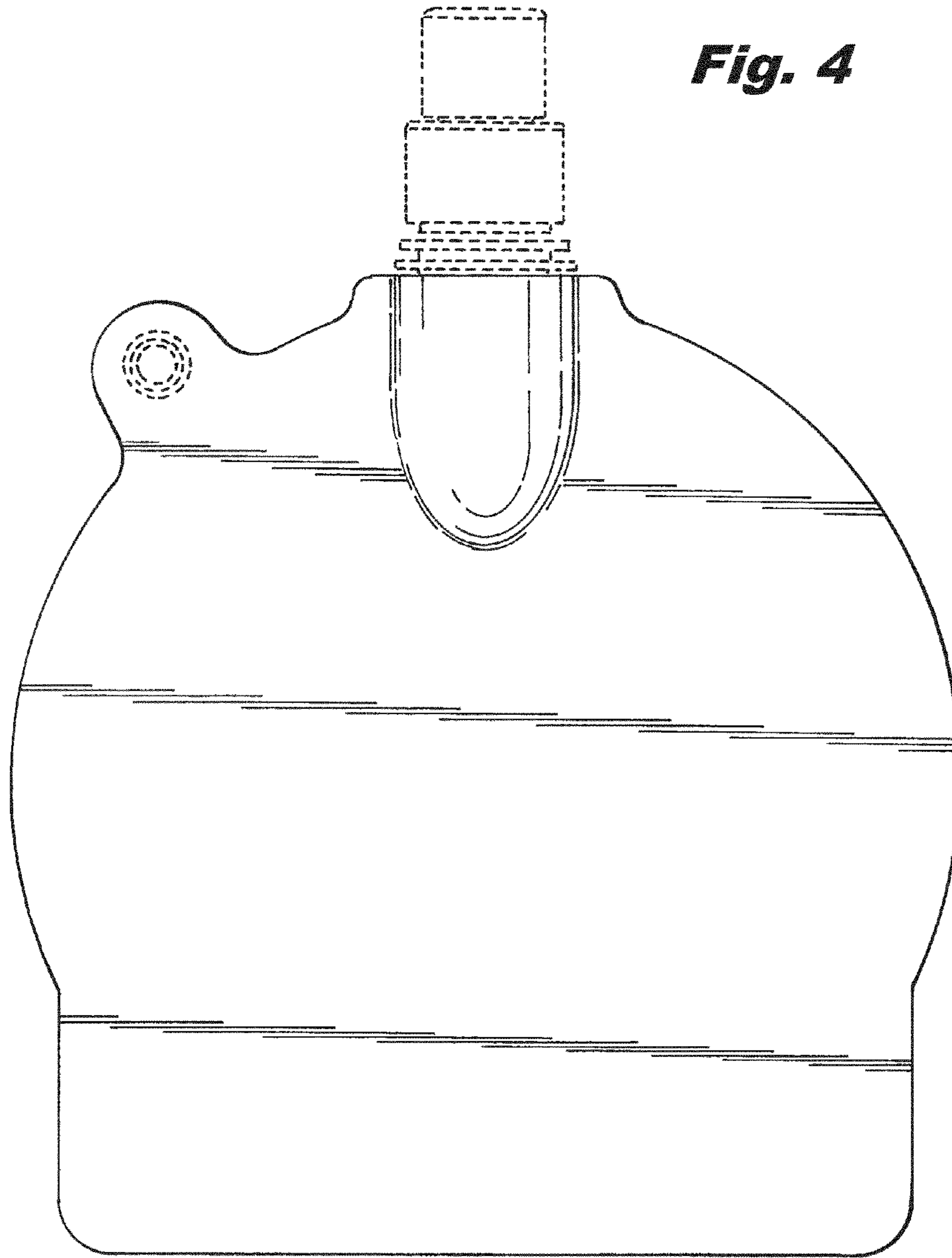
FIG. 13 is a right side view of the beverage pouch in the condition shown in FIG. 8;

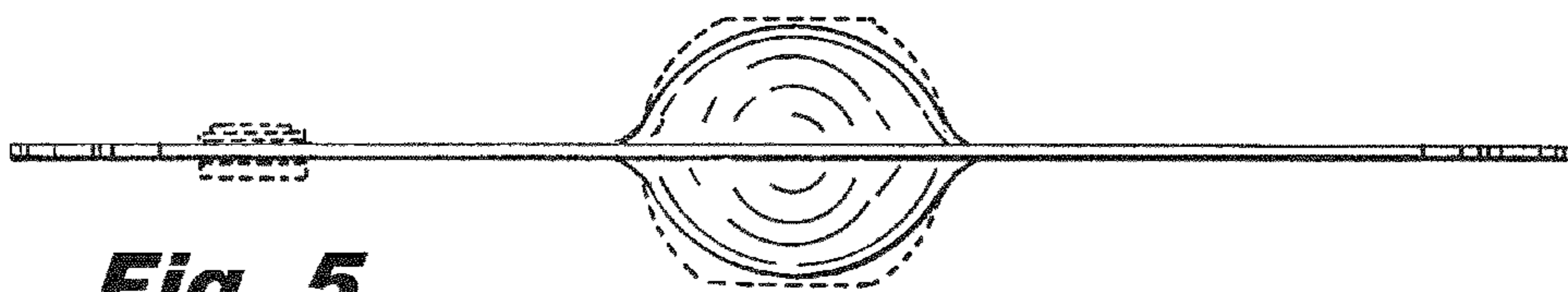

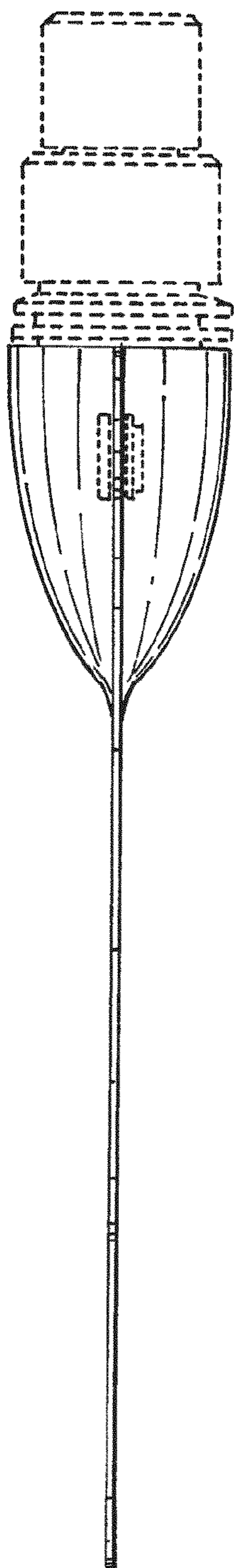




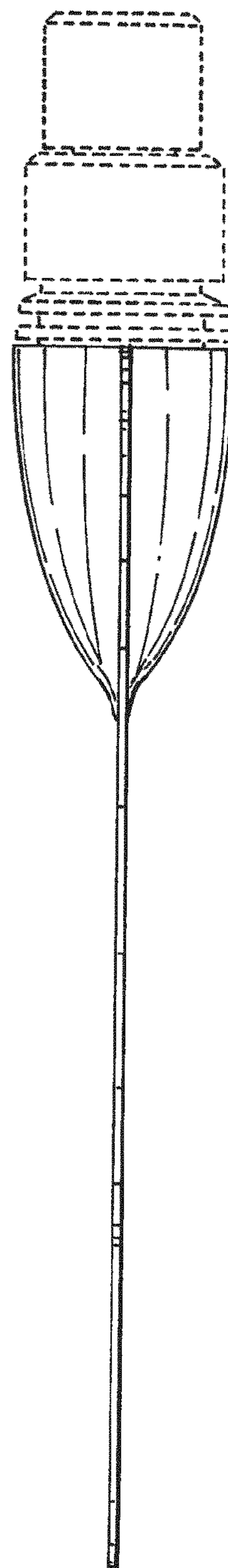

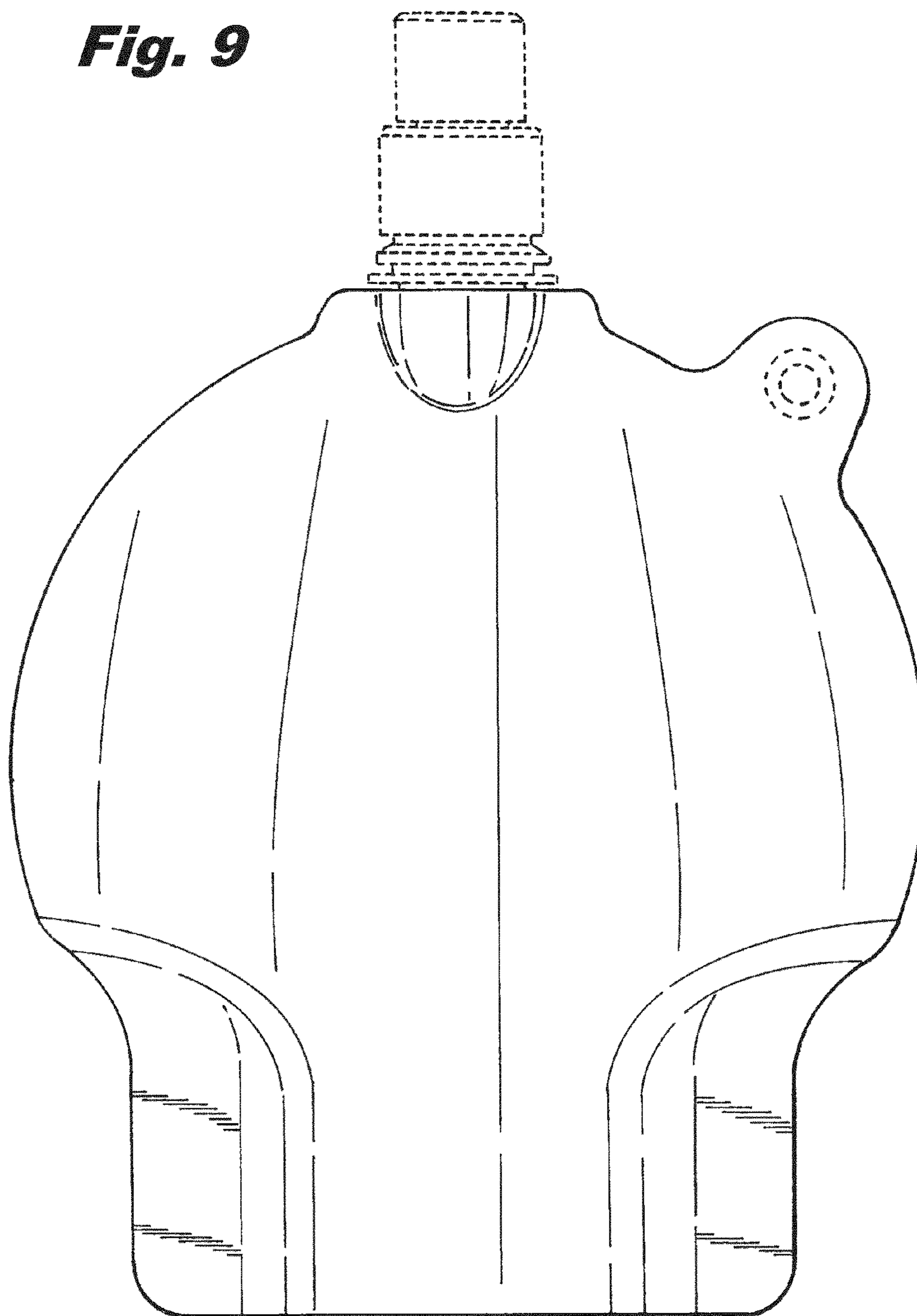

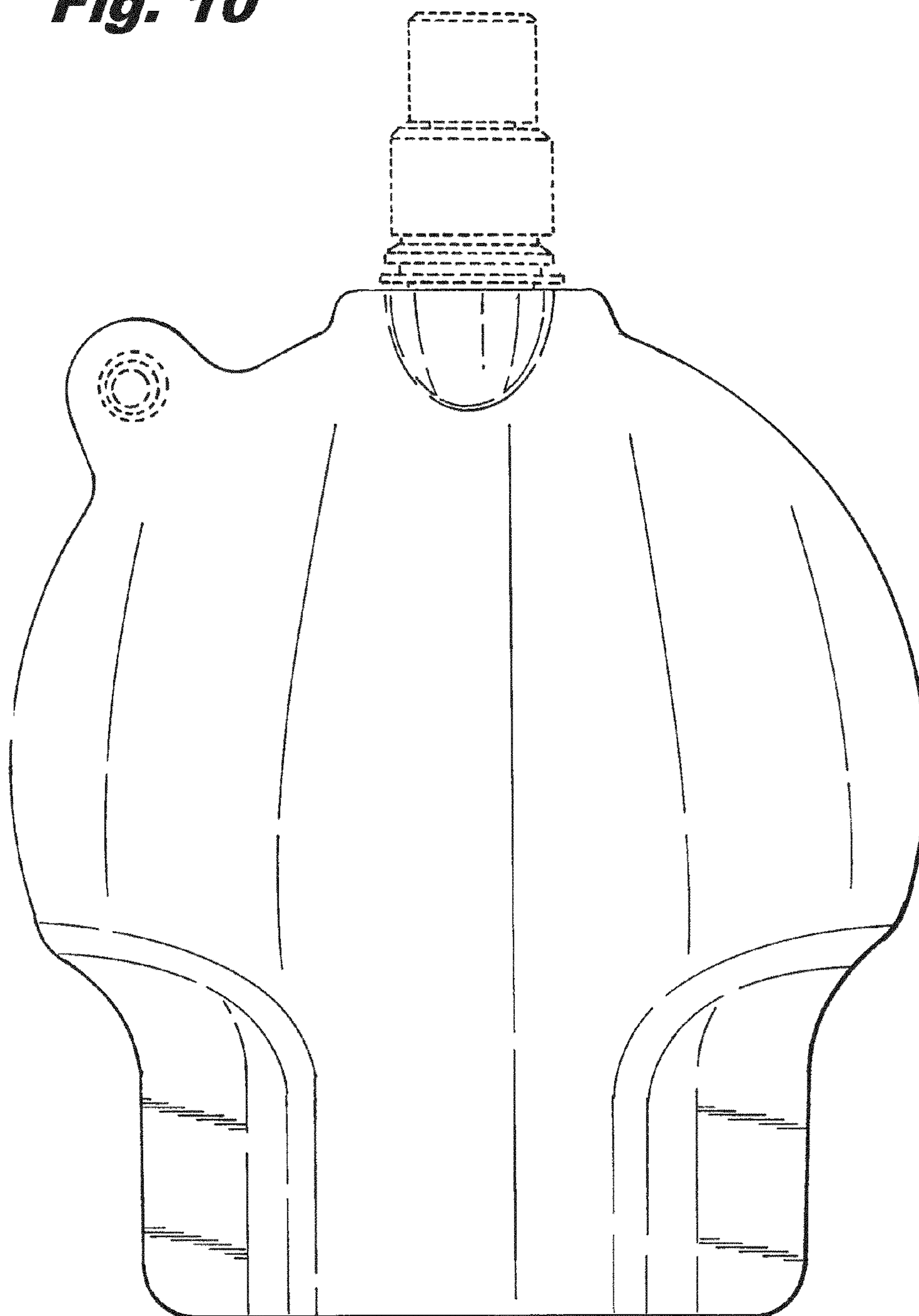

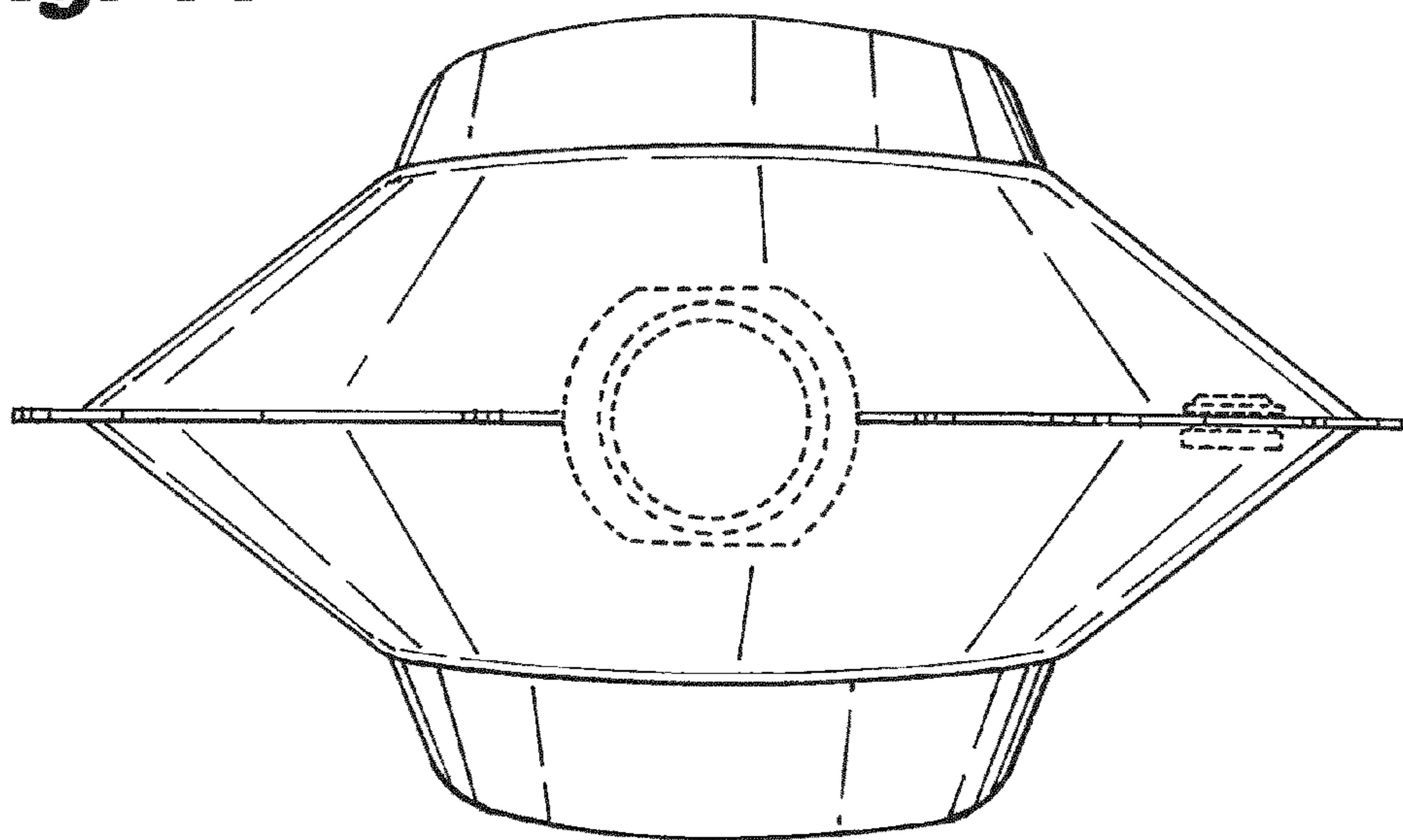




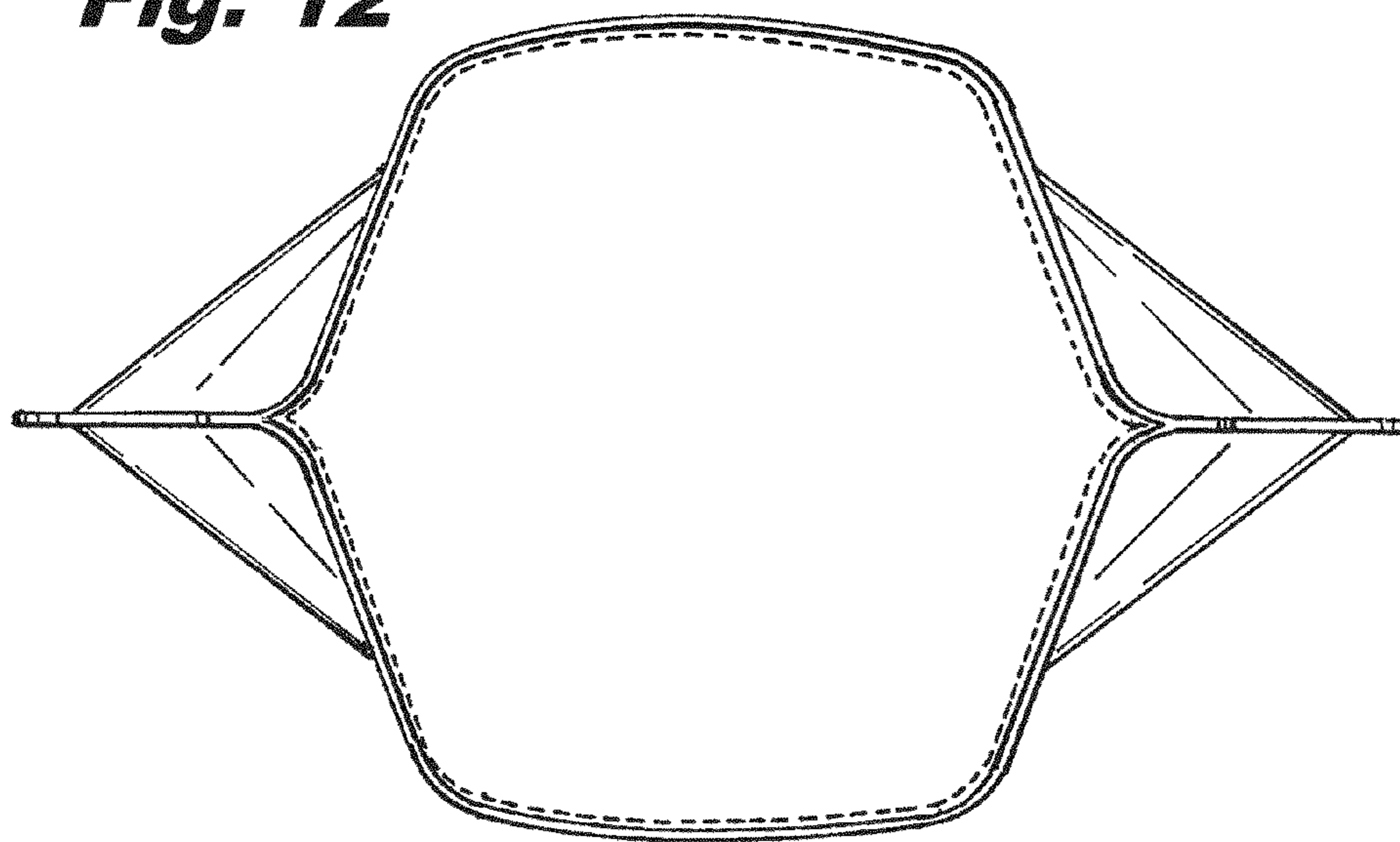

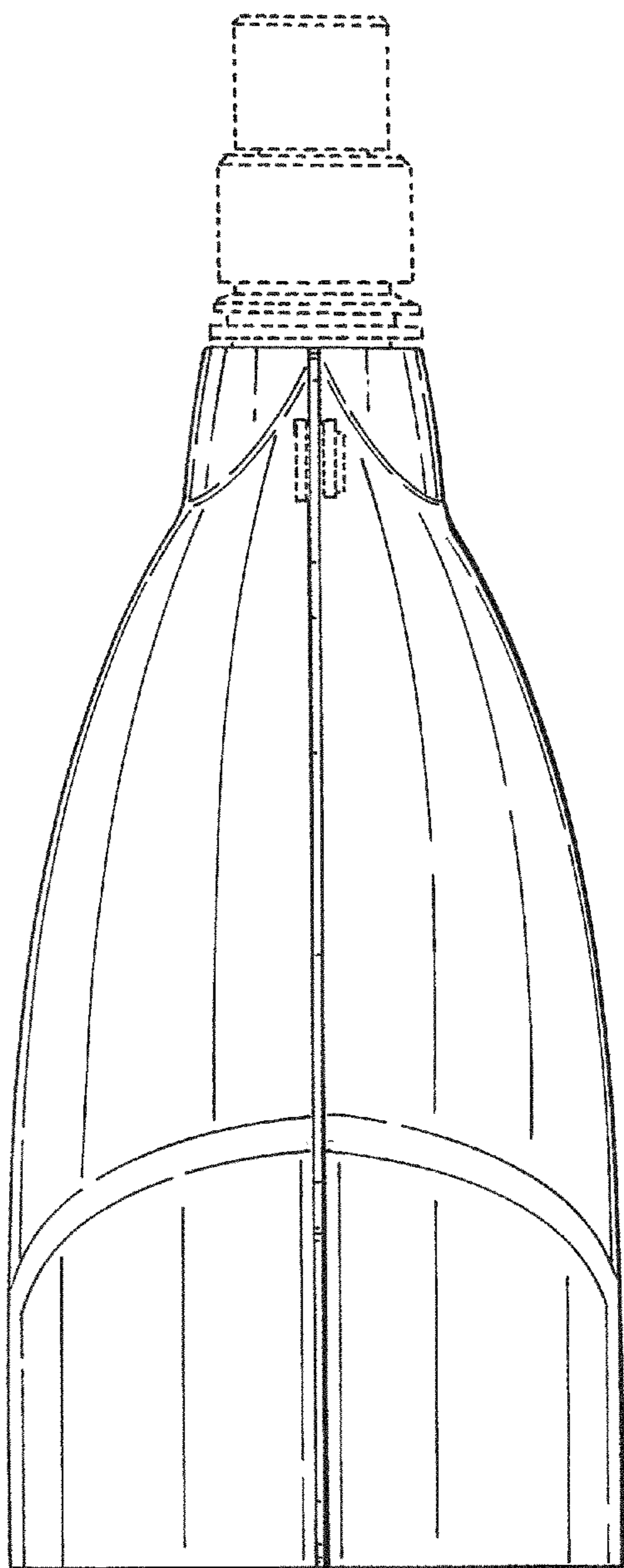

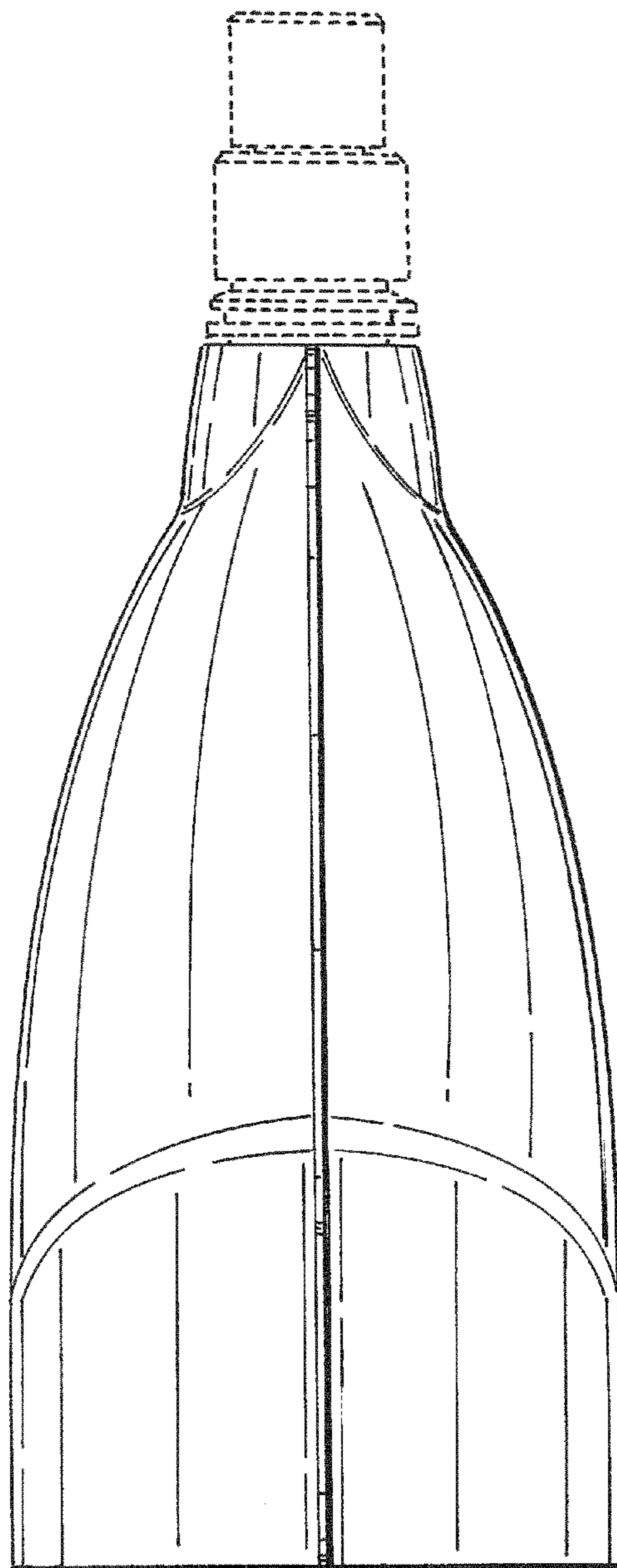

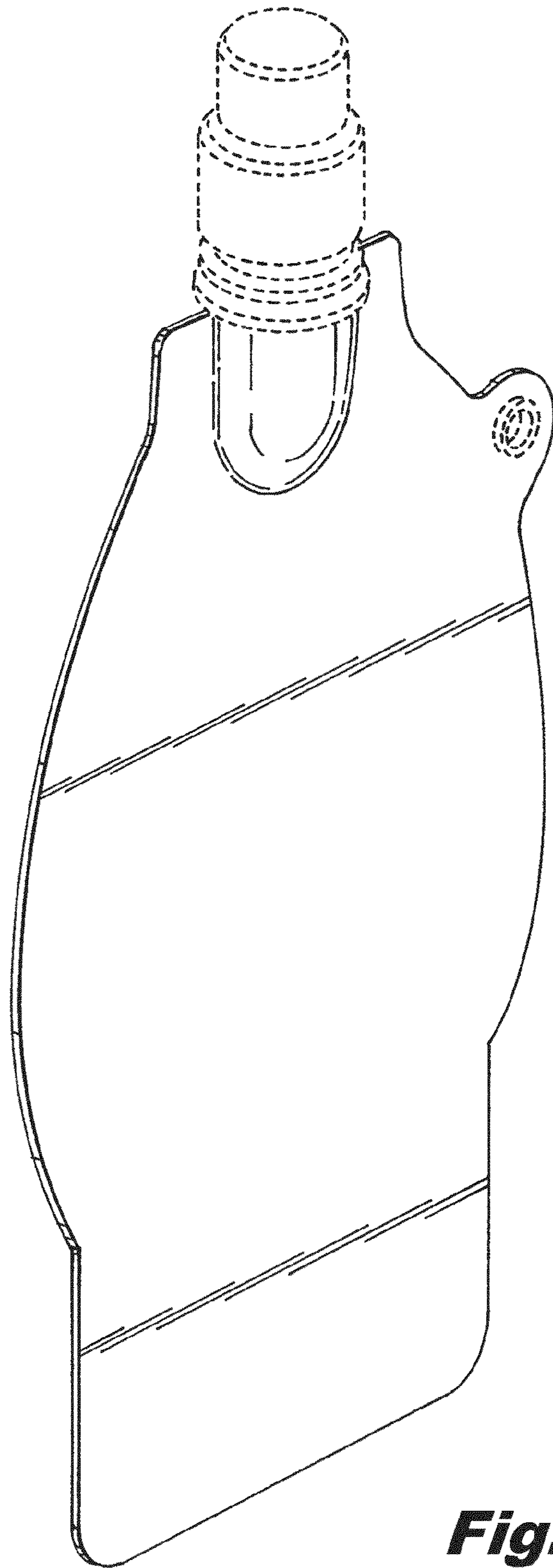

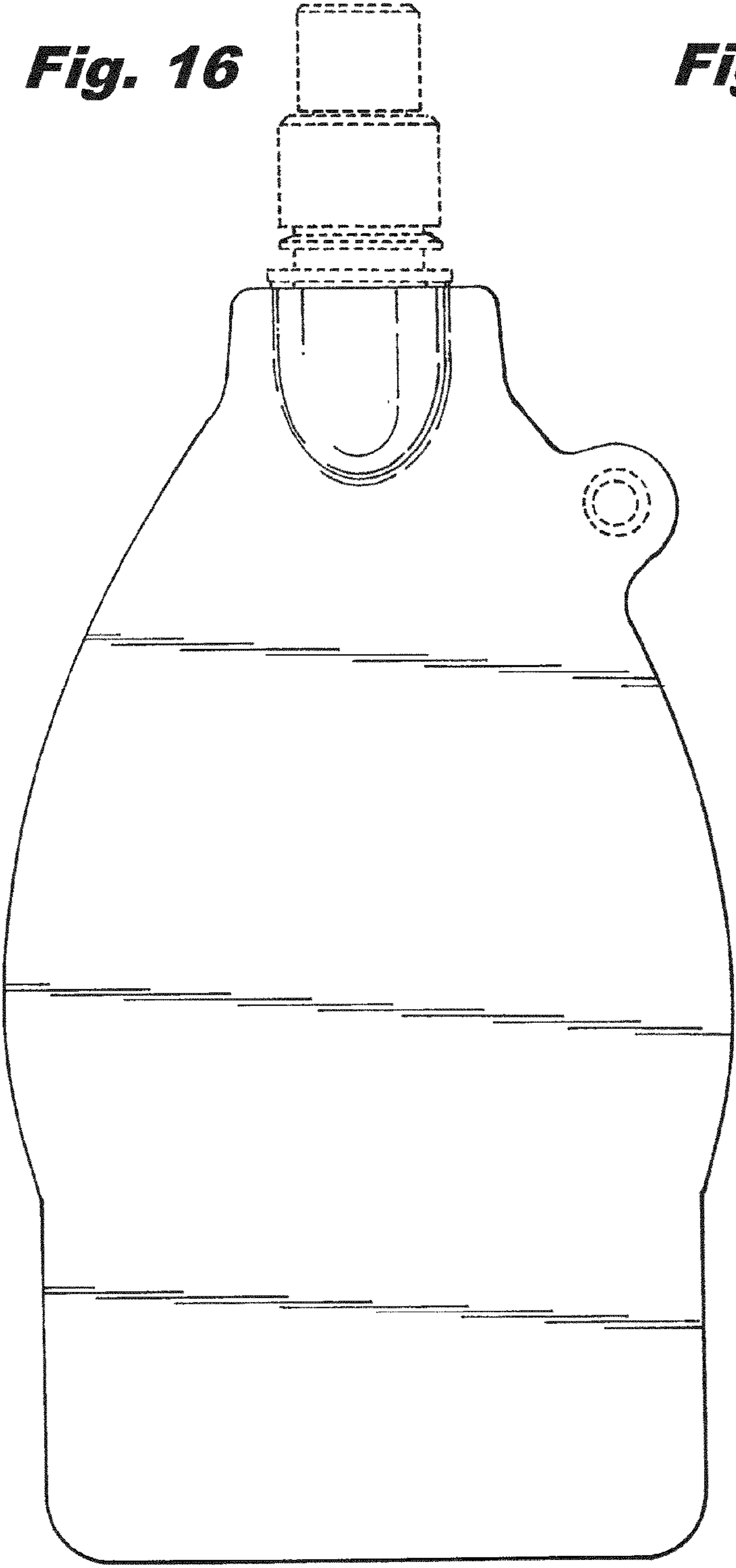

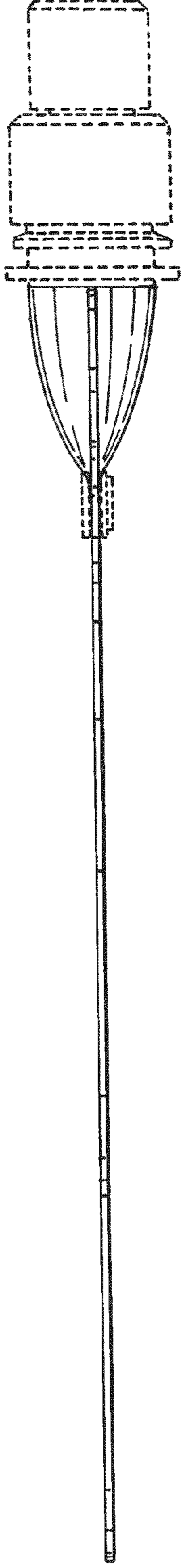


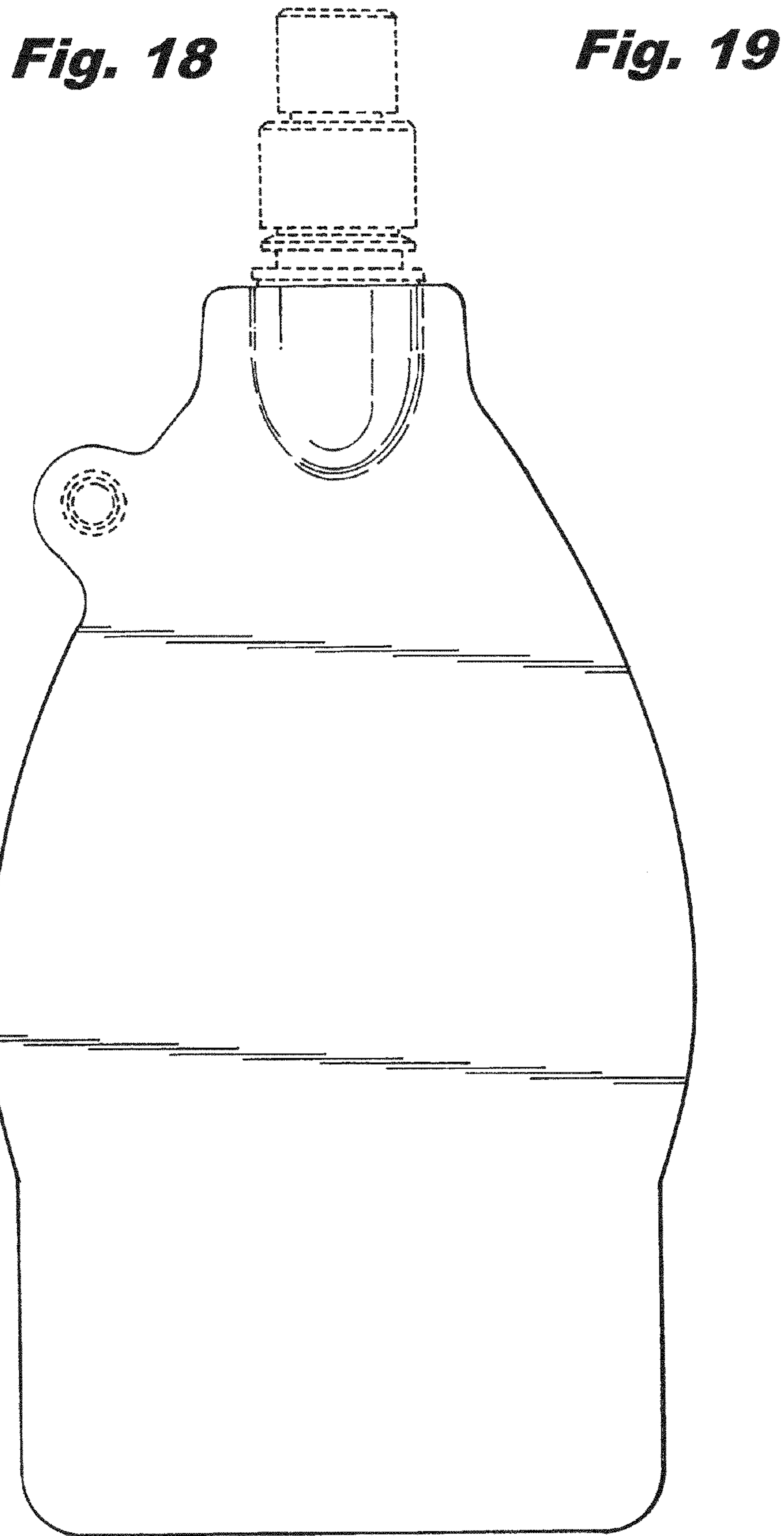

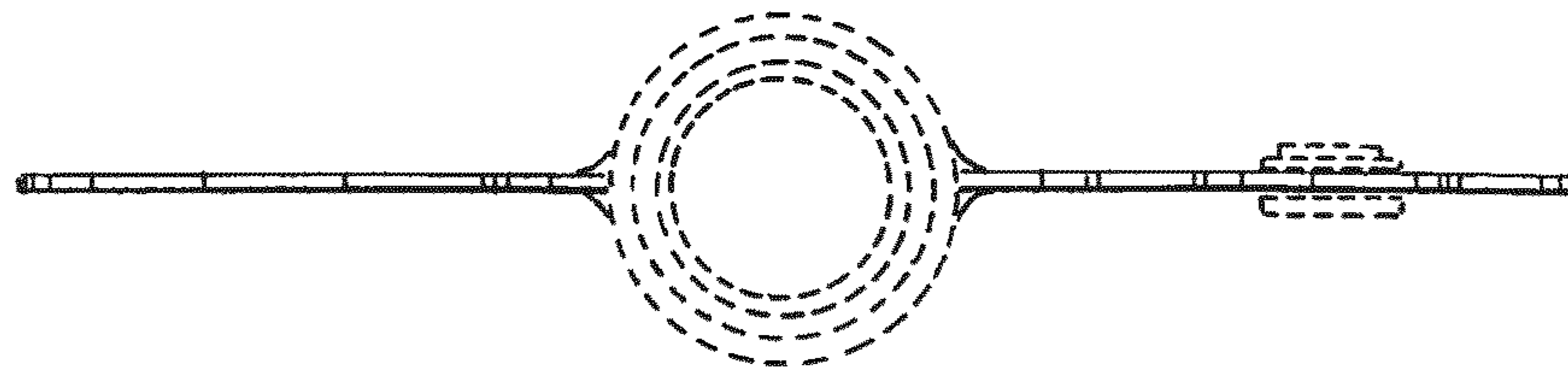

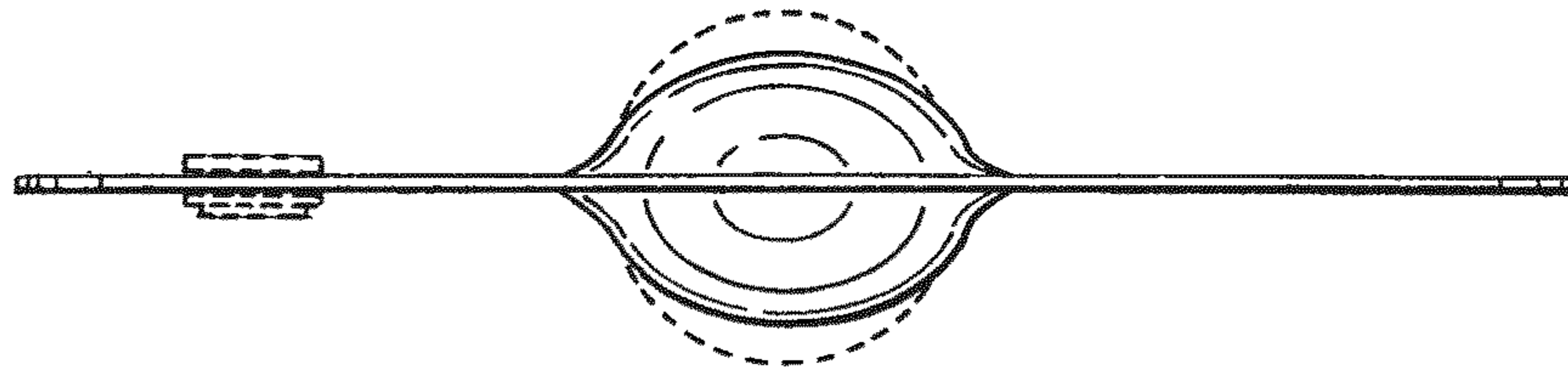

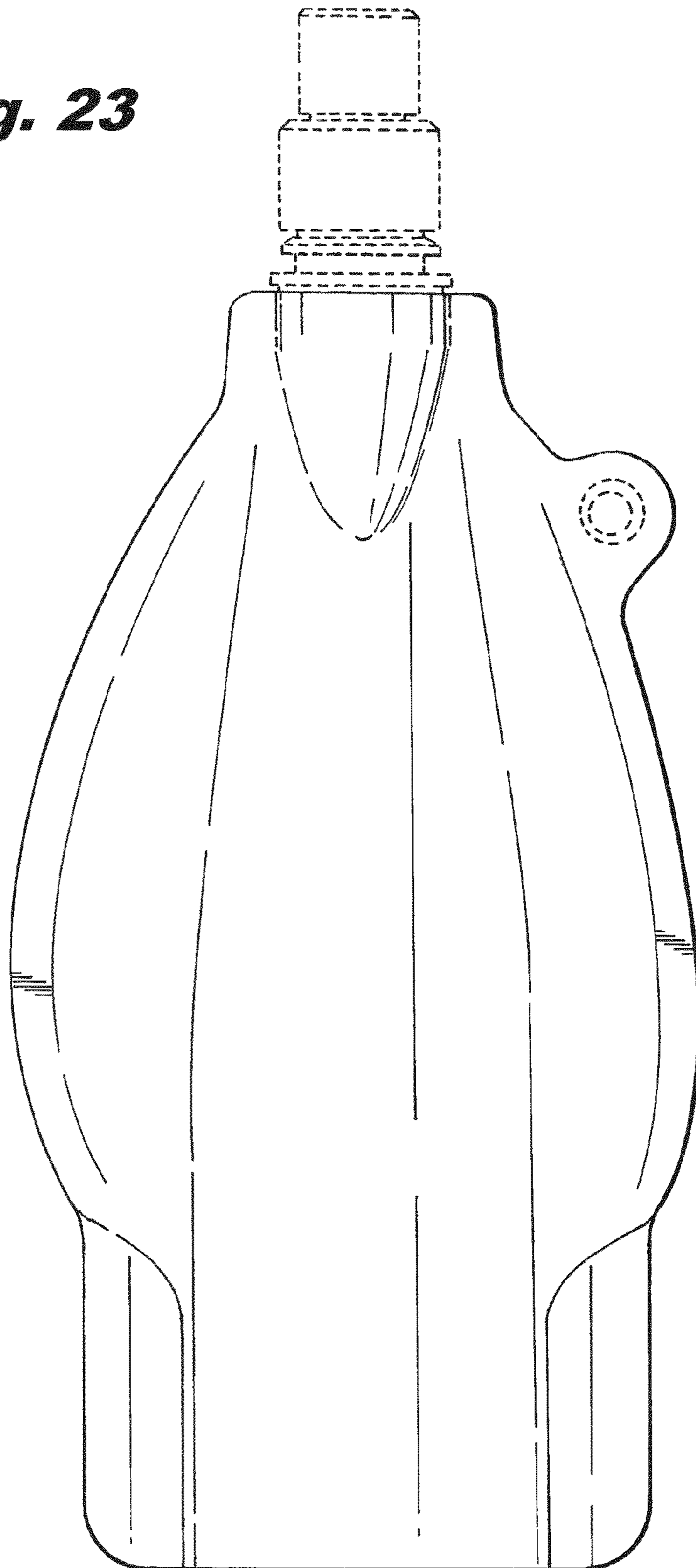
***Fig. 21***

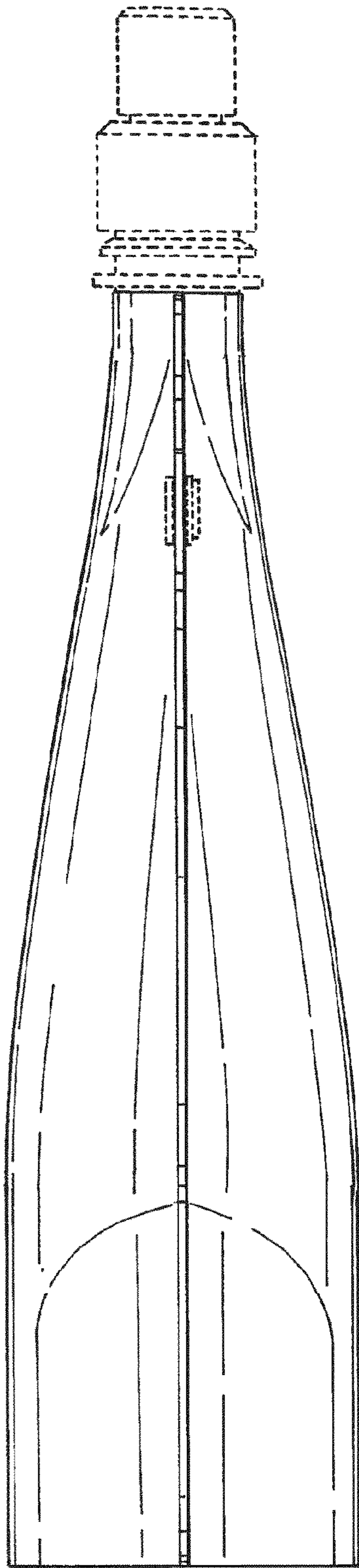

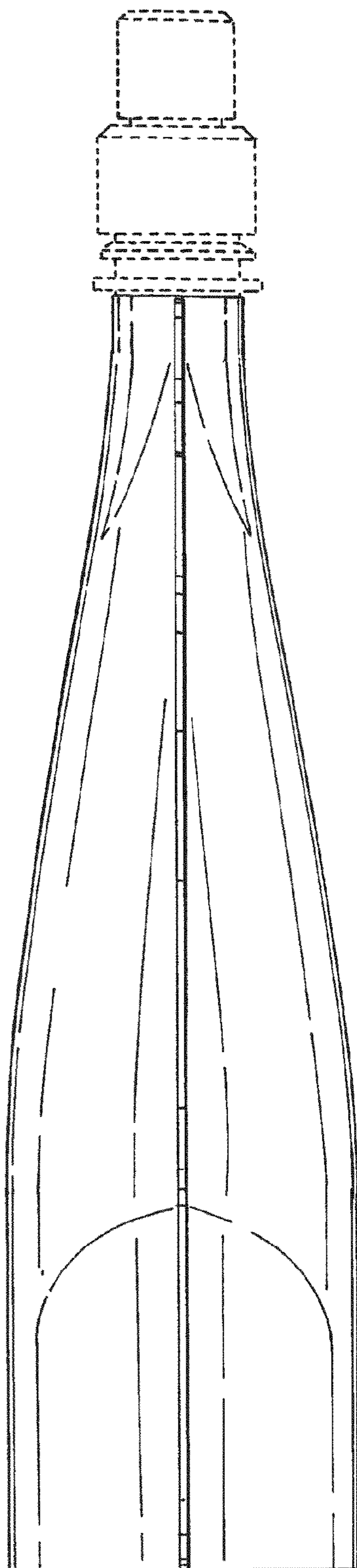




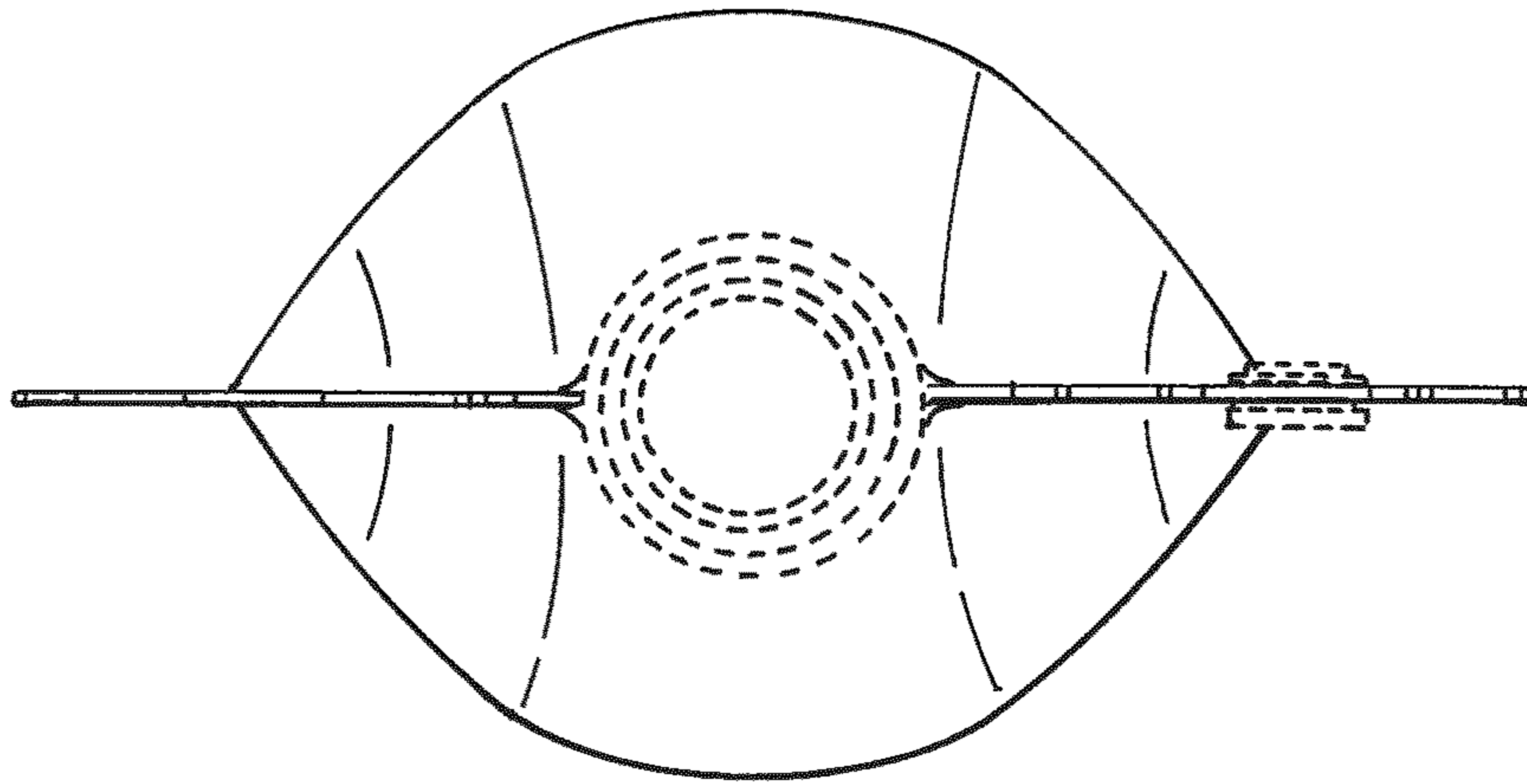

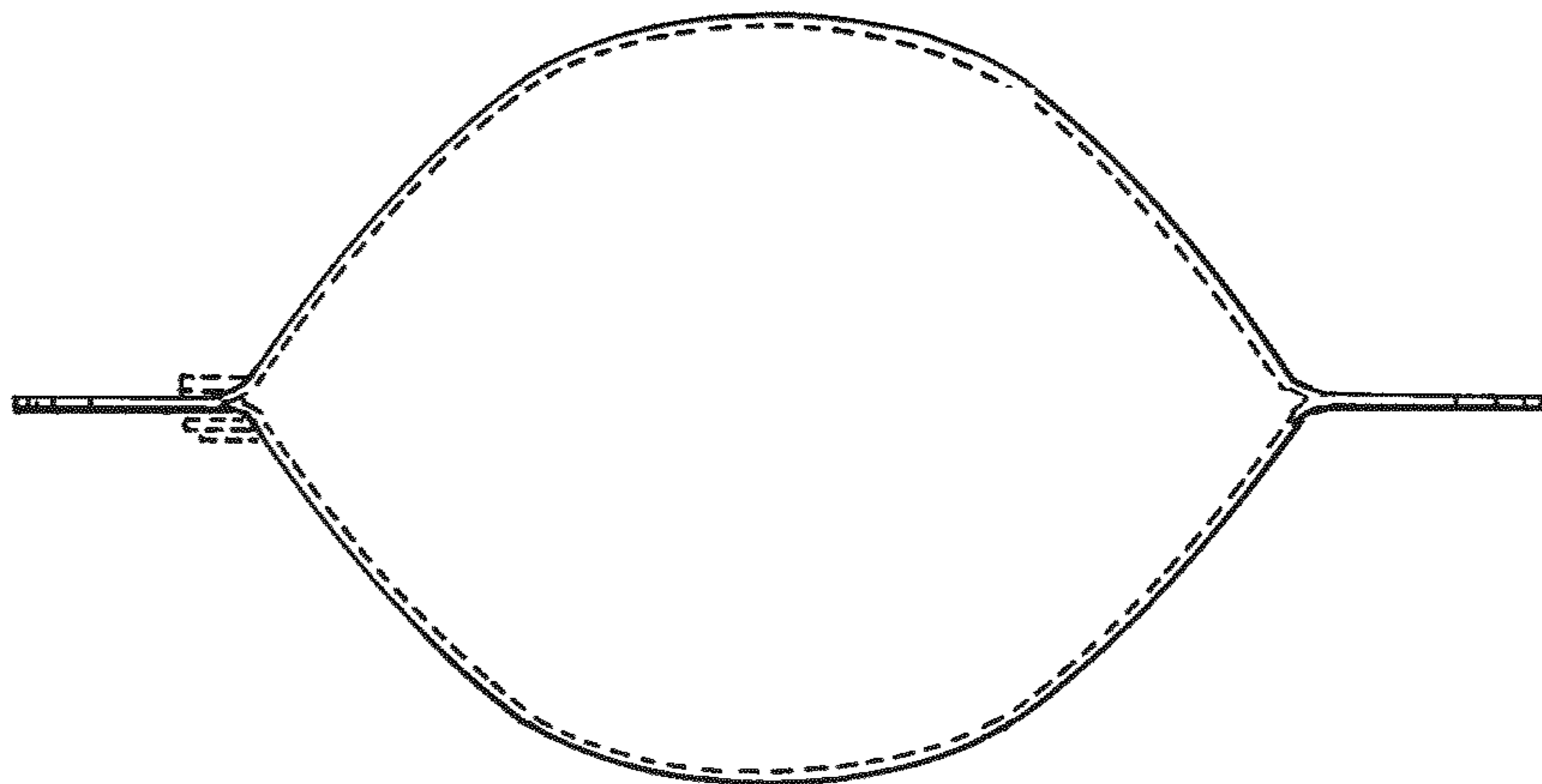
