The ornamental design for audio/video recorder/player equipment, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of an audio/video recorder/player equipment showing our new design;
FIG. 2 is a left side perspective view thereof;
FIG. 3 is a top plan view of central console of audio/video recorder/player thereof, shown separately for clarity;

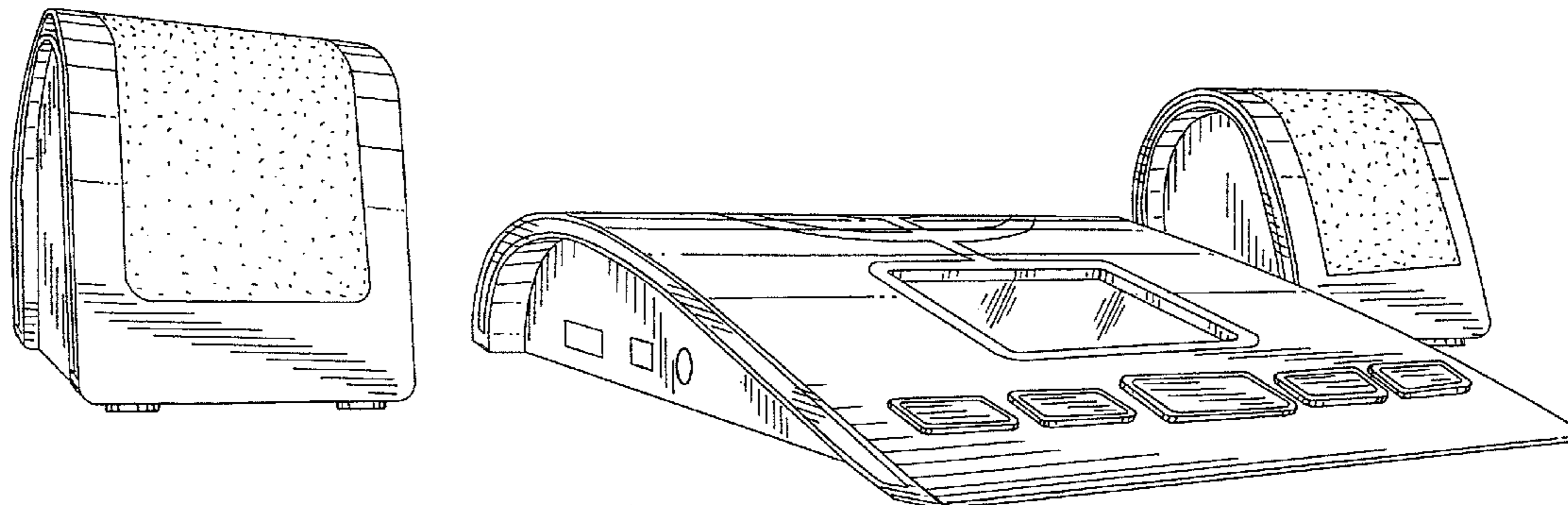

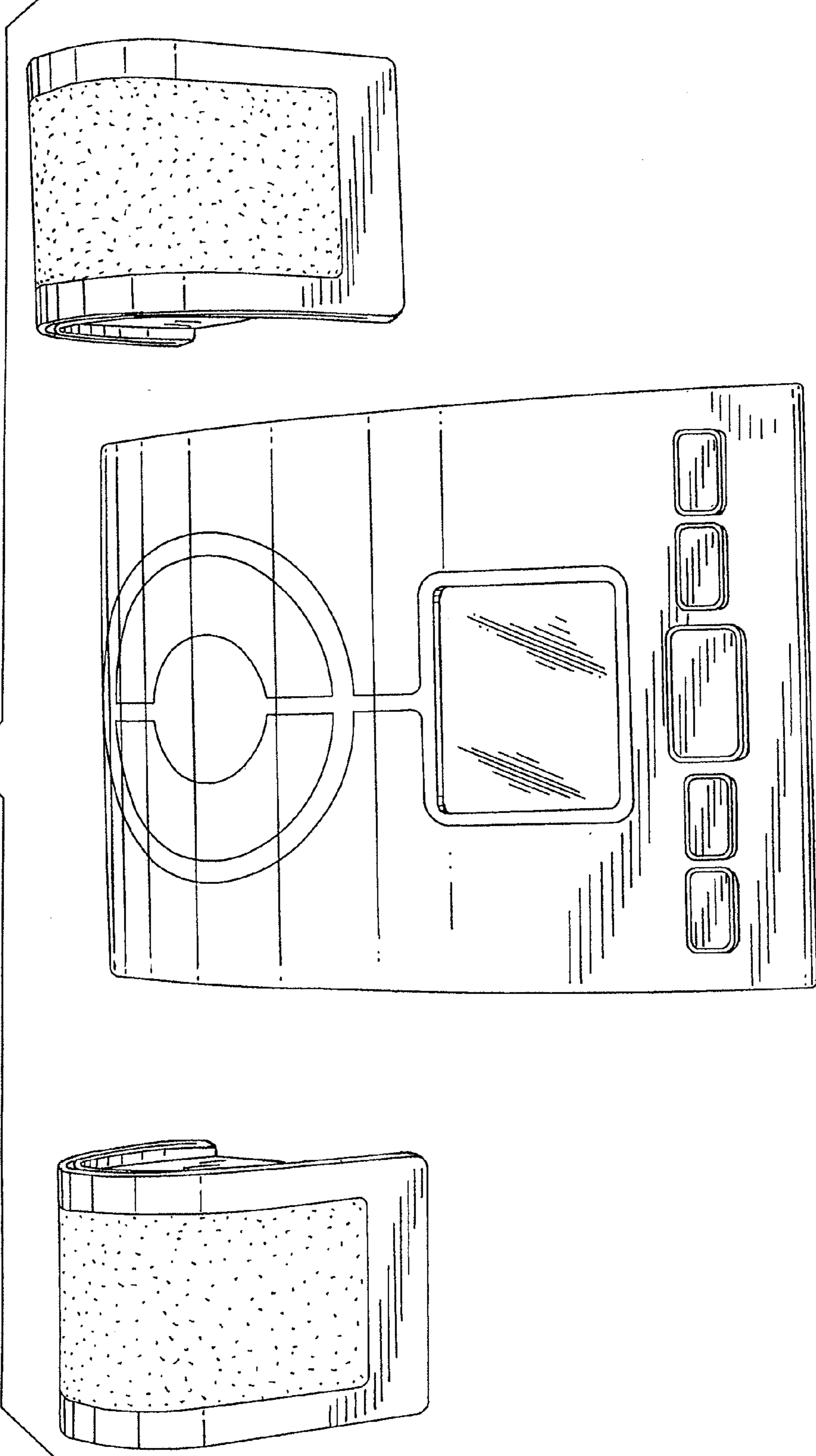
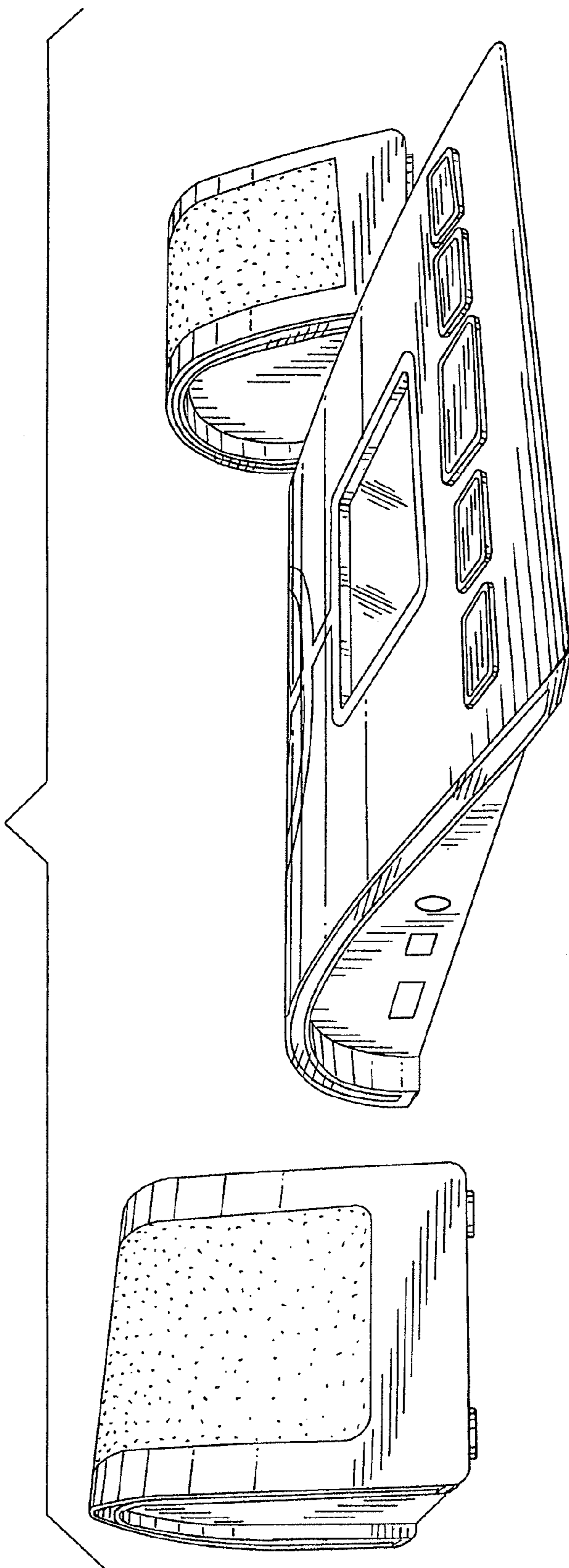

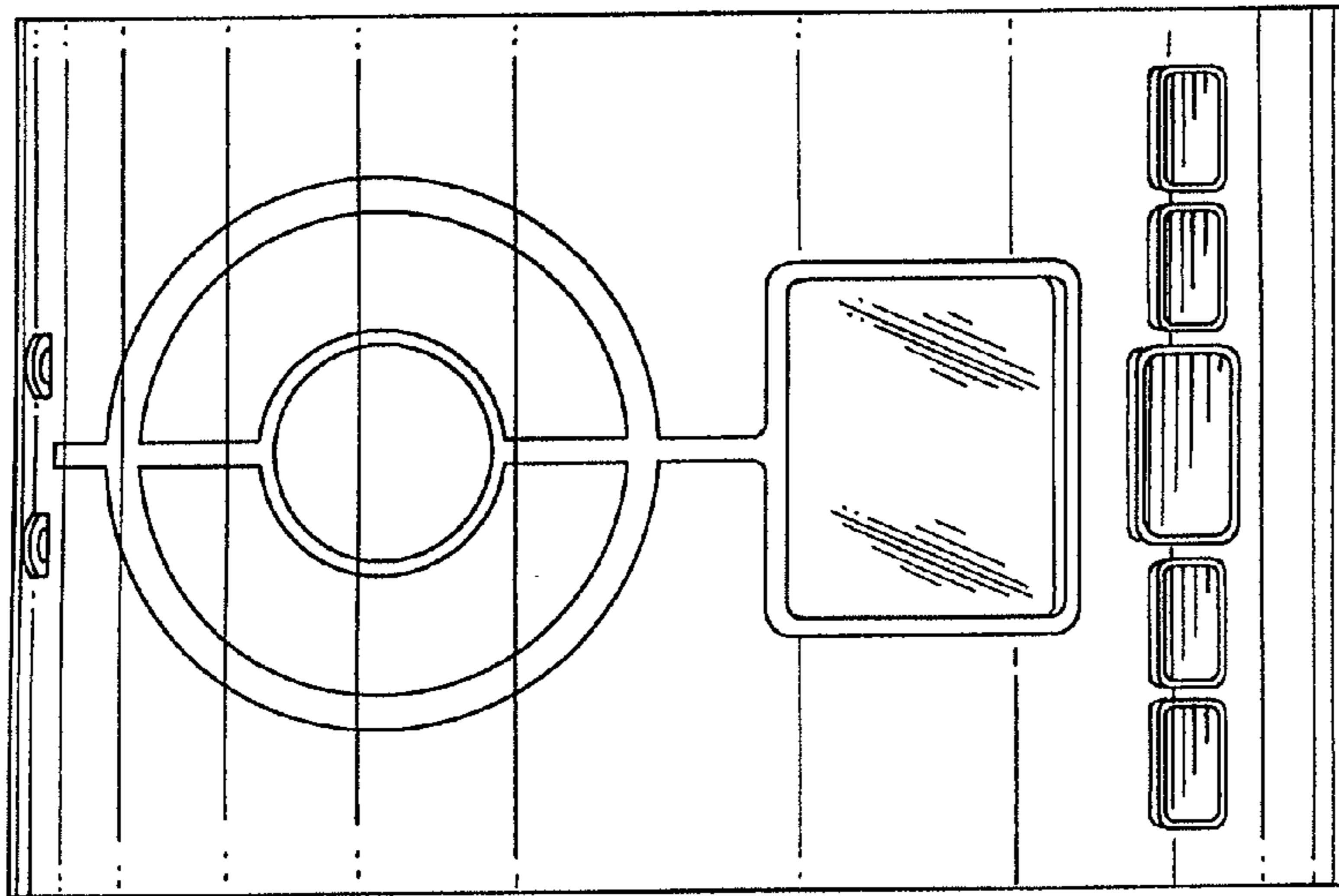

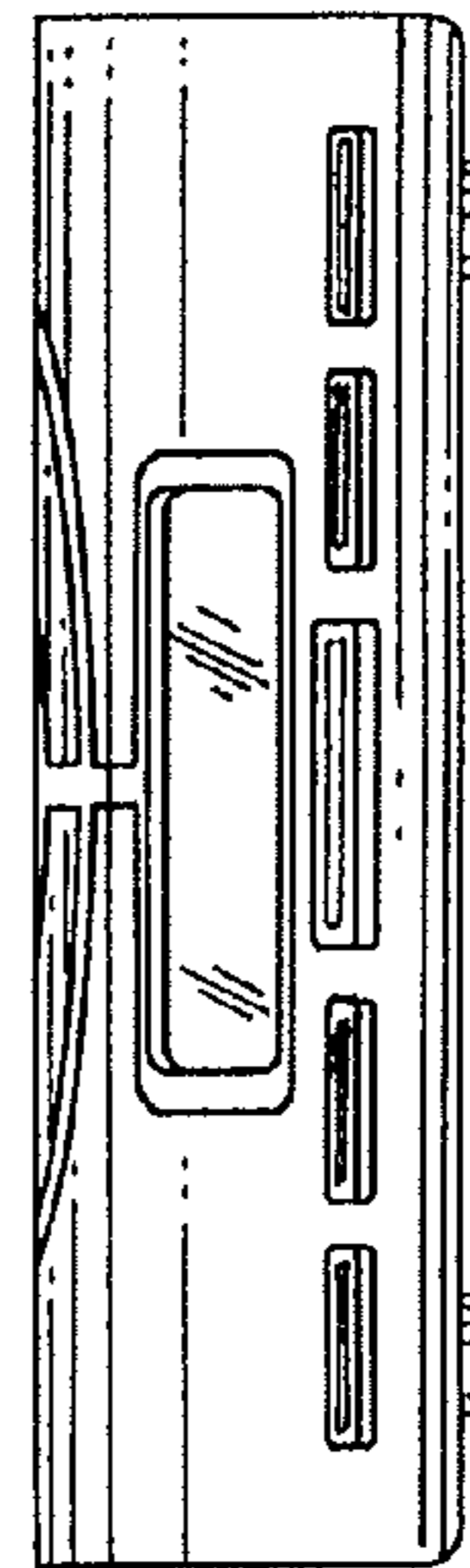

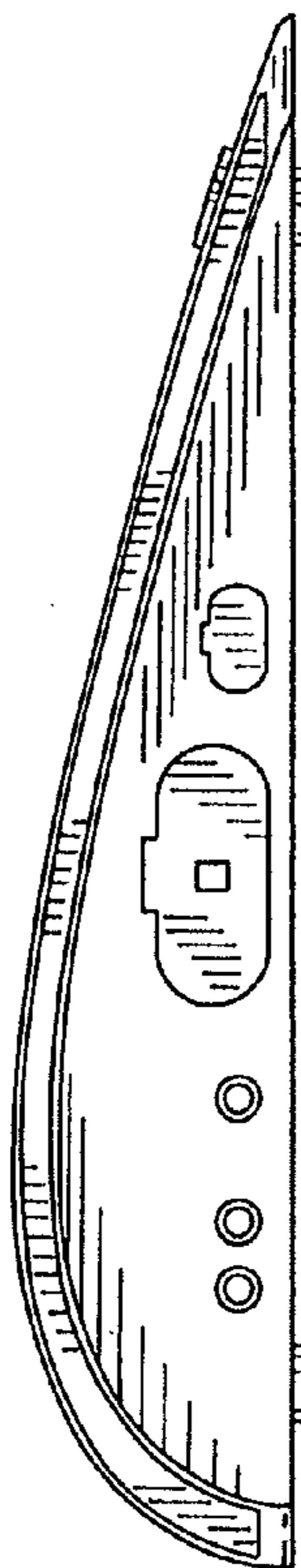

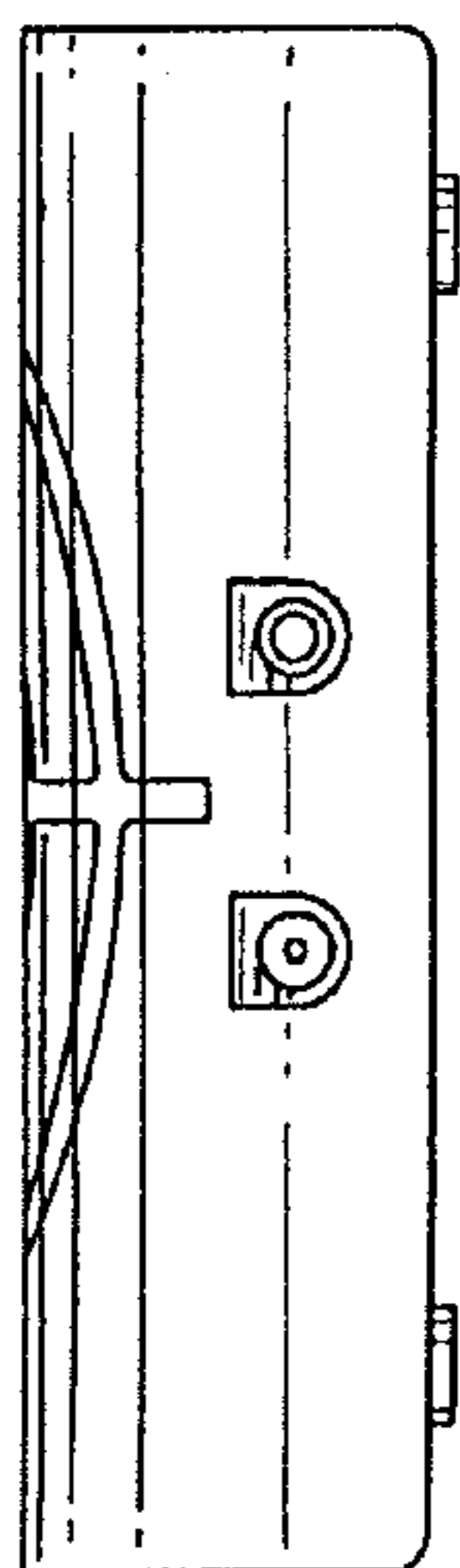

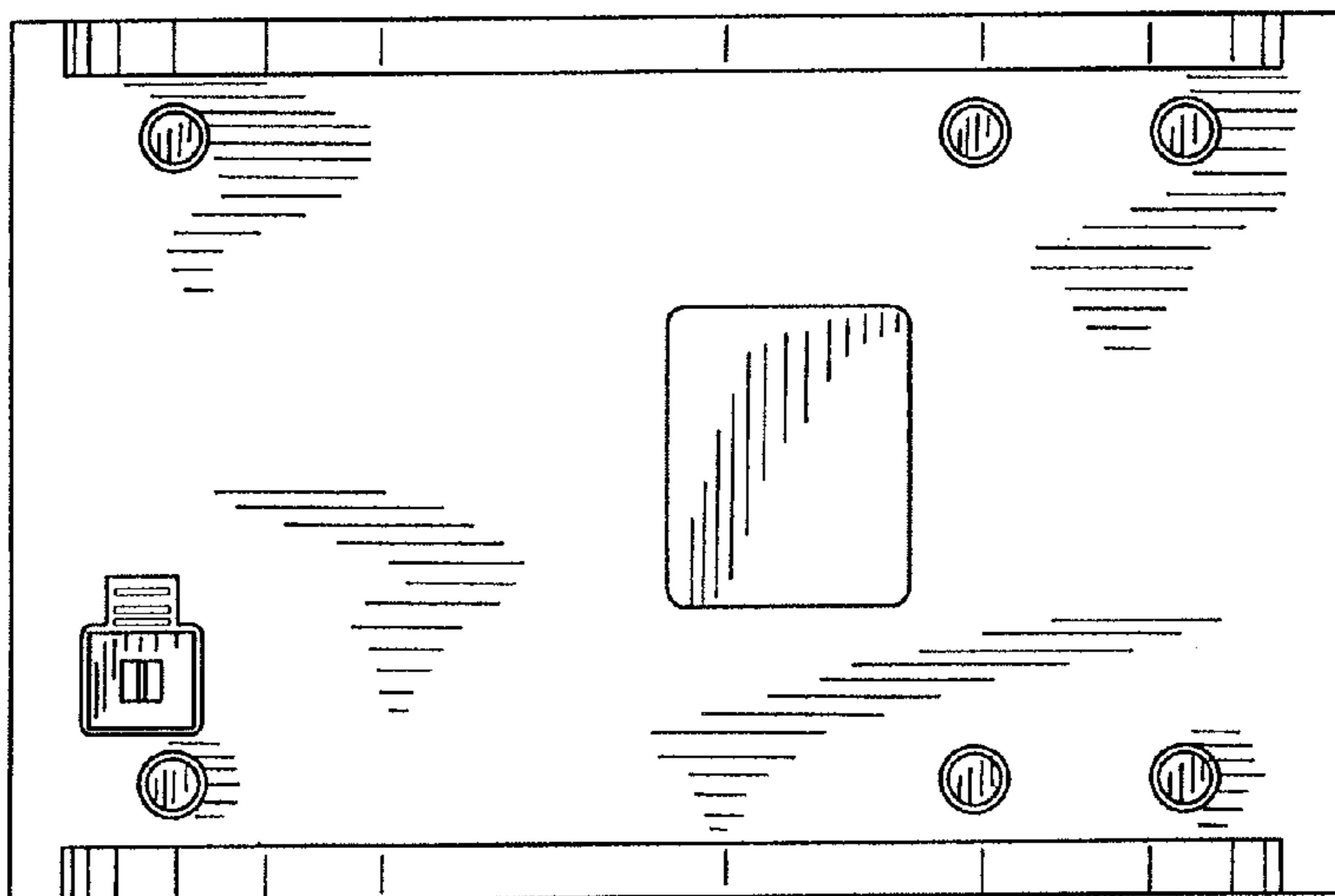

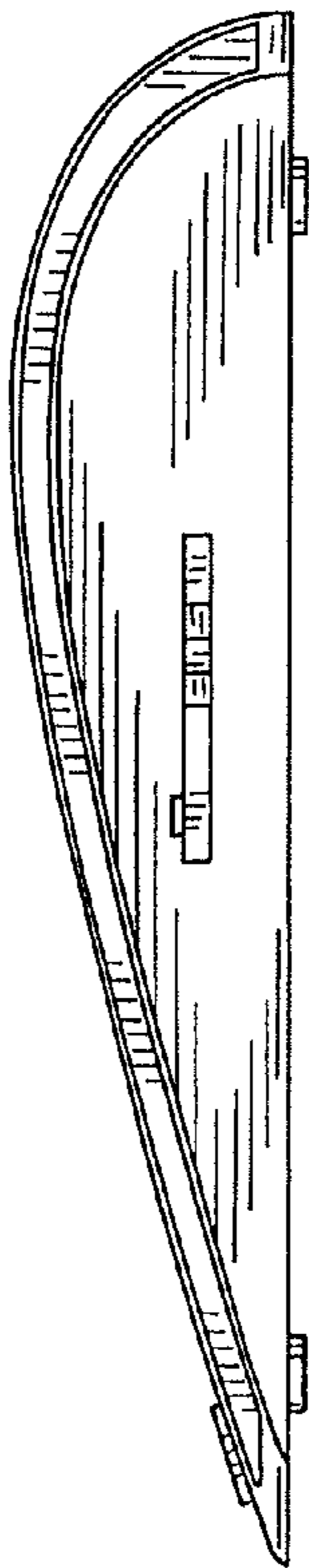

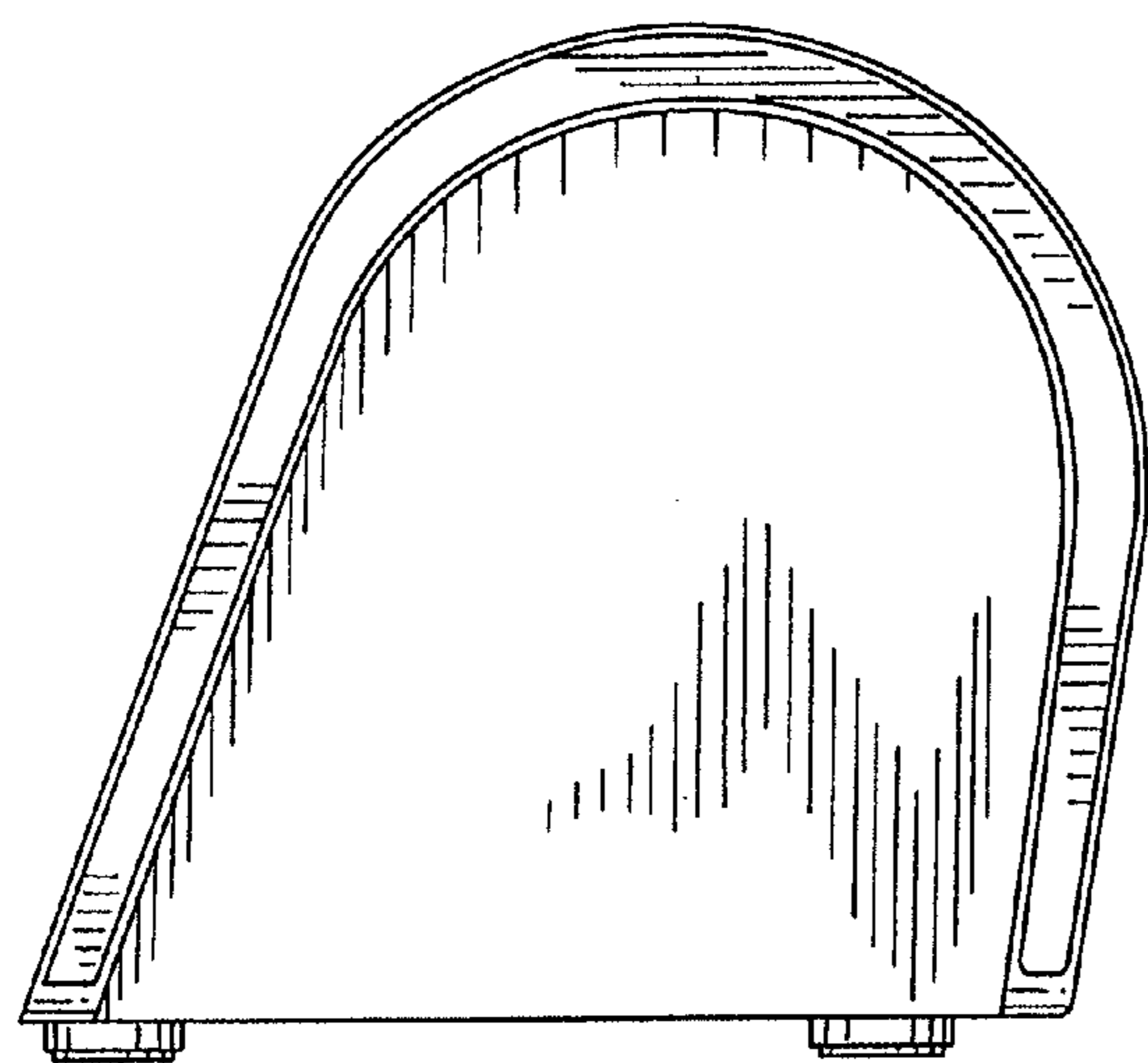
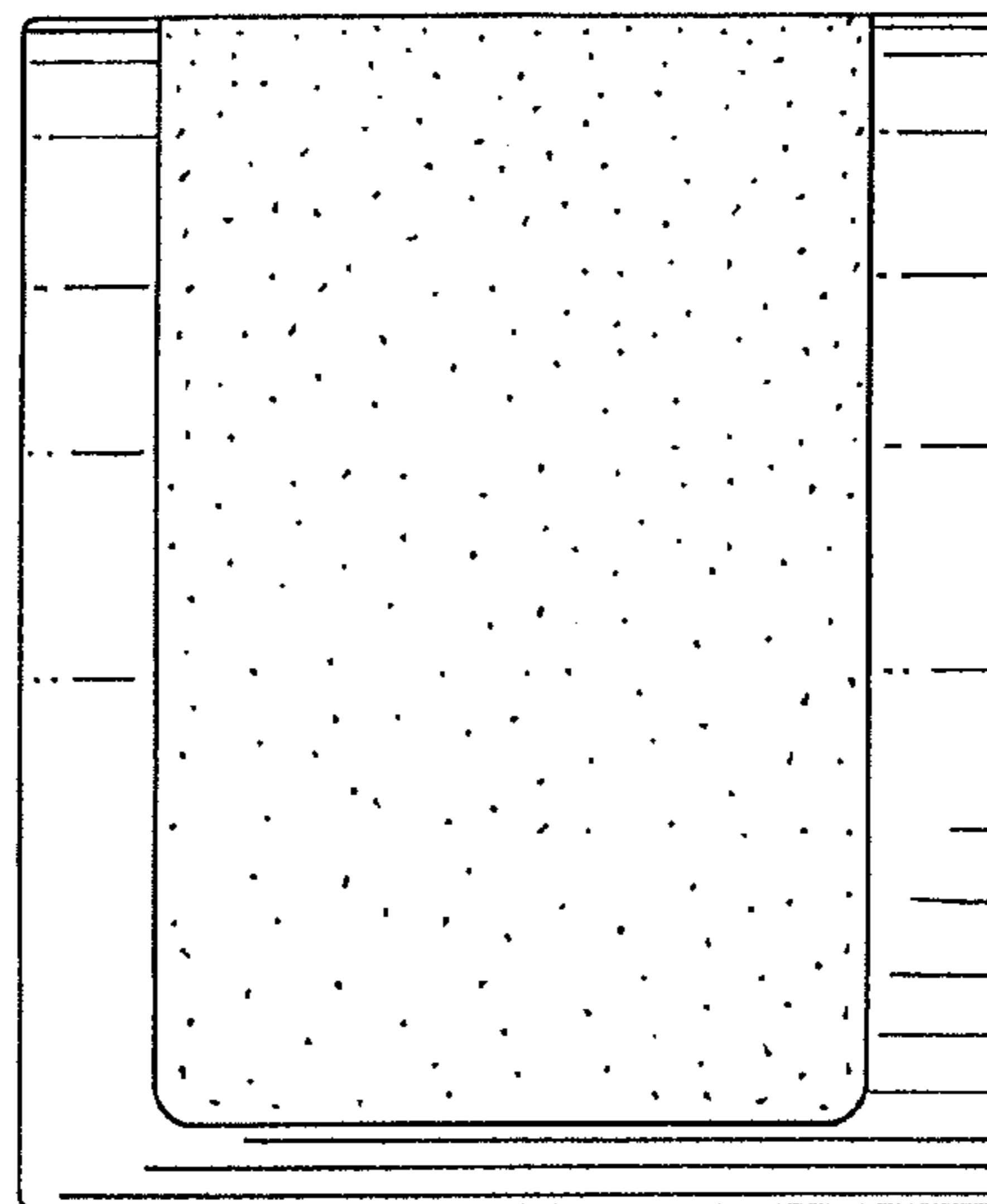

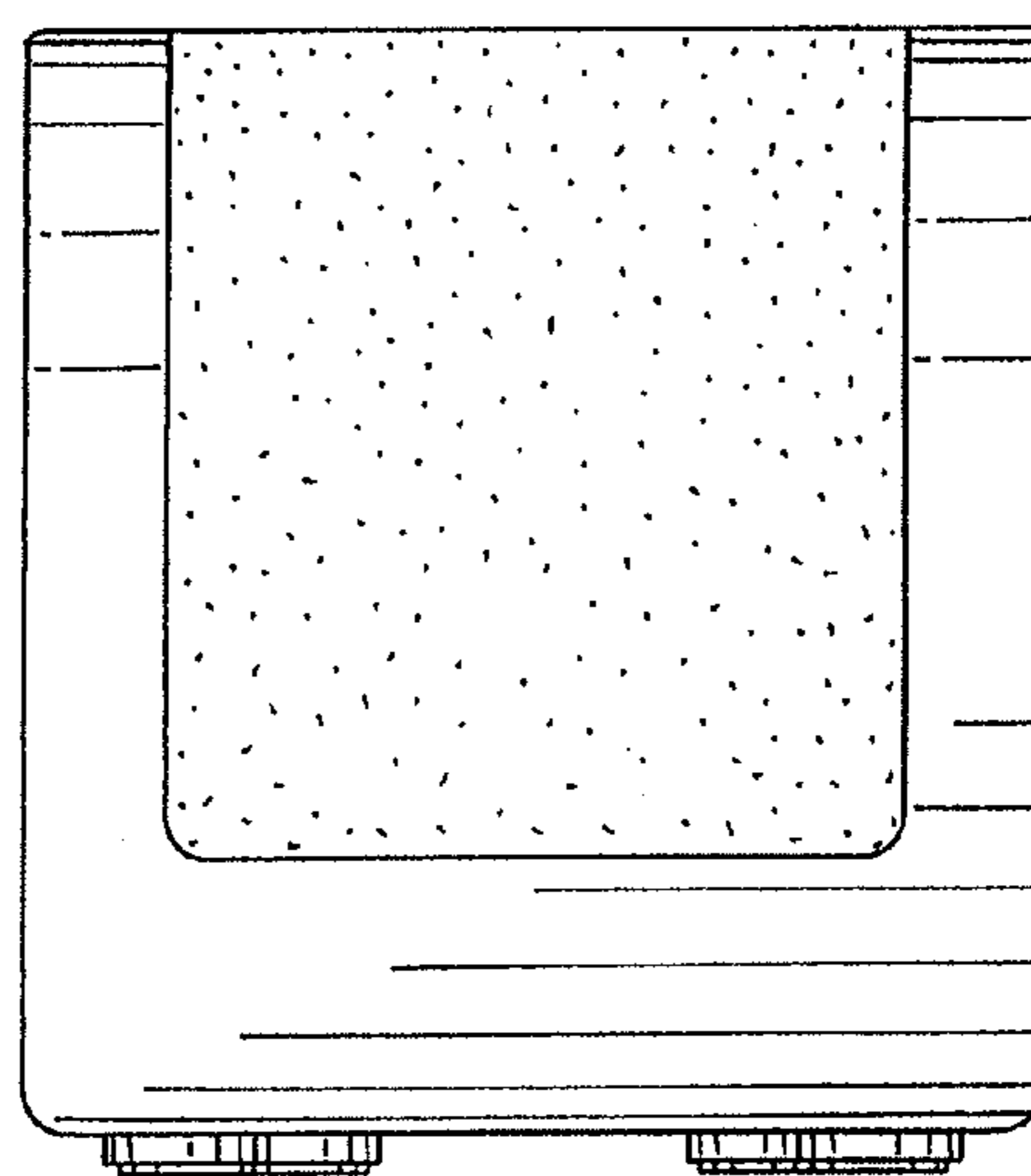

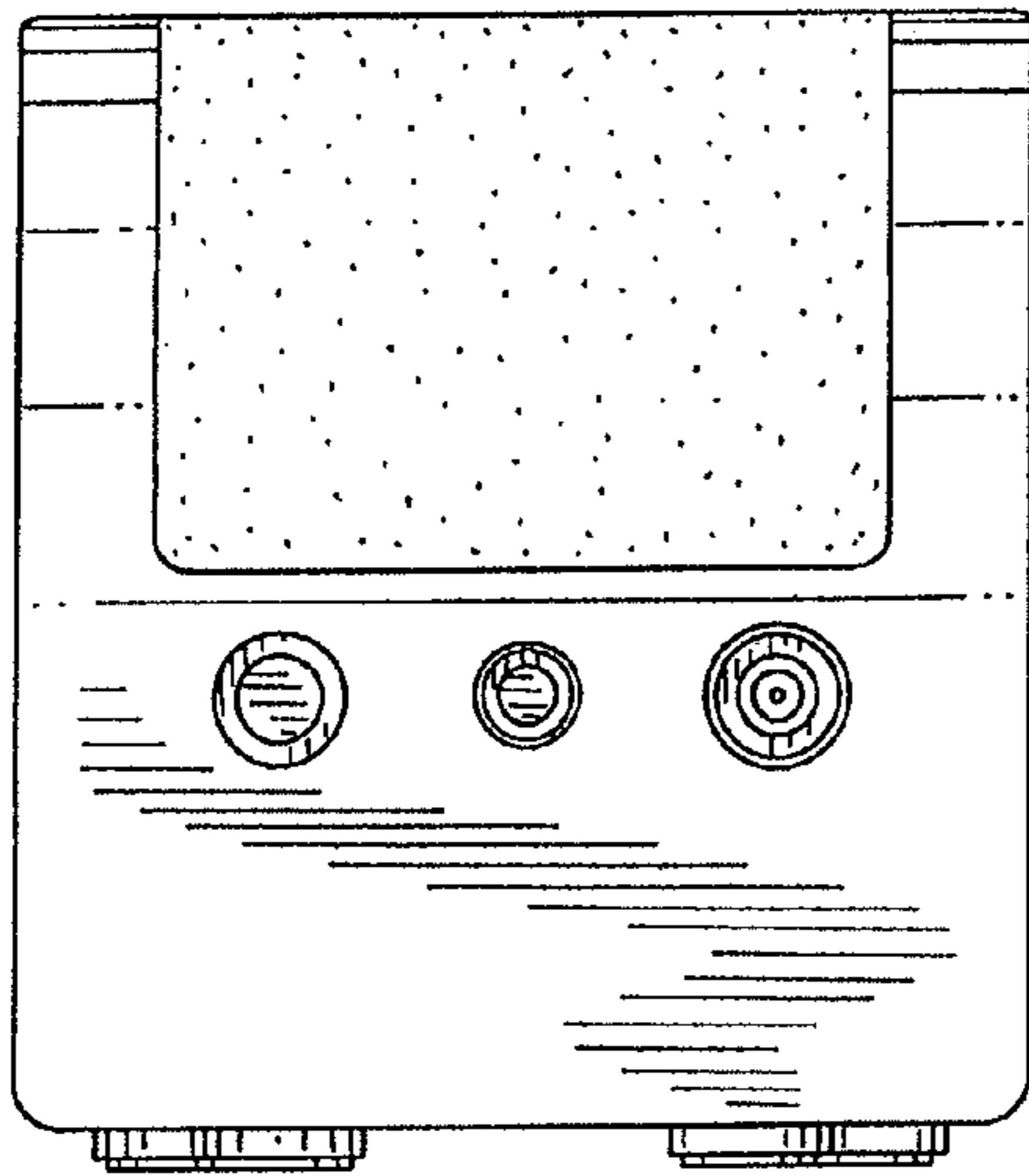

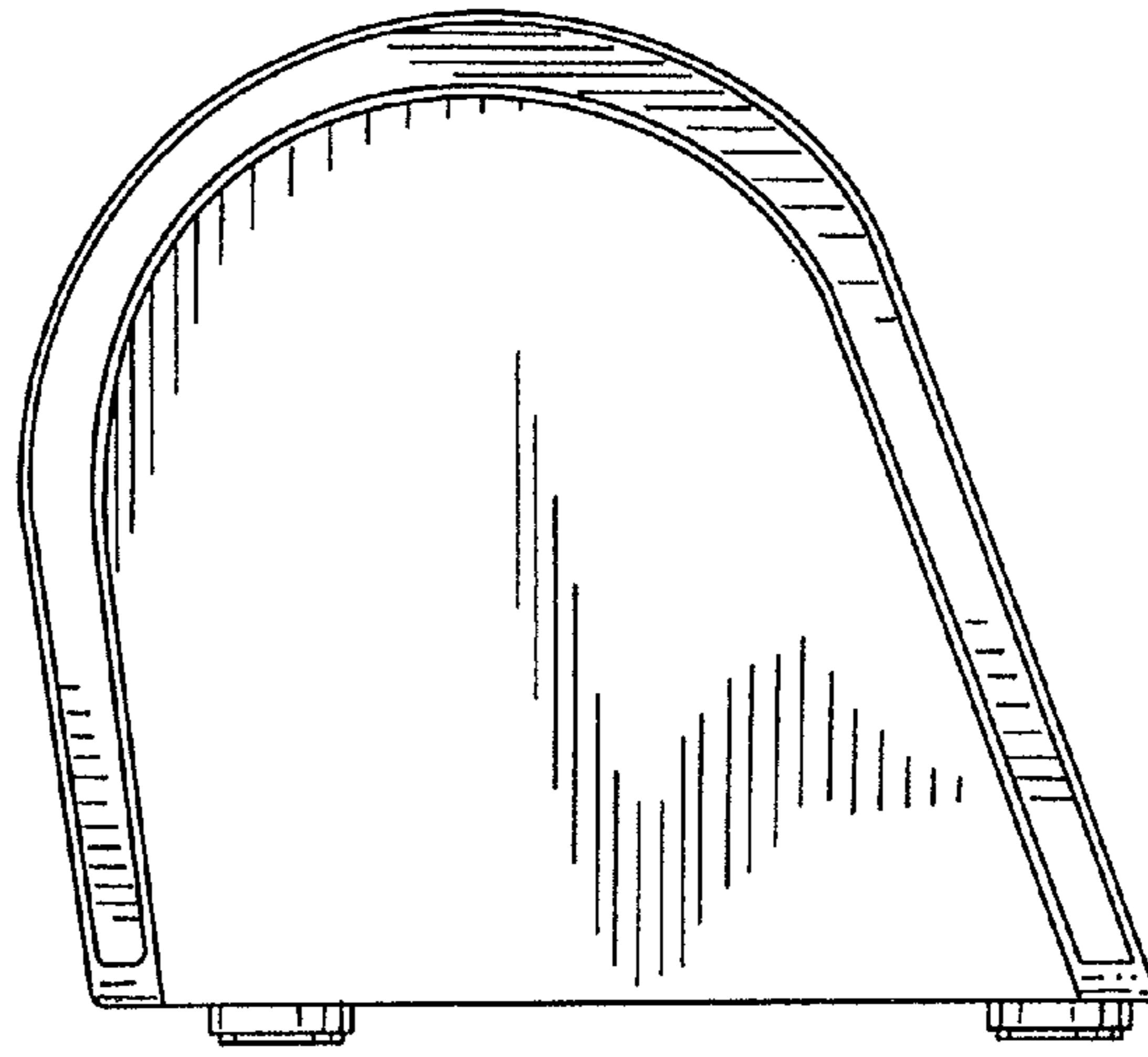

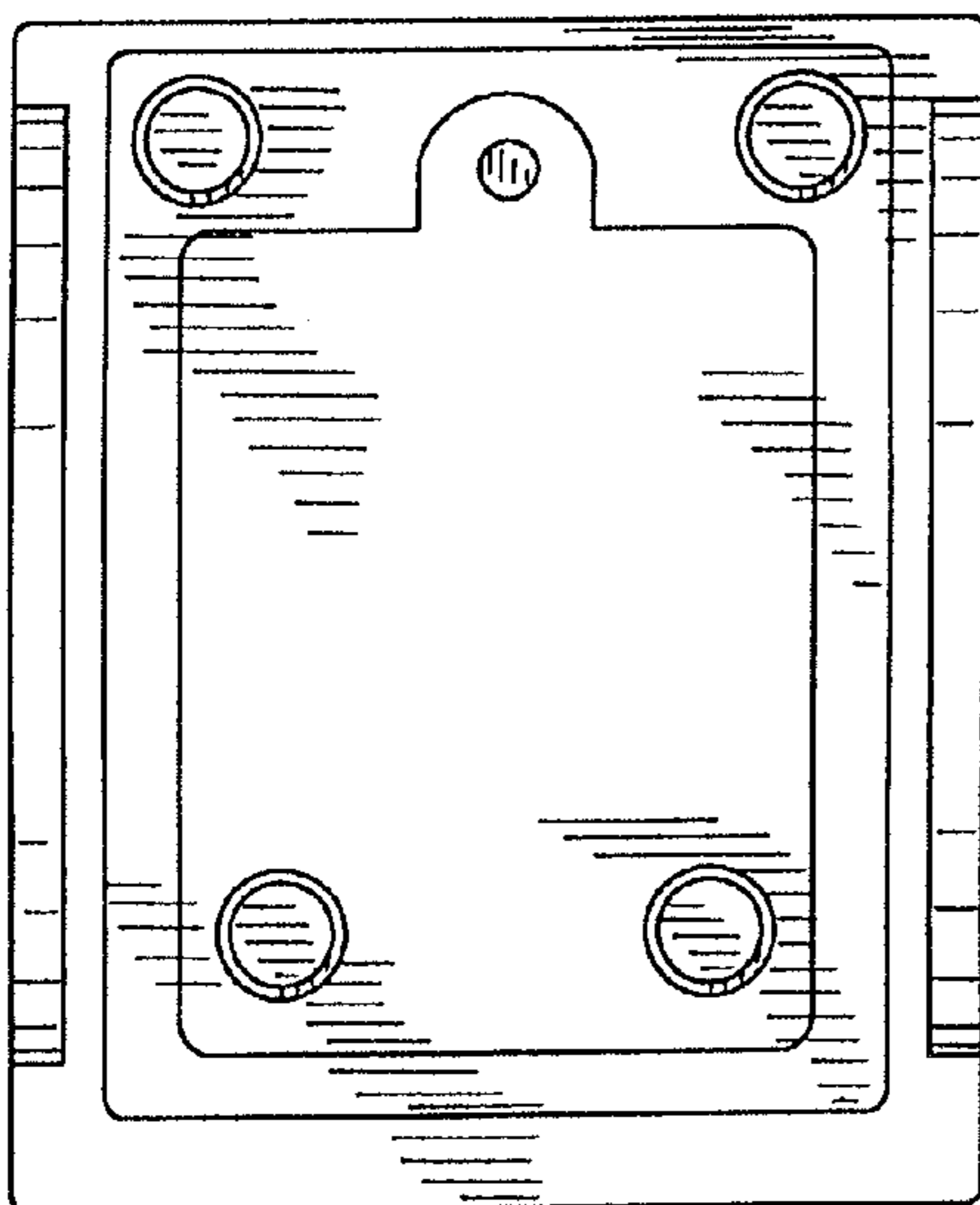
