DESCRIPTION

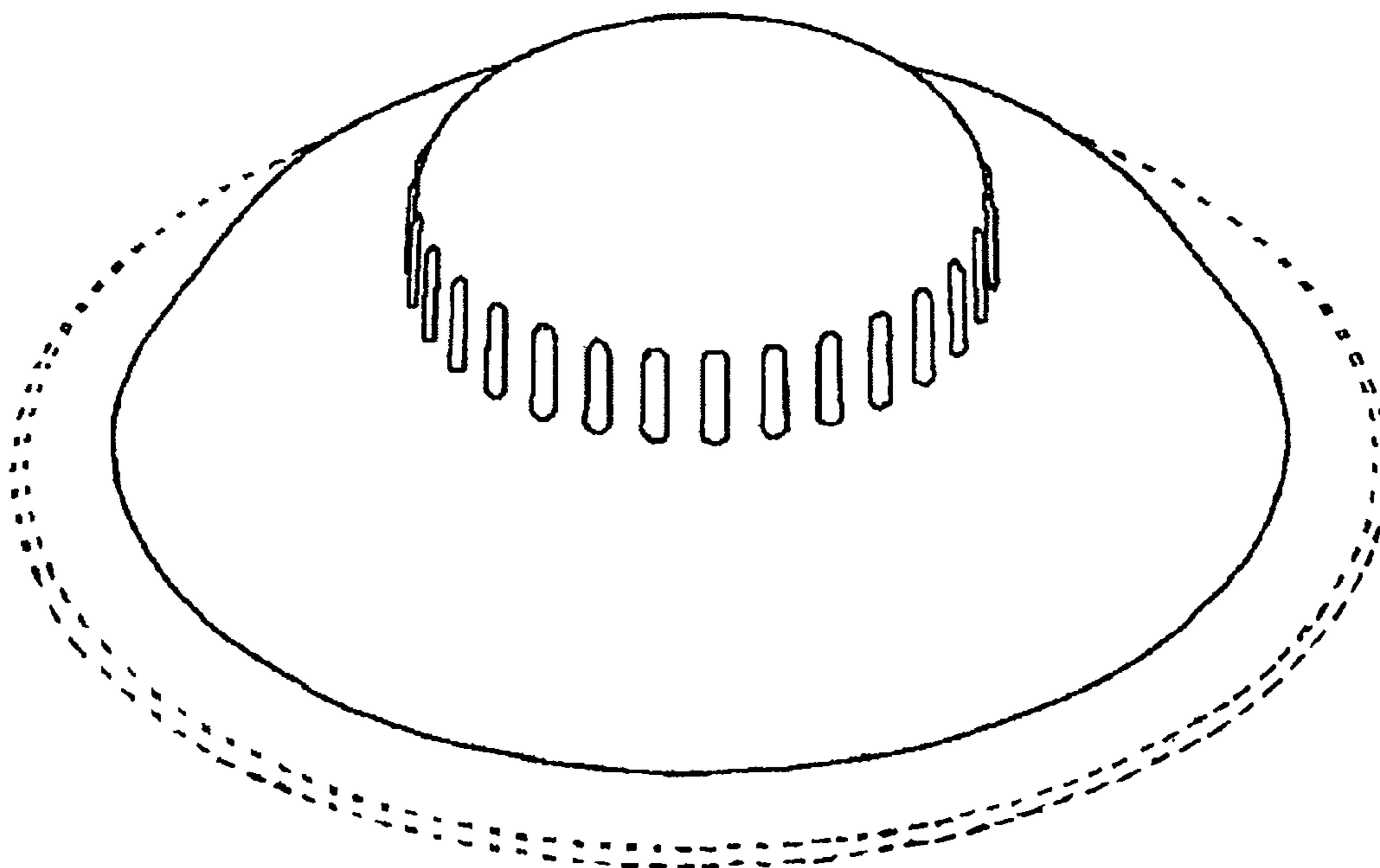
FIG. 1 is a perspective view of the sink stopper showing my new design;

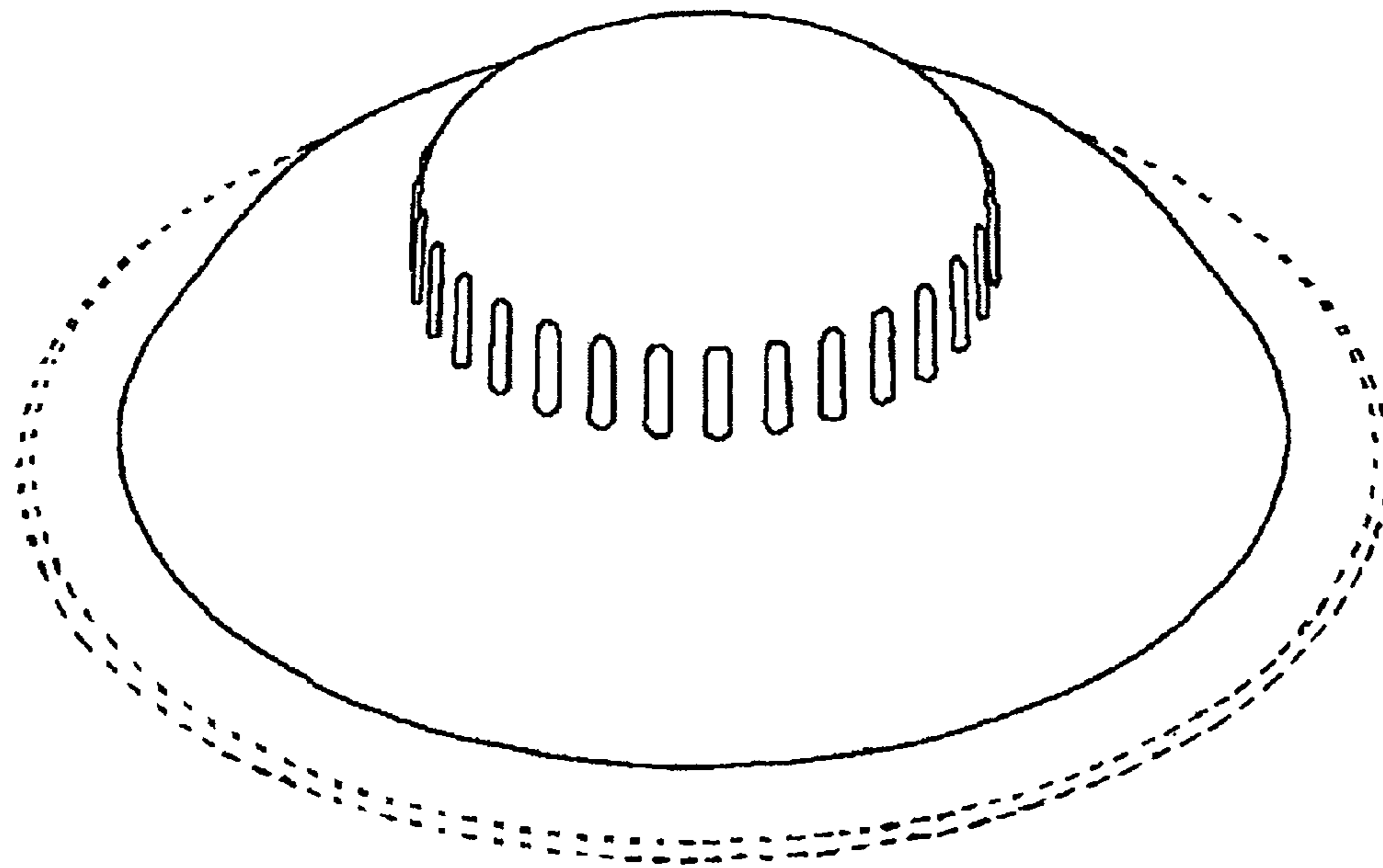

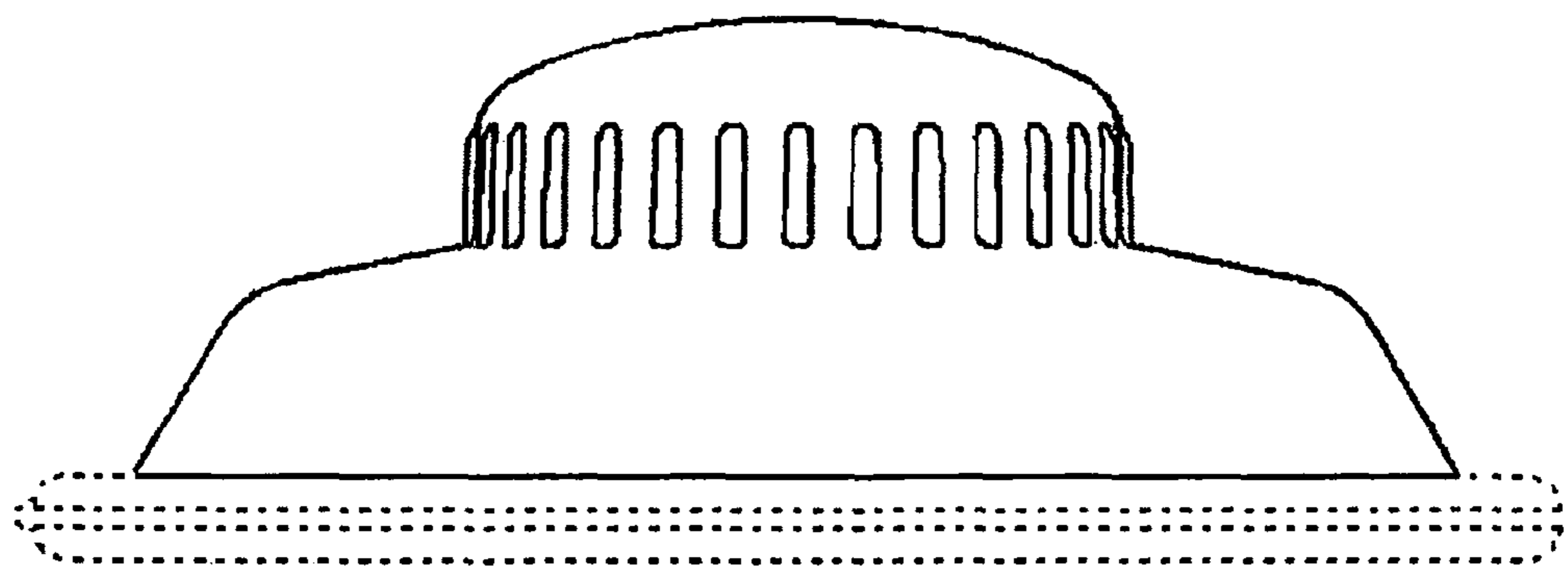

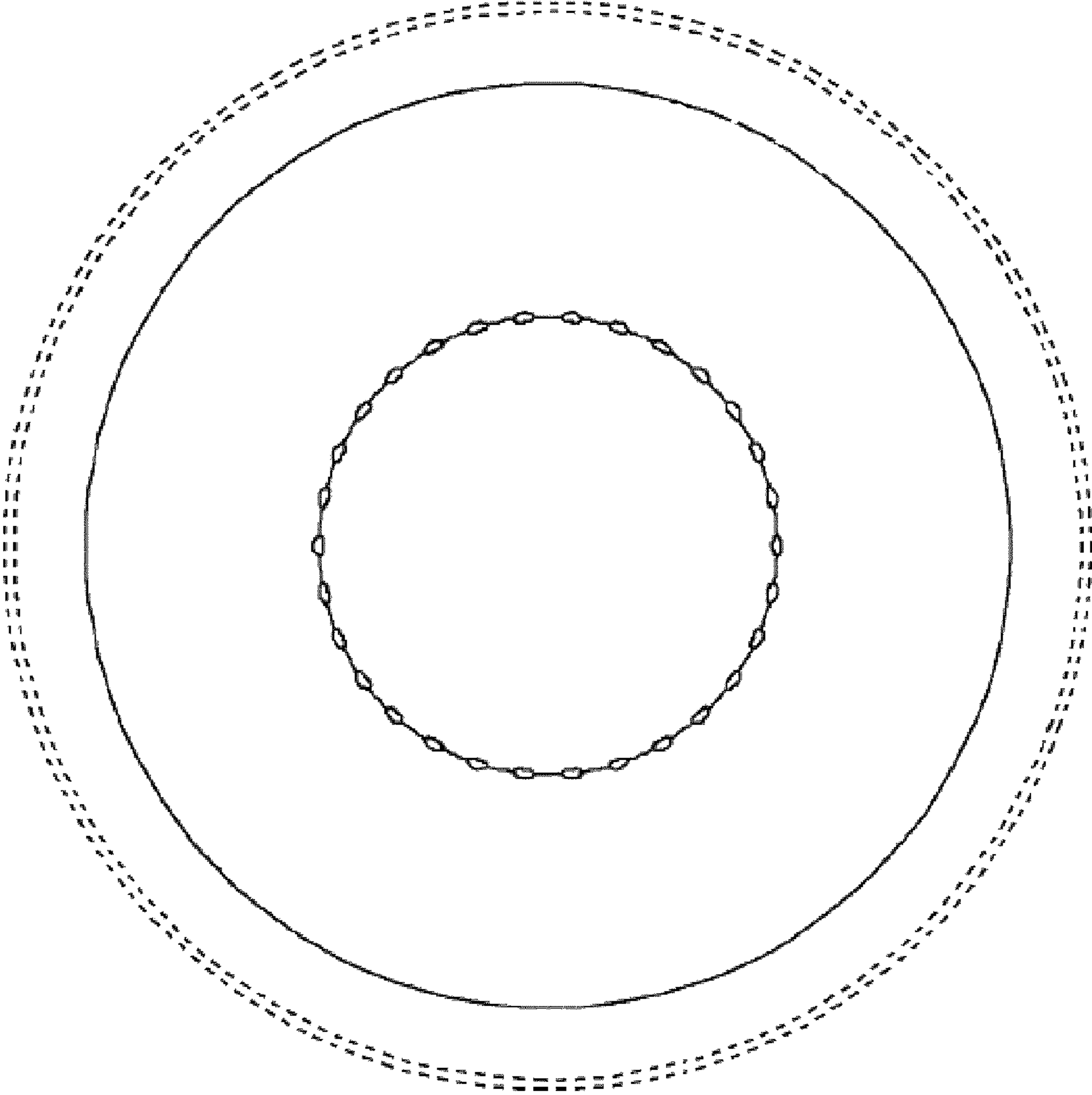

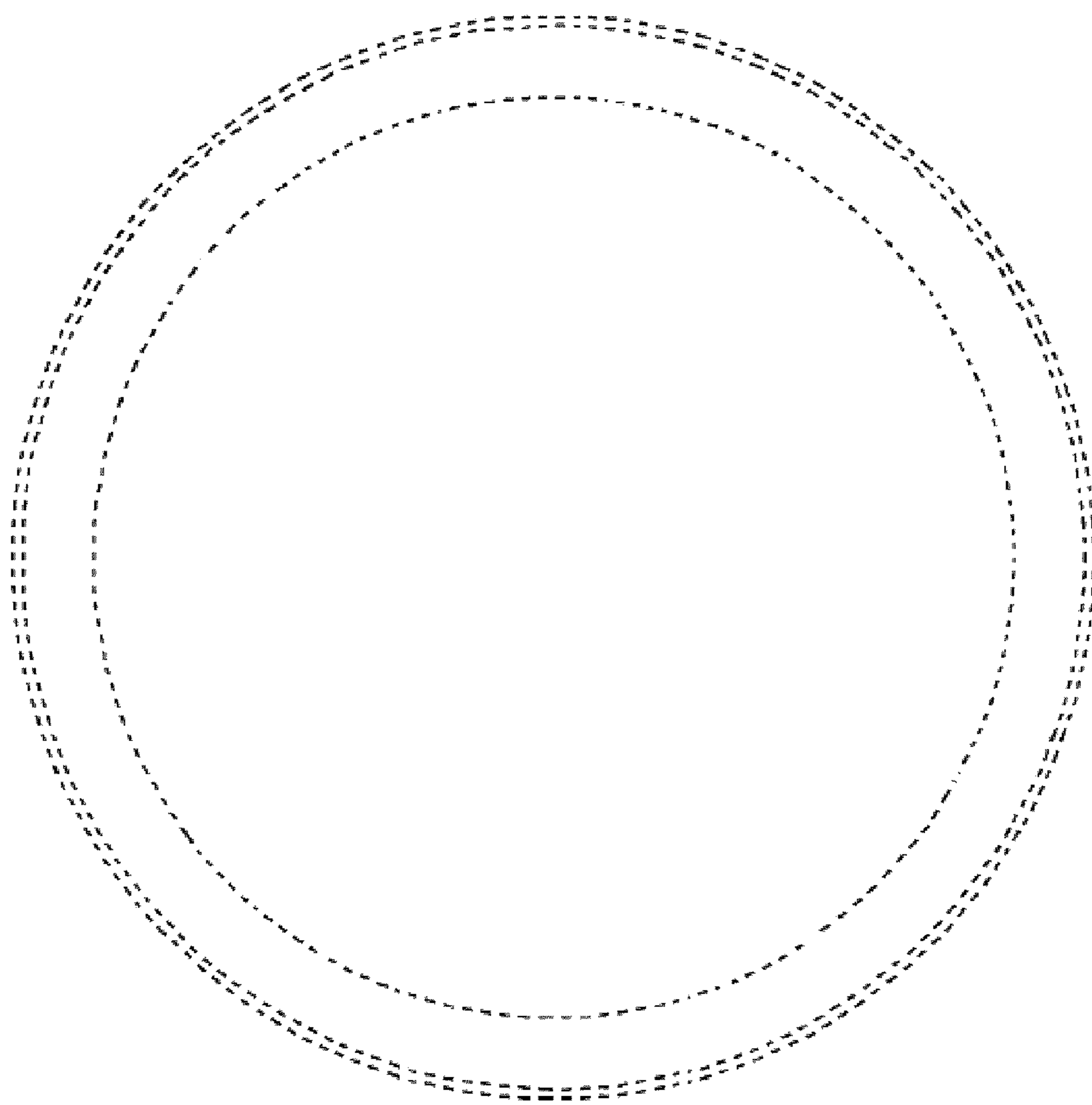
