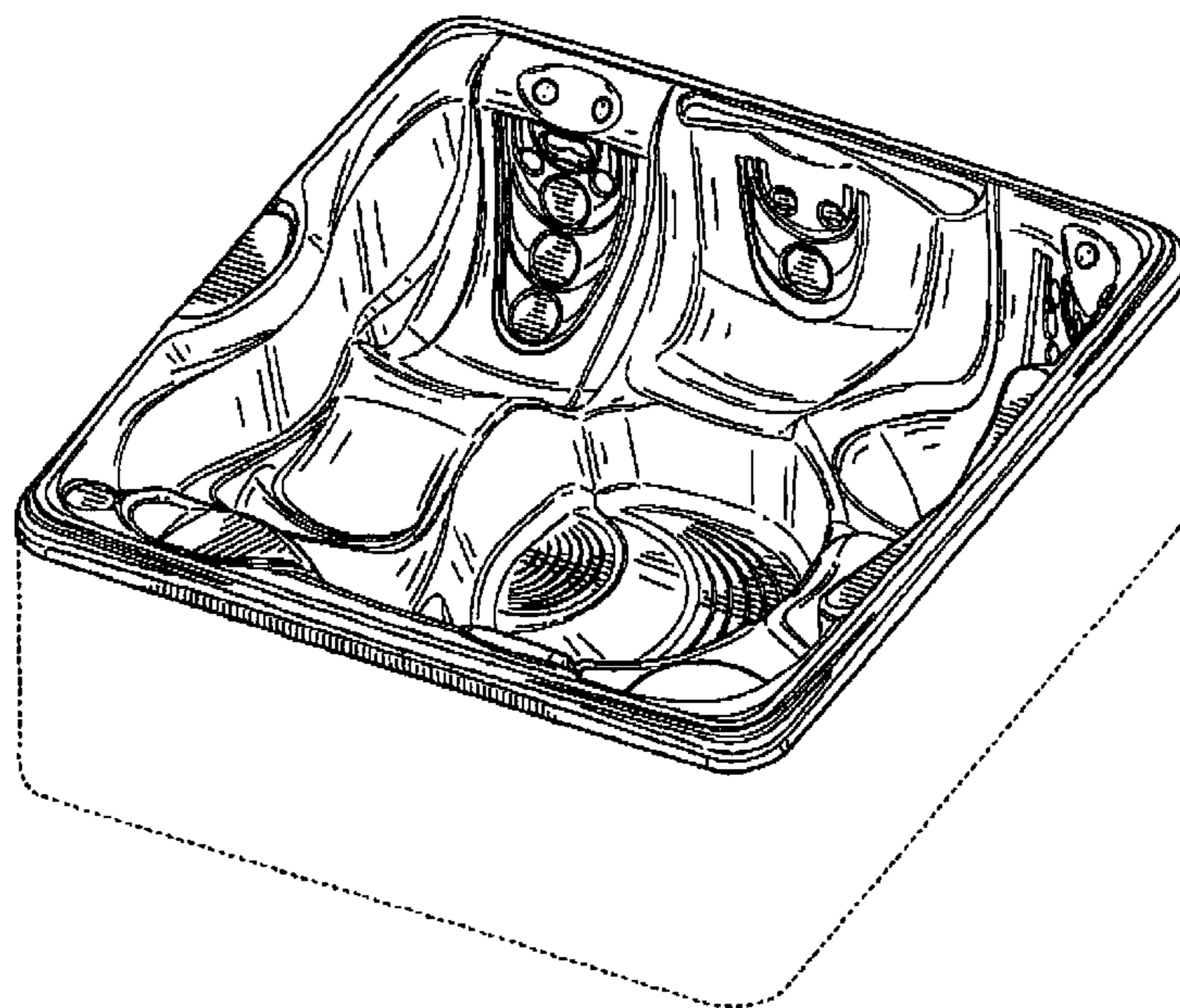
(57) **CLAIM**

The ornamental design for a spa shell, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a spa shell showing our design; FIG. 2 is a perspective view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a cross-sectional view taken along 4-4 of FIG. 3; FIG. 5 is a cross-sectional view taken along 5-5 of FIG. 3; FIG. 6 is a cross-sectional view taken along 6-6 of FIG. 3; FIG. 7 is a cross-sectional view taken along 7-7 of FIG. 3; FIG. 8 is a cross-sectional view taken along 8-8 of FIG. 3; and, FIG. 9 is a cross-sectional view taken along 9-9 of FIG. 3. The broken-line disclosure in the views represents portions of the article in which the claimed design is embodied, but which form no part of the claimed design.

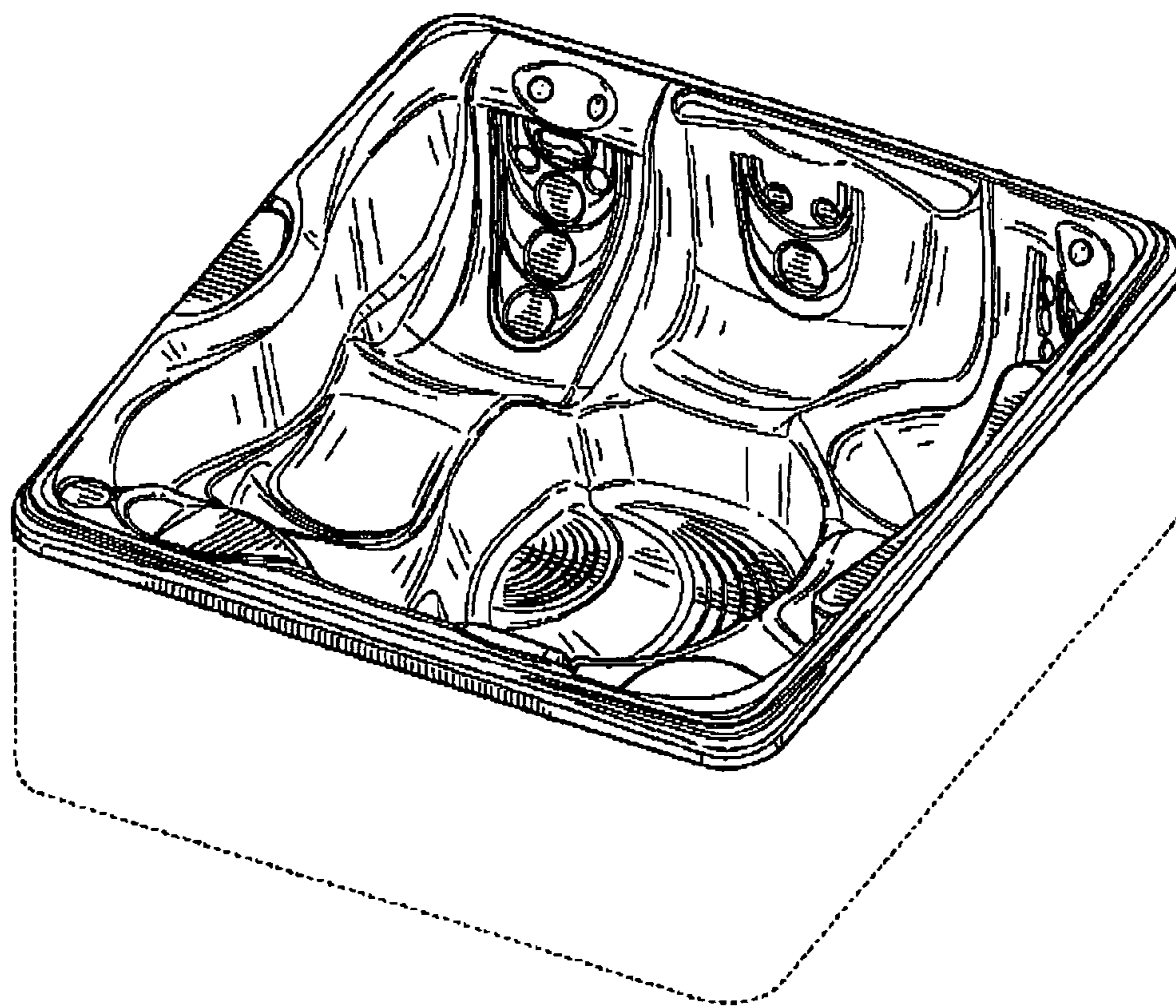

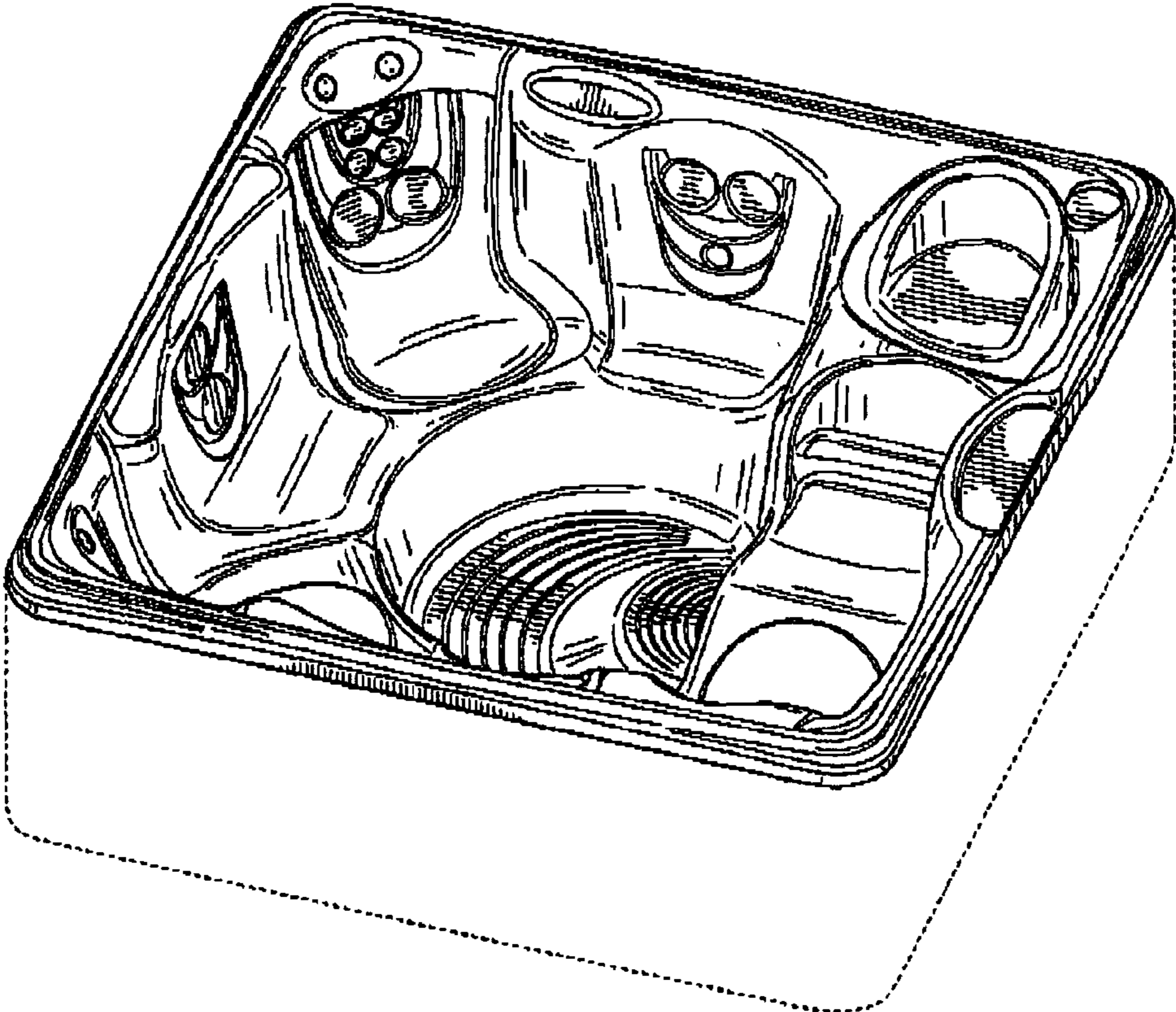

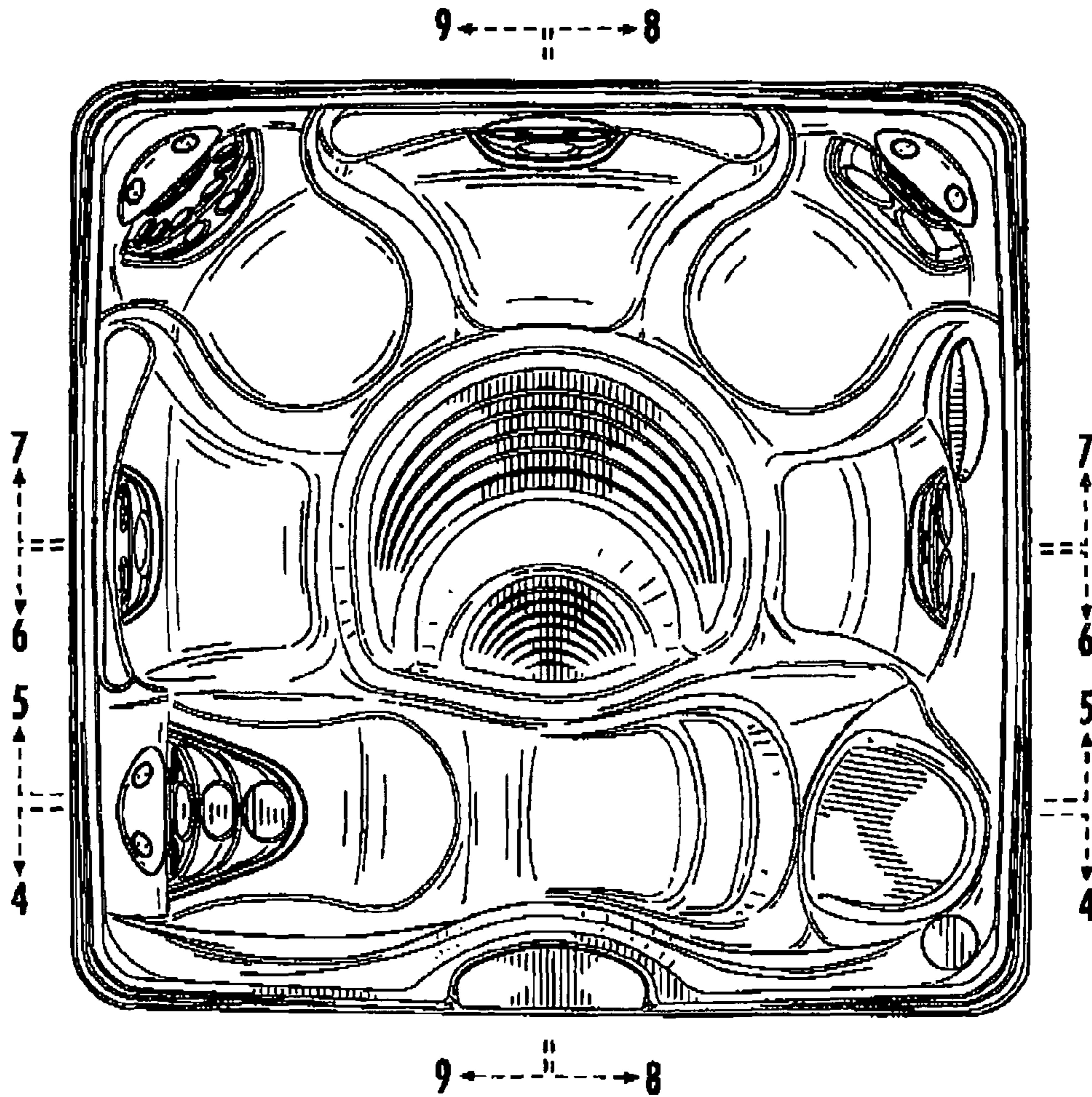

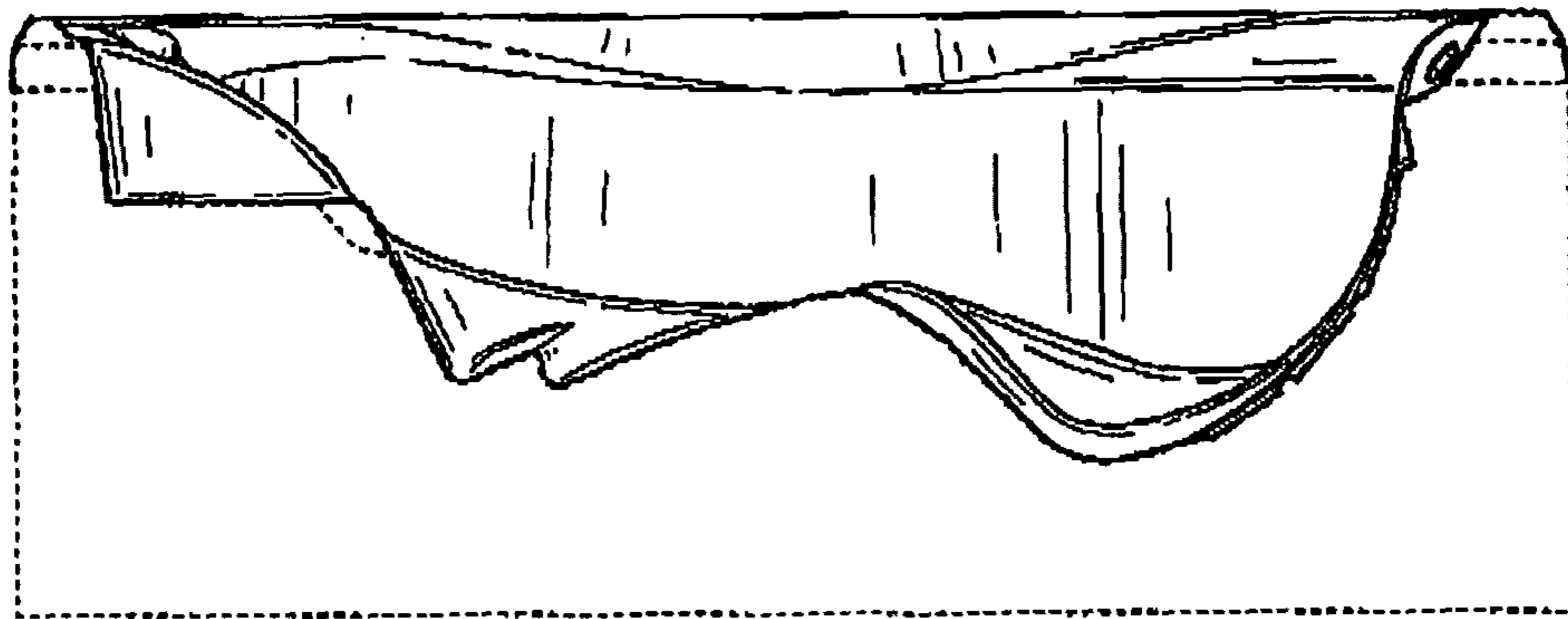

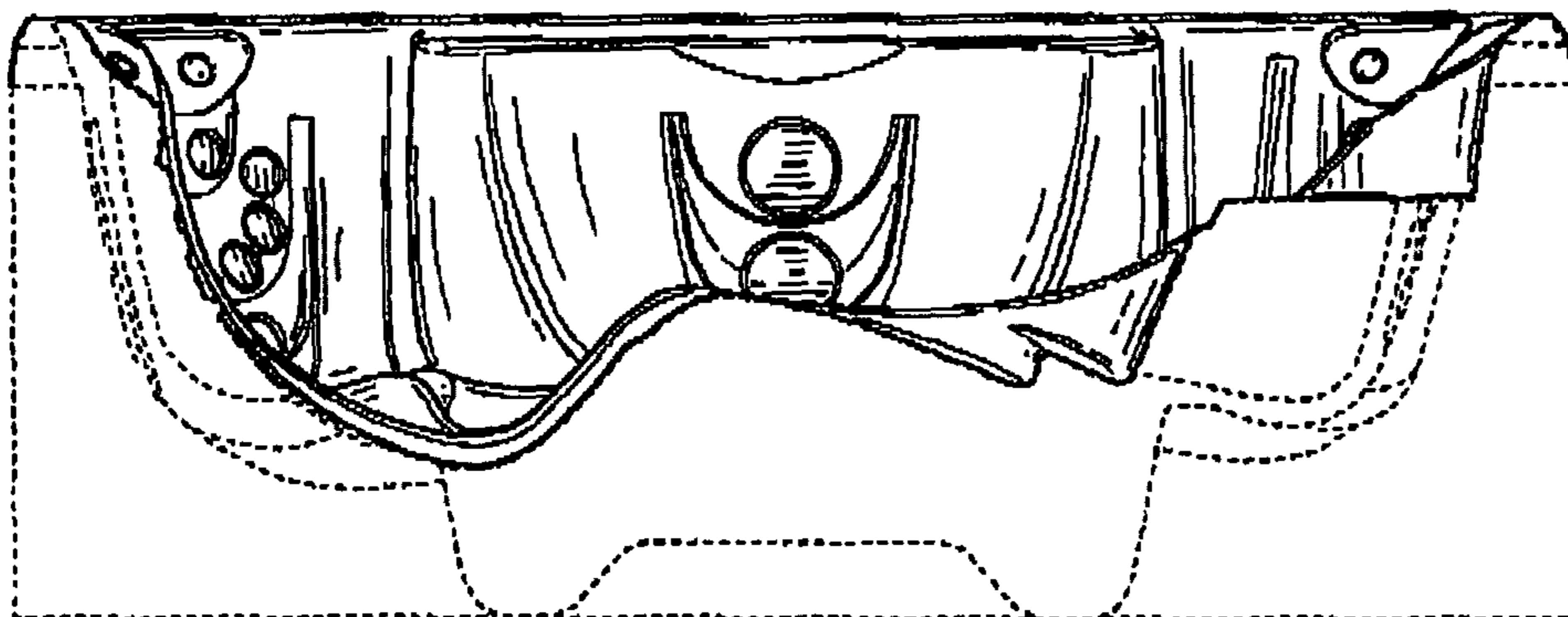

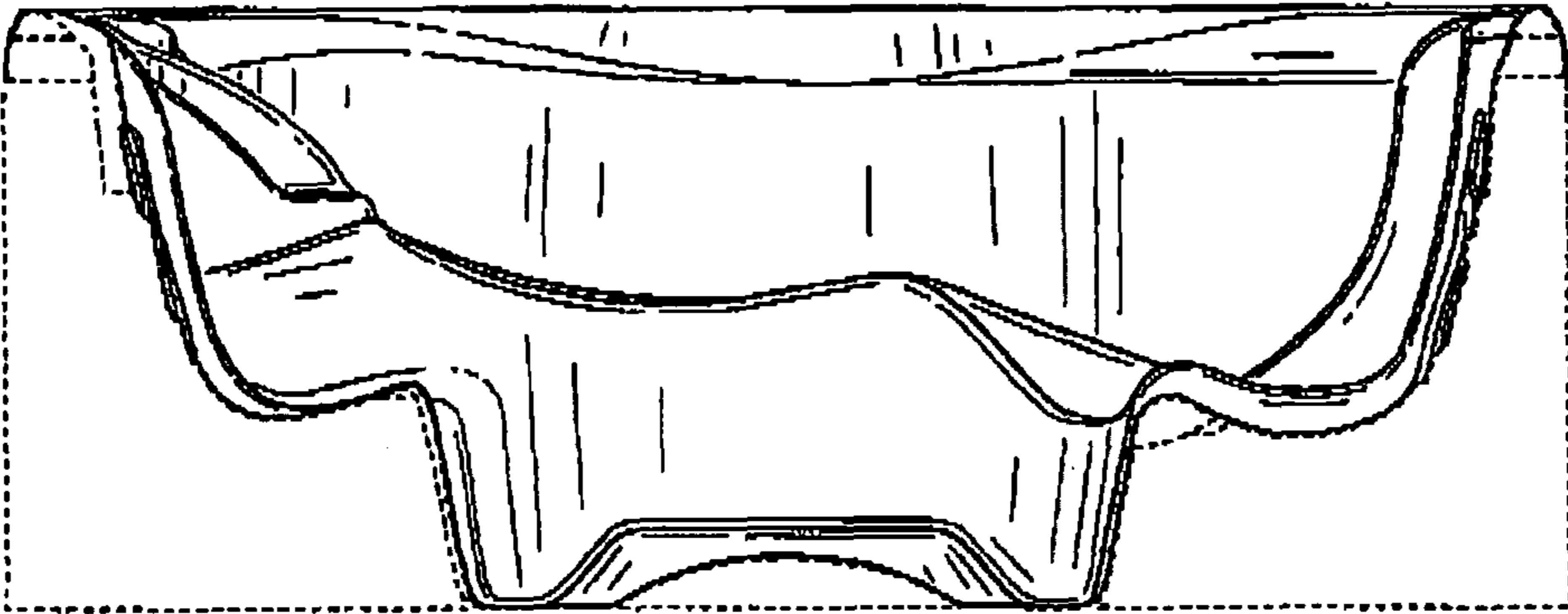

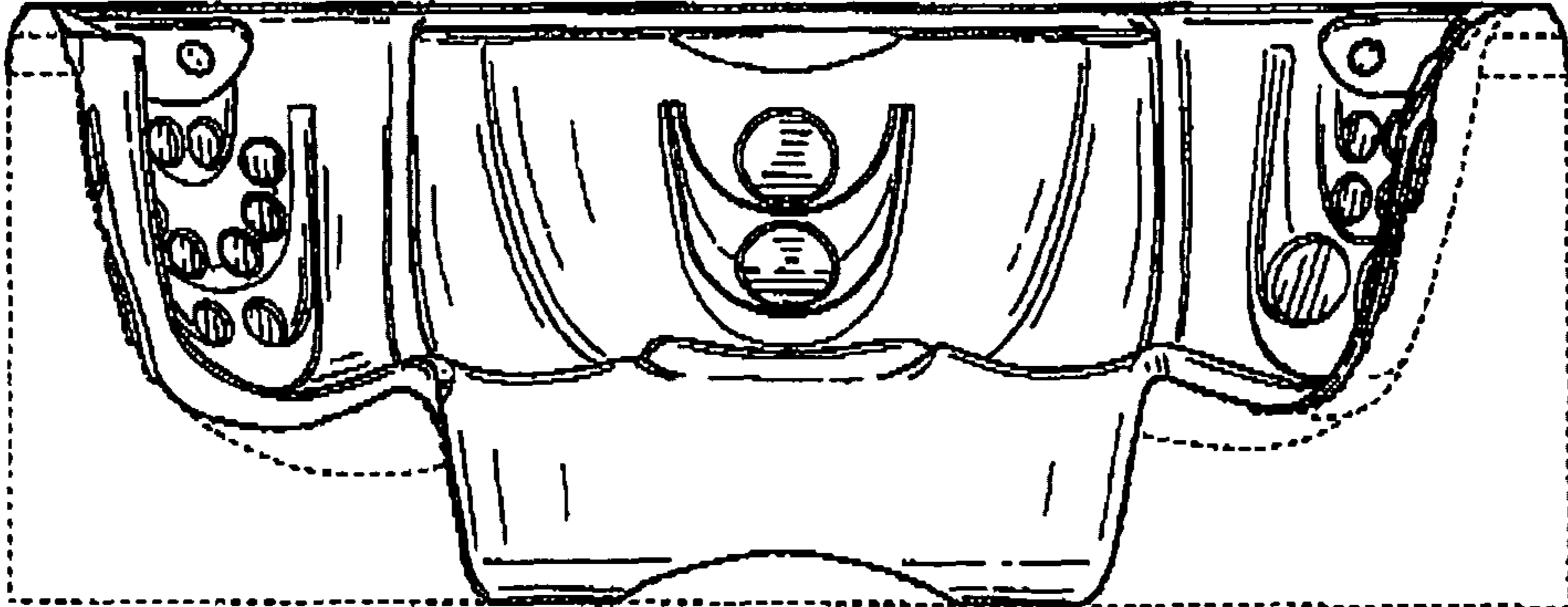

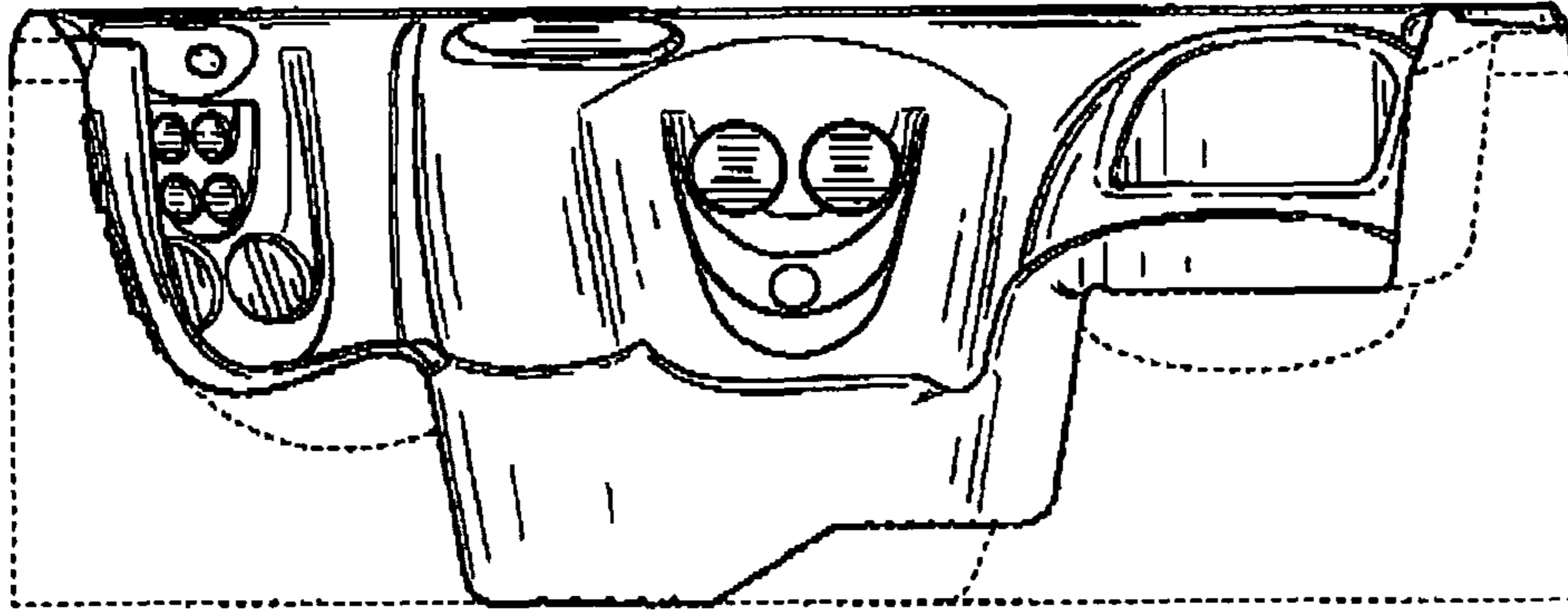

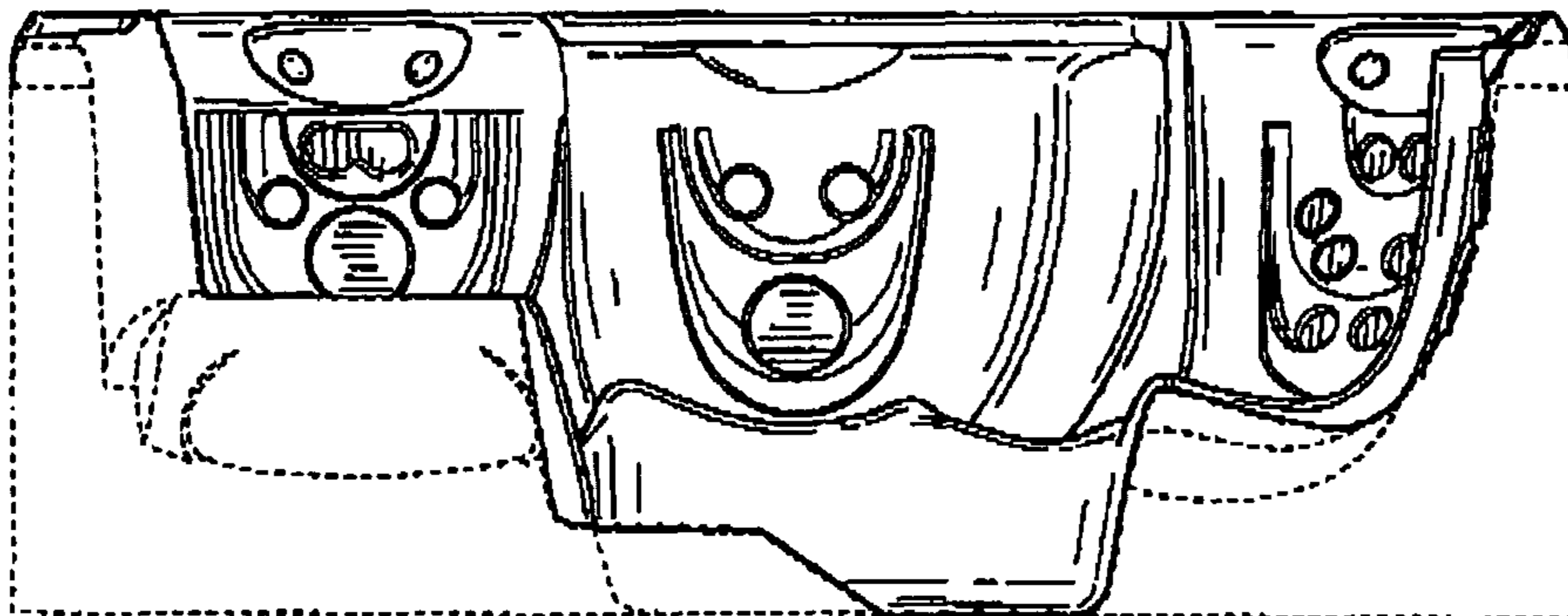
