FIG. 4 is an elevational view of the other side thereof.

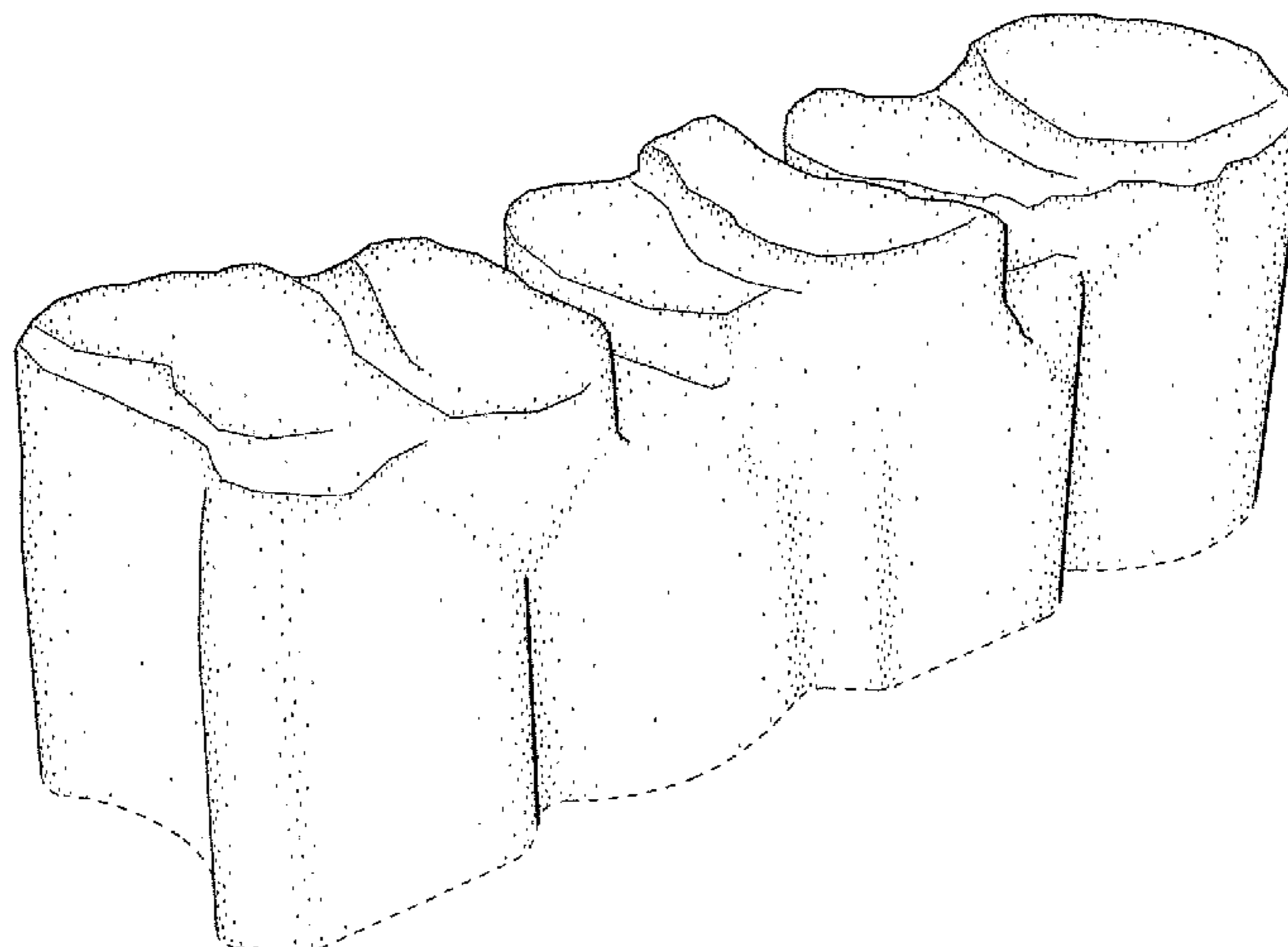
FIG. 5 is an end elevational view thereof.

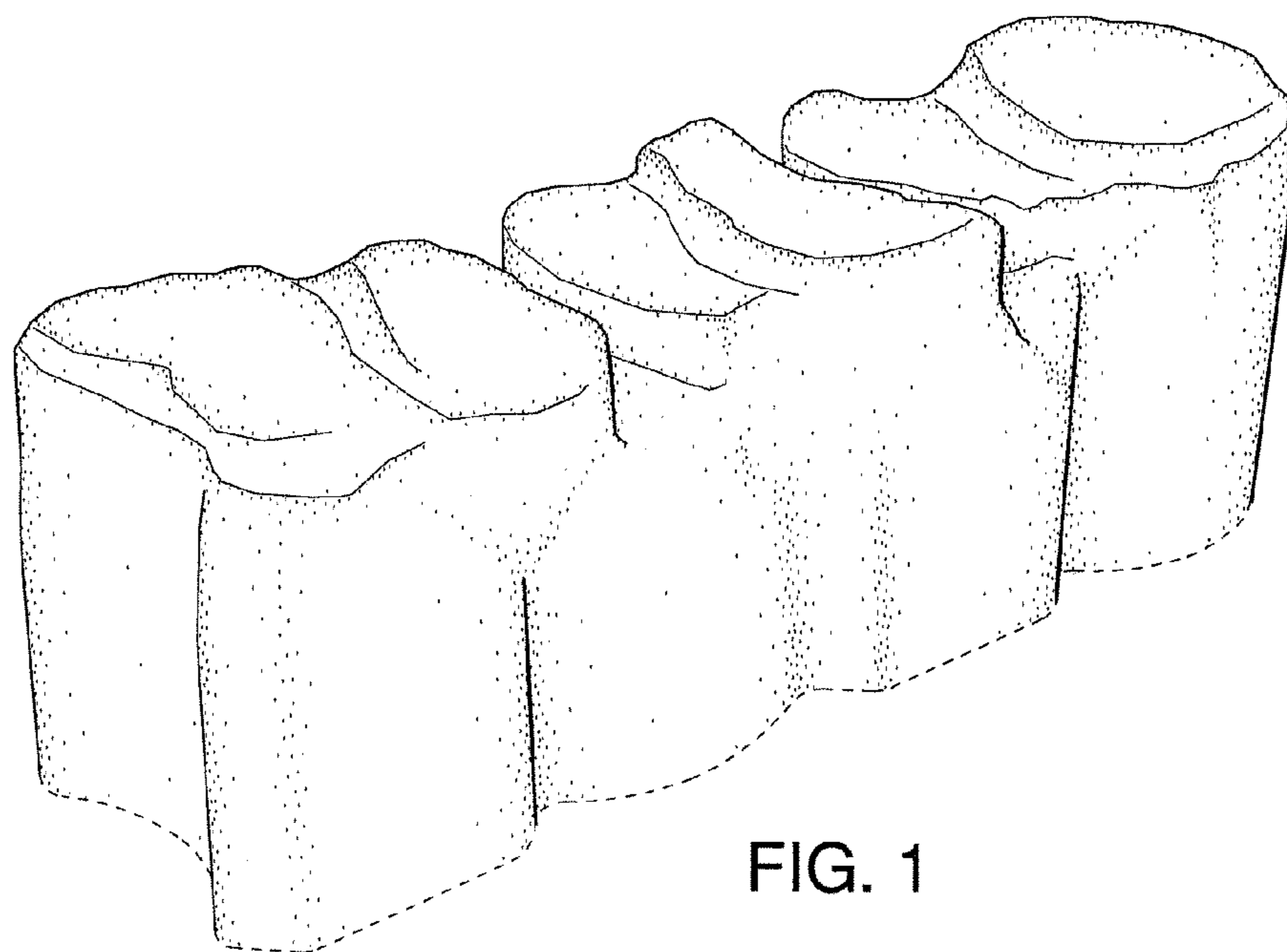

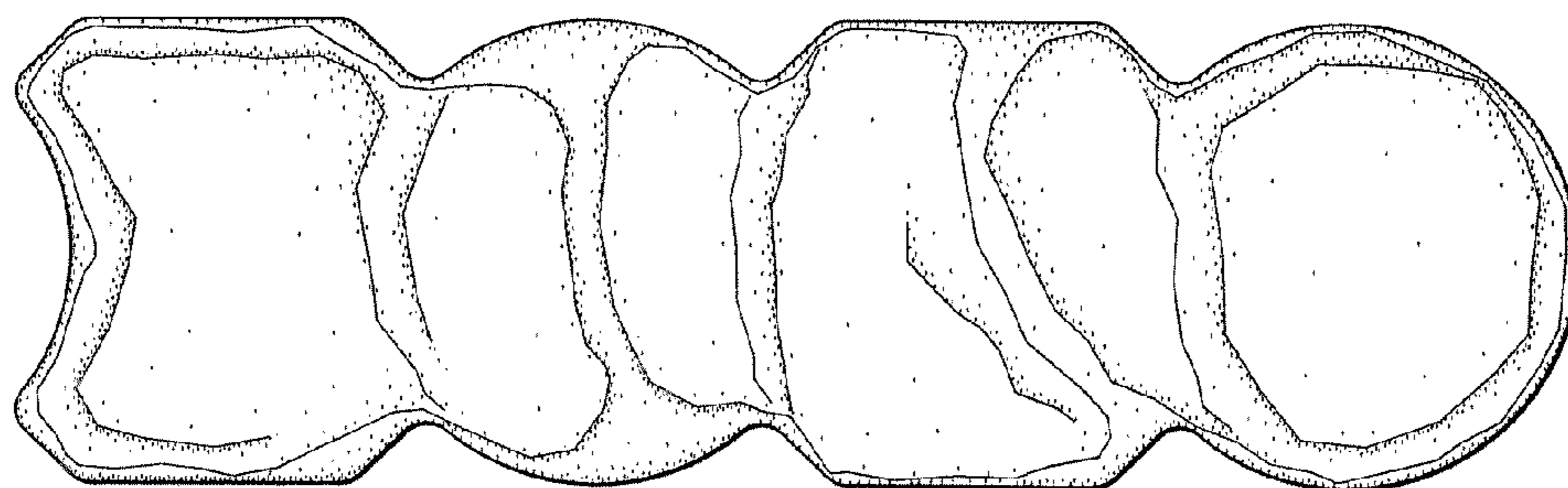

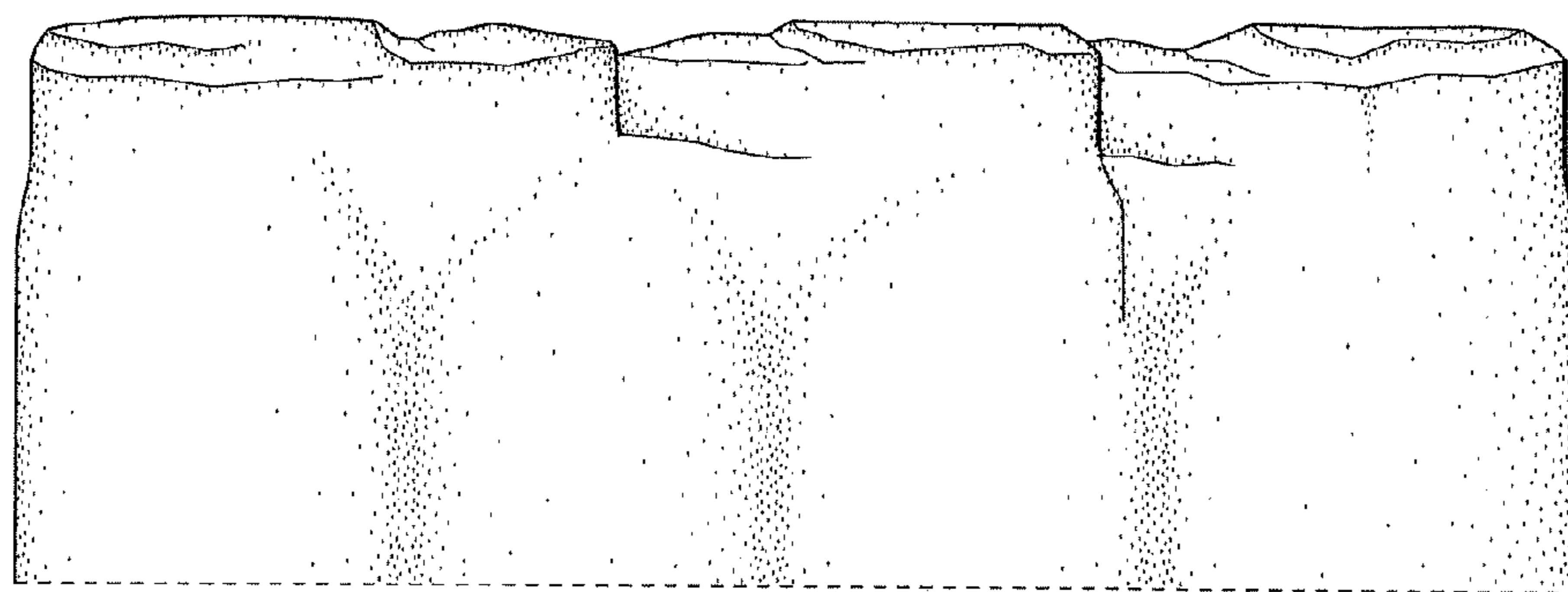

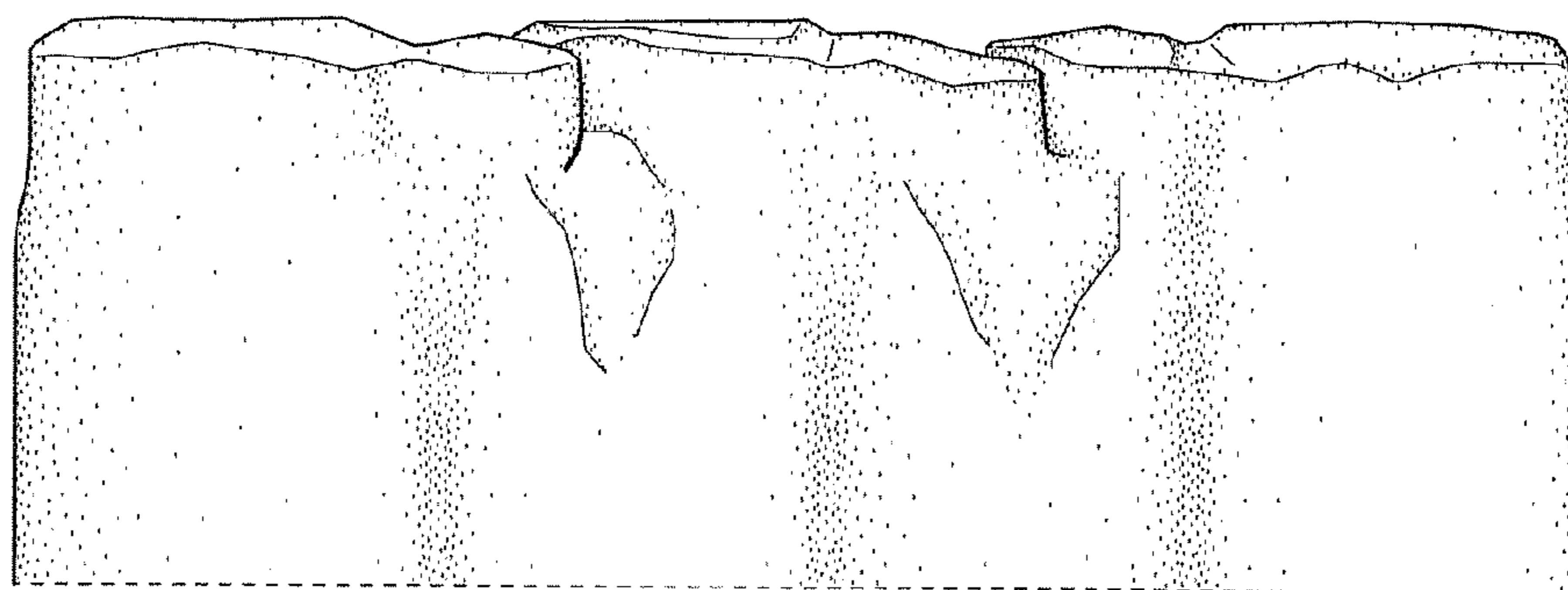

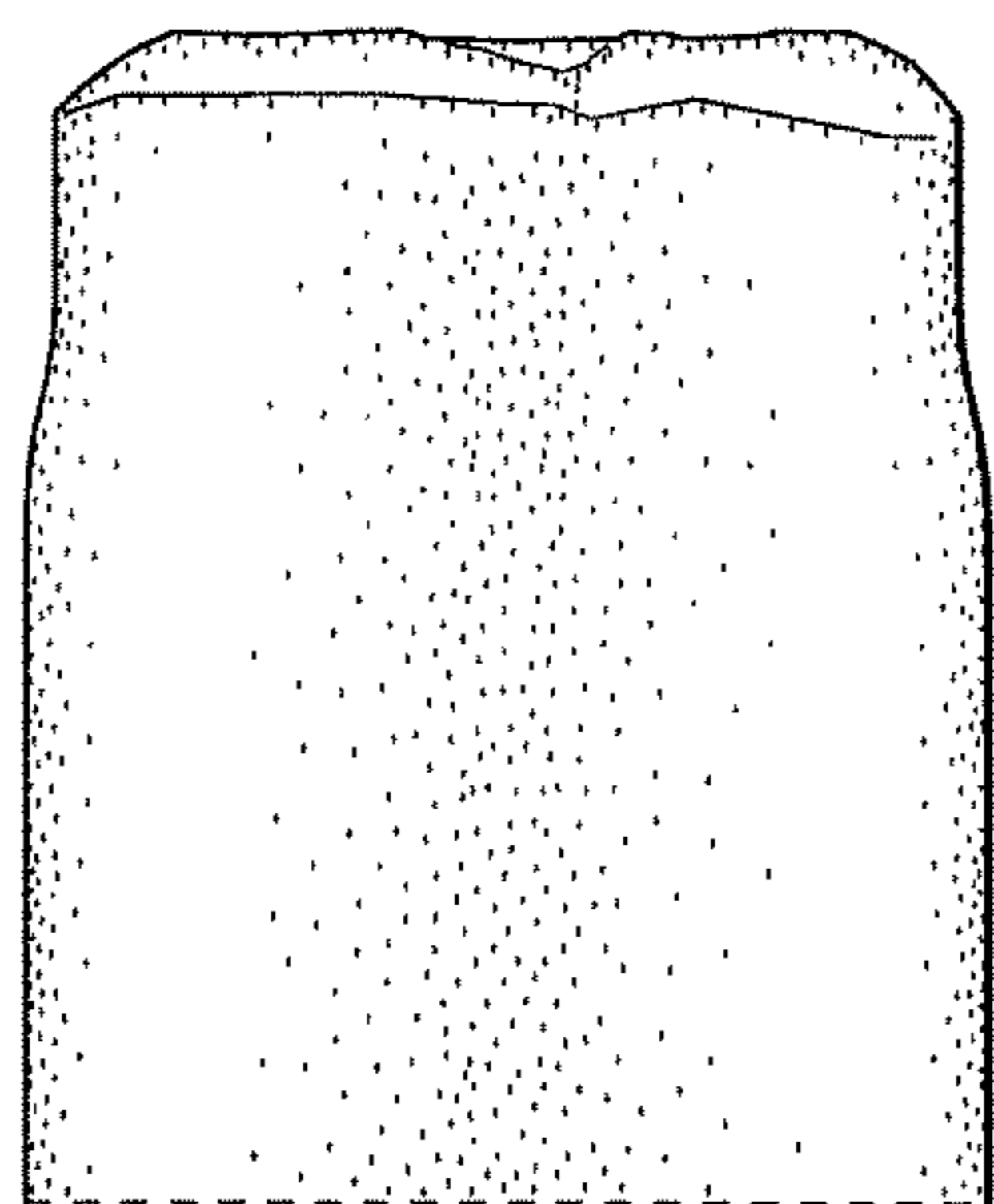

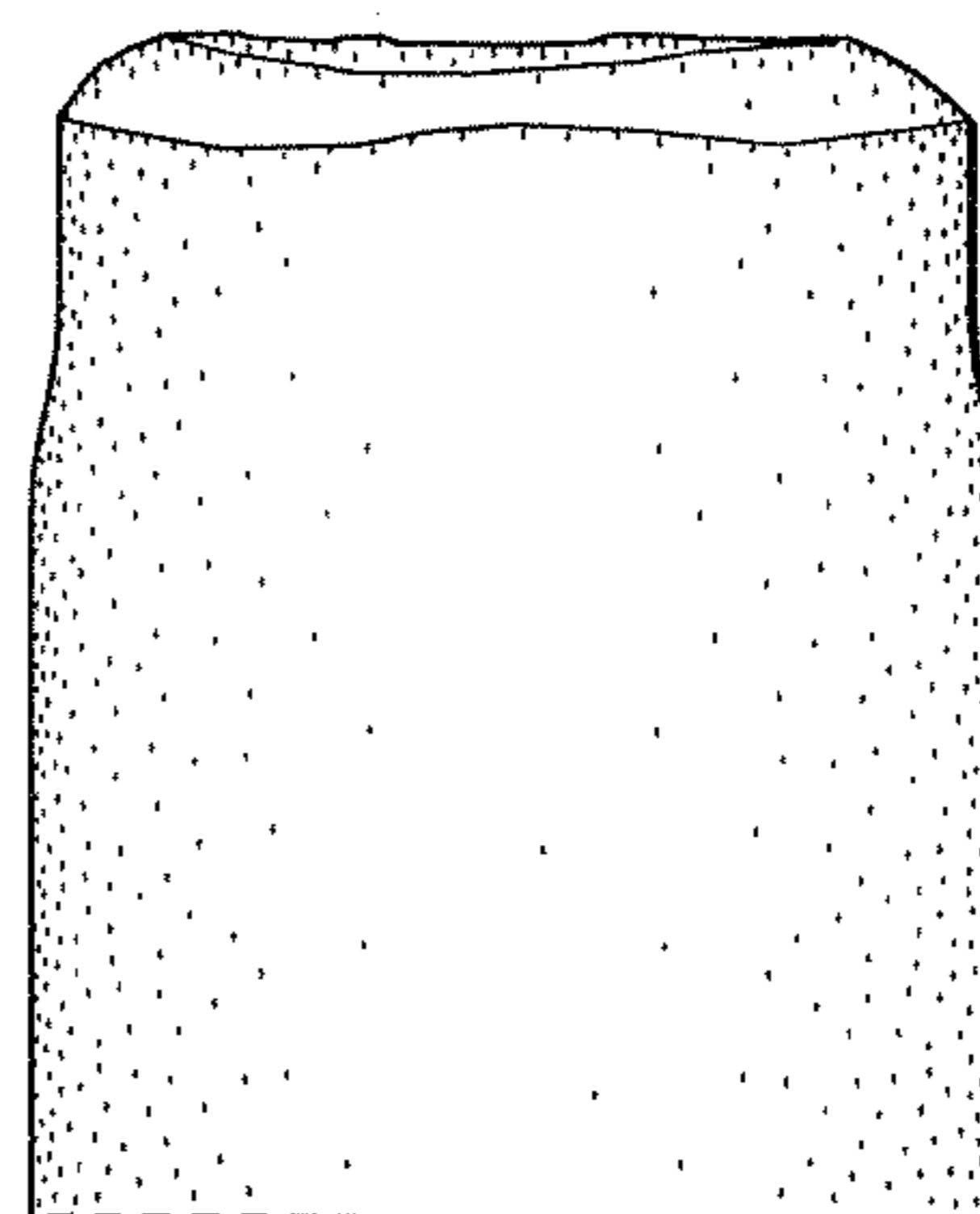

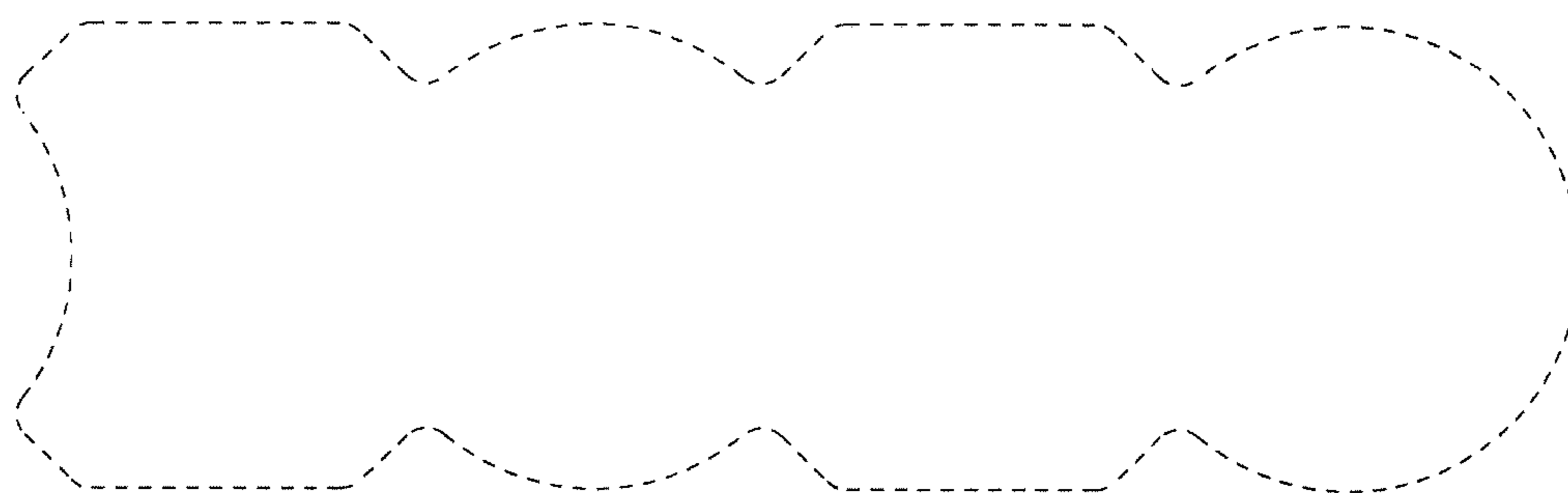
