FIG. 1 is a front plan view of a barbecue grill scraper showing my new design;

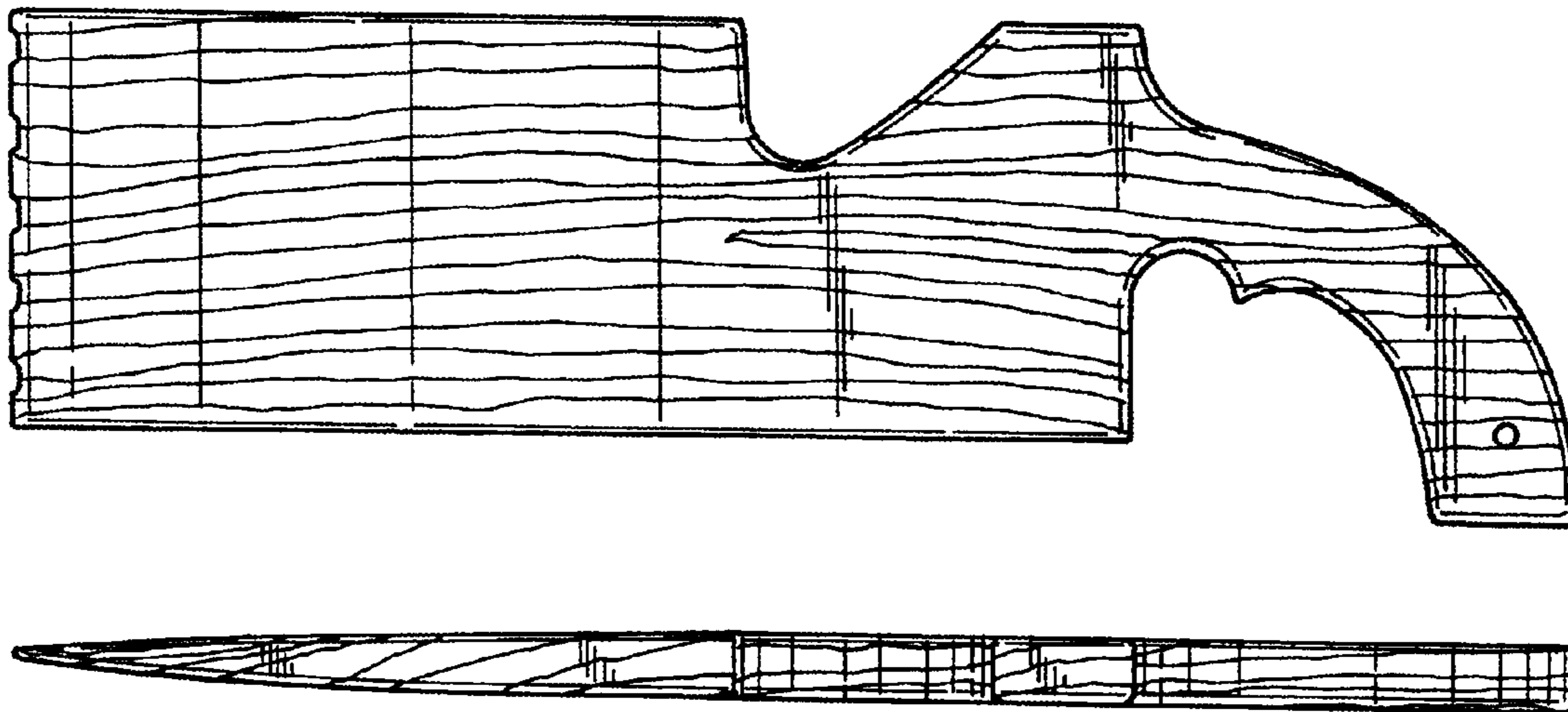
FIG. 2 is a top plan view thereof;

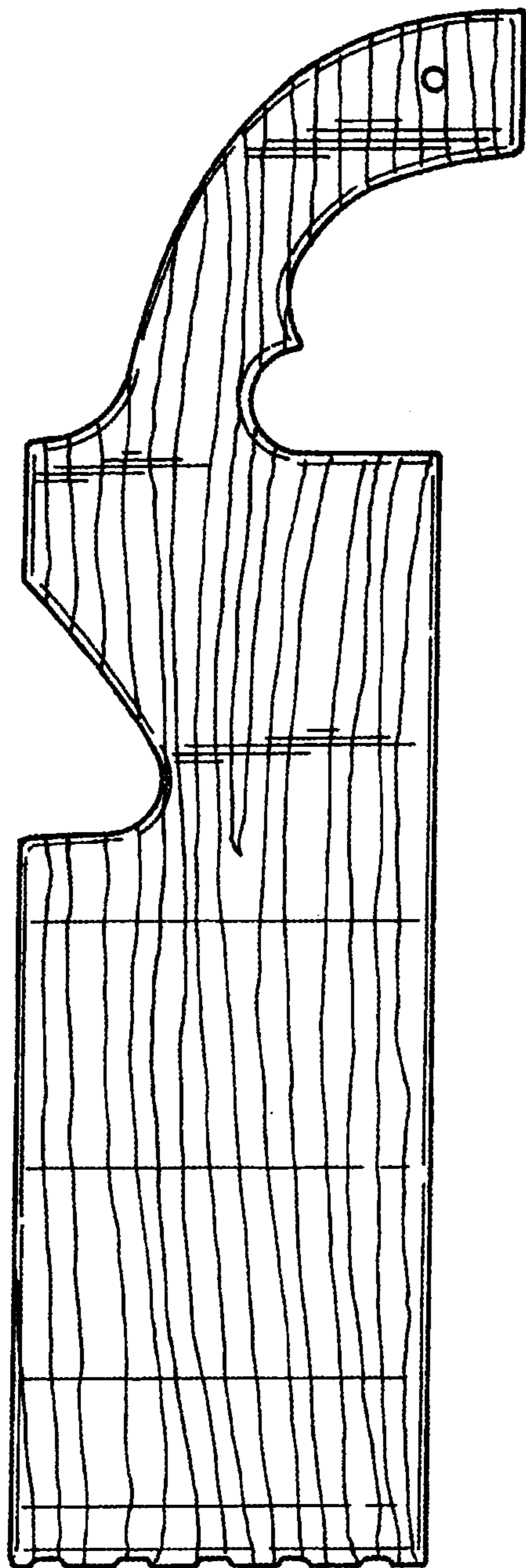
