(57) **CLAIM**

The ornamental design for belt end strap, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a belt end strap showing two belt end straps connected showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a front elevational view thereof, the rear elevational view being a mirror image thereof;

FIG. 5 is a left elevational view thereof;

FIG. 6 is a top plan view of a second embodiment of the belt end strap;

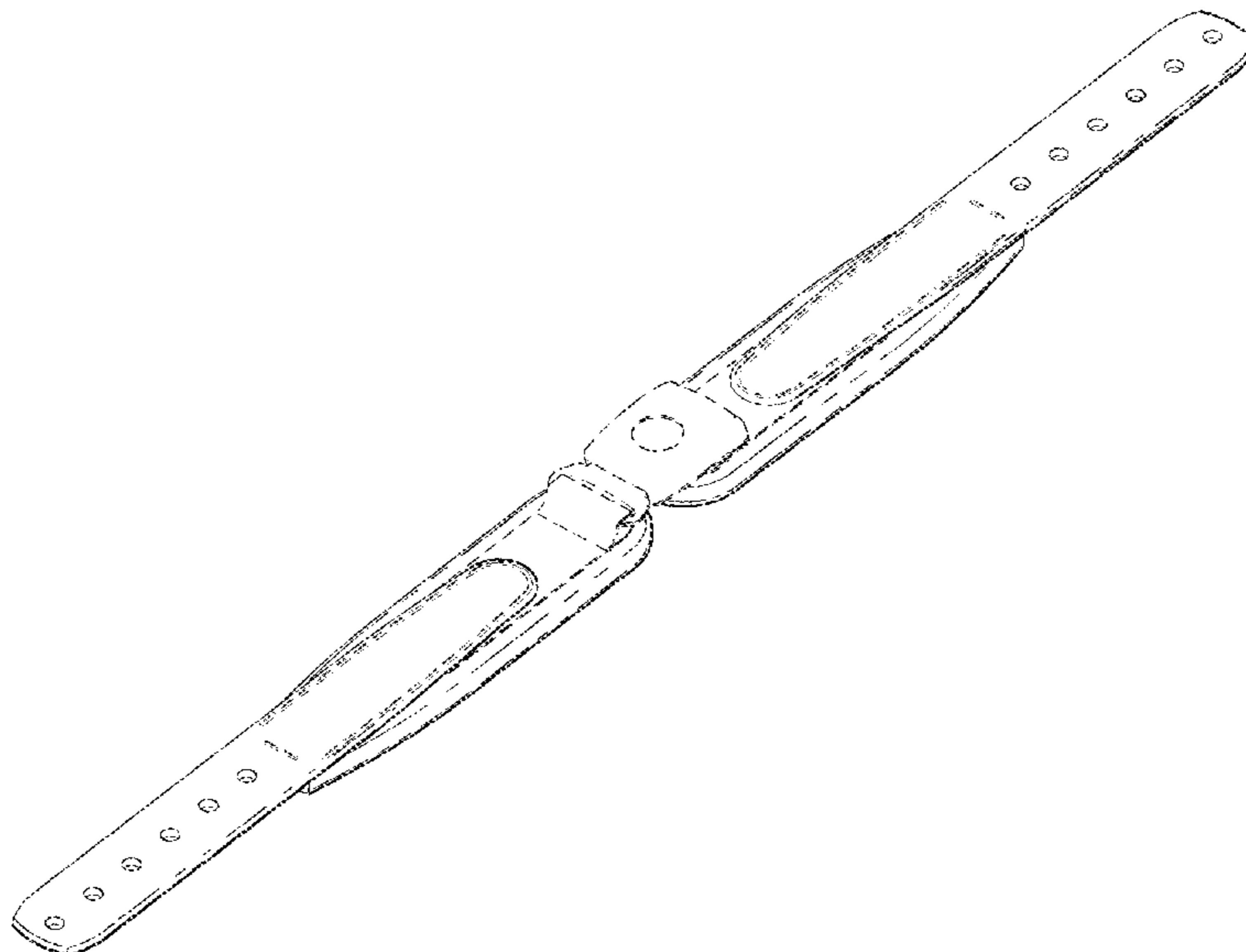
FIG. 7 is a right side elevational view thereof;

FIG. 8 is a front elevational view thereof, the rear elevational view being a mirror image thereof; and,

FIG. 9 is a left elevational view thereof.

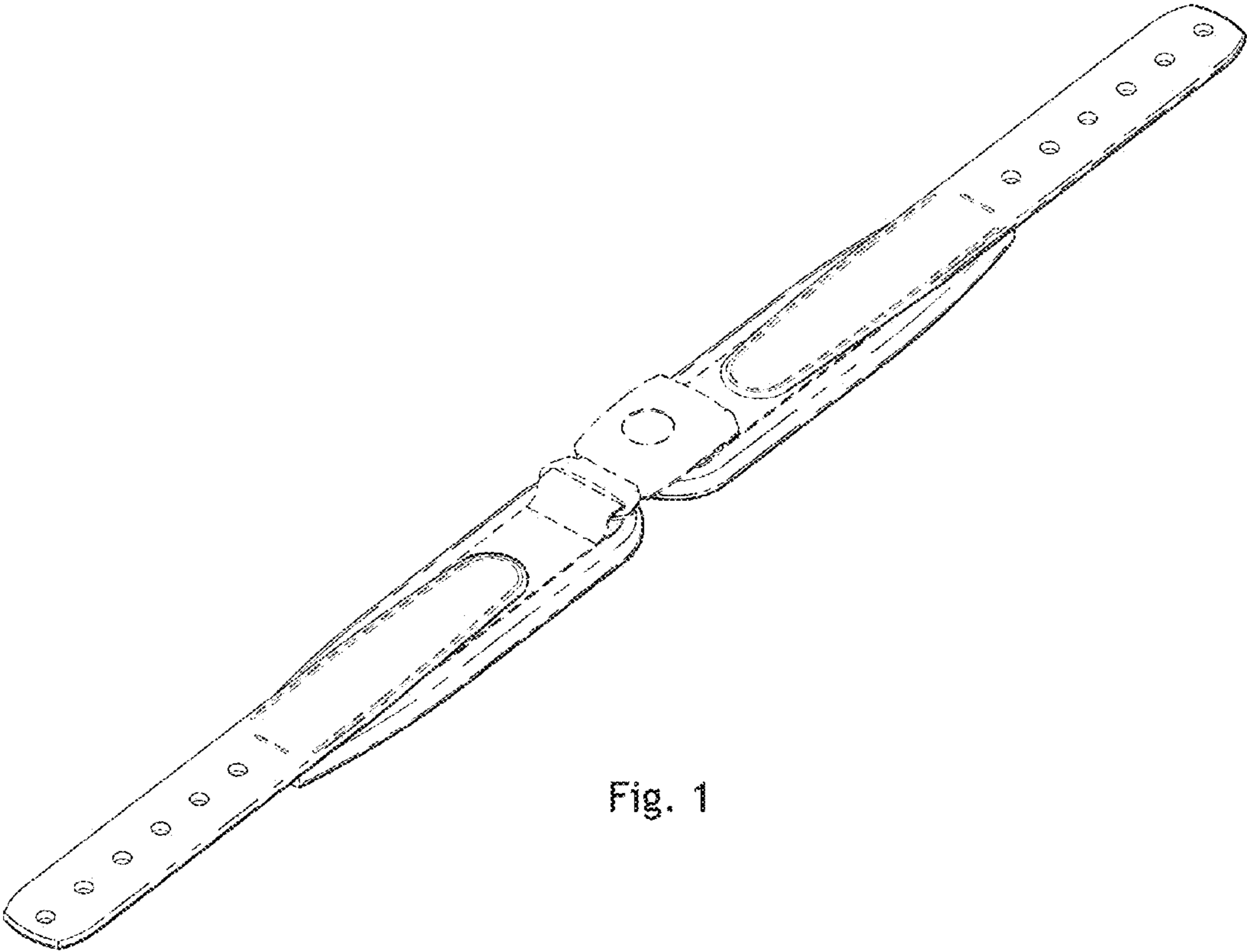

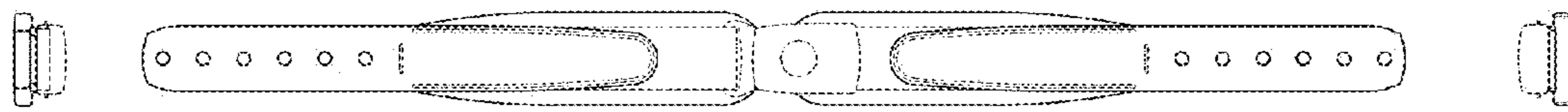

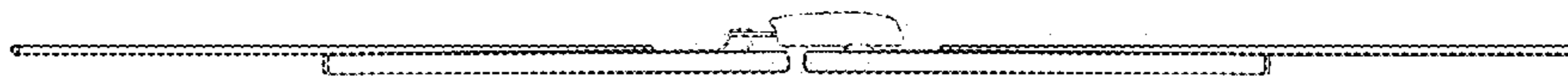

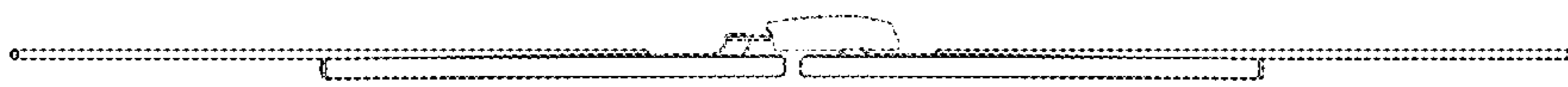
