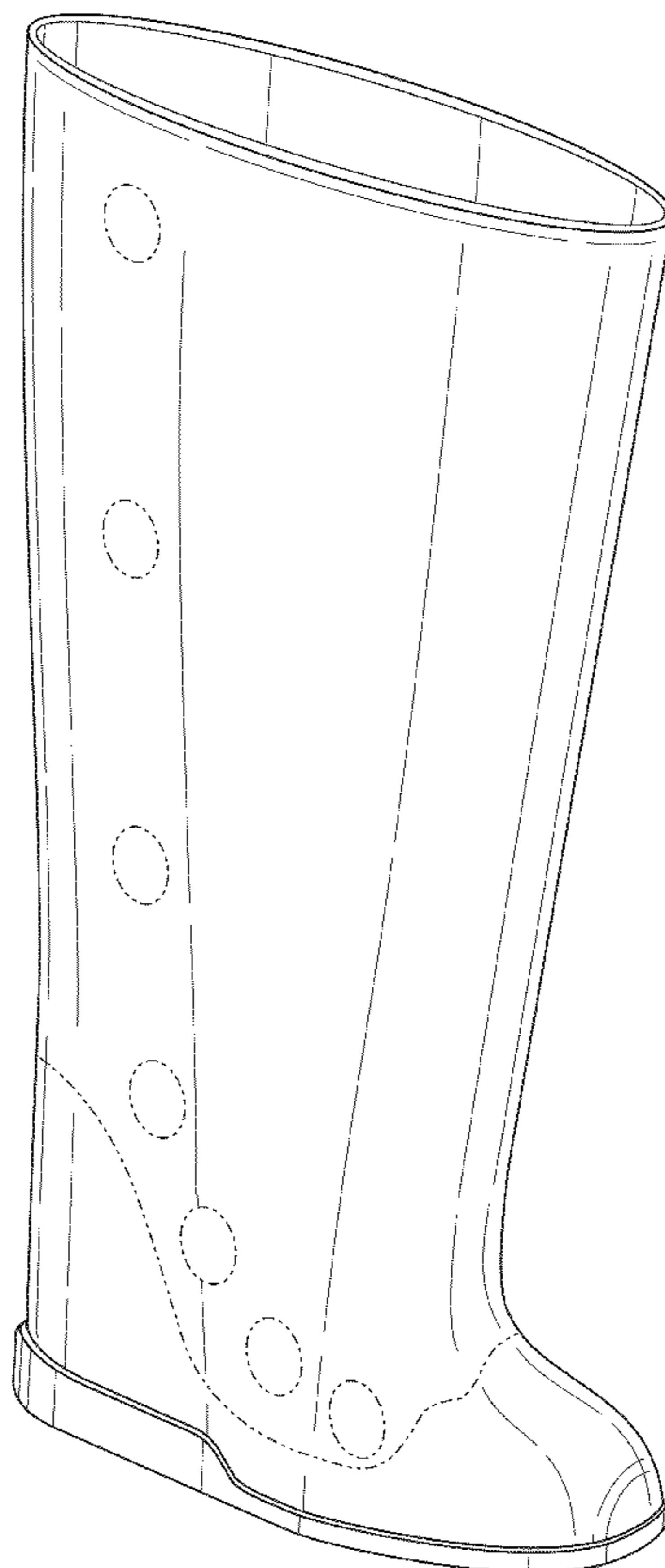
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a right side perspective view of the overboot according to the present invention;
FIG. 2 is a left side perspective view of the overboot;

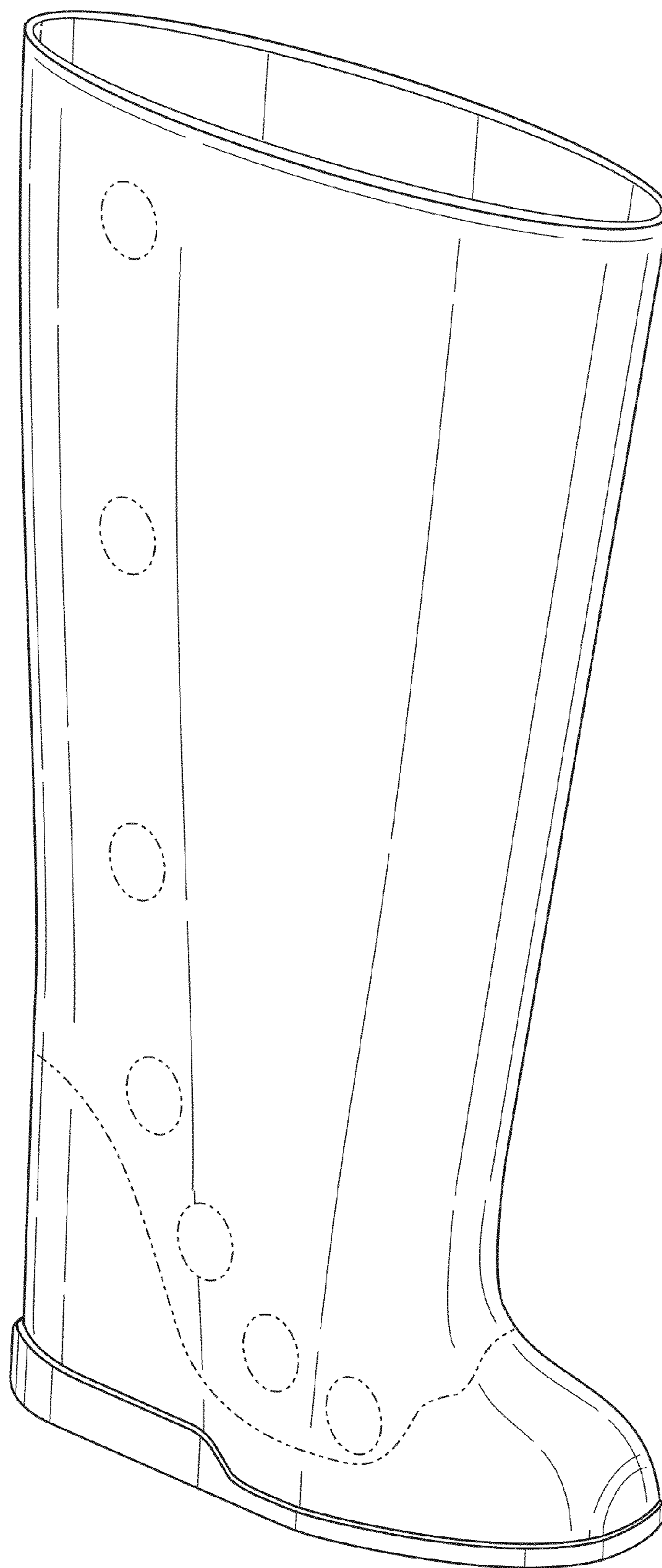

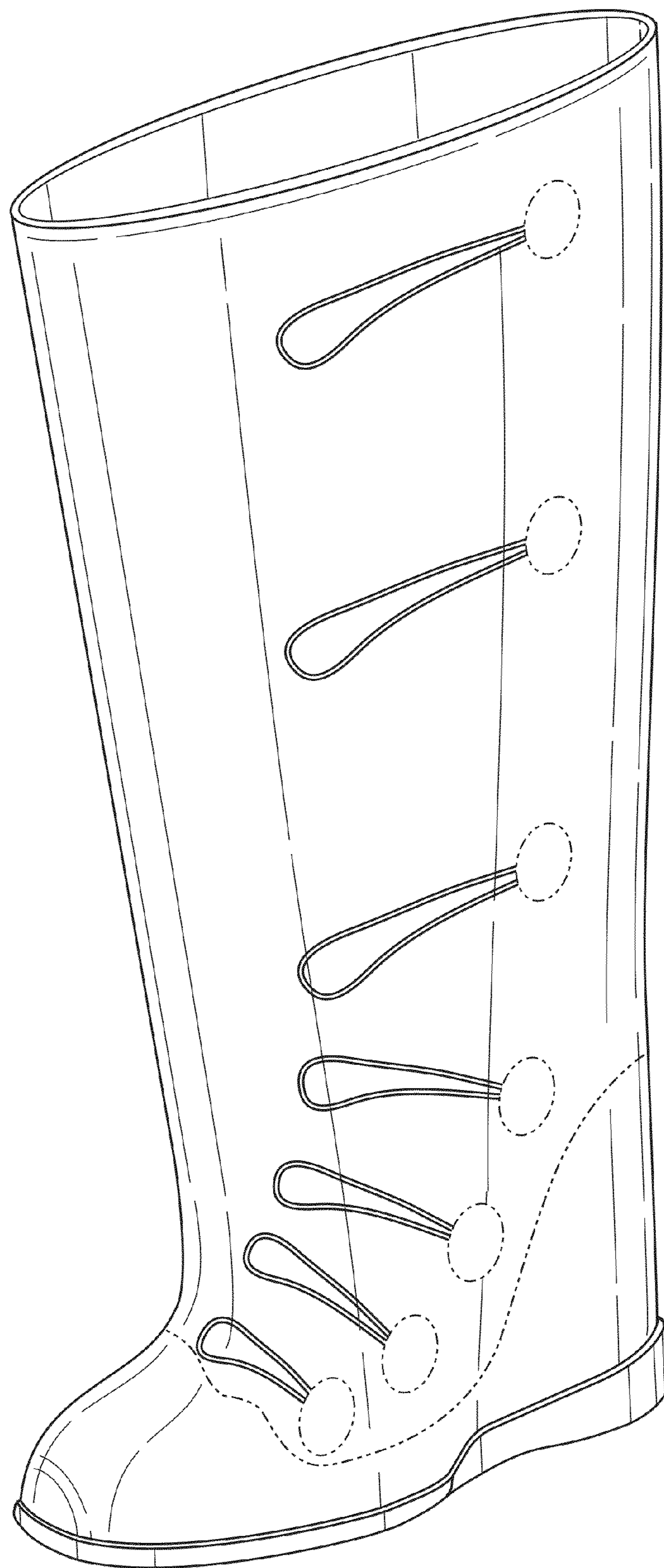

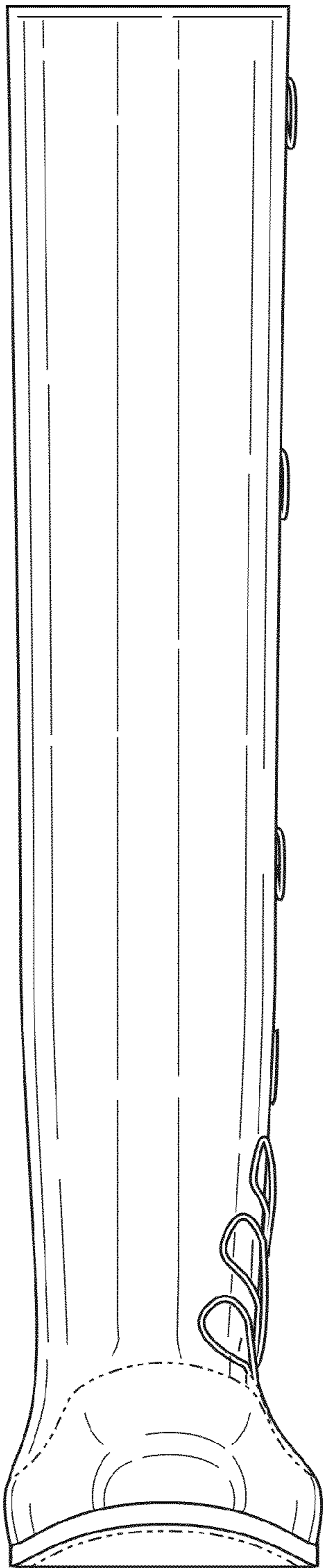

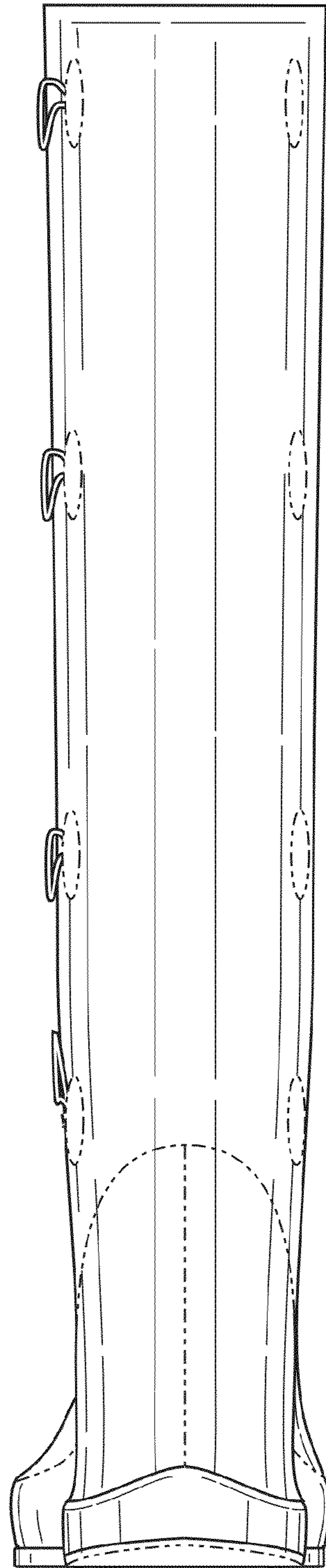

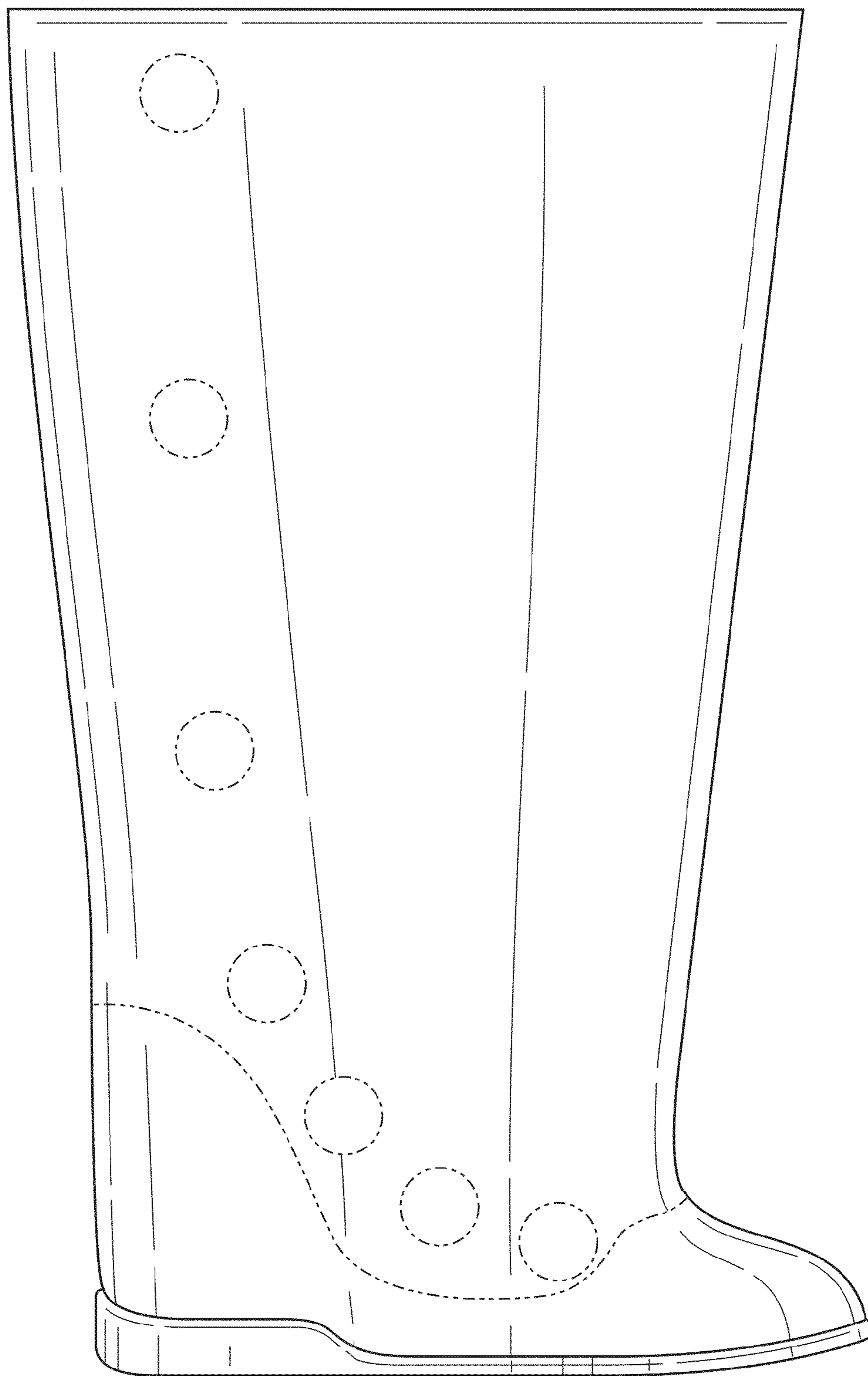

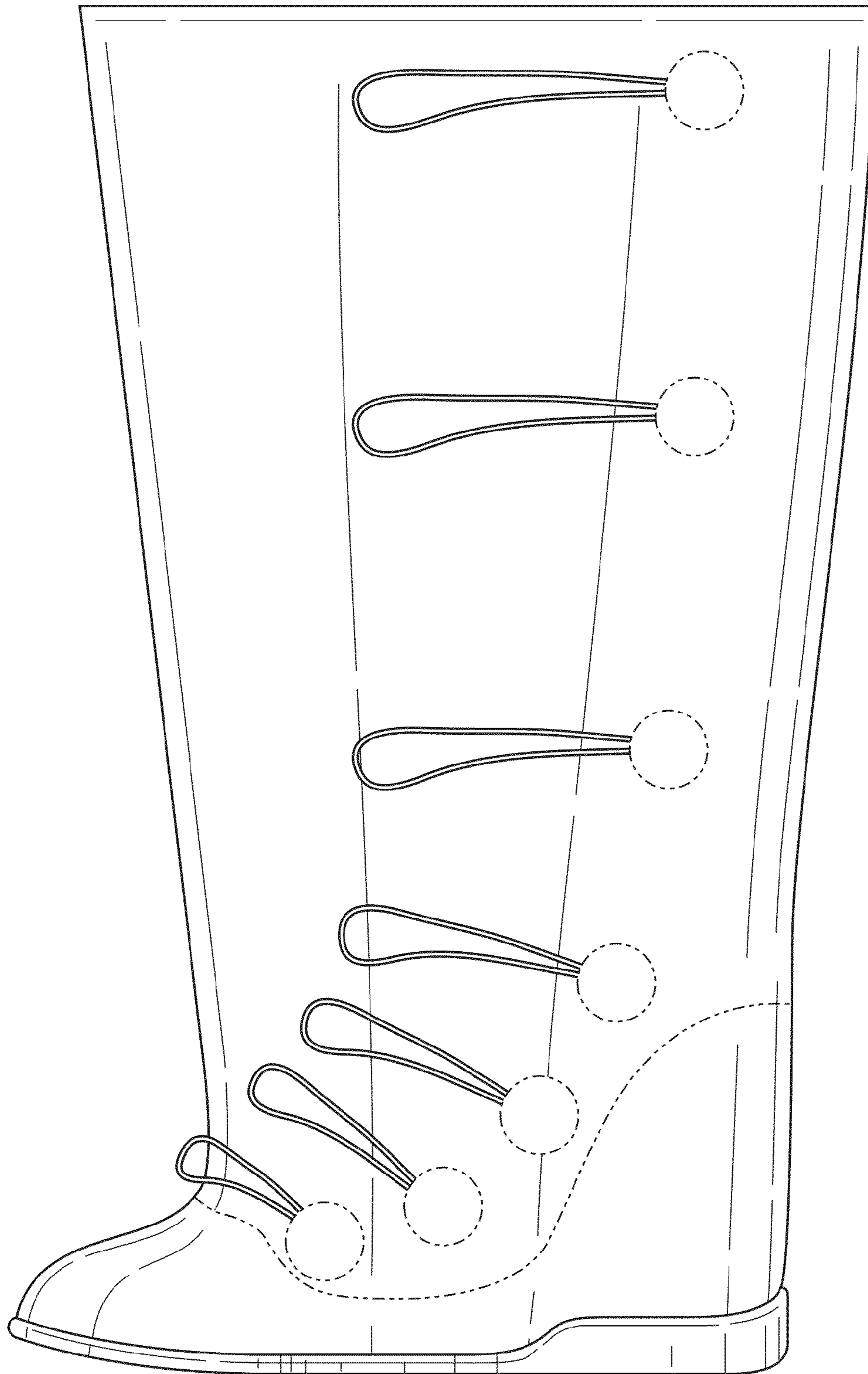

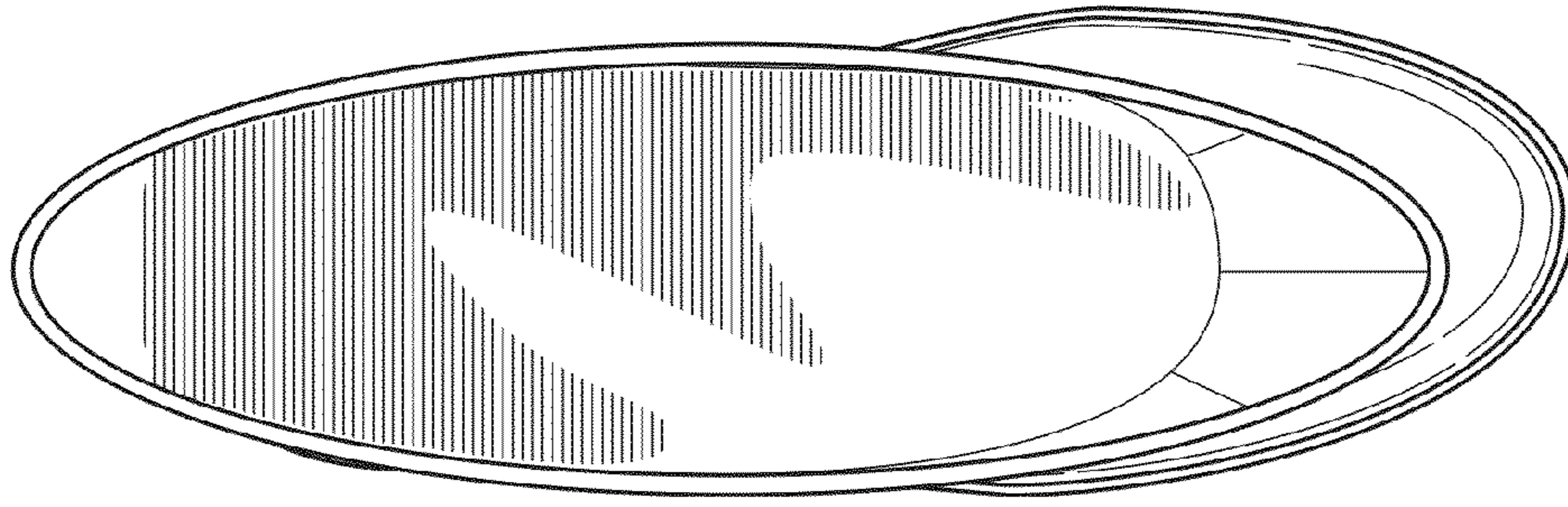

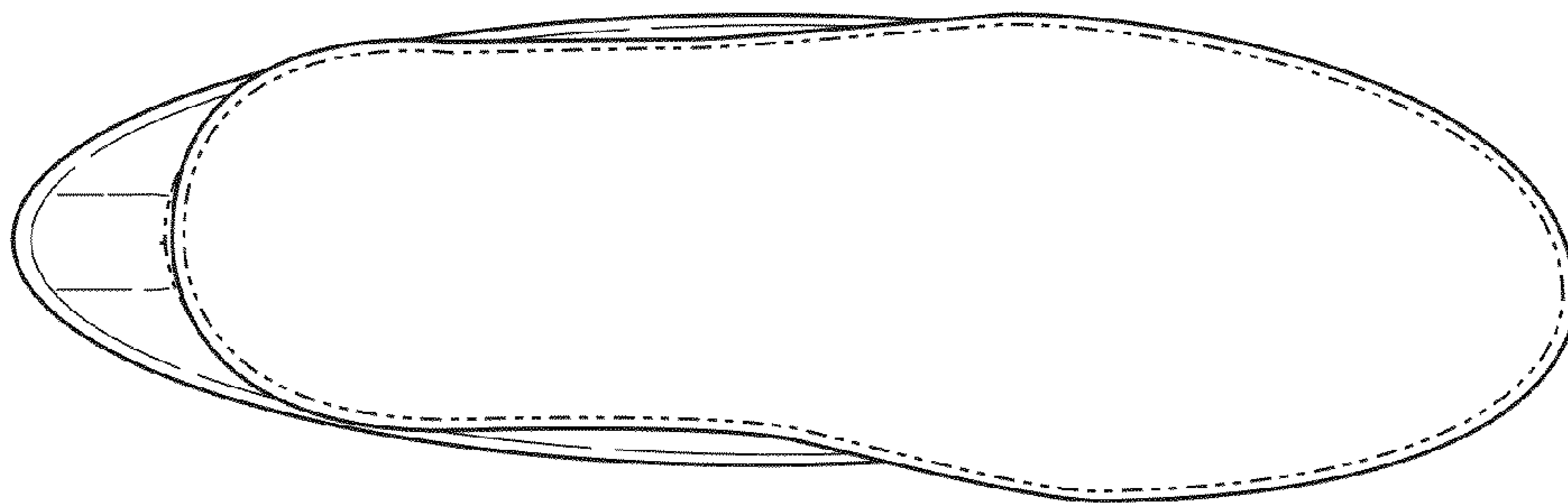
