The ornamental design for a folding zipper shoe, as shown and described.

**DESCRIPTION**

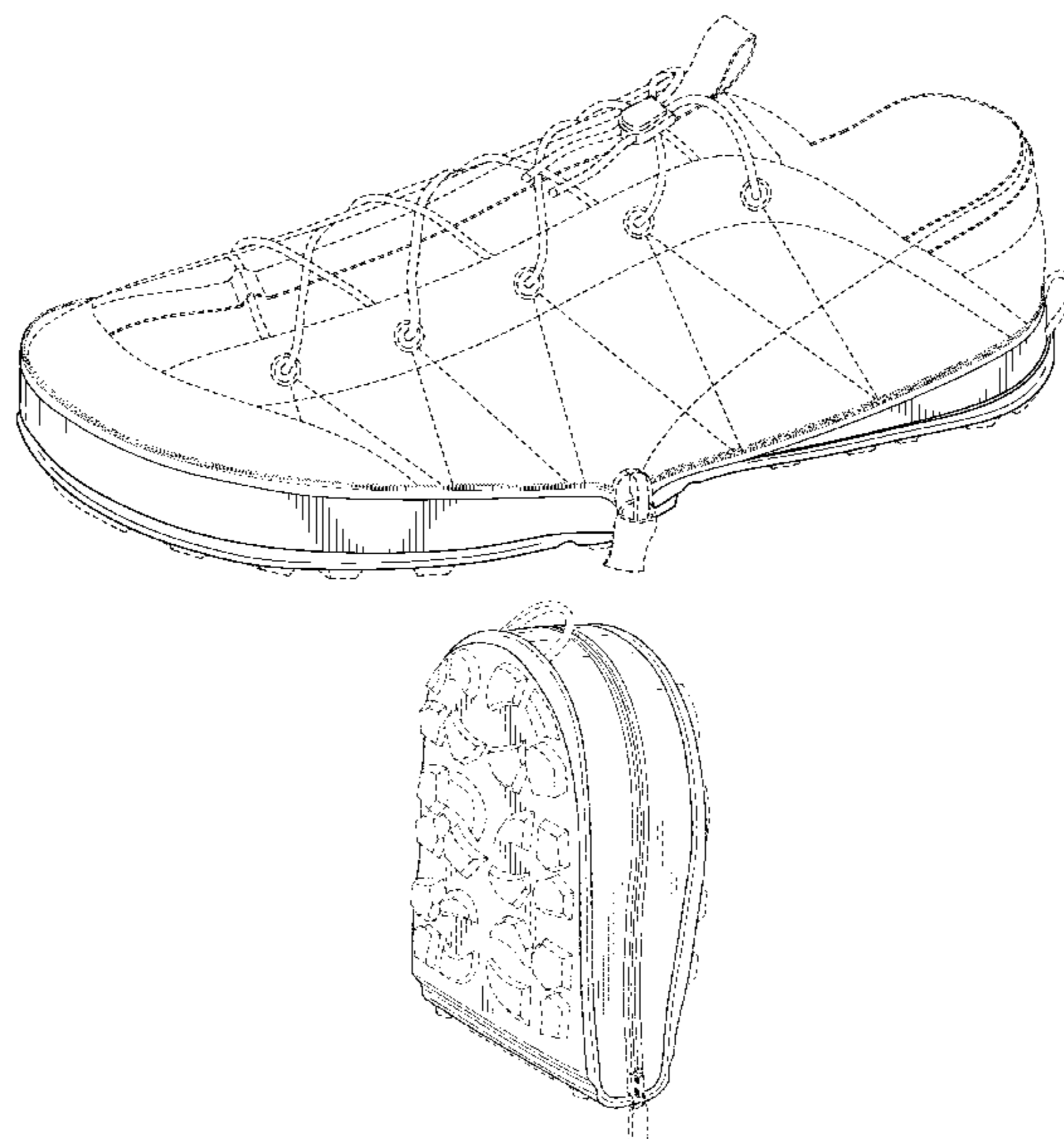
FIG. 1 is a perspective view of a folding zipper shoe showing my new design;

 FIG. 7 is a bottom plan view thereof;  
 FIG. 8 is a perspective view of the folding zipper shoe of FIG. 1 shown in a closed configuration;  
 FIG. 9 is a view of a heel portion of the bottom of the folding zipper shoe shown in a closed configuration;  
 FIG. 10 is a view of a forefoot portion of the bottom of the folding zipper shoe shown in a closed configuration;  
 FIG. 11 is a left side view thereof;  
 FIG. 12 is a right side view thereof;  
 FIG. 13 is a top plan view thereof; and,  
 FIG. 14 is a bottom view of an arch portion of the folding zipper shoe shown in a closed configuration.  
 The broken lines shown in the drawings represent portions of the folding zipper shoe that form no part of the claimed design.

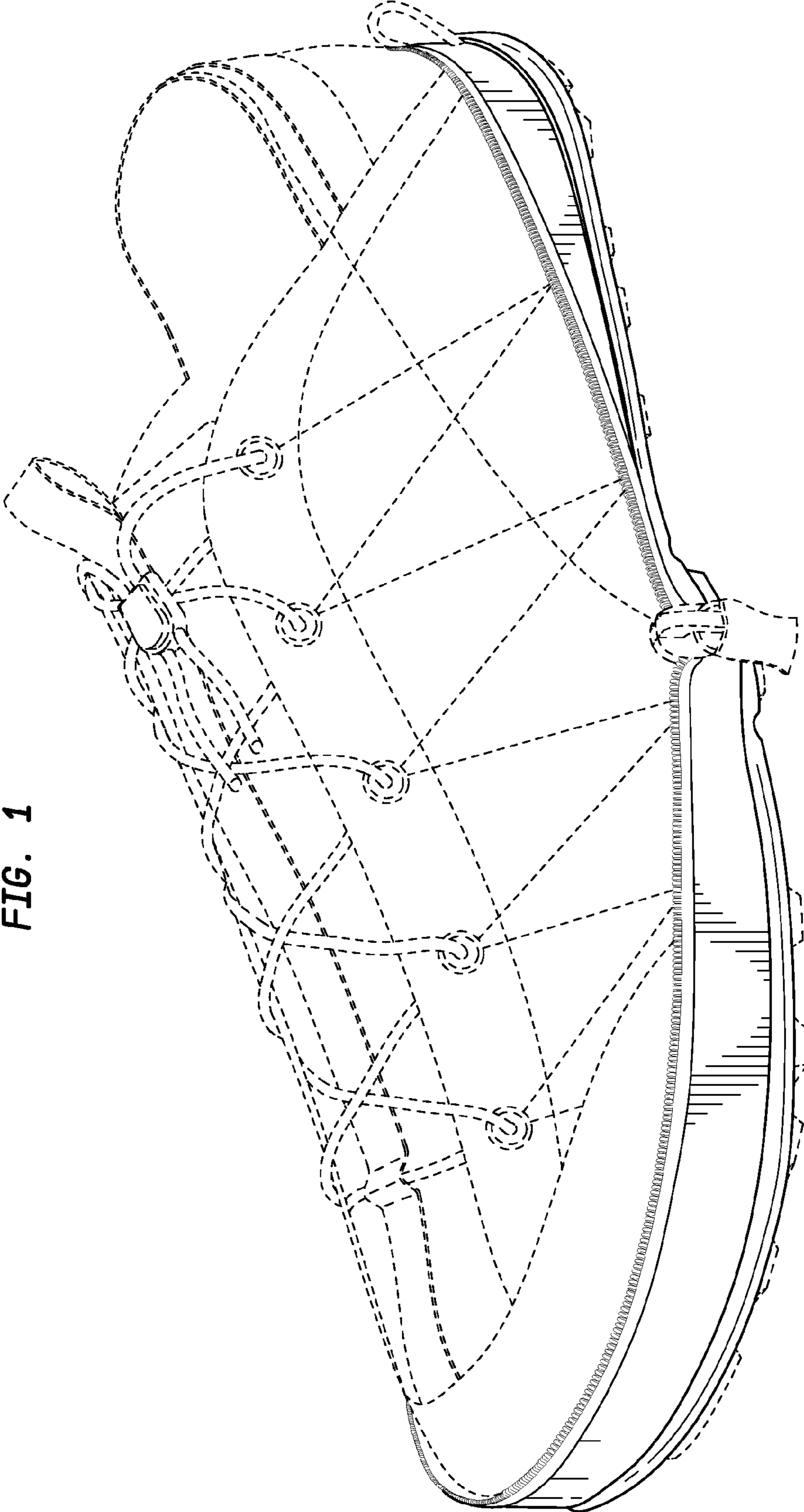

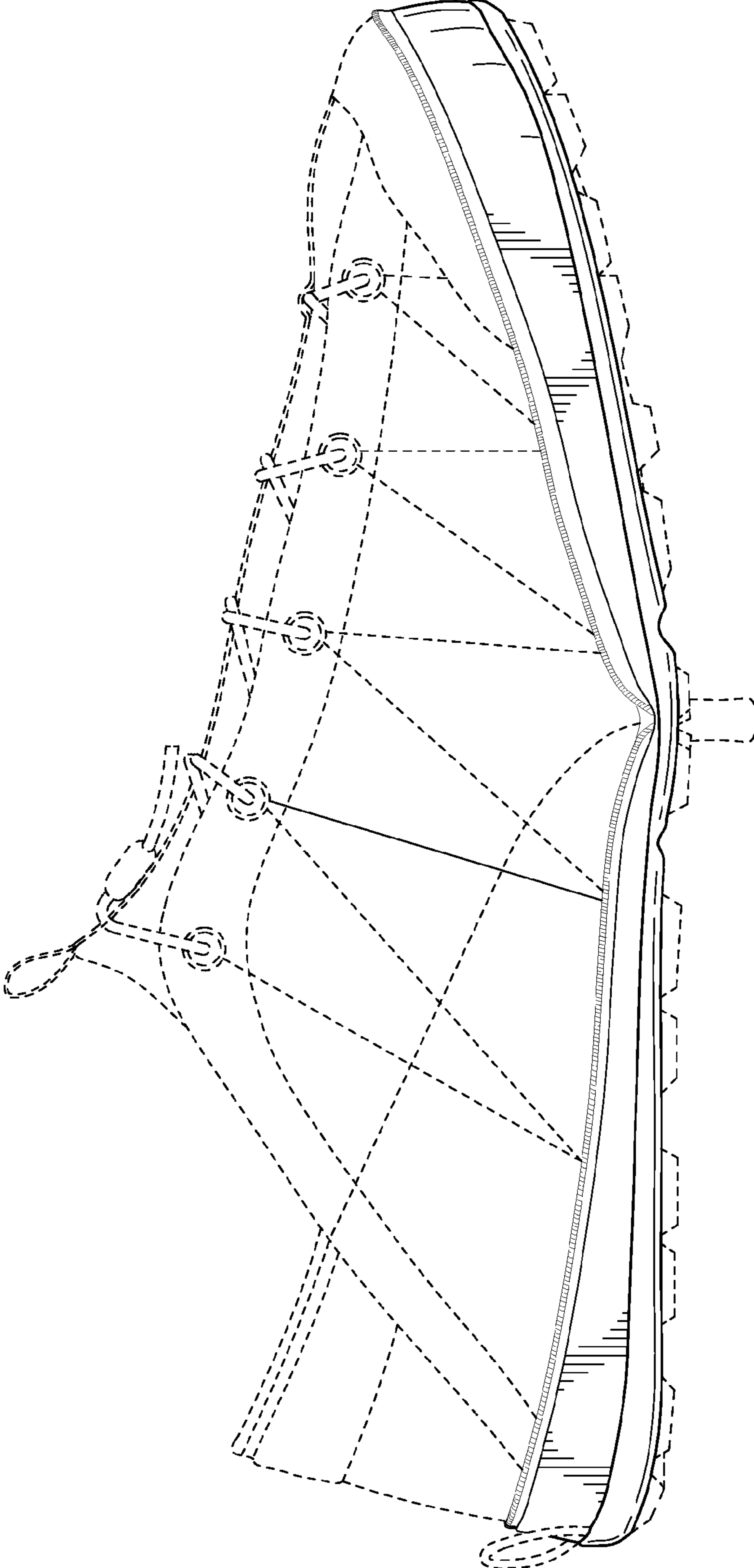

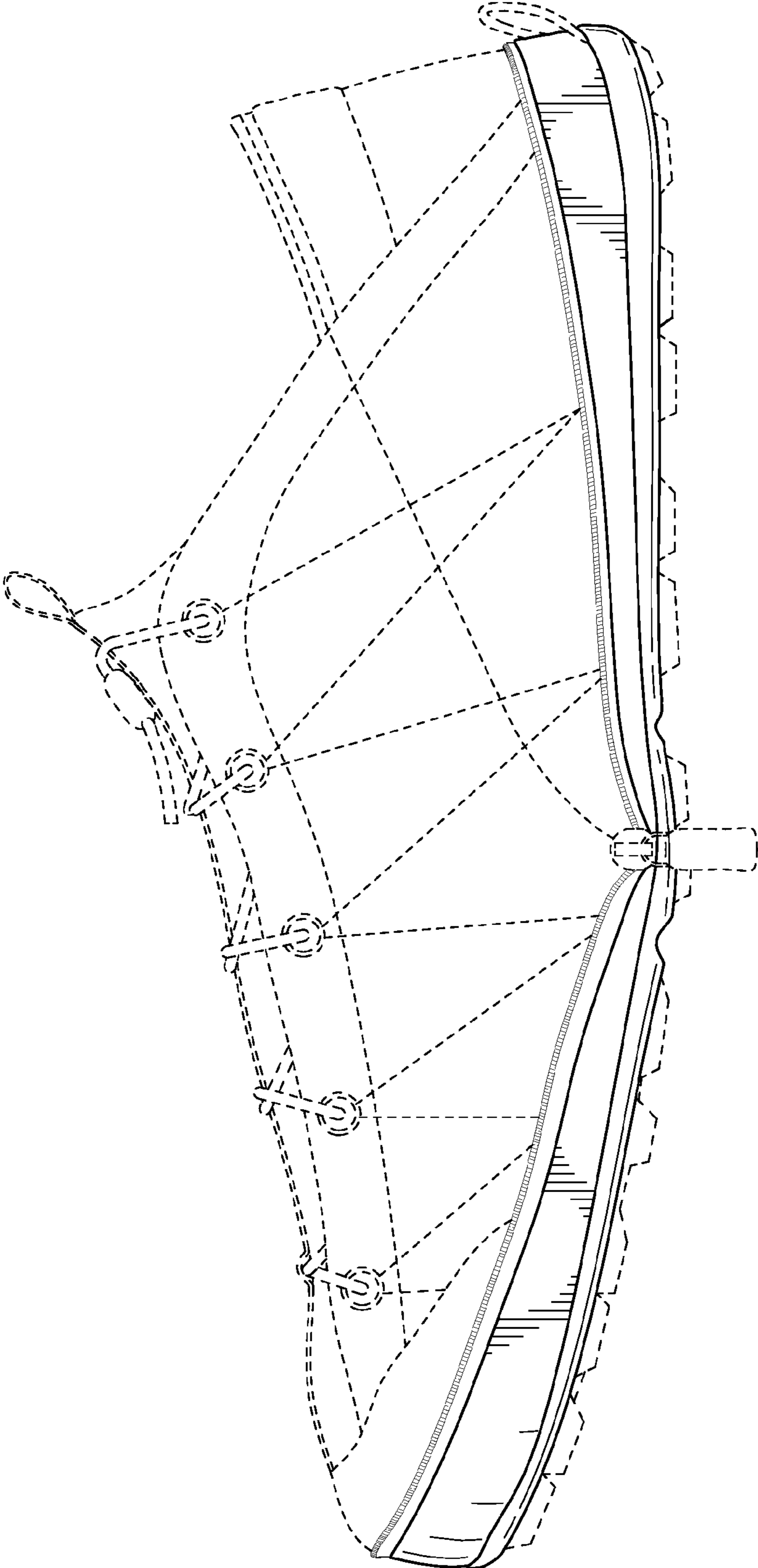

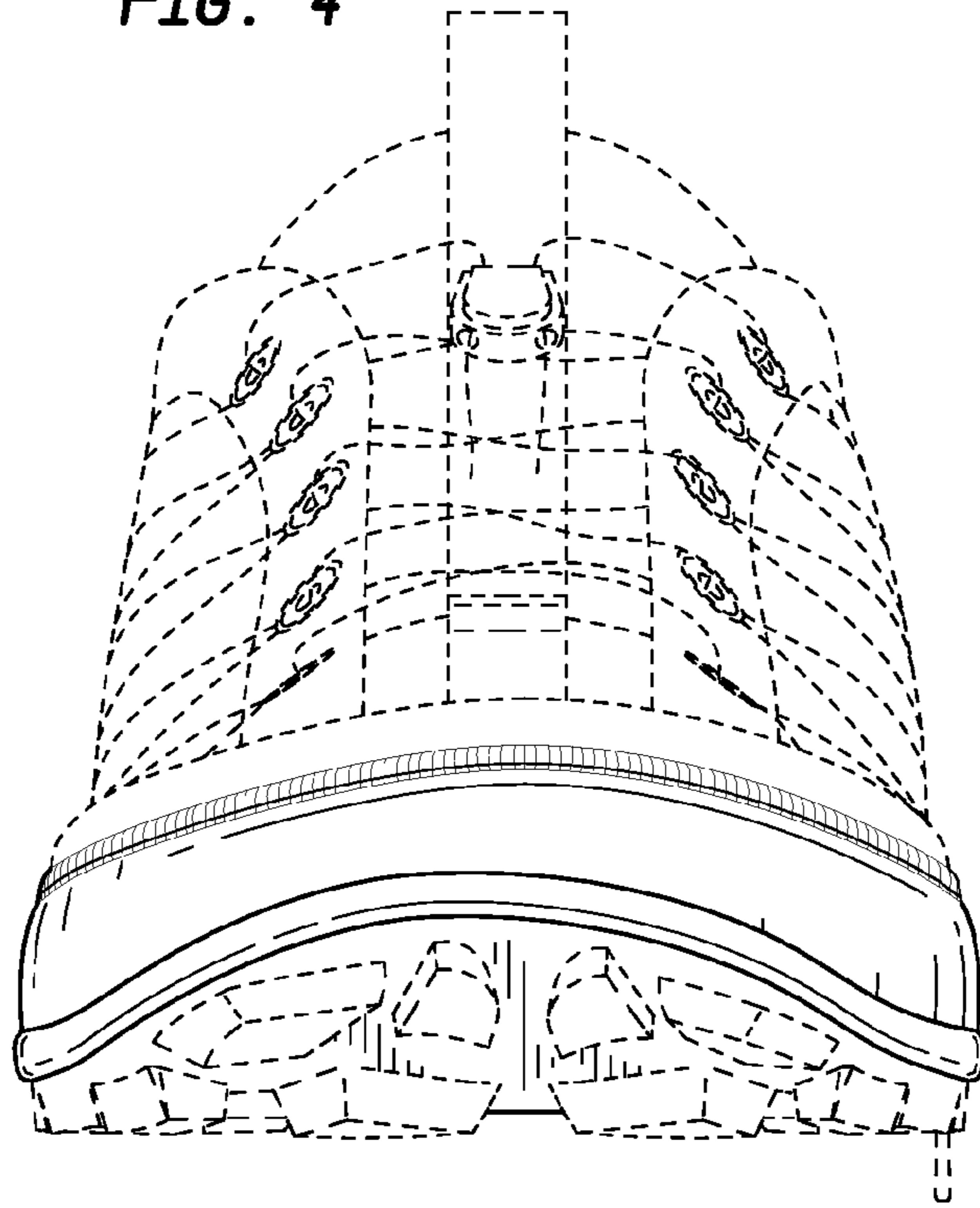

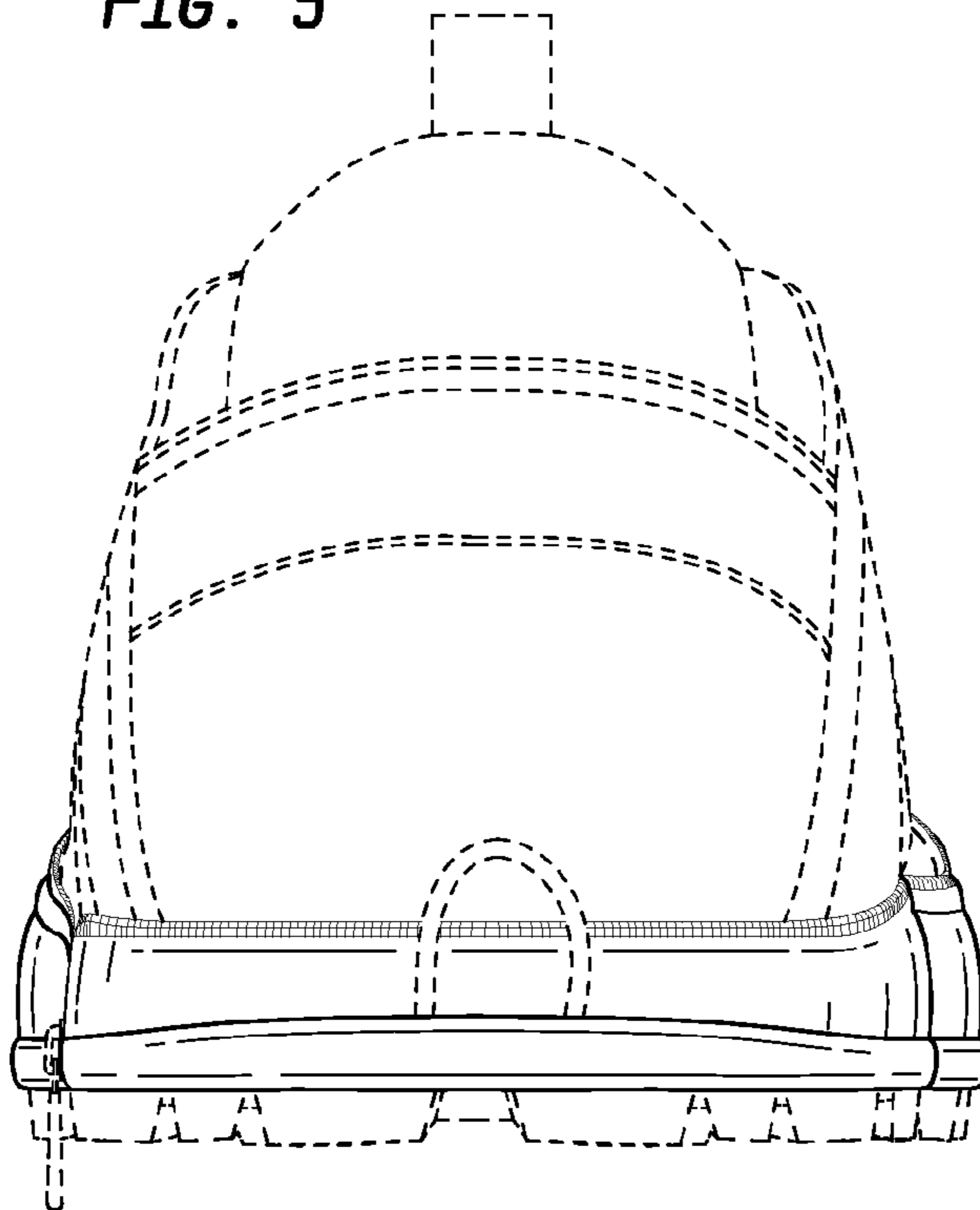

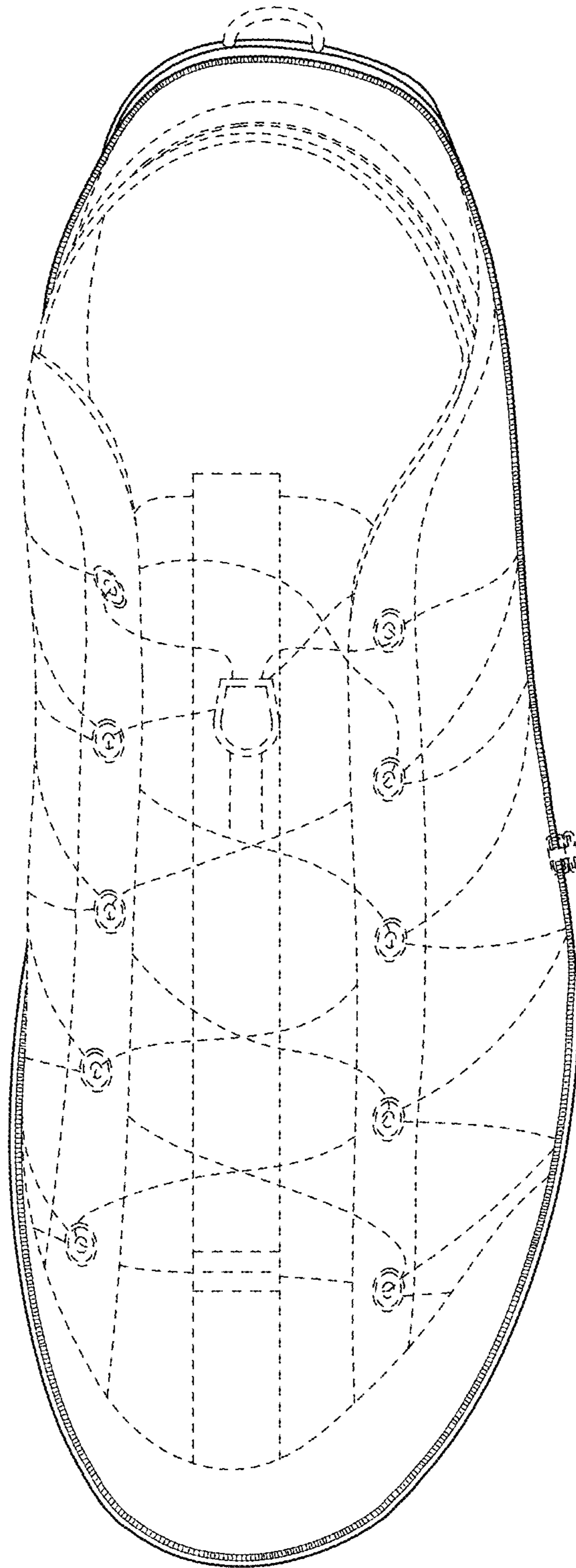

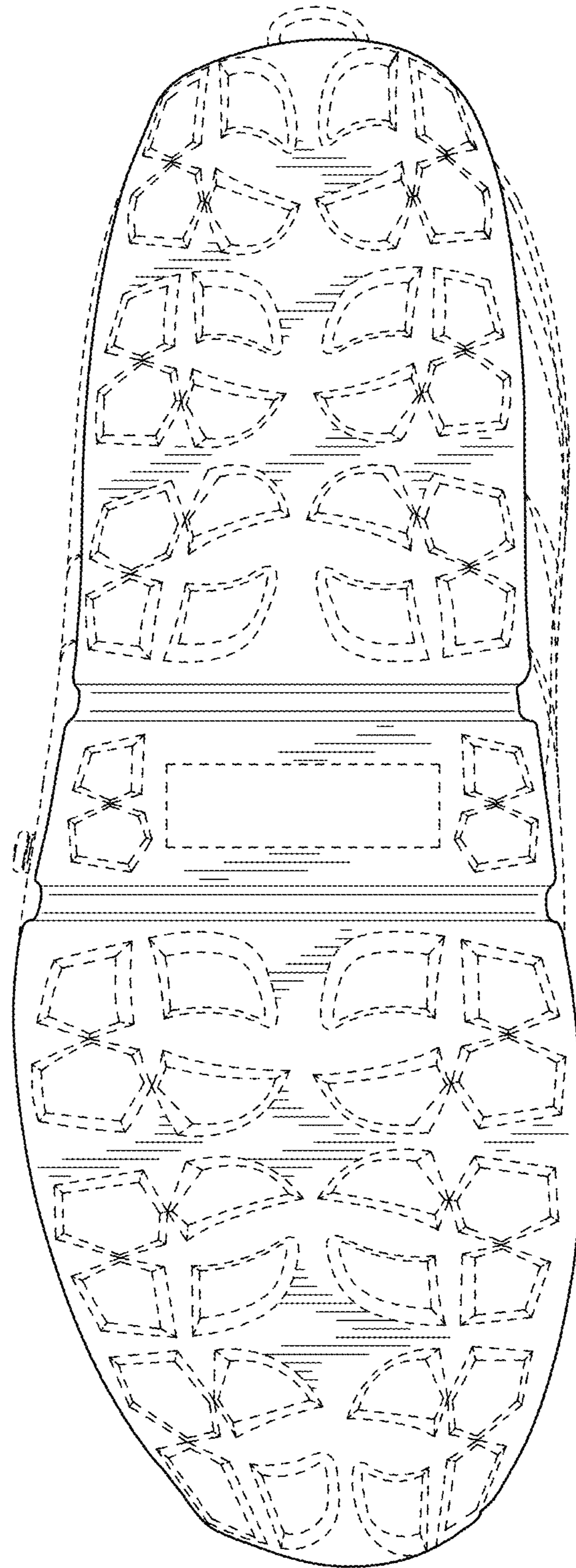

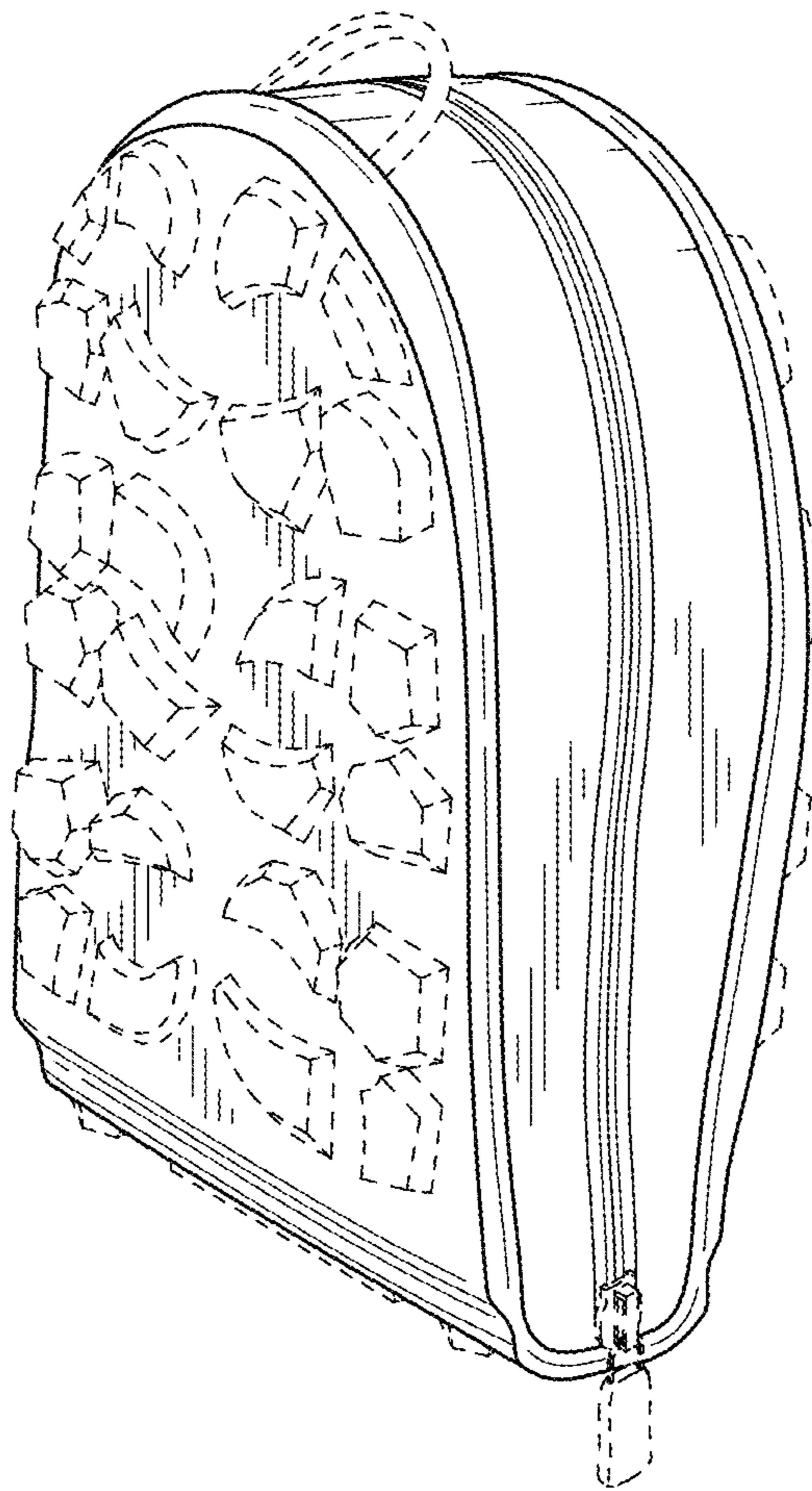

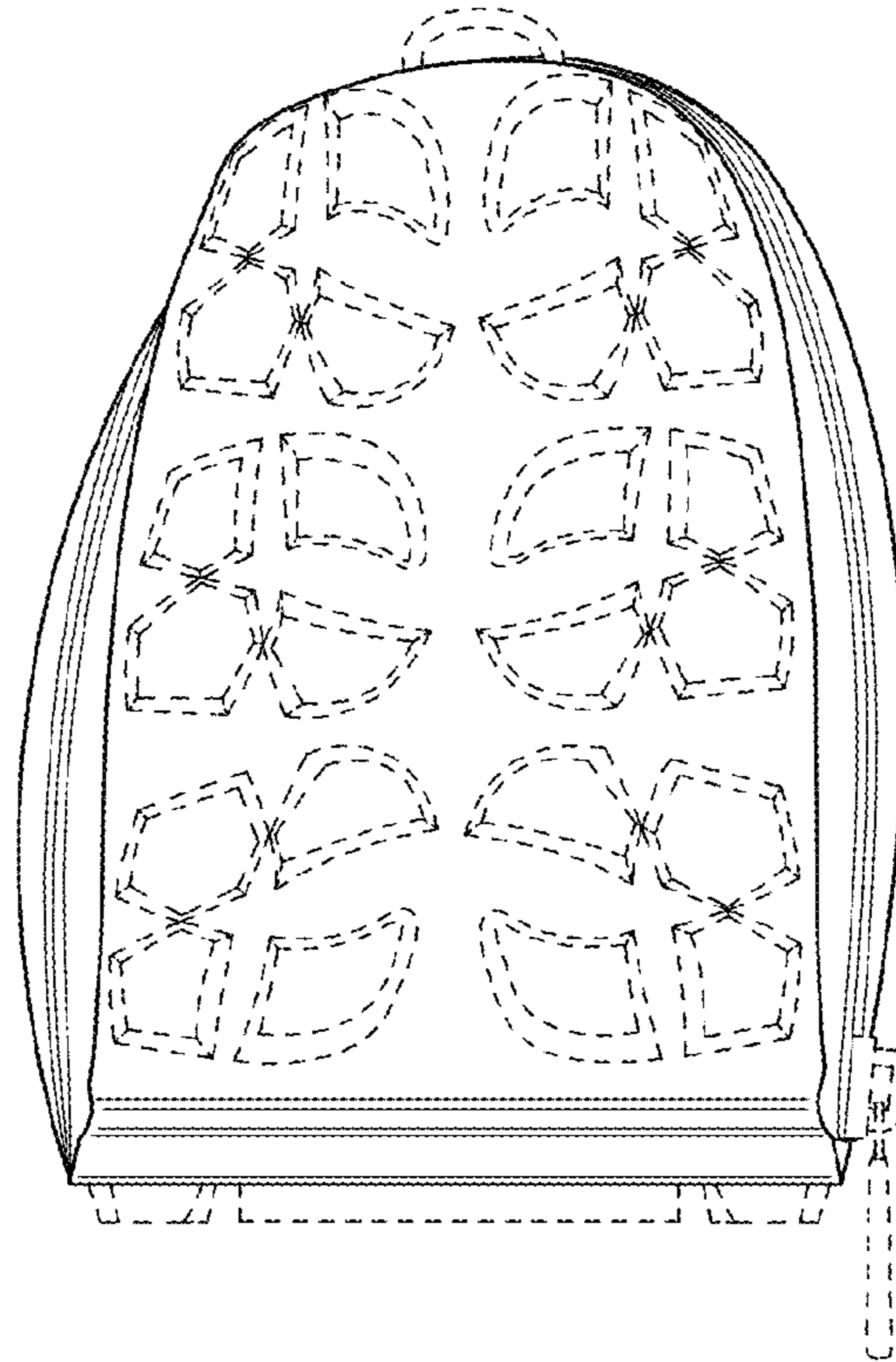
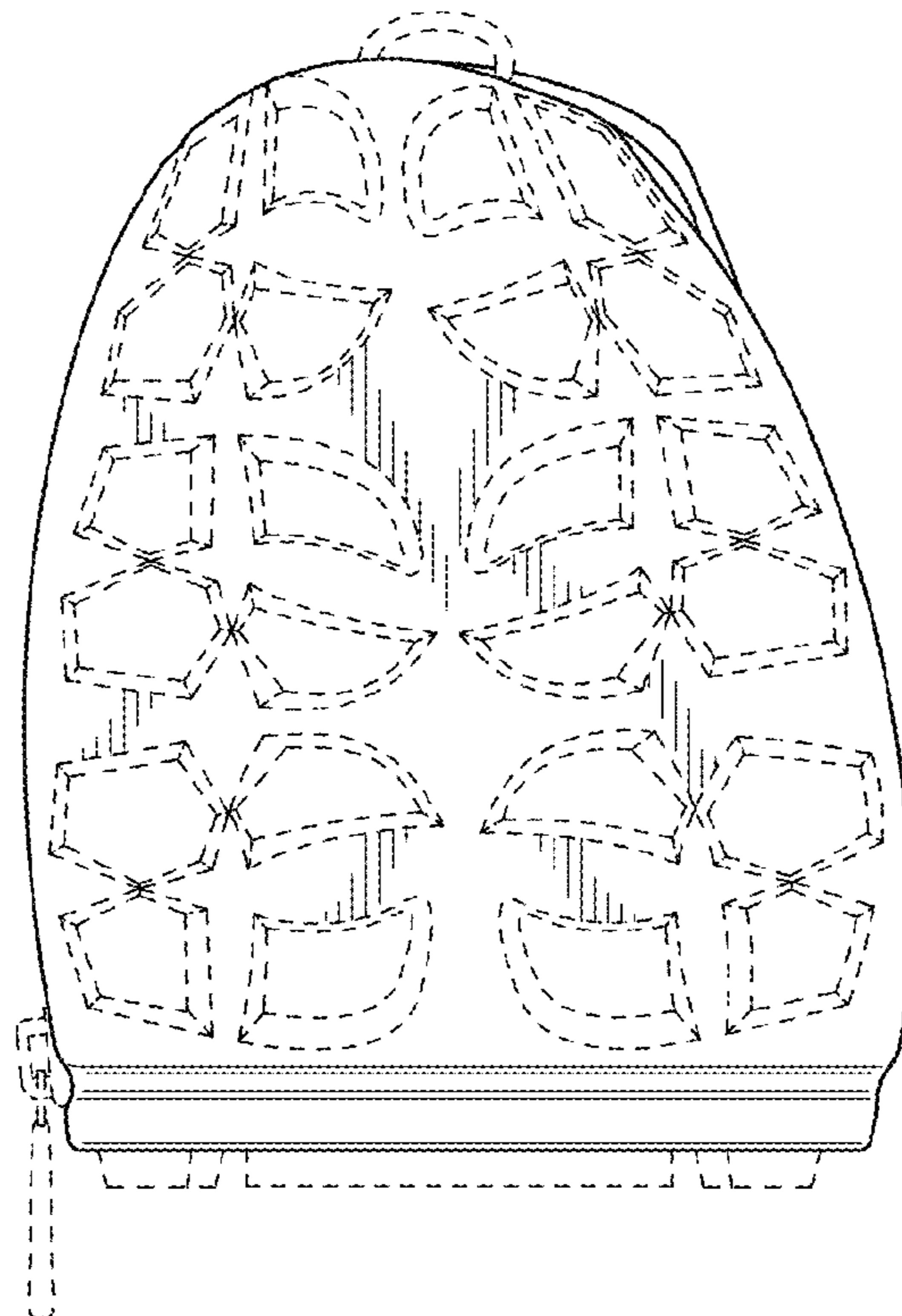
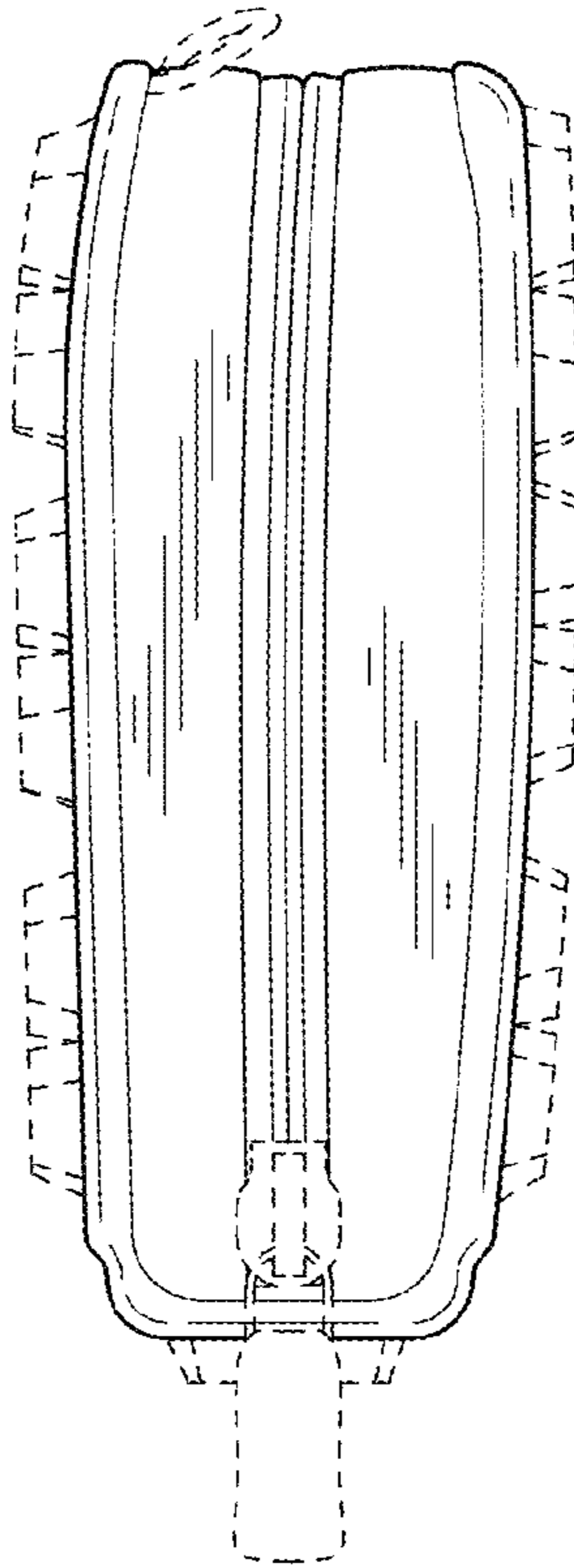

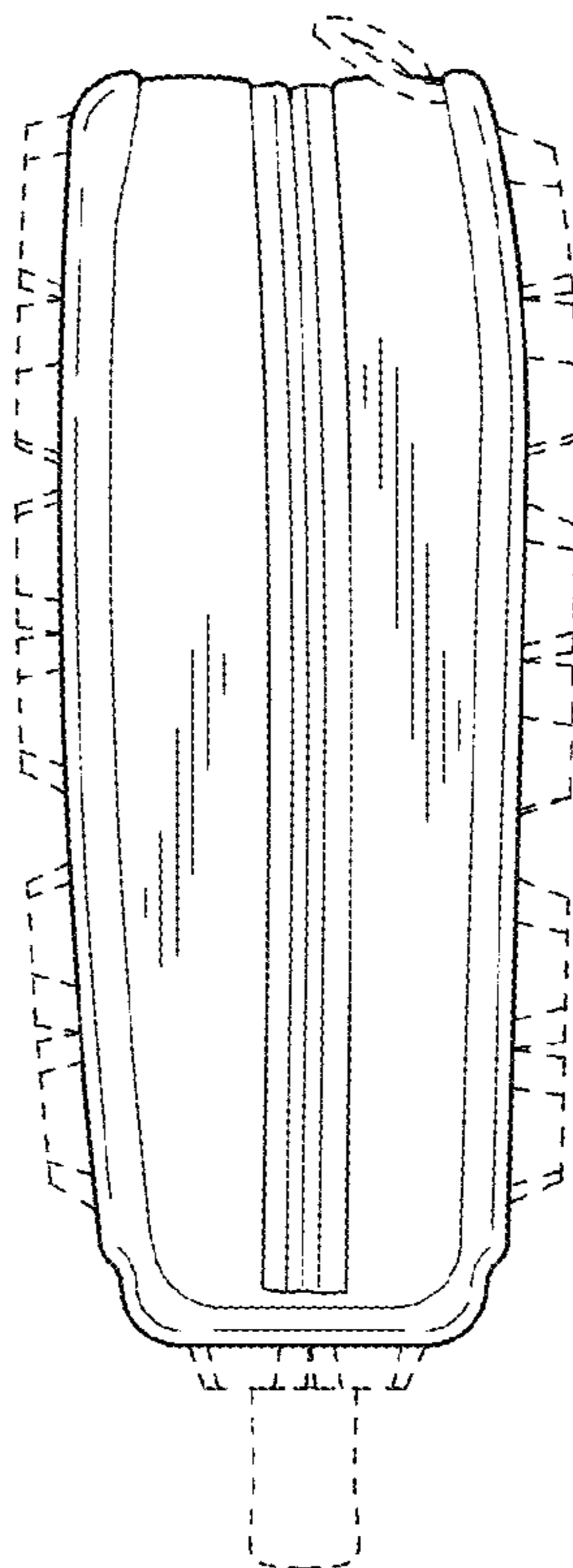

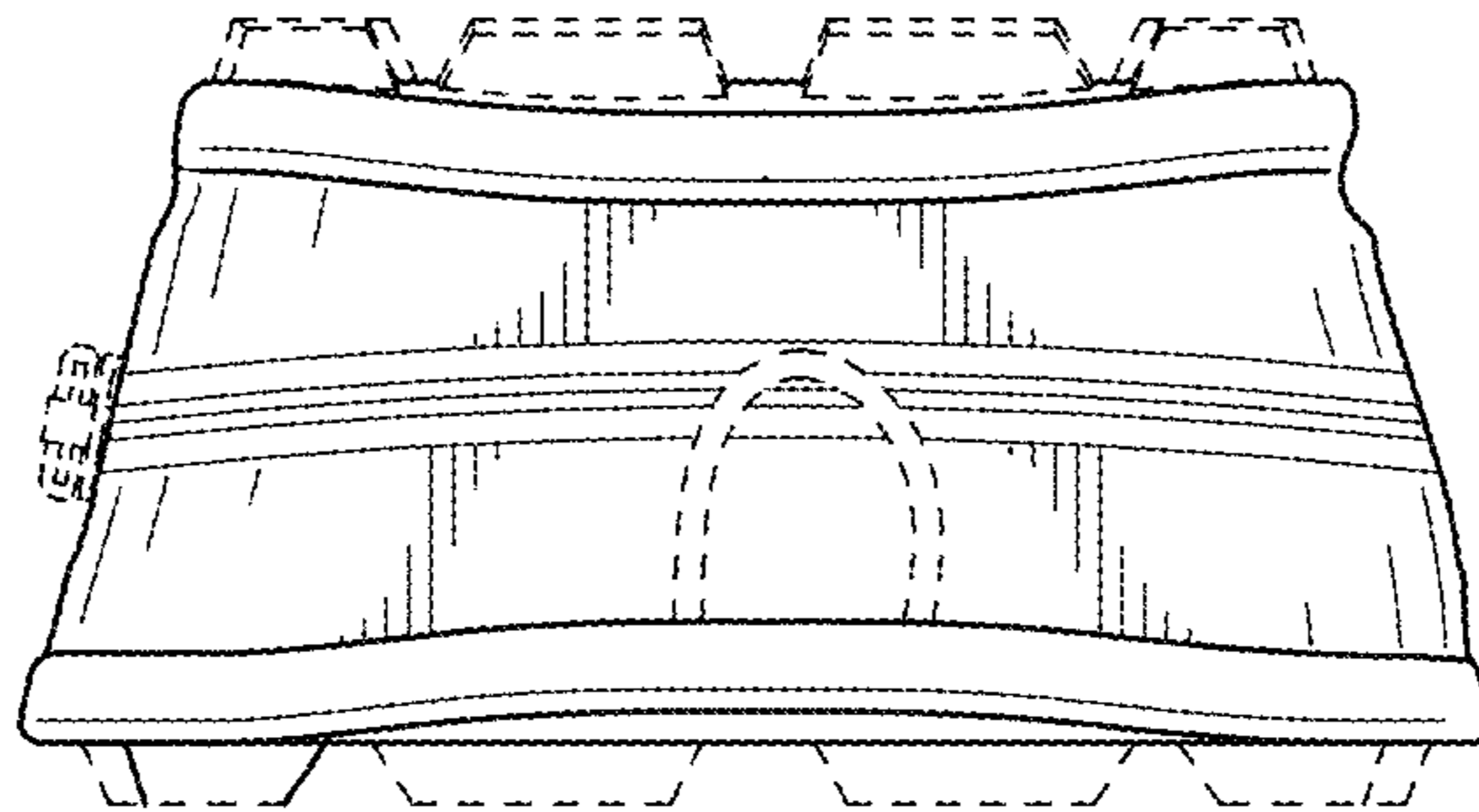
