(57) **CLAIM**

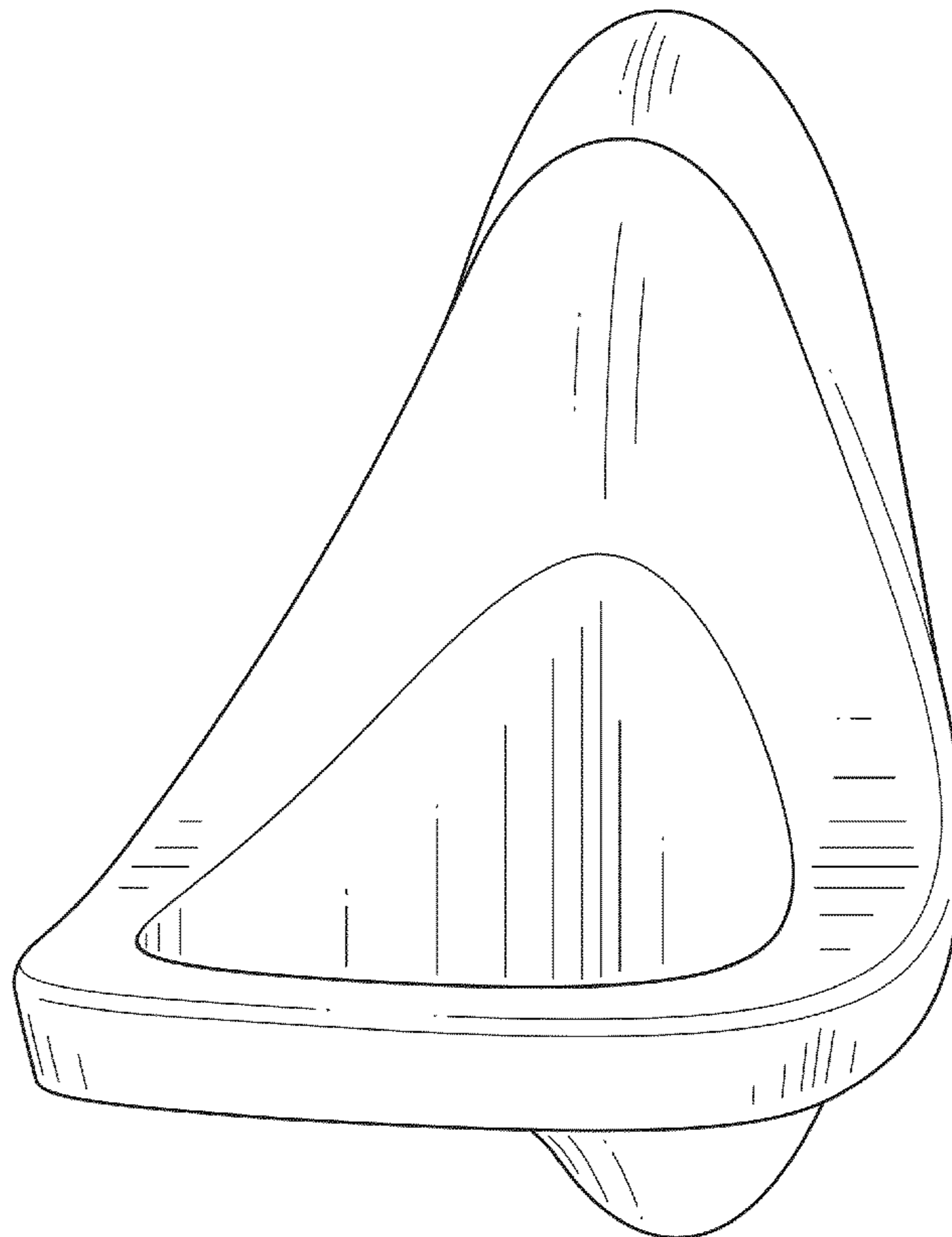
The ornamental design for a cup holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a cup holder showing the new design;
FIG. 2 is a right side view thereof, the left side view being a mirror image thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.

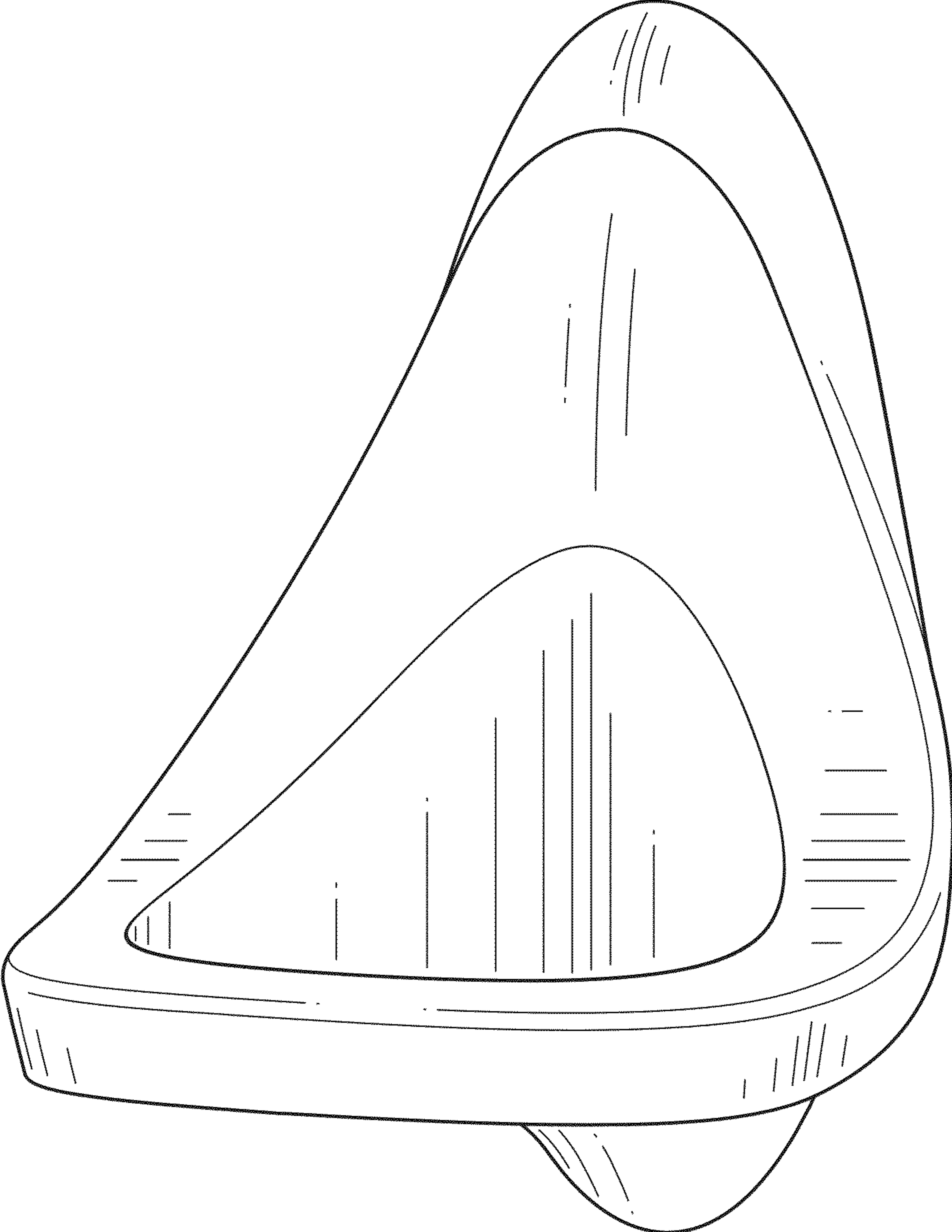

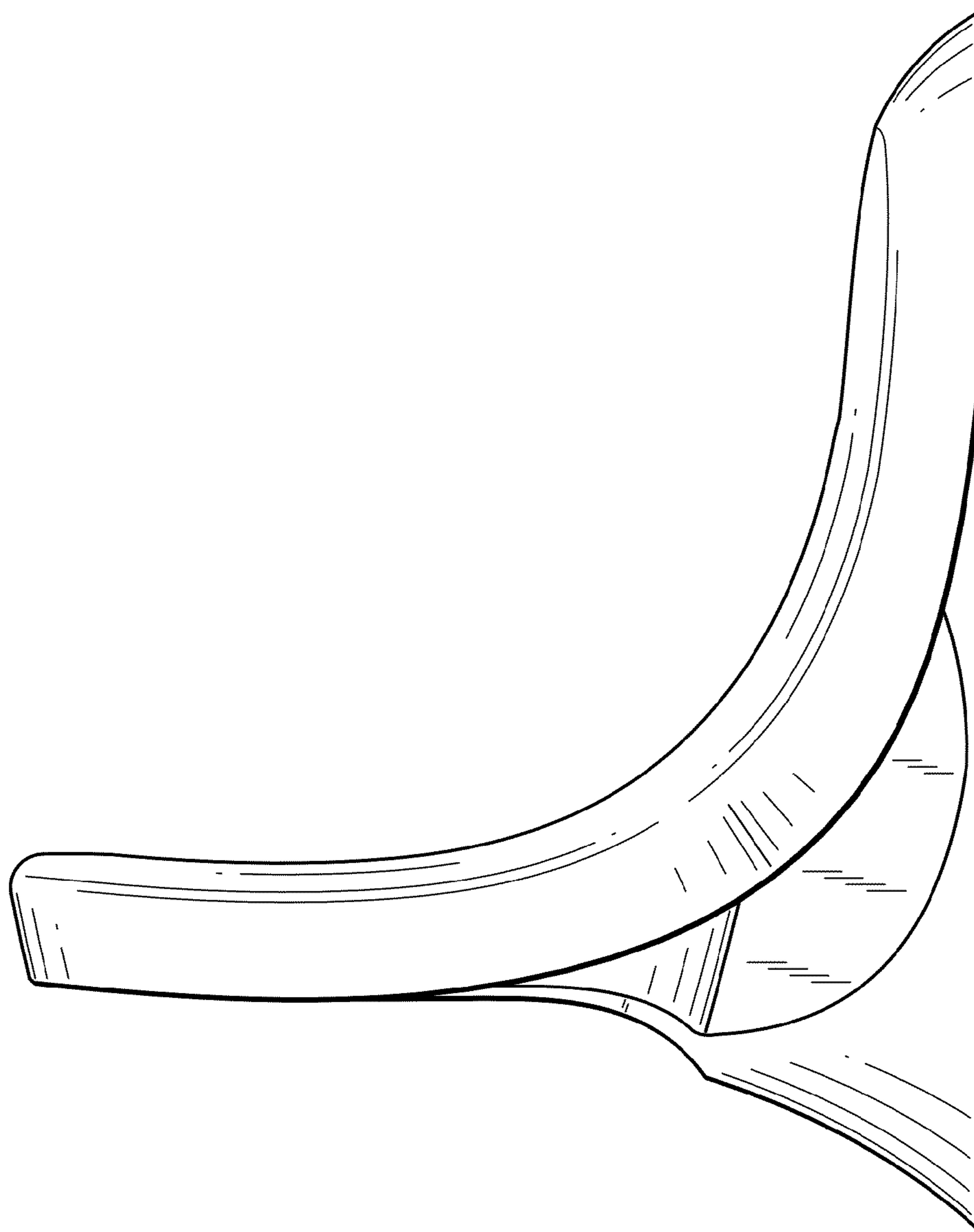

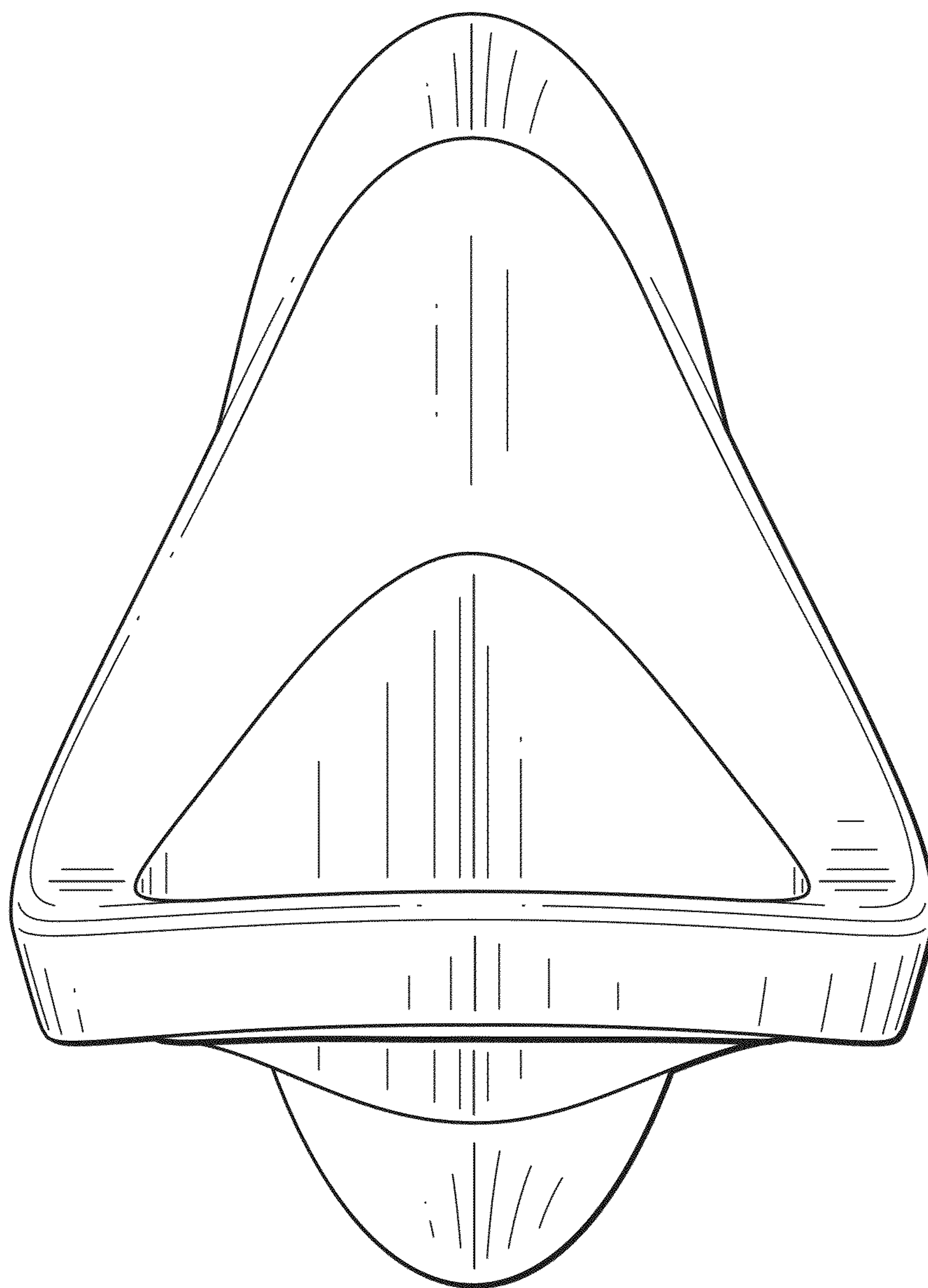

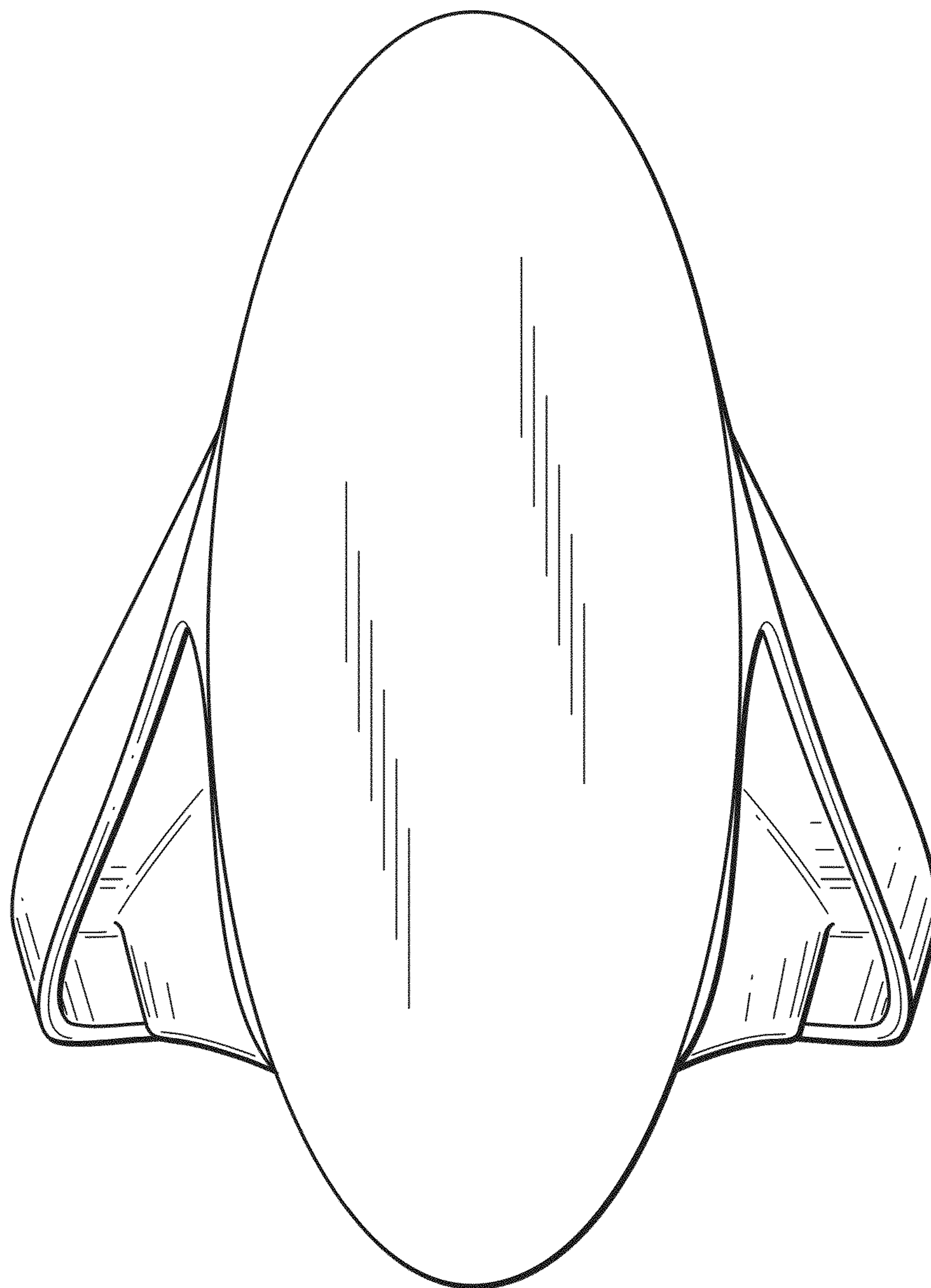

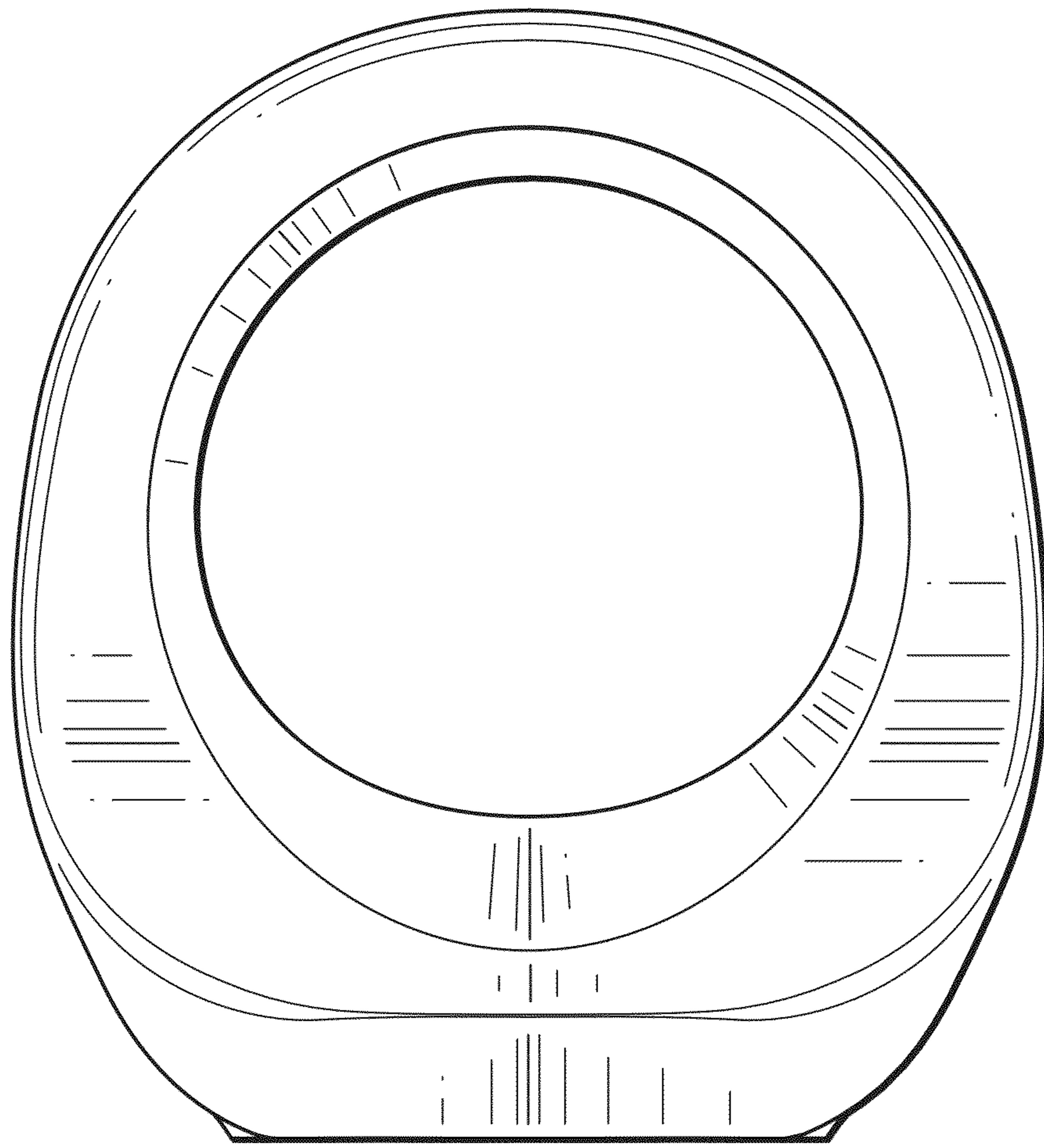

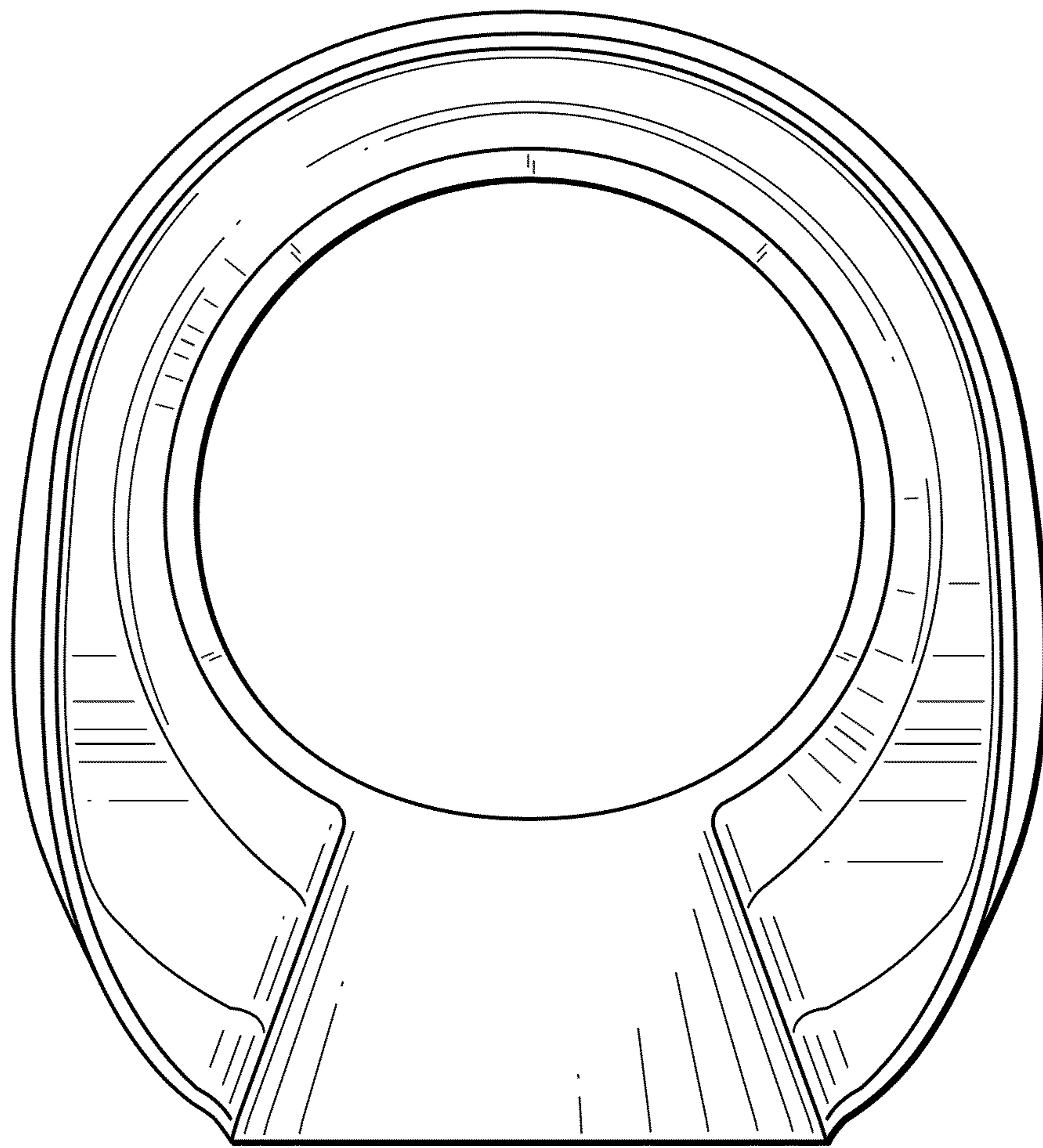
