DESCRIPTION

FIG. 1 is a front view of a scissors showing my new design related to the first embodiment;

FIG. 20 is an end view of the sectioned part taken along the arrowed line 20-20 thereof;

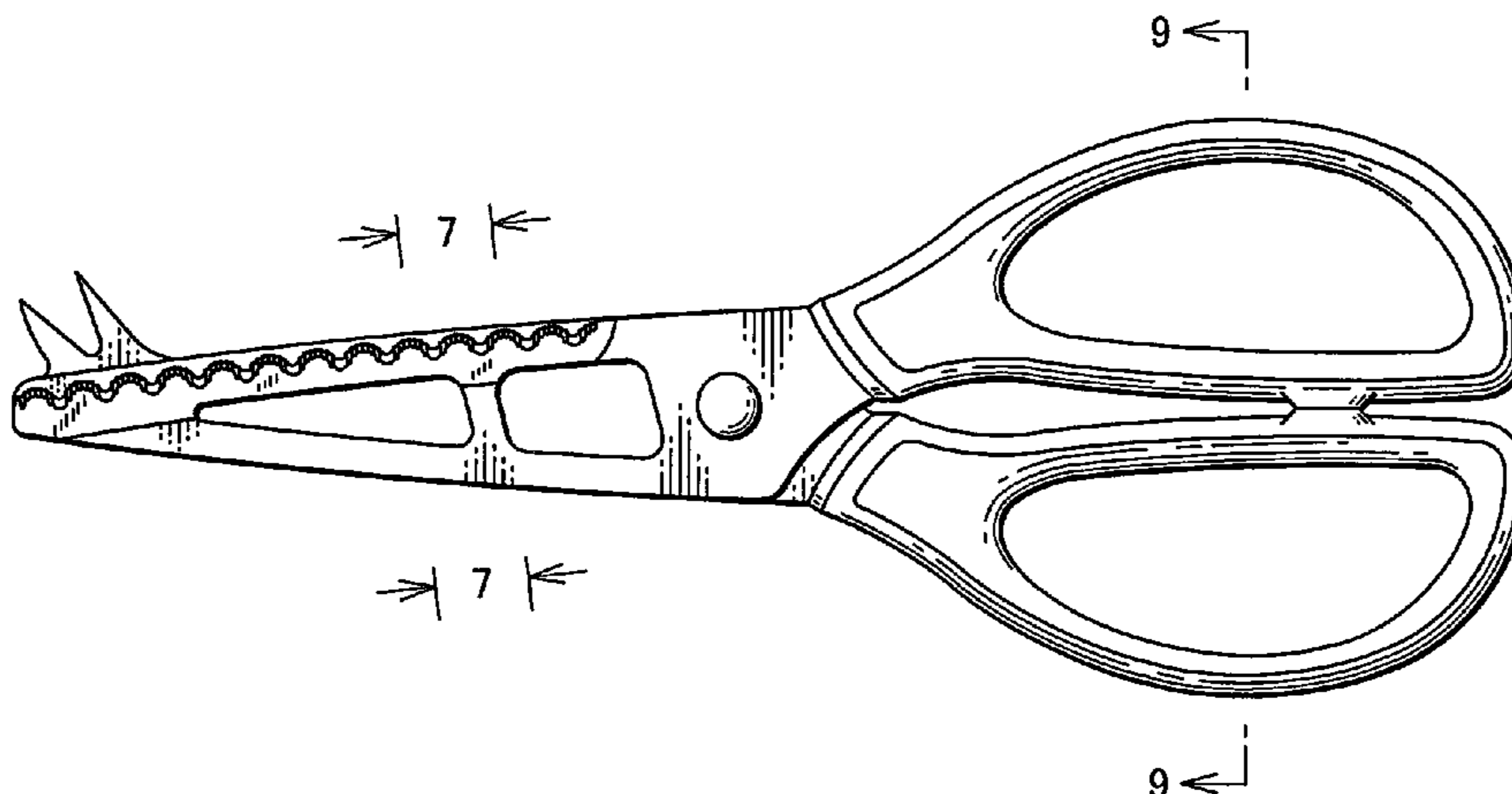
FIG. 21 is an end view of the sectioned part taken along the arrowed line 21-21 thereof;

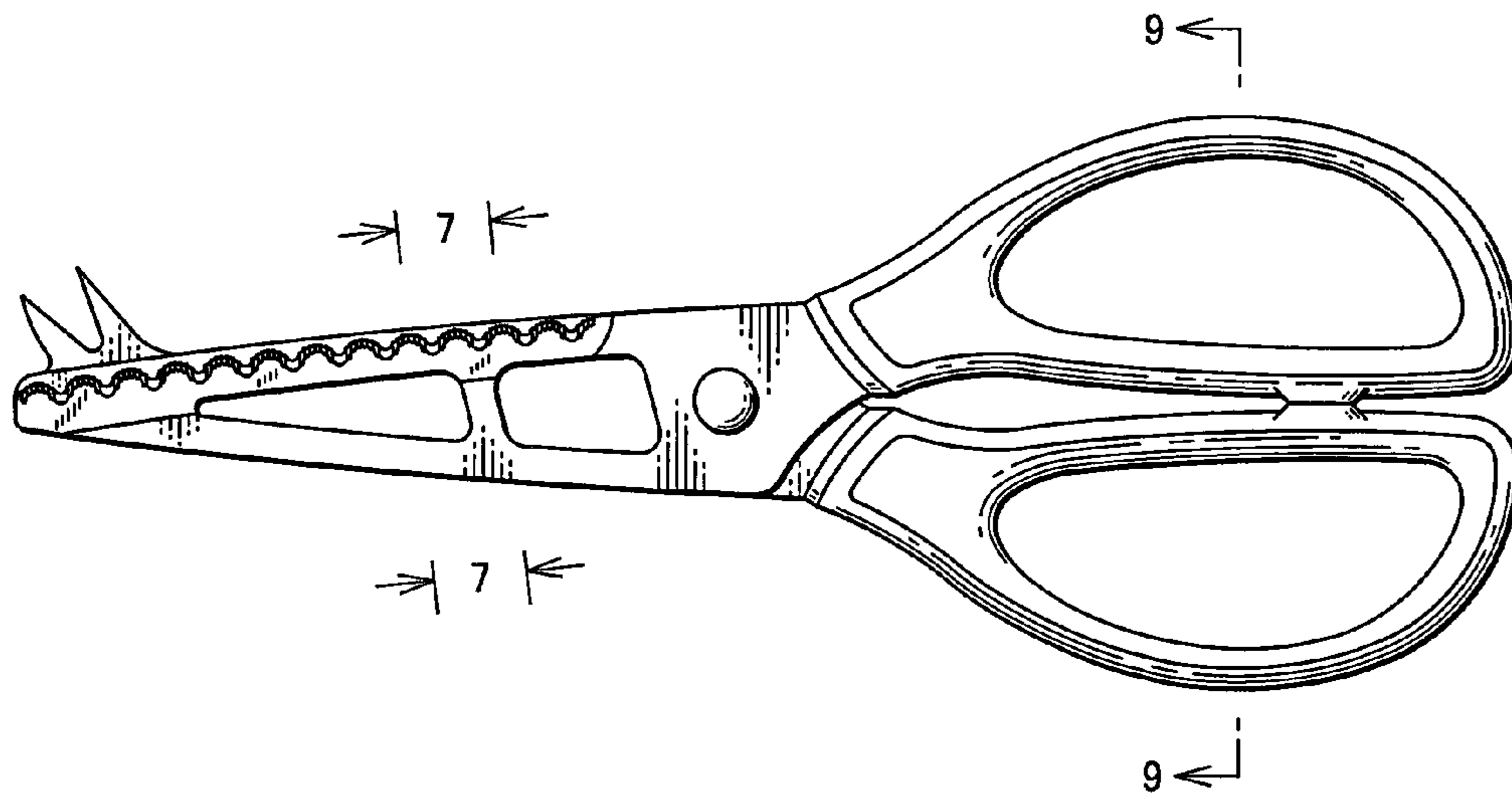

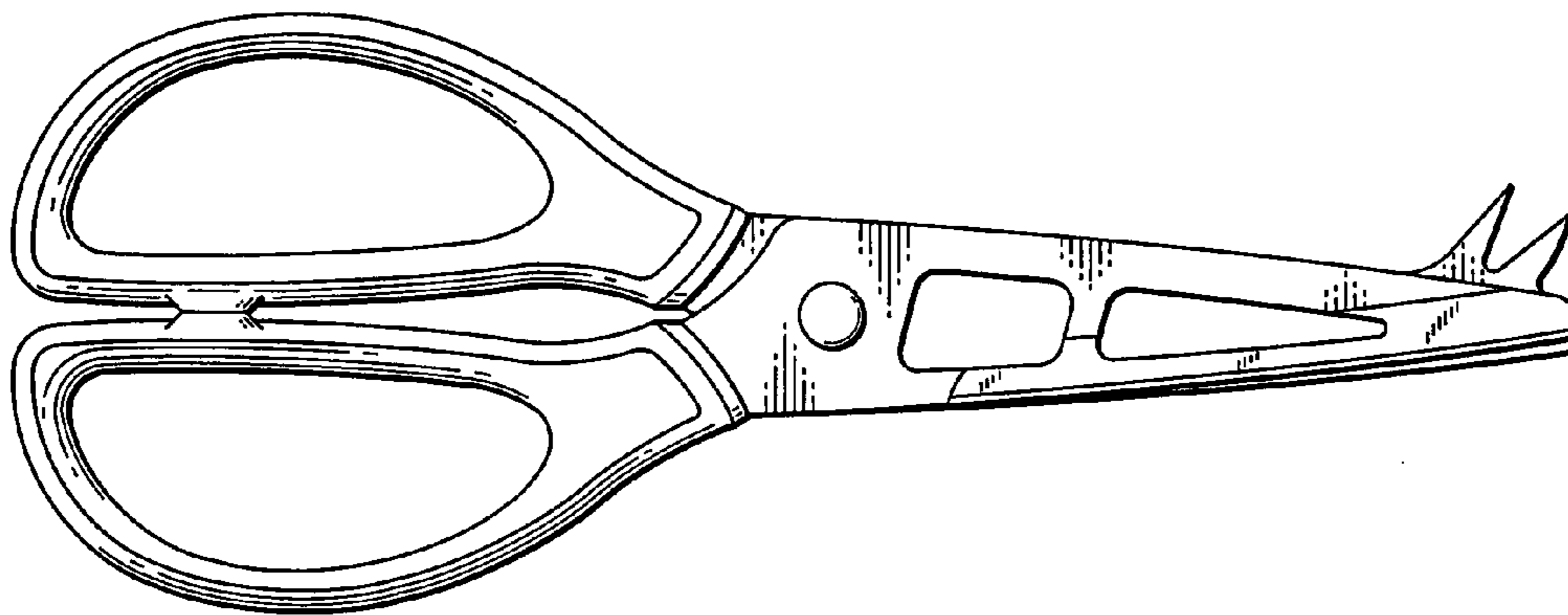

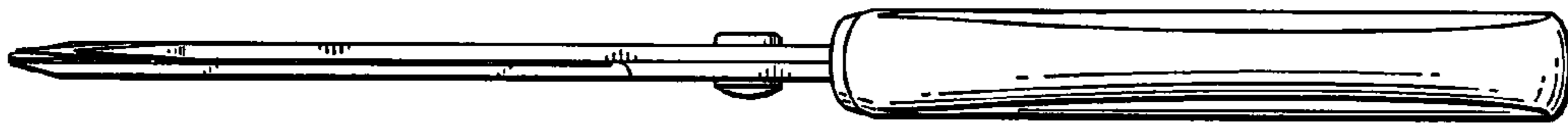

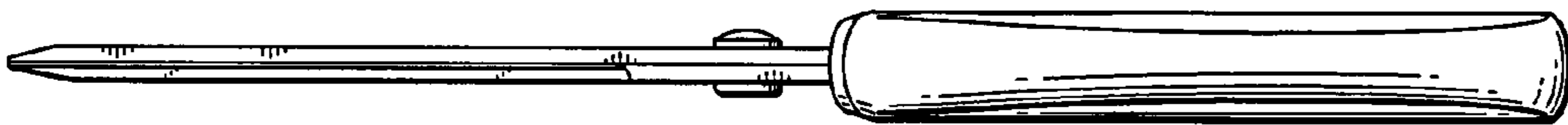

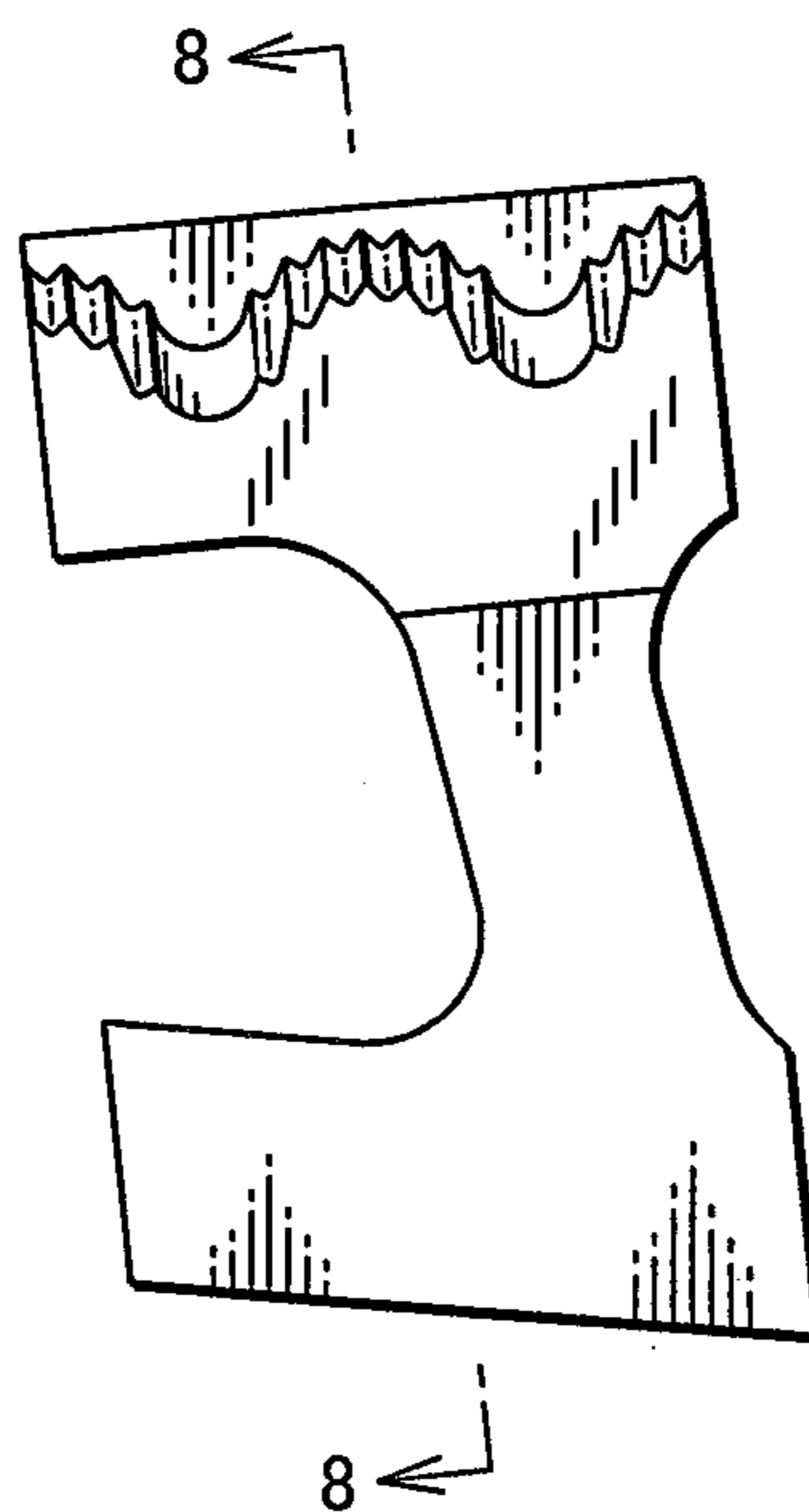

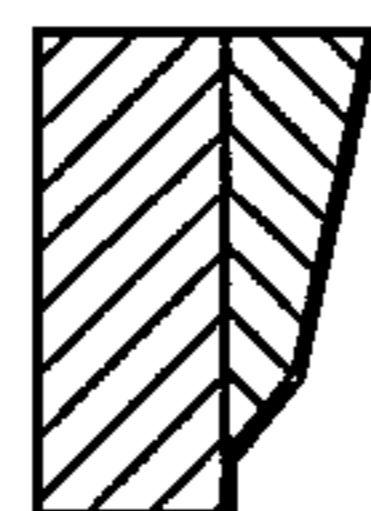
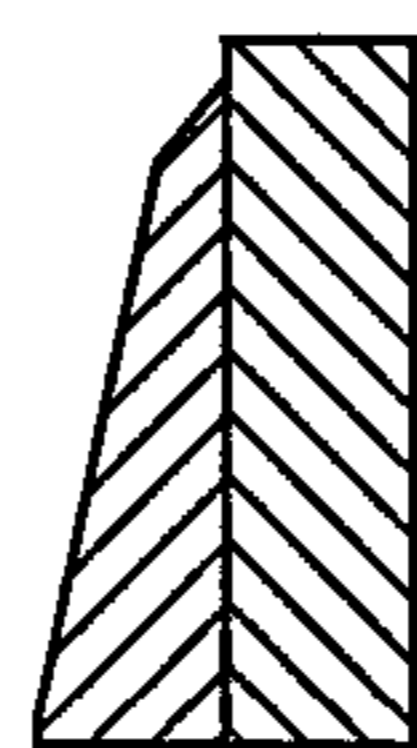

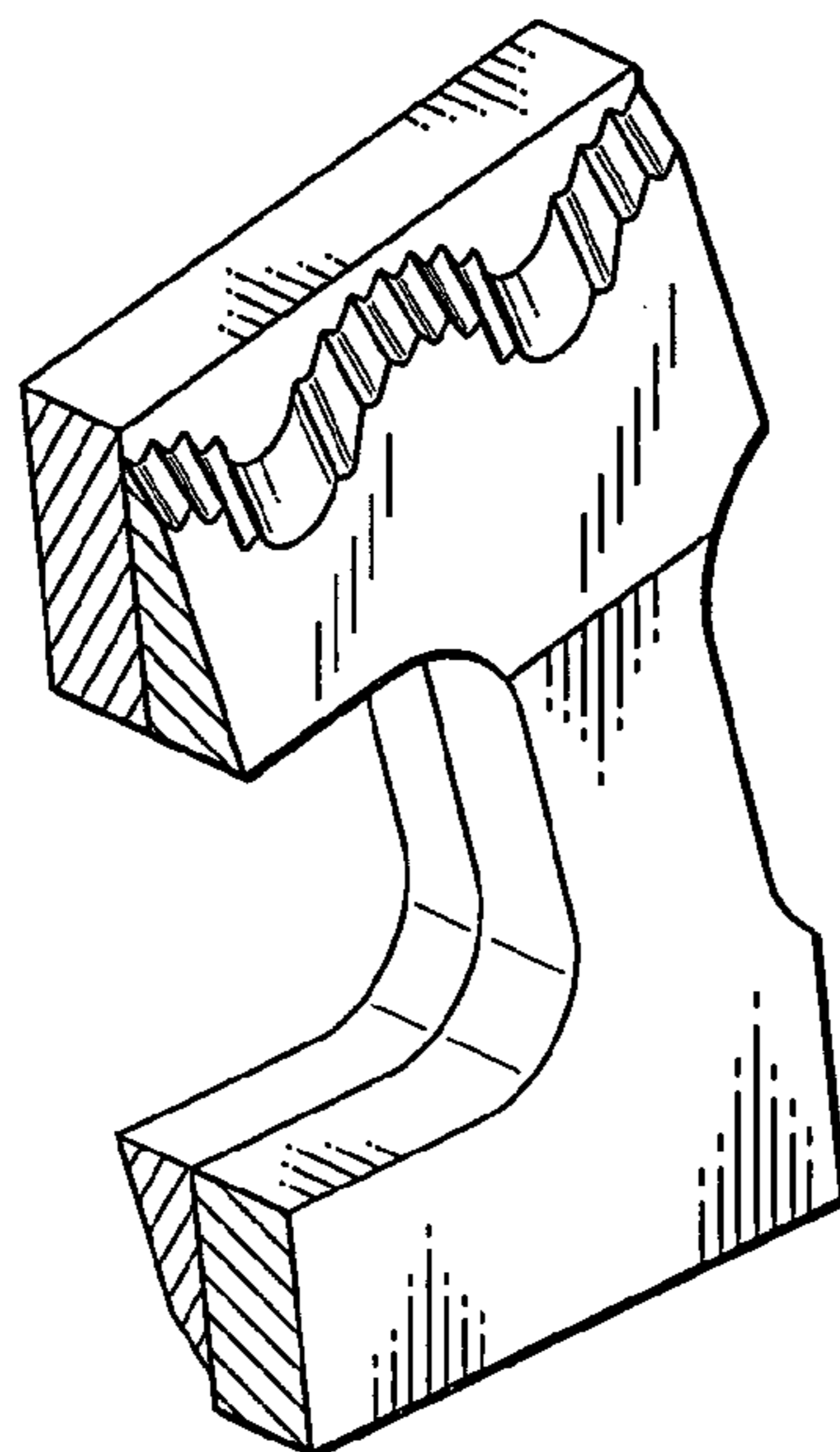

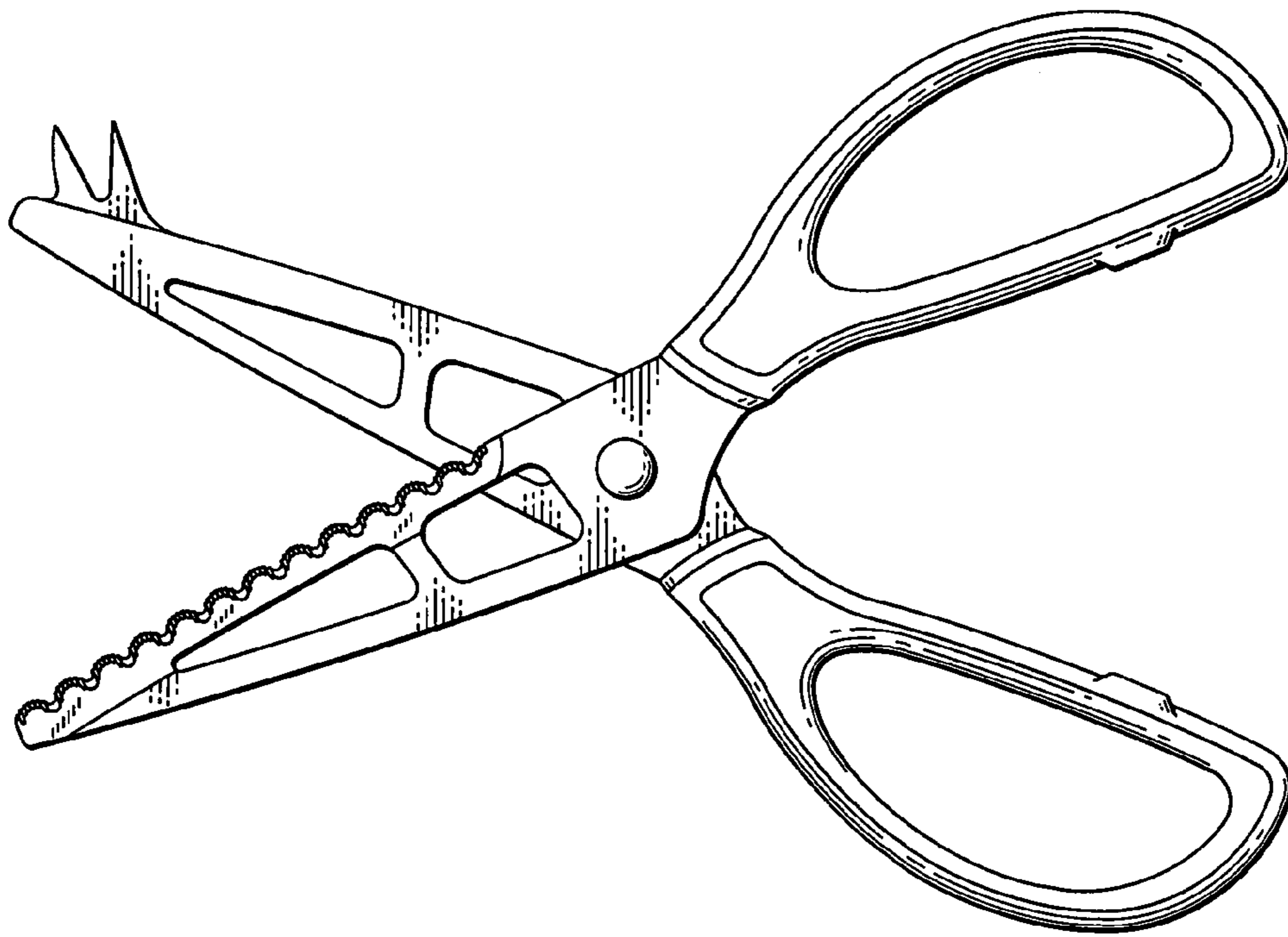

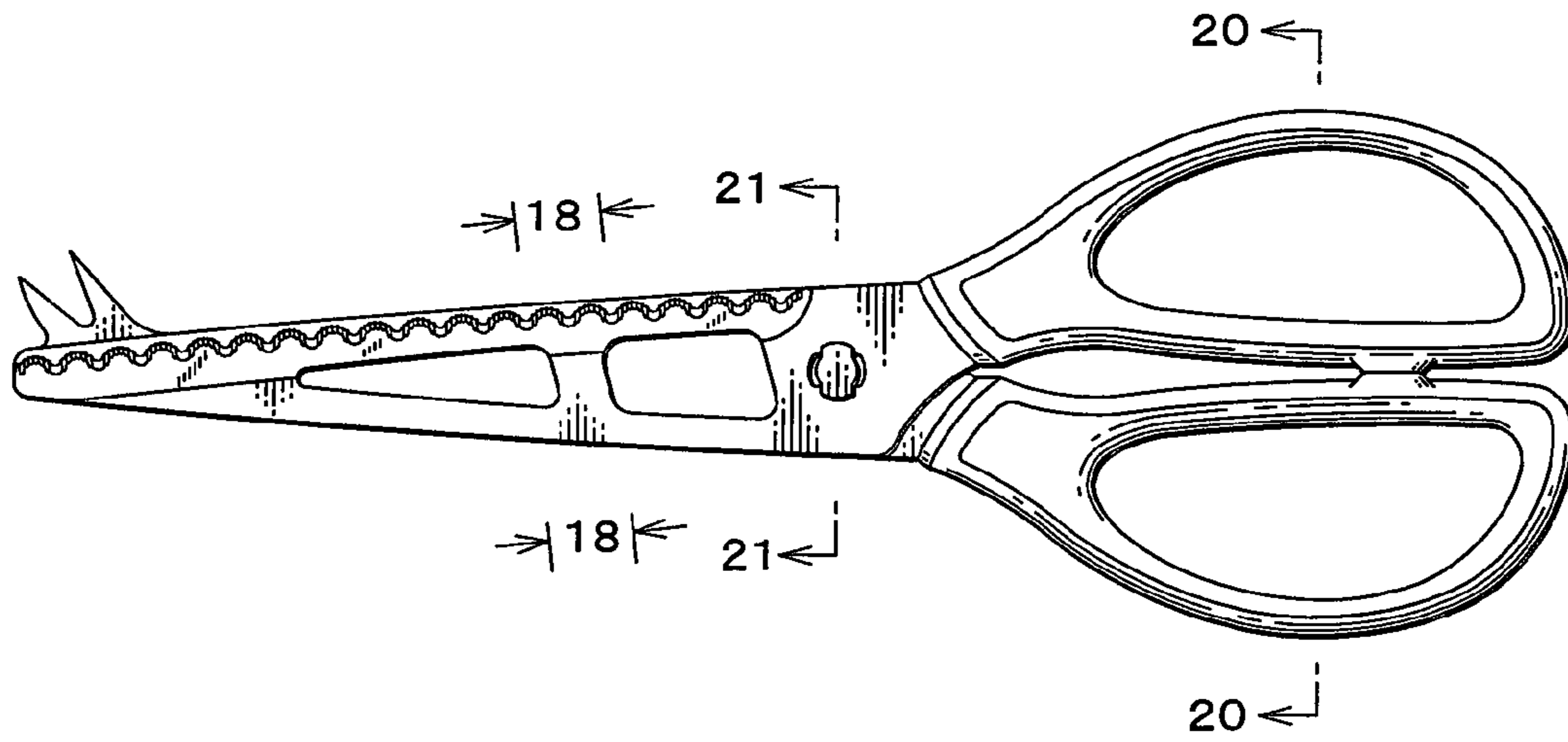

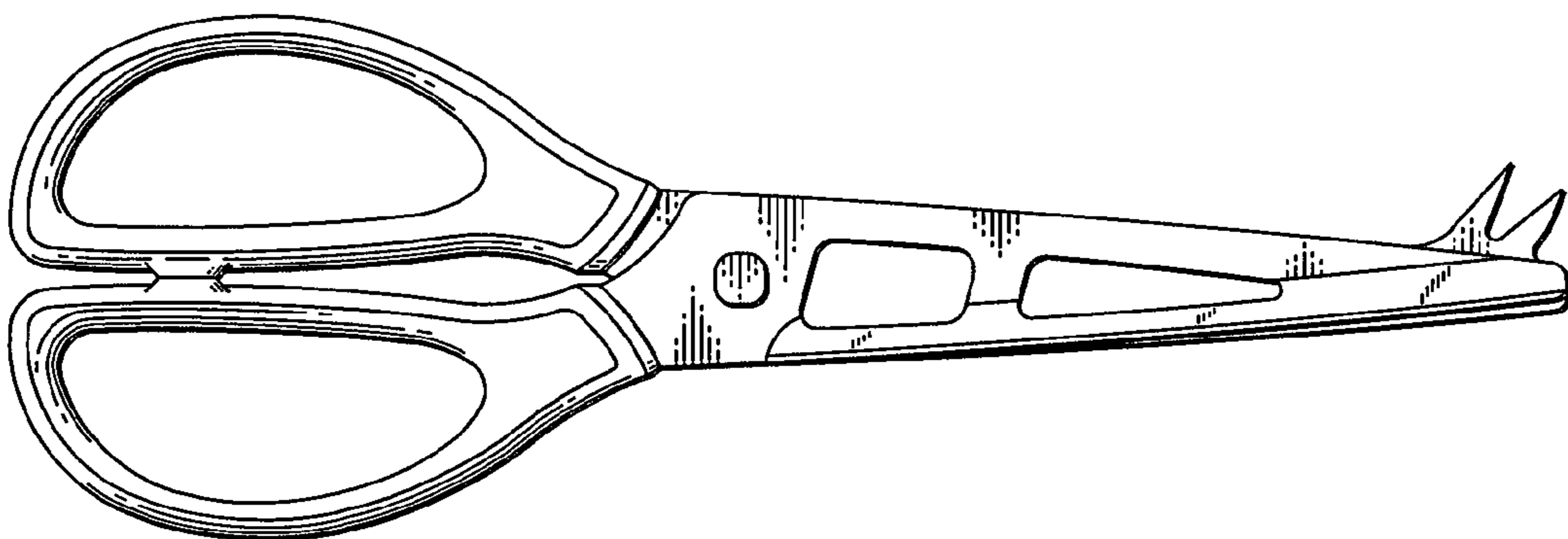

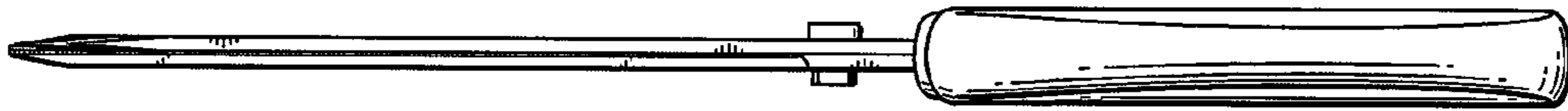

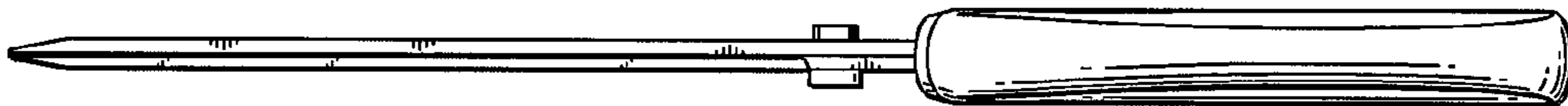

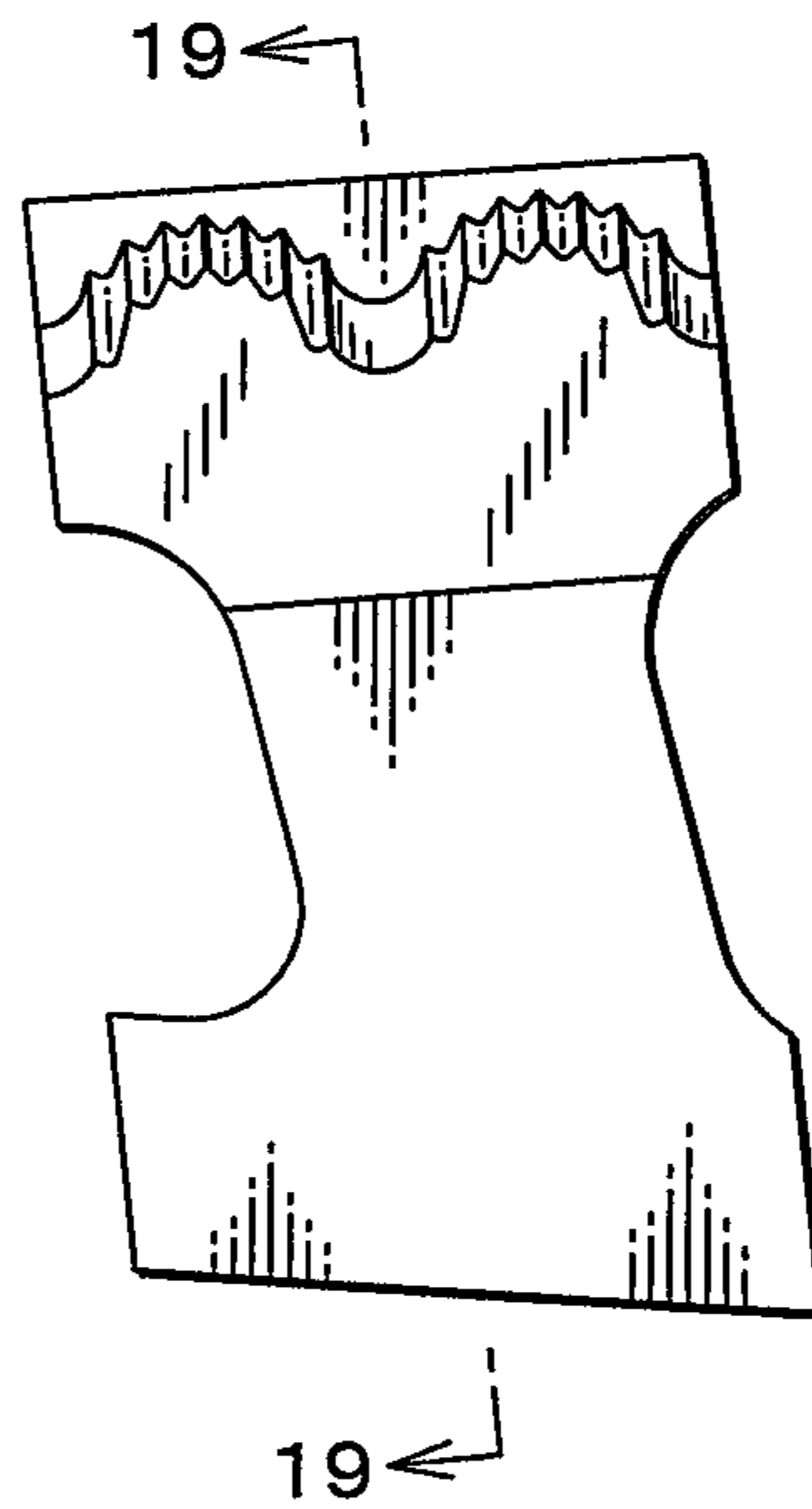

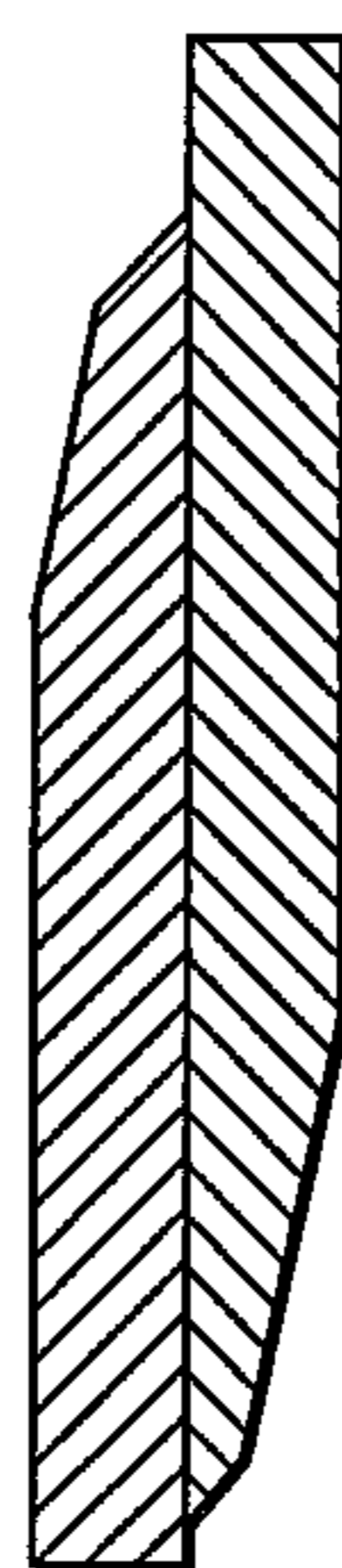

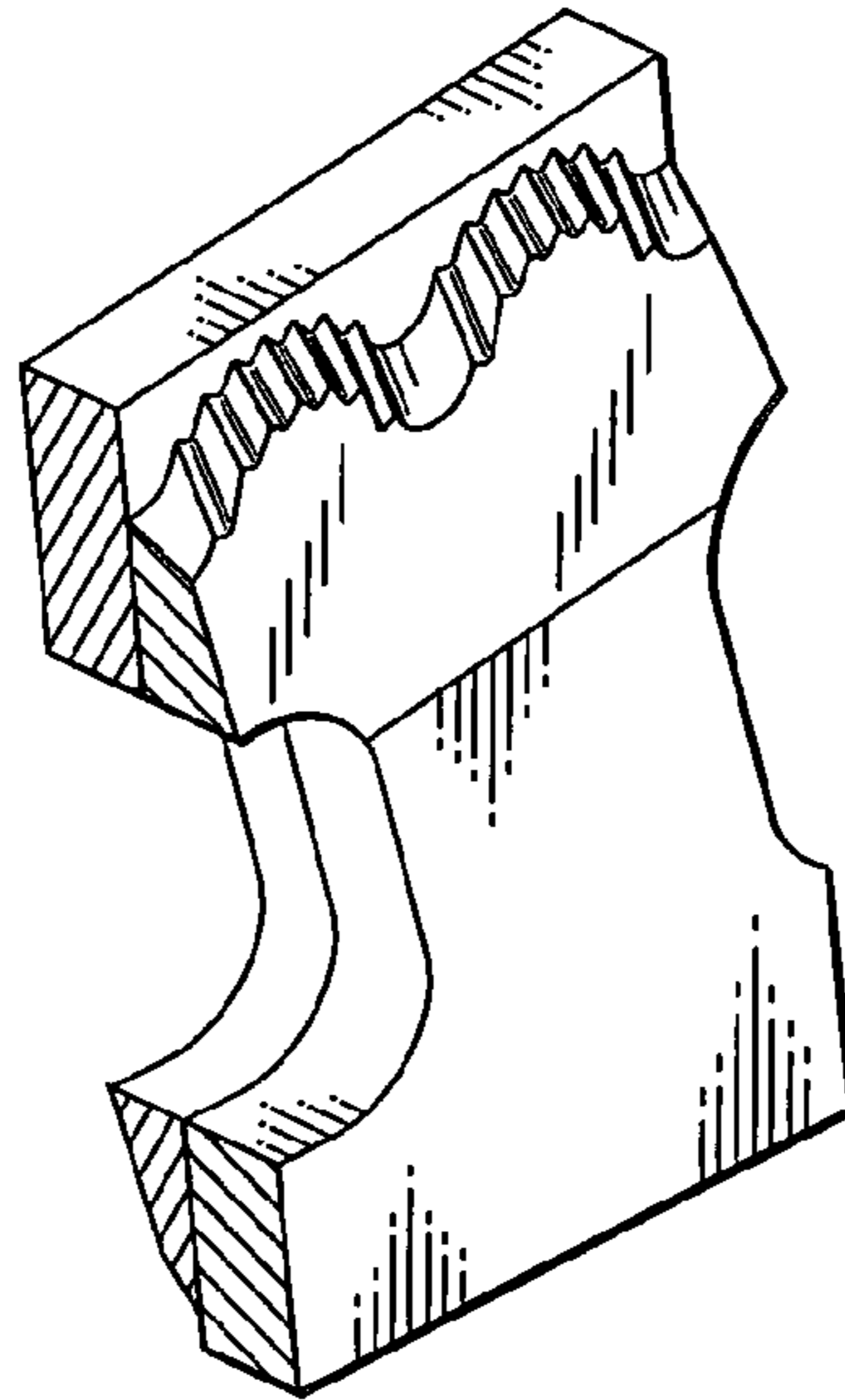

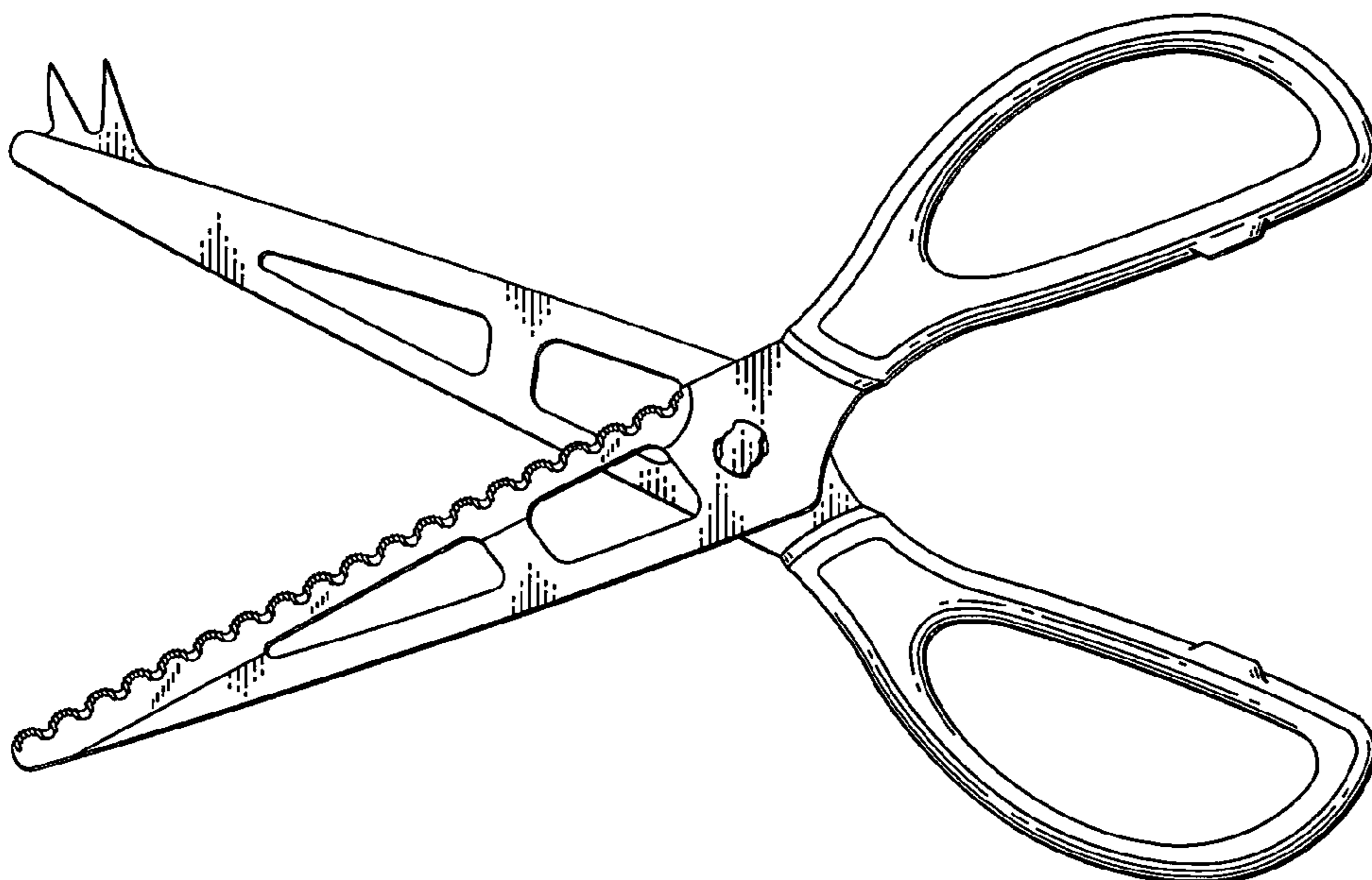
