 FIG. 13 is a bottom plan view without a sheath thereof;  
 FIG. 14 is a right side view without a sheath thereof;  
 FIG. 15 is a left side view without a sheath thereof; and,  
 FIG. 16 is a front view showing the opened state without a  
 sheath thereof.

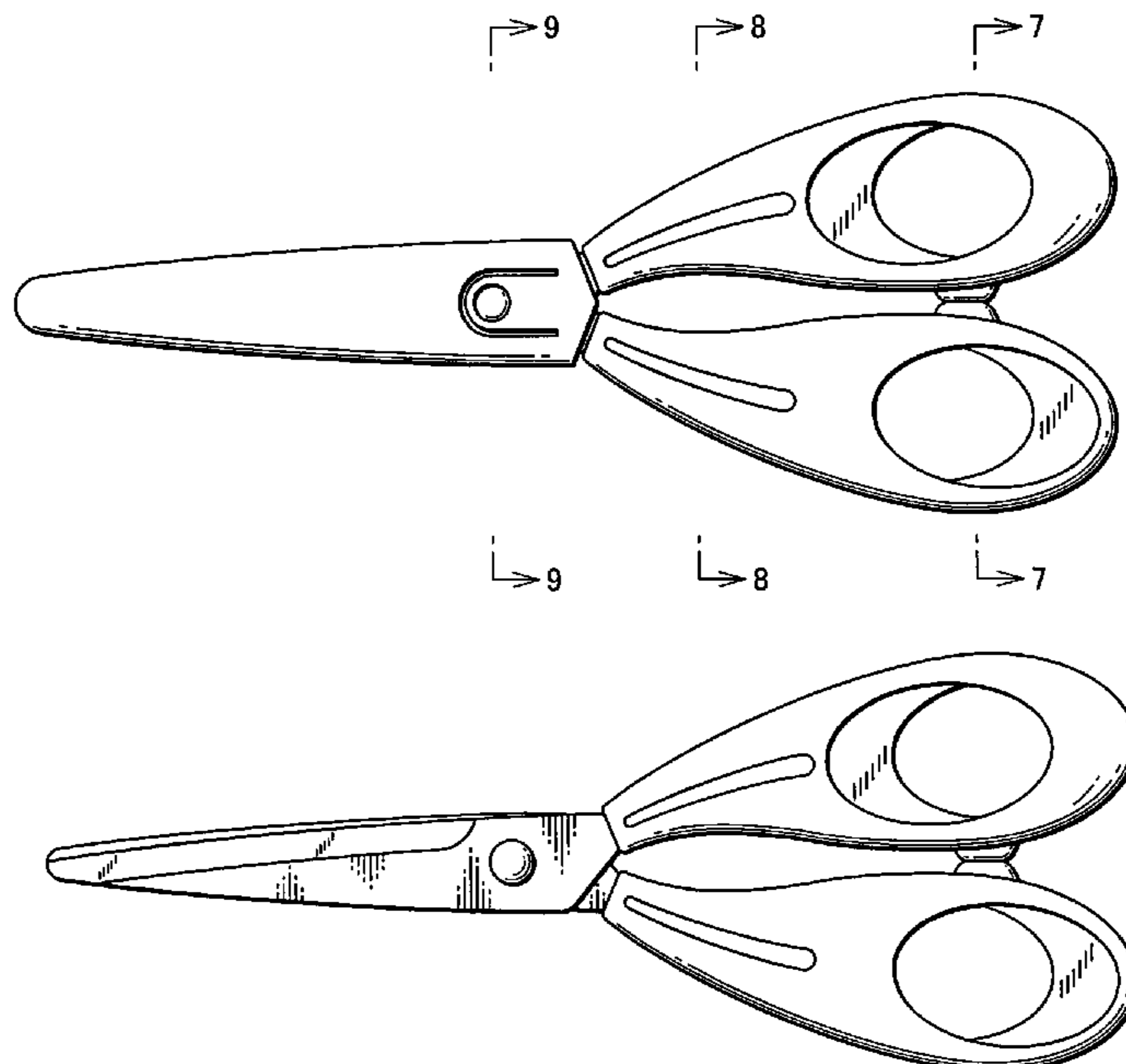

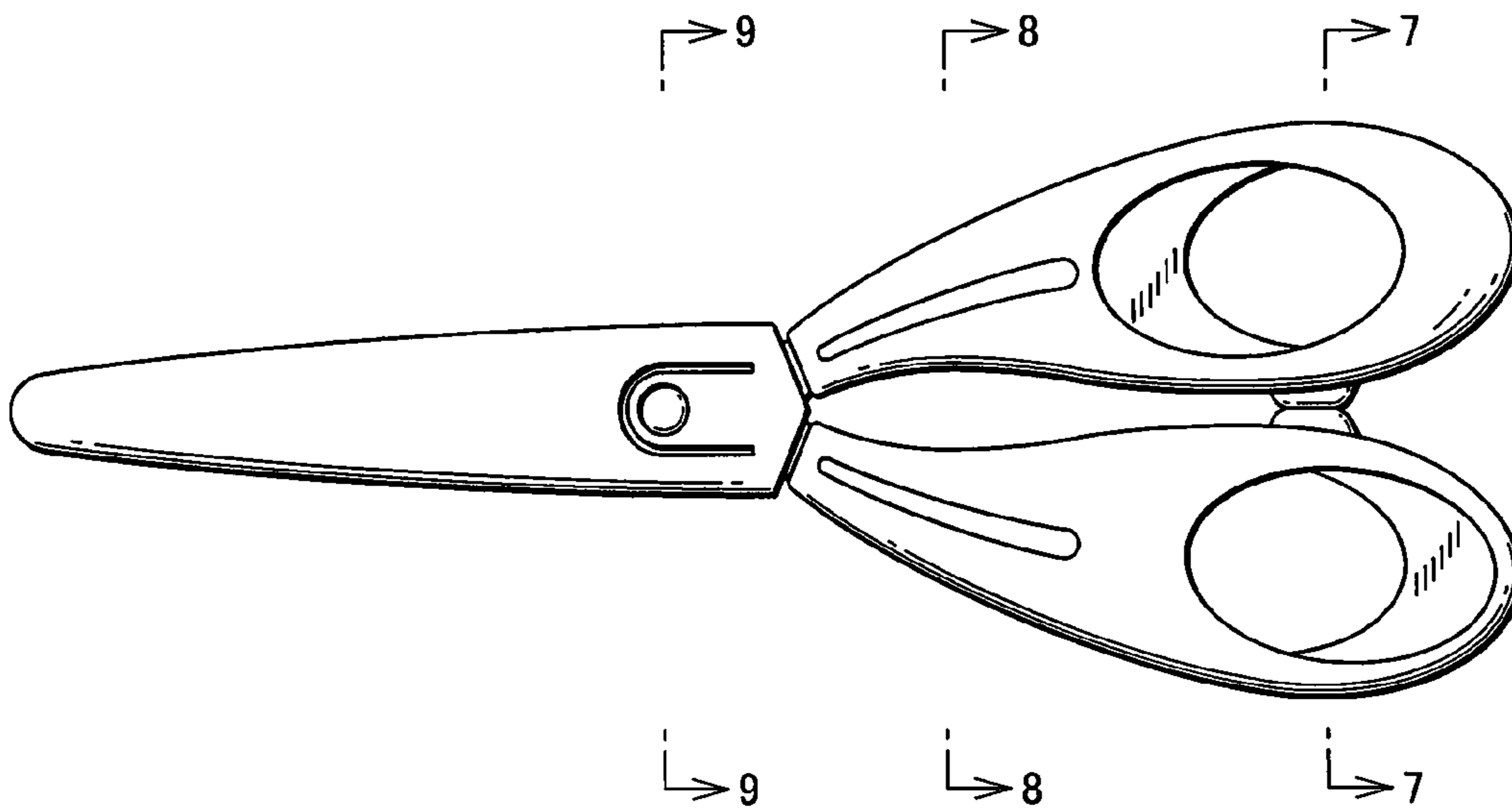

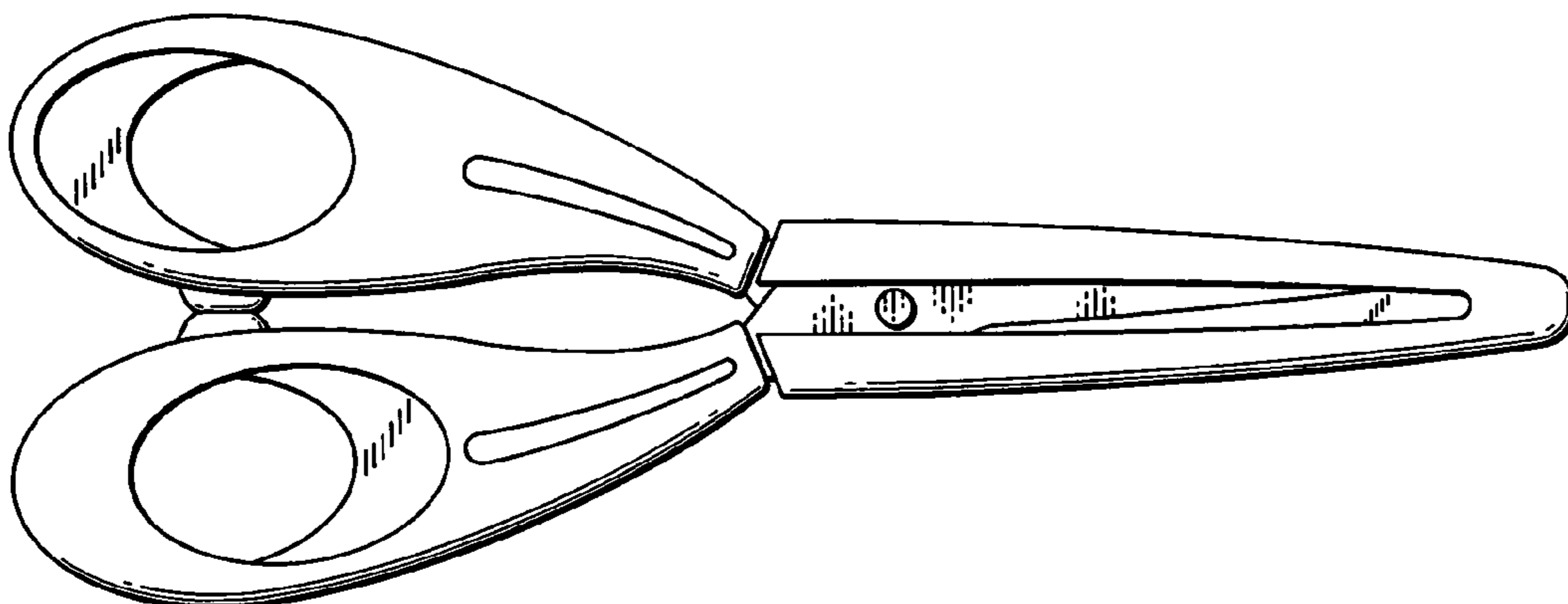

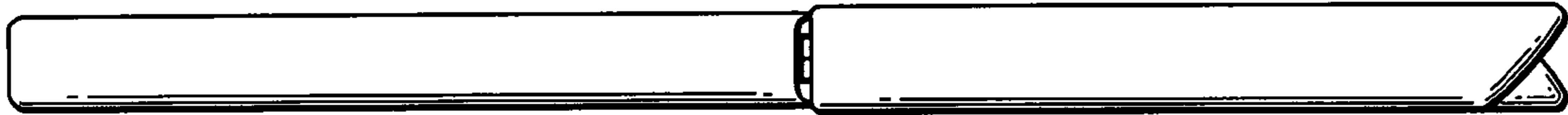

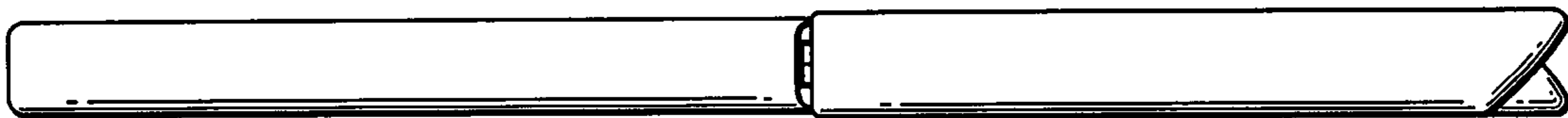

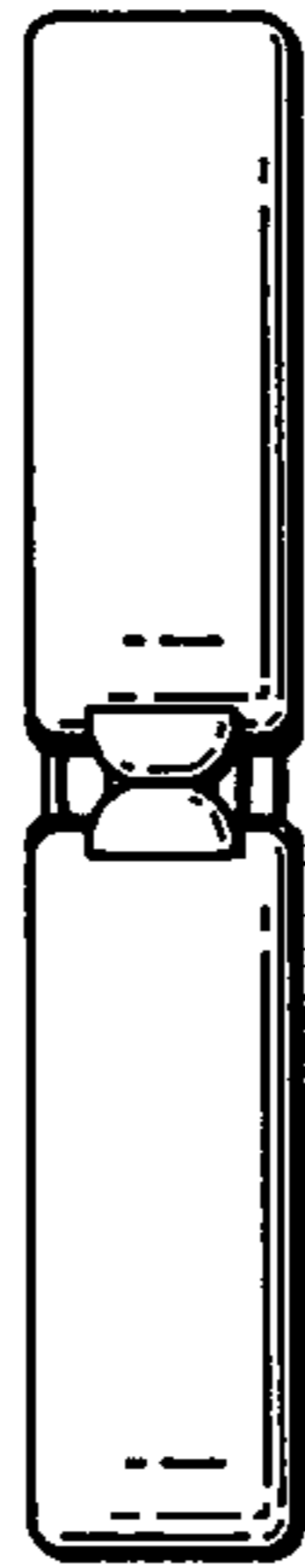

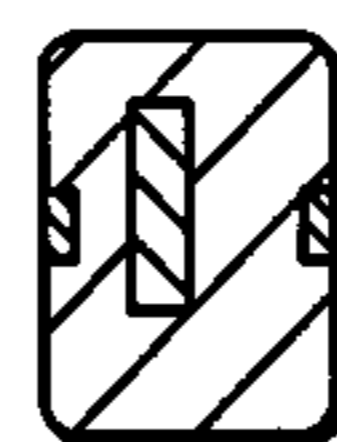
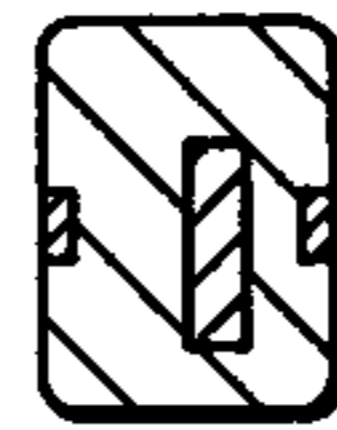

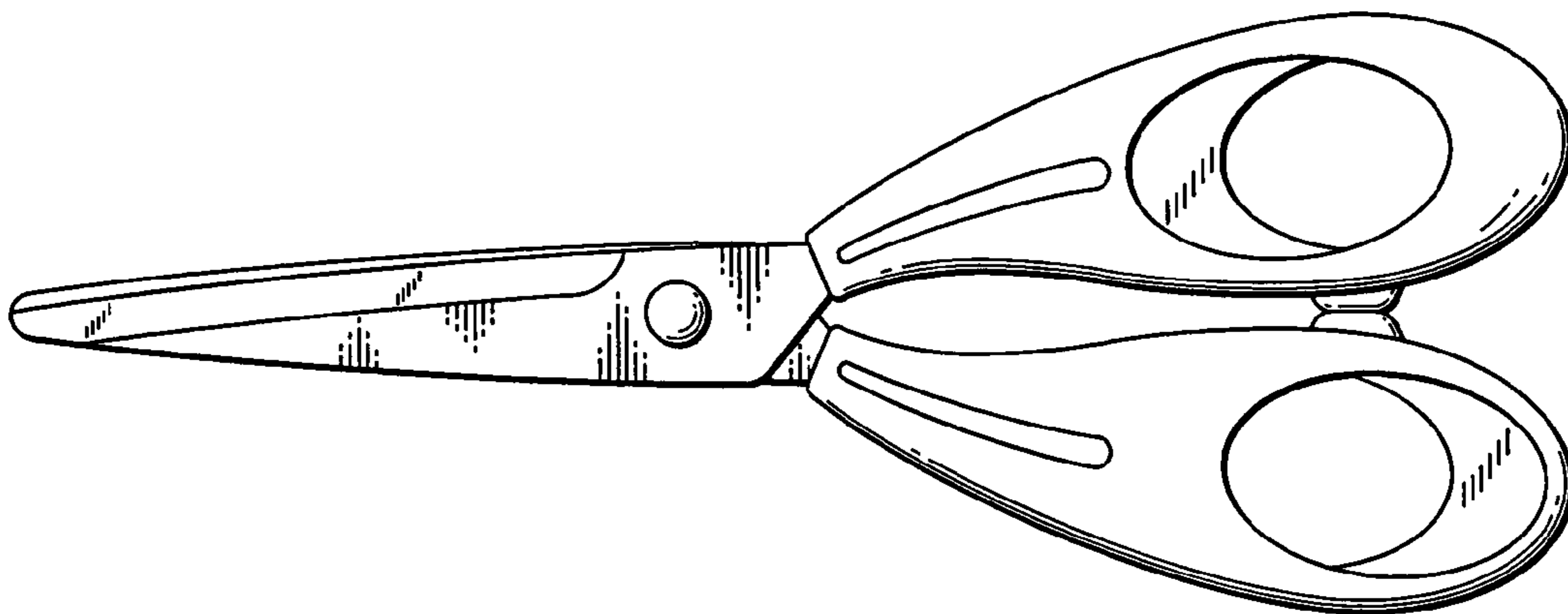

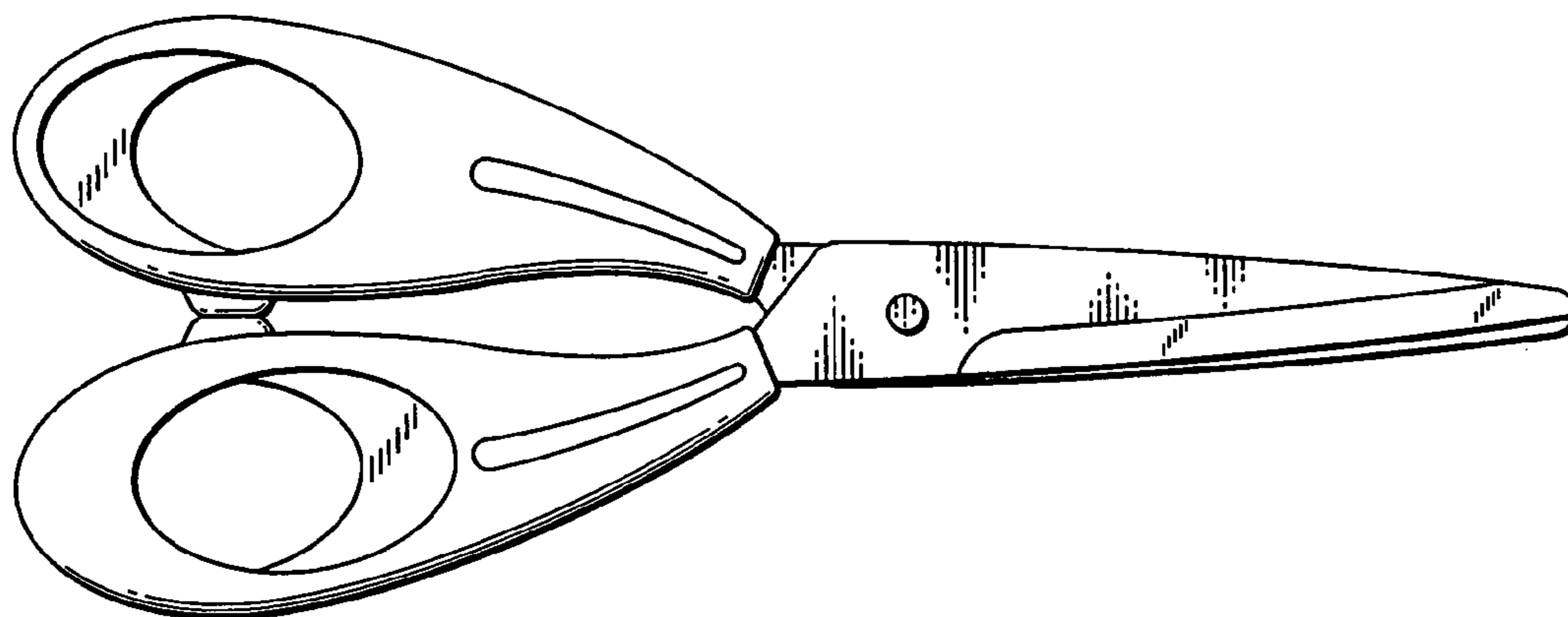

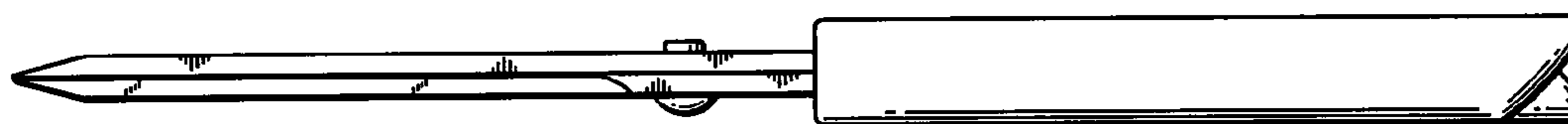

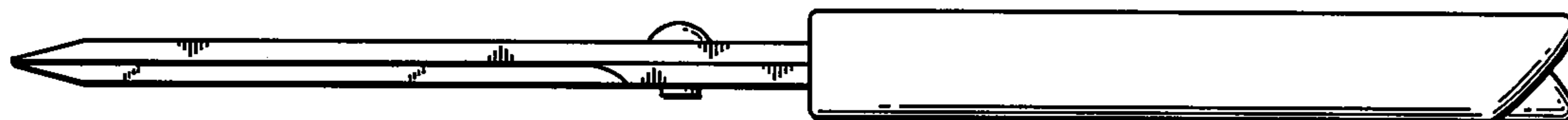

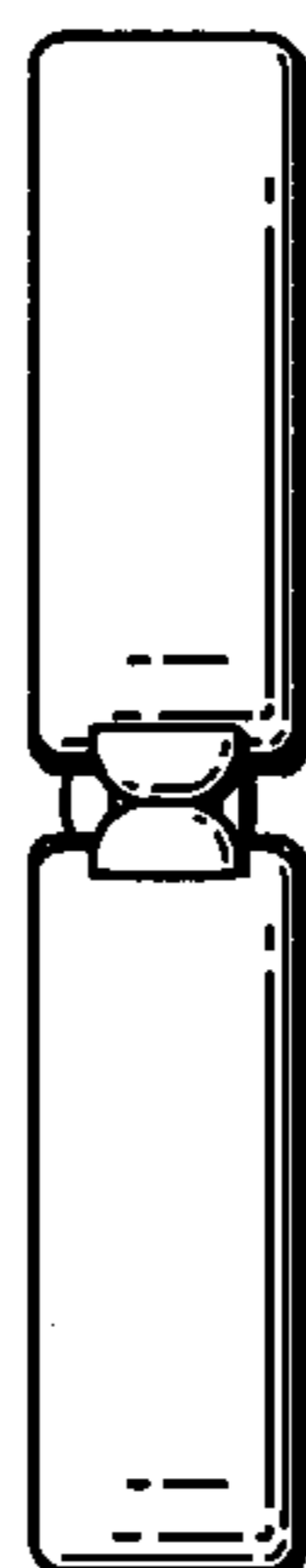
