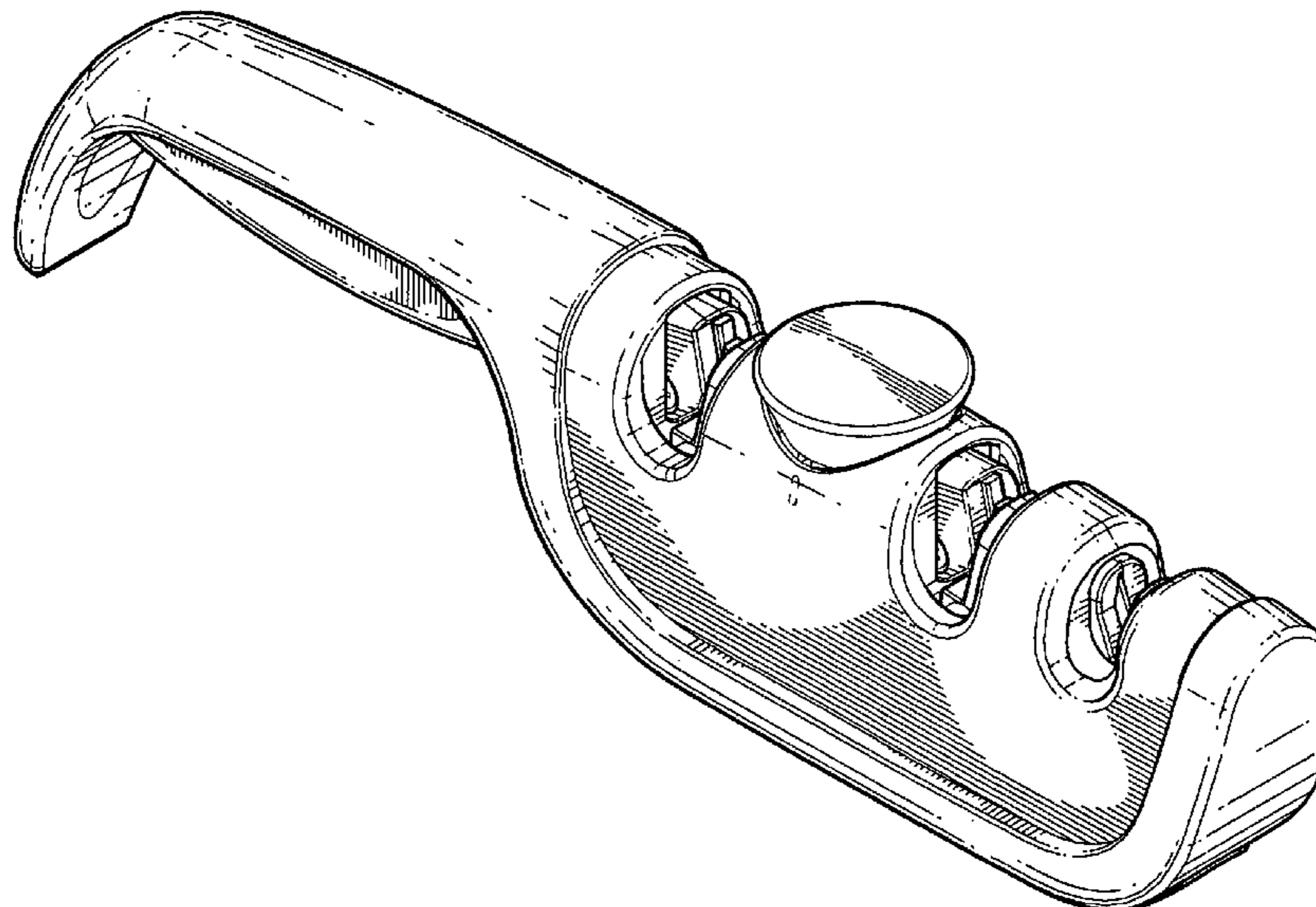
(57) **CLAIM**

The ornamental design for an adjustable manual abrasive sharpener, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the design for the adjustable manual abrasive sharpener of the invention; FIG. 2 is a rear perspective view of the design for the adjustable manual abrasive sharpener of the invention; FIG. 3 is a right side elevational view, viewing FIG. 1, of the adjustable manual abrasive sharpener of FIG. 1; FIG. 4 is a top plan view of the adjustable manual abrasive sharpener of FIG. 1; FIG. 5 is a front elevational view of the adjustable manual abrasive sharpener of FIG. 1; FIG. 6 is a rear elevational view of the adjustable manual abrasive sharpener of FIG. 1; and, FIG. 7 is a bottom plan view of the adjustable manual abrasive sharpener of FIG. 1.

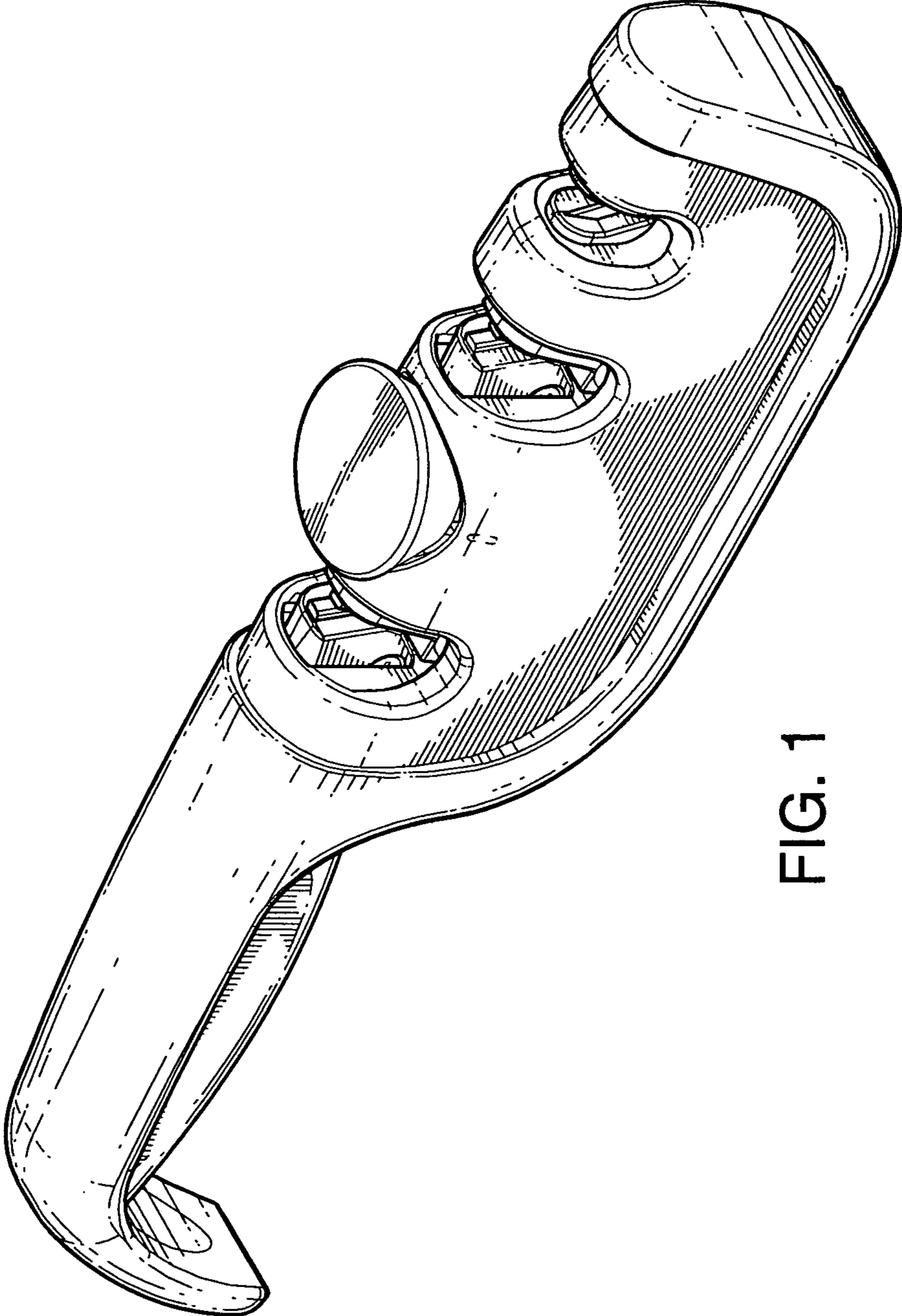

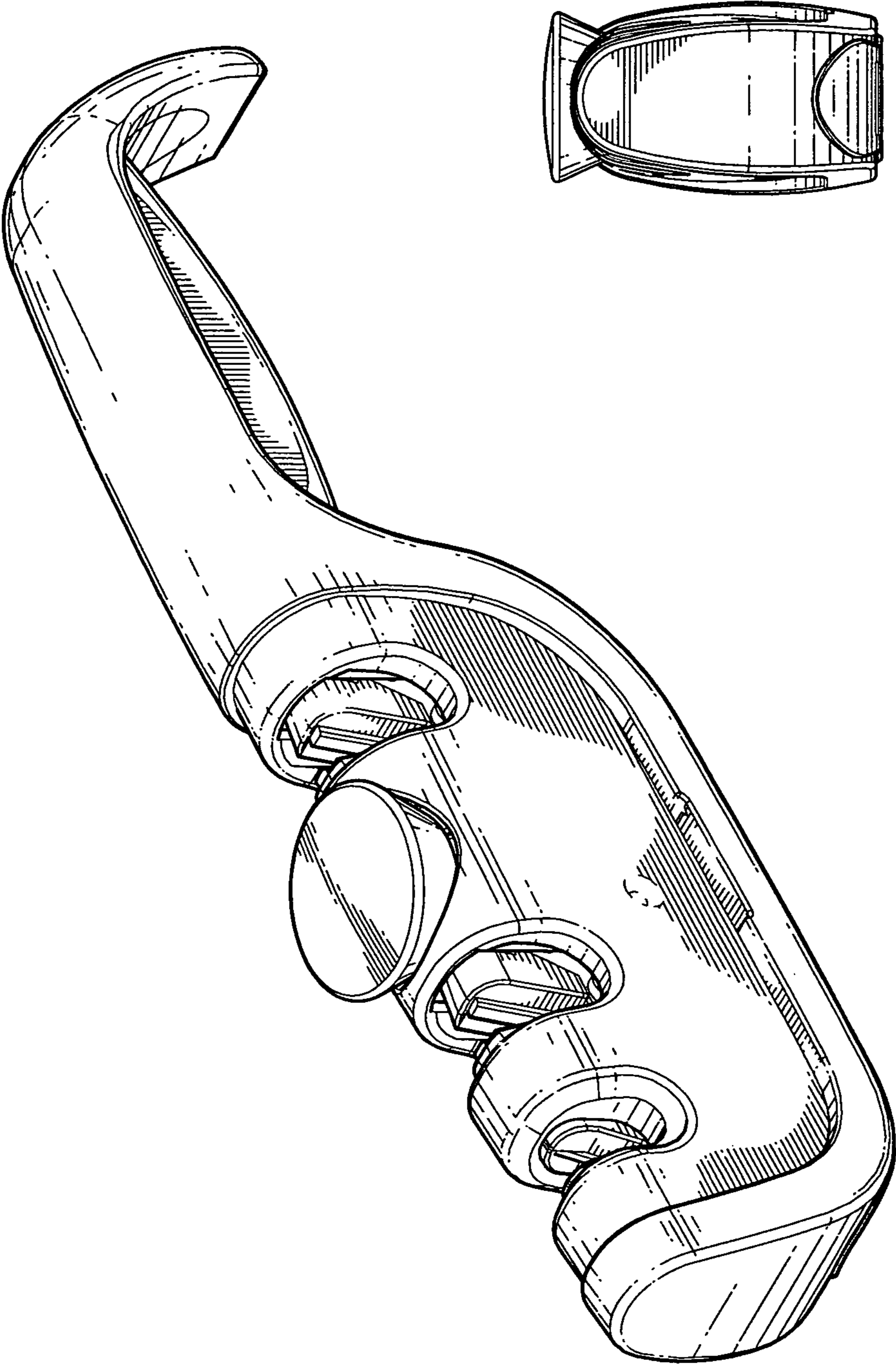

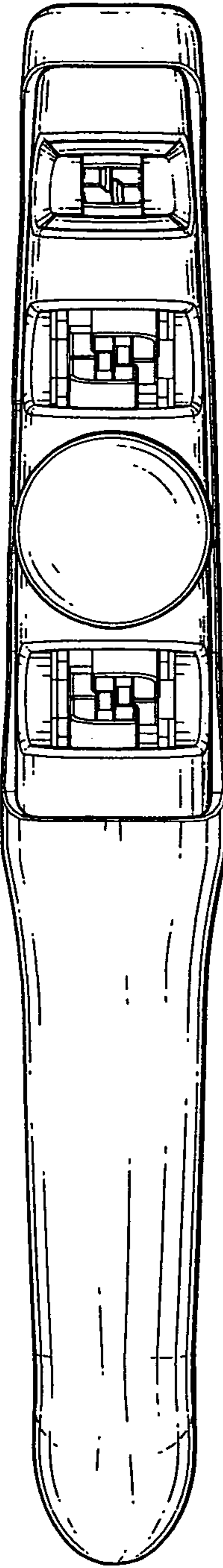

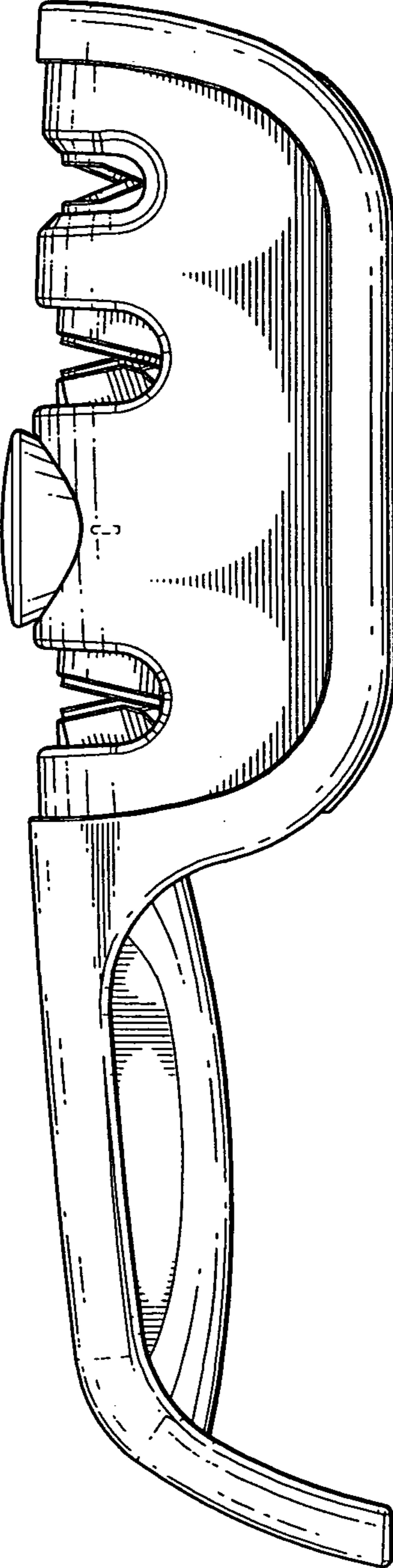

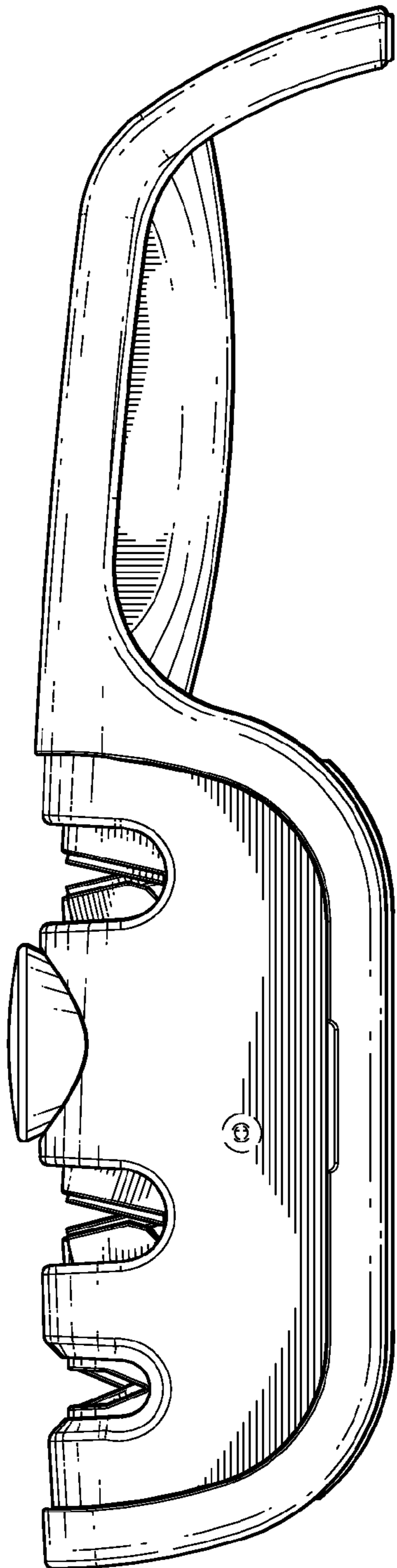

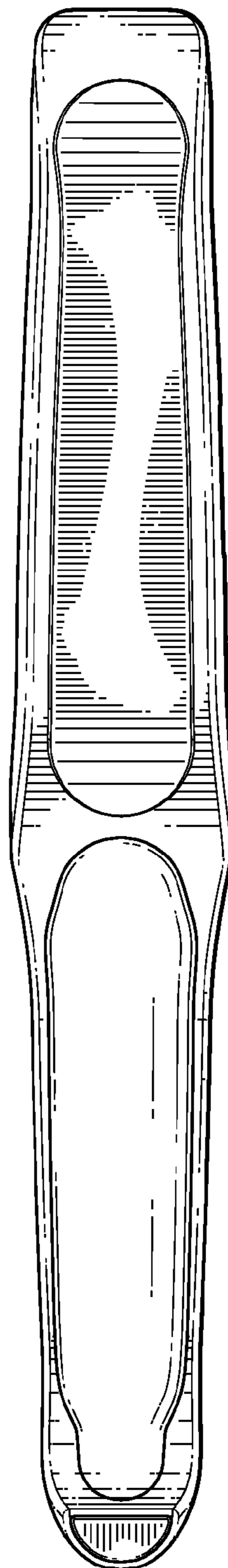
