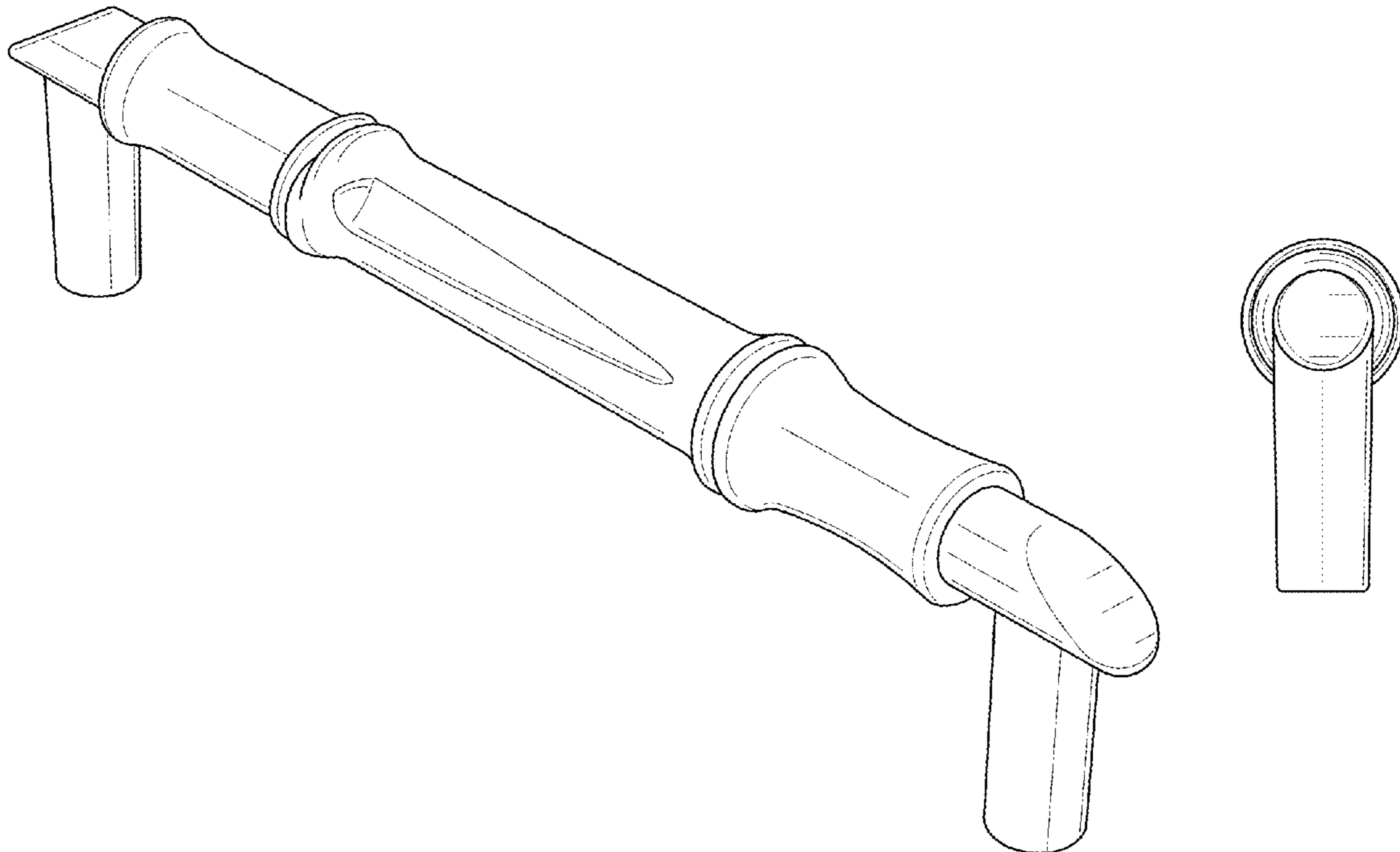
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a cabinet pull;
FIG. 2 is a rear view thereof;

FIG. 5 is top perspective view thereof; and,

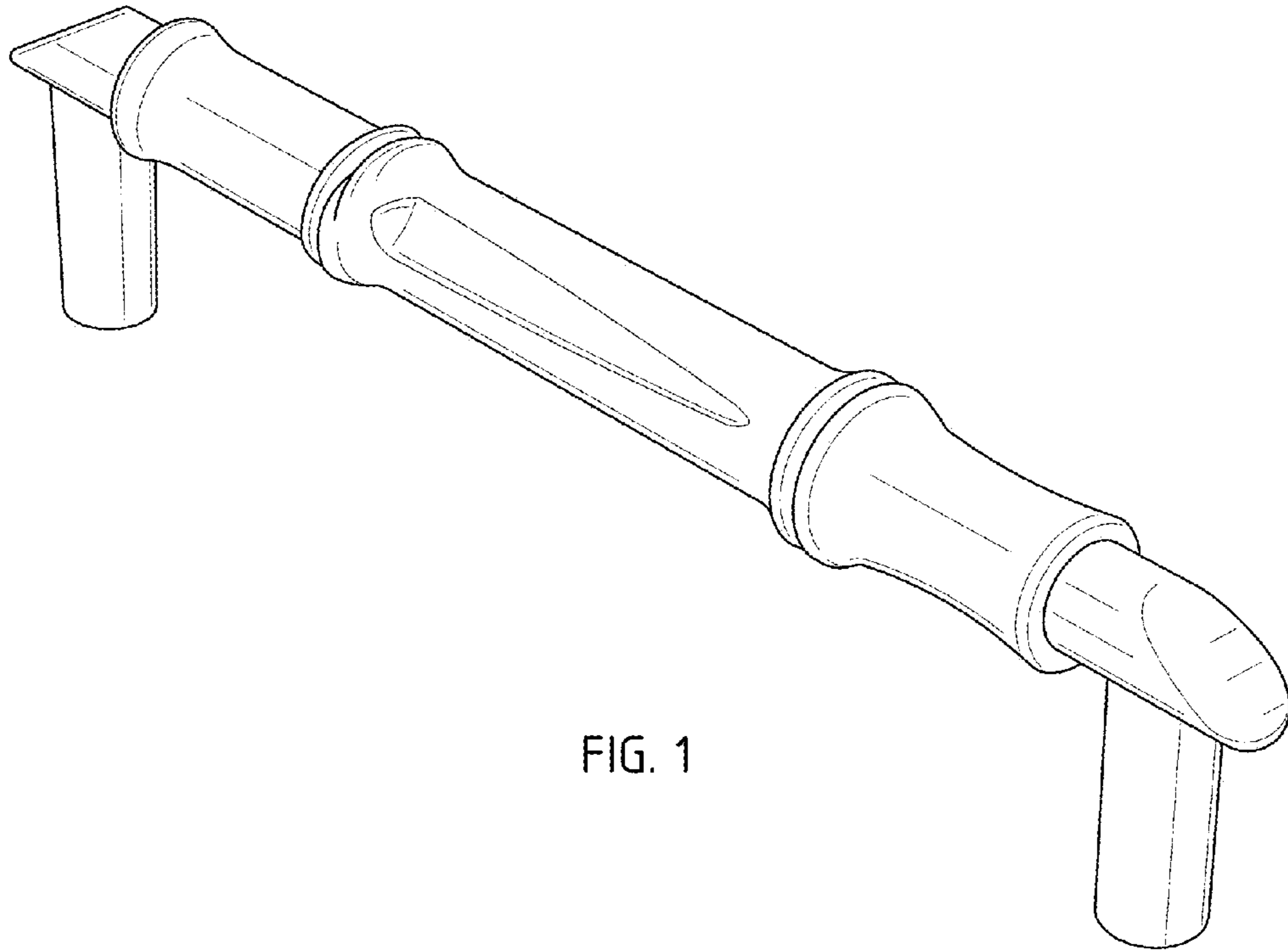

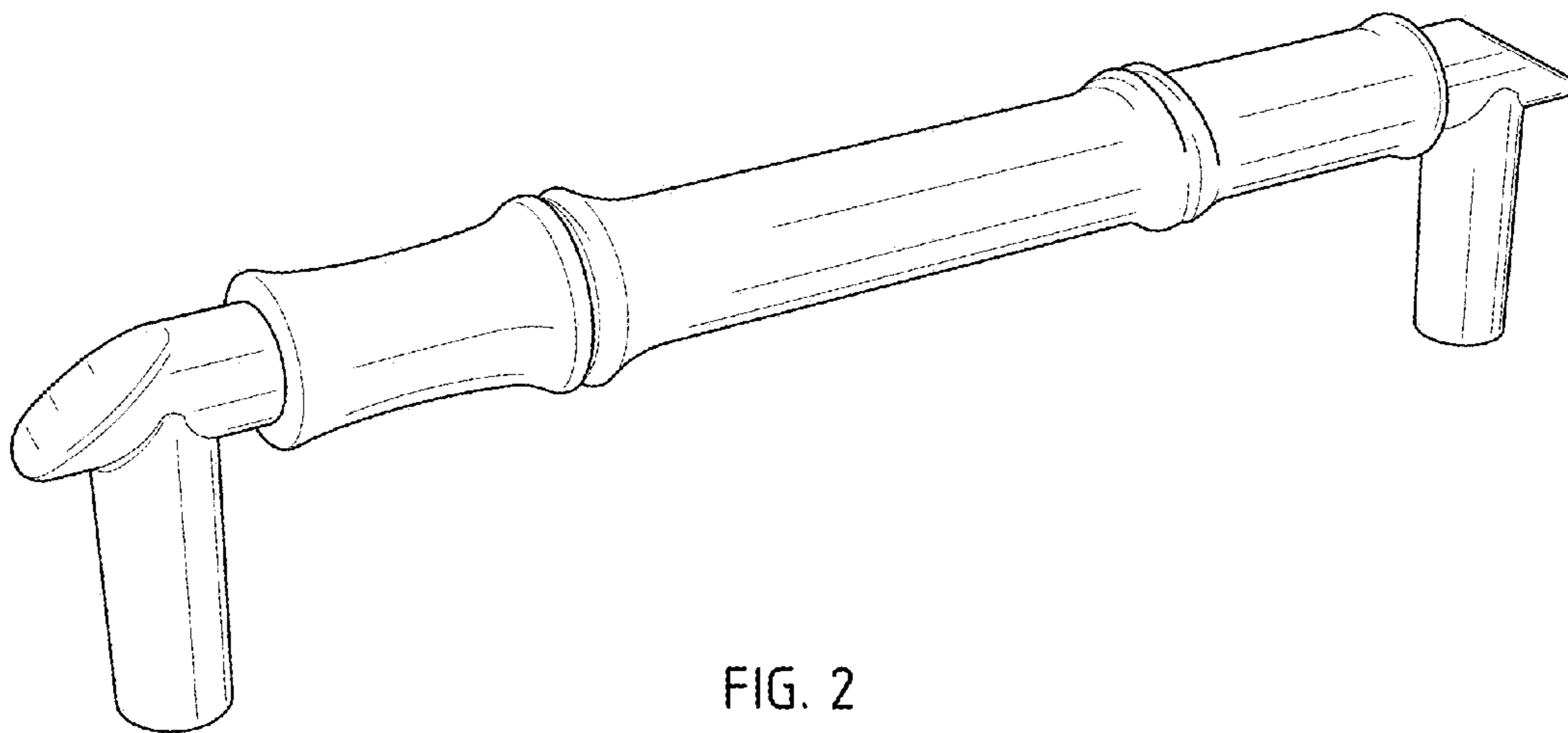

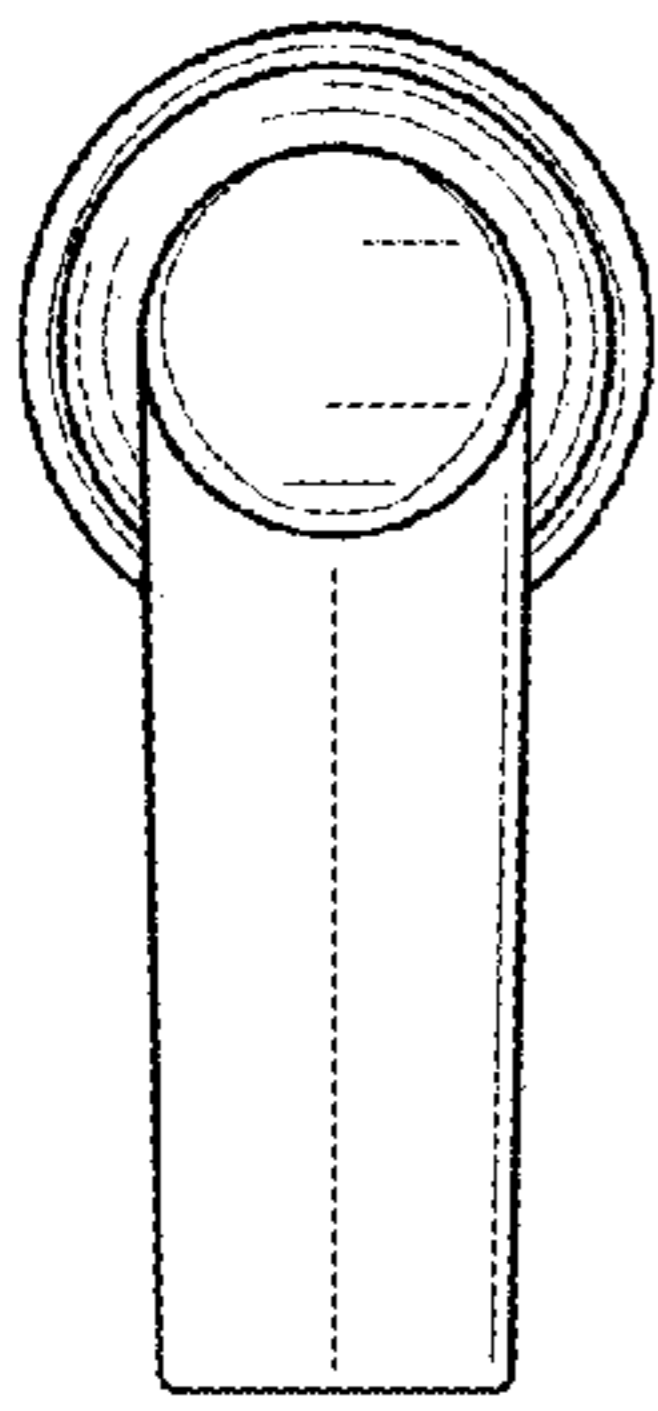

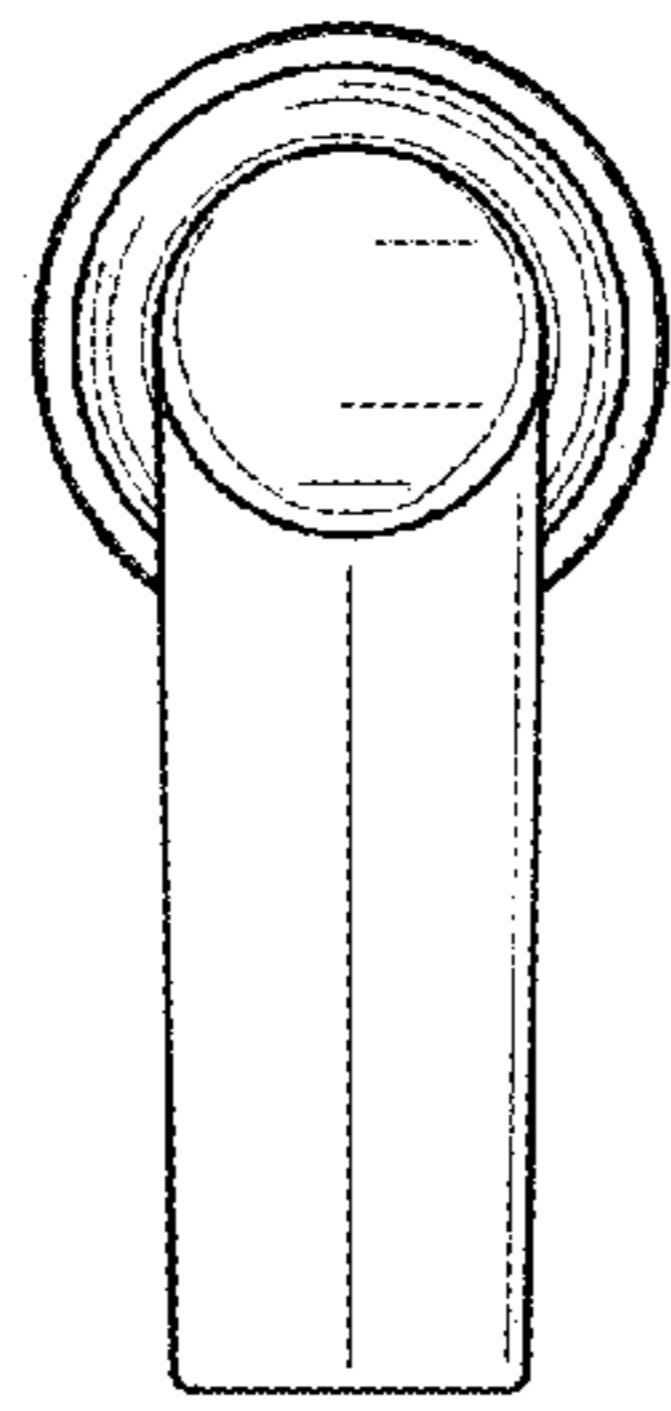

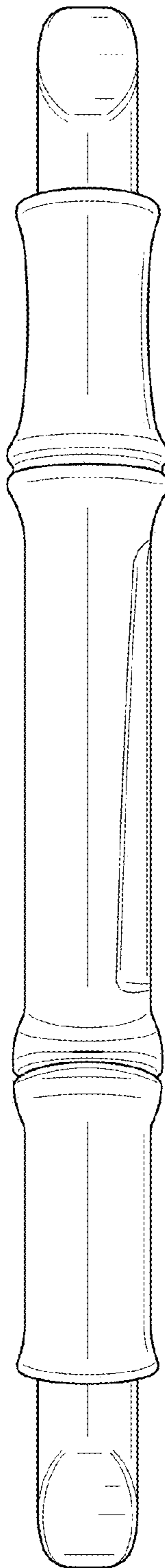

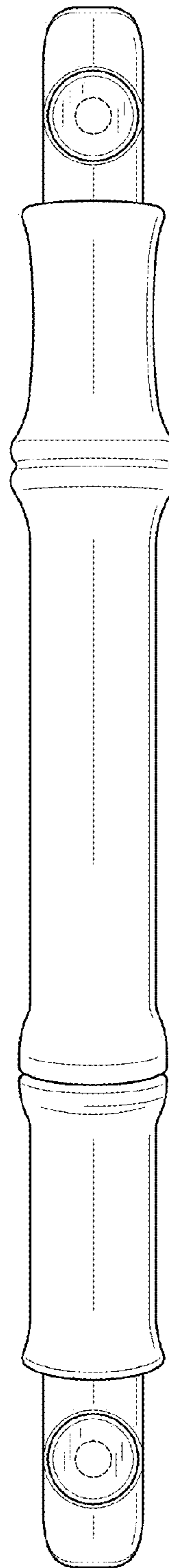
