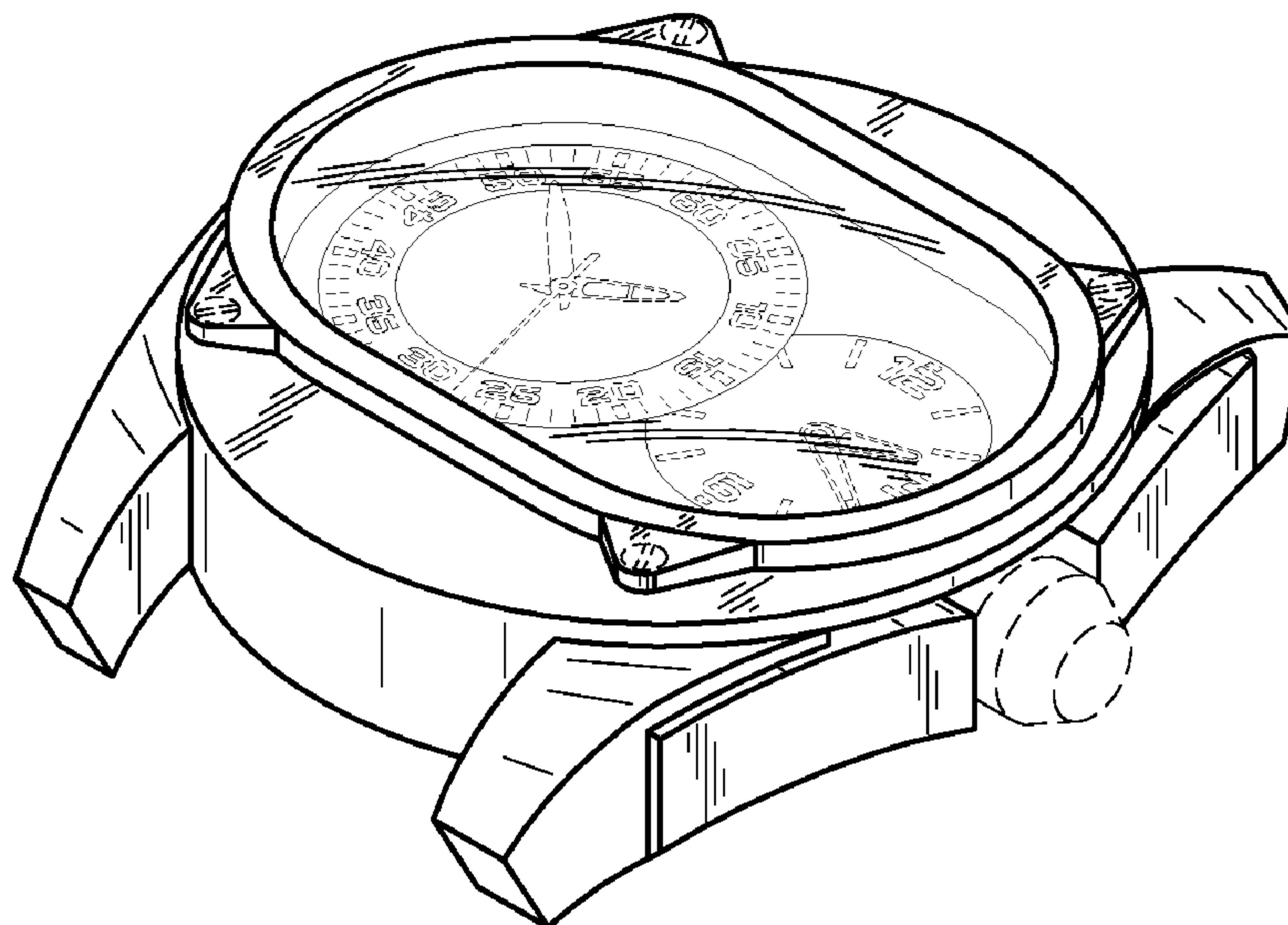

DESCRIPTION

FIG. 1 is a front, right side and bottom perspective view of a watch showing my new design;

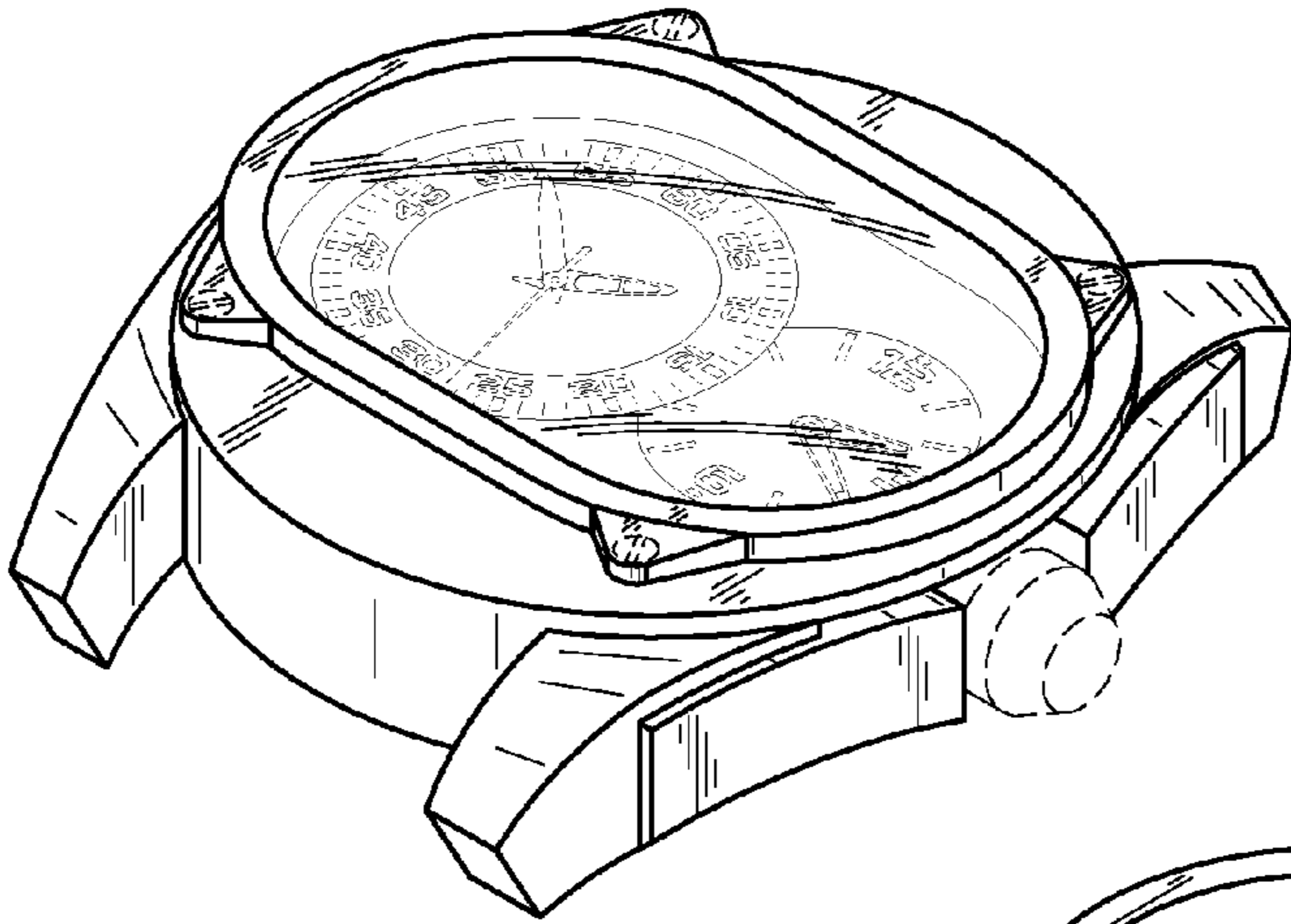

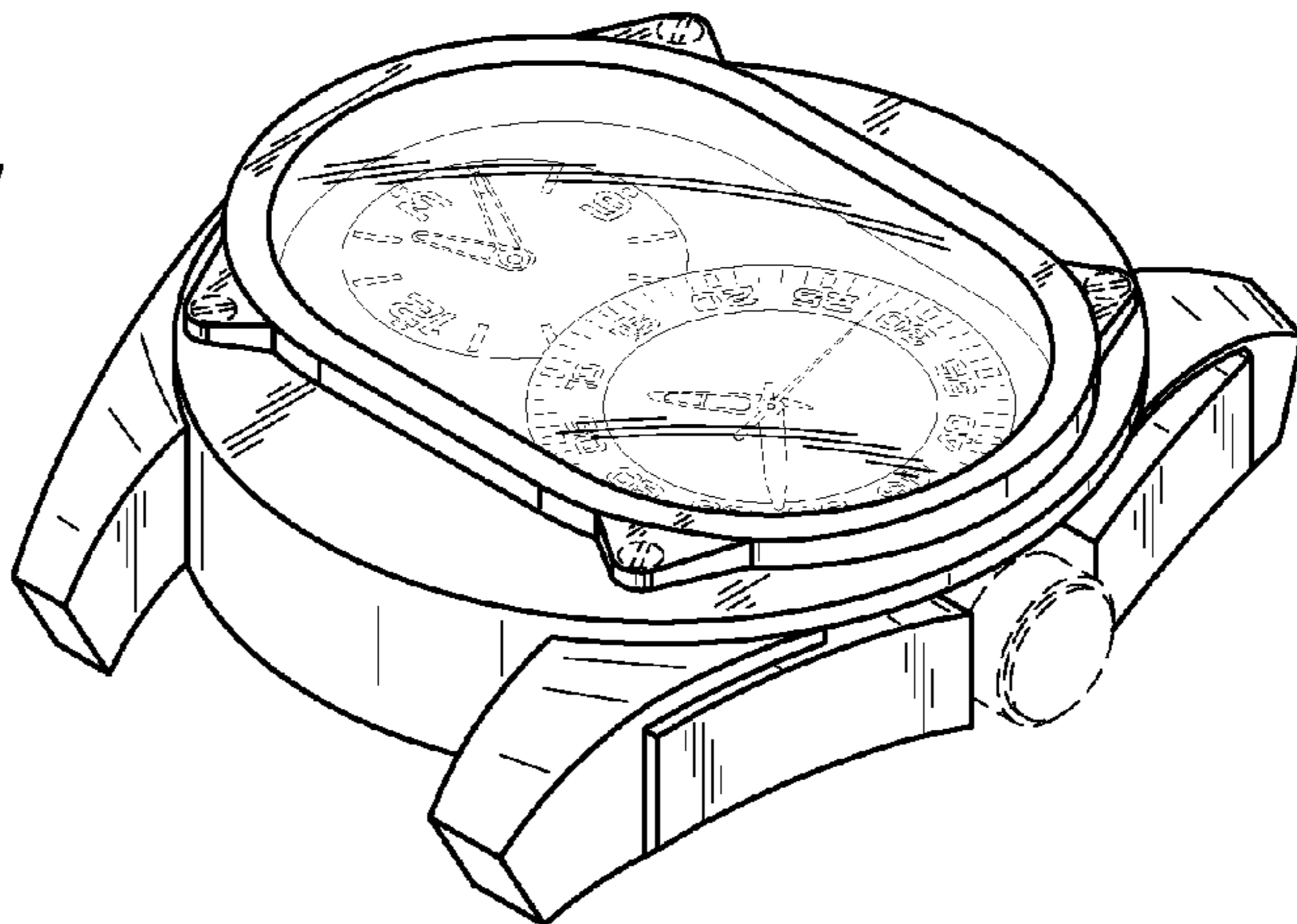

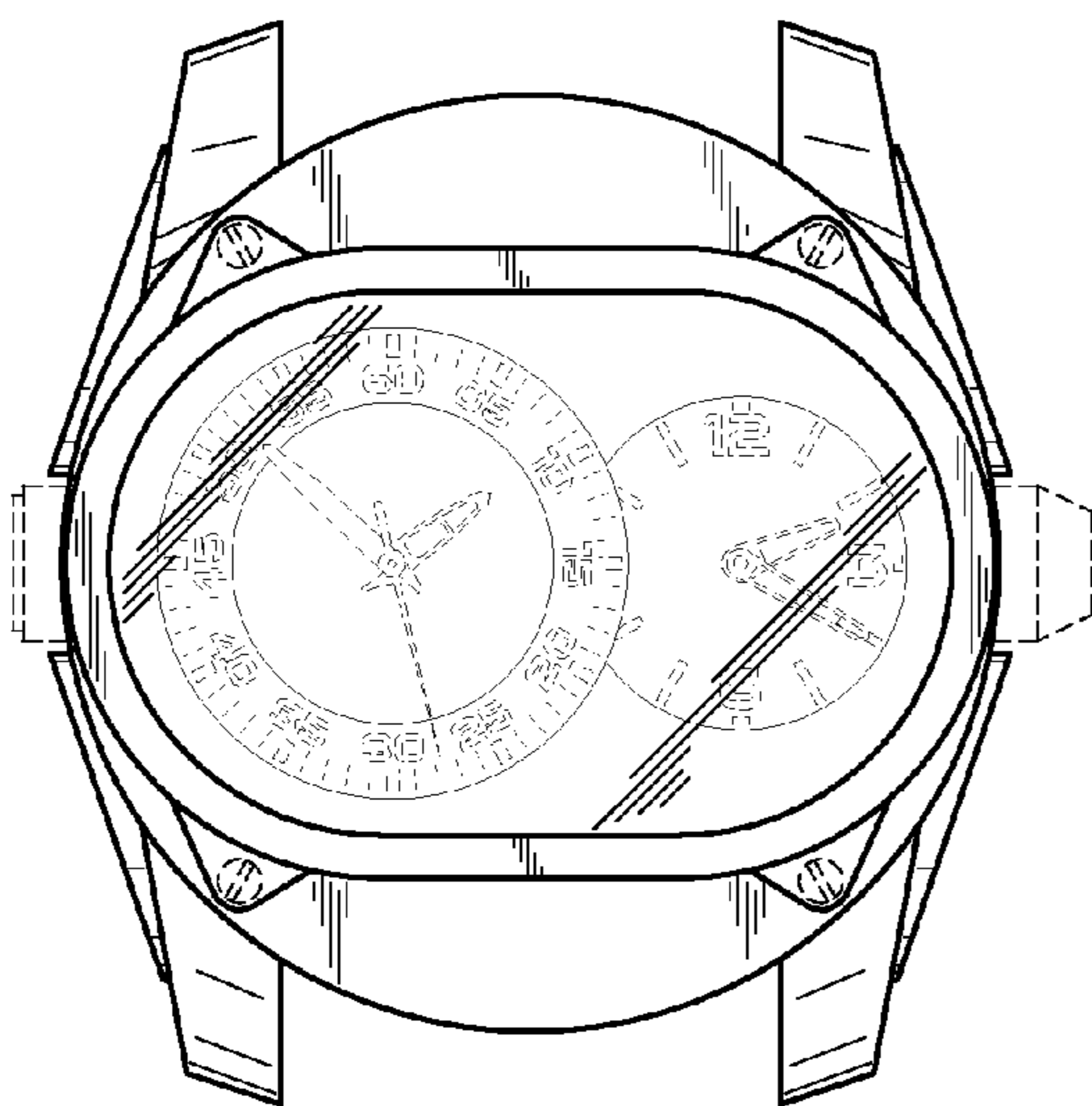

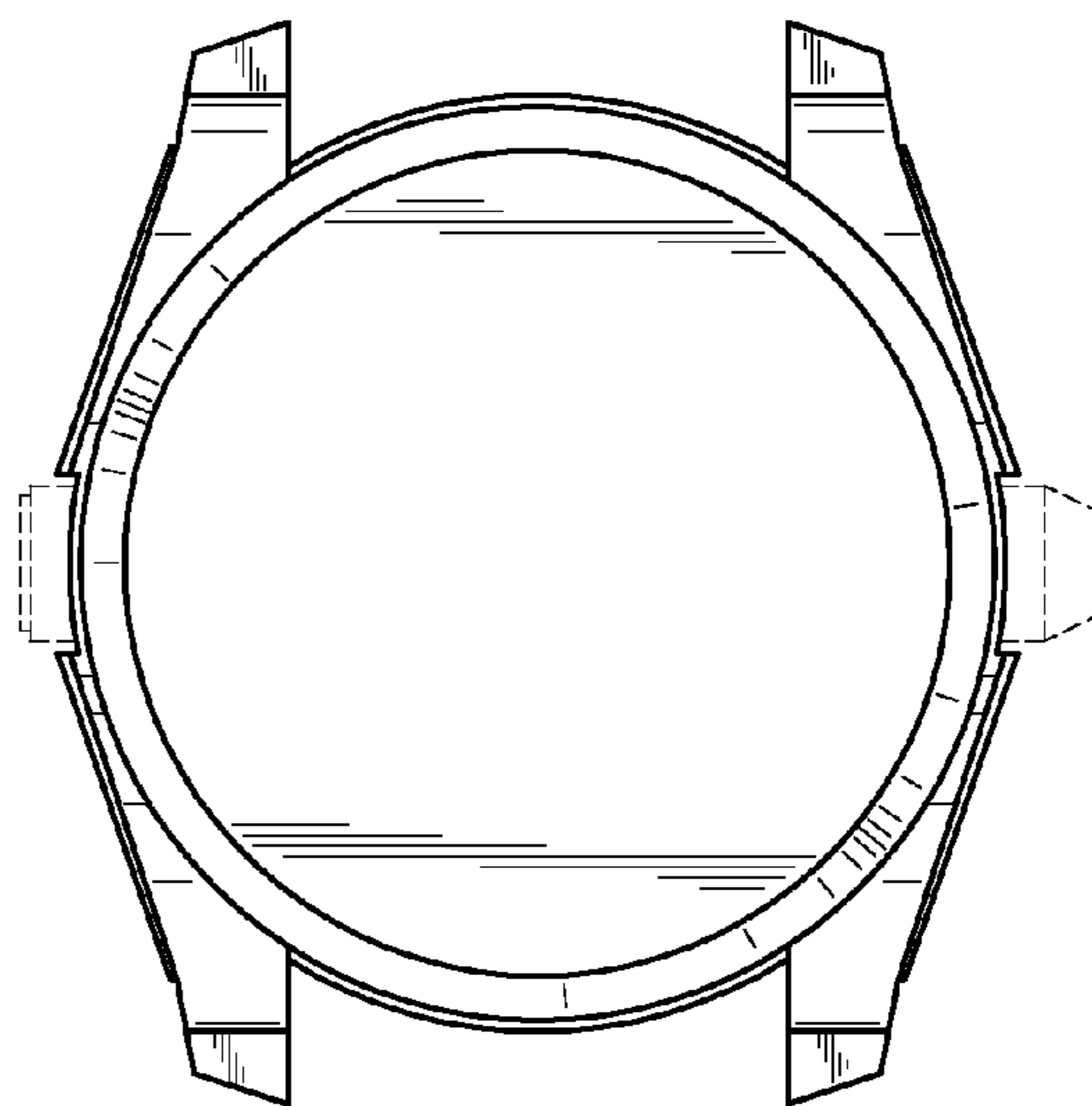

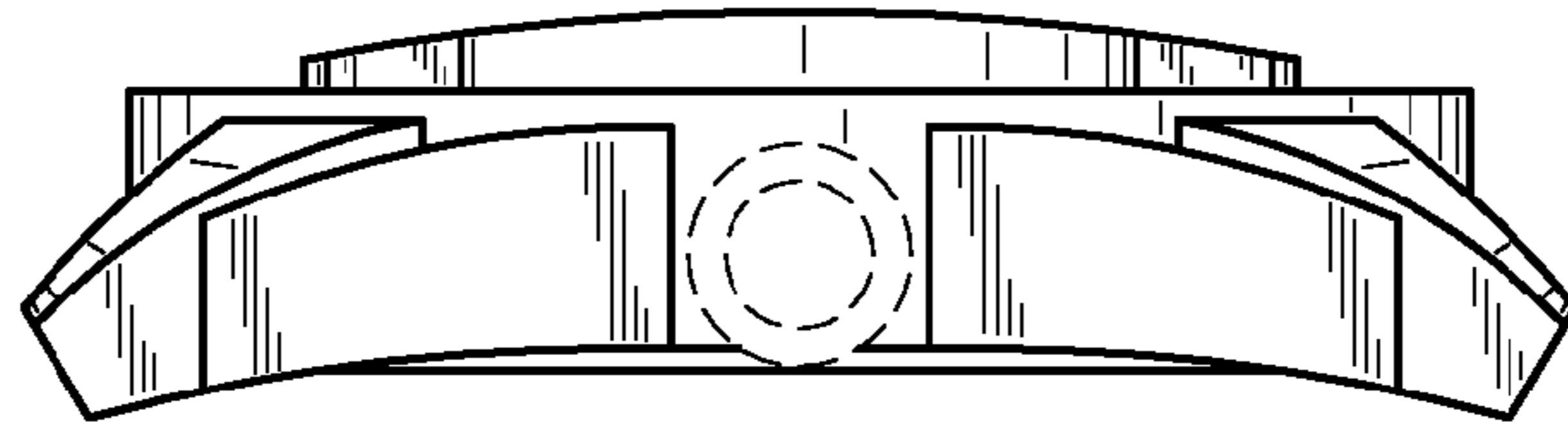

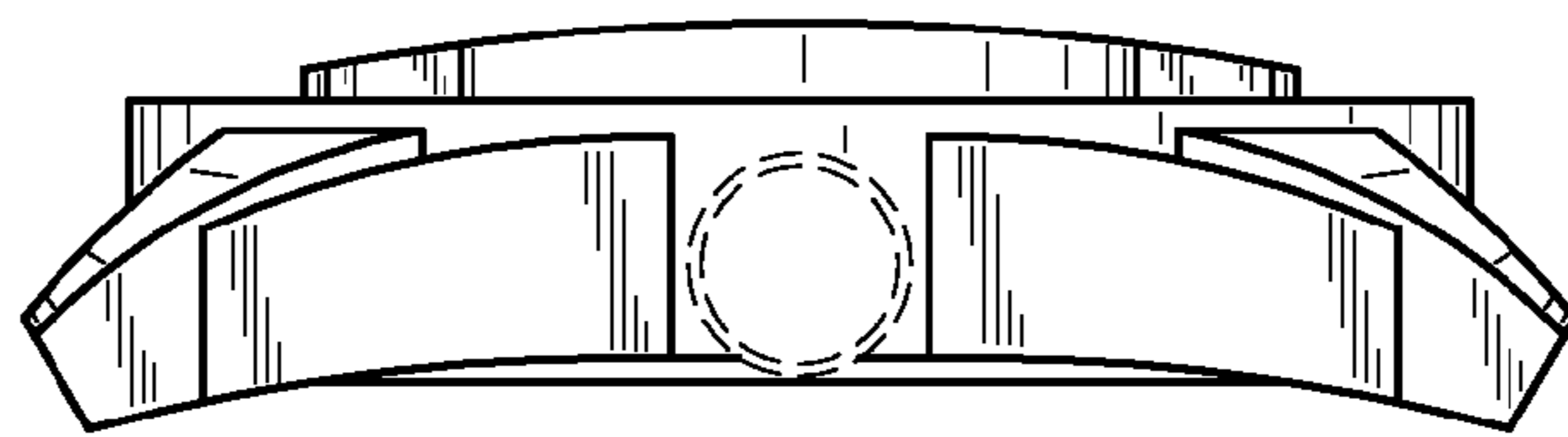

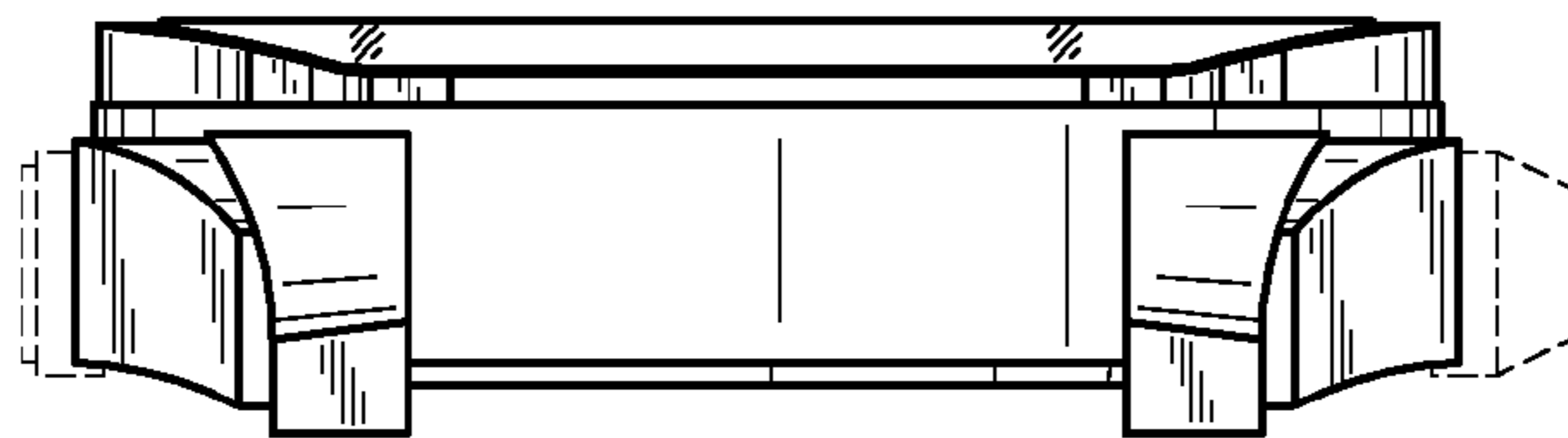

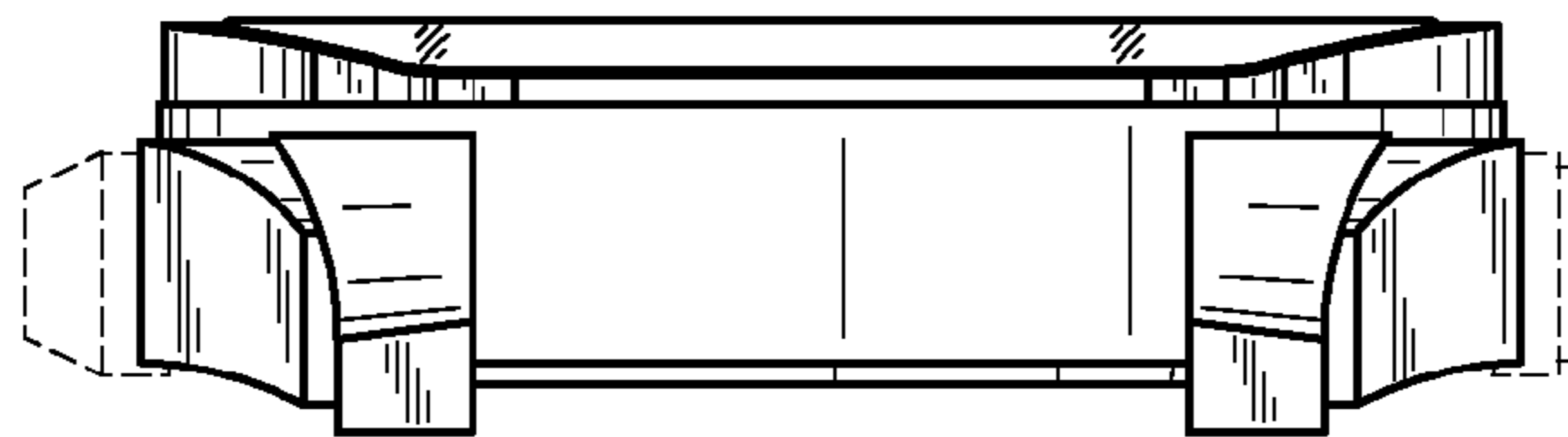
