The ornamental design for, a side cover for a motor scooter, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of a side cover for a motor scooter, showing our new design; FIG. 2 is a right front perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a top plan view thereof; and, FIG. 5 is a right side elevation view thereof. The broken lines illustrate unclaimed structure.

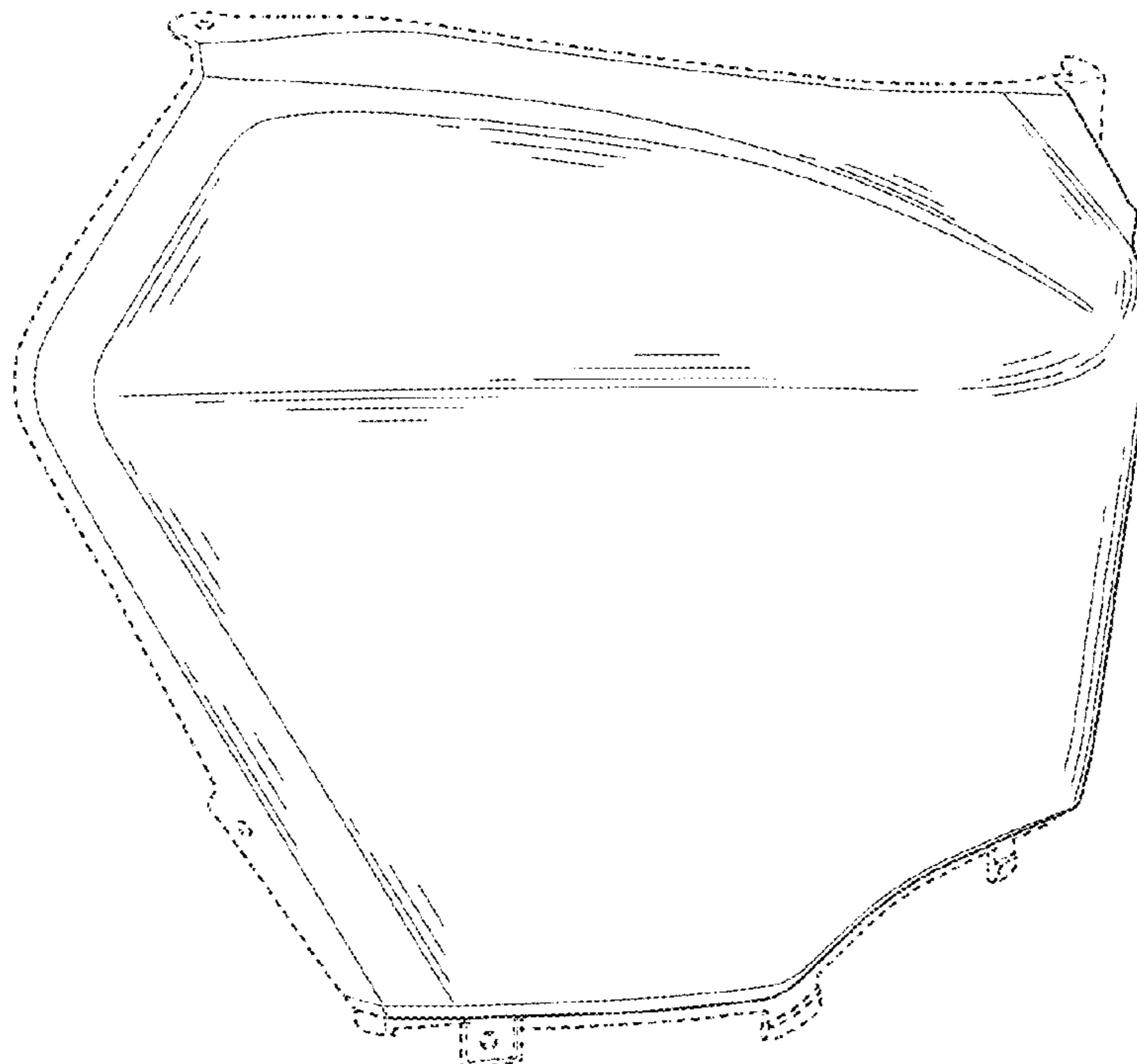

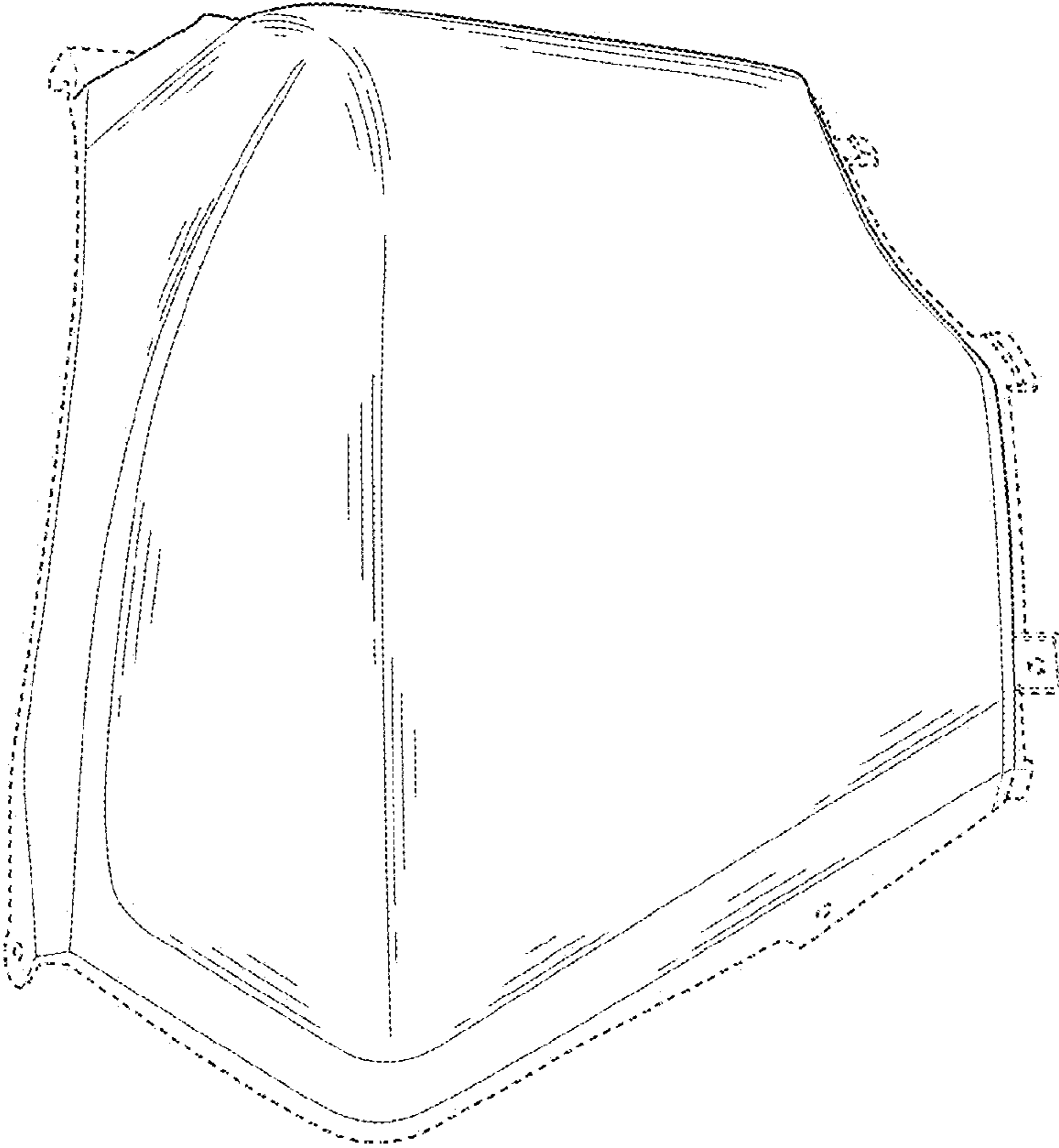

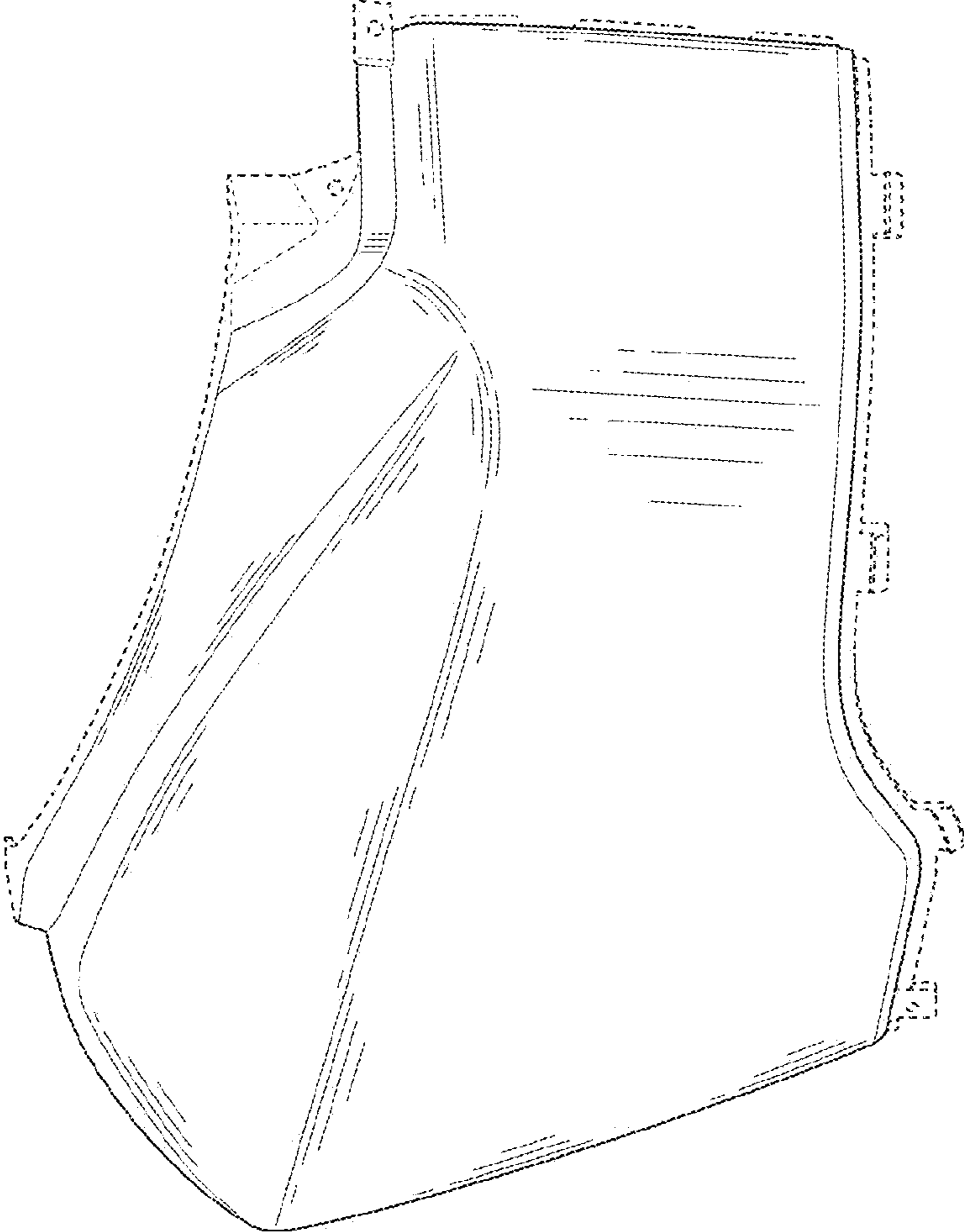

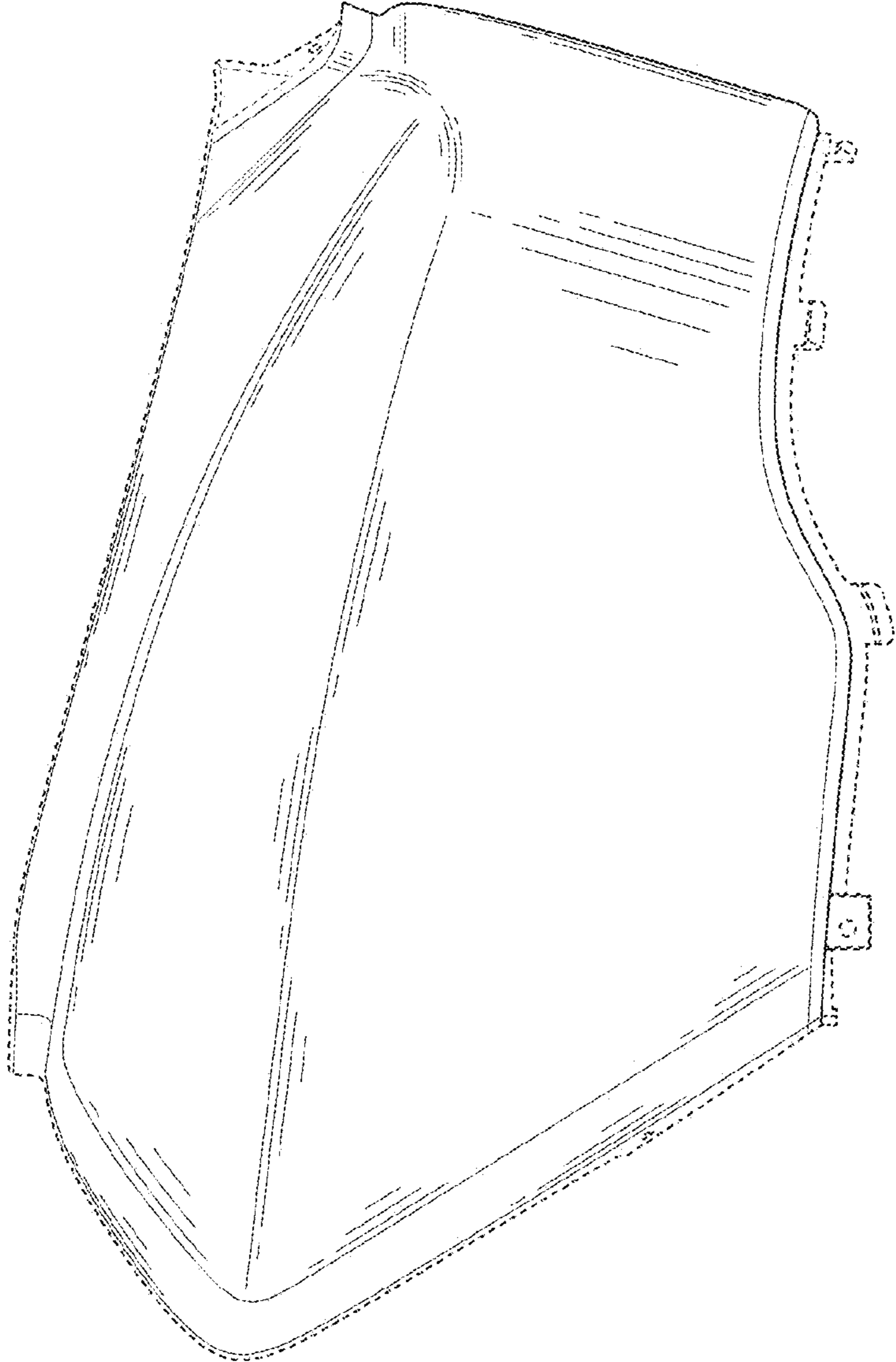

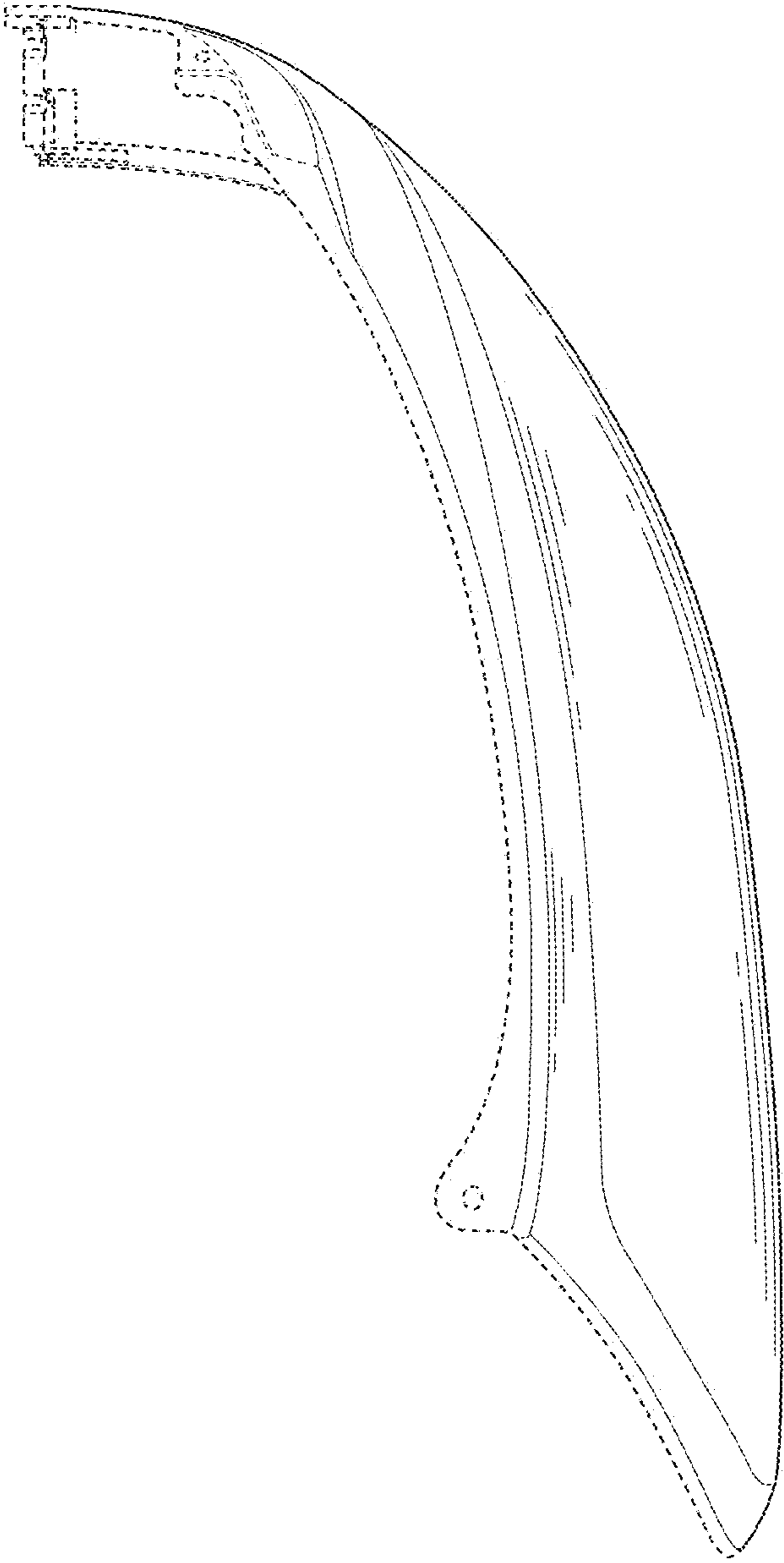
