as shown and described.

**DESCRIPTION**

luggage compartment.

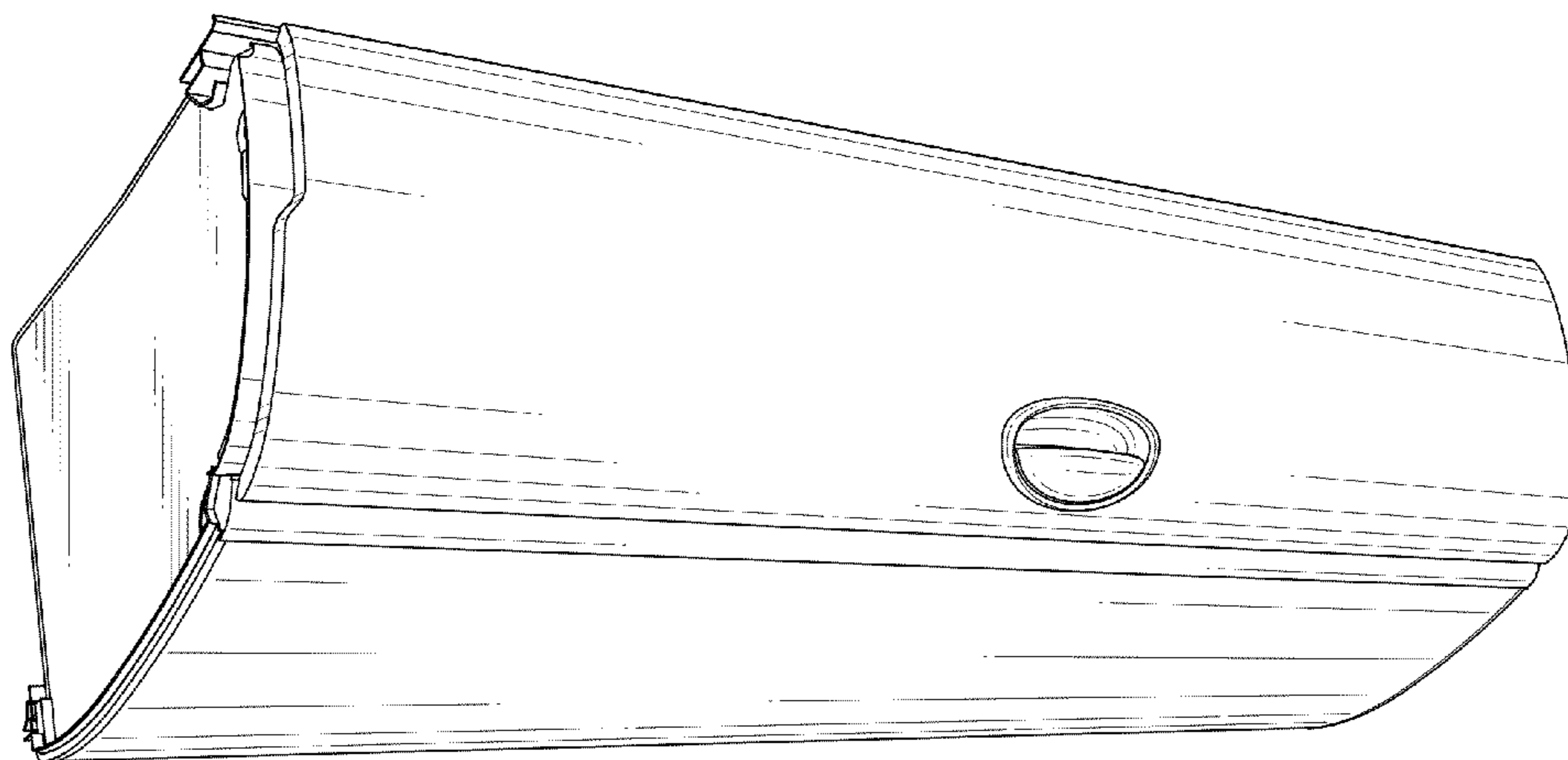

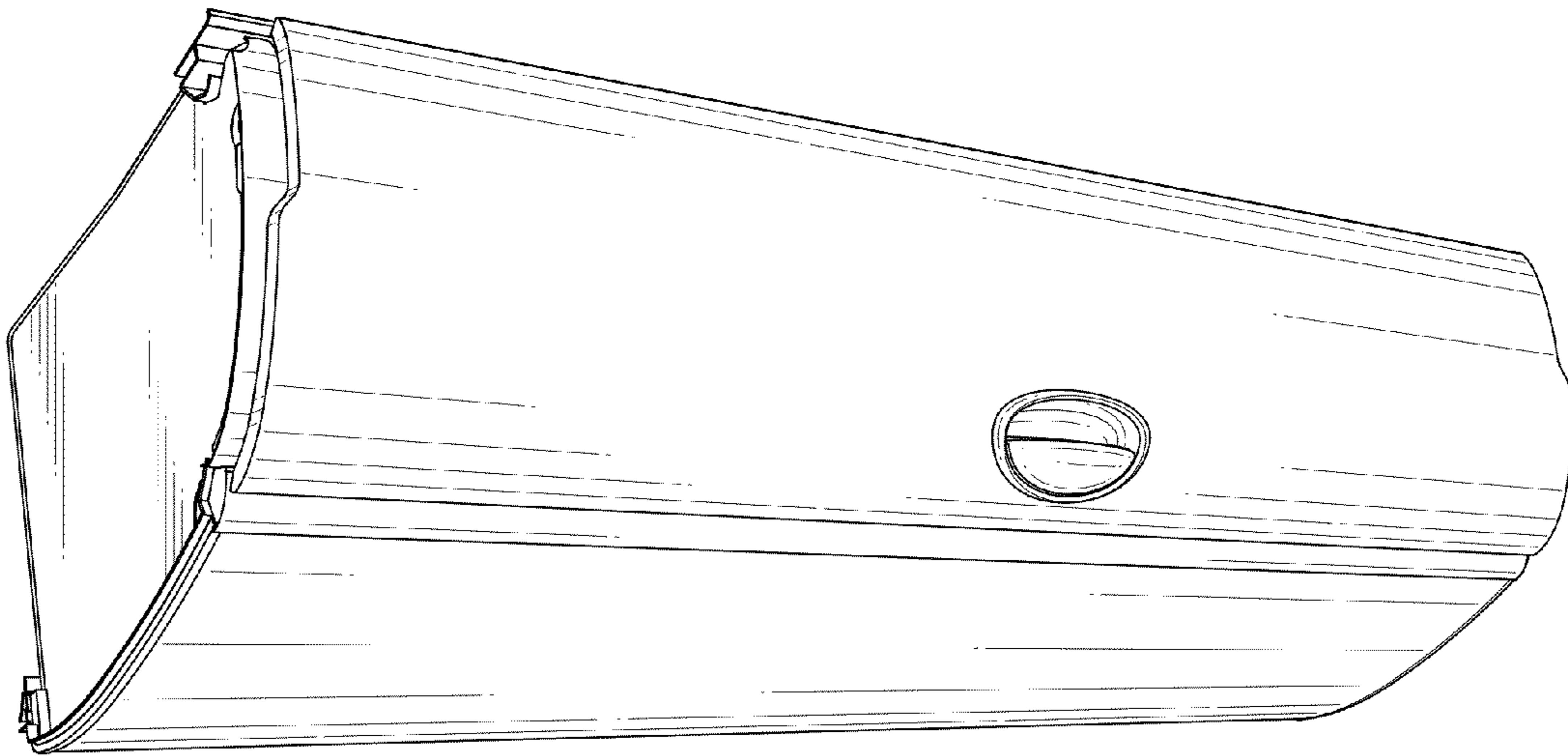

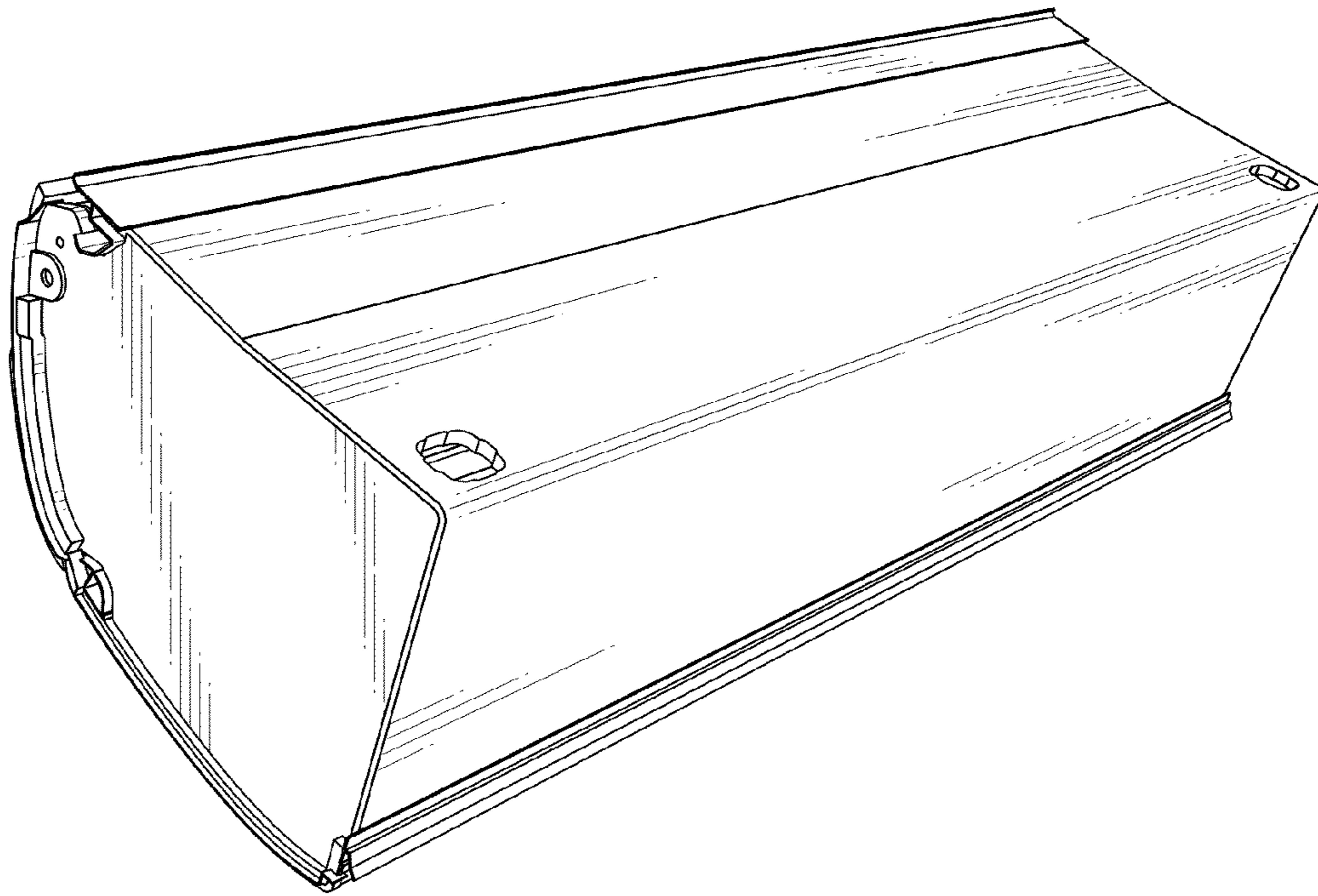

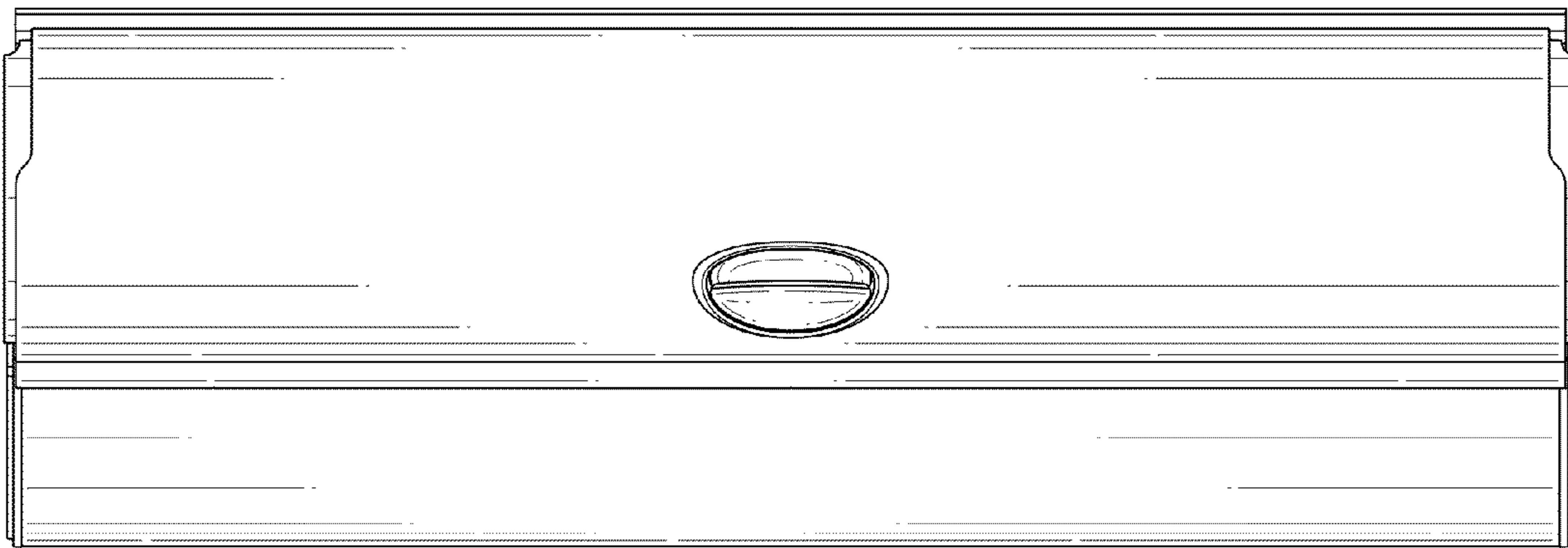

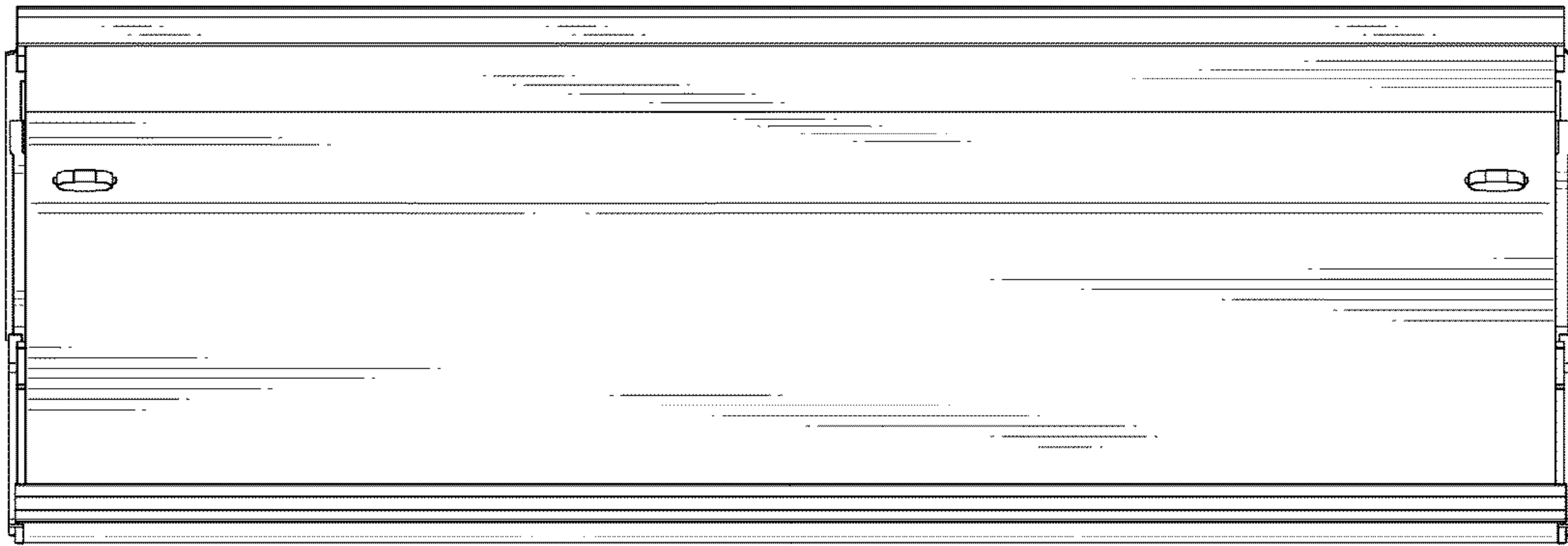

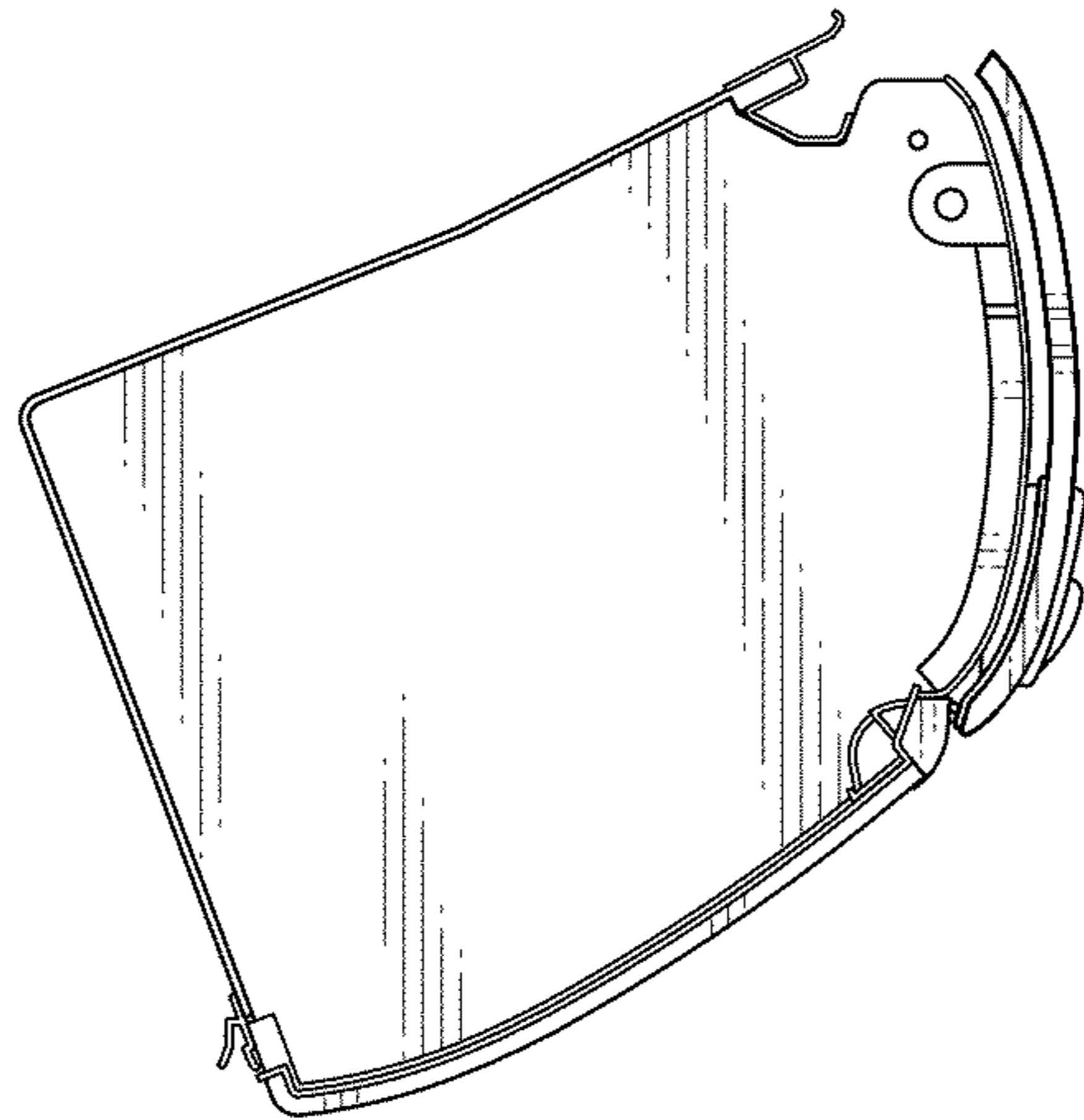

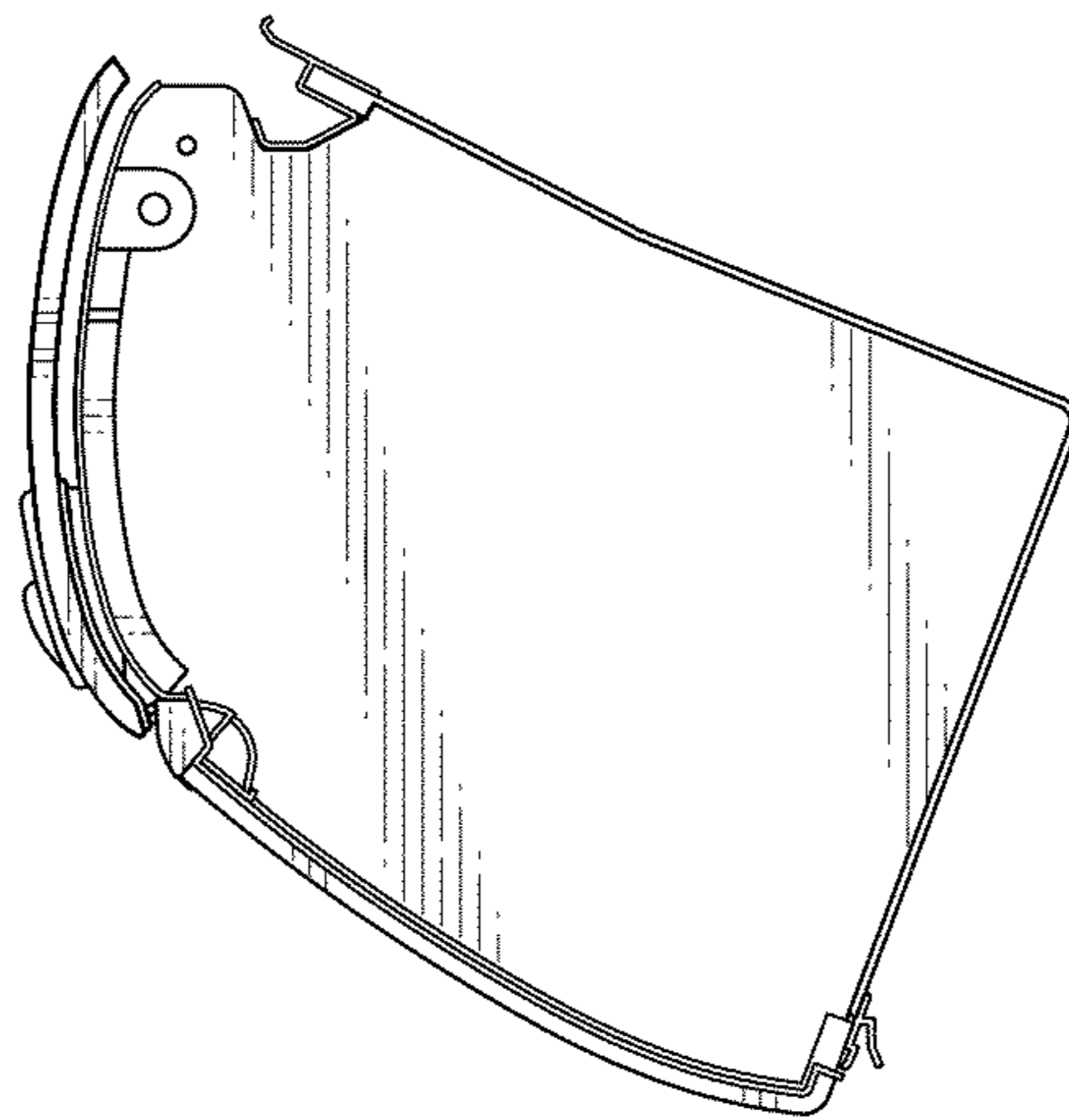

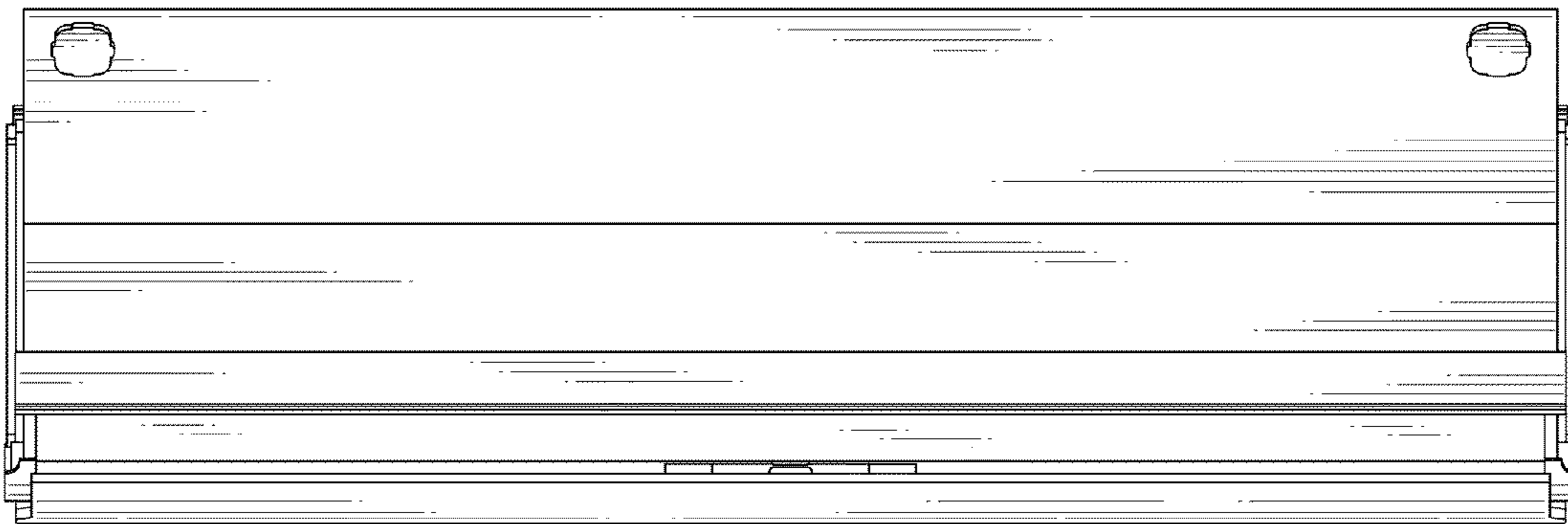
