(57) **CLAIM**

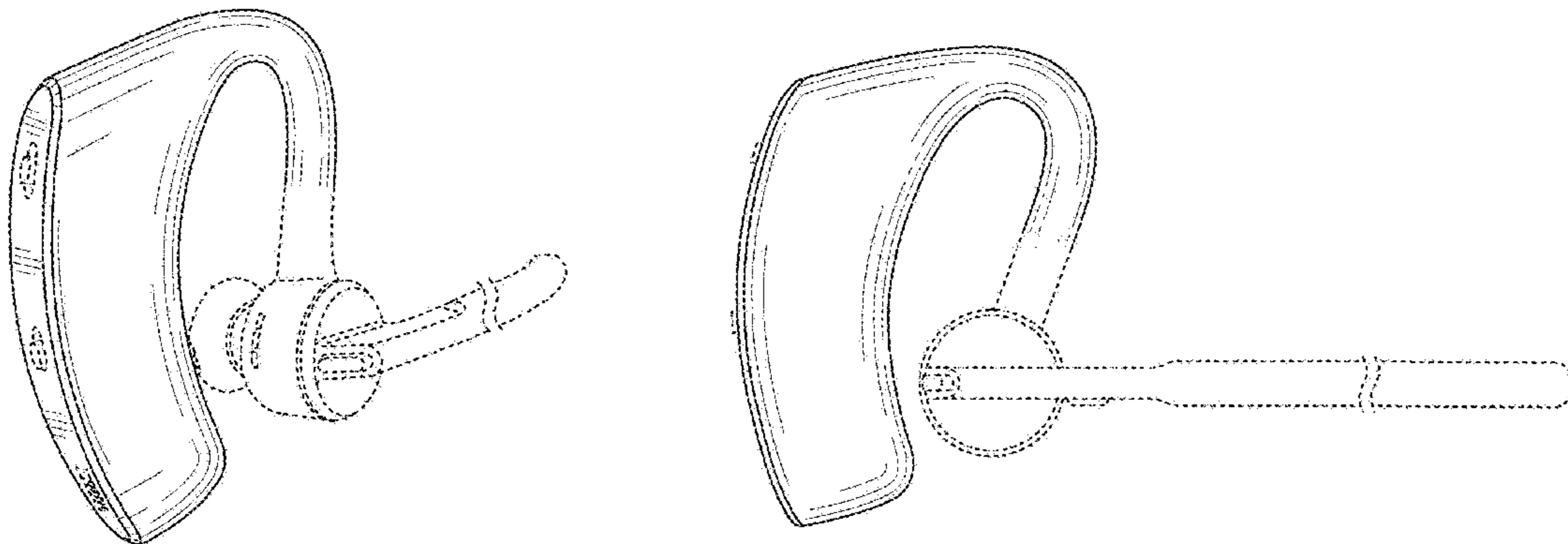
The ornamental design for a communications headset, as shown and described.

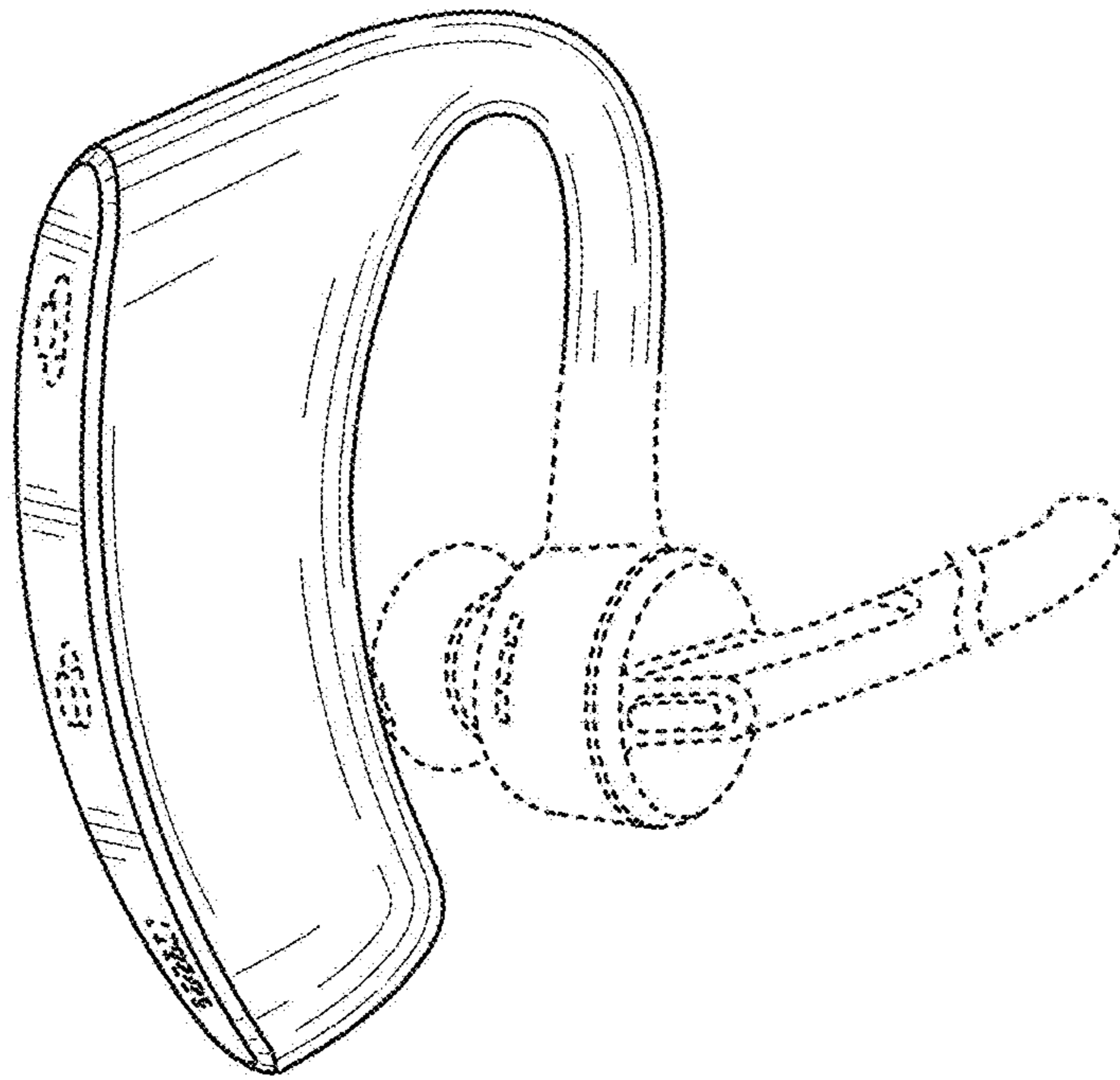

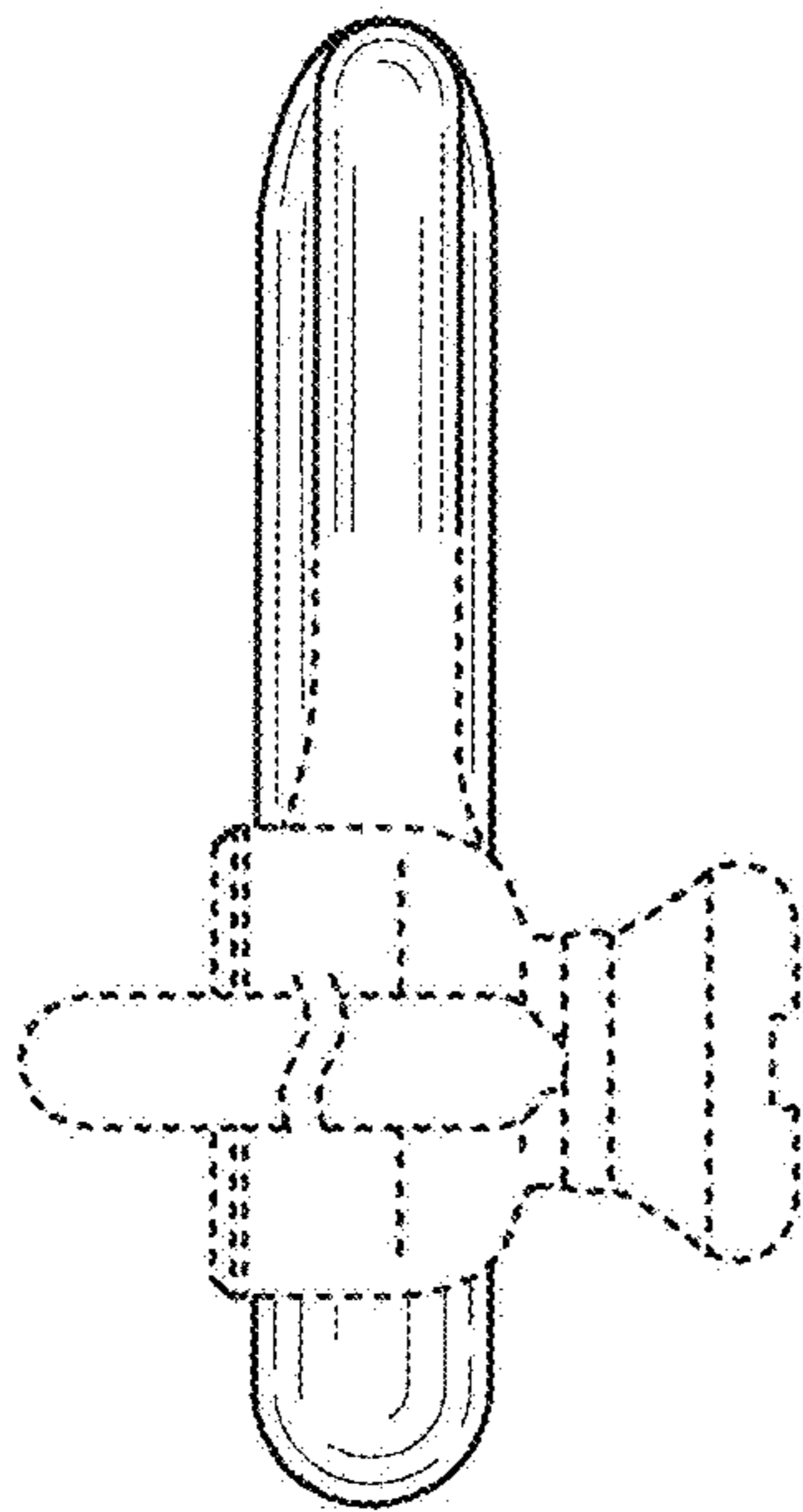

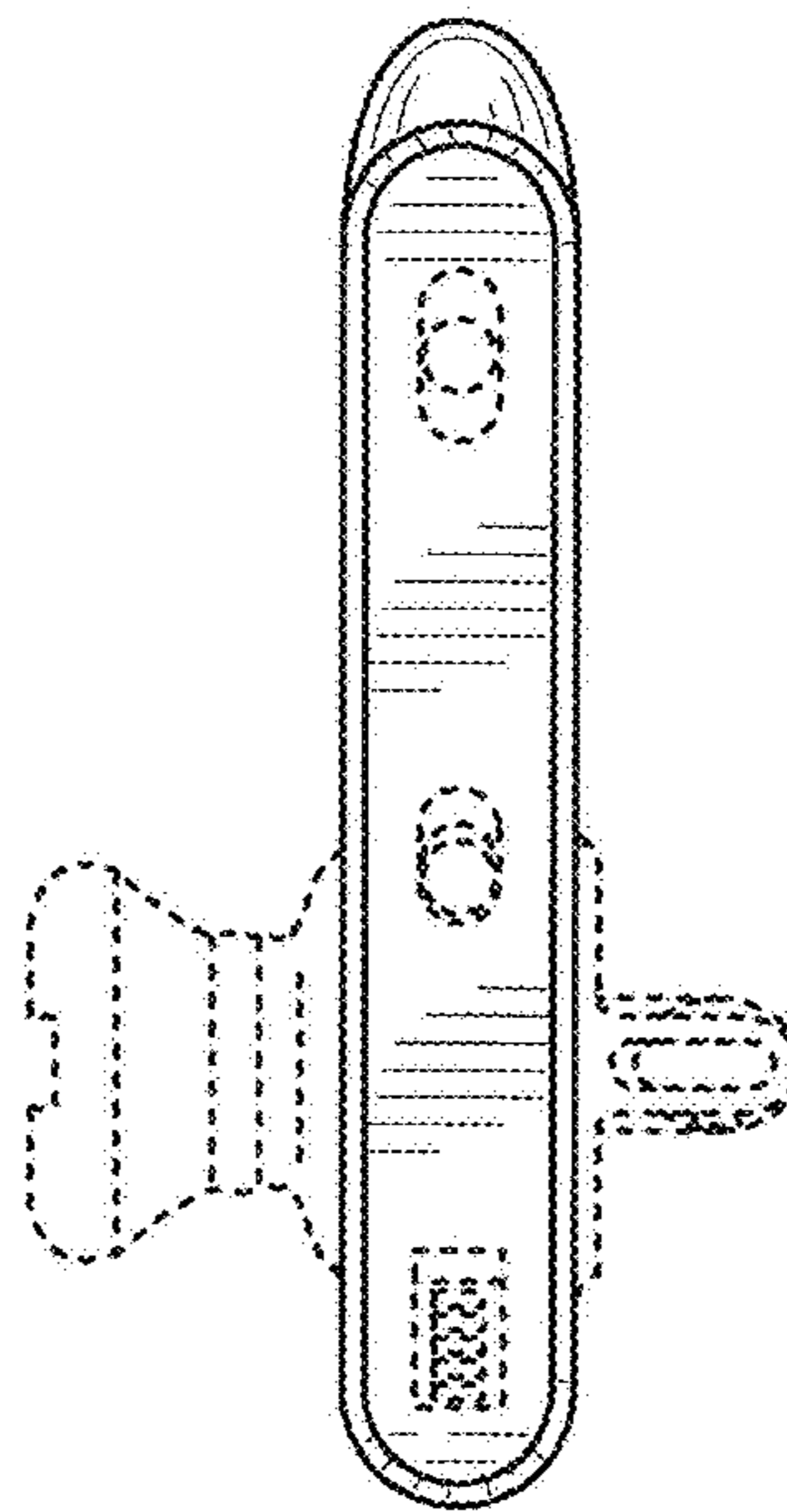

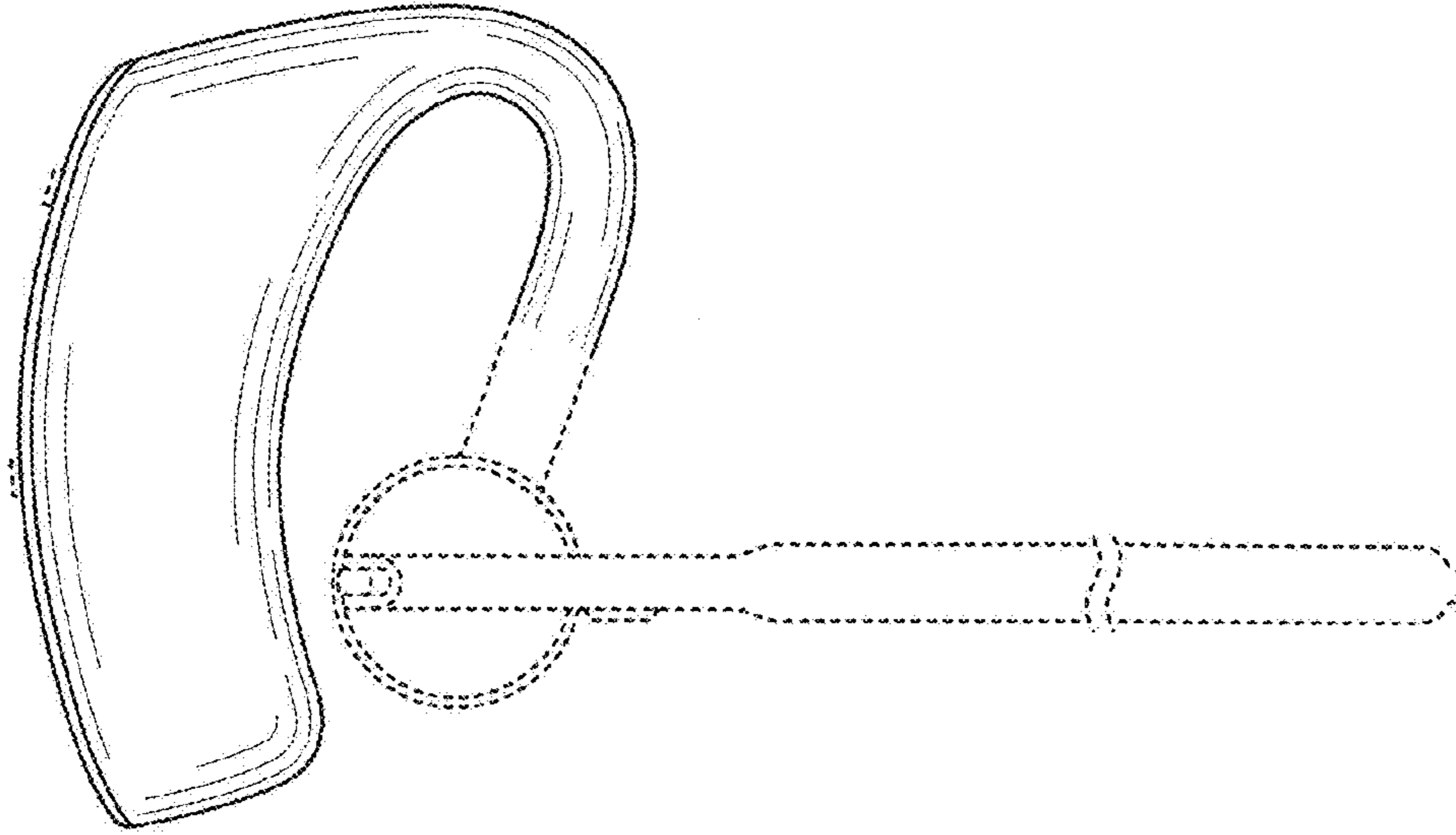

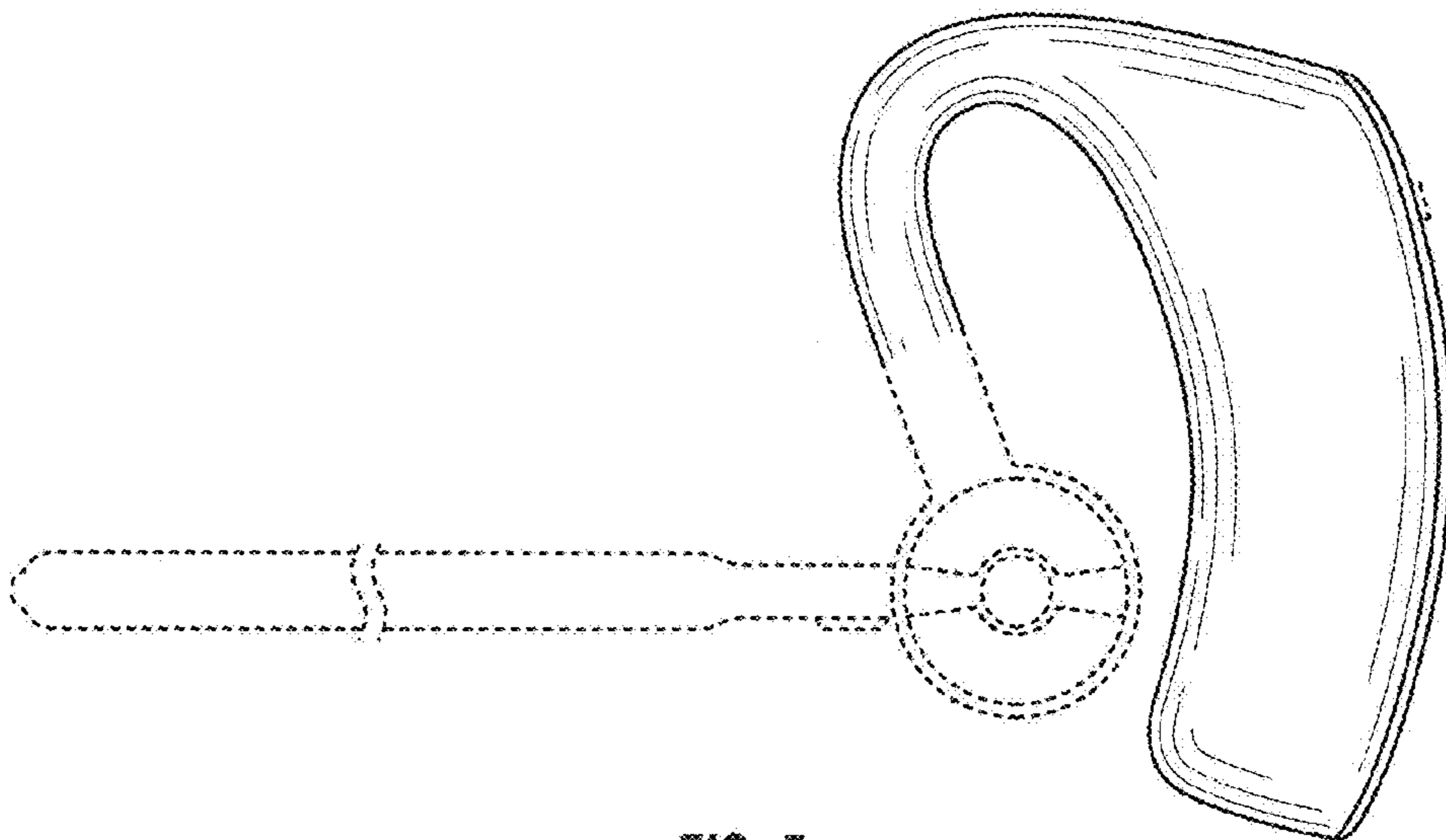

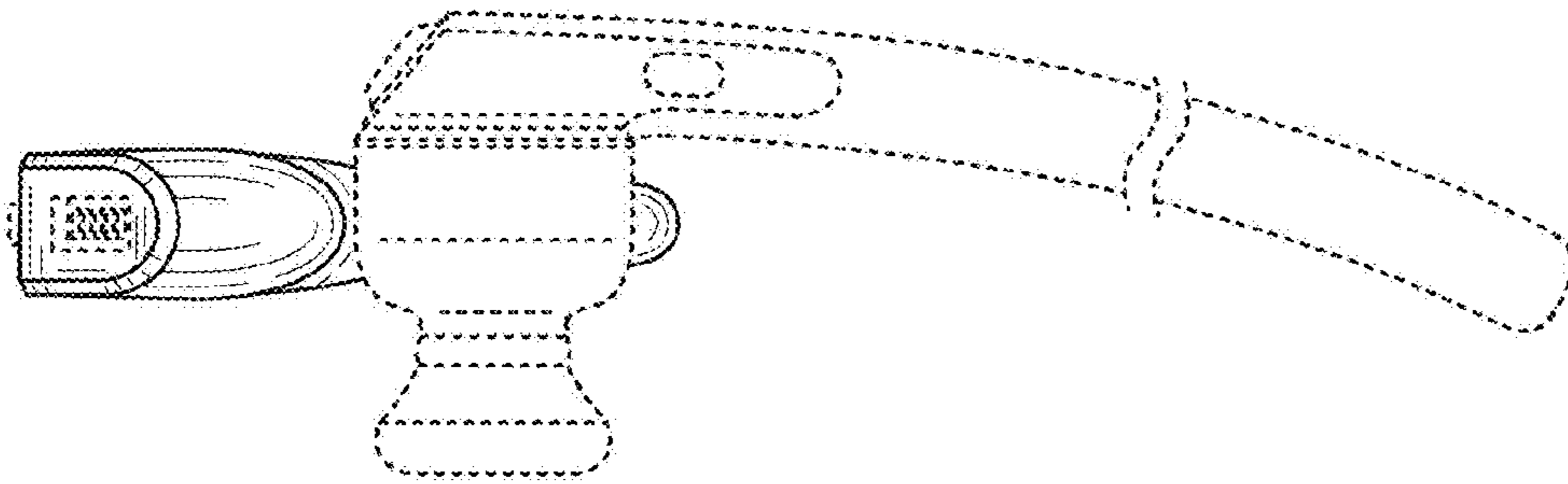

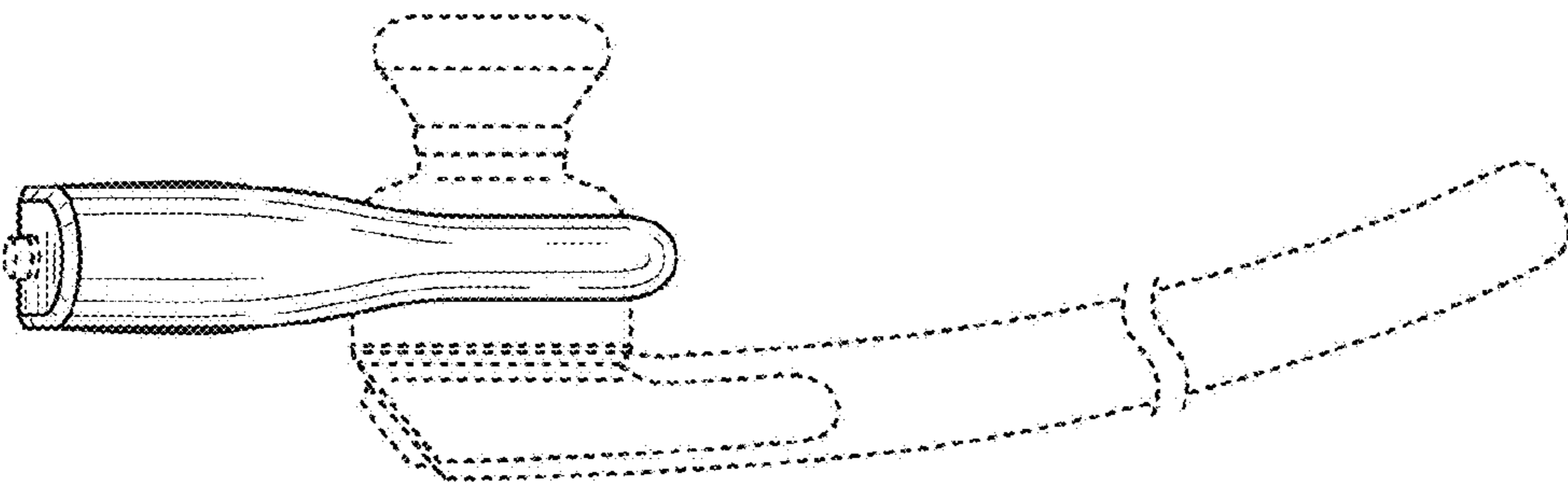
