(57) **CLAIM**

I claim the ornamental design for a side panel for a mower, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a side panel for a mower, showing my new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a perspective view thereof;

FIG. 7 is another perspective view thereof;

FIG. 8 is another perspective view thereof;

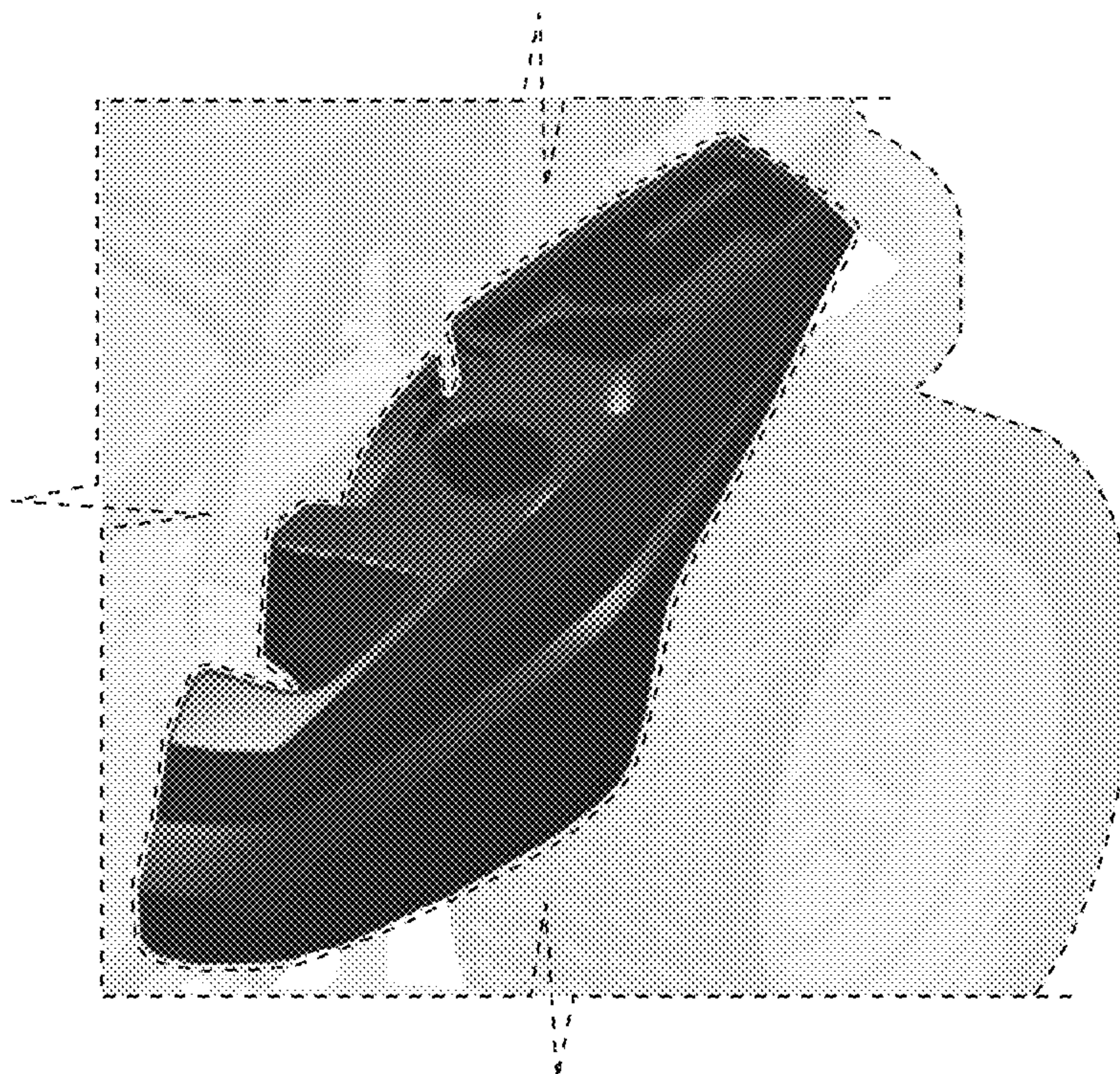
FIG. 9 is another perspective view thereof;

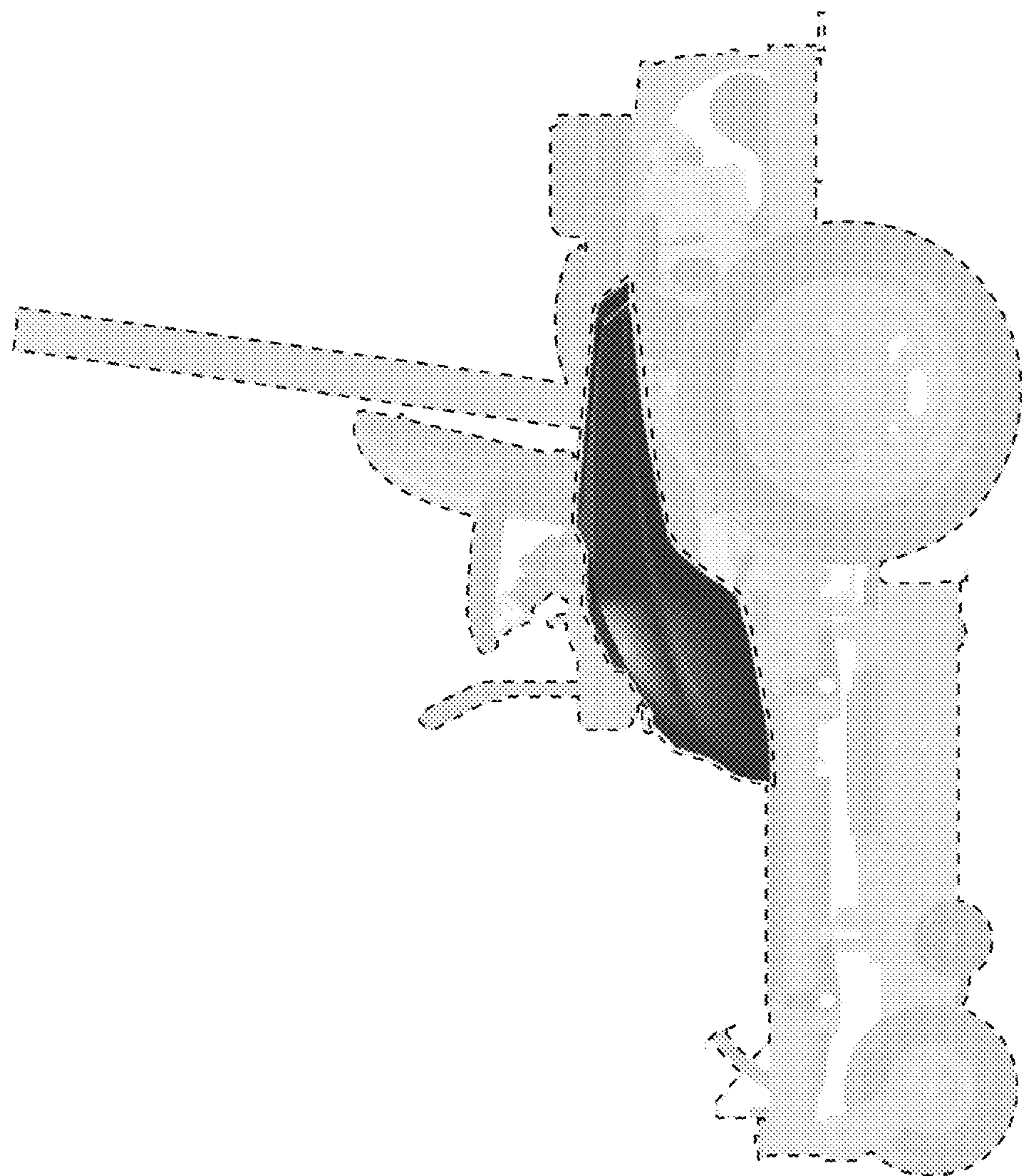

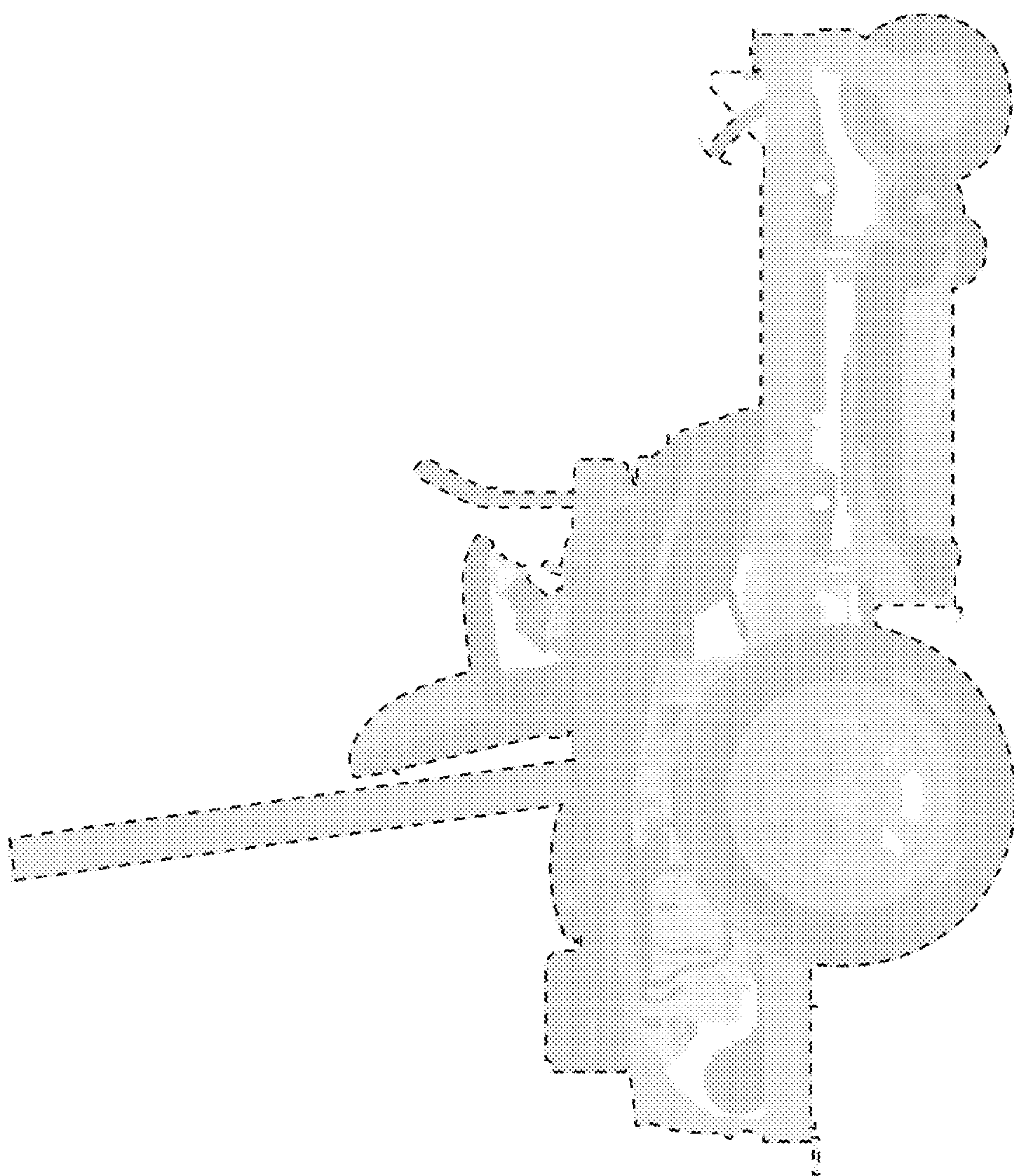

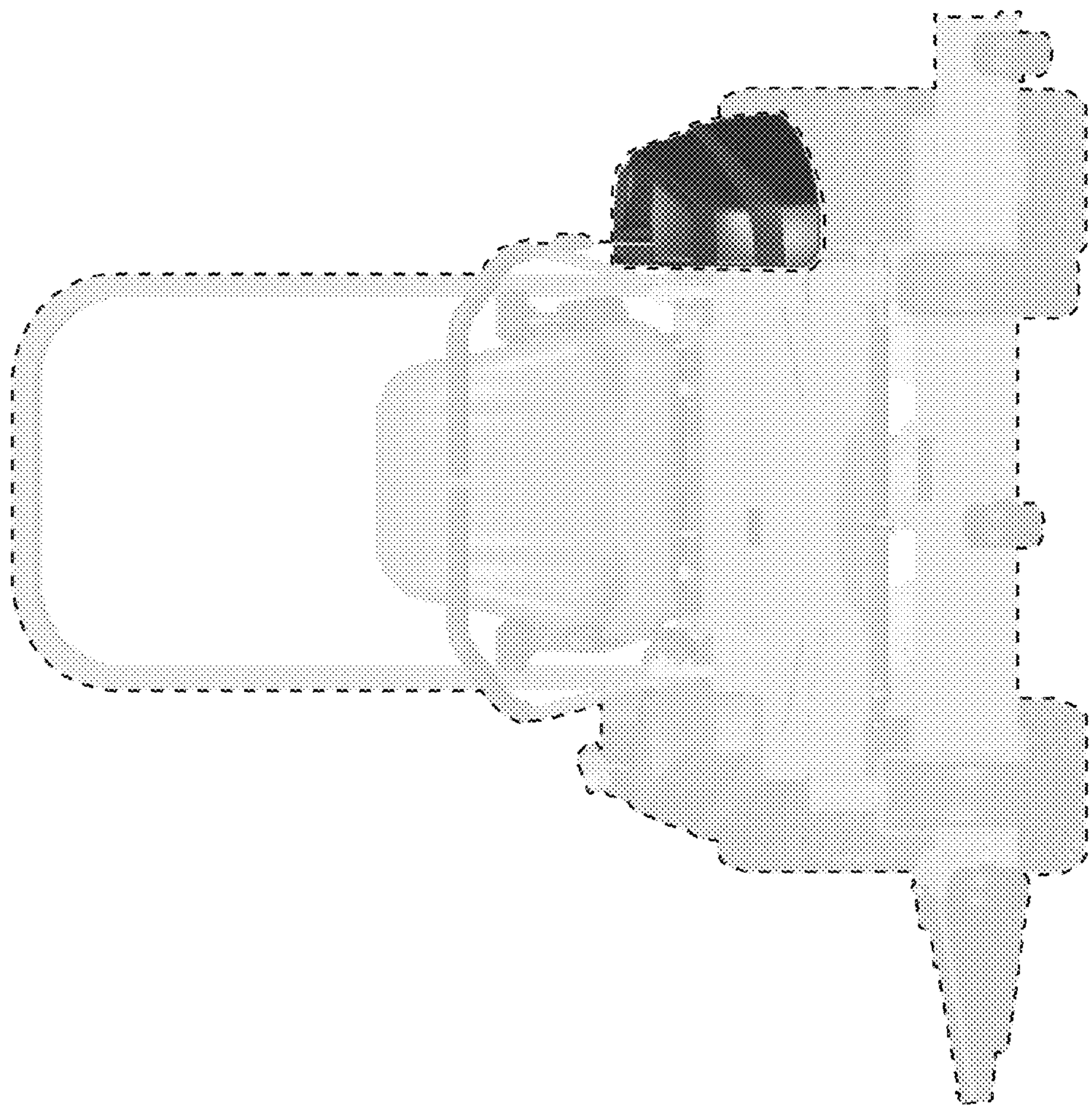

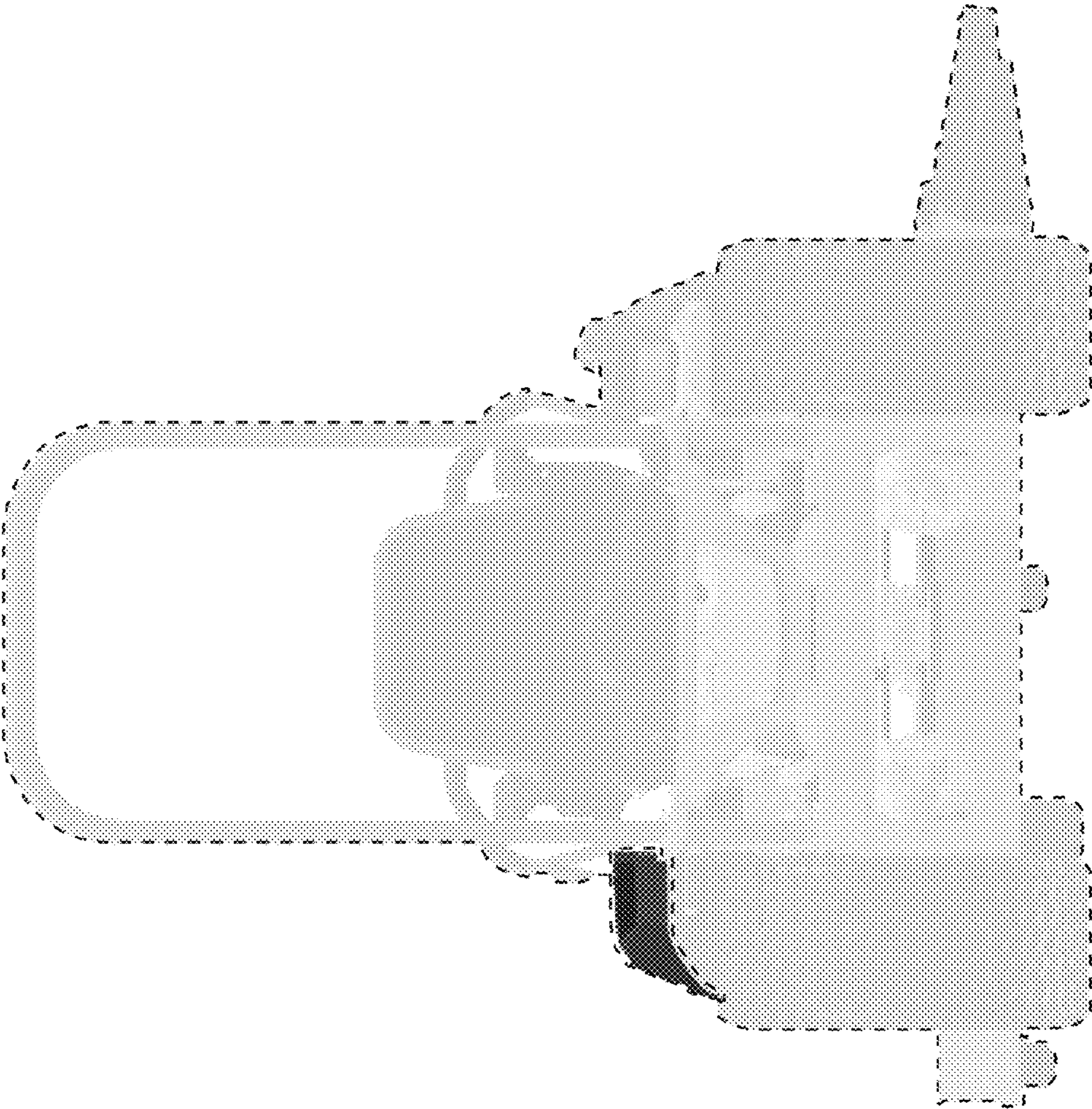

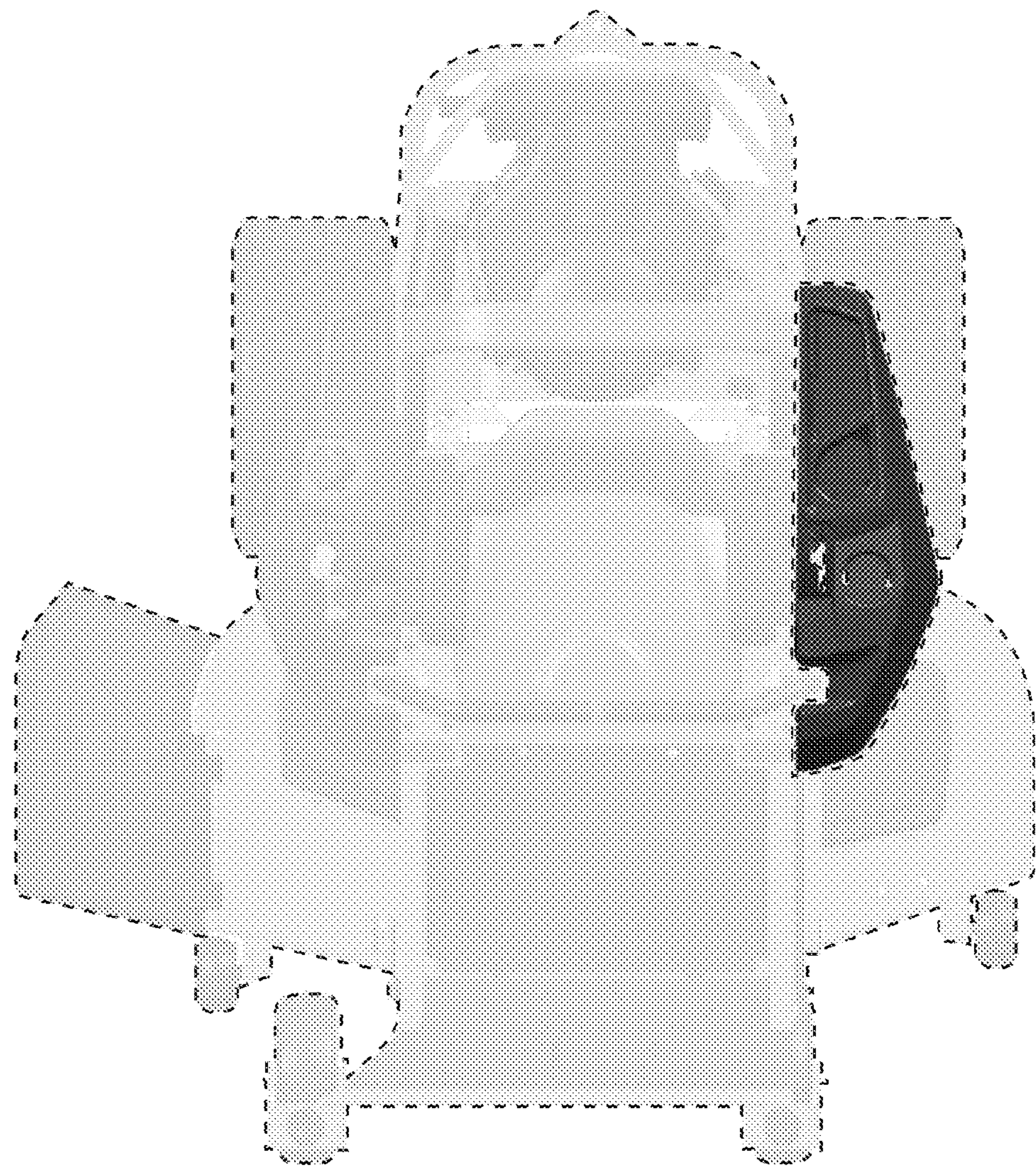

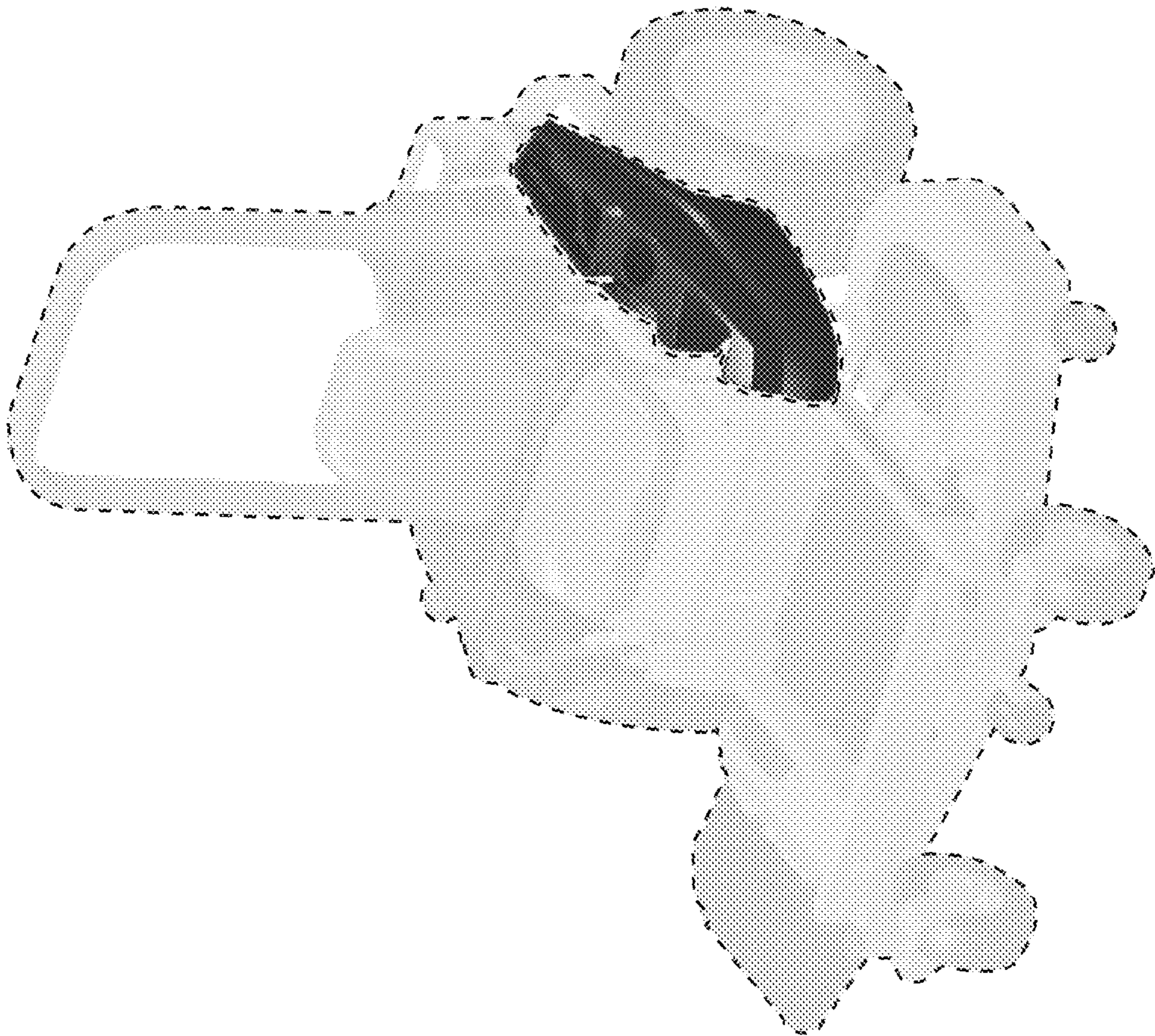

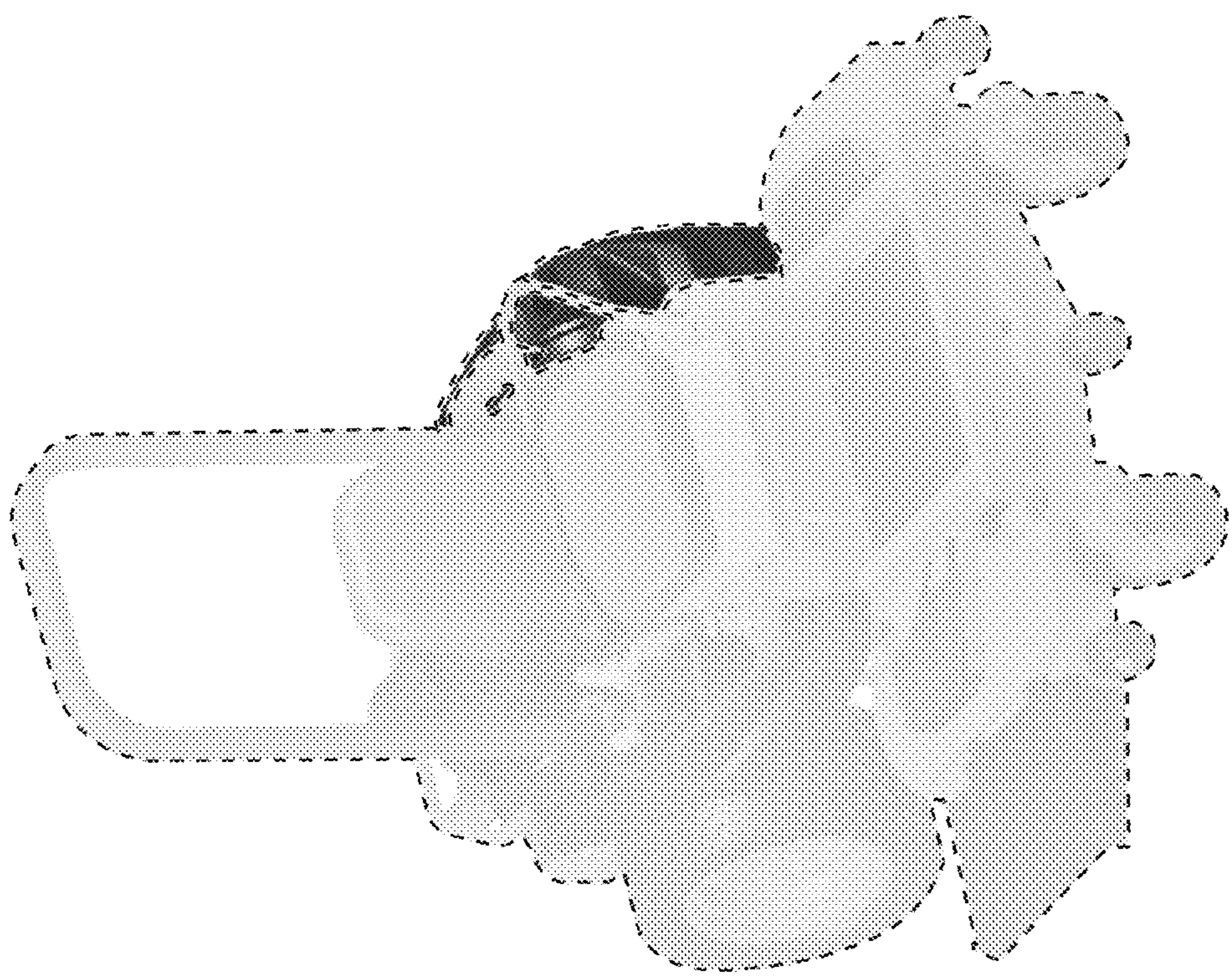

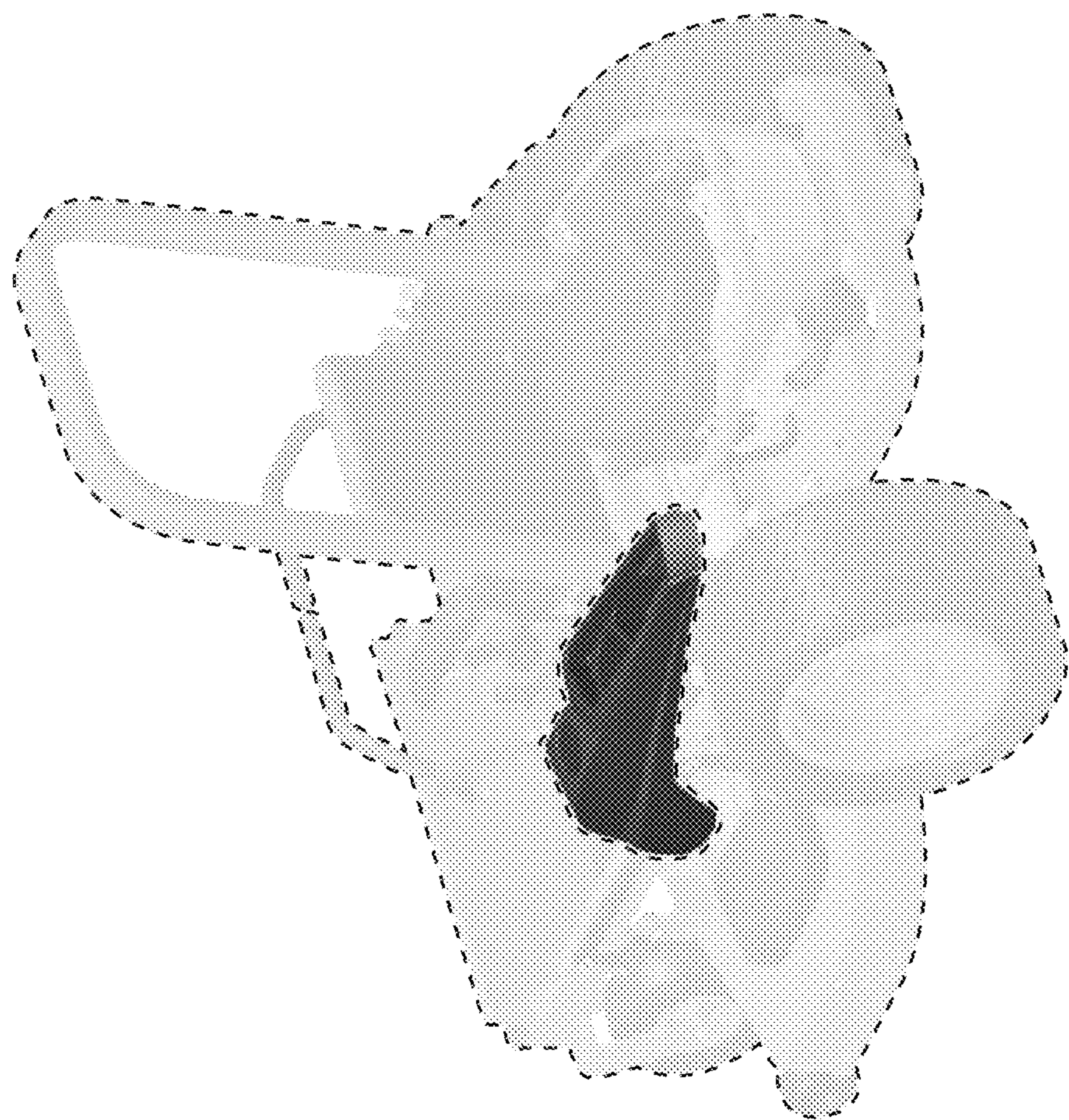

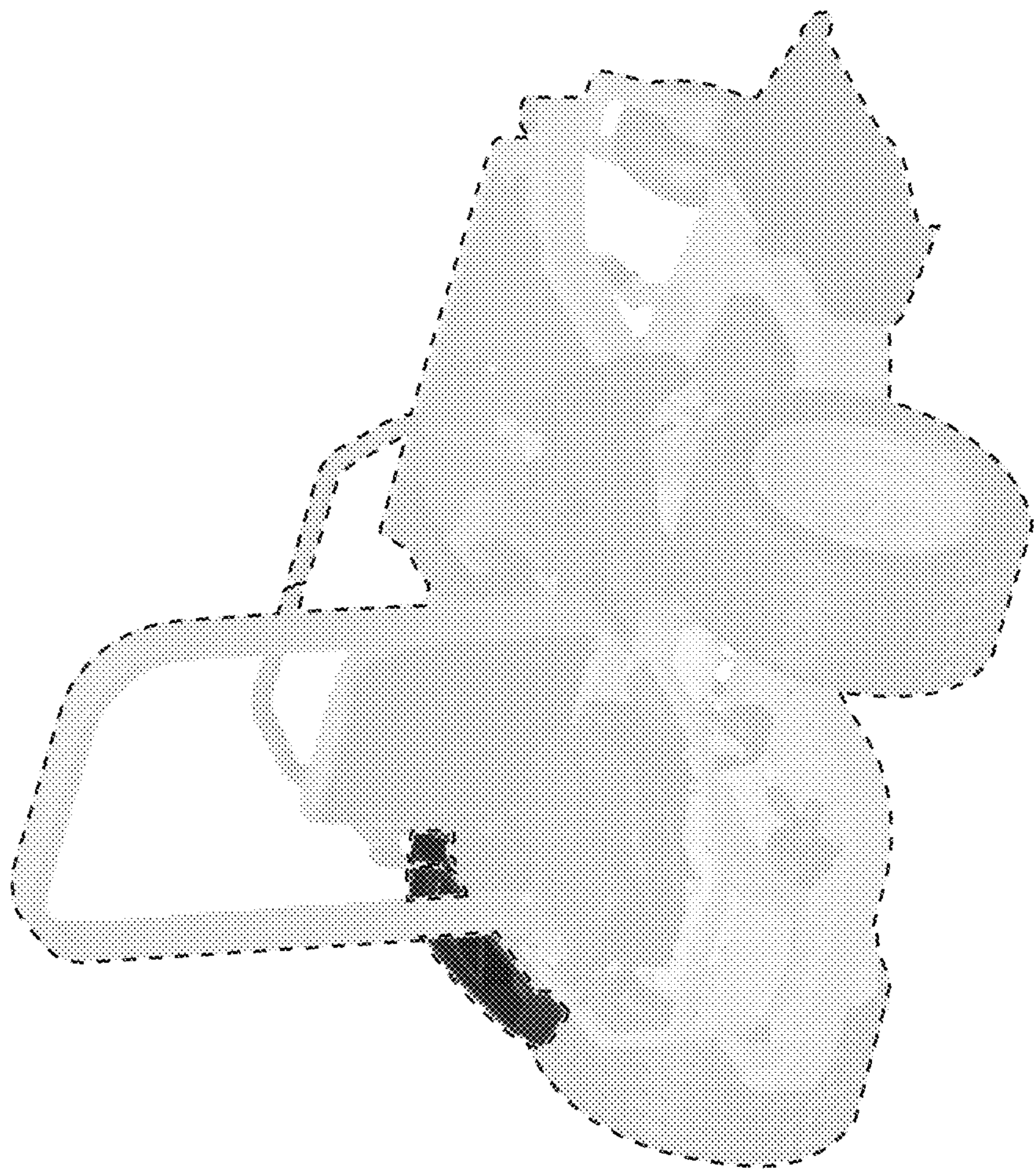

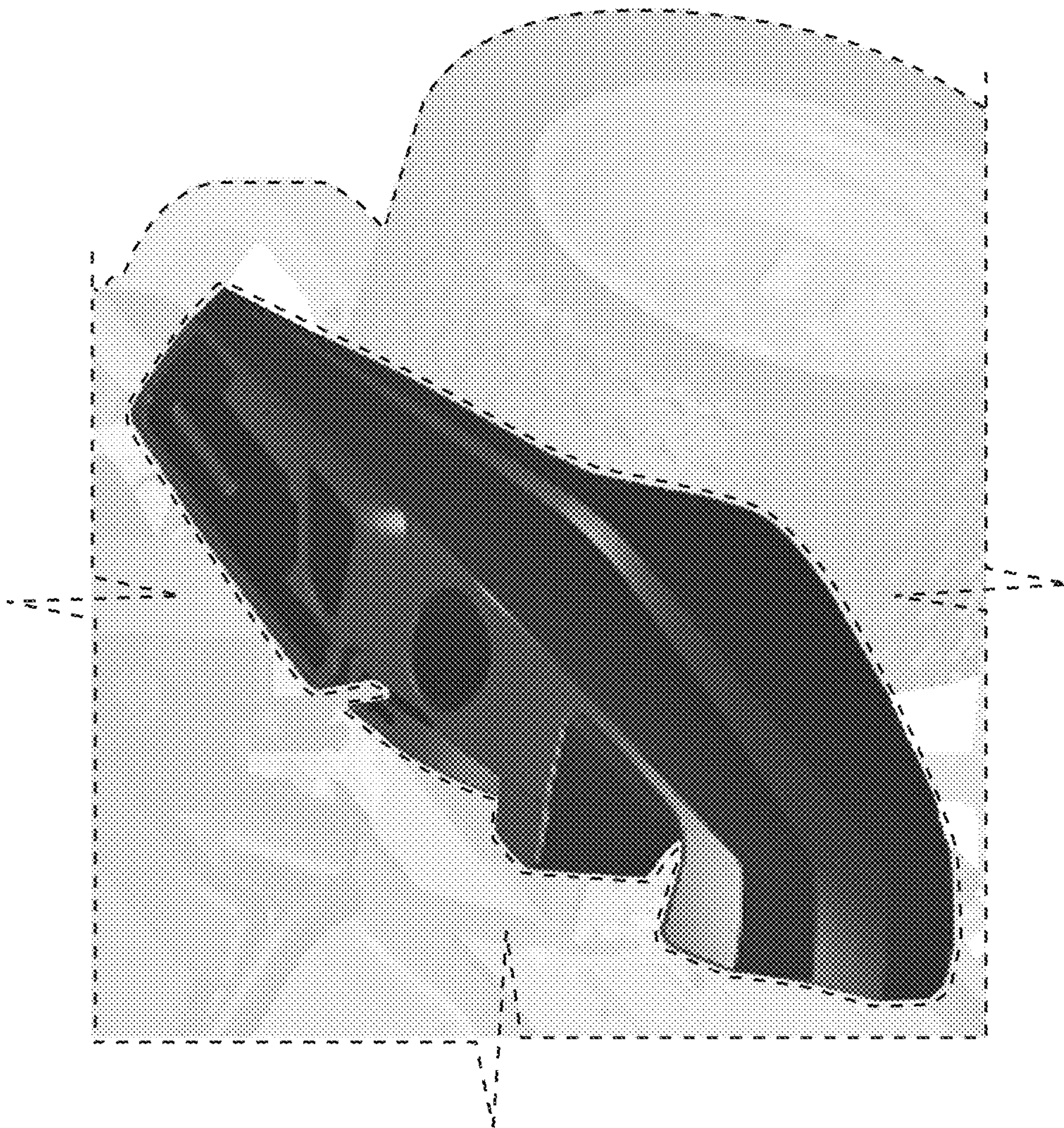

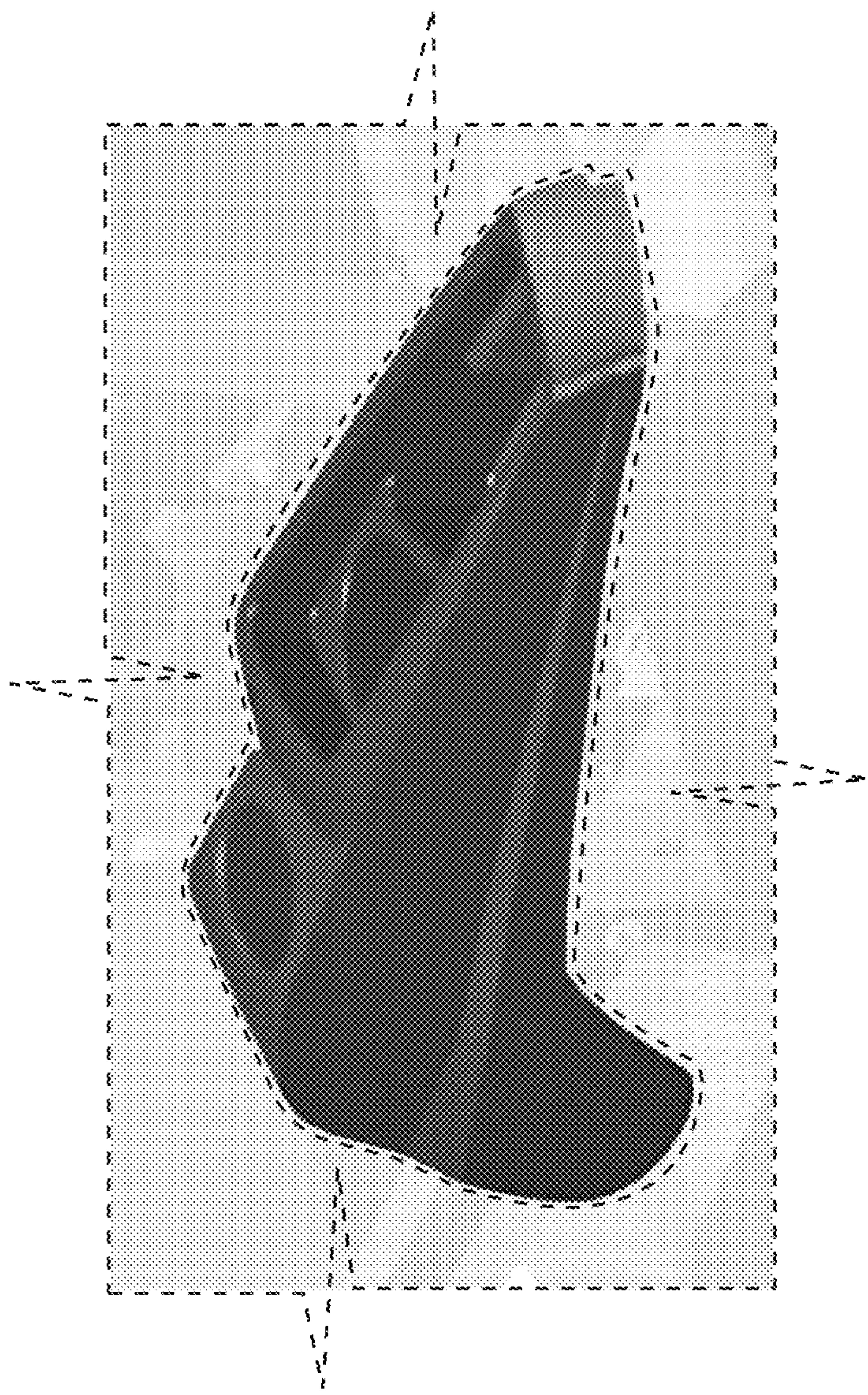
