DESCRIPTION

FIG. 1 is a top, rear perspective view of a bass drum showing my new design;

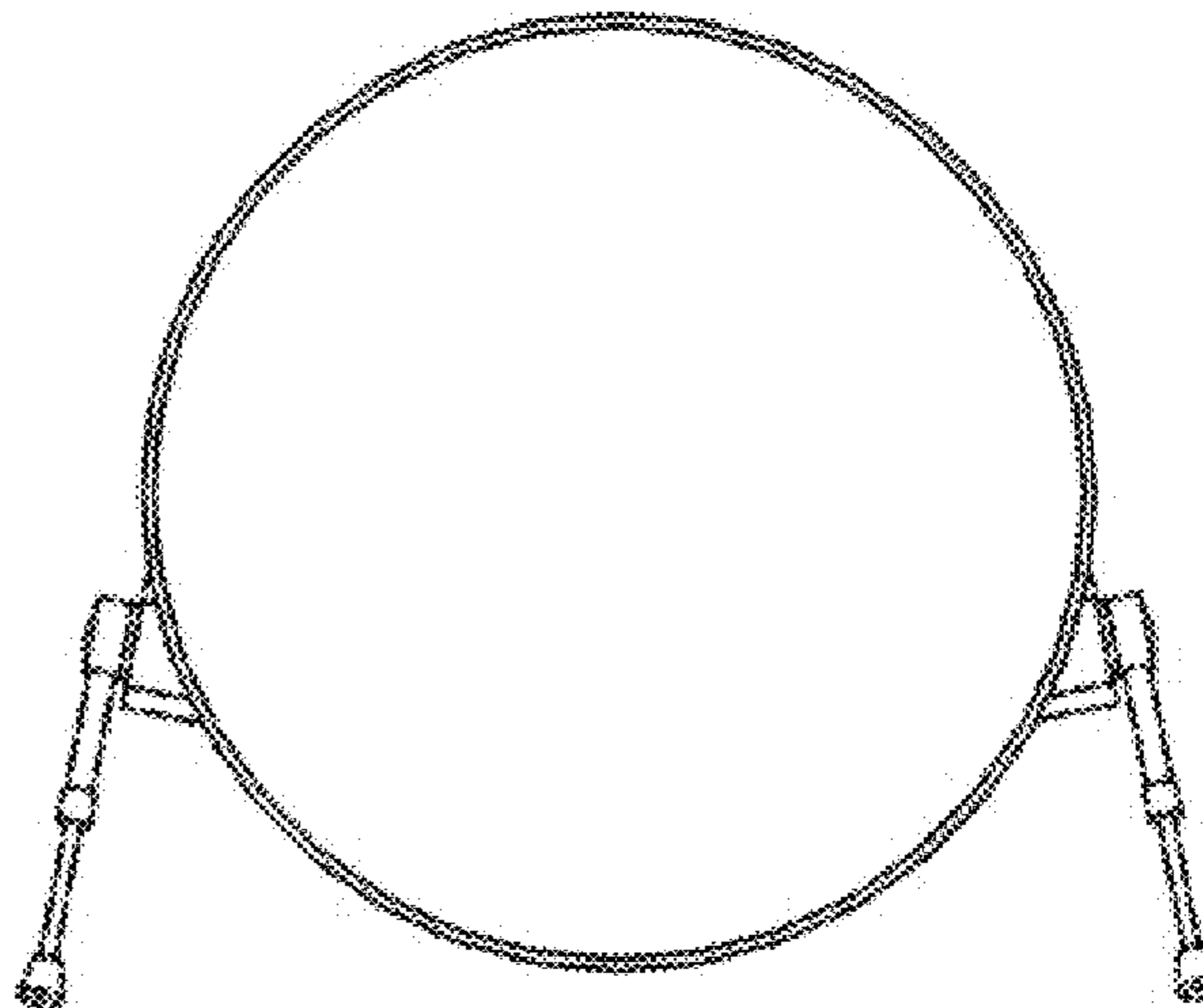
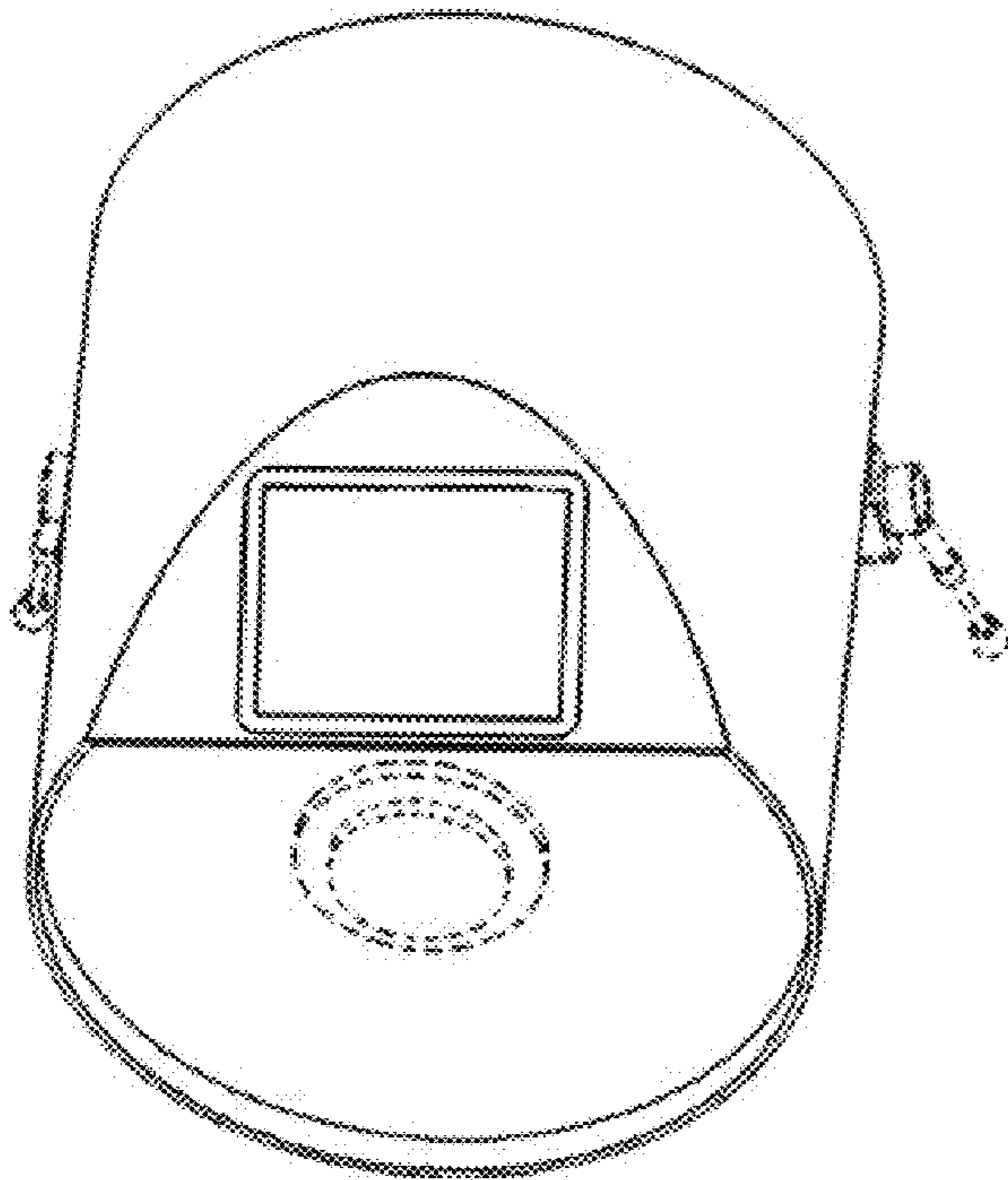

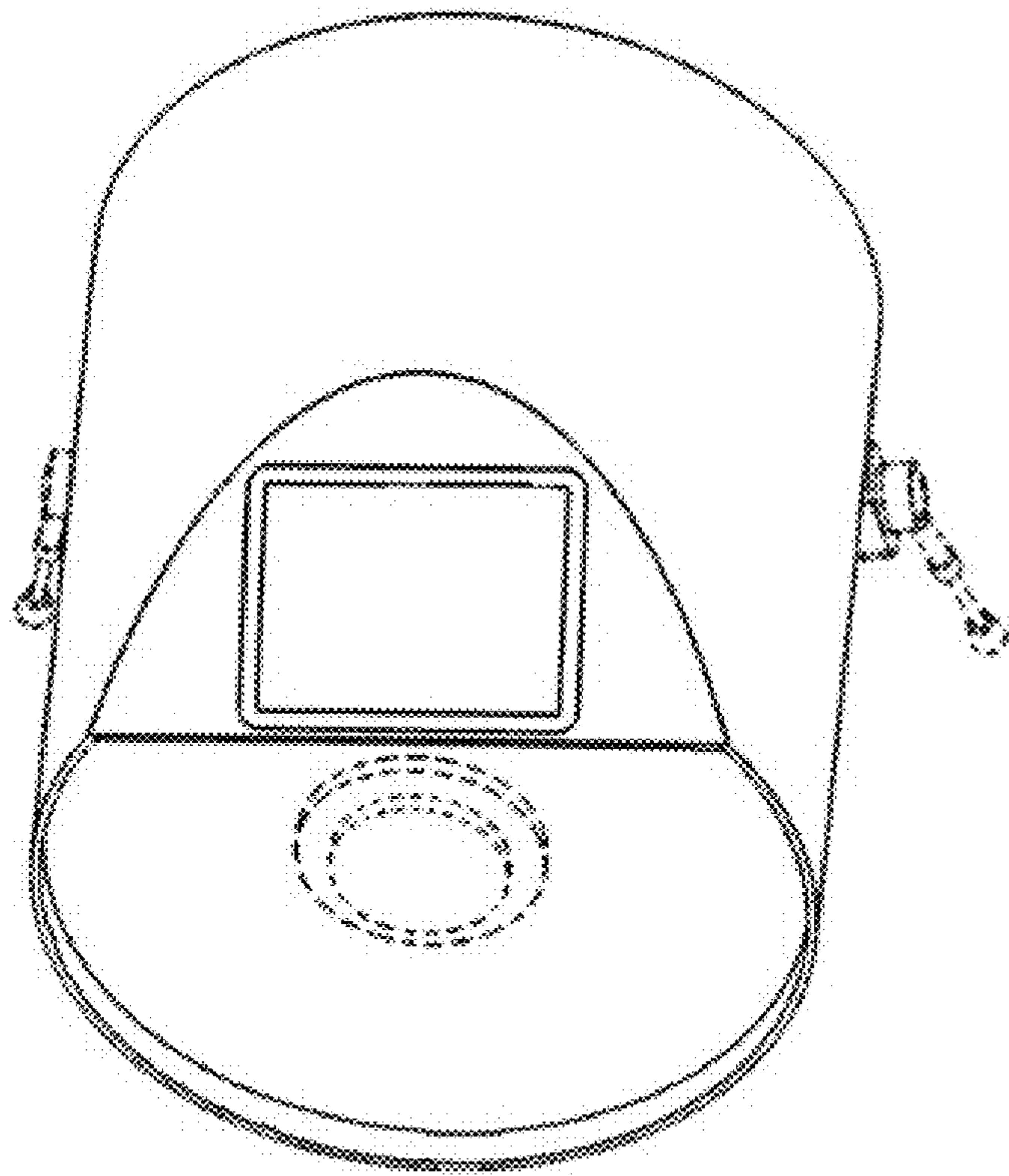

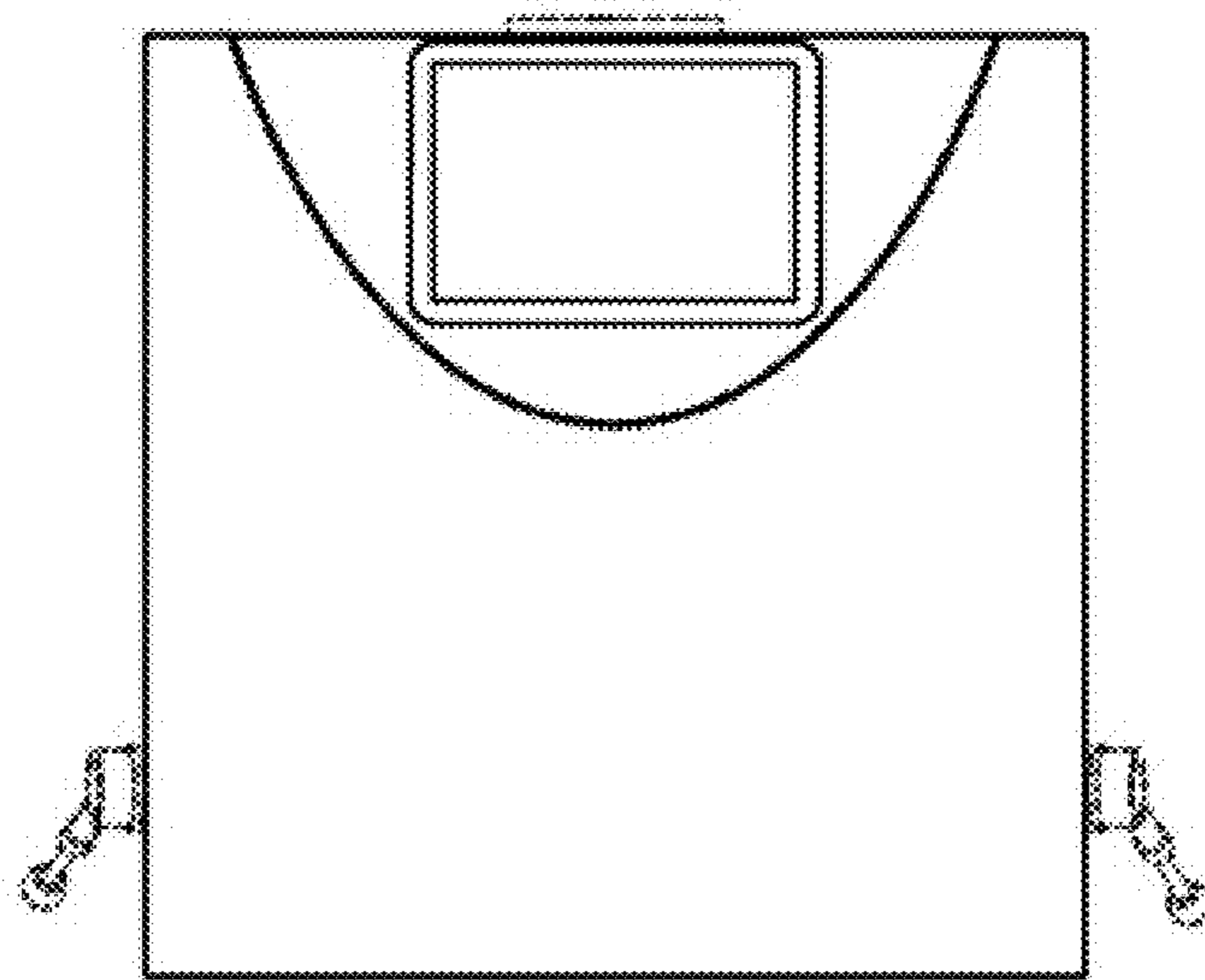

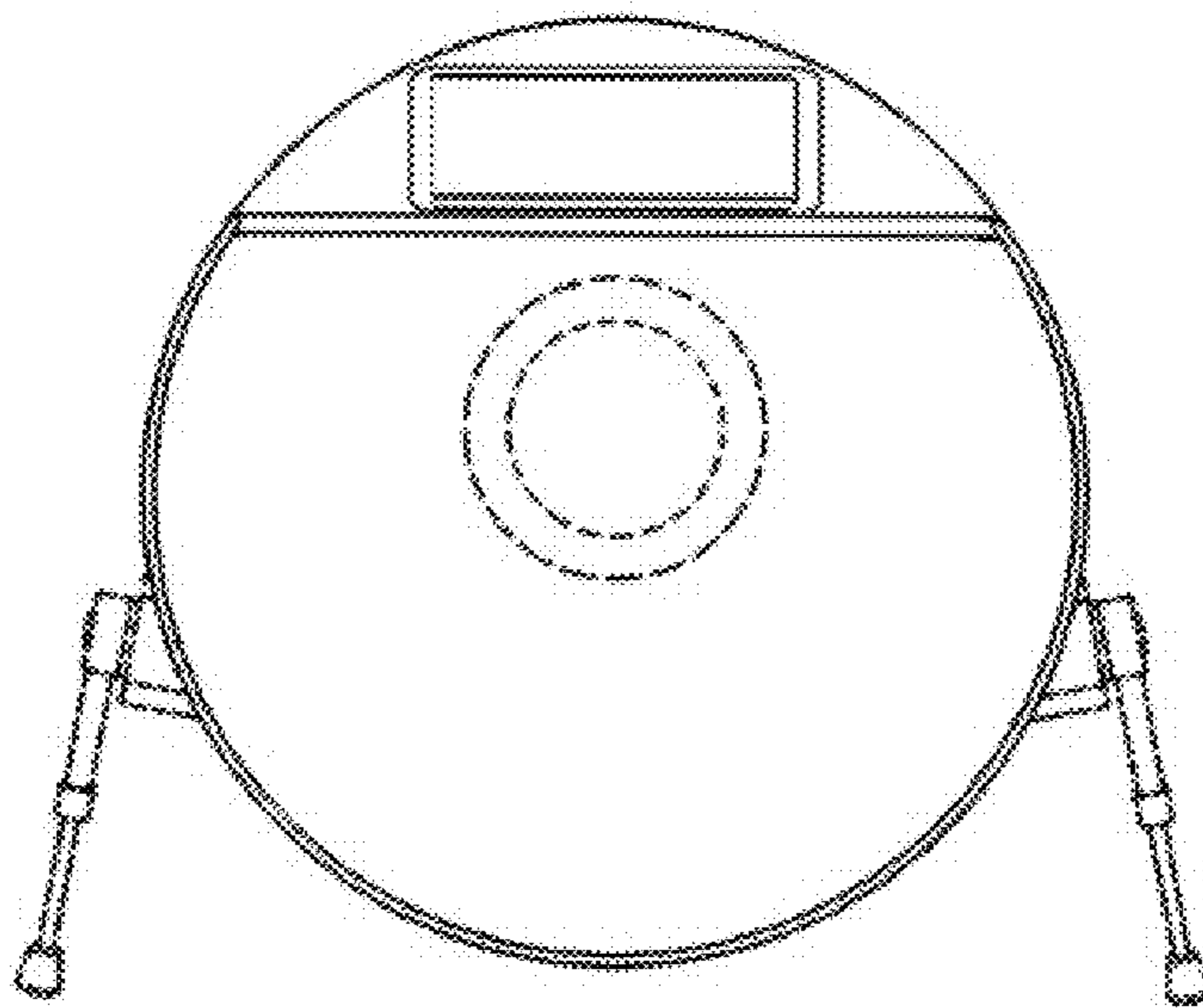

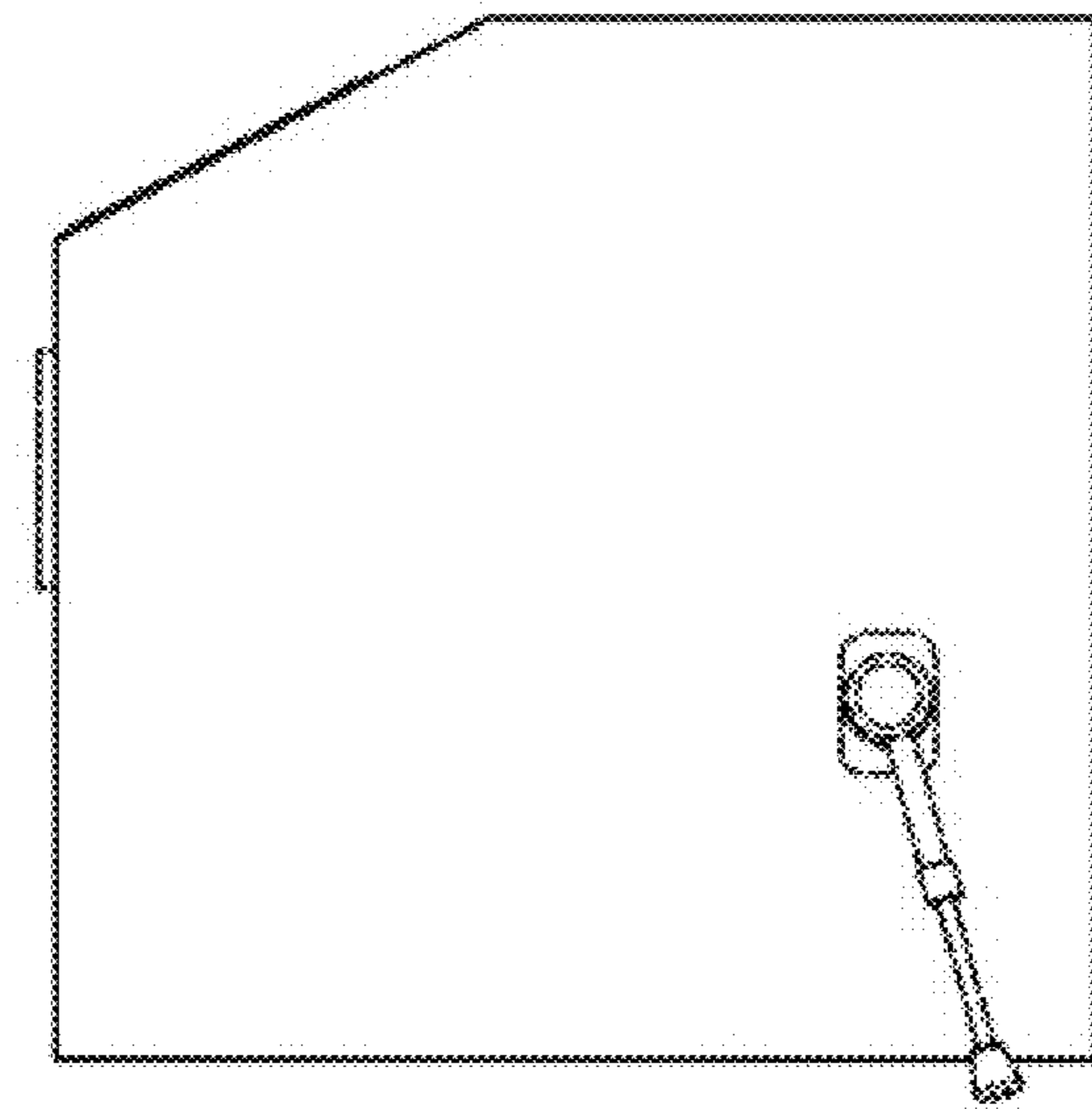

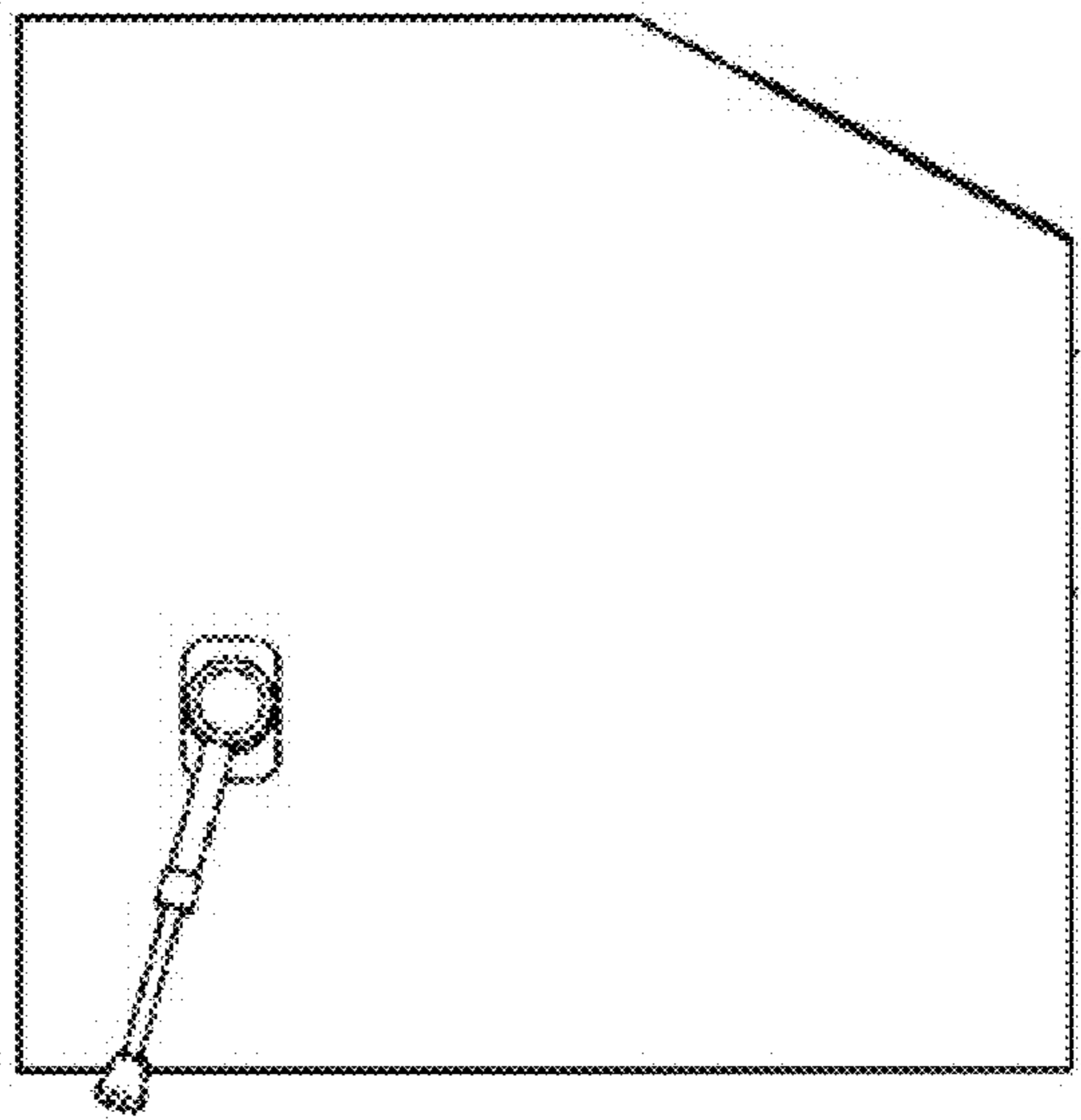

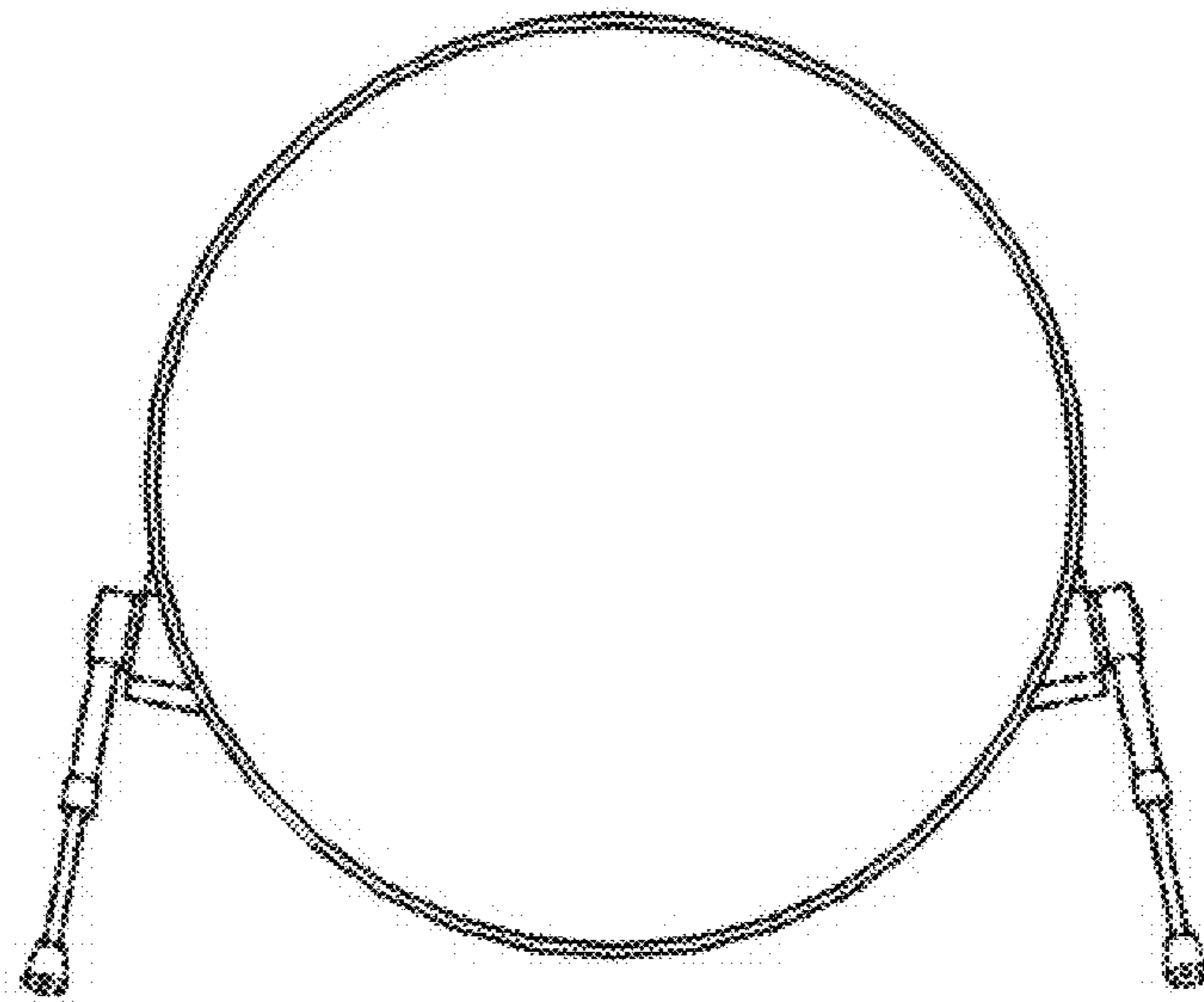
