(57) **CLAIM**

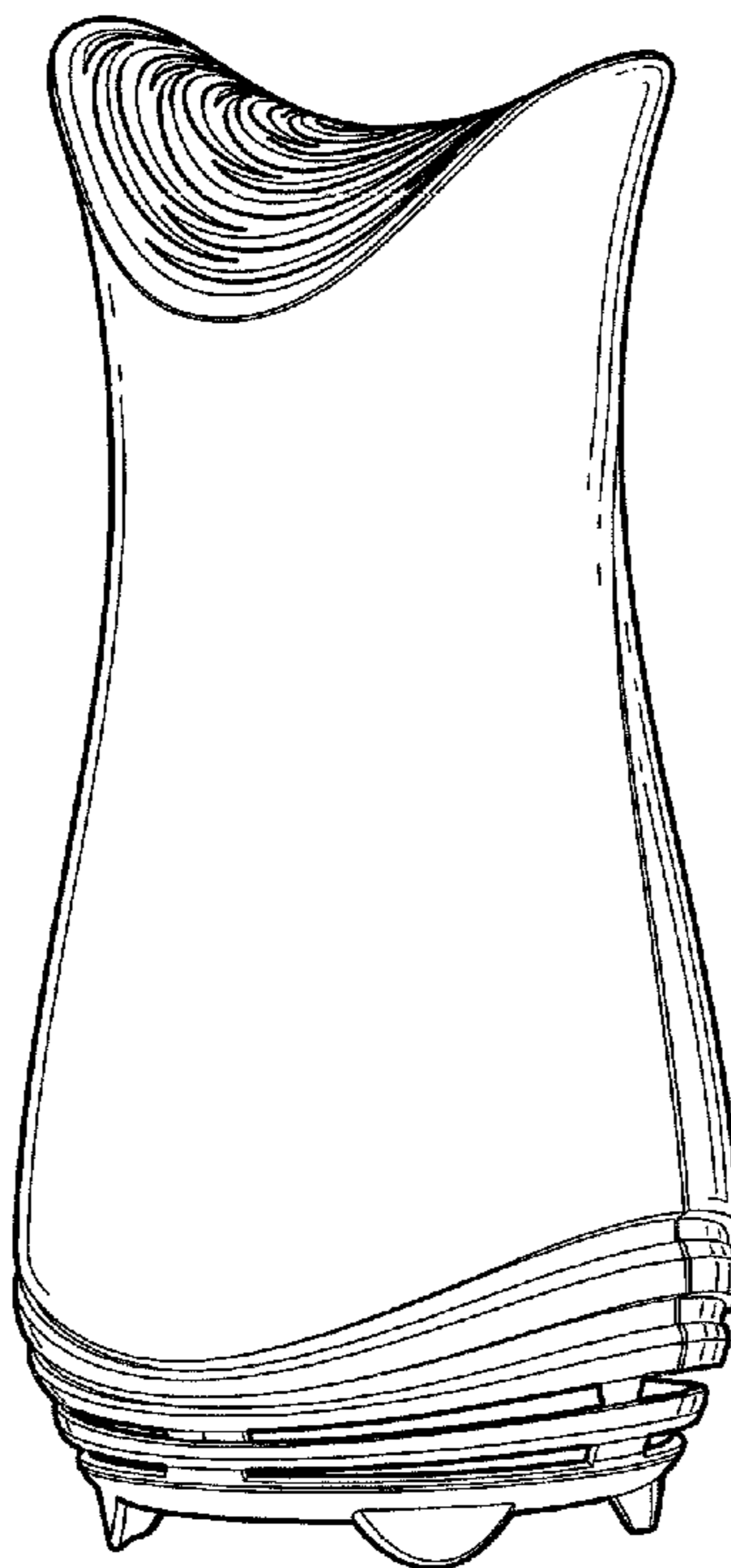
The ornamental design for an air freshener, as shown and described.

DESCRIPTION

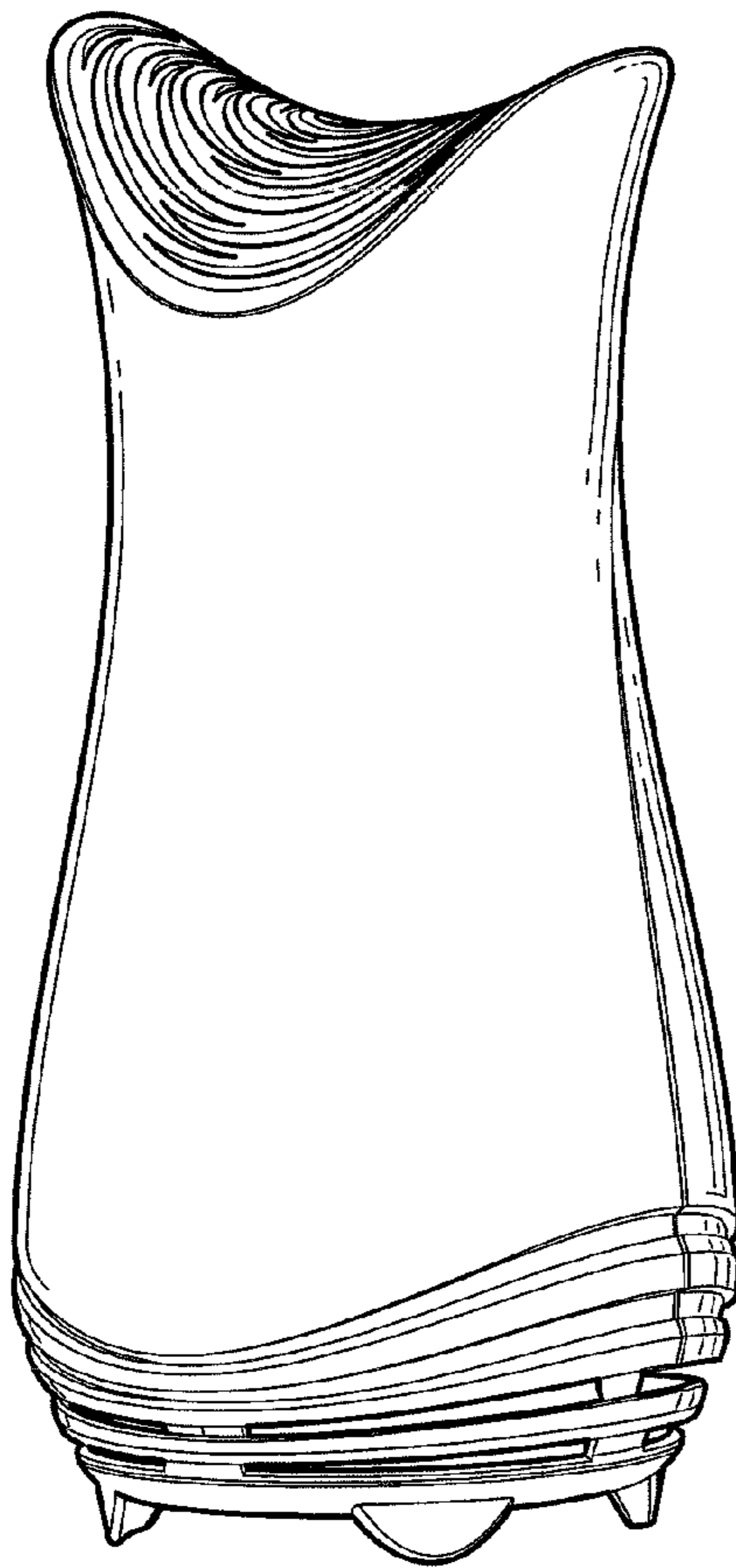

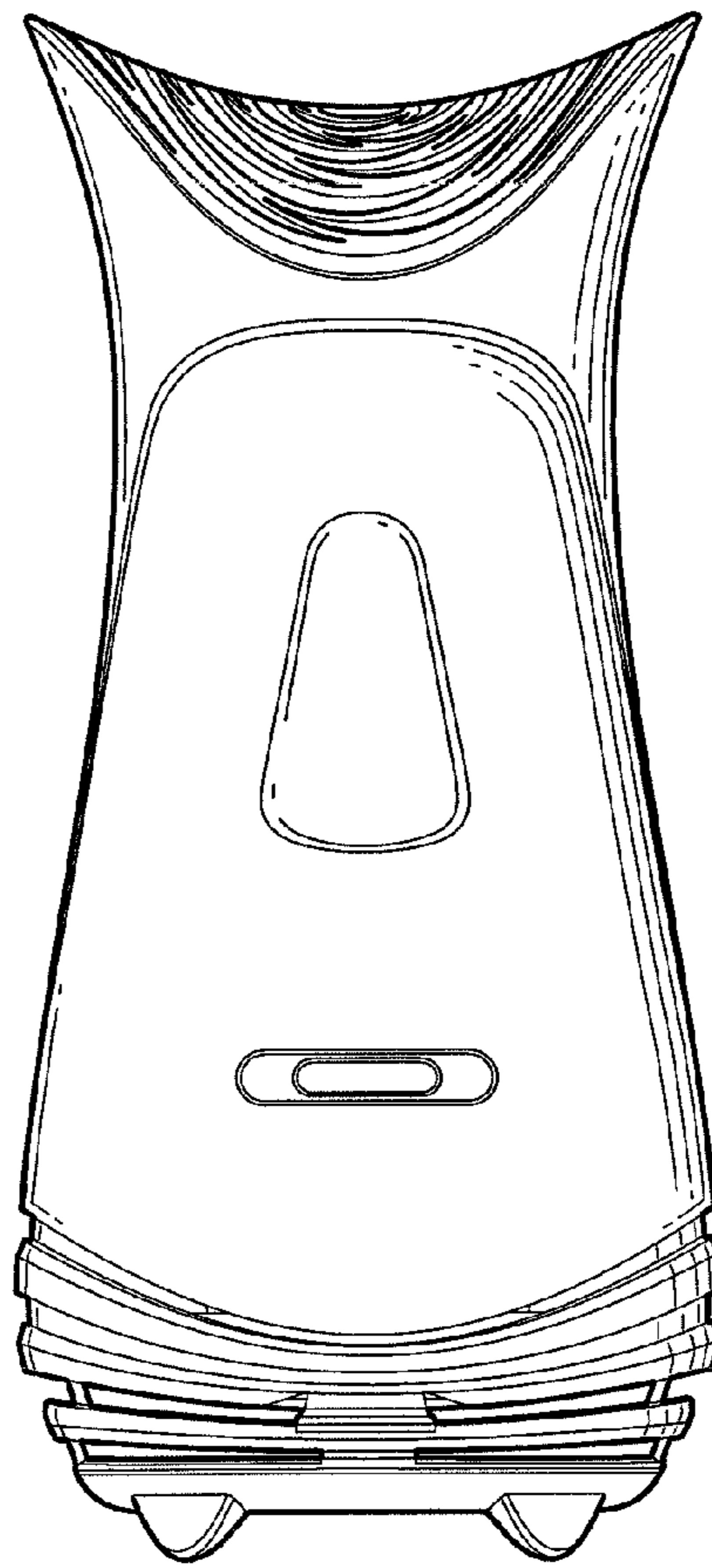

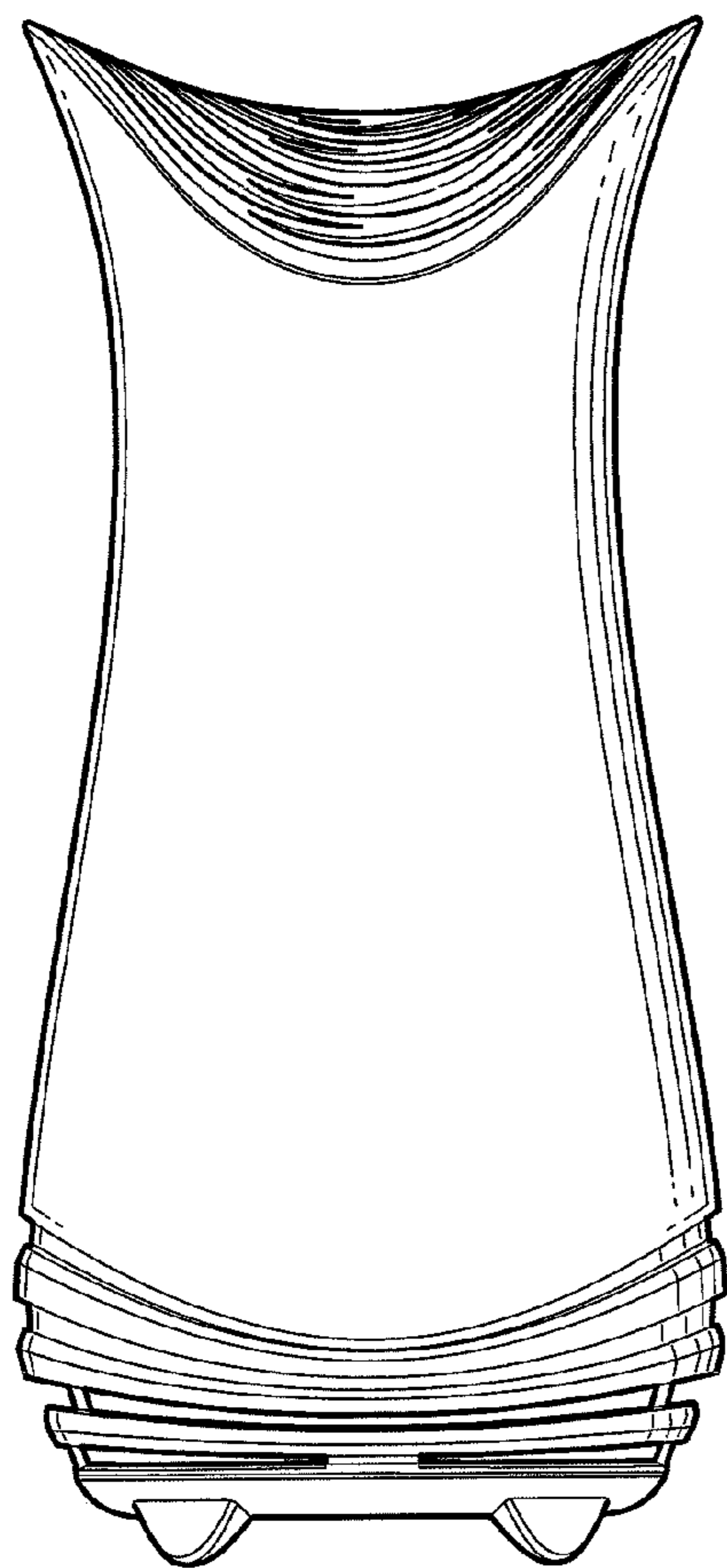

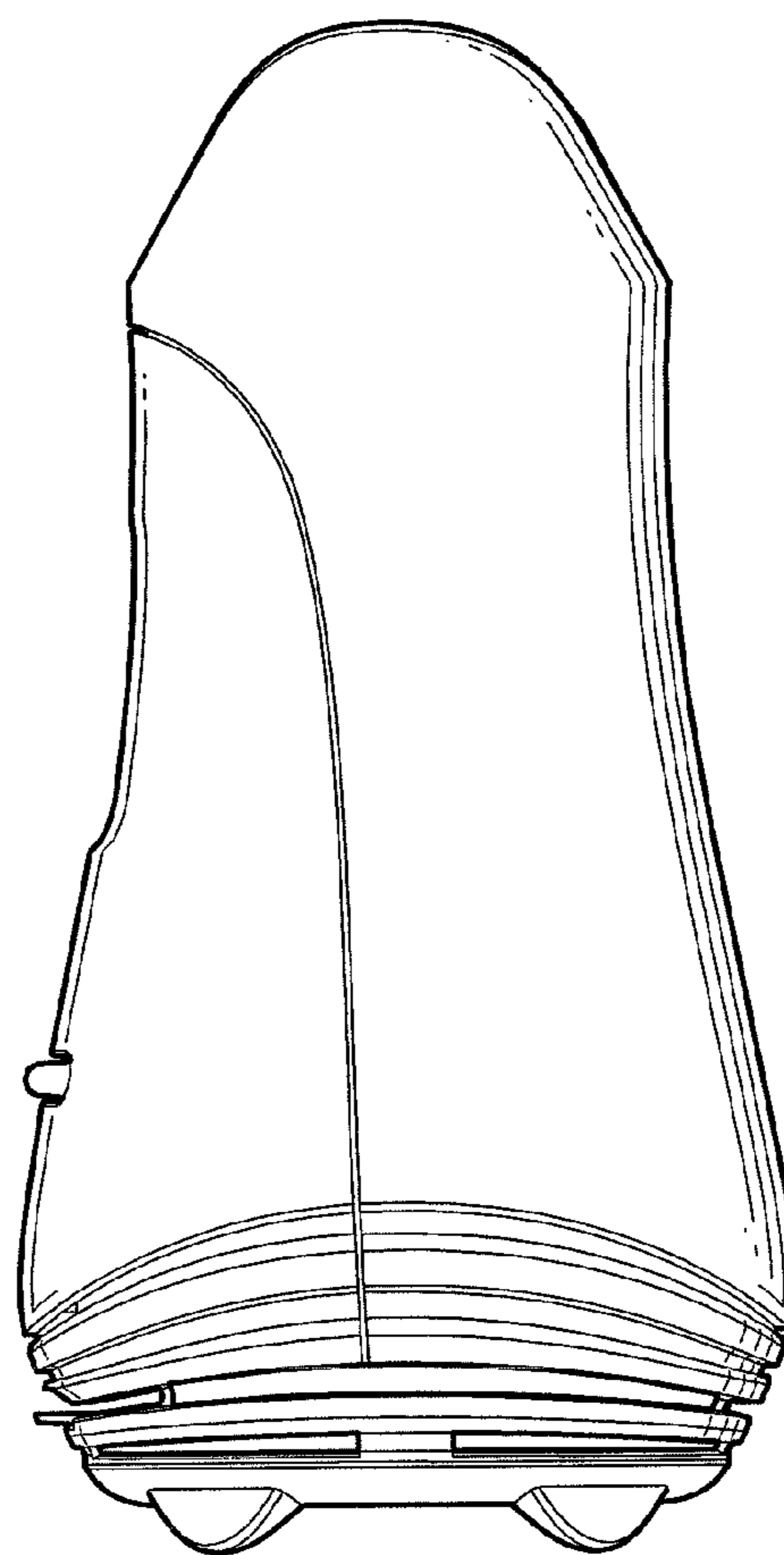

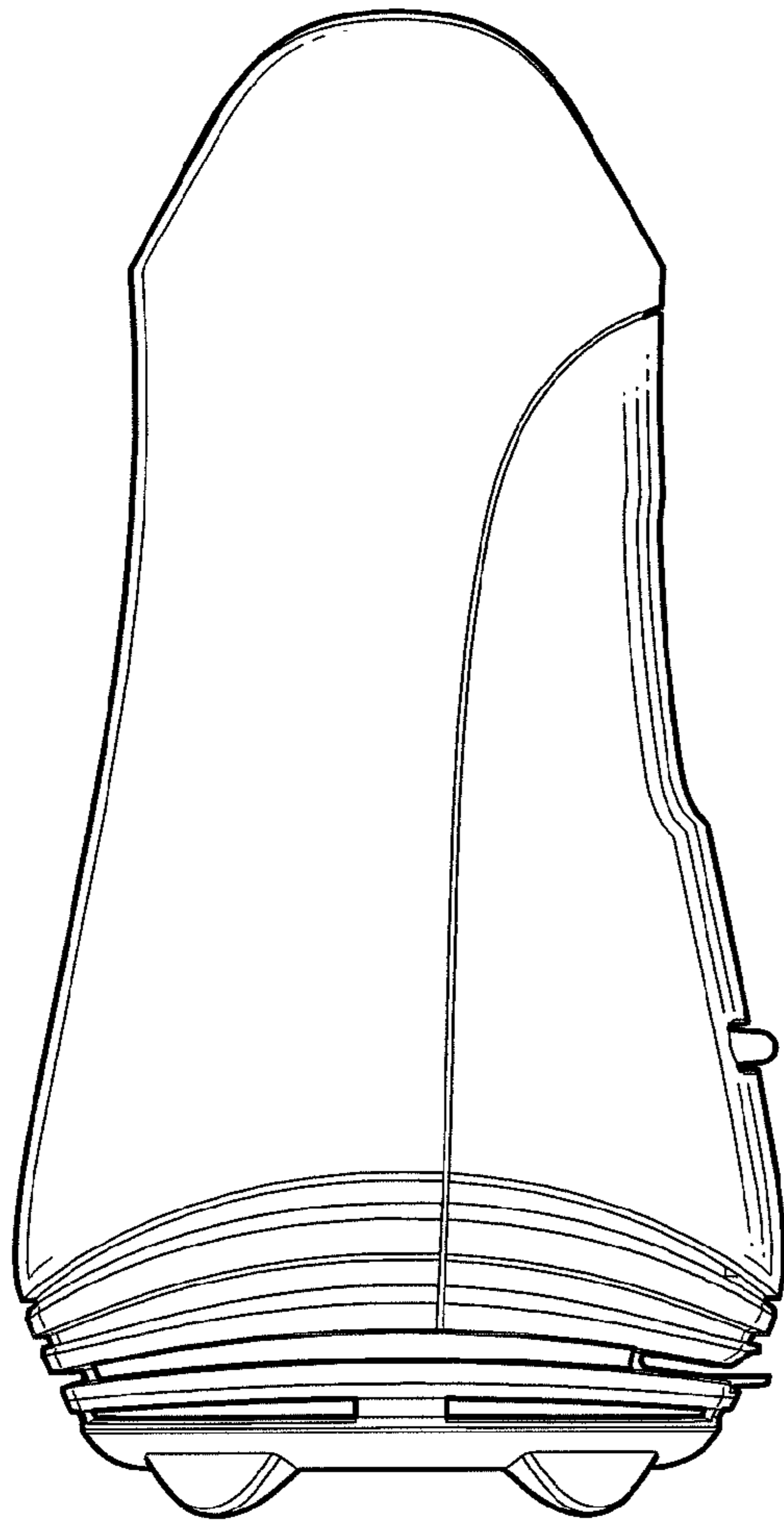

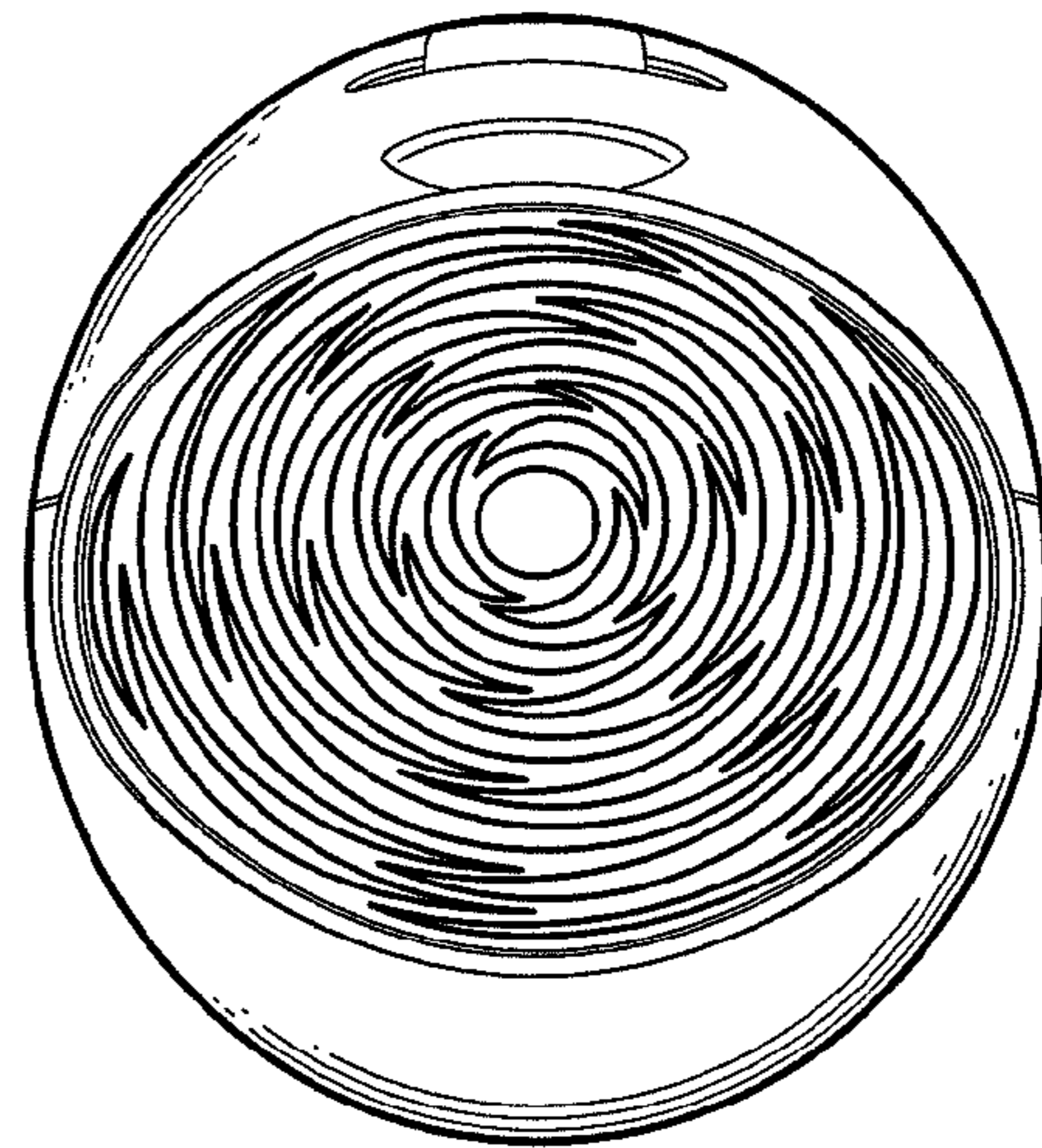

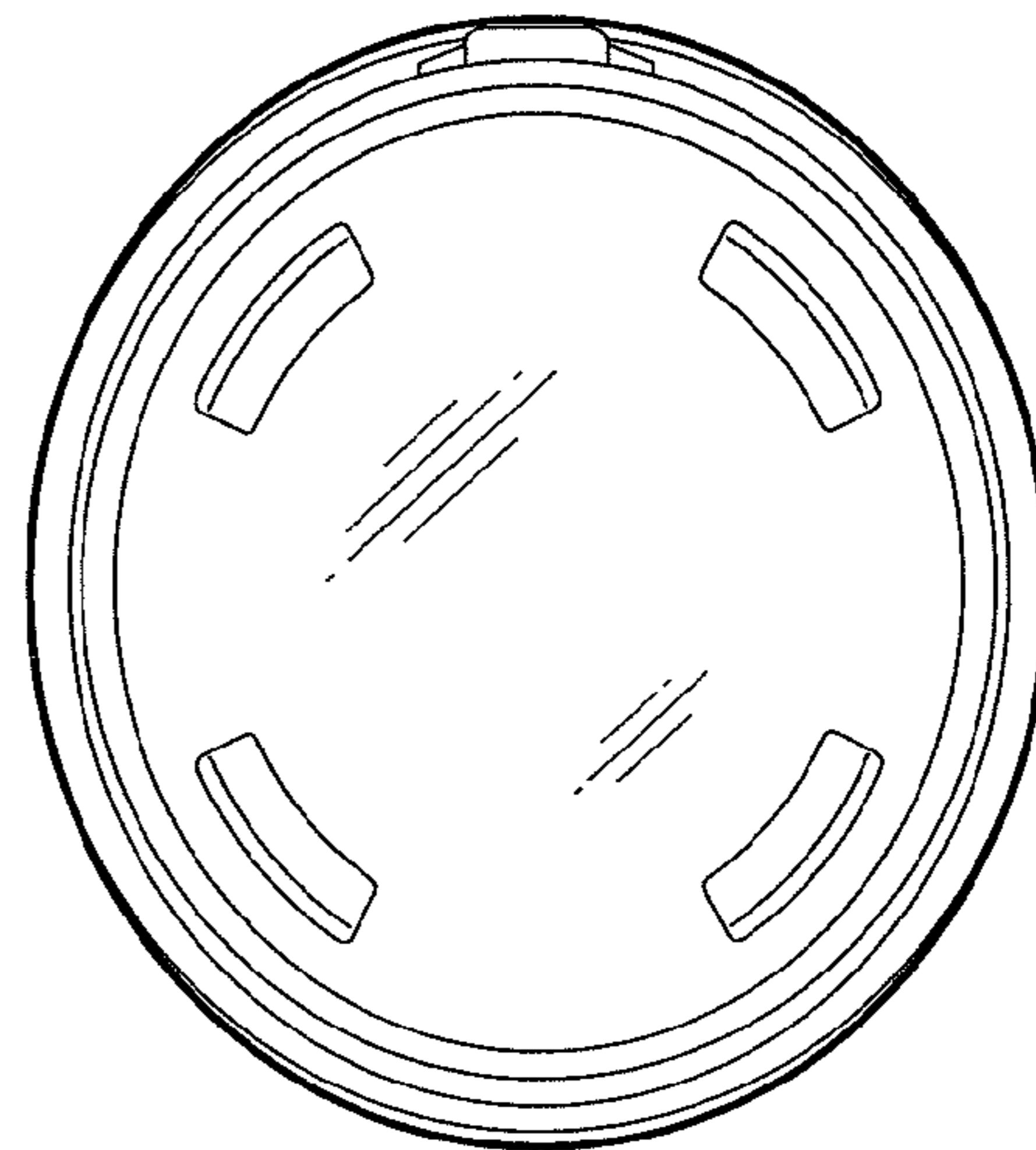
