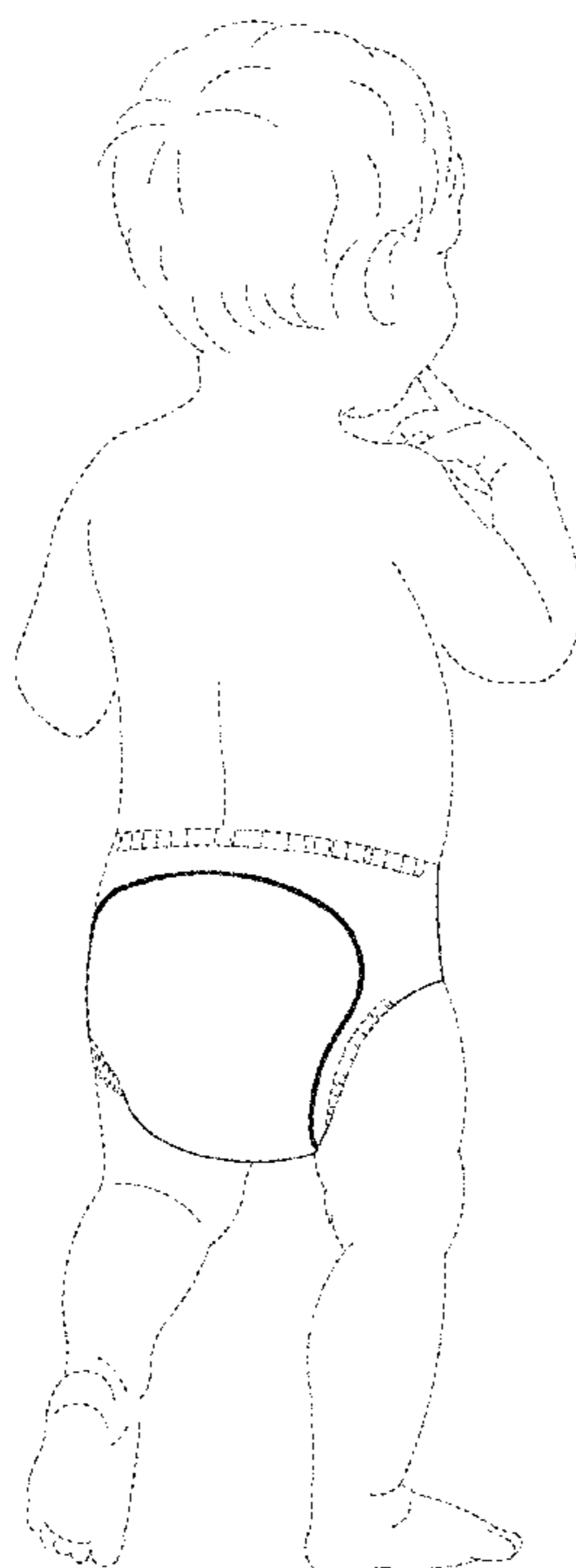
**CLAIM**

The ornamental design for an absorbent article, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an absorbent article;  
FIG. 2 is a front view of the absorbent article of FIG. 1;  
FIG. 3 is a left side view of the absorbent article of FIG. 1, the right side being a mirror image;  
FIG. 4 is a rear view of the absorbent article of FIG. 1;  
FIG. 5 is a top view of the absorbent article of FIG. 1; and,  
FIG. 6 is a bottom view of the absorbent article of FIG. 1.

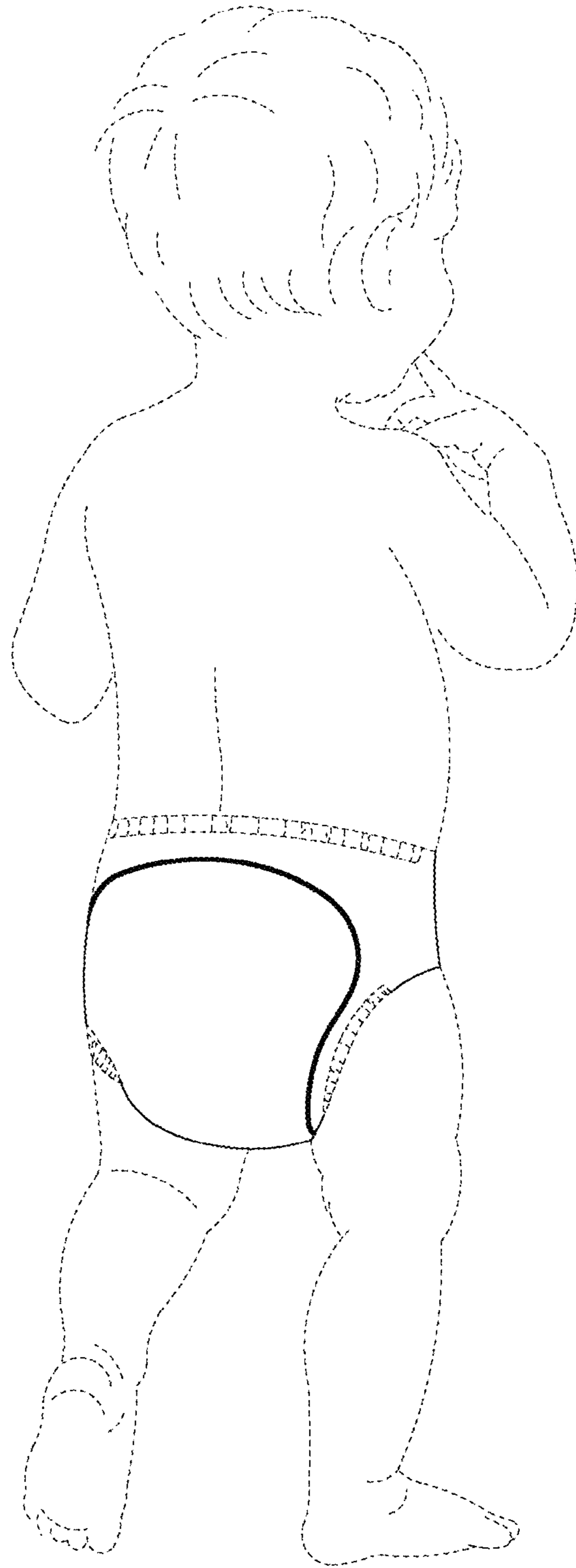

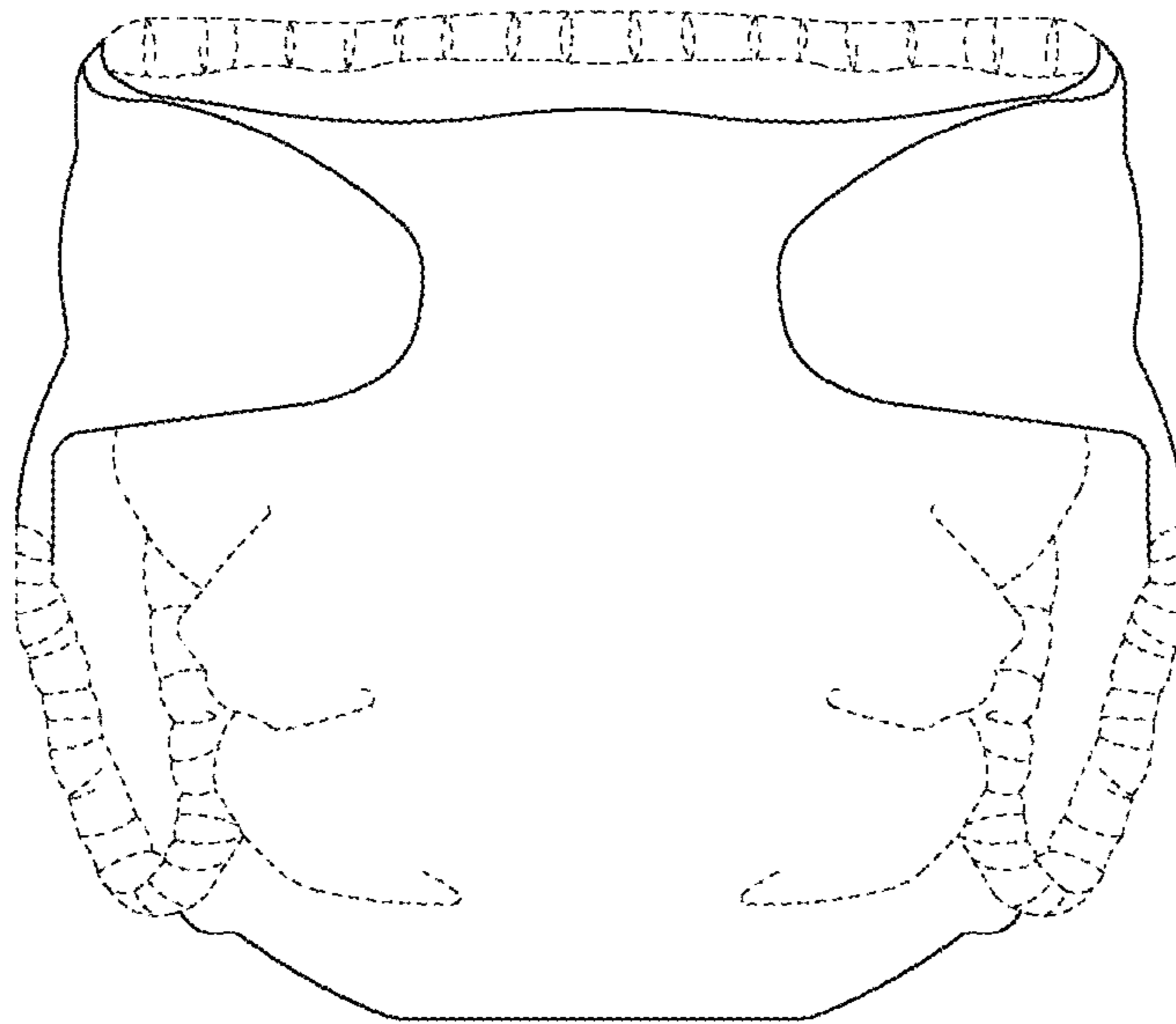

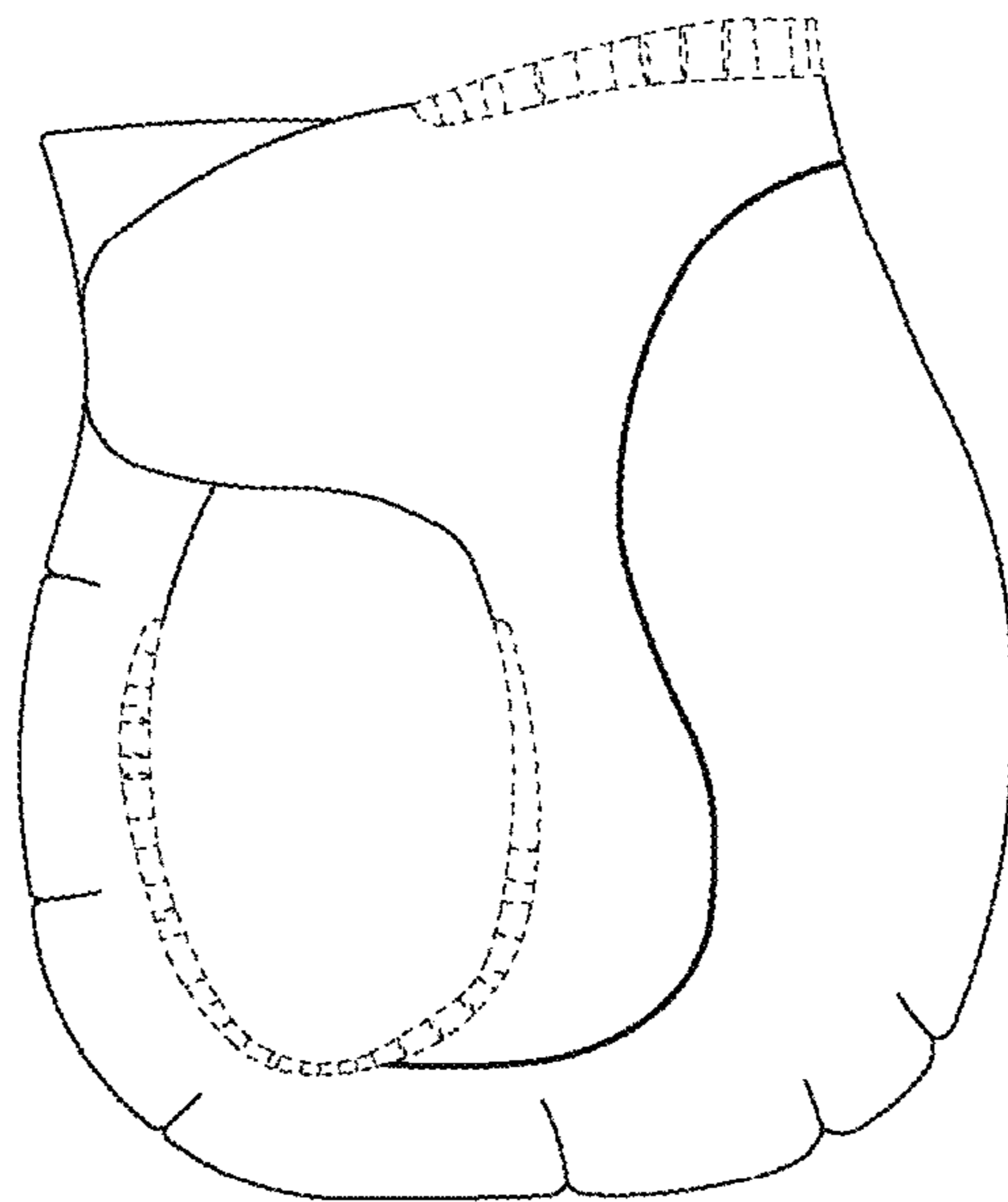

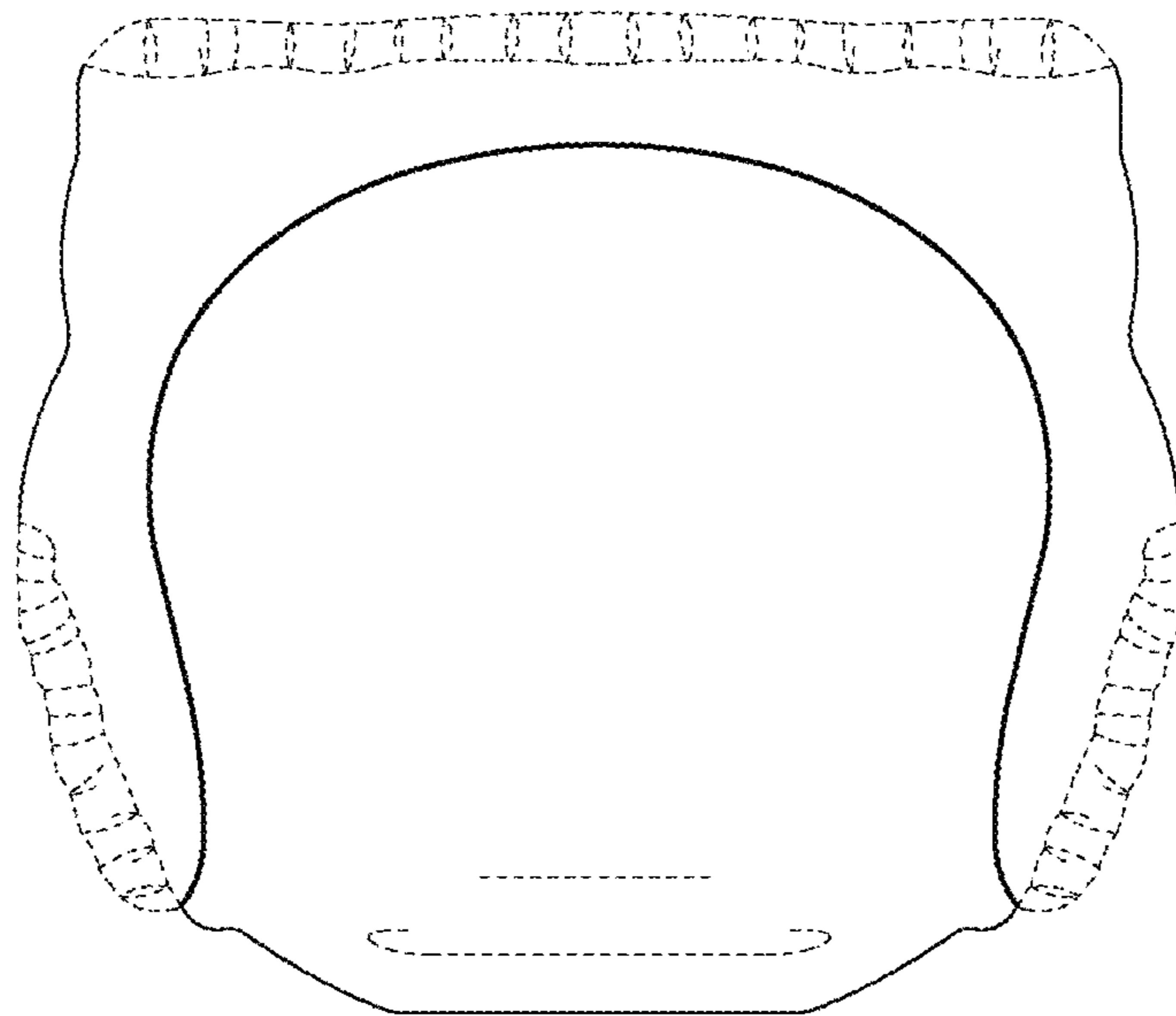

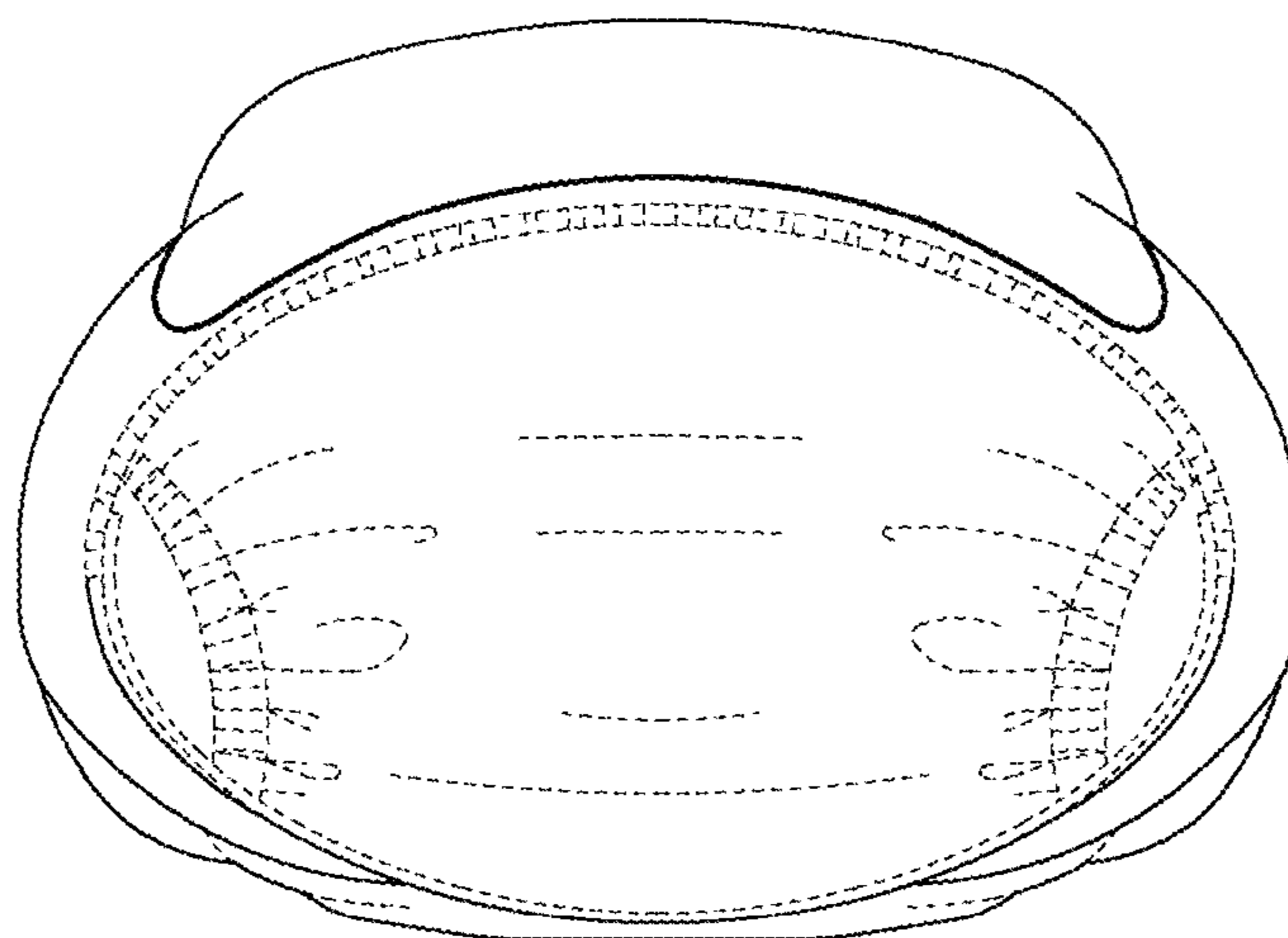

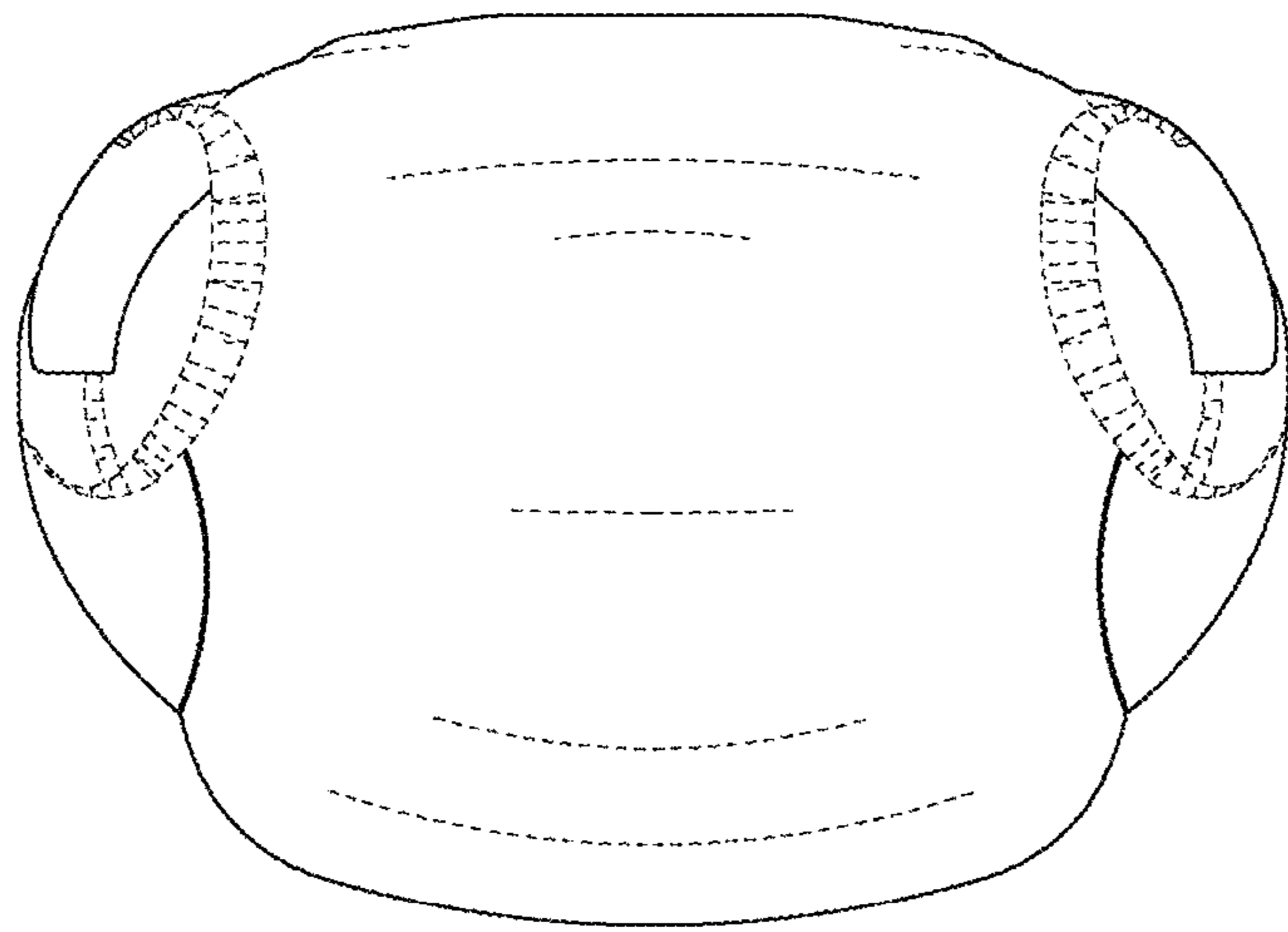
