The ornamental design for a building siding, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of building siding showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a back view thereof;

FIG. 4 is a right side view thereof;

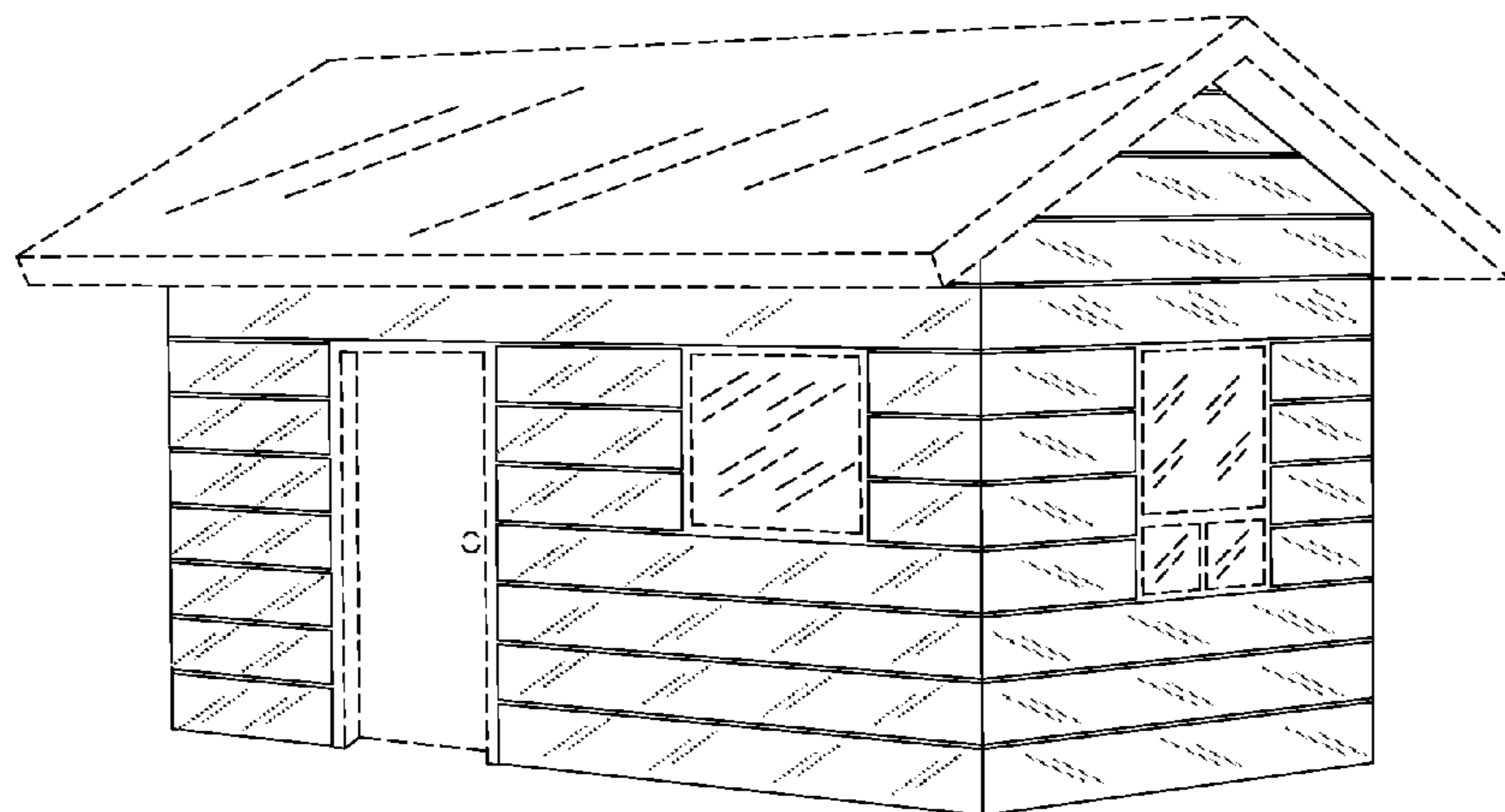
FIG. 5 is a left side view thereof; and,

FIG. 6 is an enlarged partial view of a corner of siding on a building.

The broken lines are for illustrative purposes only and form no part of the claimed design.

The design is embodied in building siding that may be constructed over conventional or prefabricated walls or building frames providing siding and even the appearance of gorgeous wide panel siding.

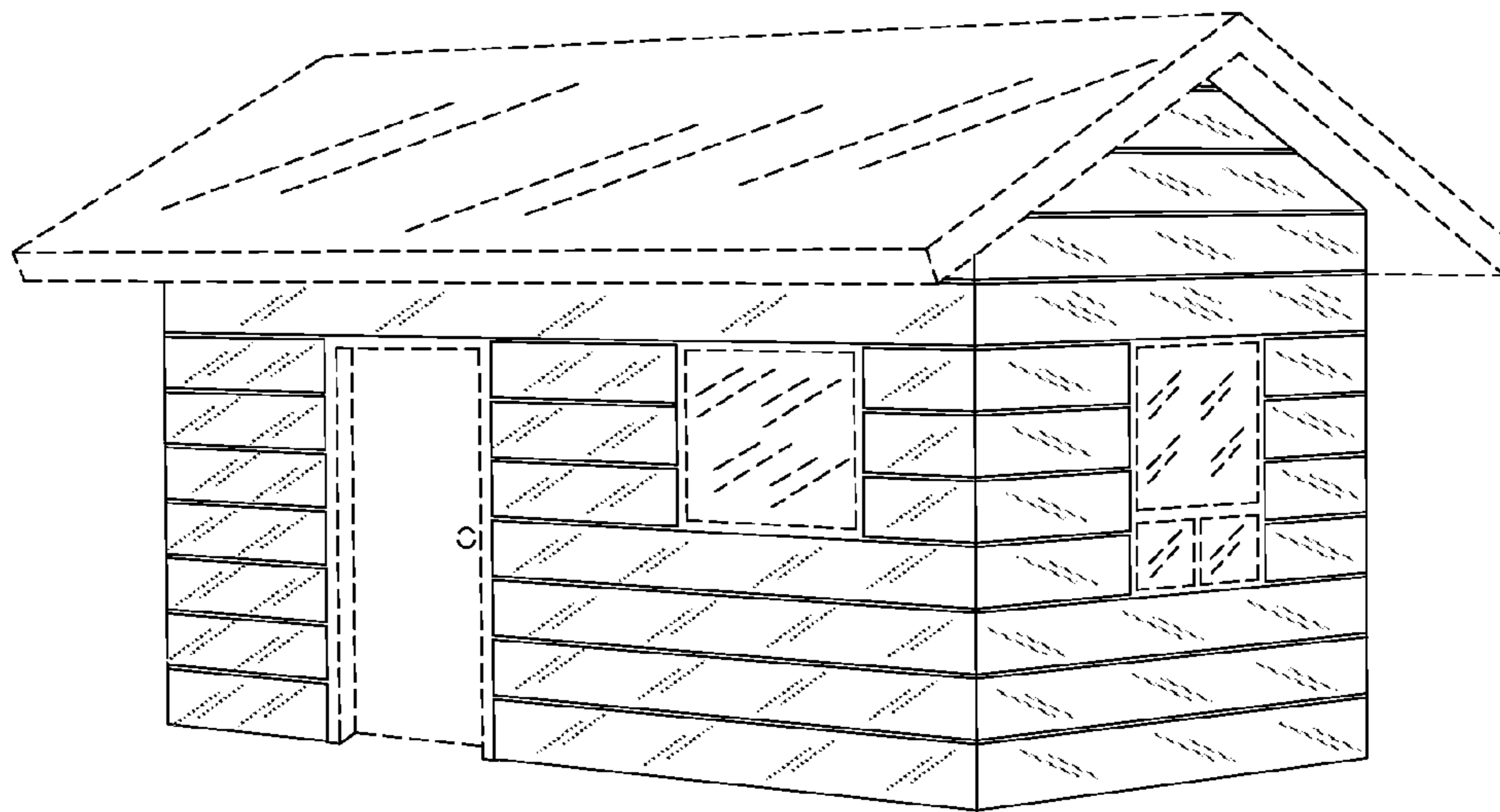

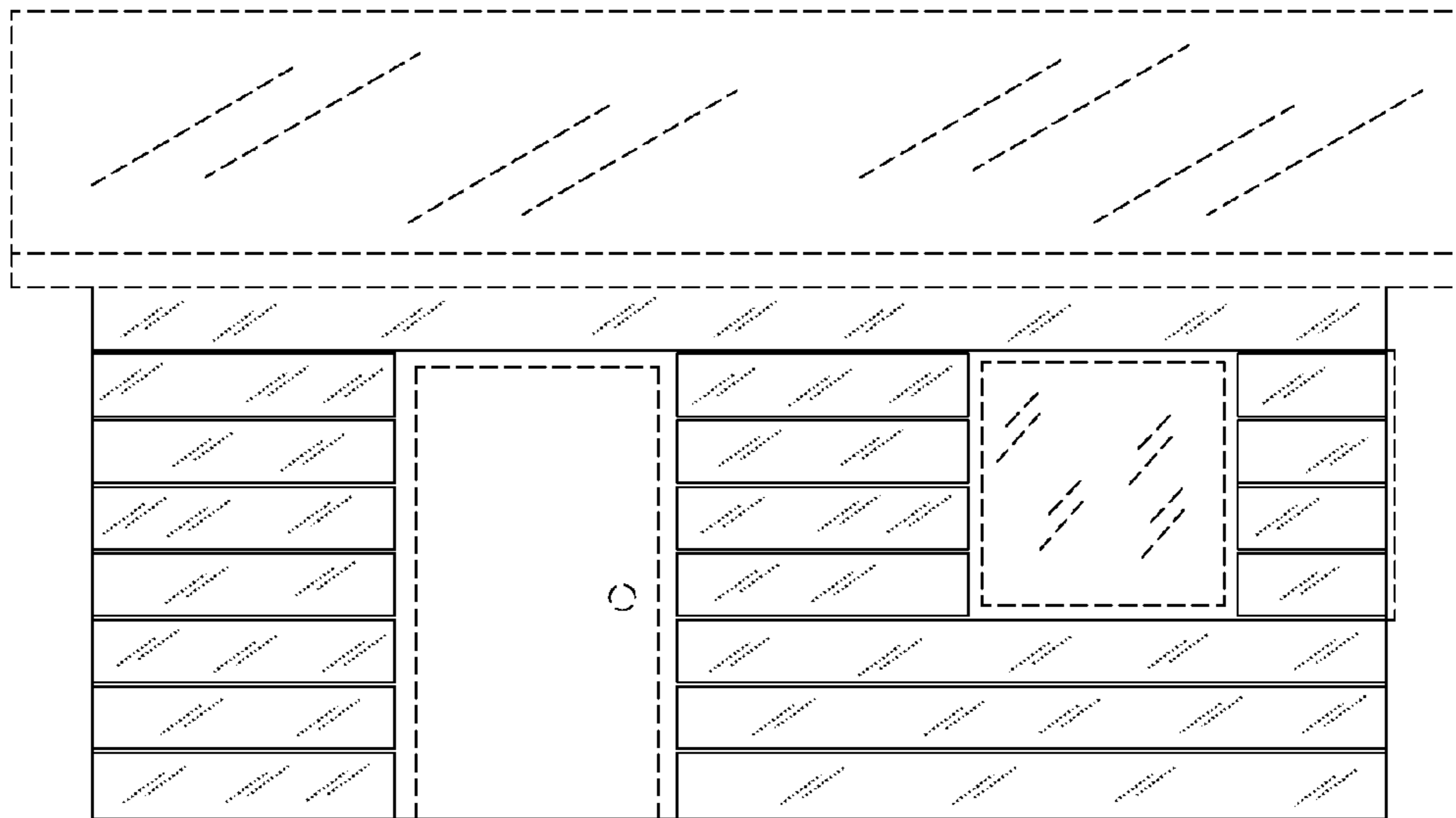

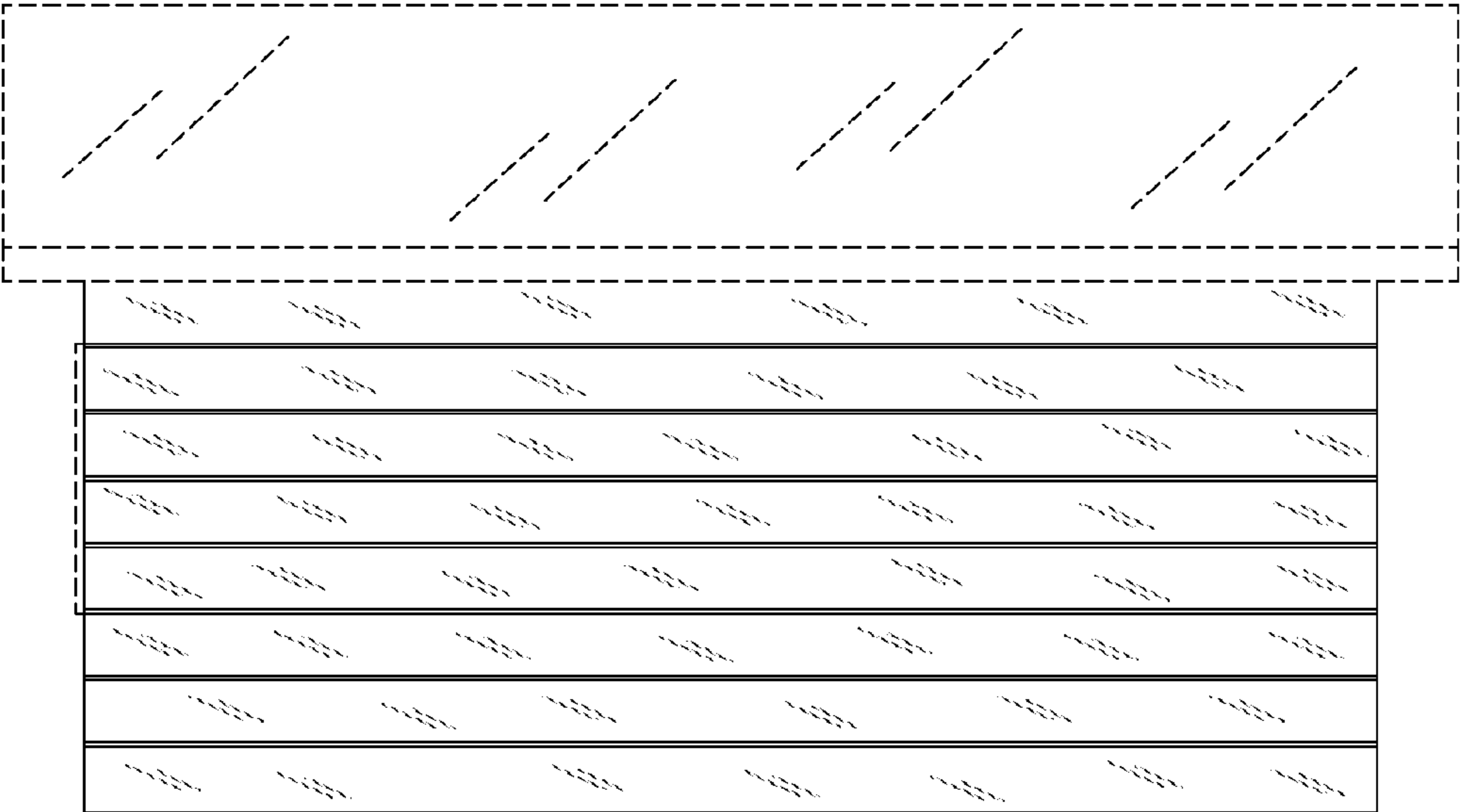

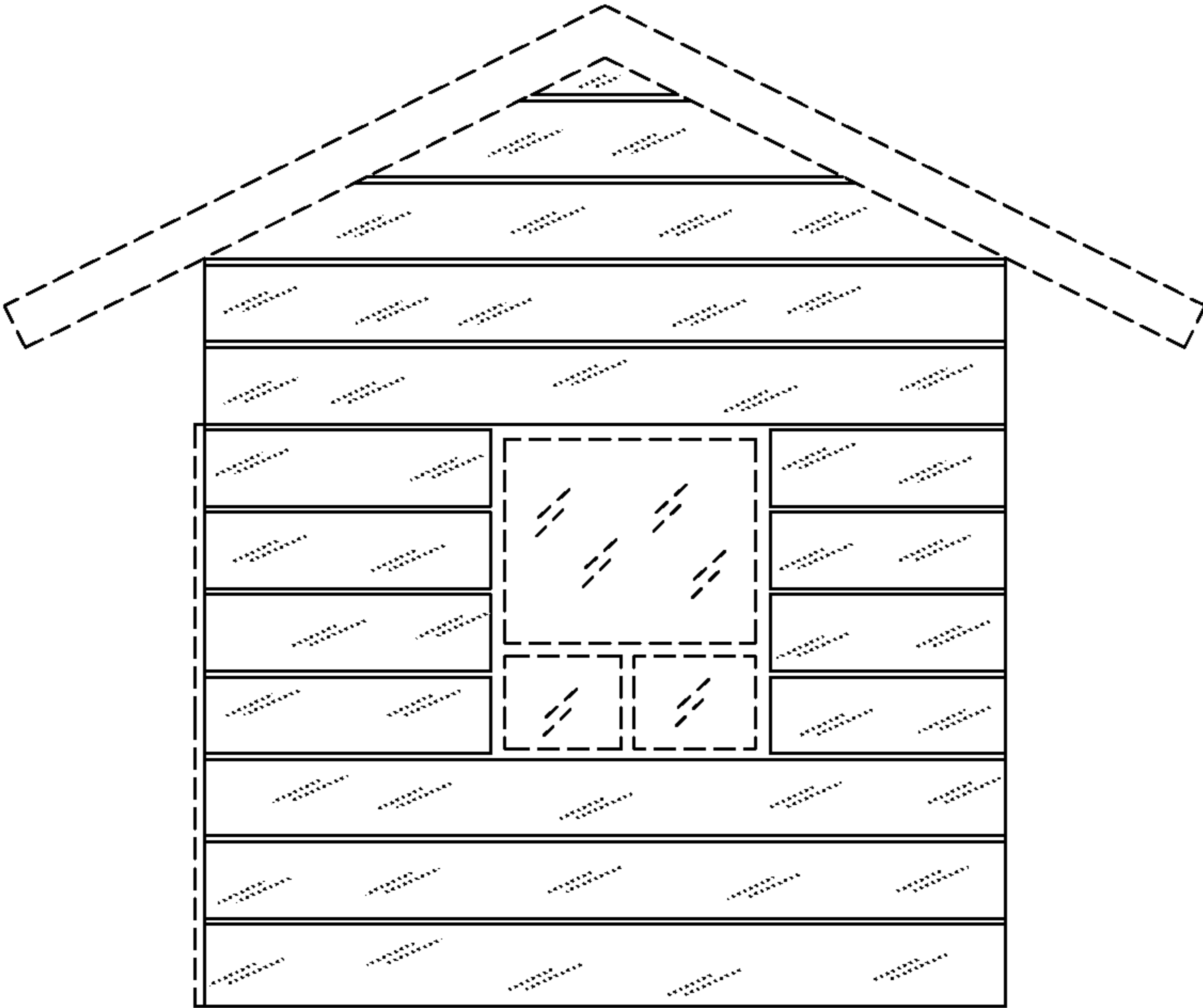

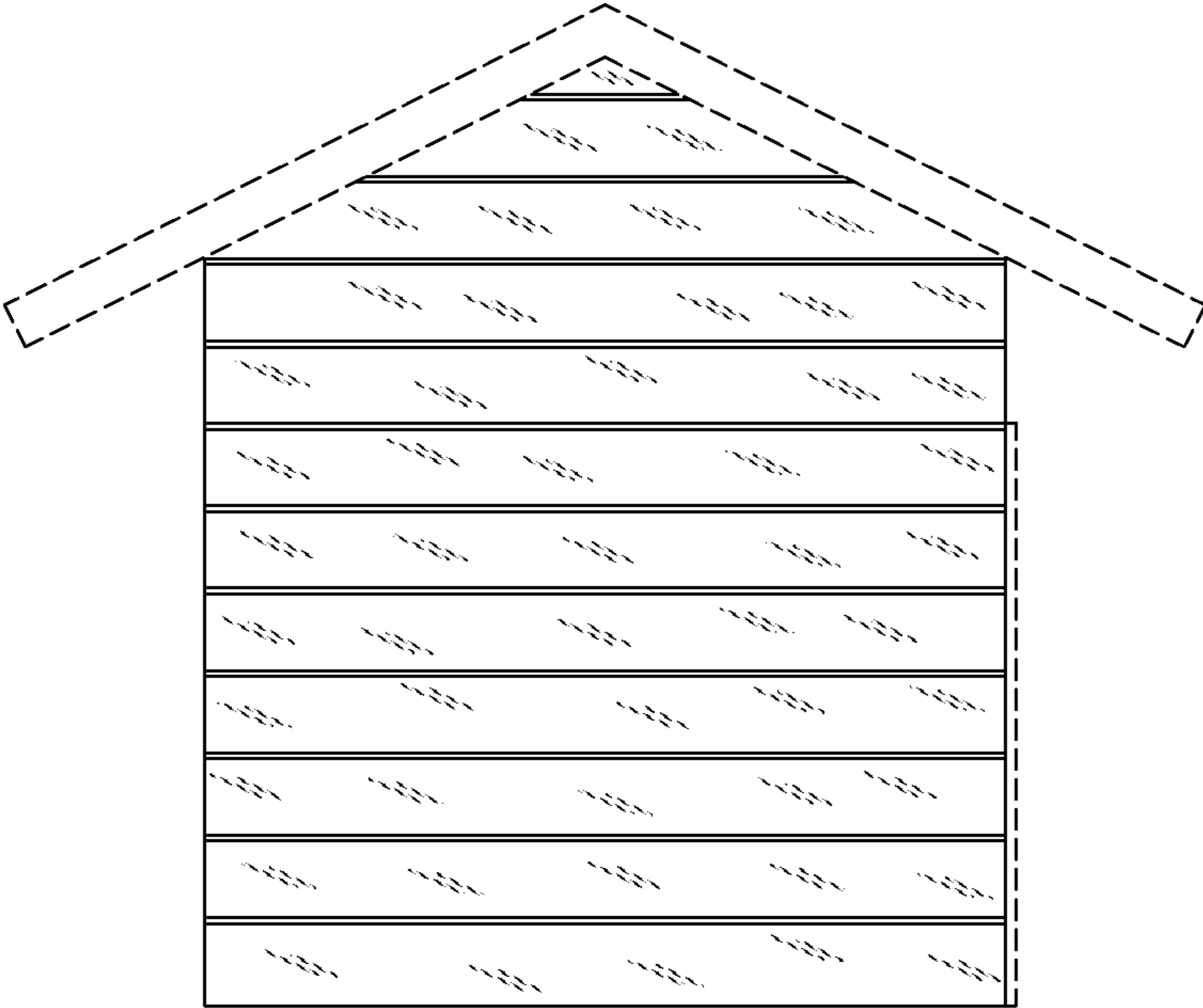

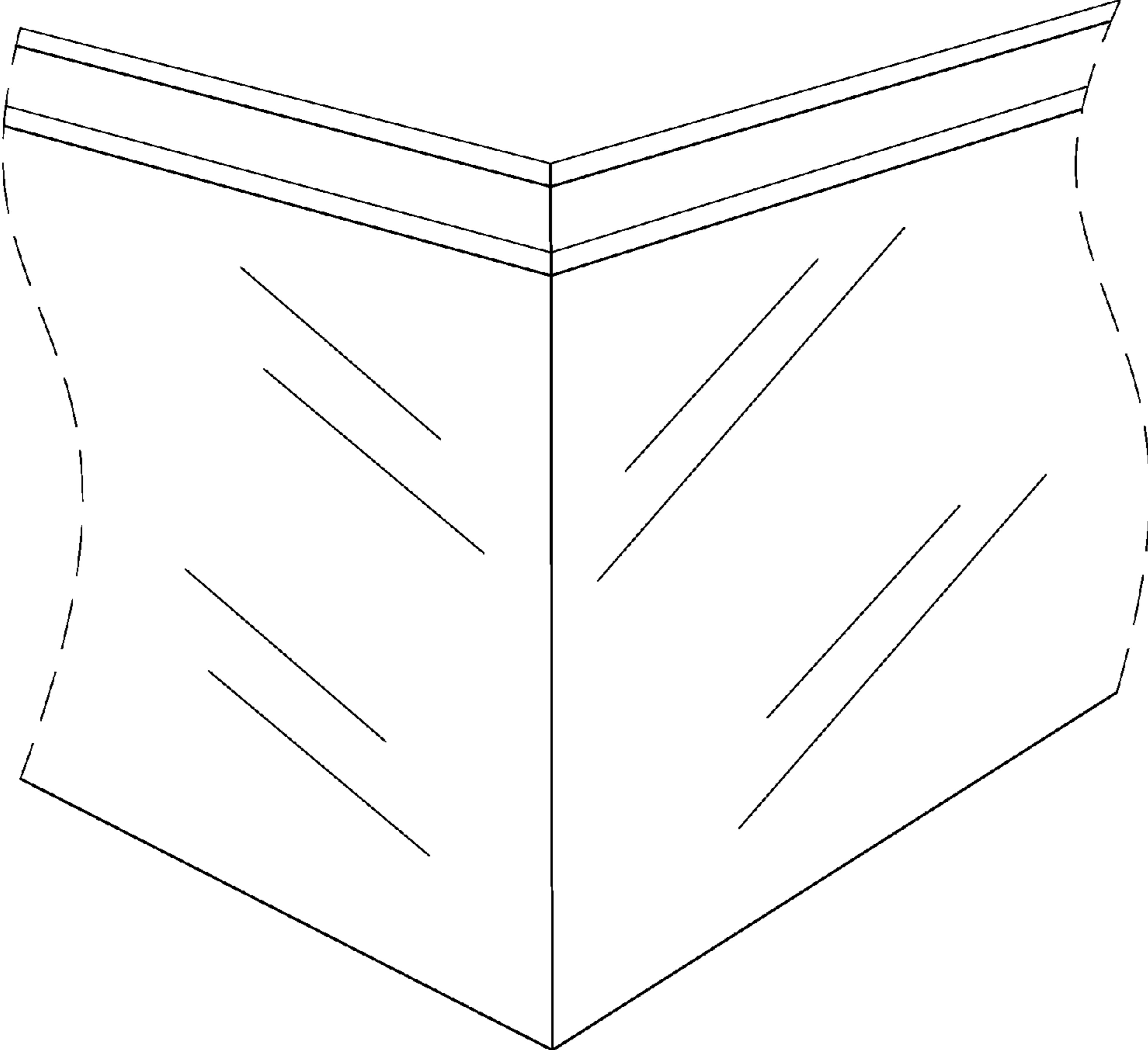
