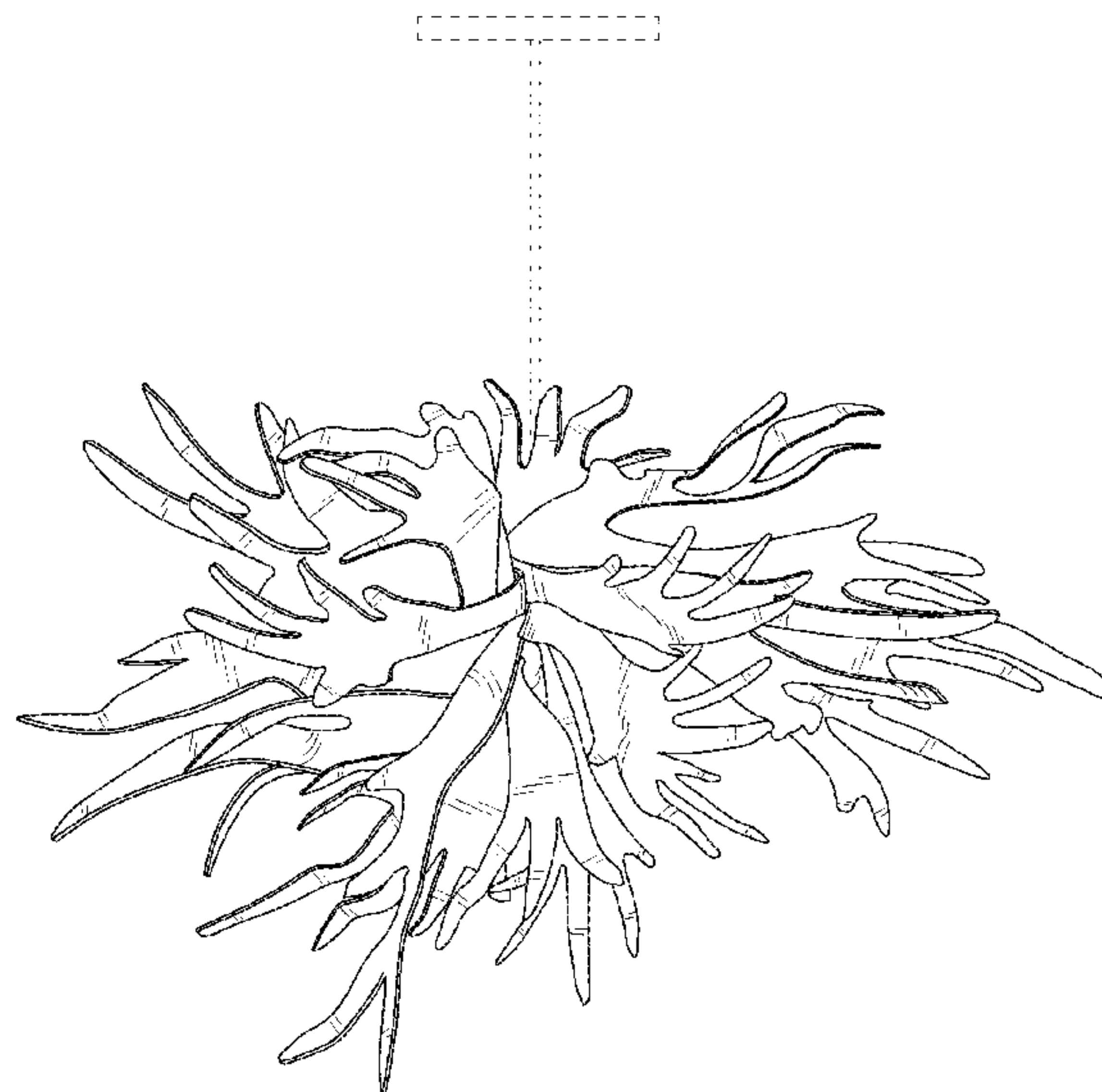
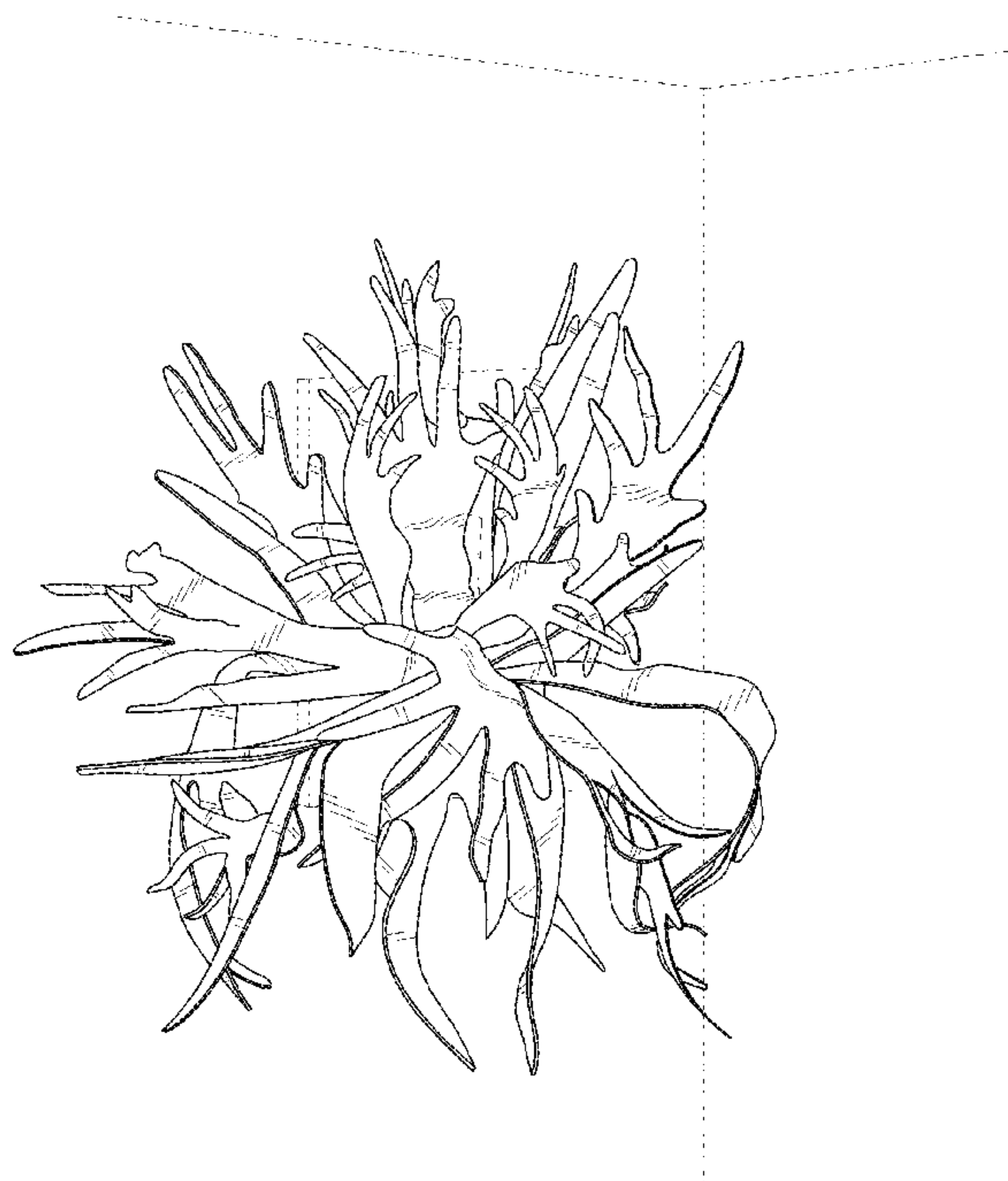
(57) **CLAIM**

The ornamental design for a staghorn fern lighting fixture, as shown and described.

DESCRIPTION

FIG. 1 is an environmental perspective view of a staghorn fern lighting fixture including my design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a right-side elevational view thereof;
FIG. 4 is a left-side elevational view thereof;

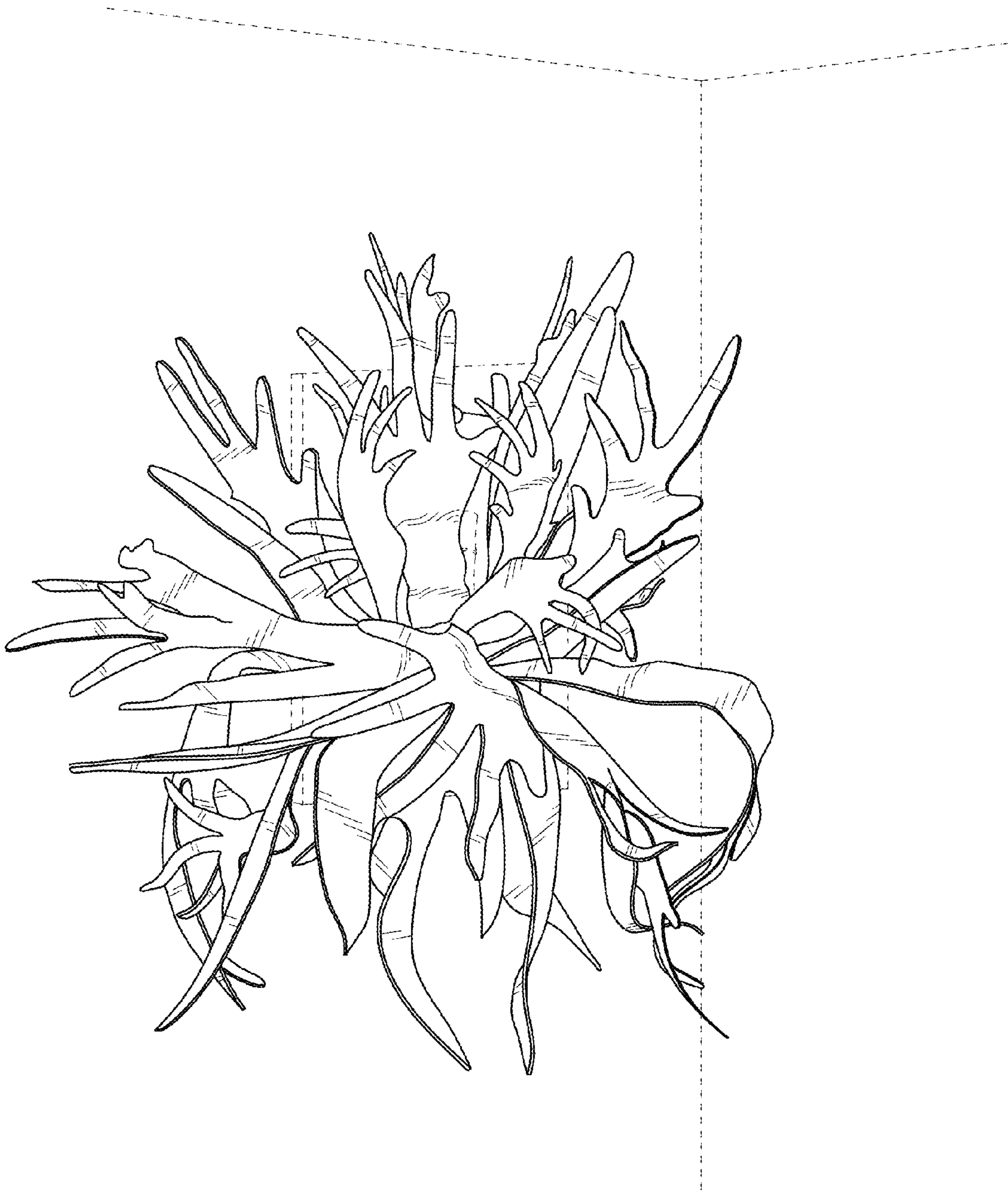

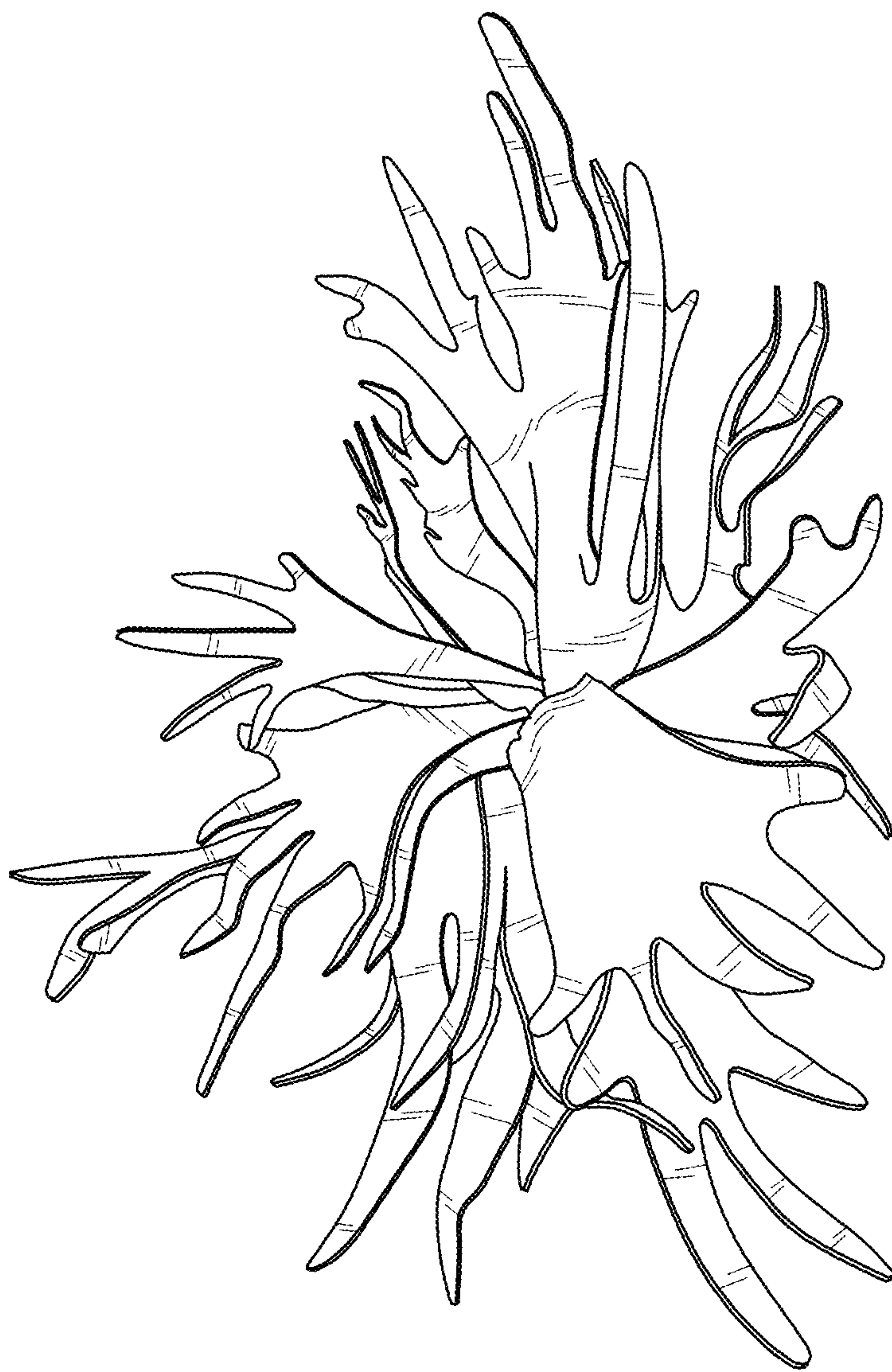

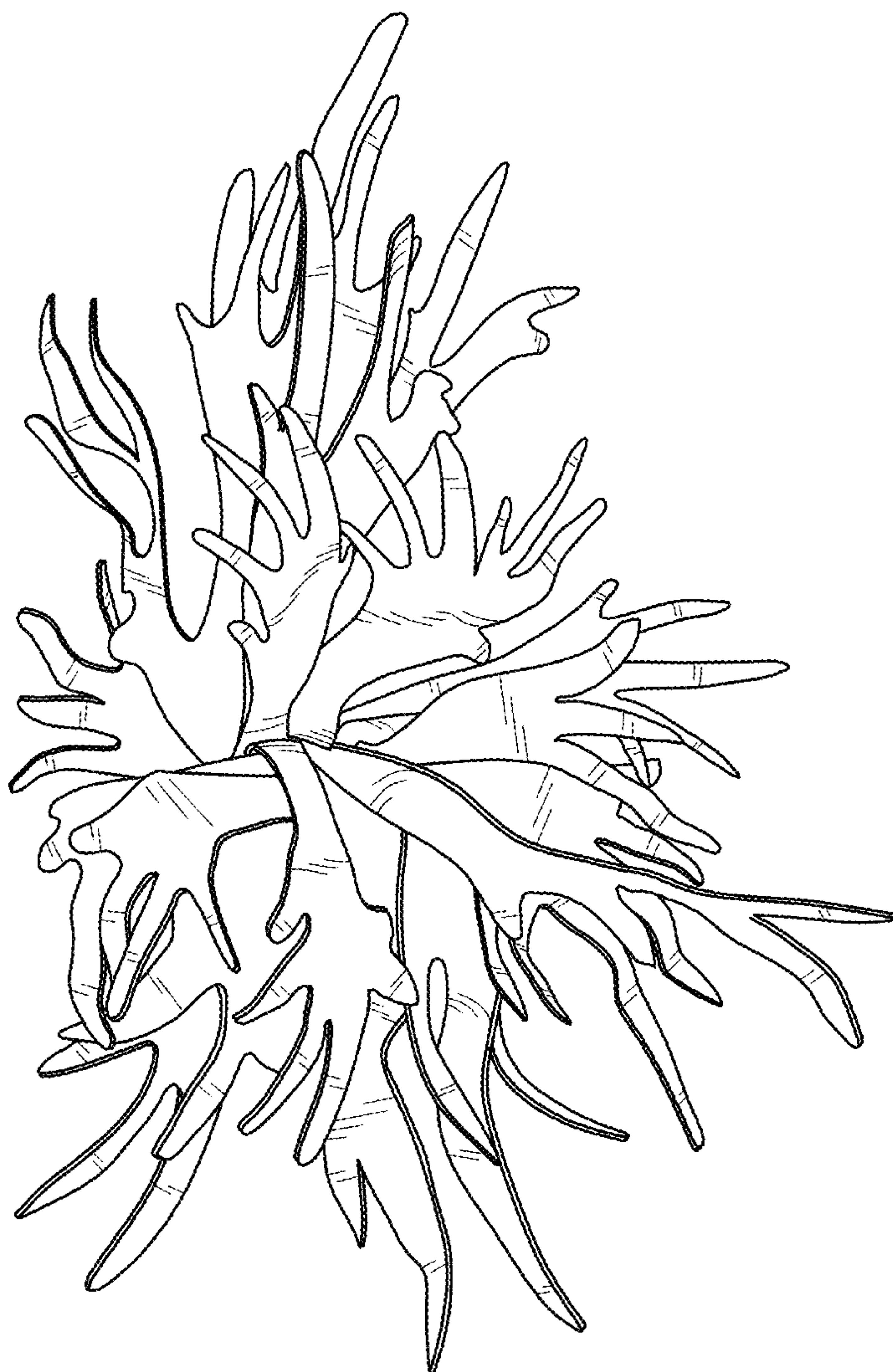

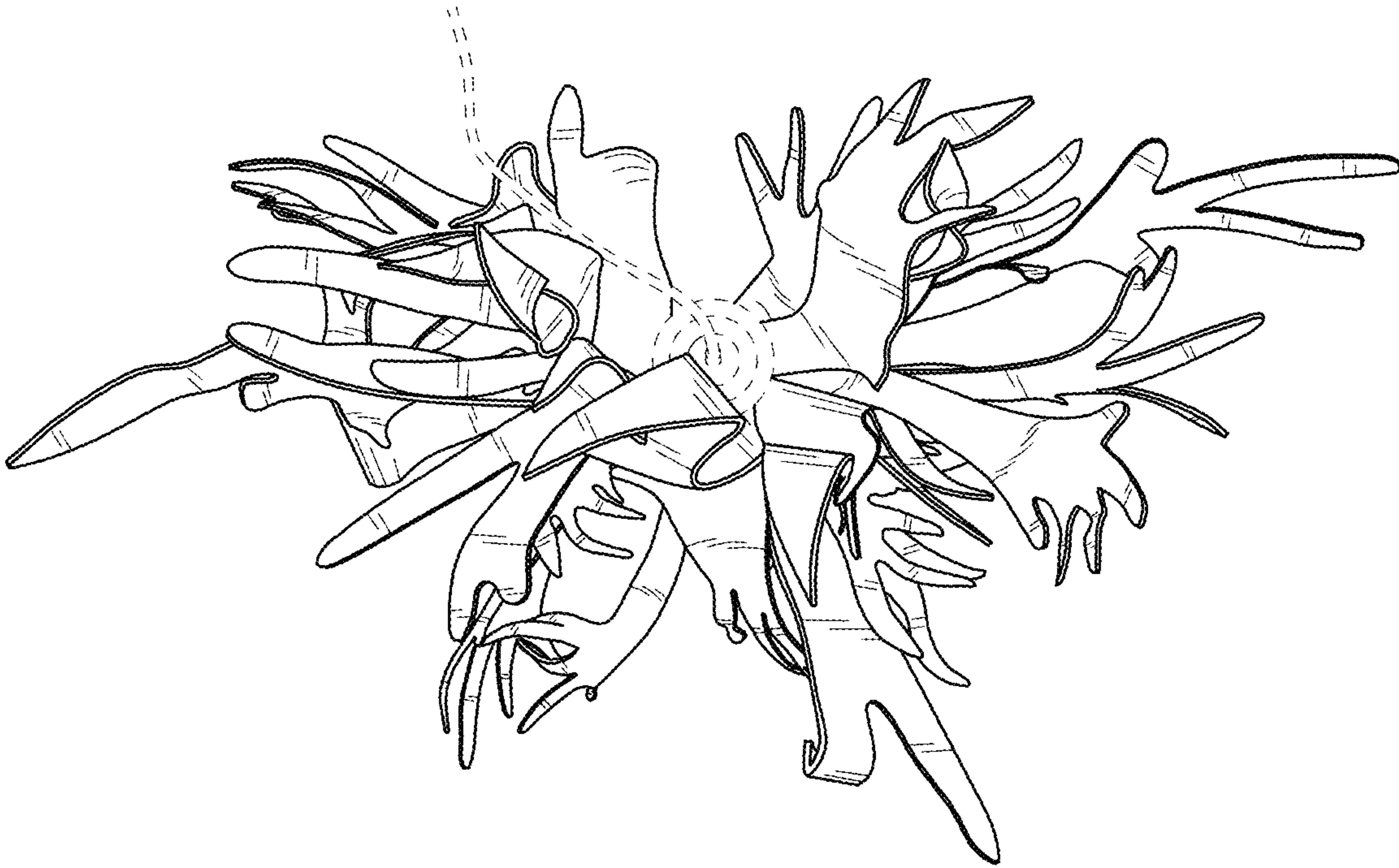

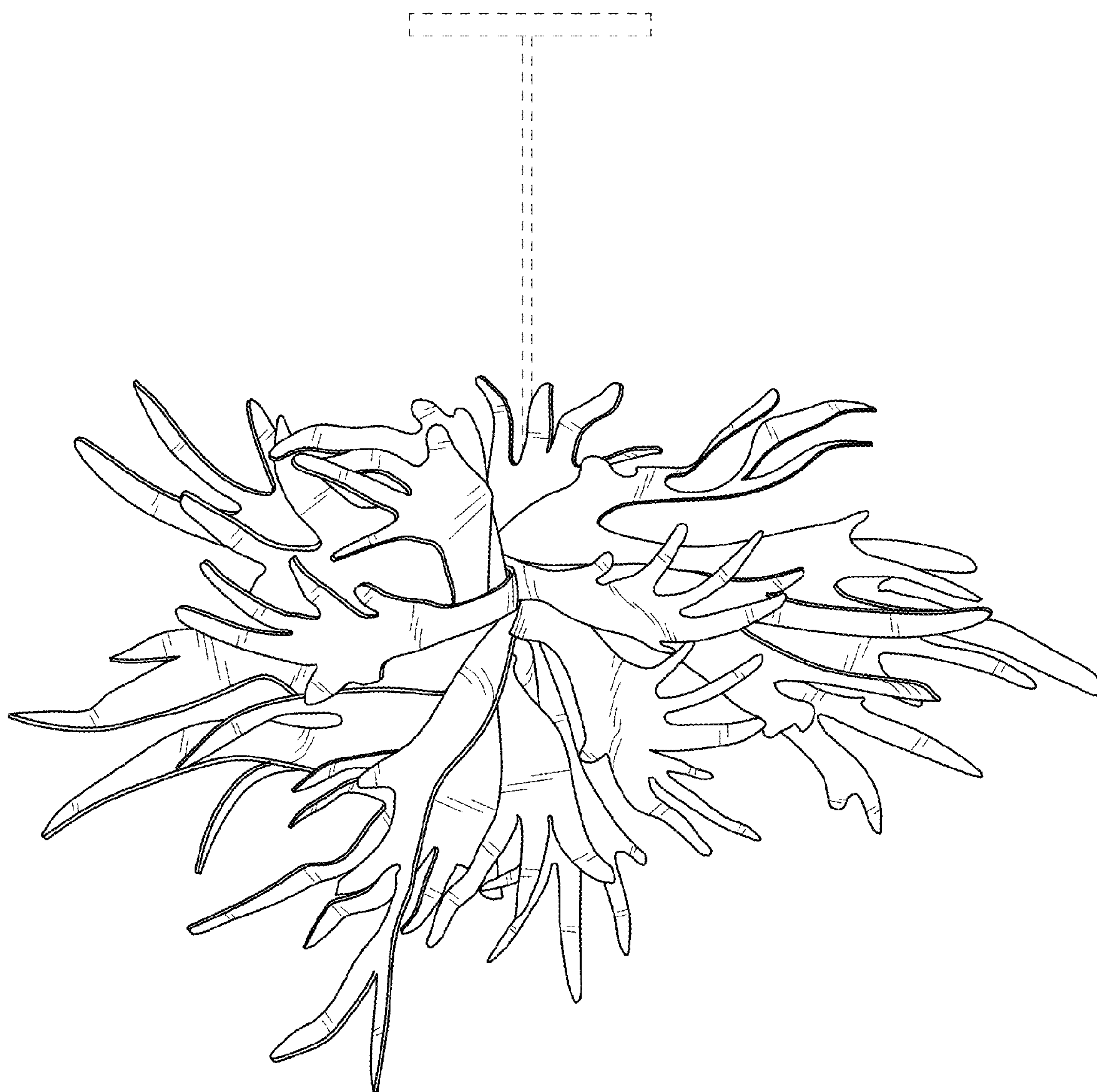
