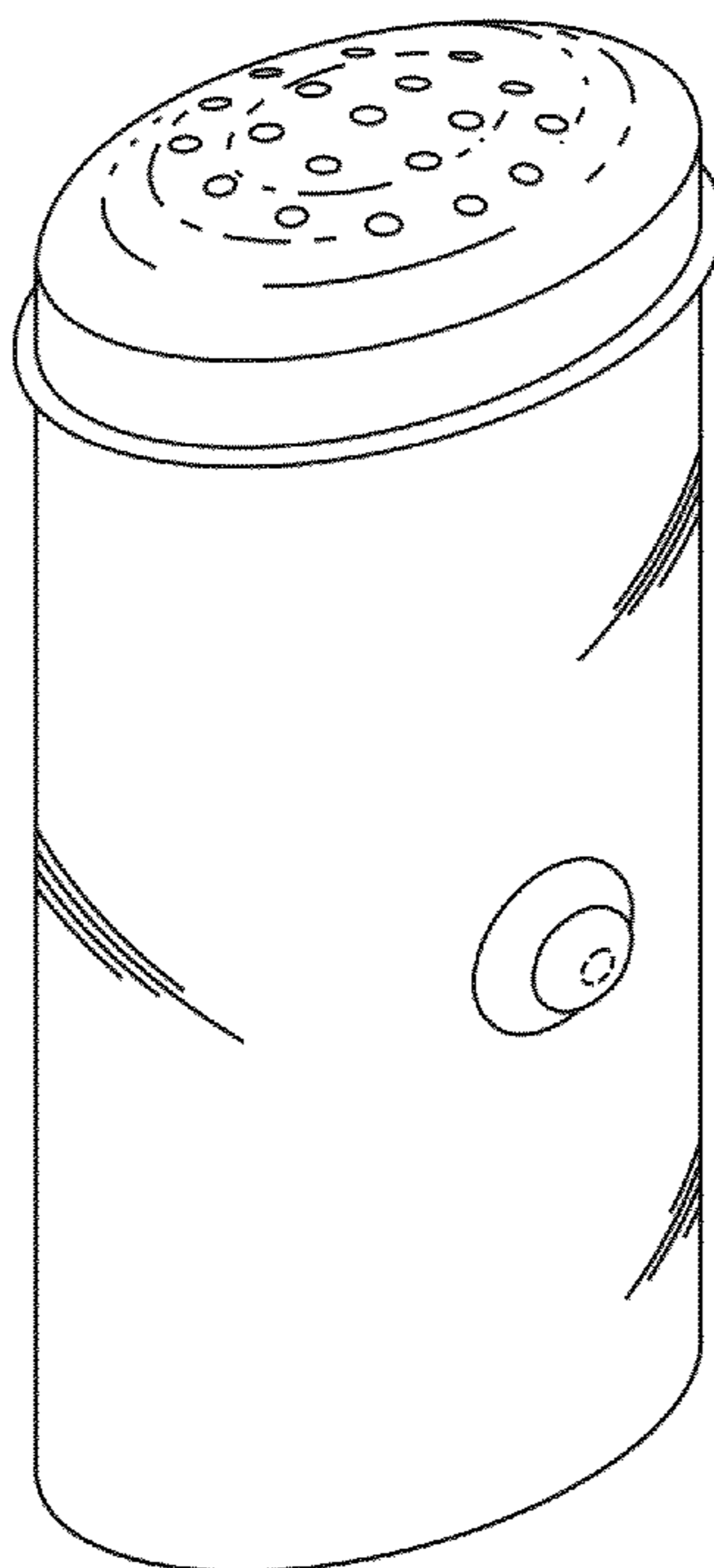

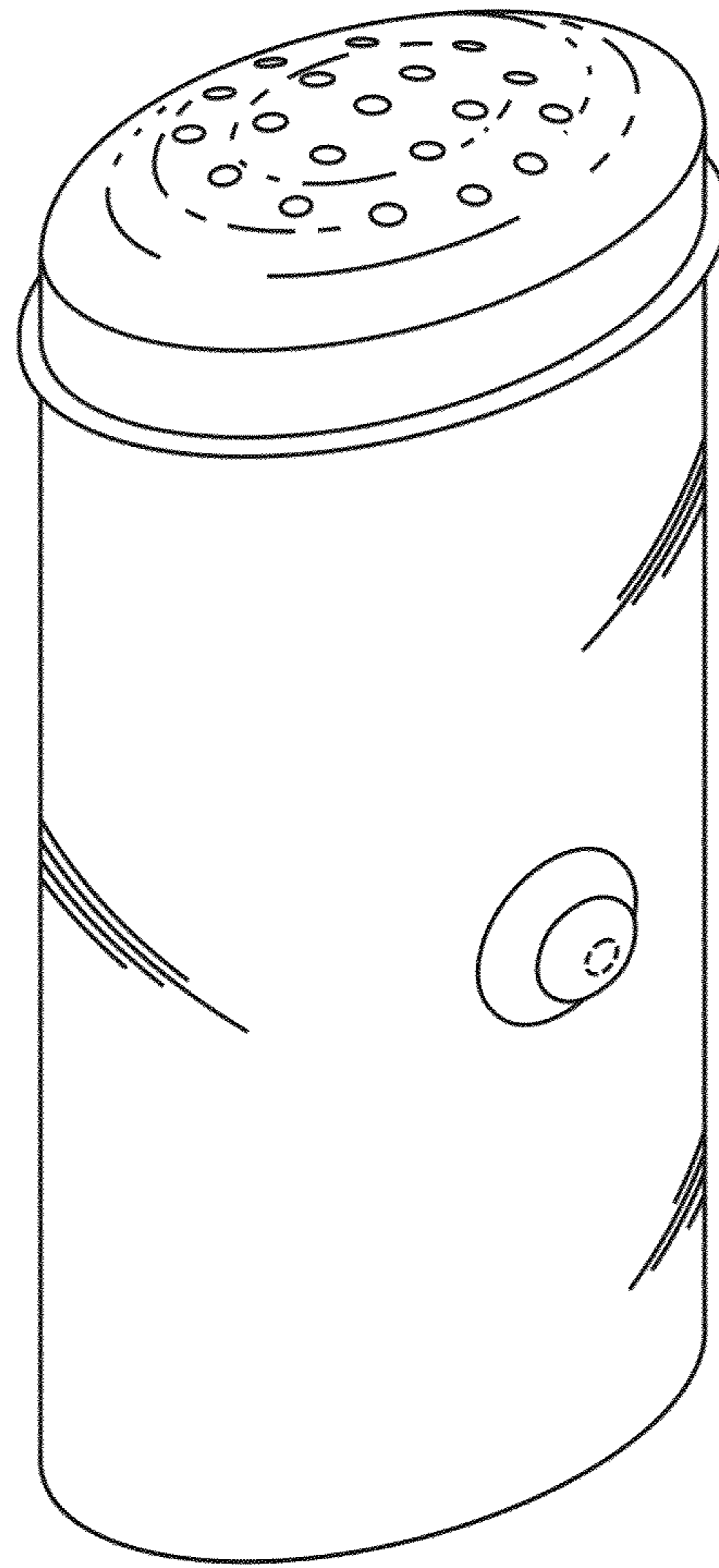

**DESCRIPTION**

FIG. 1 is a perspective view of a smoking apparatus showing my new design;  
 FIG. 2 is a front view of the smoking apparatus shown in FIG. 1;  
 FIG. 3 is a back view of the smoking apparatus shown in FIG. 1; and,  
 FIG. 4 is a top view of the smoking apparatus shown in FIG. 1.  
 The evenly spaced broken lines showing an aperture in a plug on the front of the smoking apparatus in FIGS. 1 and 2 show portions that form no part of the claimed design.

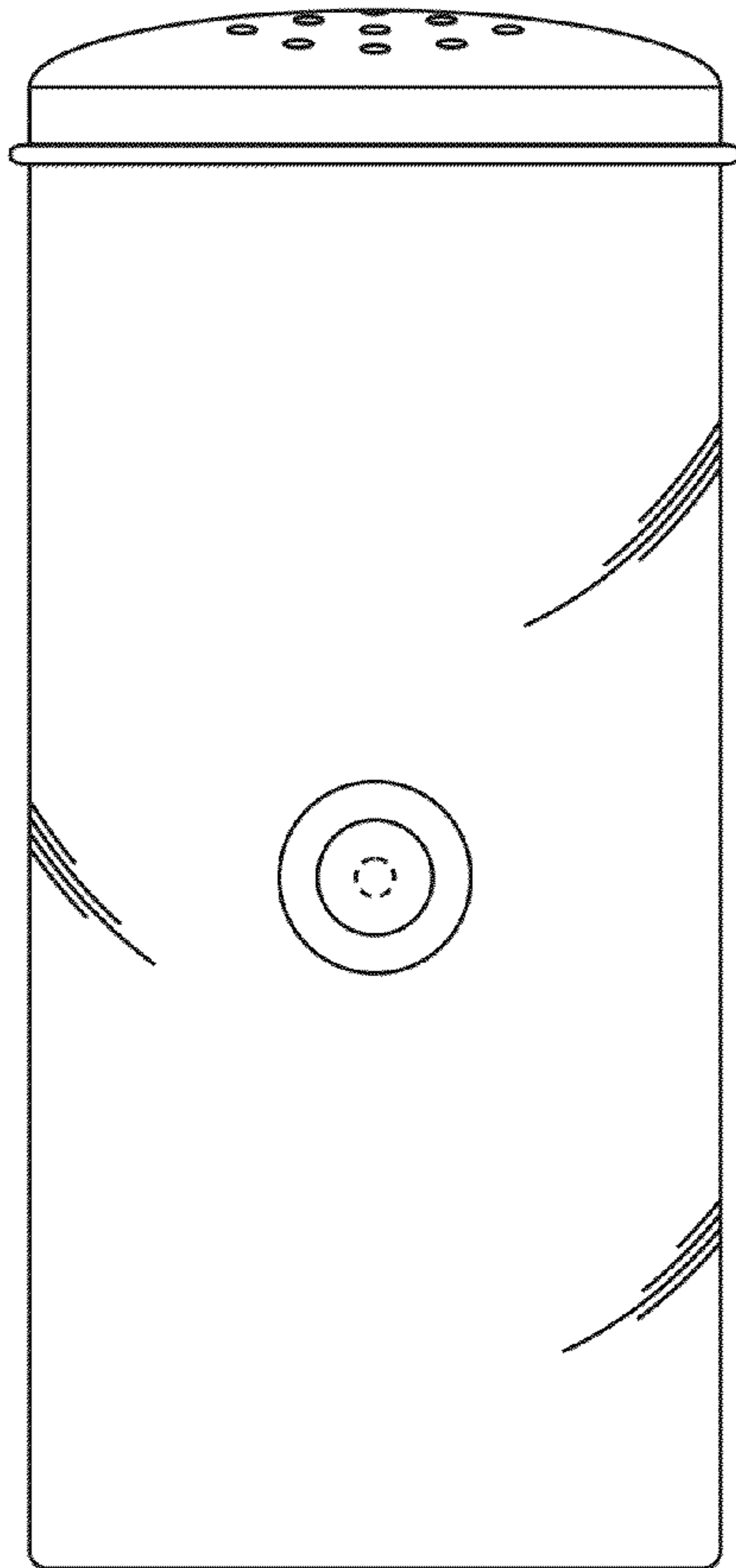

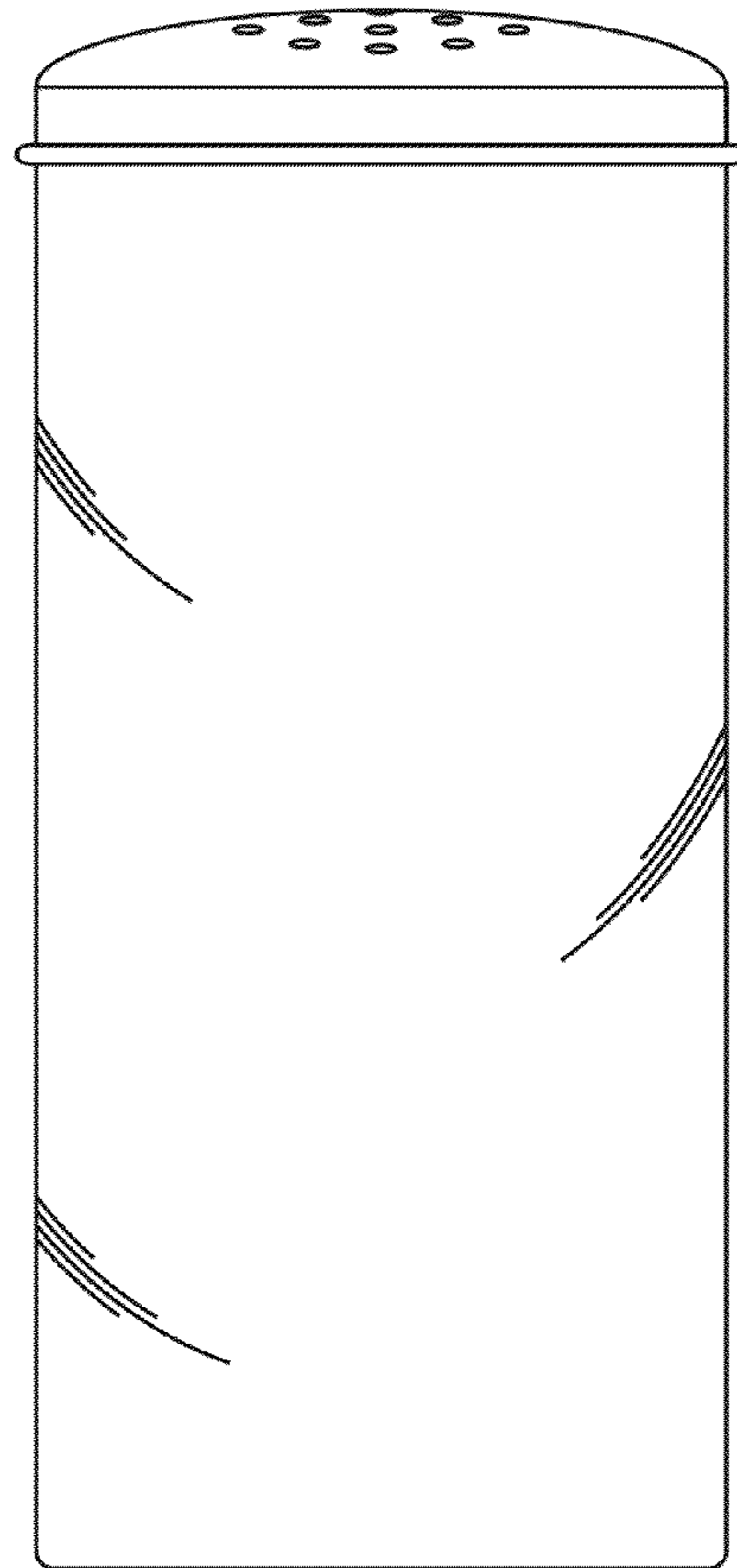

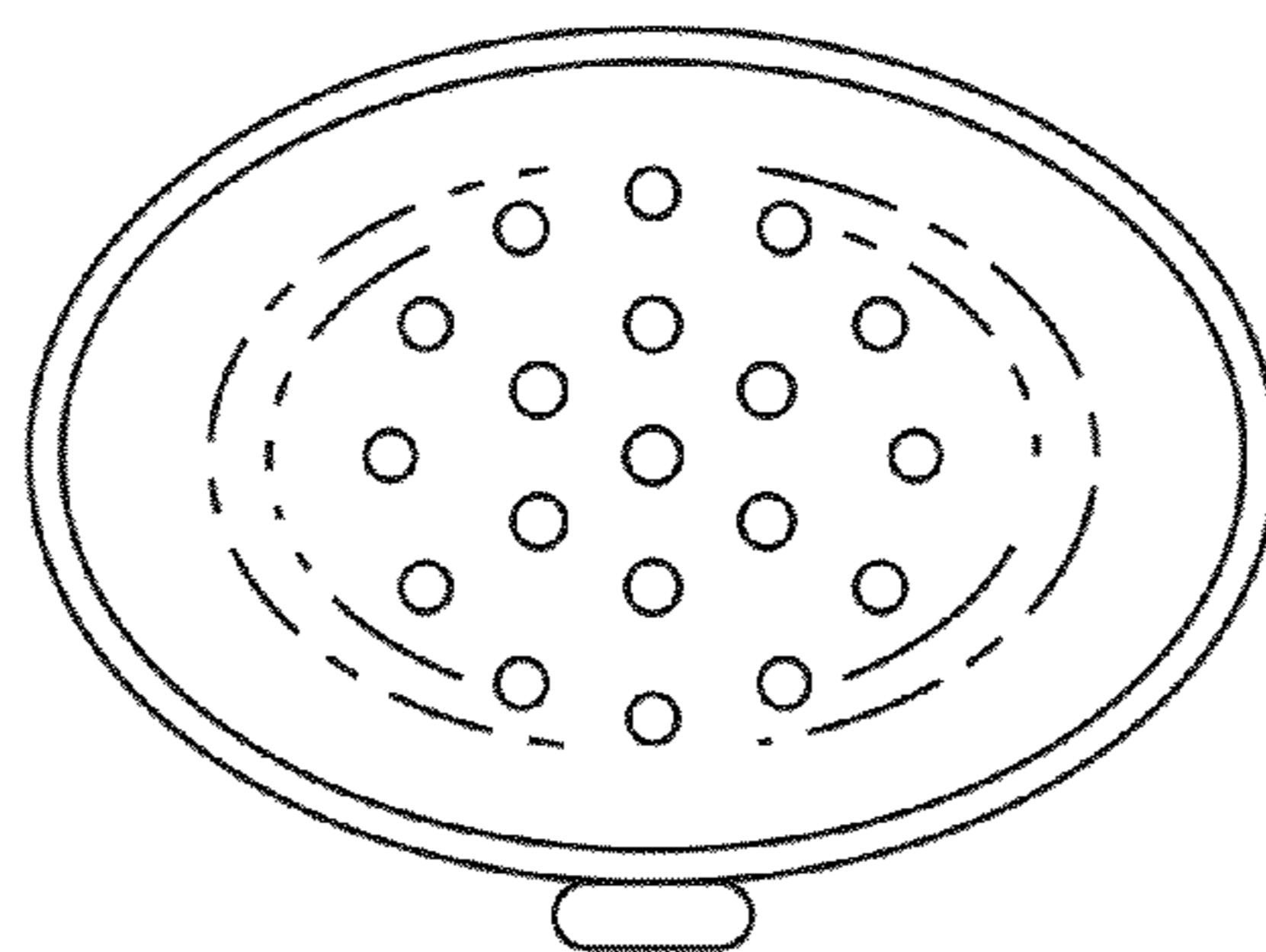
