(57) **CLAIM**

The ornamental design for a flower sponge holder of frozen confection drops, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a first embodiment of a flower sponge holder of frozen confection drops showing my new design;

FIG. 2 is a top elevational view thereof;

FIG. 3 is a bottom elevational view thereof;

FIG. 4 is a side elevational view thereof; and

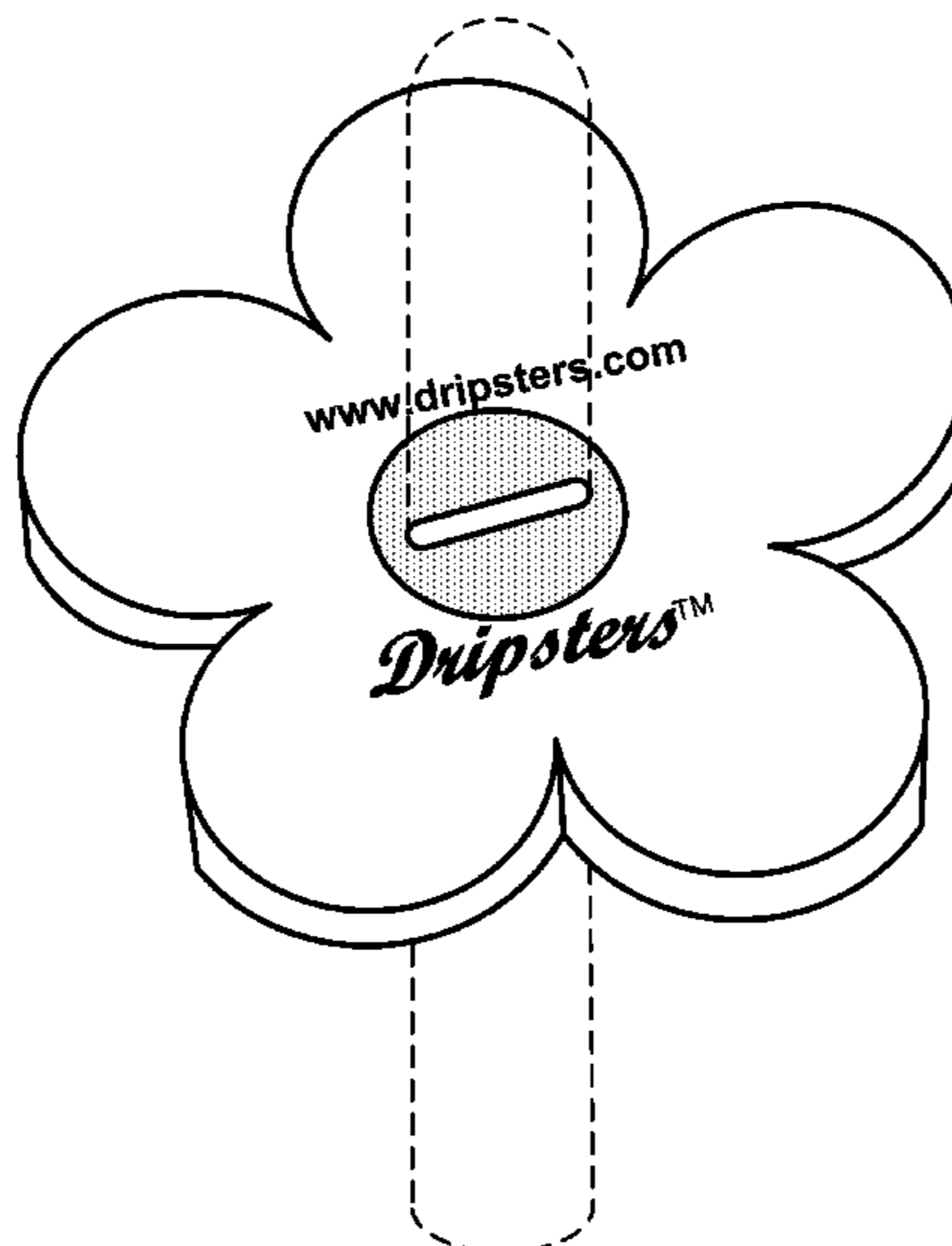
FIG. 5 is a top elevational view of a second embodiment of the design shown in FIGS. 1 through 4, the bottom and side elevational views being identical to those of Embodiment 1; and,

FIG. 6 is a view of a second modified embodiment of the design shown in FIG. 1 through 4, all other views being identical.

The broken line showing of a stick is for the purpose of illustrating environment, and forms no part of the claimed design.

The word “Dripsters”, which forms part of the claimed design, is a registered trademark of Dawn Firsing-Paris.

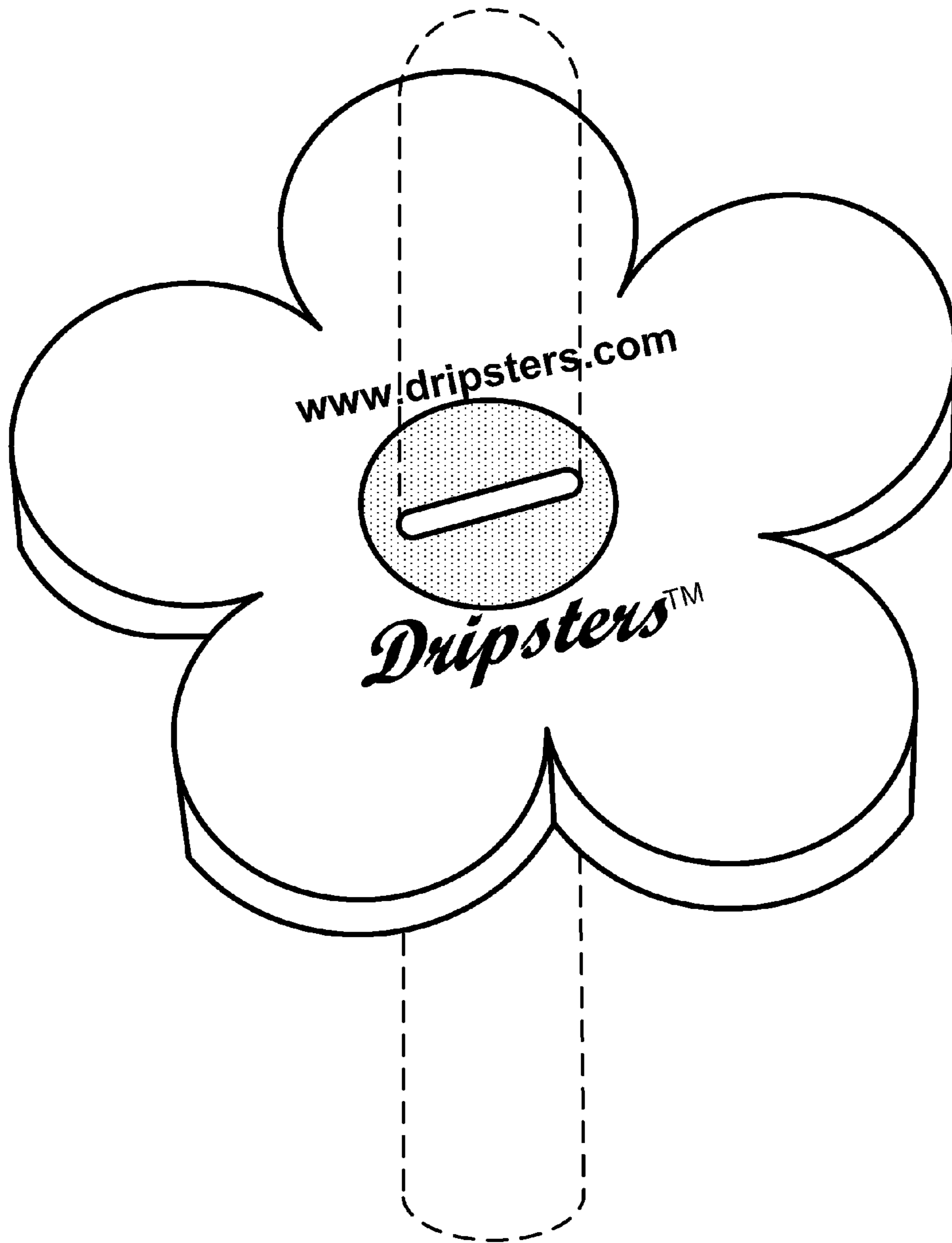

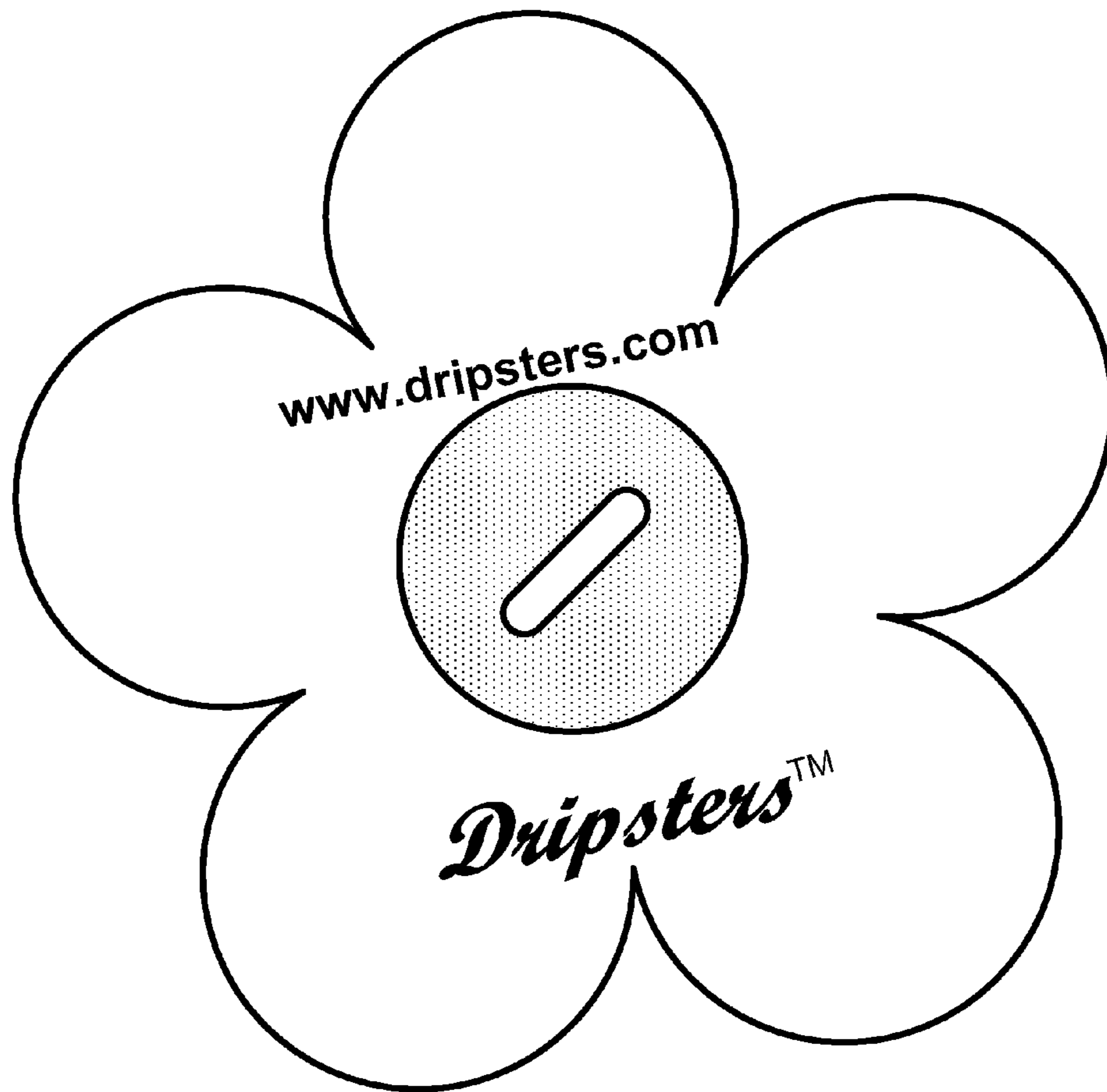

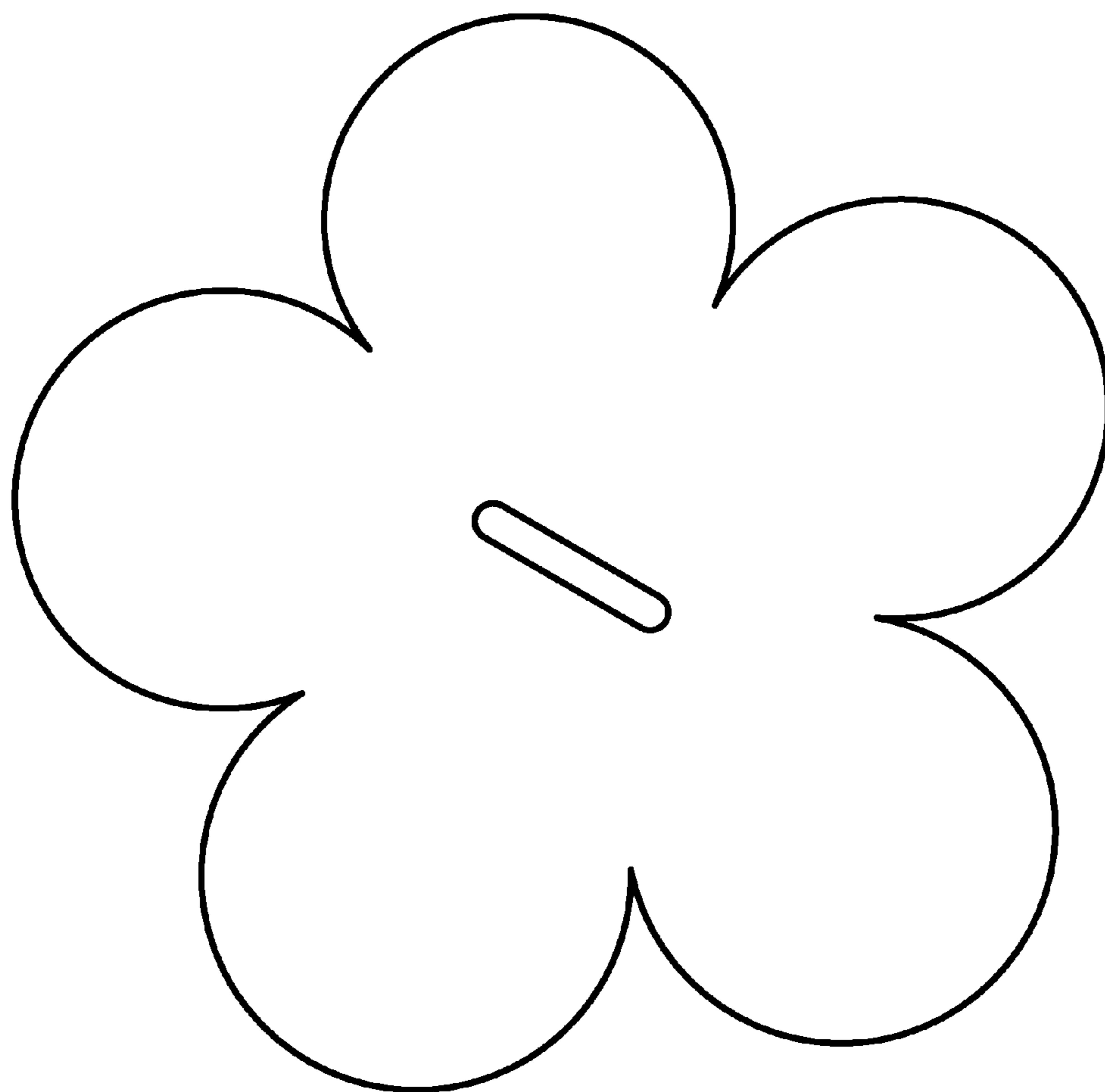

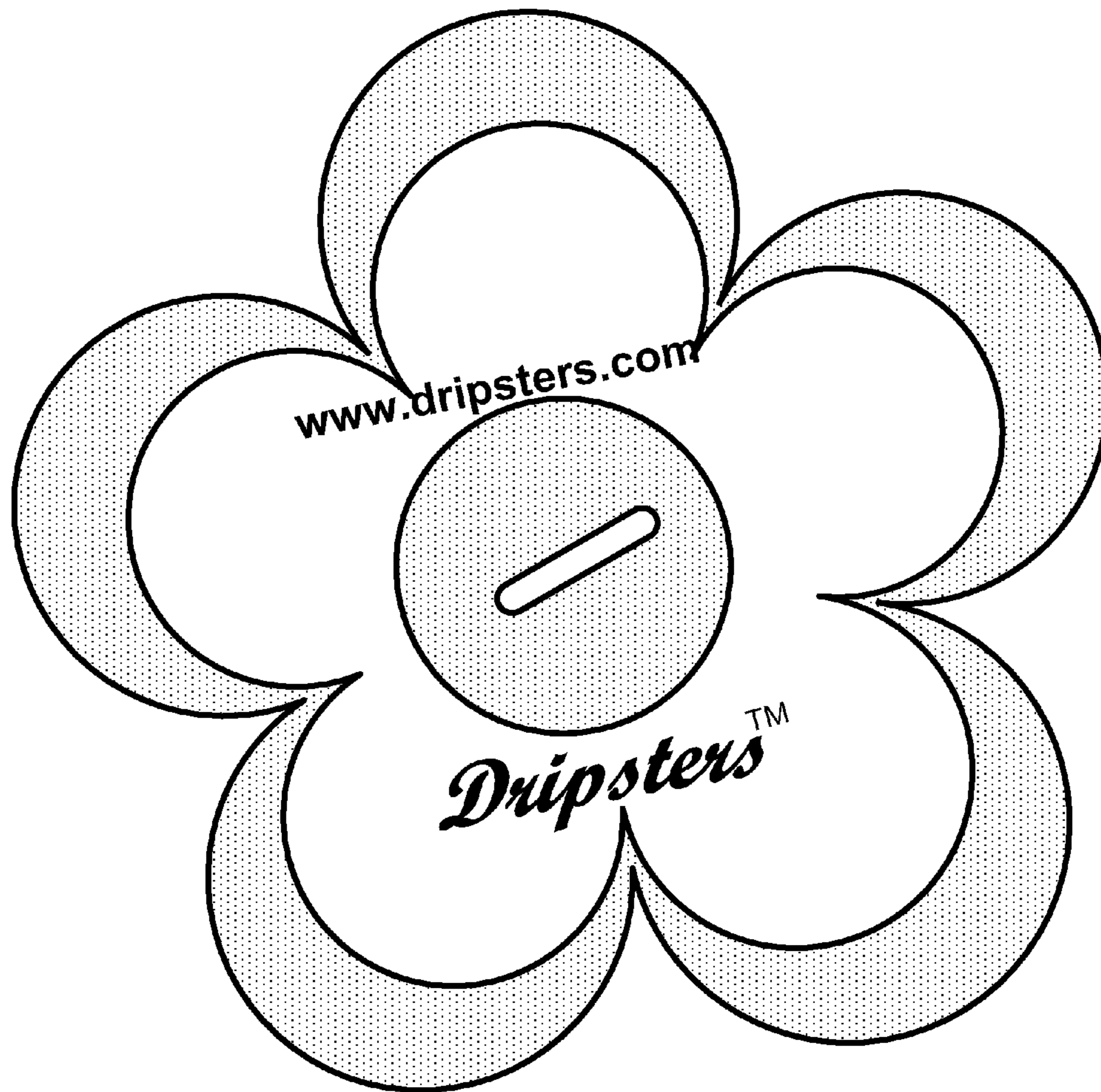

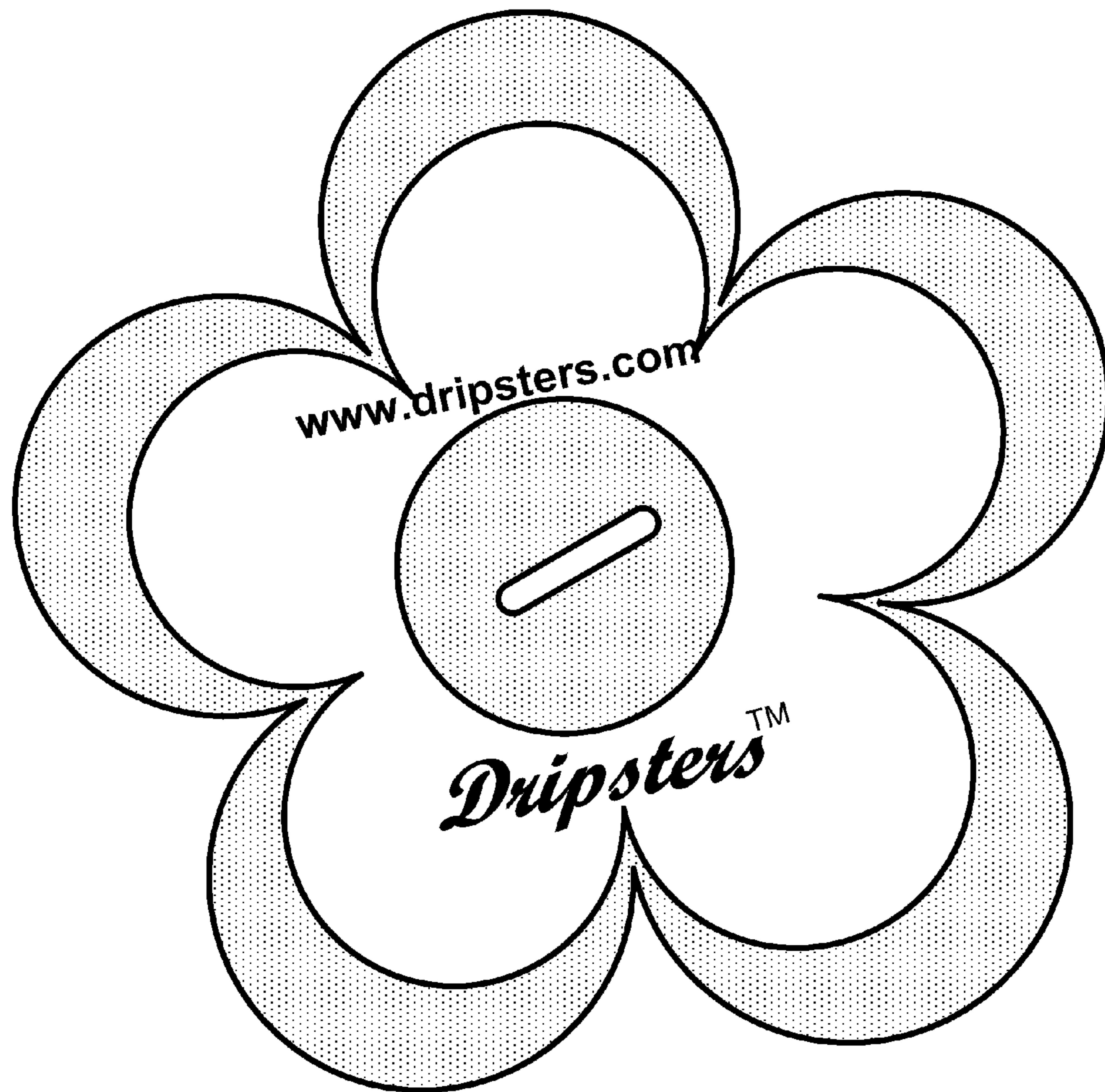
