(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shoe showing our new design.

FIG. 2 is a front elevational view thereof.

FIG. 3 is a rear elevational view thereof.

FIG. 4 is a left side elevational view thereof.

FIG. 5 is a right side elevational view thereof.

FIG. 6 is a top plan view thereof; and,

FIG. 7 is a bottom plan view thereof.

The evenly dashed lines in FIGS. 1-6 represent stitching and are part of the claimed design. The portions of FIG. 7 shown in broken dot-dash lines form no part of the claimed design.

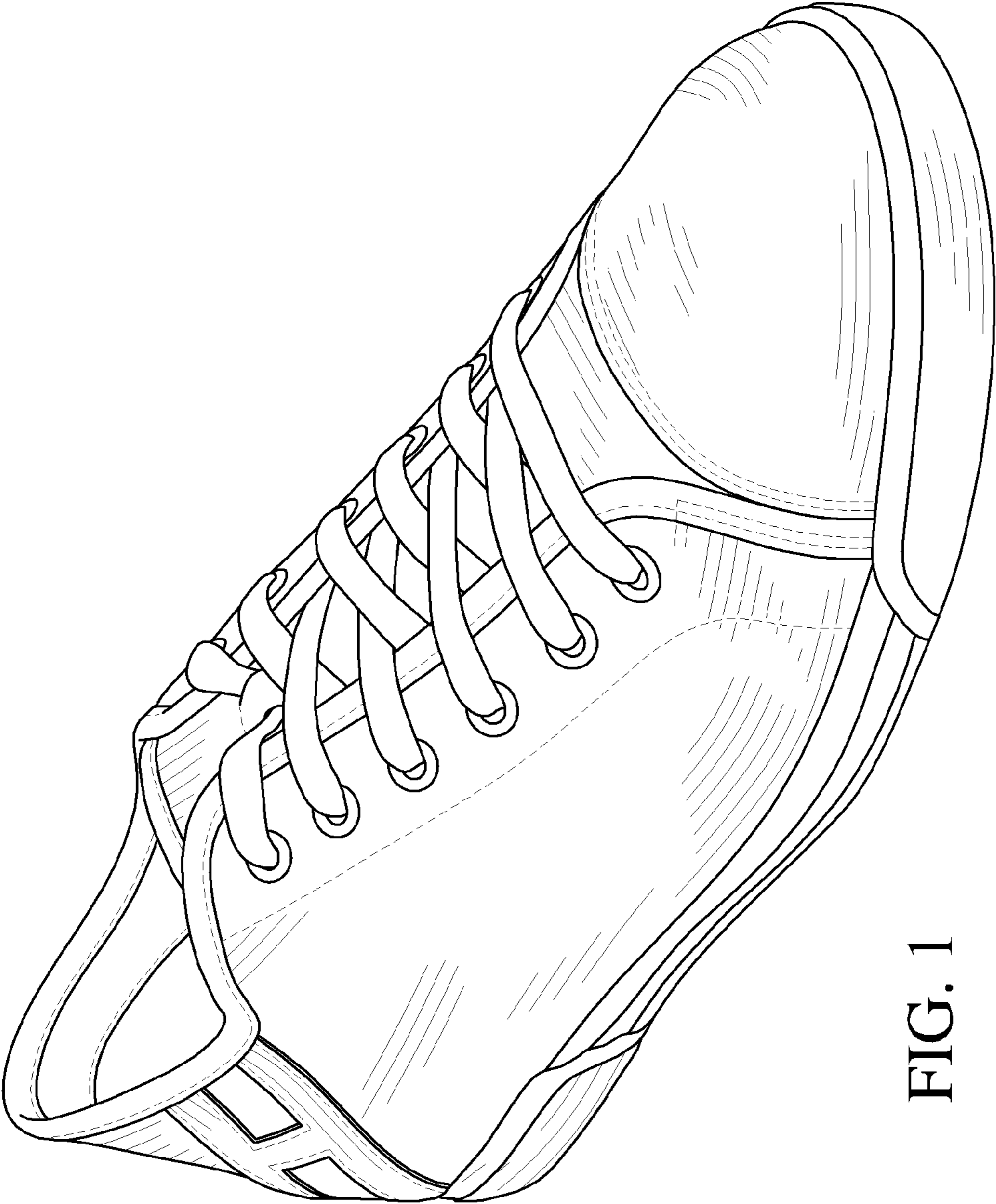

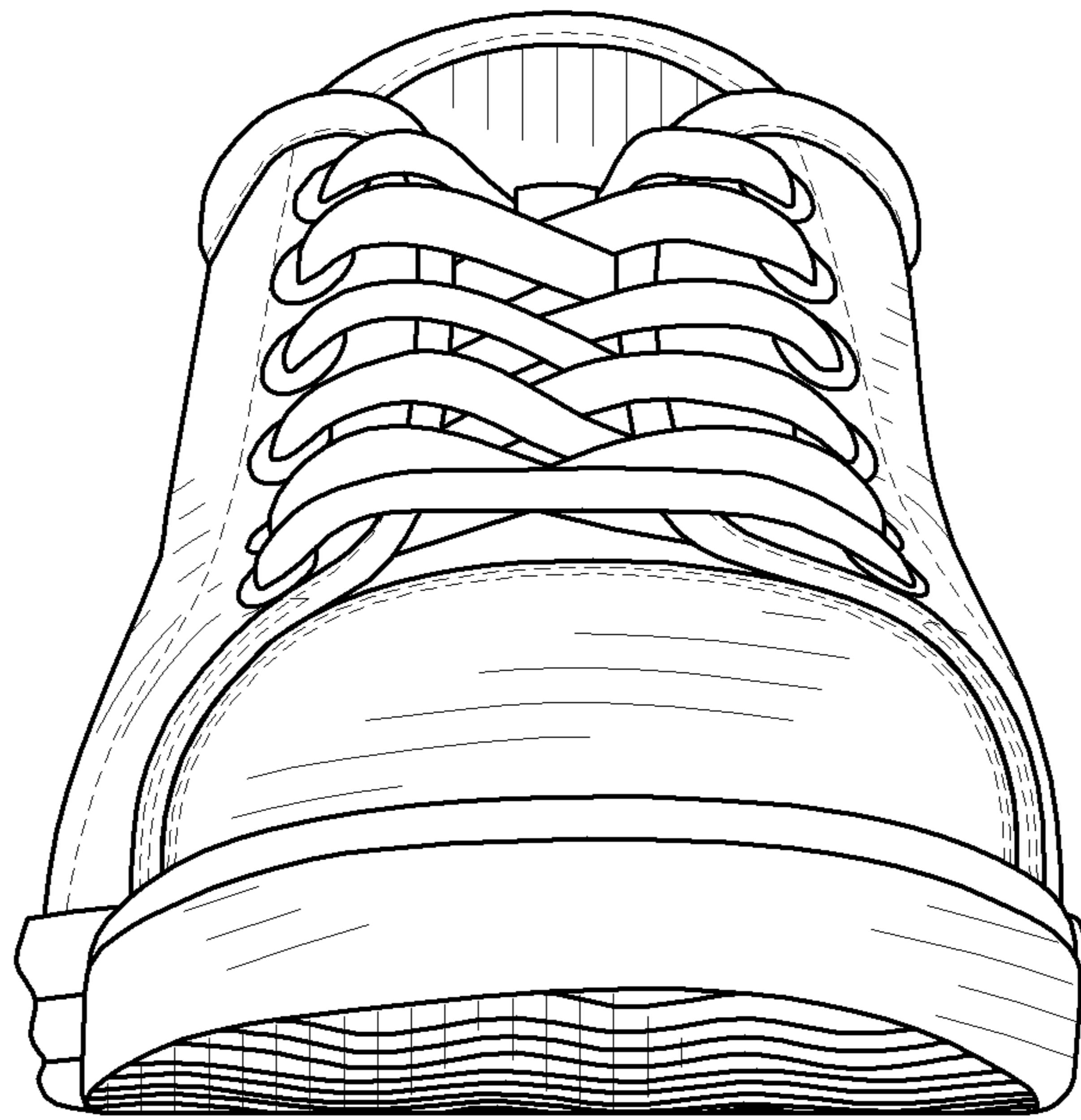

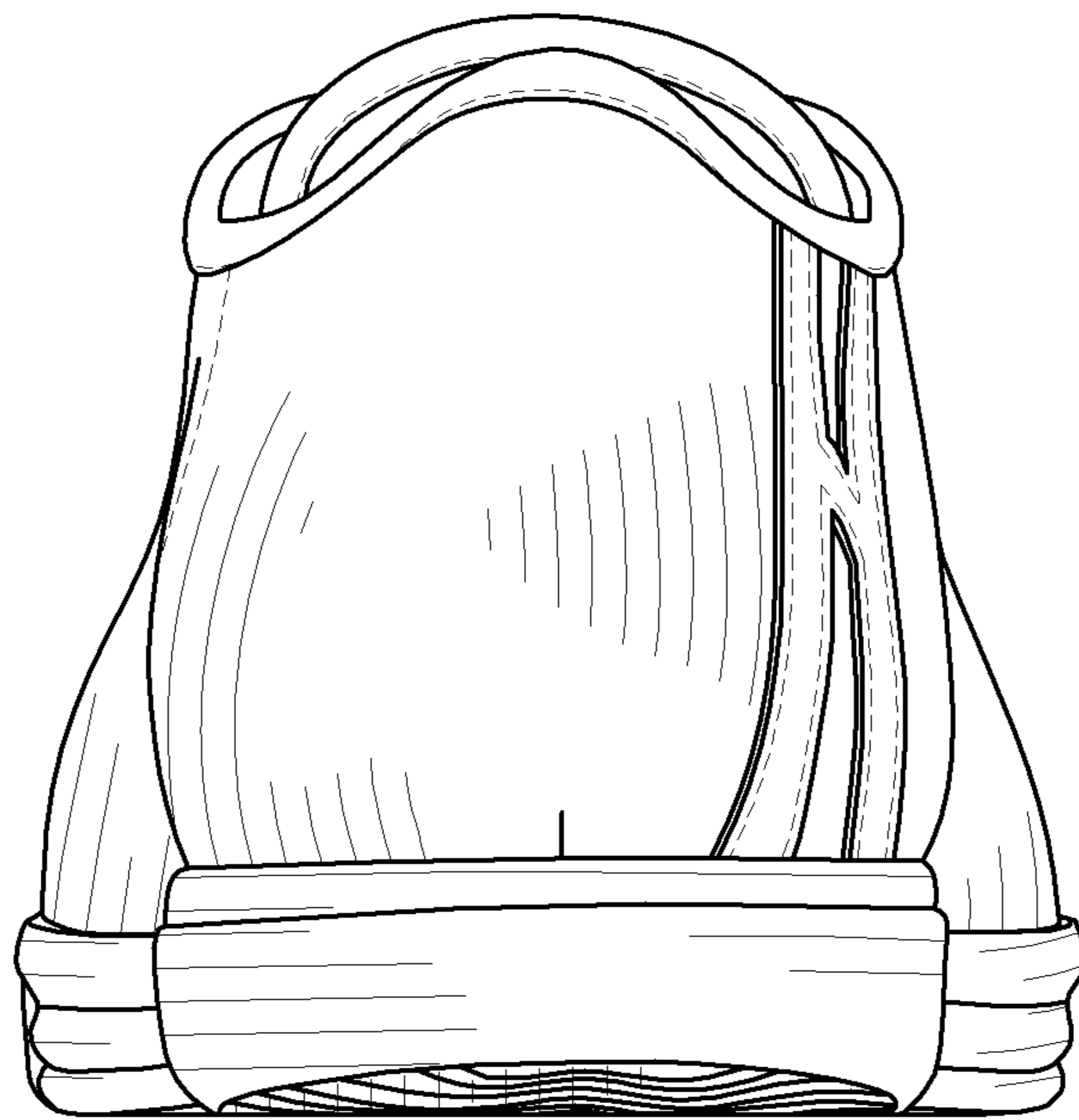

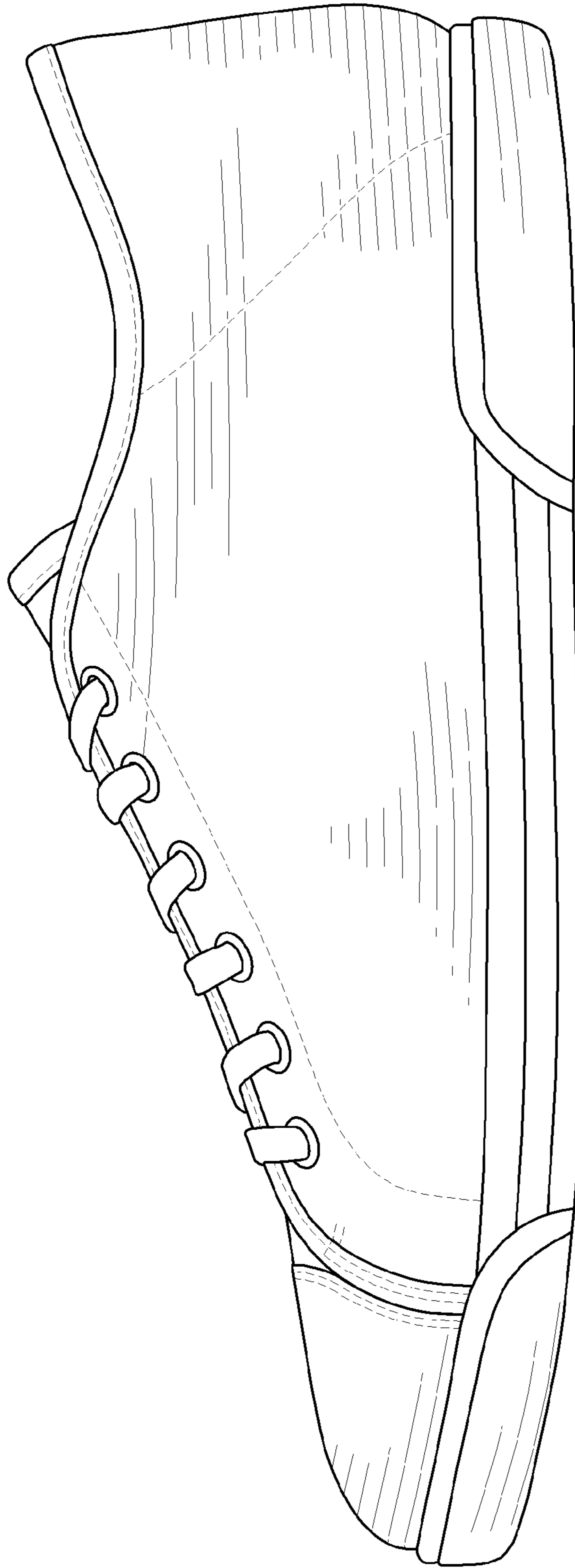

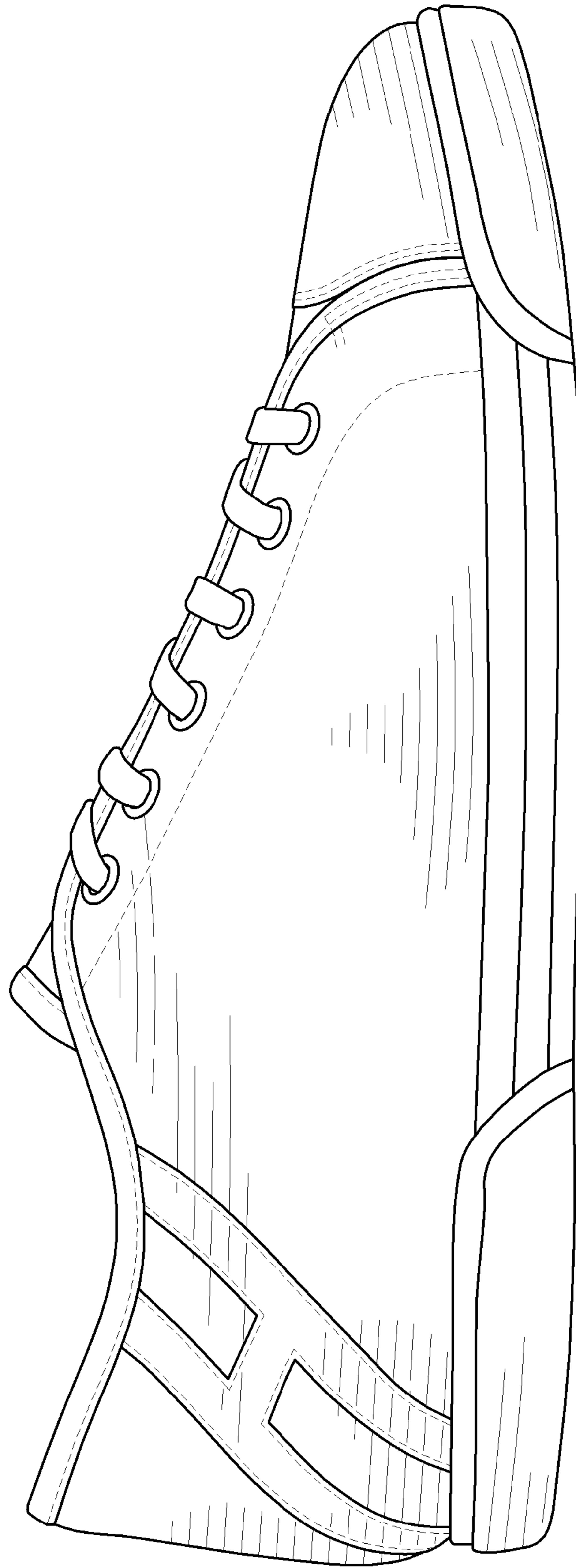

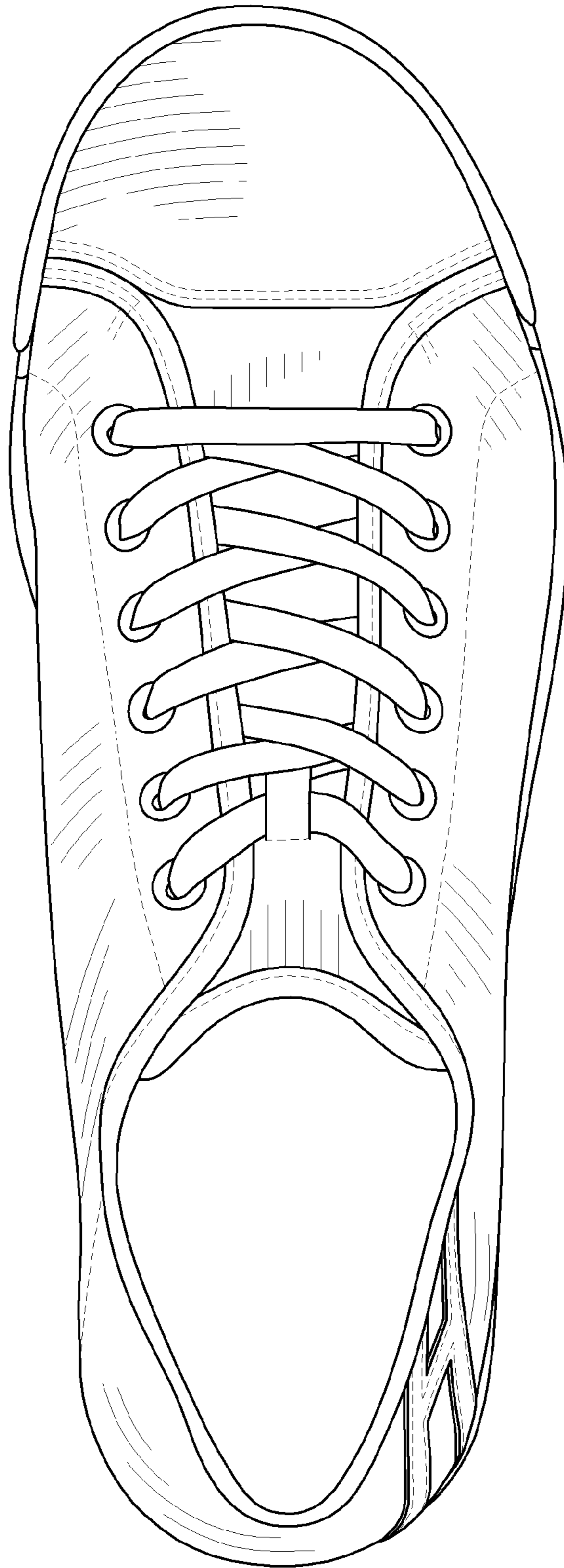
