(57) **CLAIM**

The ornamental design for a hand tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hand tool showing the new design;

FIG. 2 is a side view thereof;

FIG. 3 is a top view thereof;

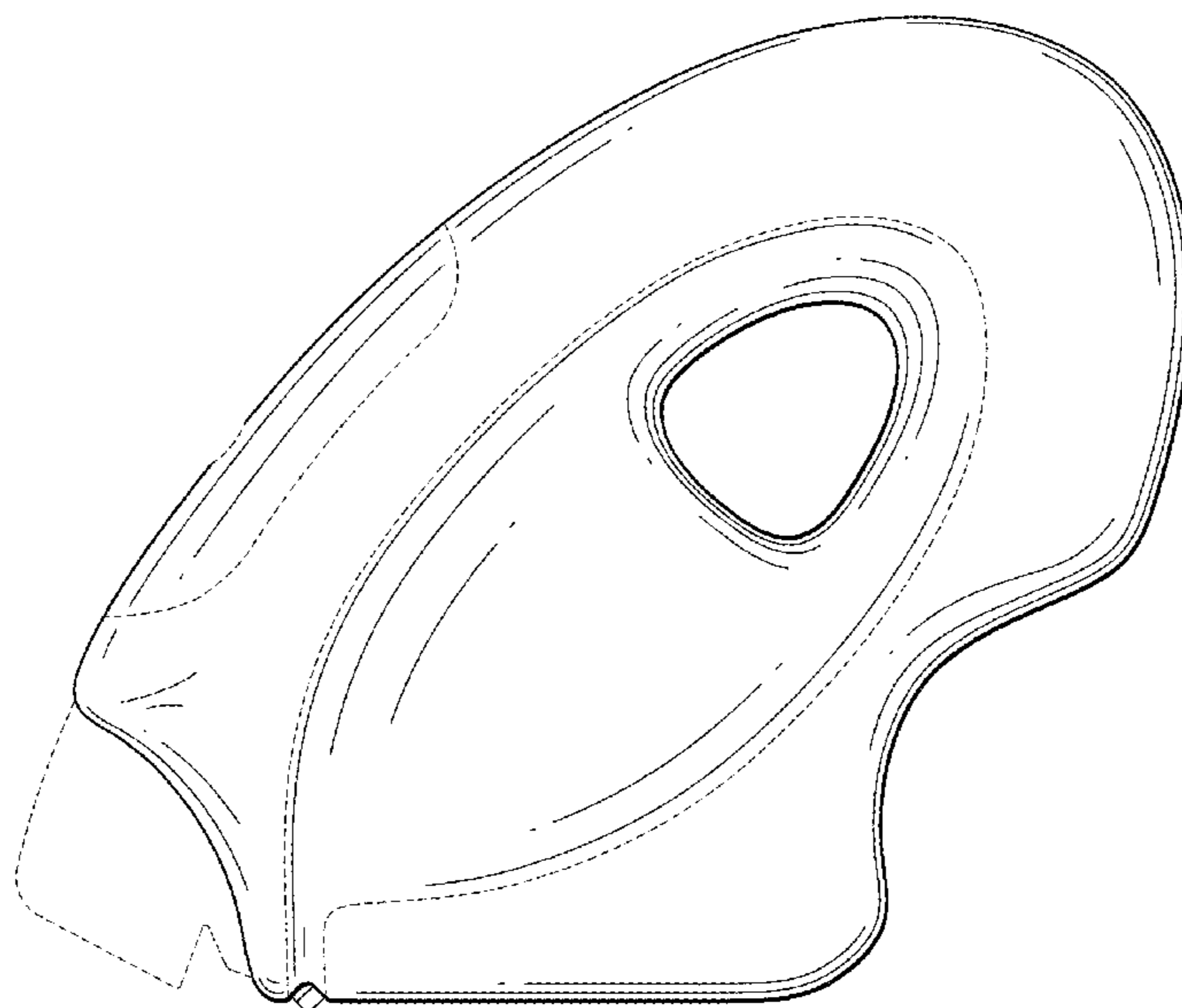
FIG. 4 is a bottom view thereof;

FIG. 5 is a front view thereof, as taken from the left side of FIG. 2; and,

FIG. 6 is a rear view thereof, as taken from the right side of FIG. 2.

The broken lines showing a blade are illustrative of environment and form no part of the claim. The broken lines appearing to form oval outlines, oblong outlines, etc. illustrate features of the hand tool that also form no part of the claim. It is to be noted that only the outlines are disclaimed and not the shapes within them.

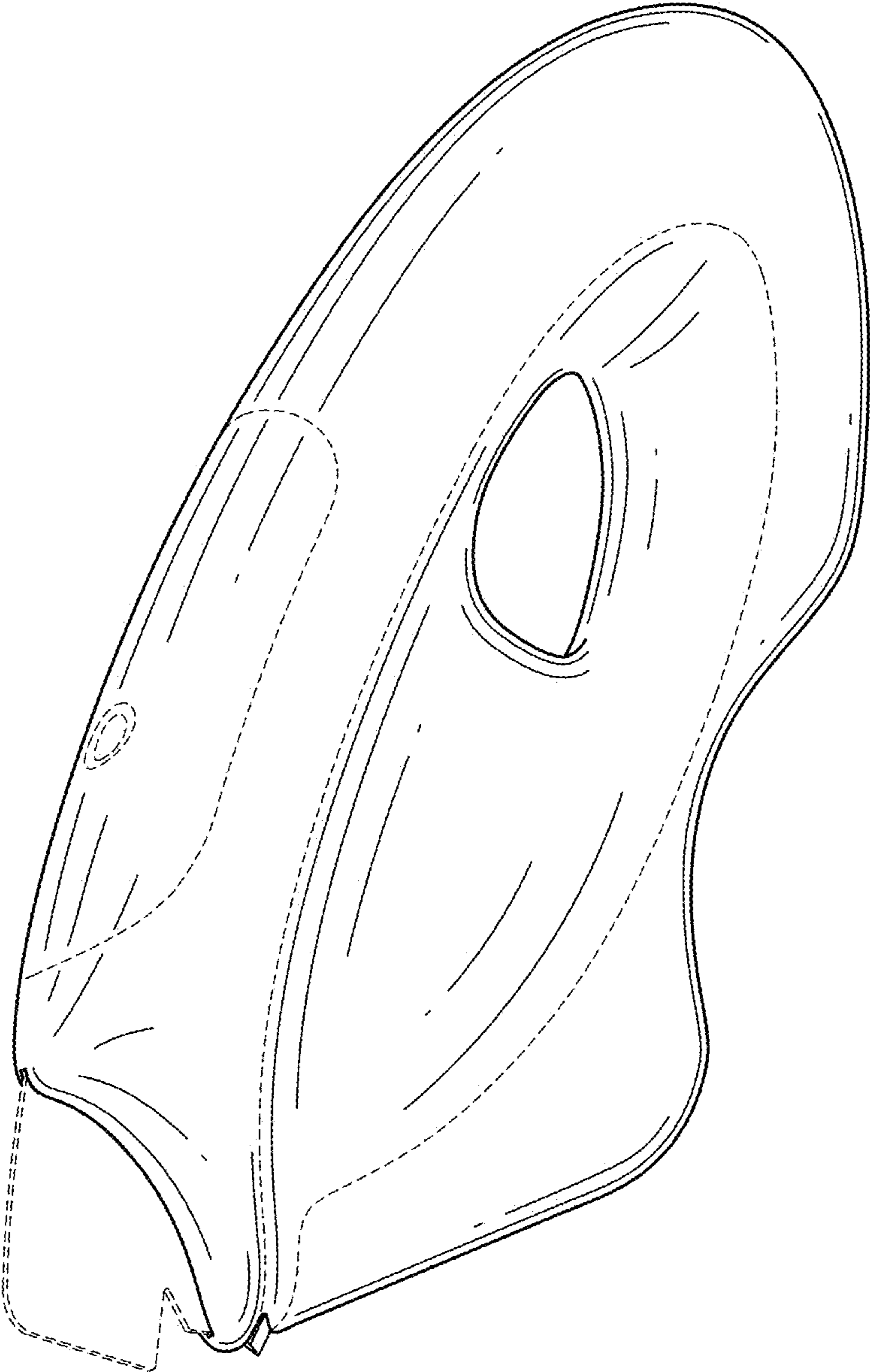

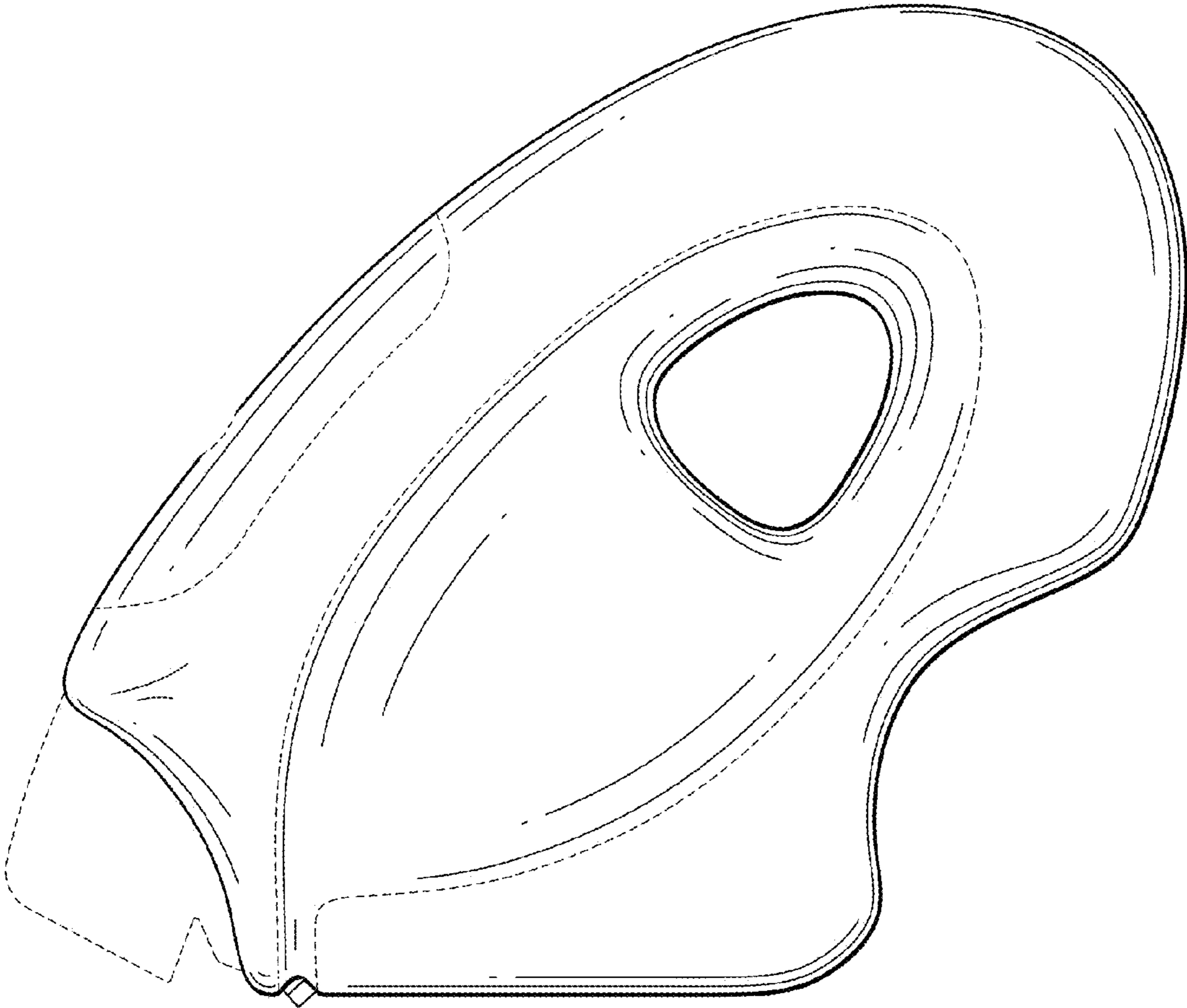

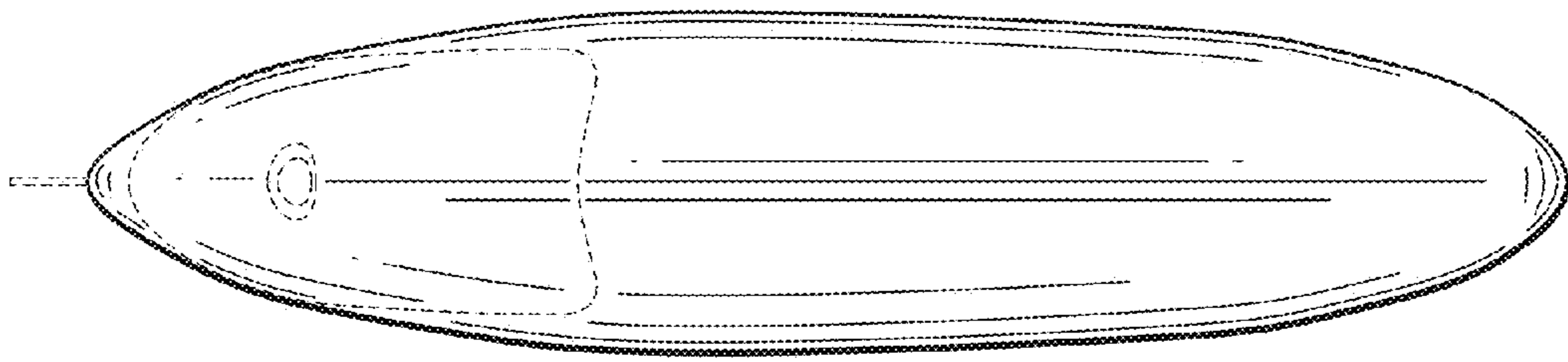

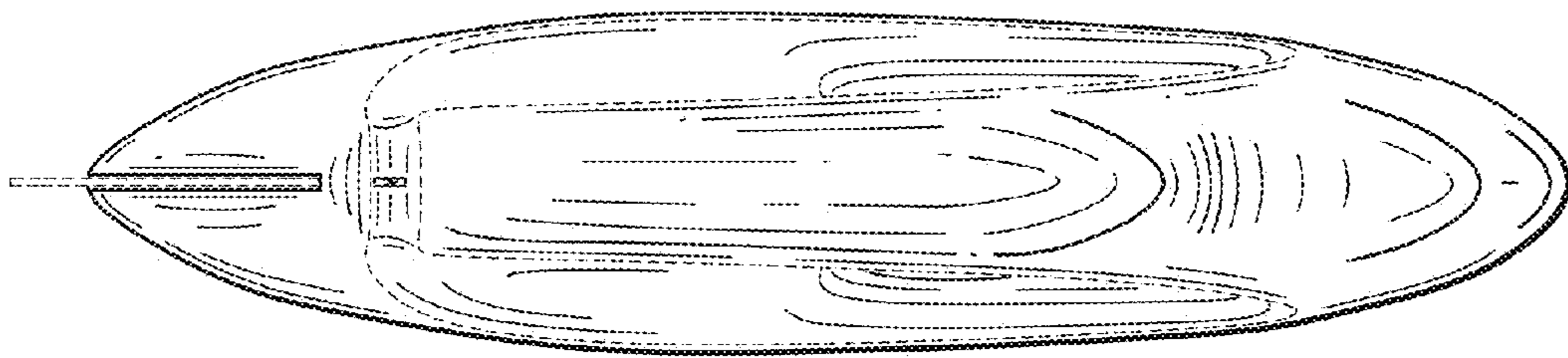

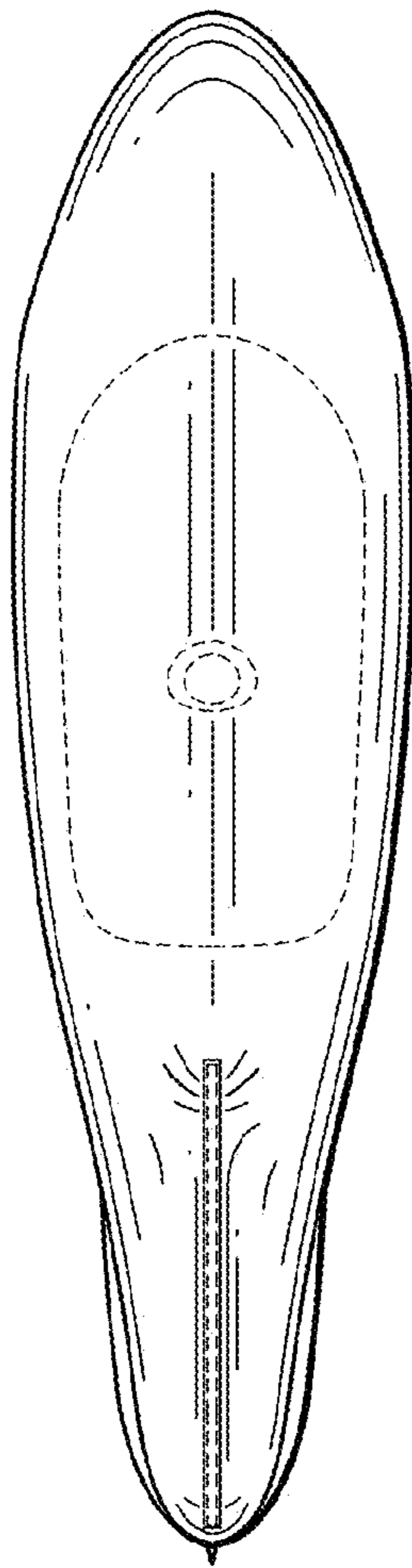

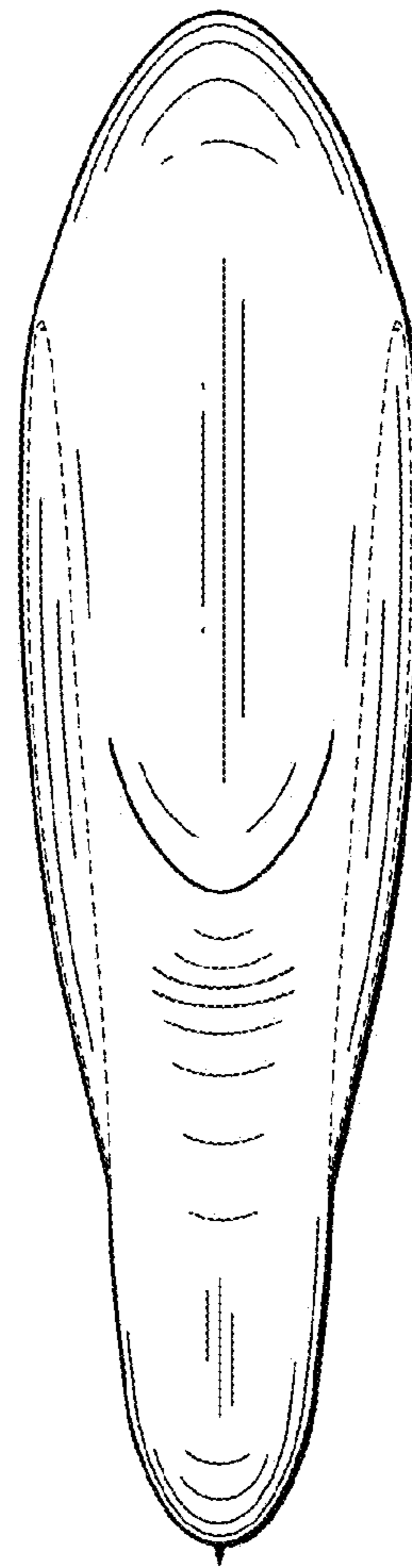
