(57) **CLAIM**

The ornamental design for a pair of shower rod end caps, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a pair of shower rod end caps in accordance with a preferred embodiment of my design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

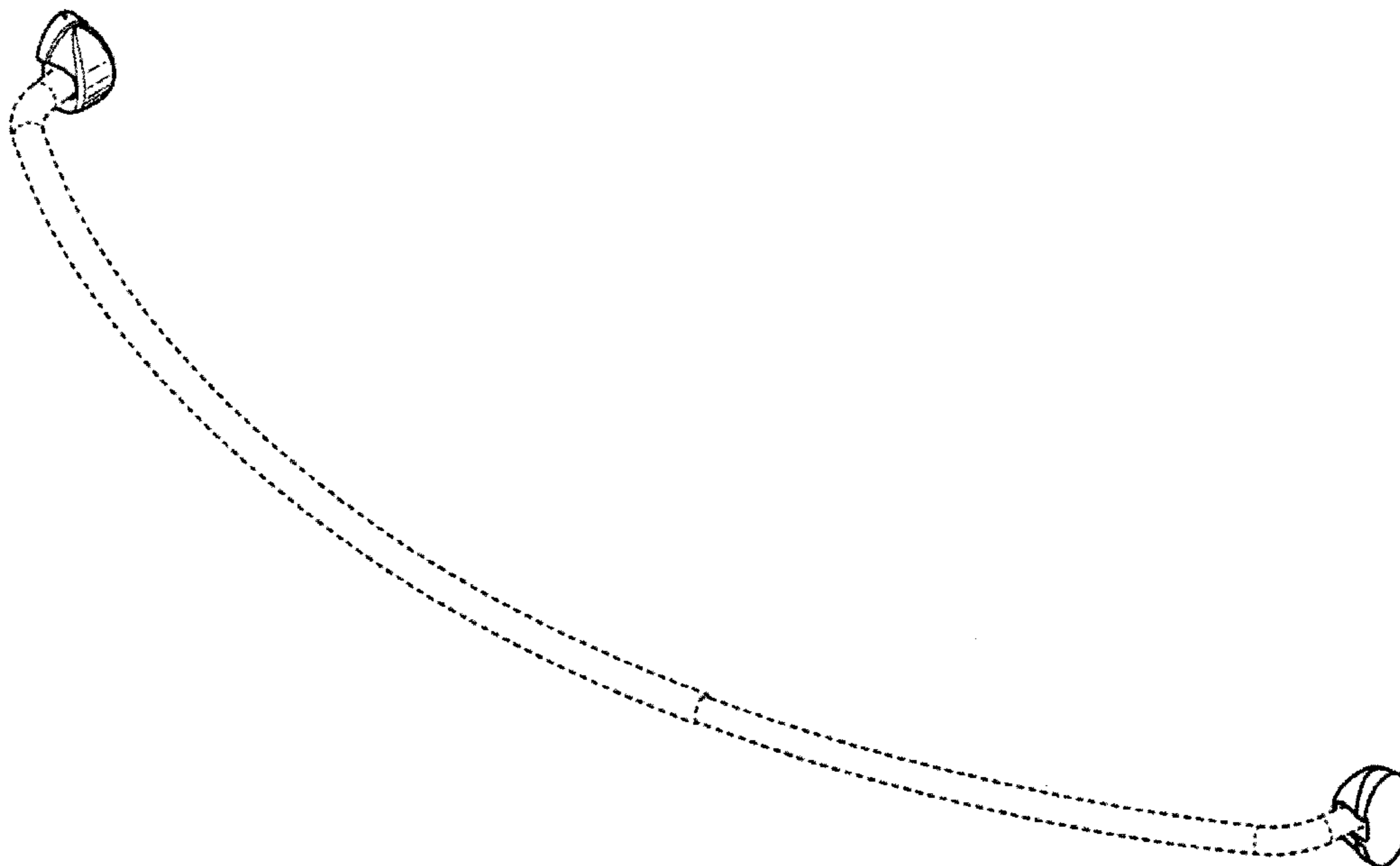
FIG. 6 is a left side elevational view thereof;

FIG. 7 is a right side elevational view thereof; and,

FIG. 8 is a greatly enlarged perspective view of an endcap of the pair of curtain rod end caps in accordance with the preferred embodiment of my design.

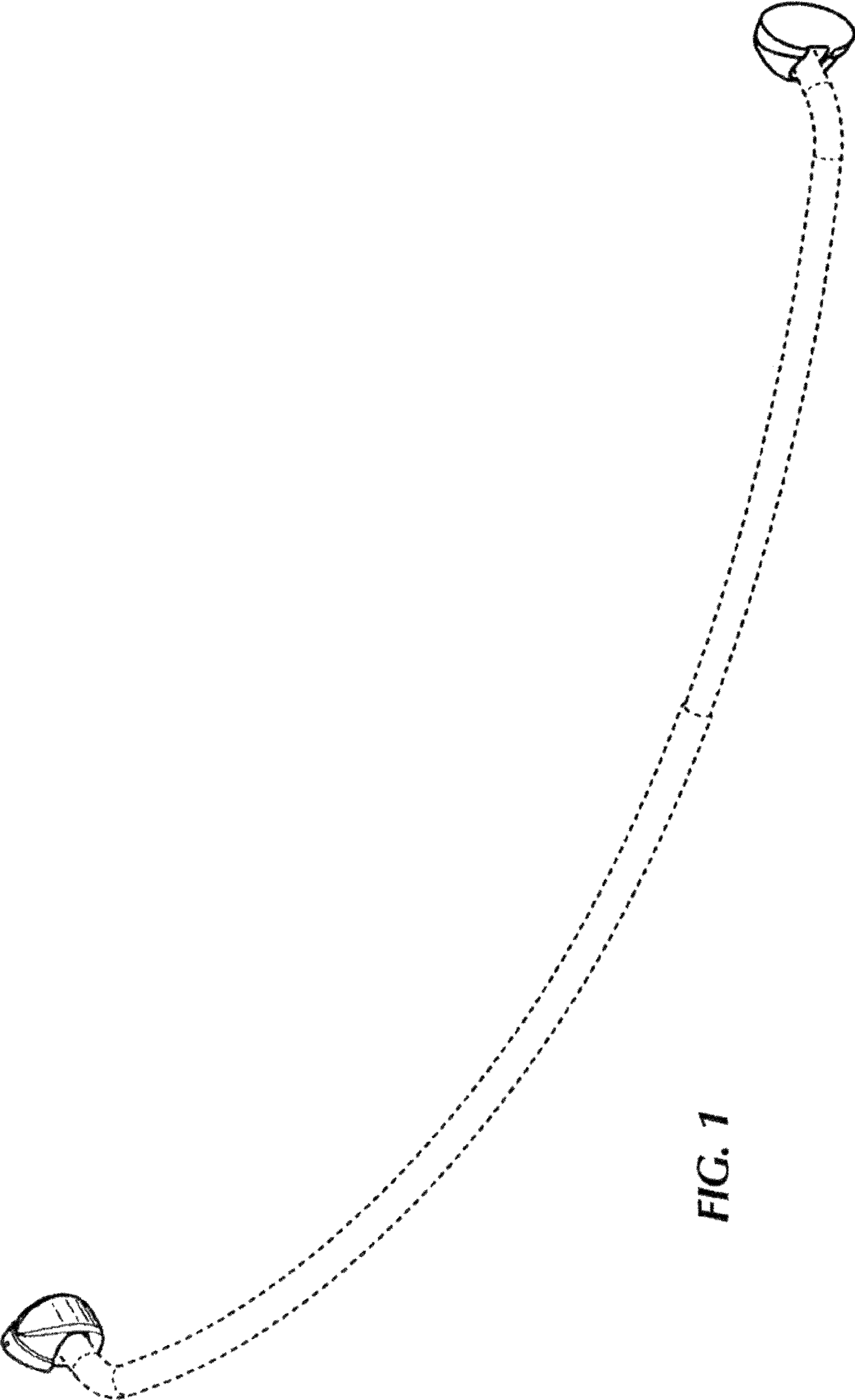

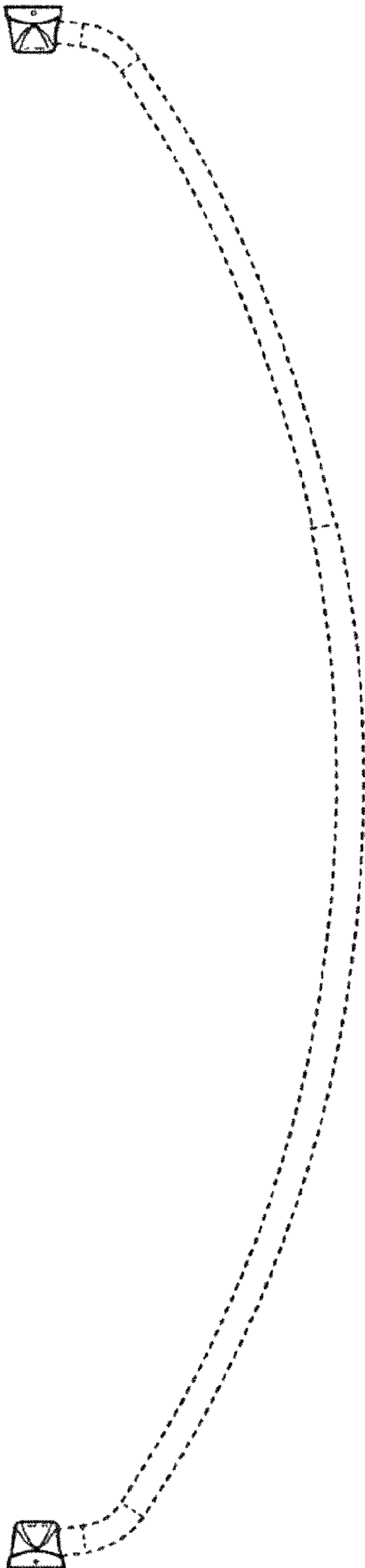

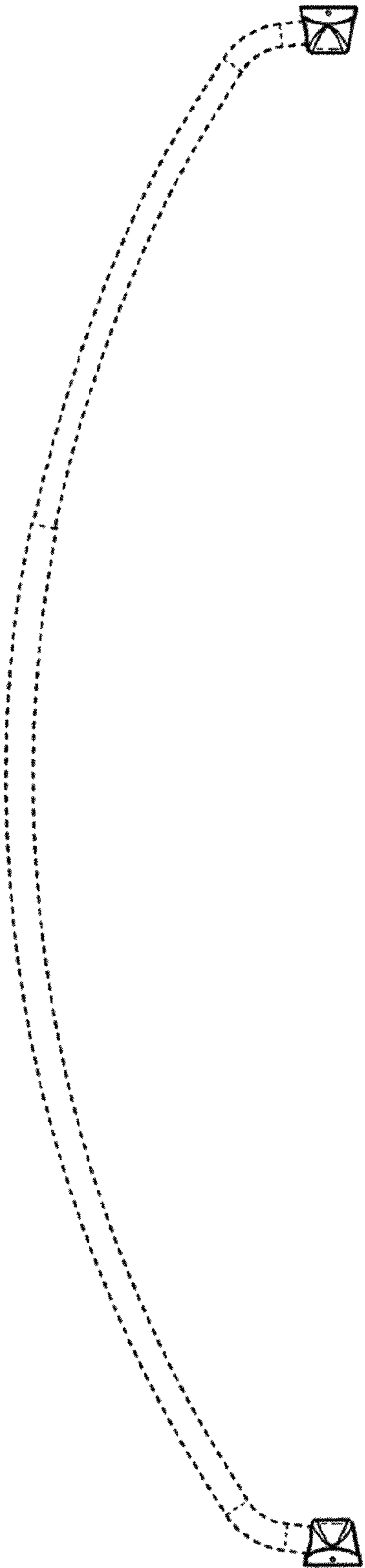

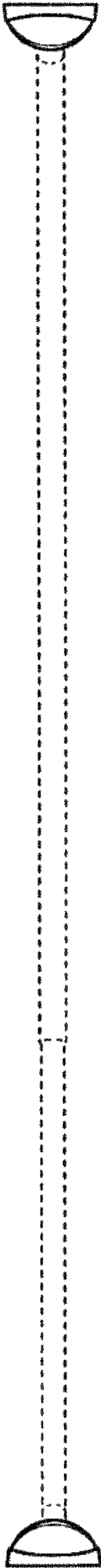

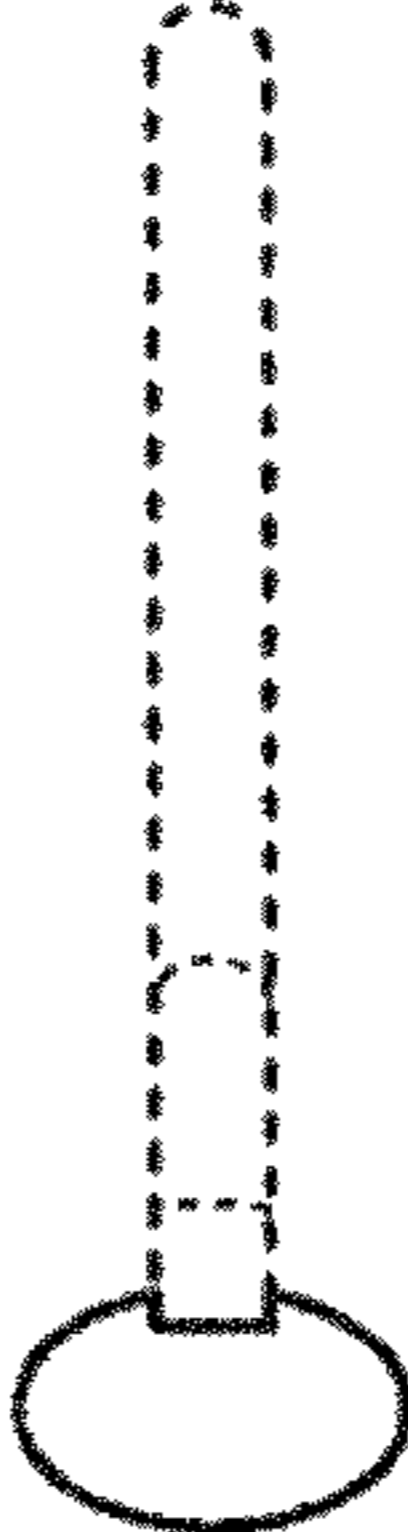

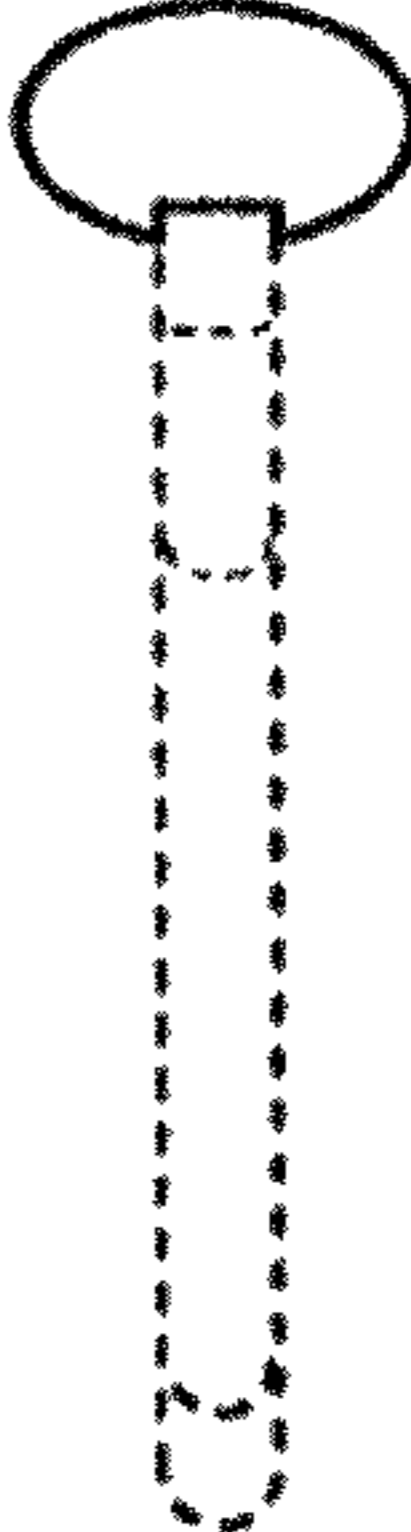

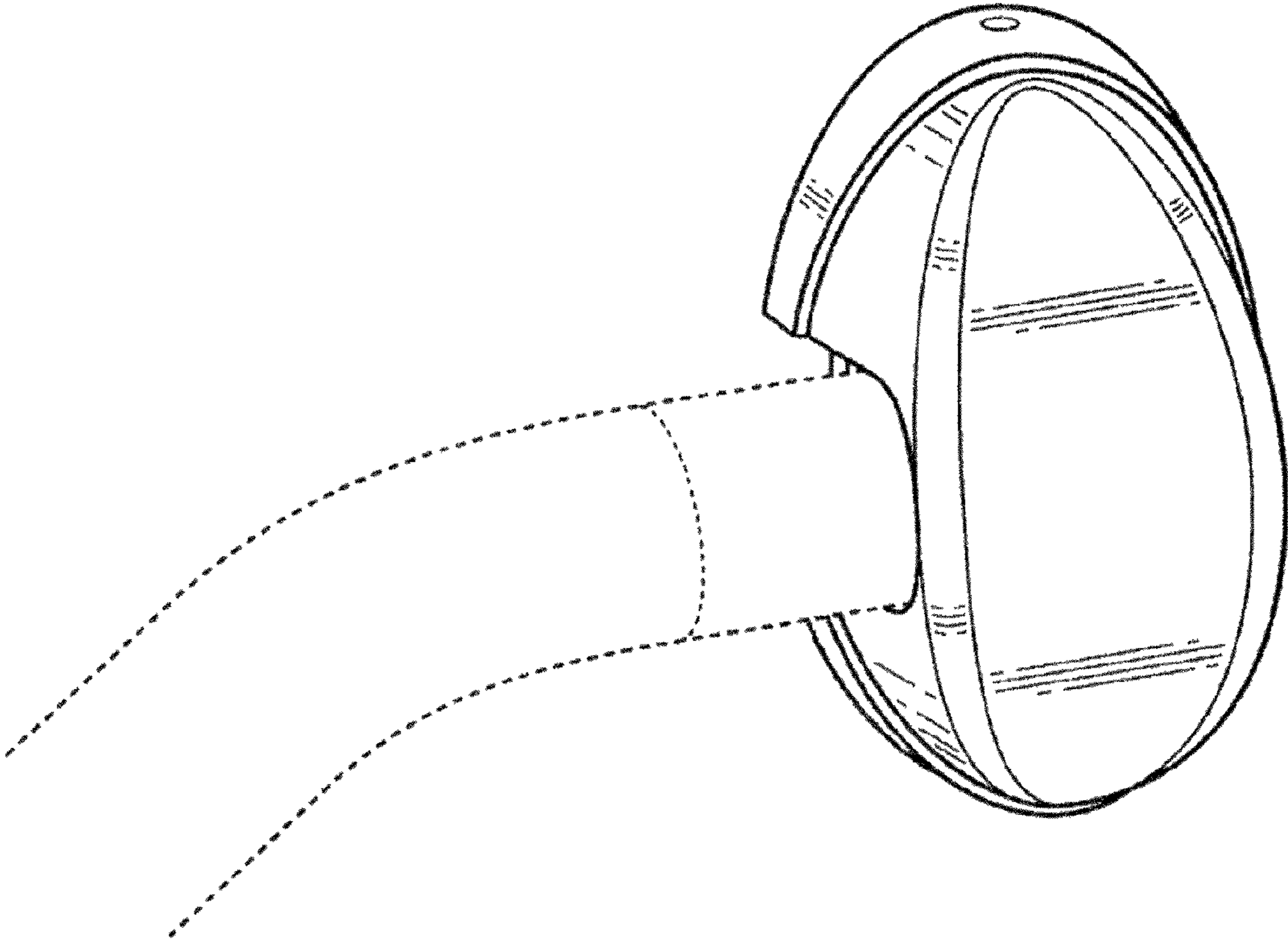
