(57) **CLAIM**

The ornamental design for a rectangular hinged food container, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of a hinged food container showing my new design in a closed configuration.

FIG. 2 is a top plan view of the hinged food container of FIG. 1.

FIG. 3 is a bottom plan view of the hinged container of FIG. 1.

FIG. 4 is a front elevational view of the hinged container of FIG. 1.

FIG. 5 is a rear elevational view of the hinged container of FIG. 1.

FIG. 6 is a left side elevational view of the hinged container of FIG. 1. The right side elevational view is a mirror image of the left side elevational view of the hinged container.

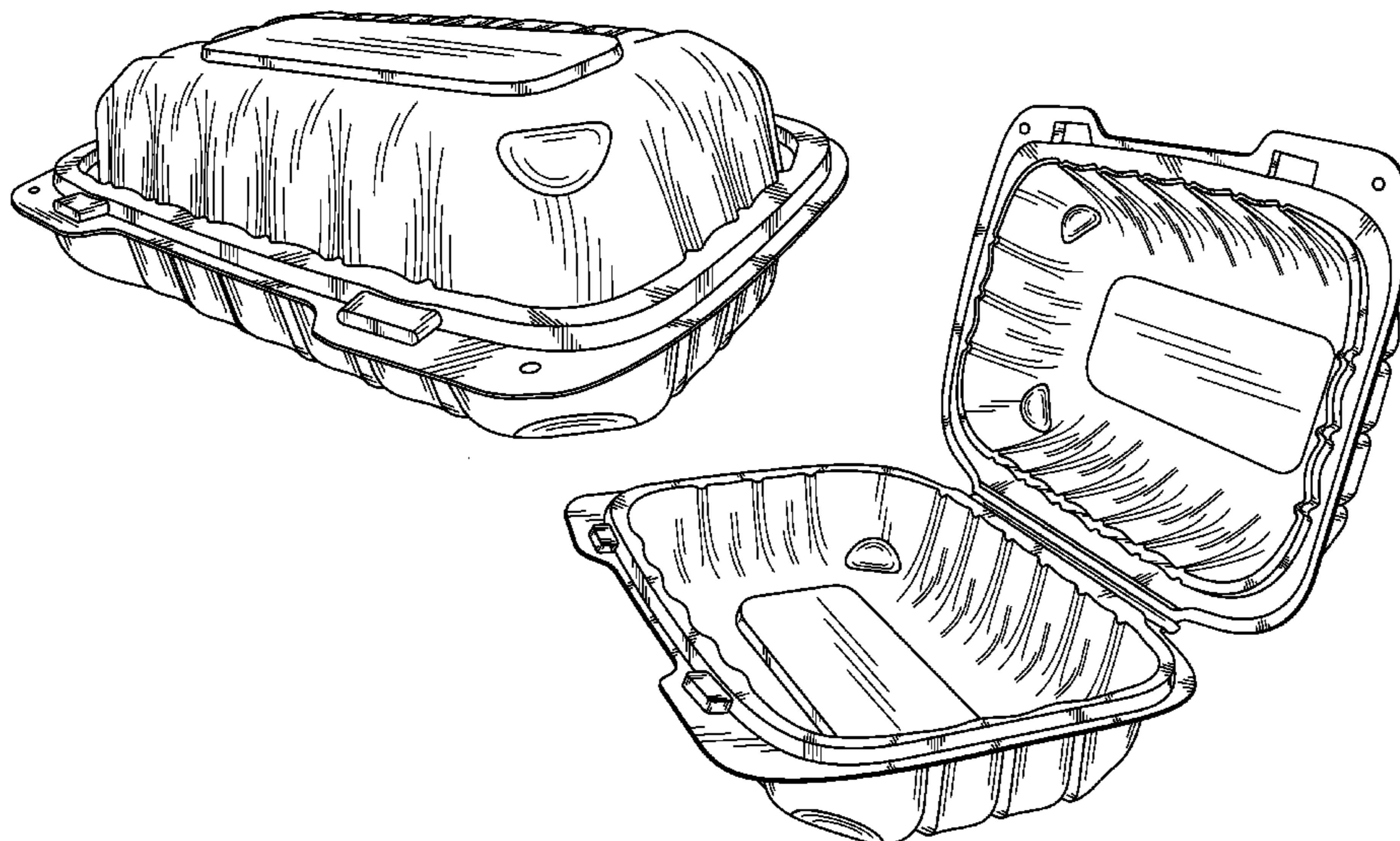
FIG. 7 is a side perspective view of a hinged container in an open configuration.

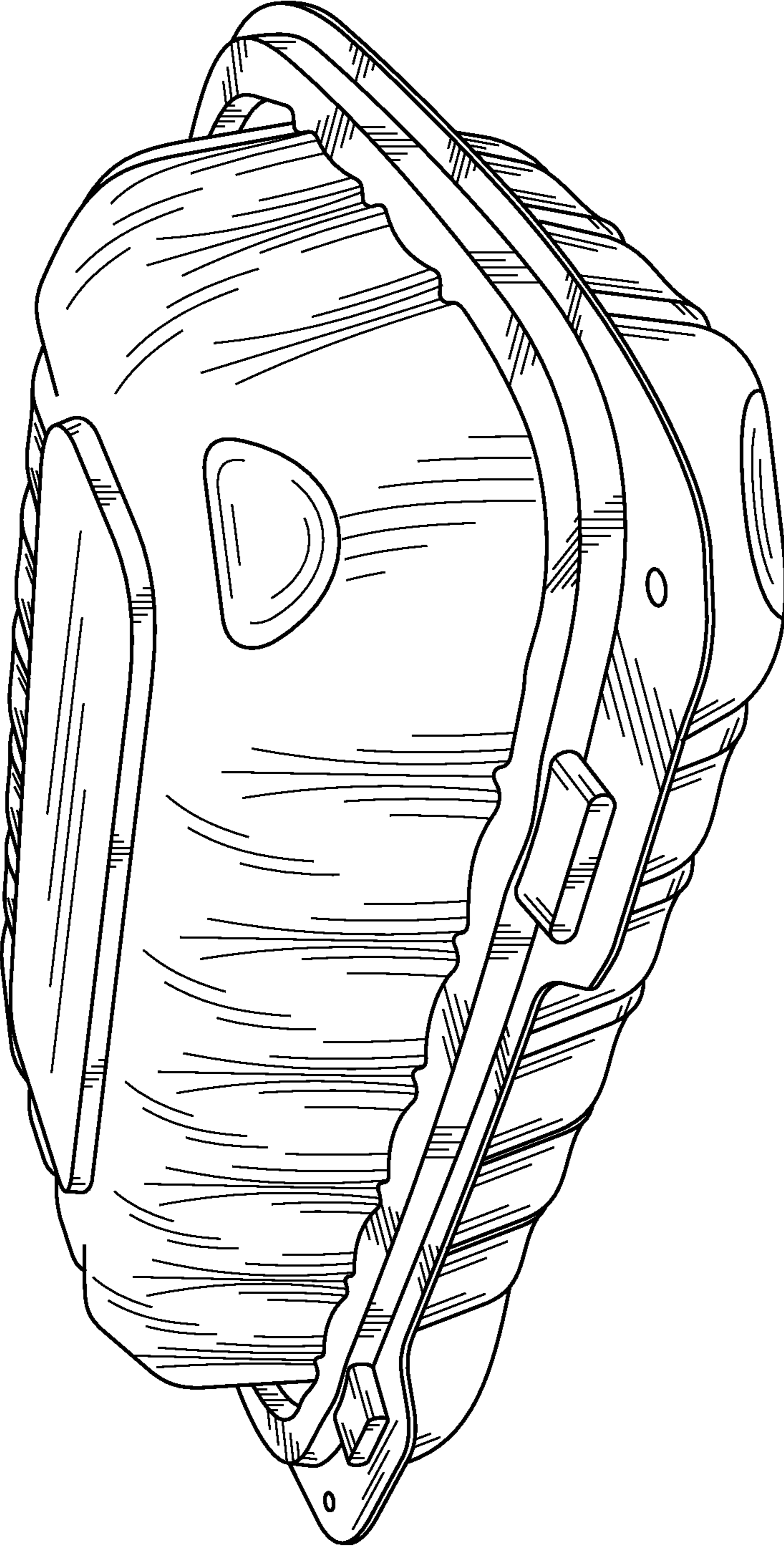

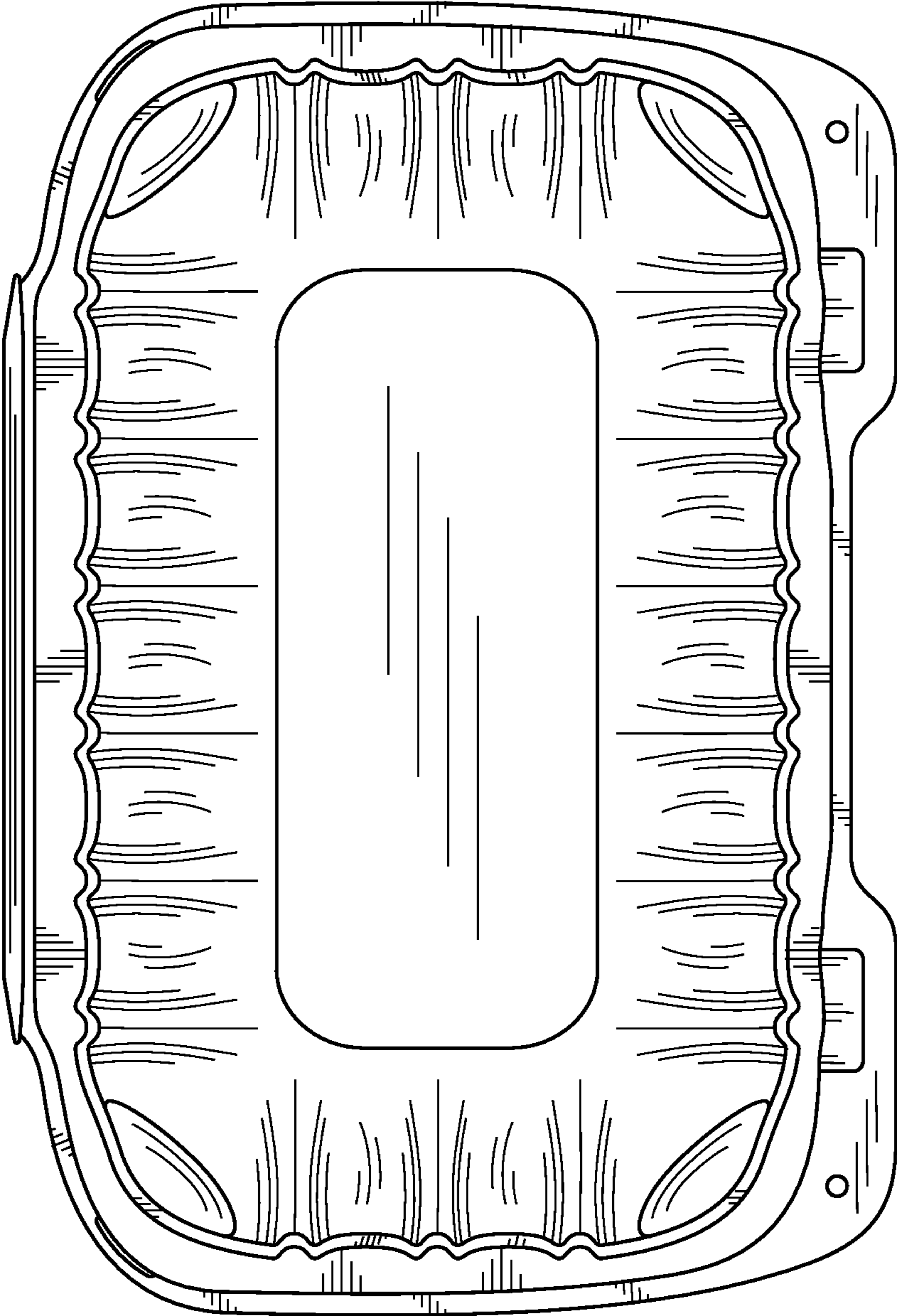

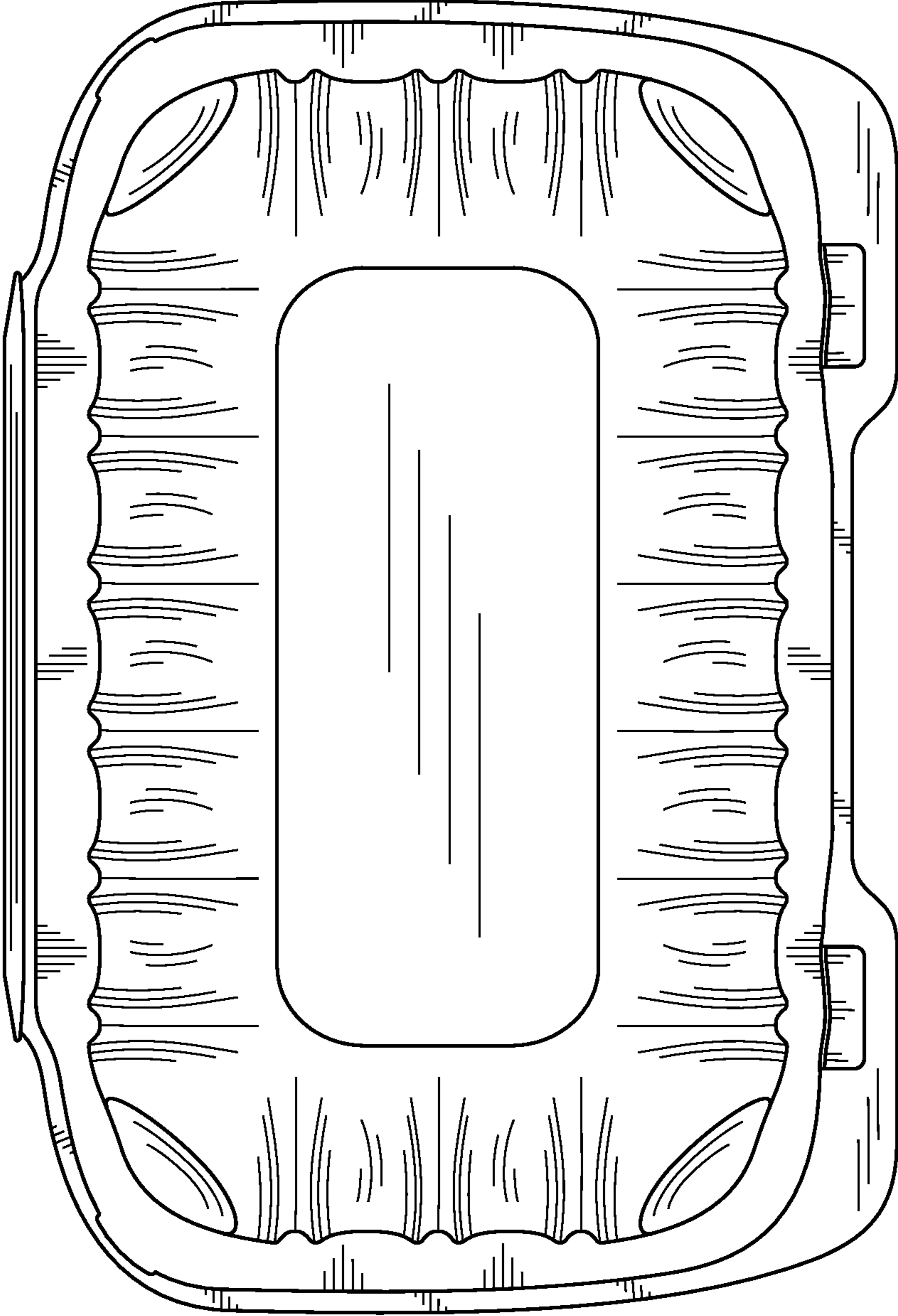

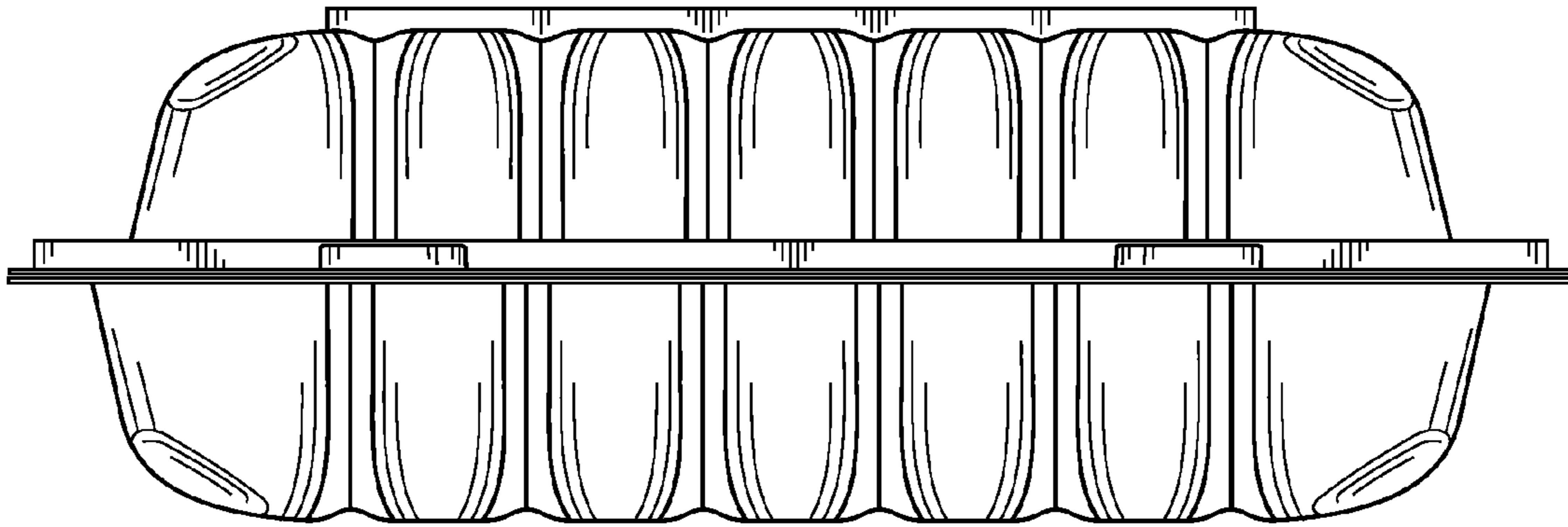

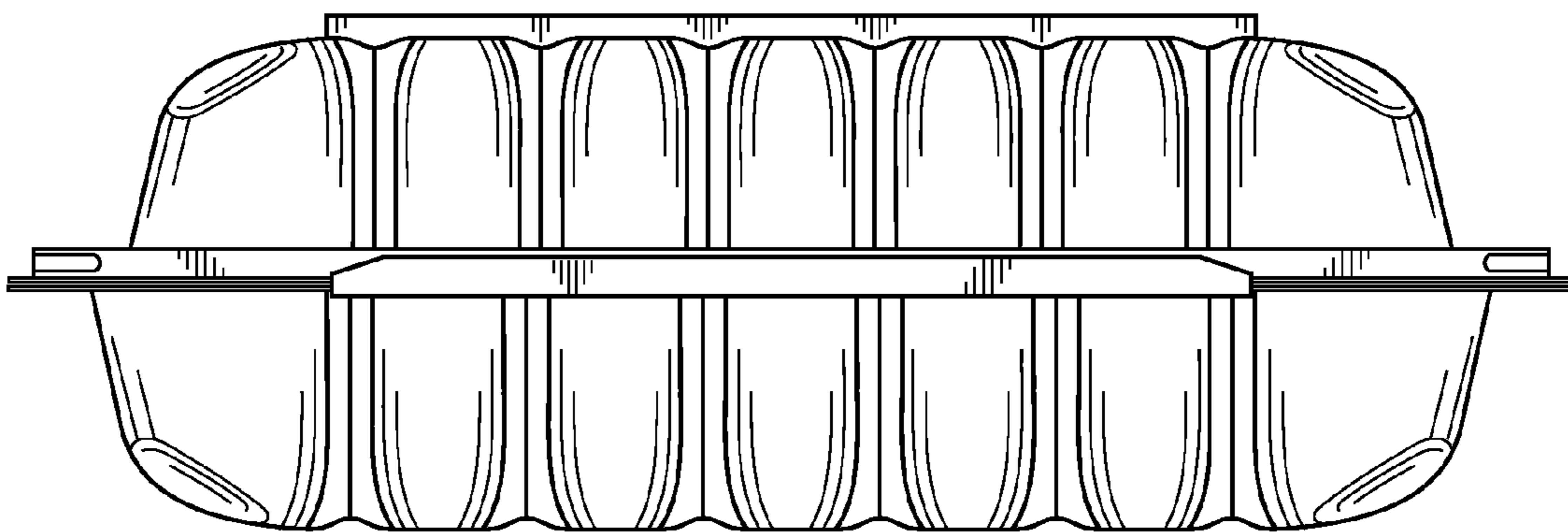

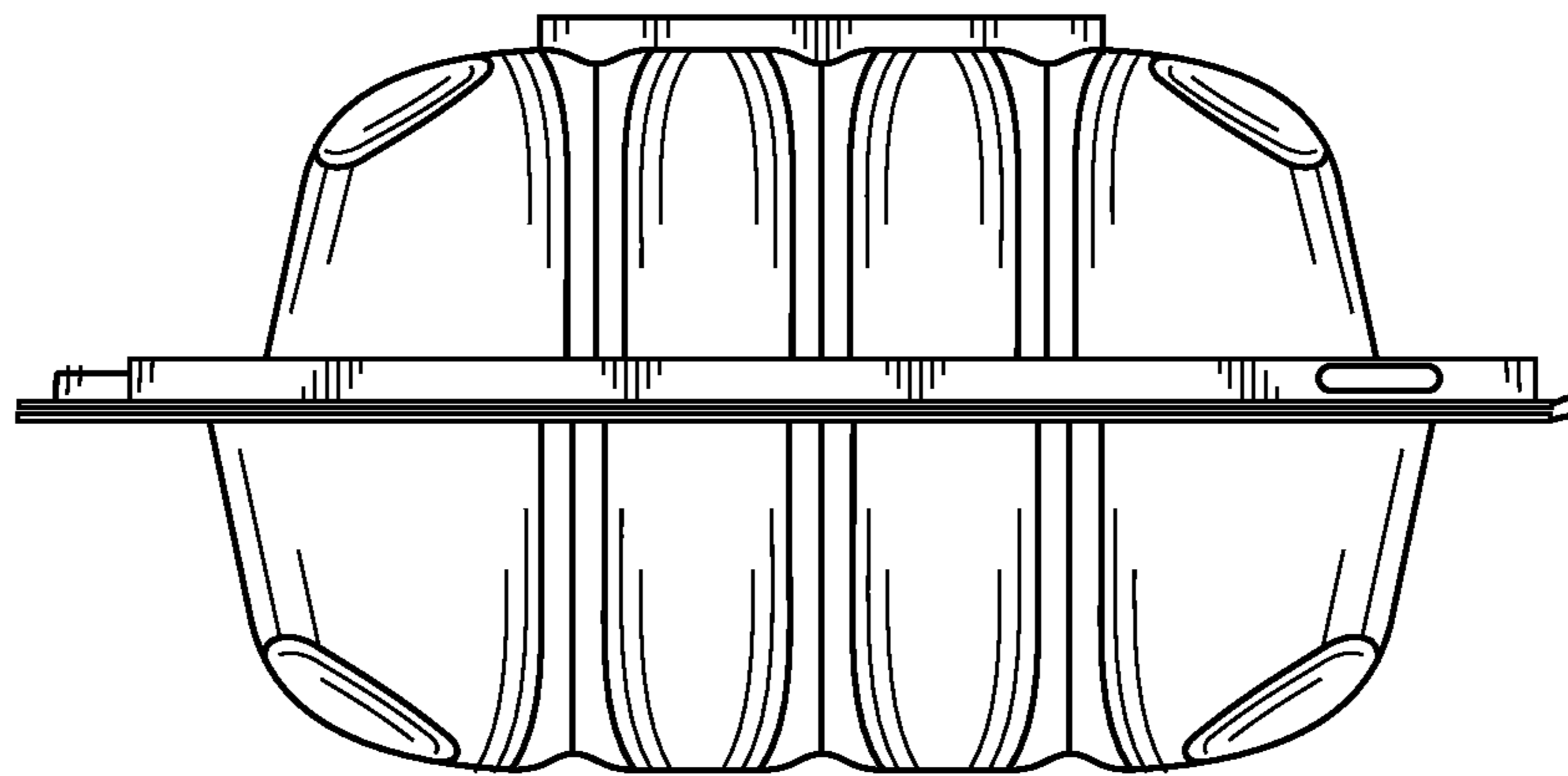

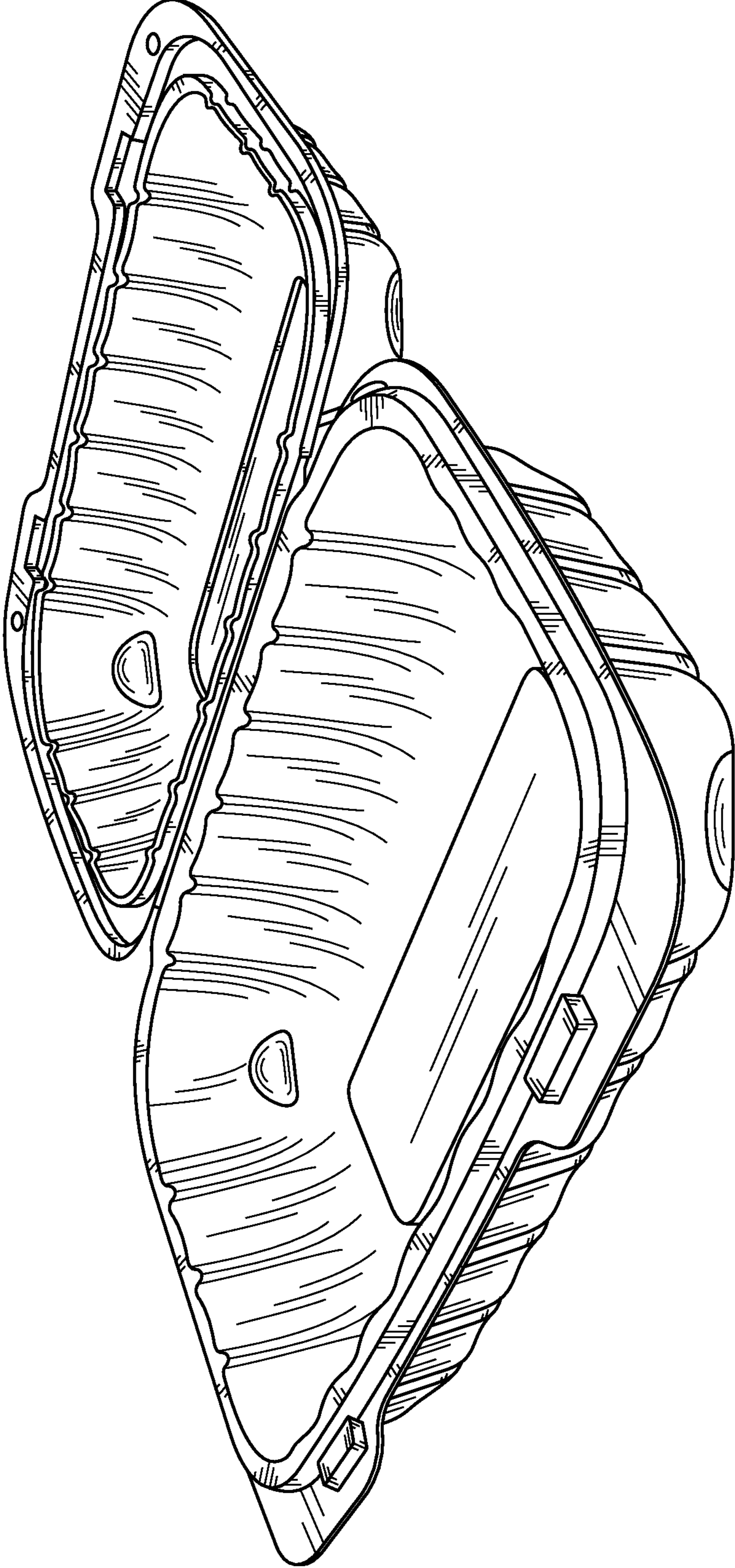

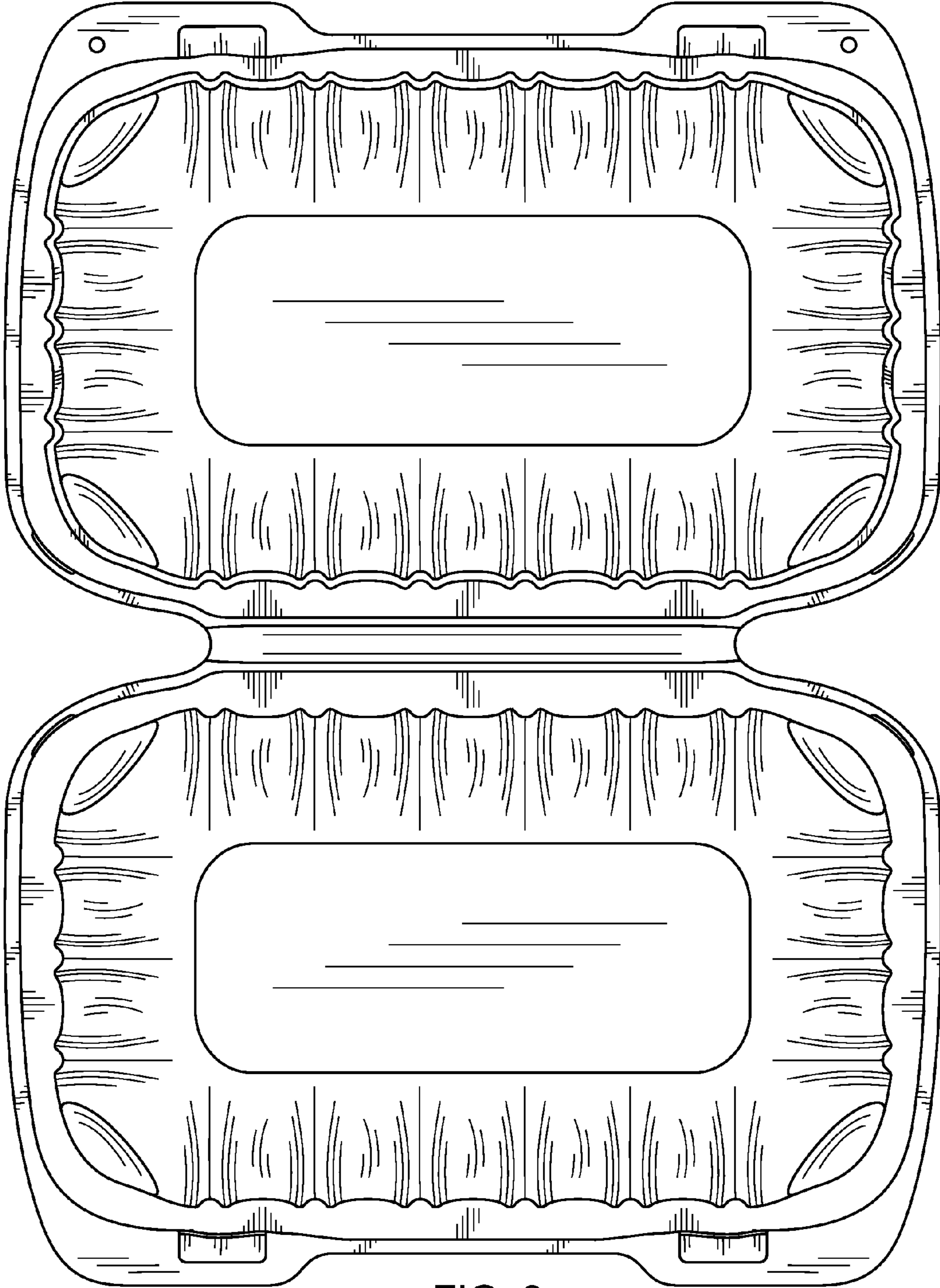

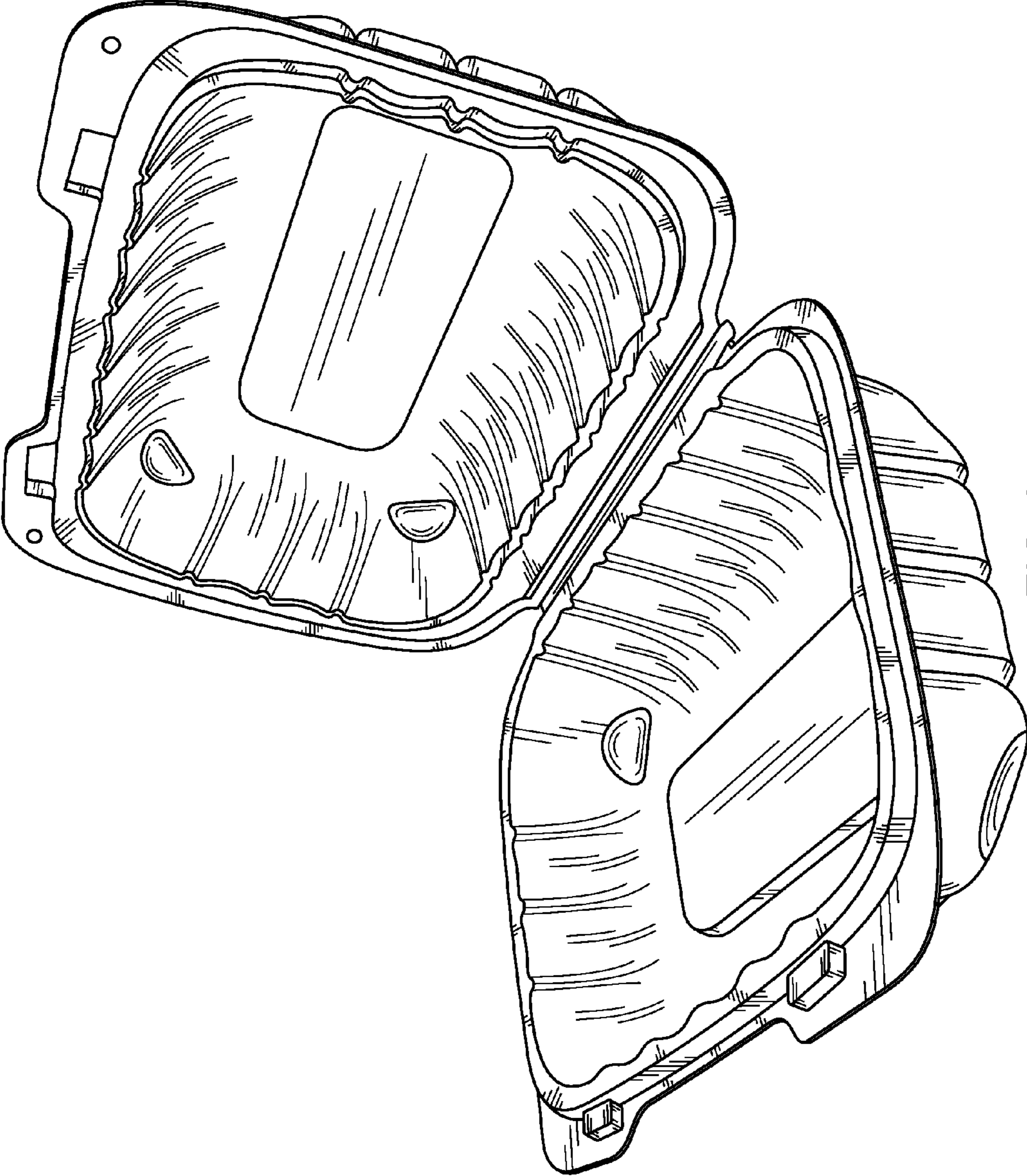

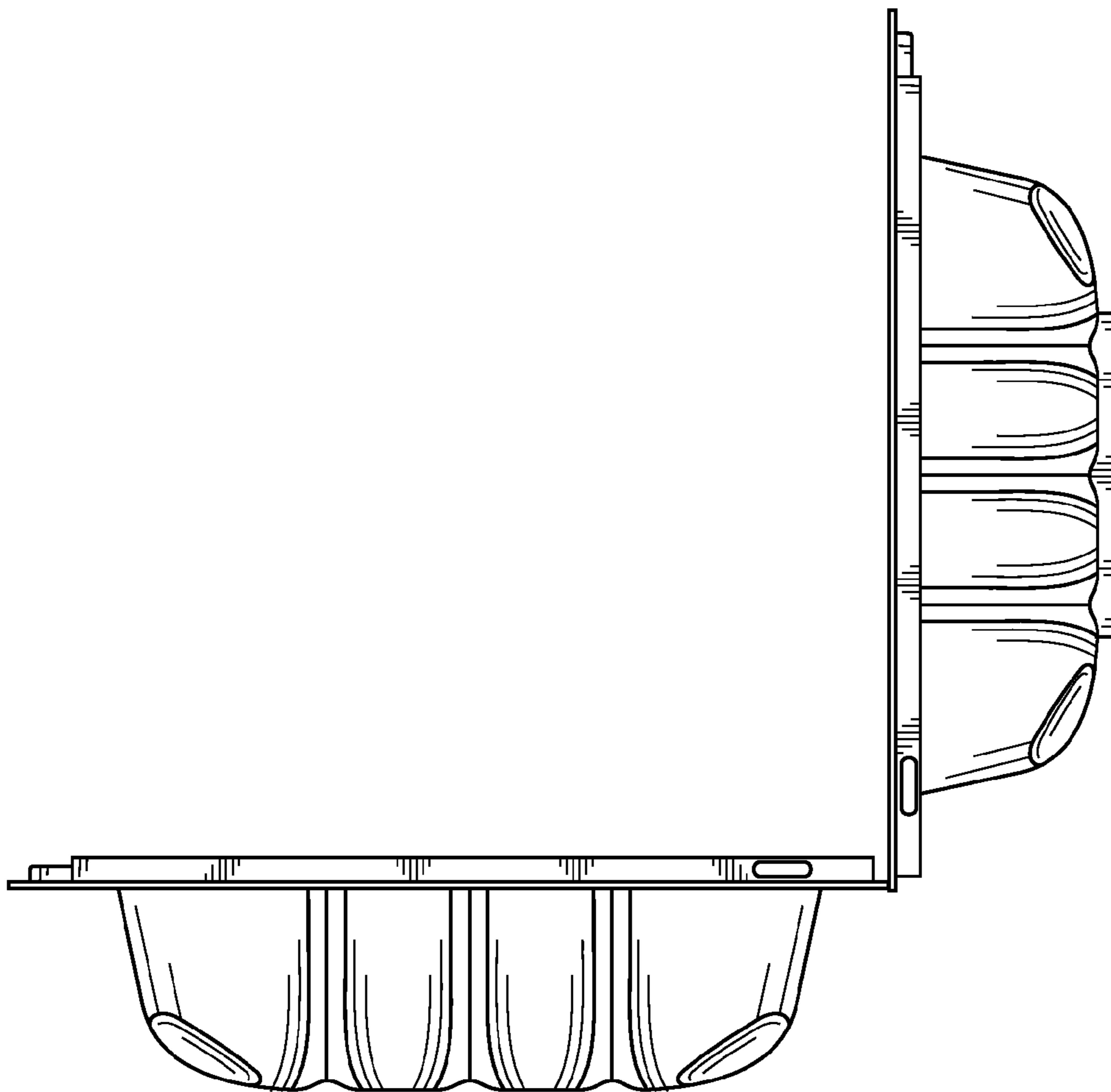
