planar.

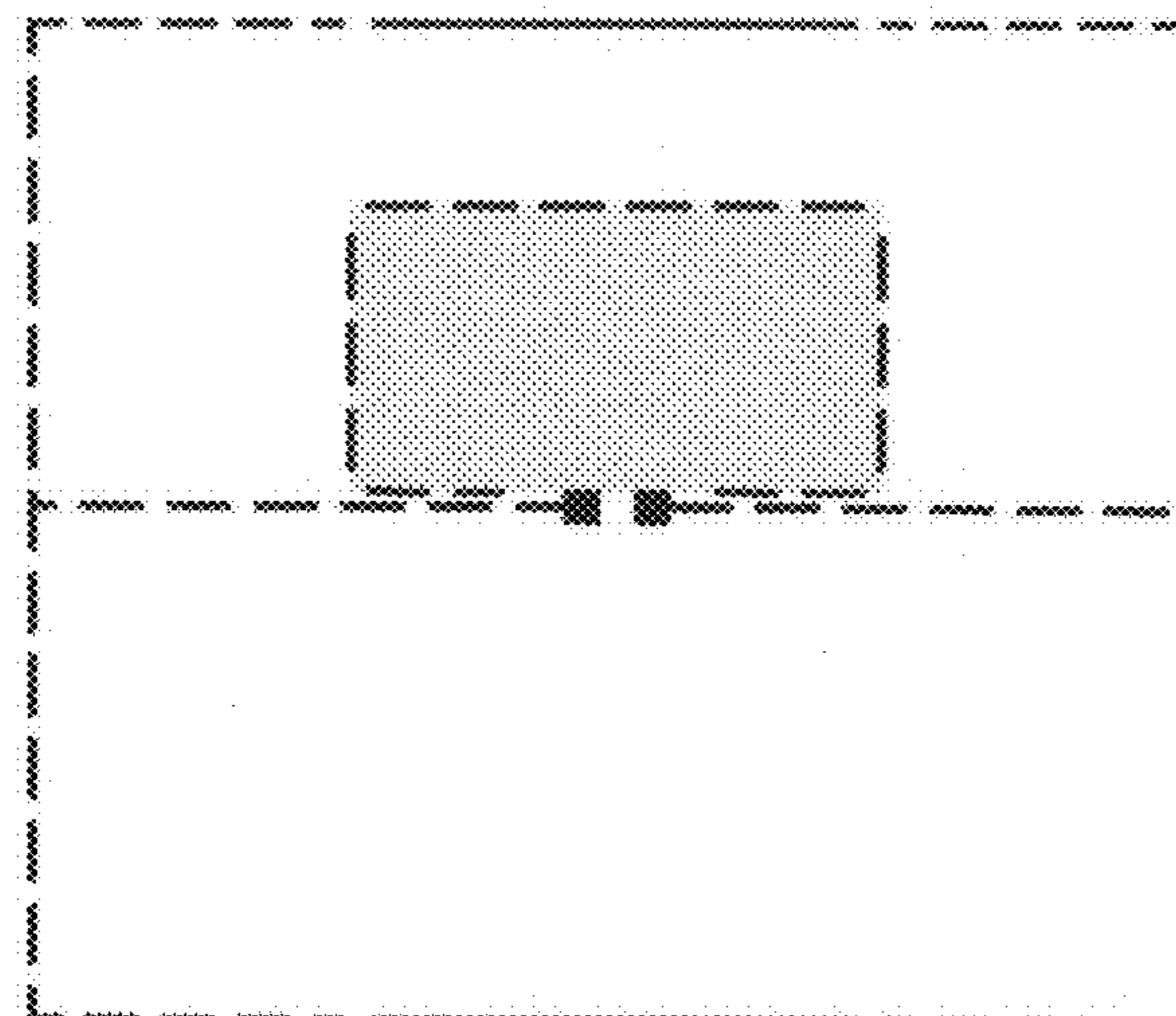

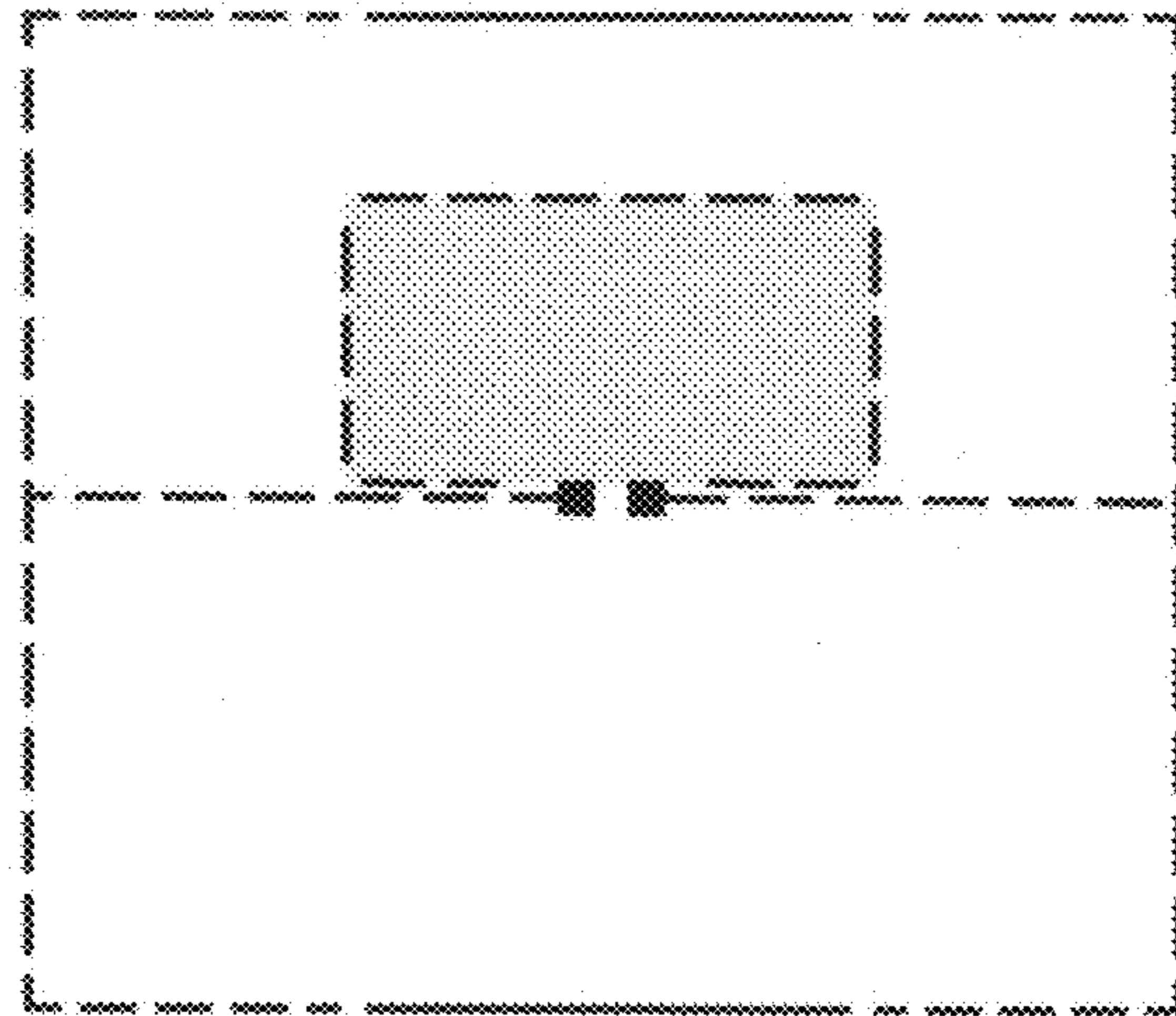

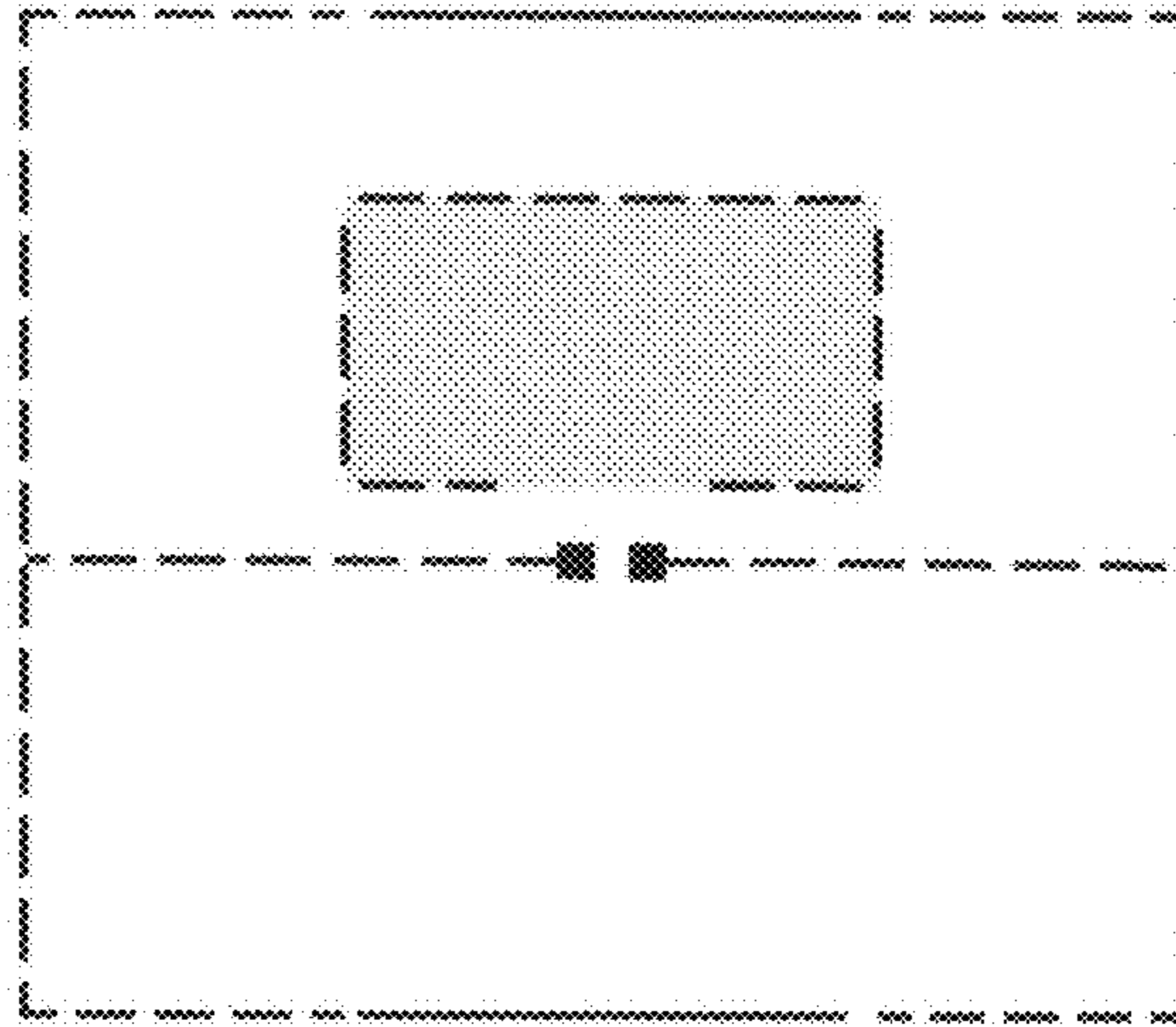
