FIG. 2 is a rear elevational view thereof;

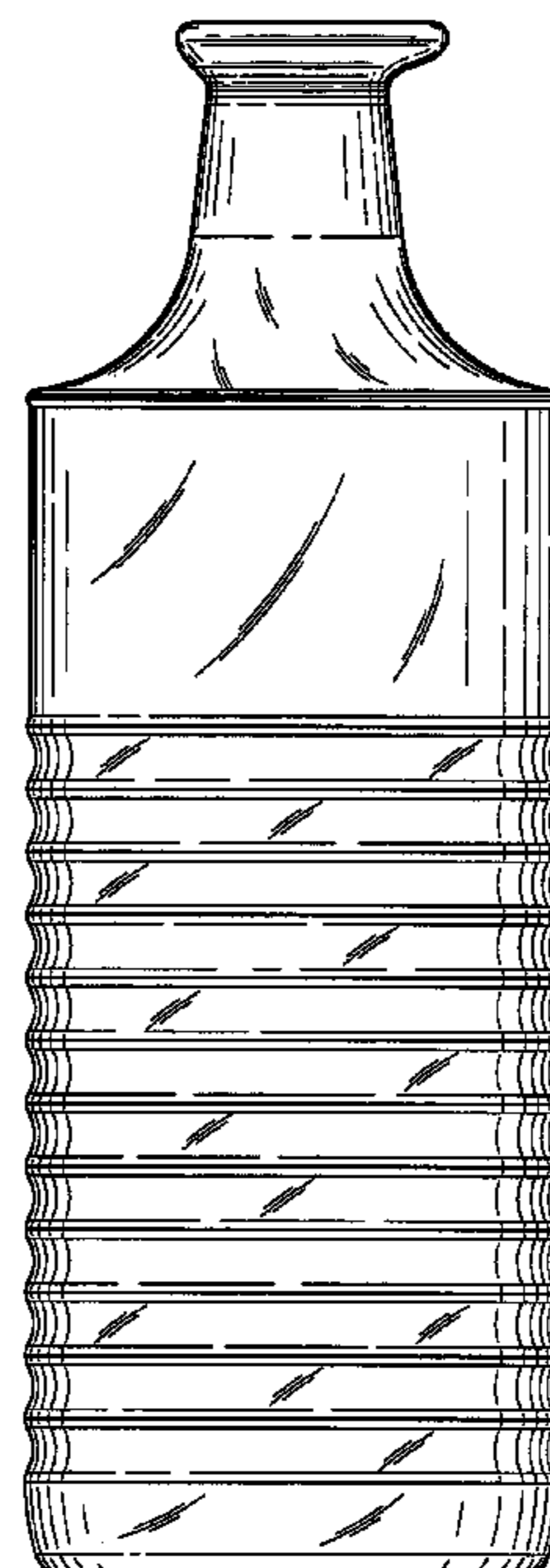
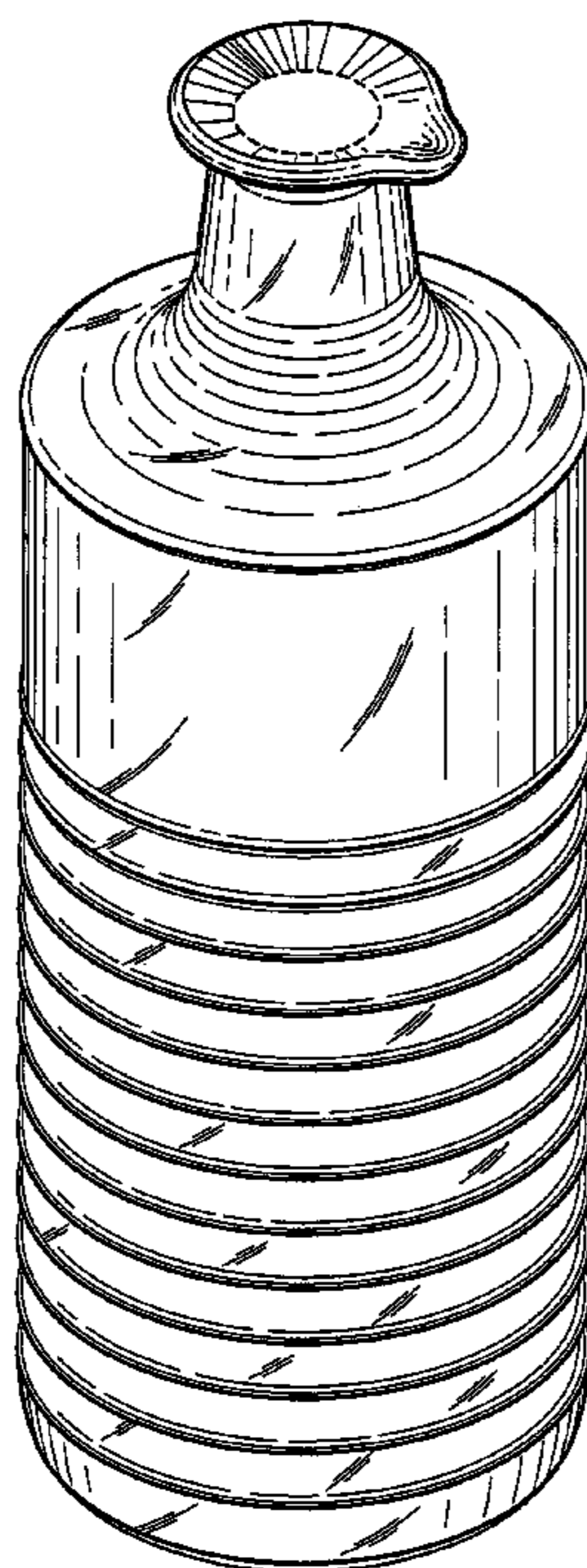
FIG. 3 is a front elevational view thereof;

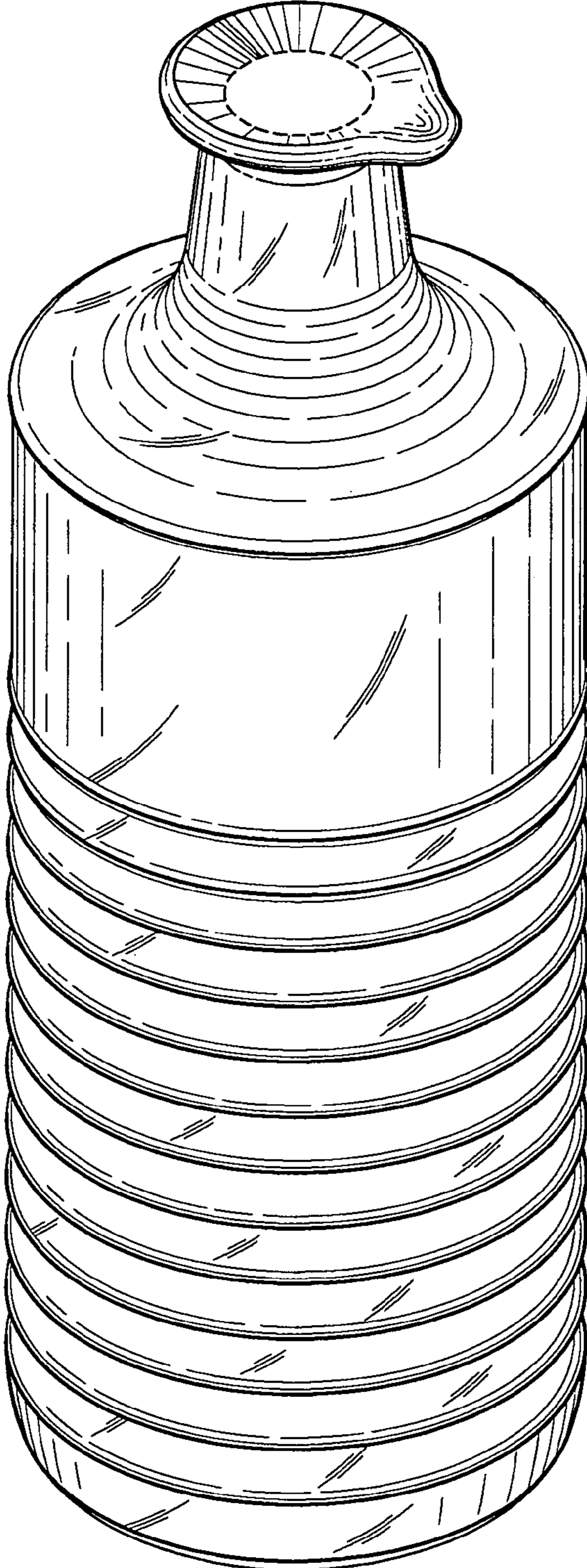
FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image; and,

FIG. 5 is a top plan view thereof.

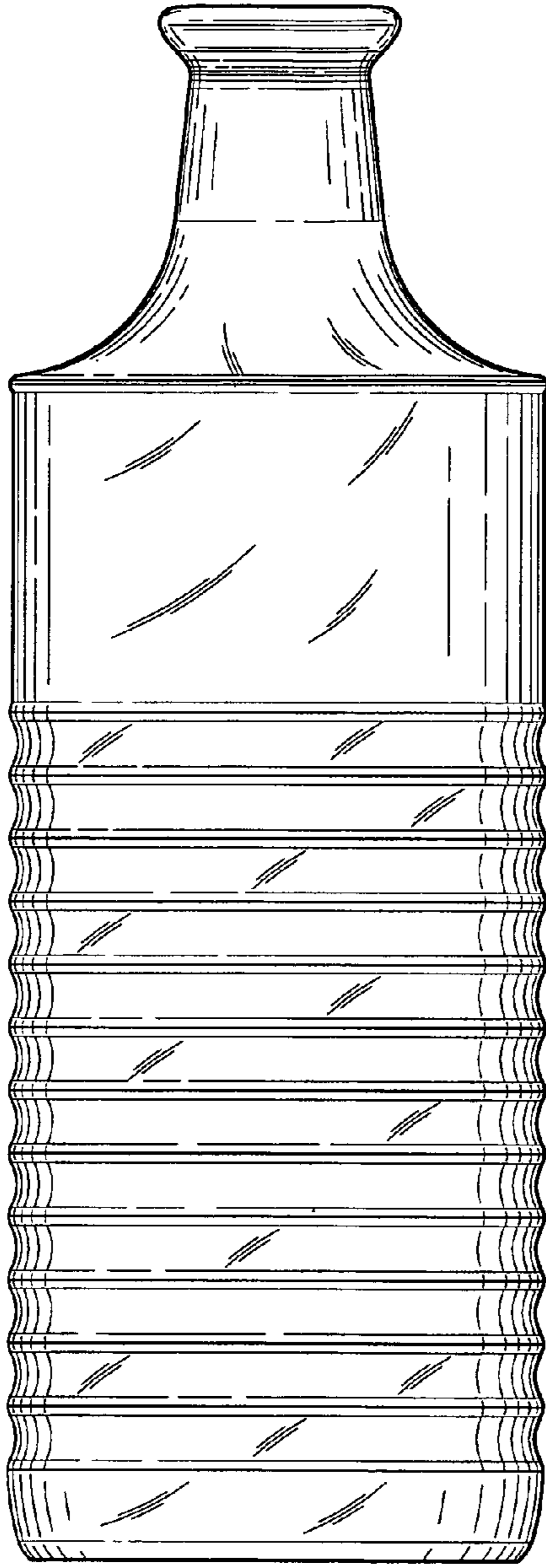
The broken line showing of the inner edge of the pour spout opening is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

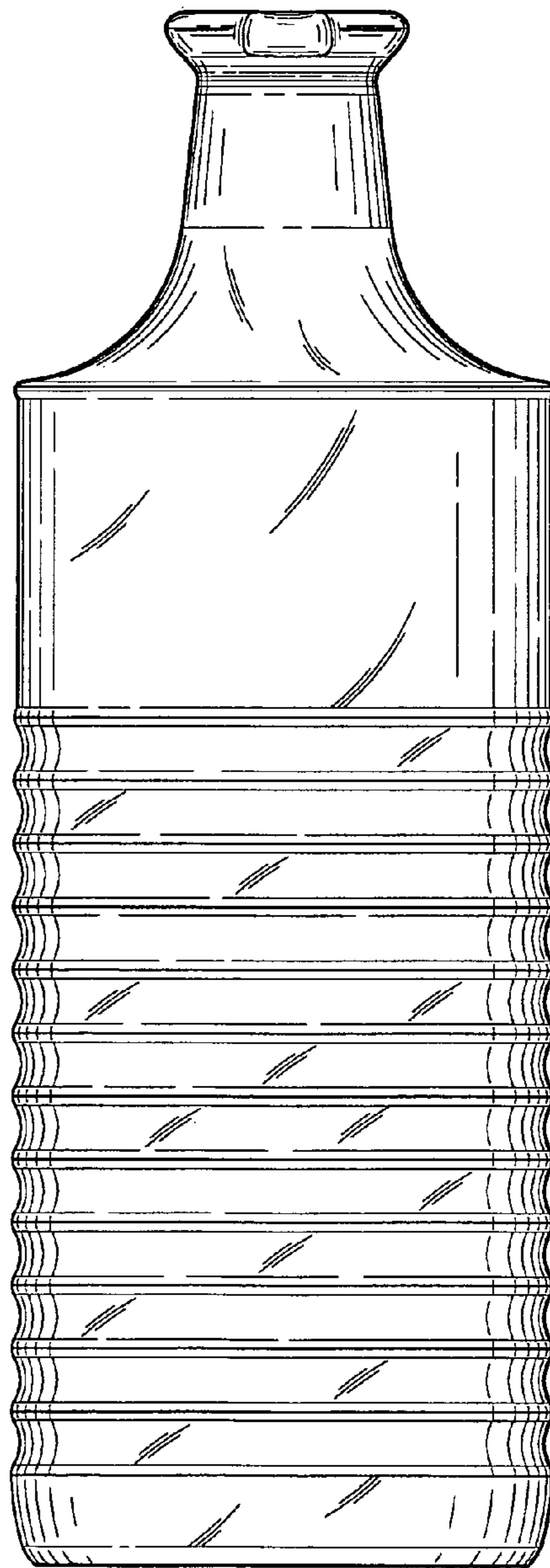




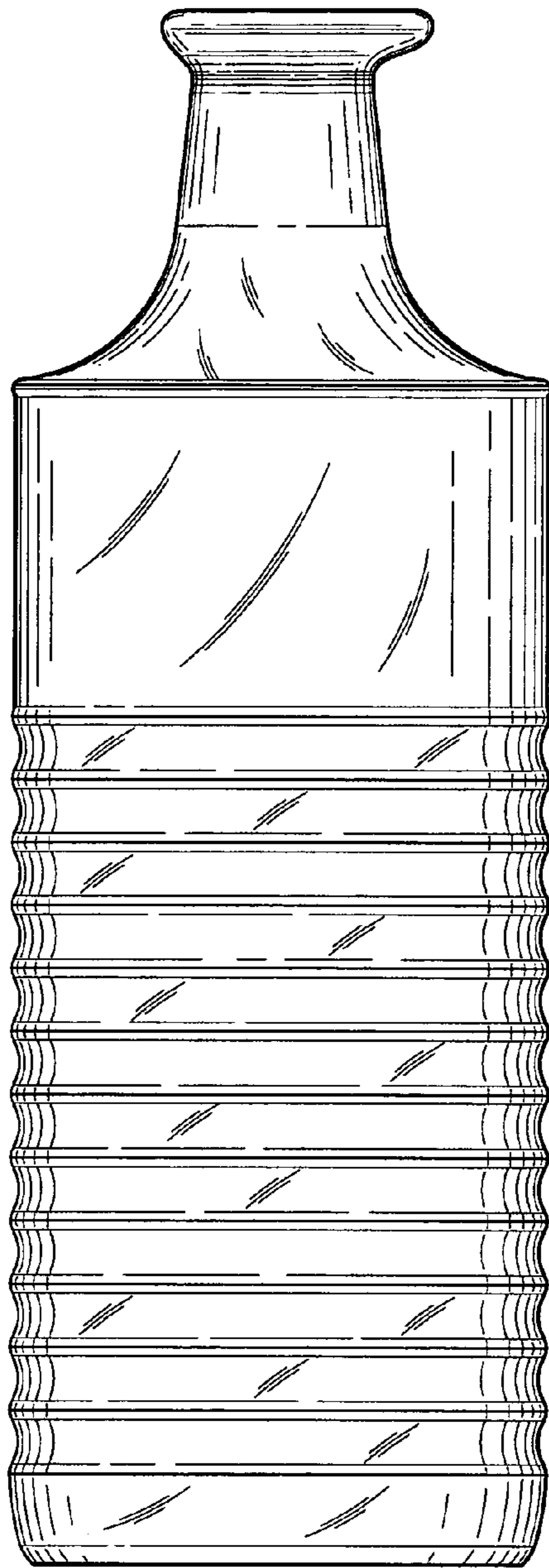

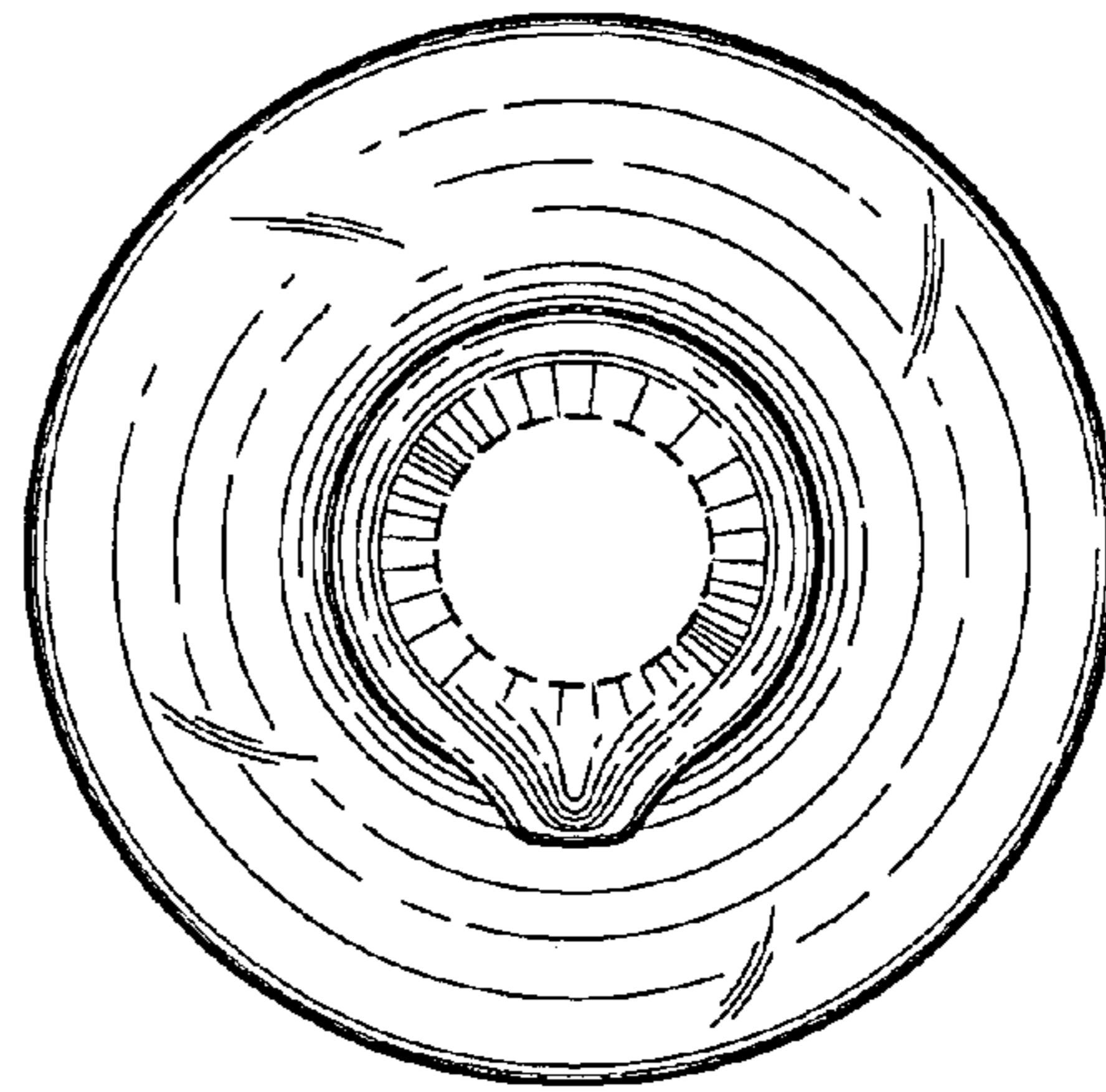
