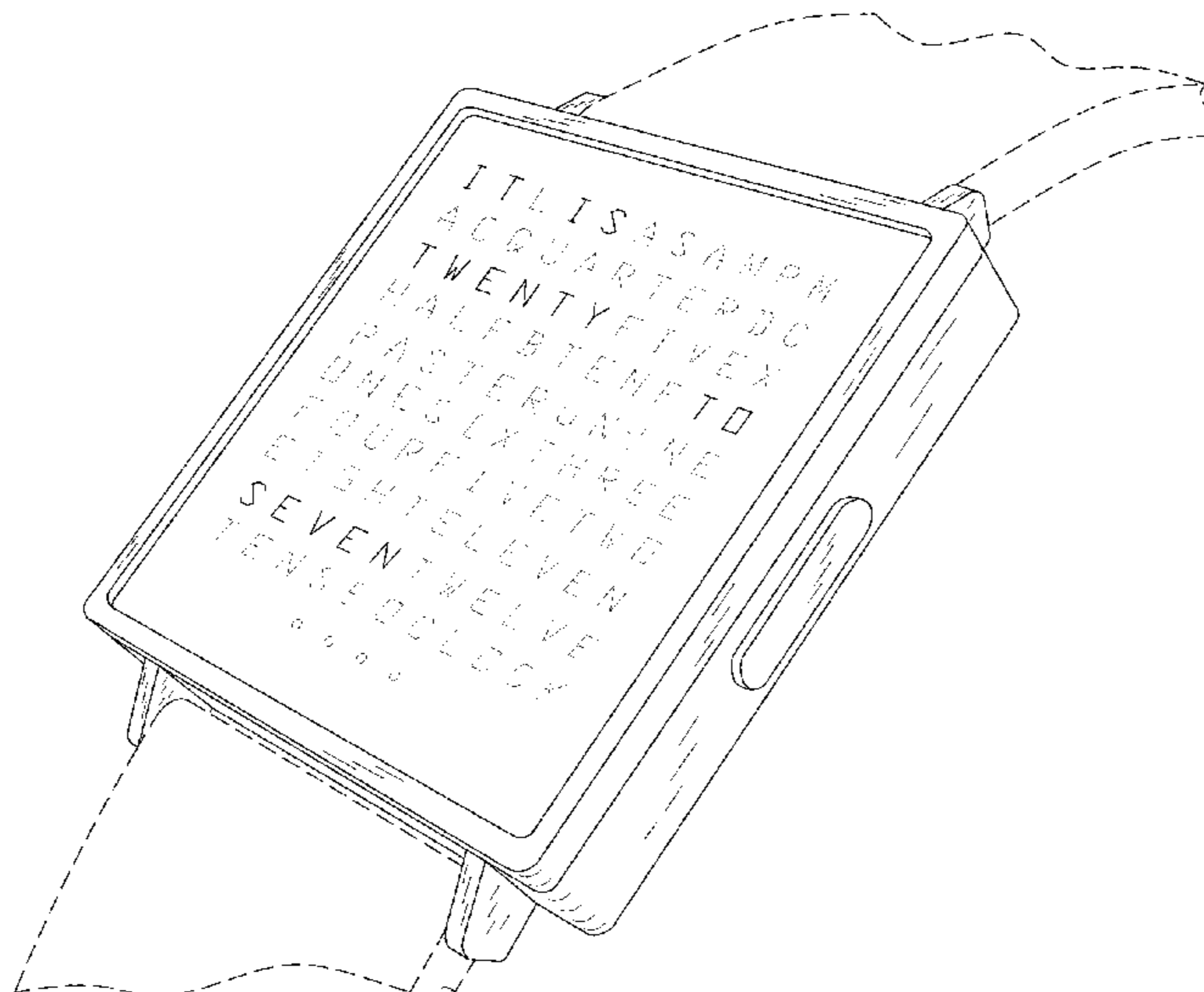
We claim the ornamental design for a watch, as shown and described.
