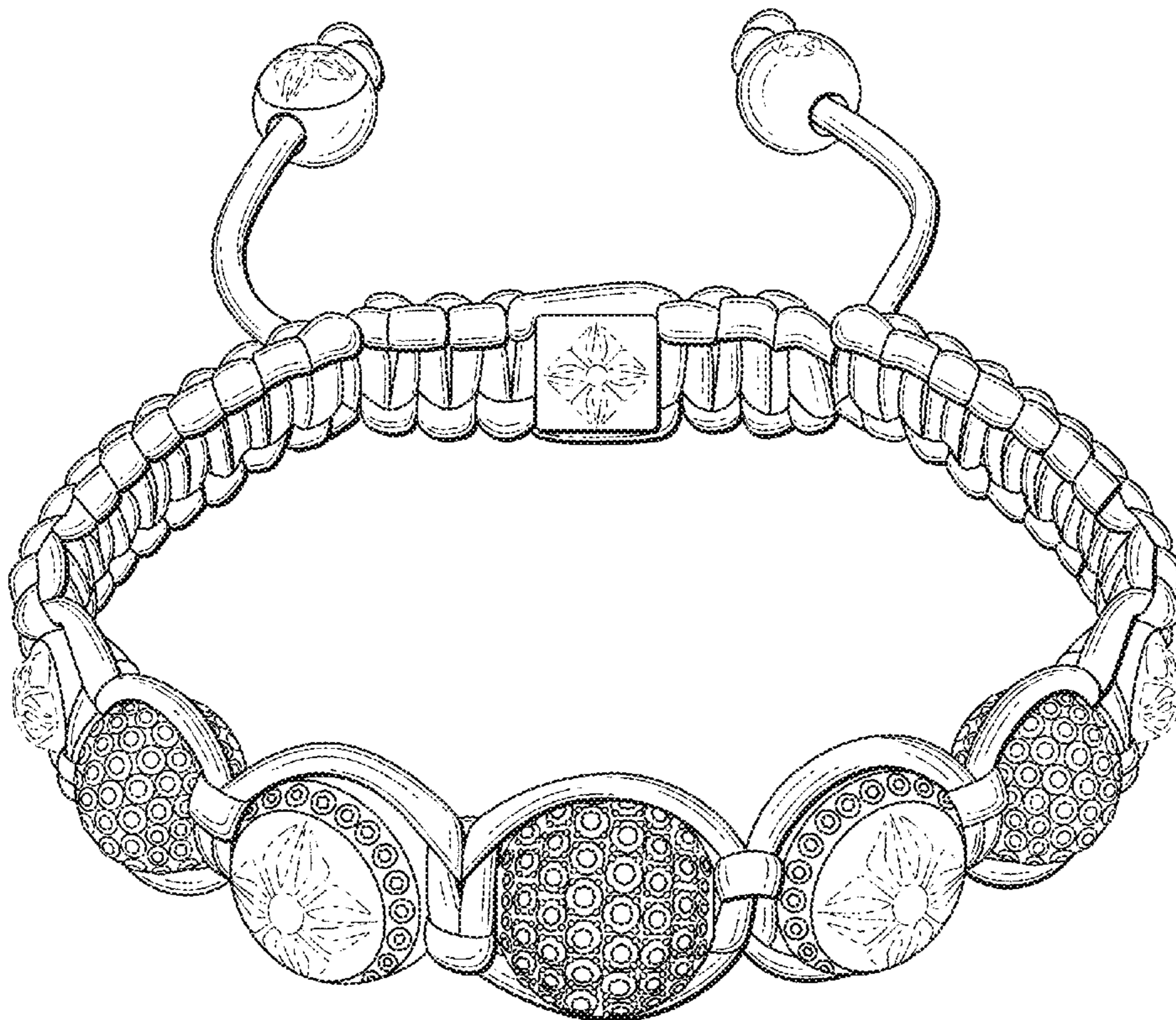
(57) **CLAIM**

The ornamental design for a macramé bracelet with a lock, as shown and described.

DESCRIPTION

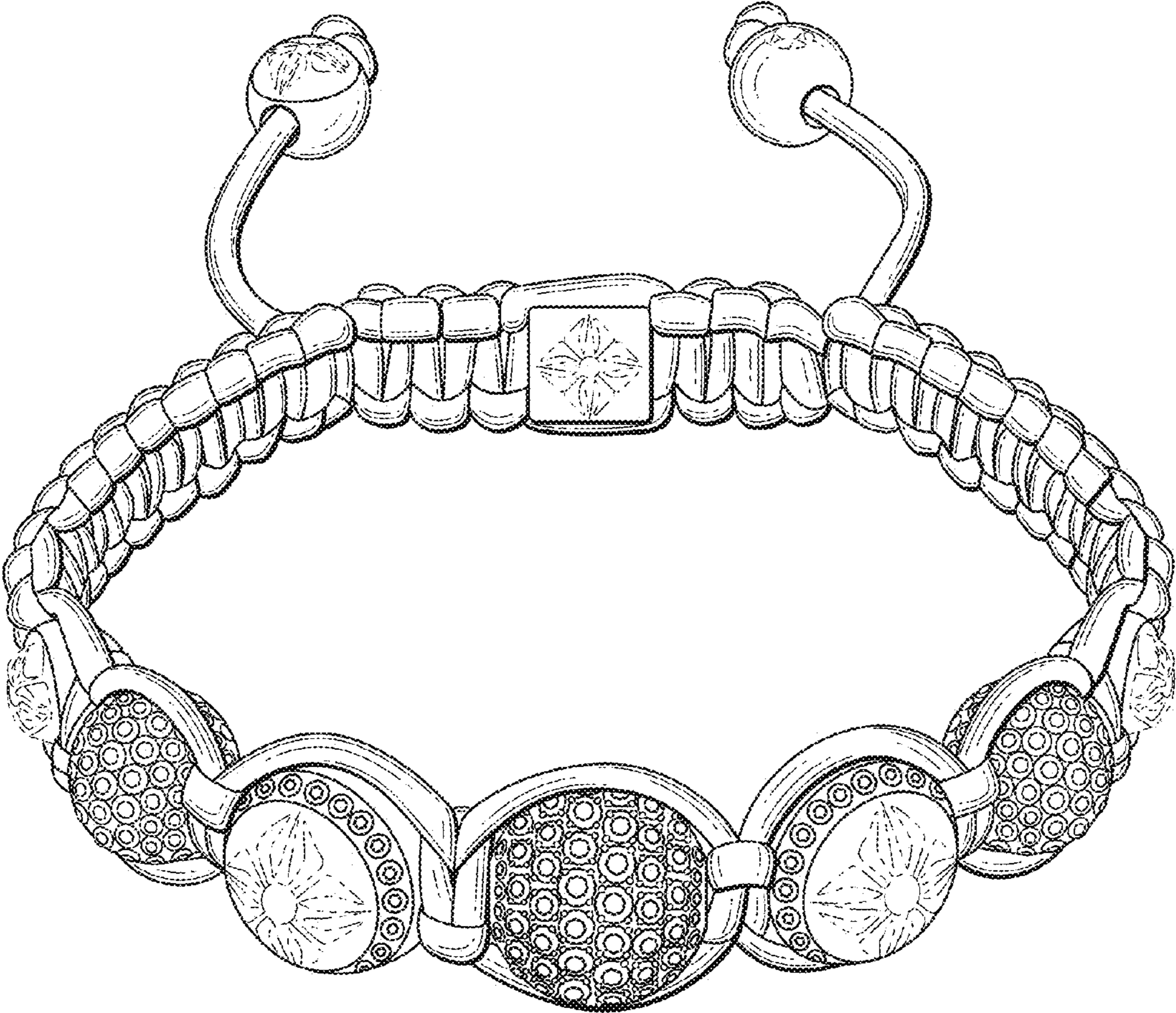

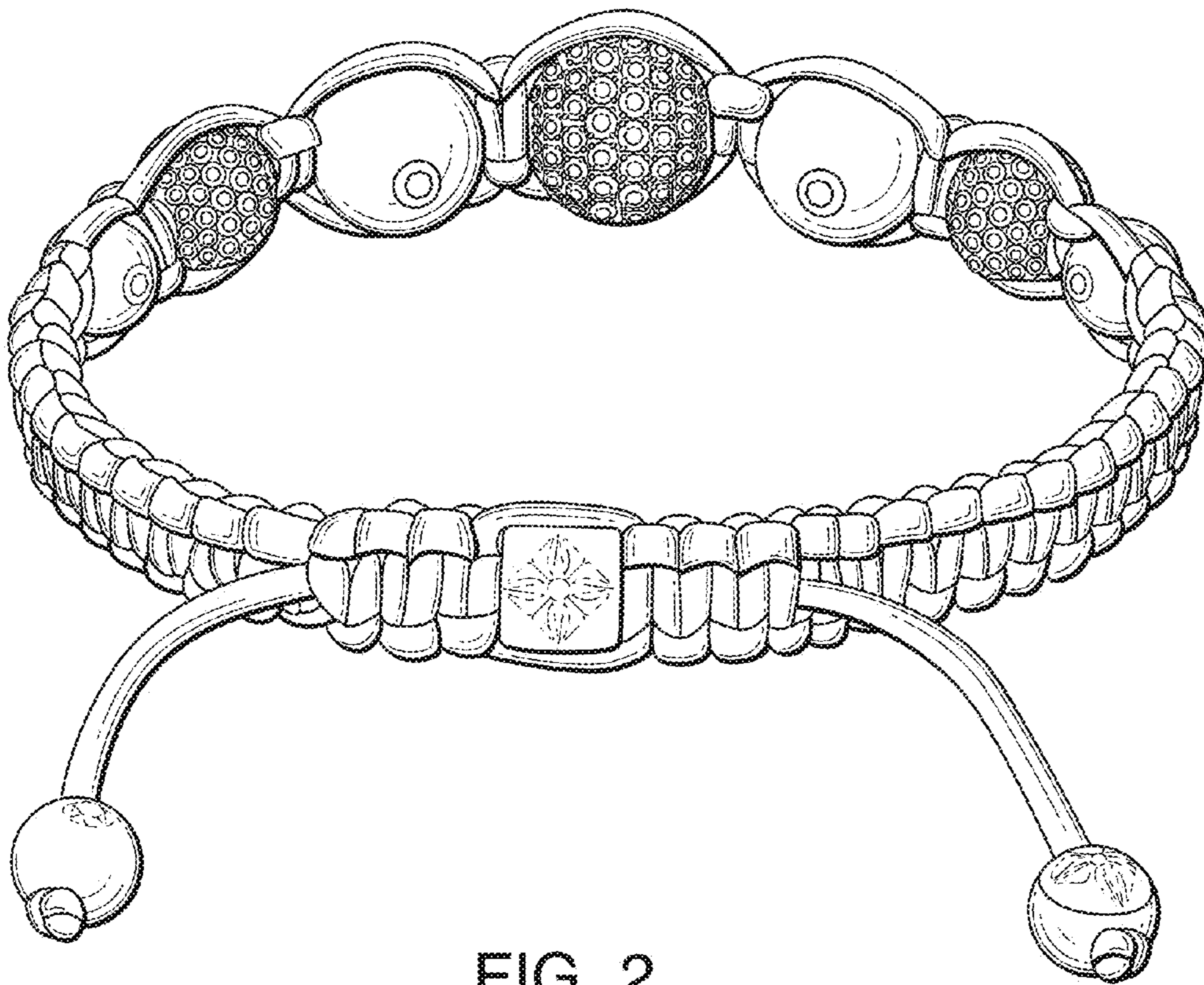
