FIG. 4 is a third side elevation view thereof;

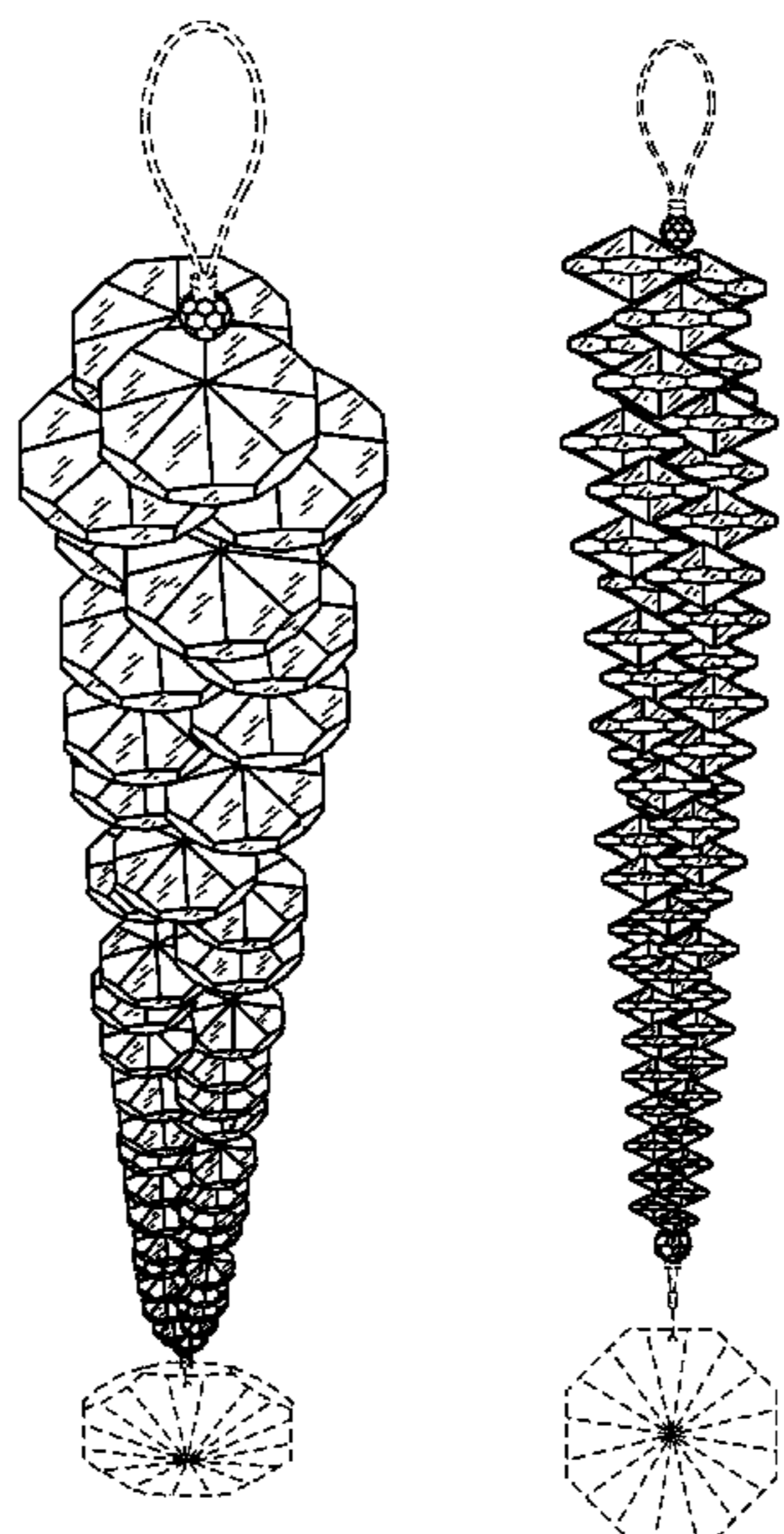
FIG. 5 is a fourth side elevation view thereof;

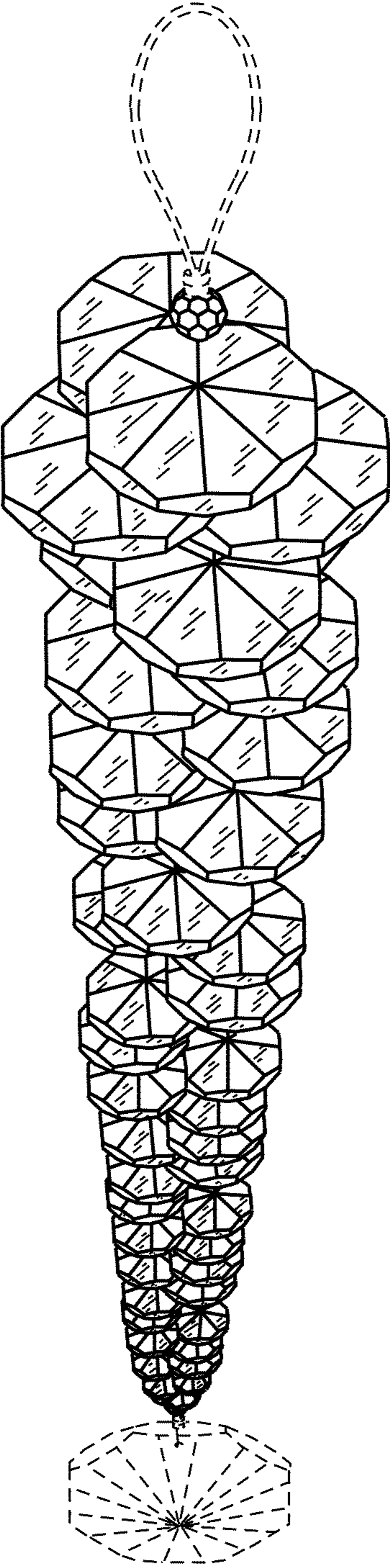

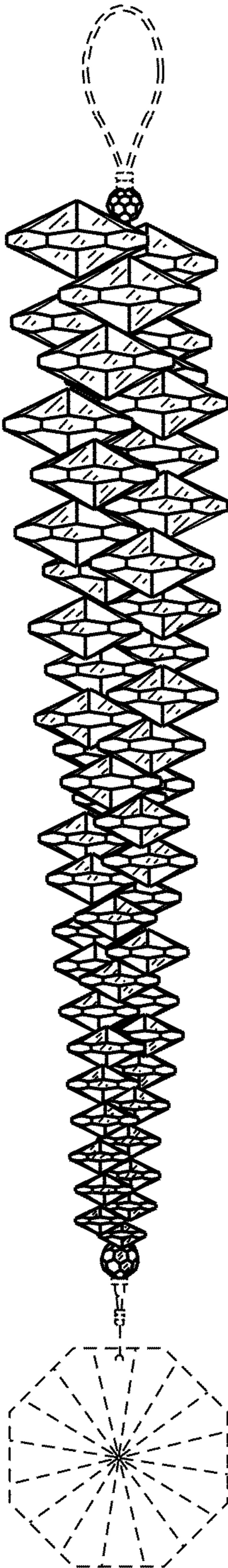

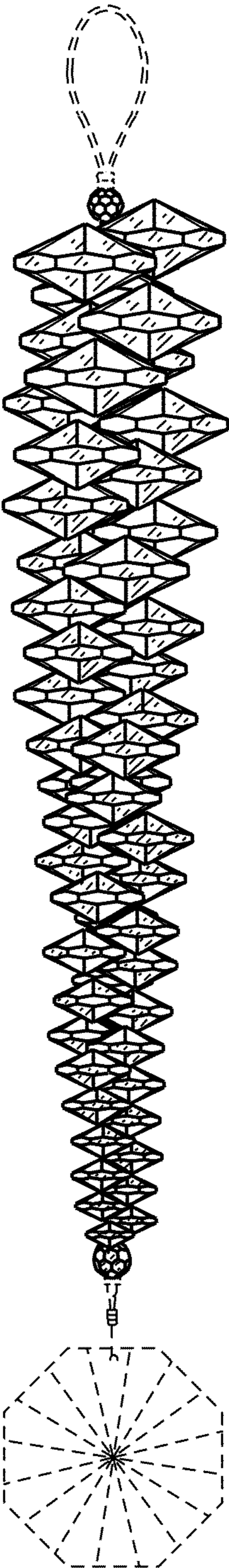

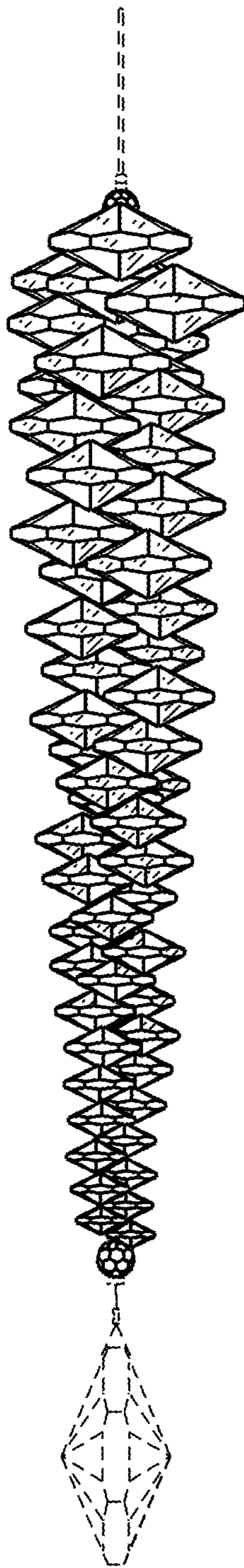

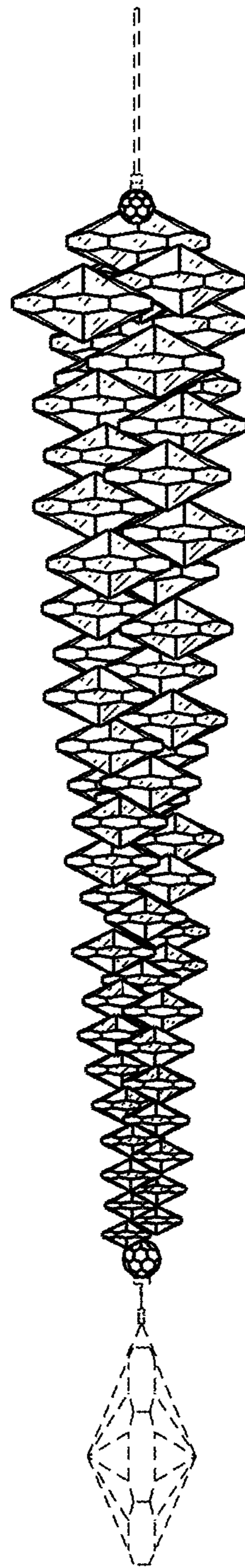

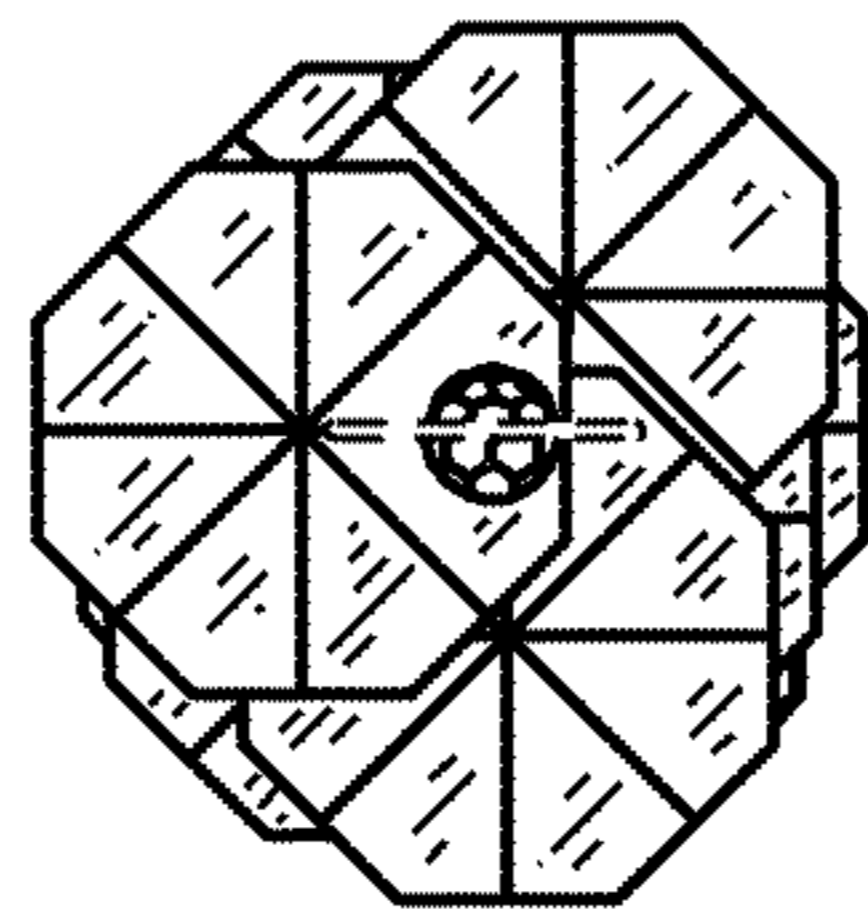

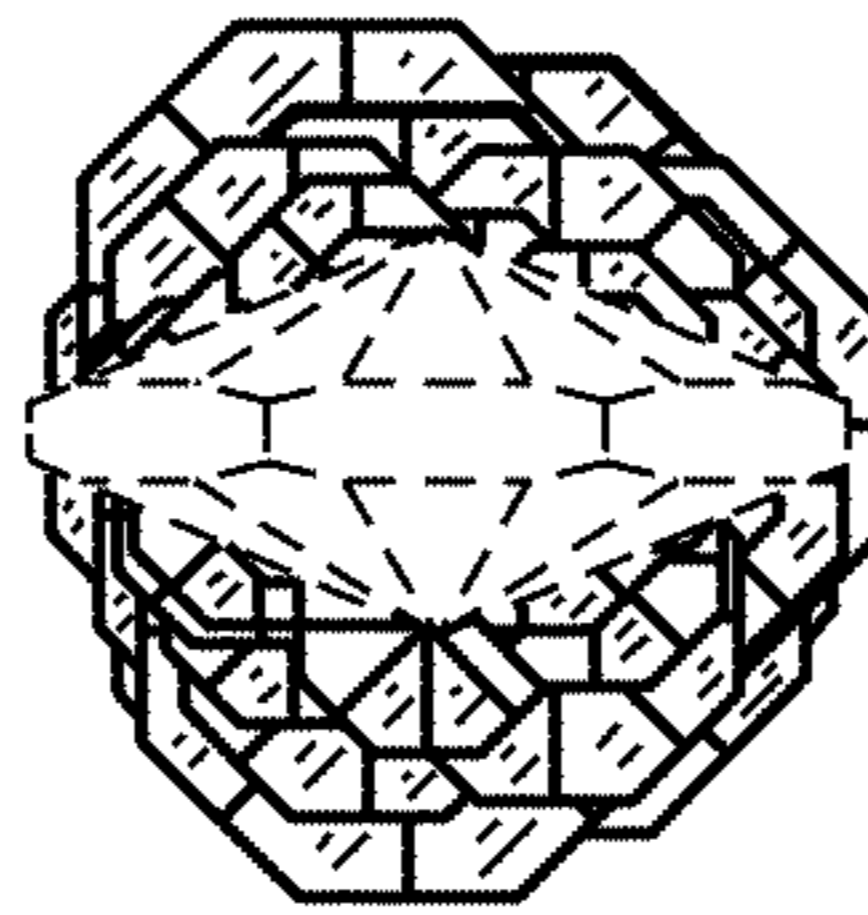
