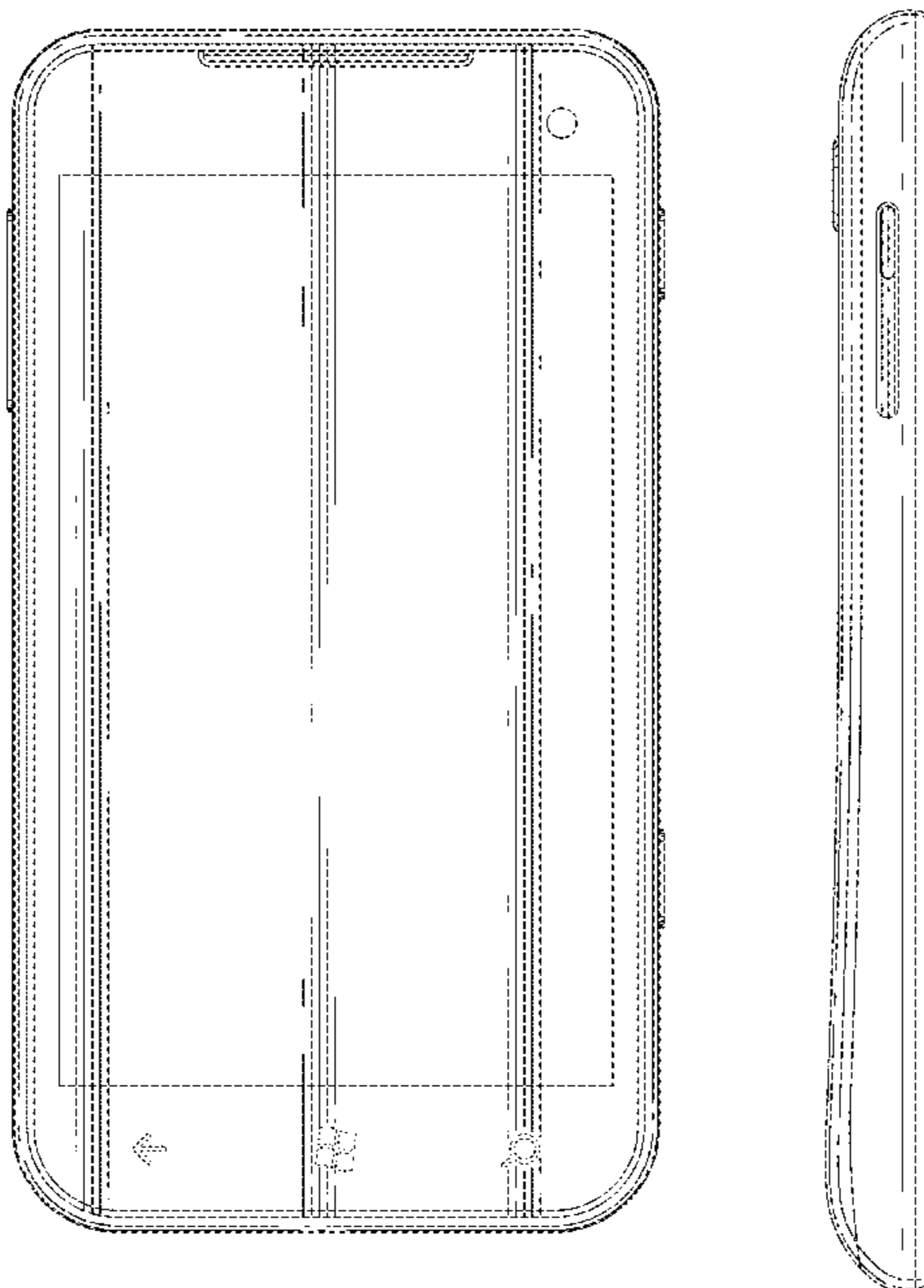
**CLAIM**

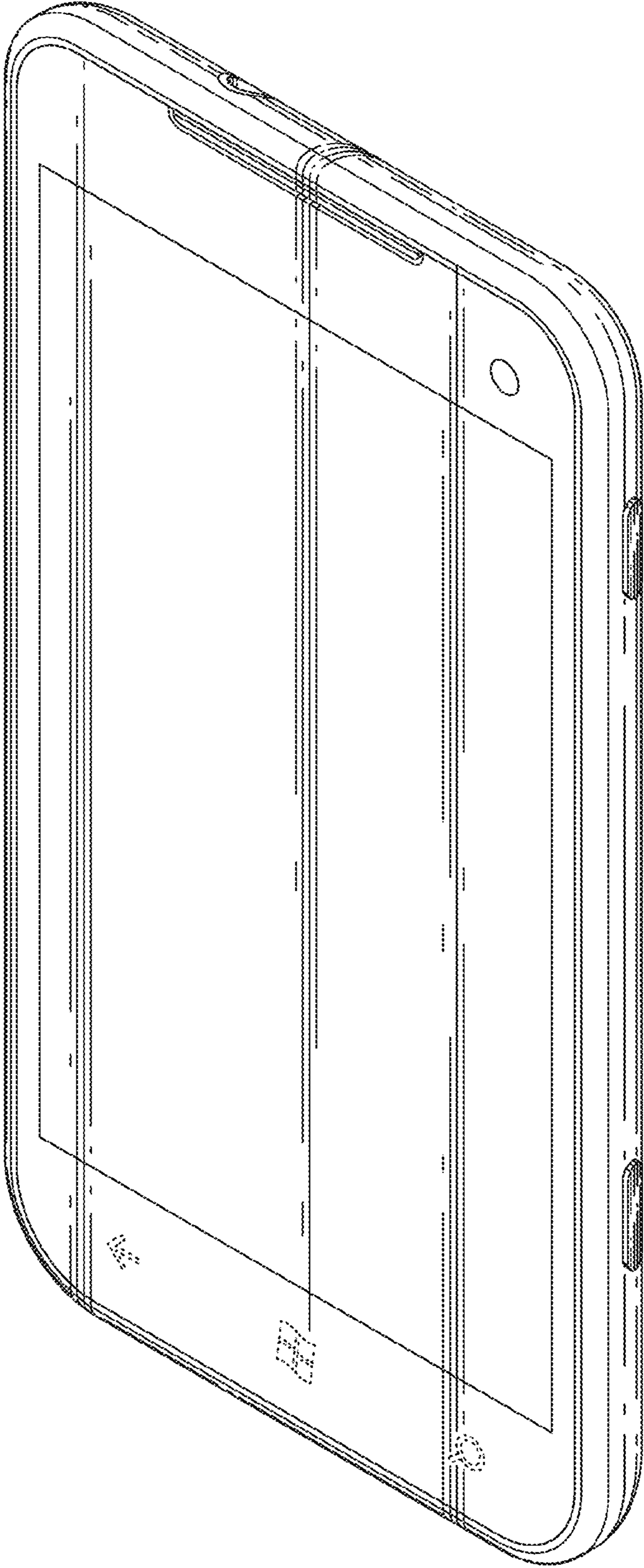

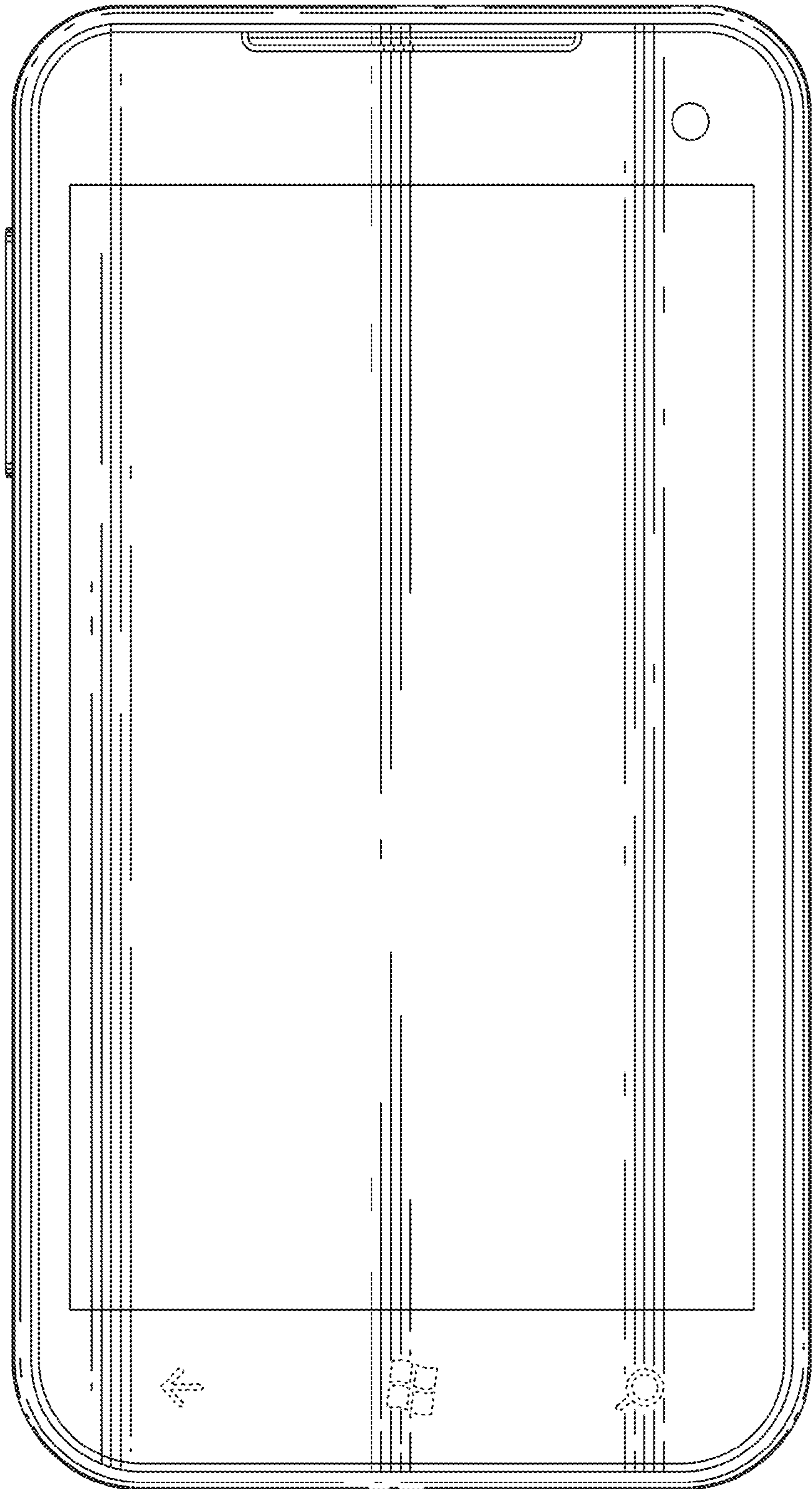

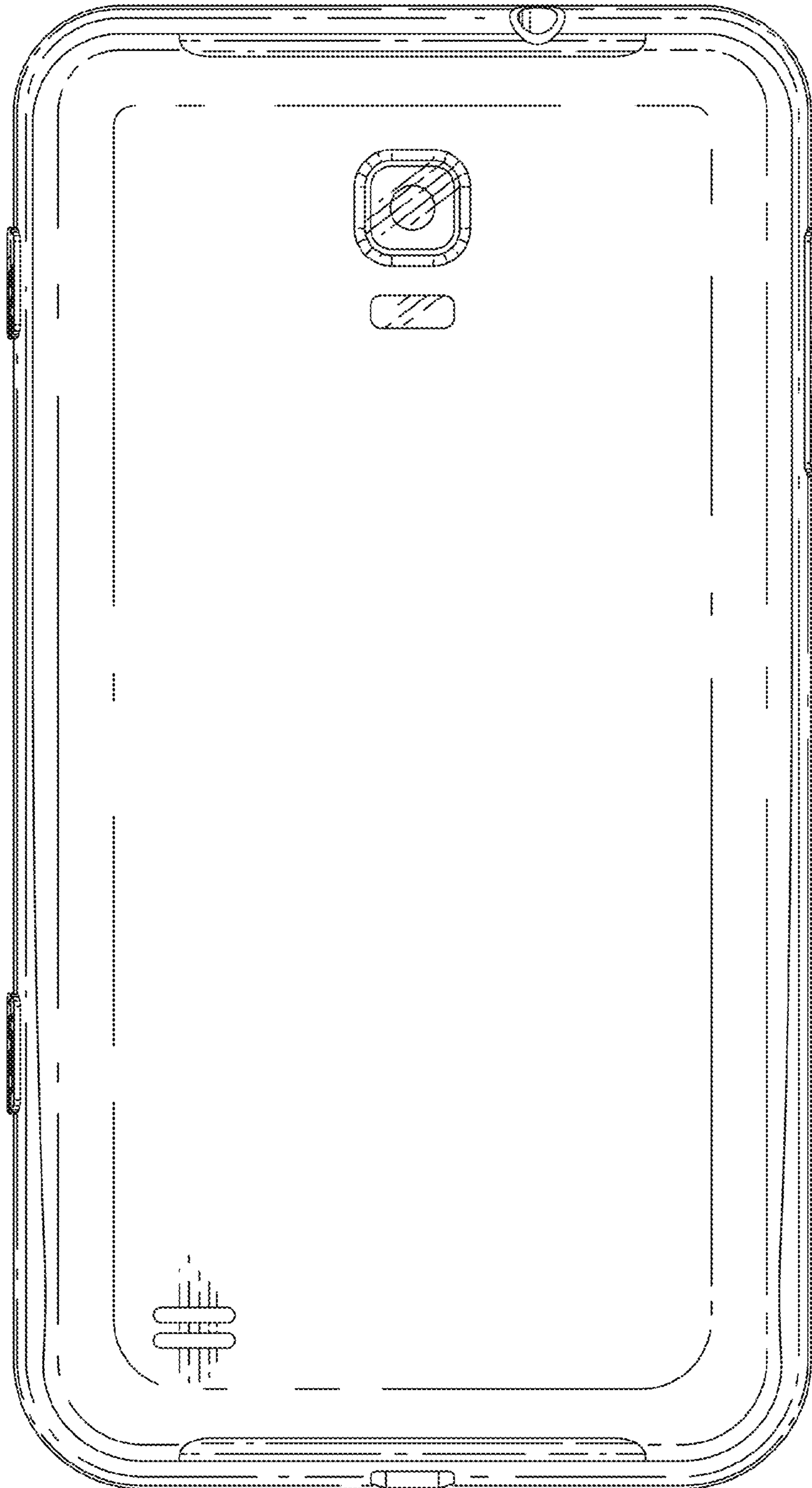

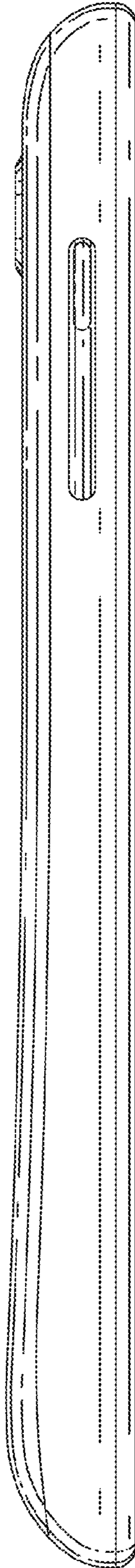

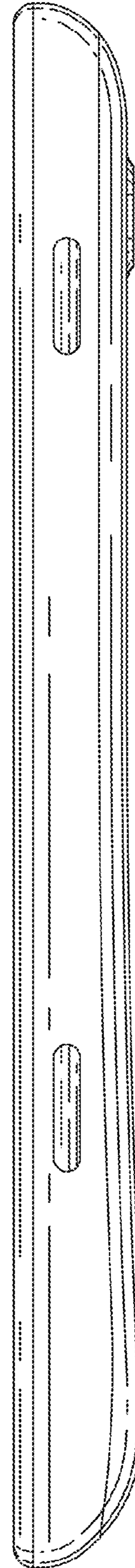

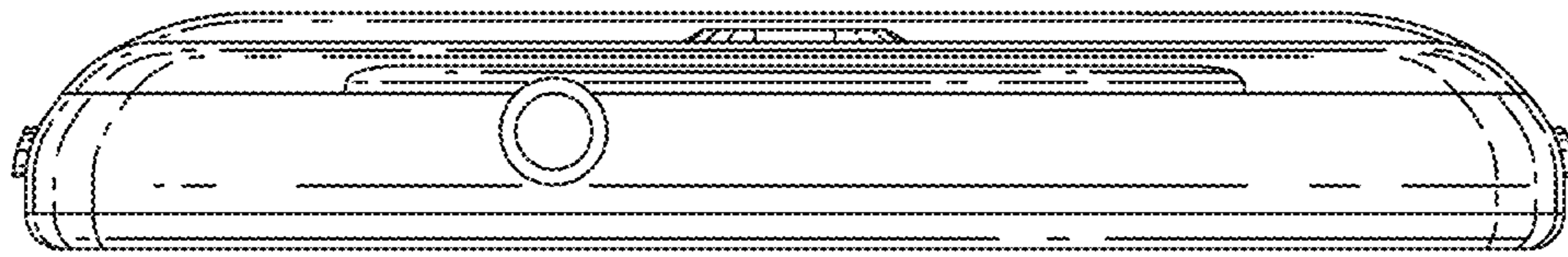
