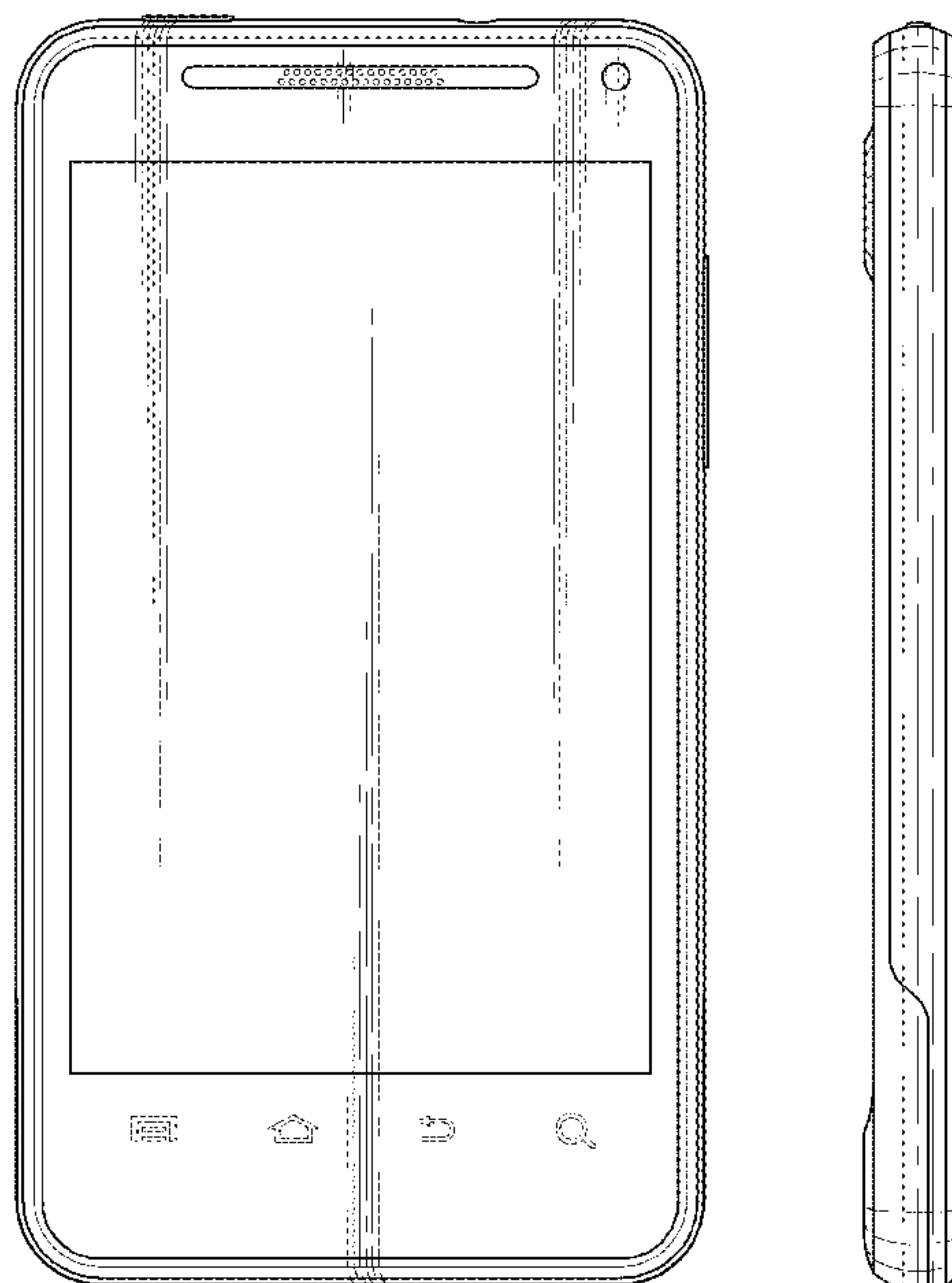
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a mobile terminal;
FIG. 2 is a front view of the mobile terminal of FIG. 1;
FIG. 3 is a rear view of the mobile terminal of FIG. 1;
FIG. 4 is a left-side view of the mobile terminal of FIG. 1;
FIG. 5 is a right-side view of the mobile terminal of FIG. 1;

FIG. 7 is a bottom plan view of the mobile terminal of FIG. 1.

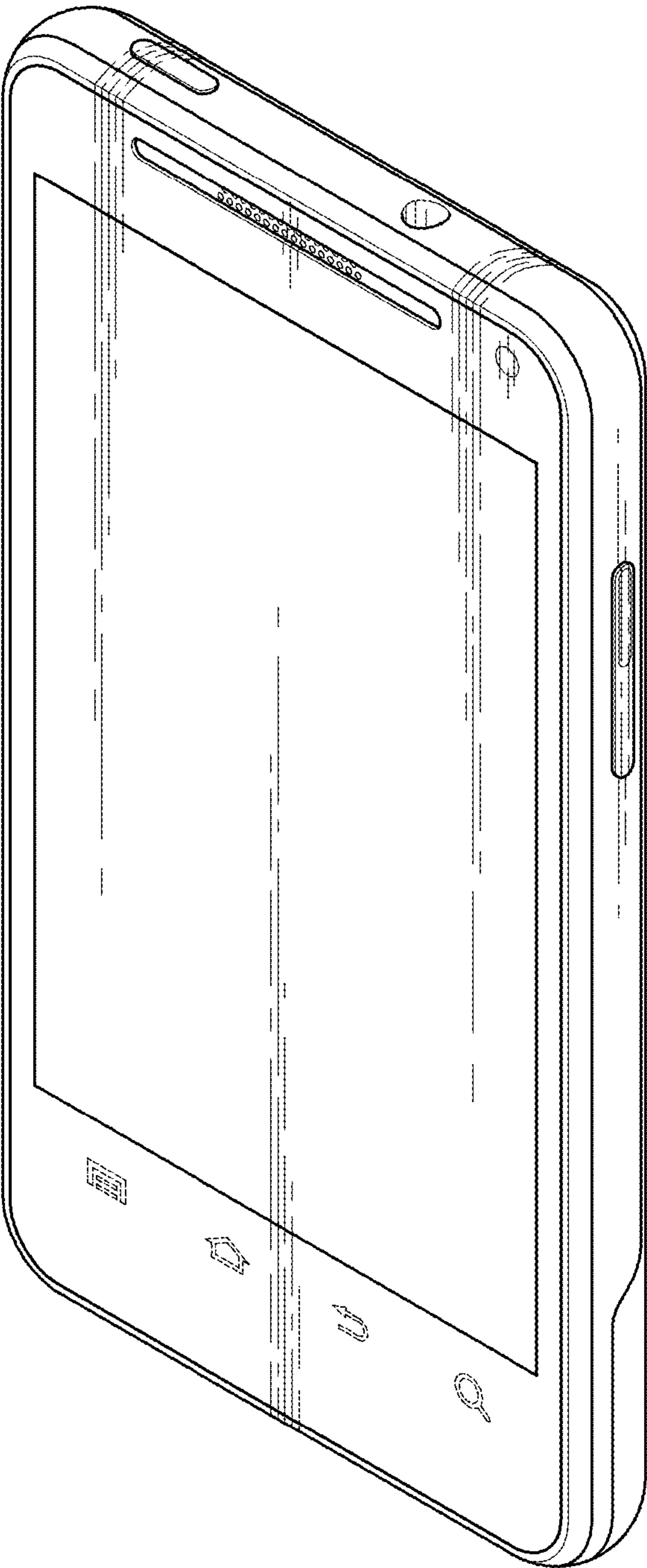

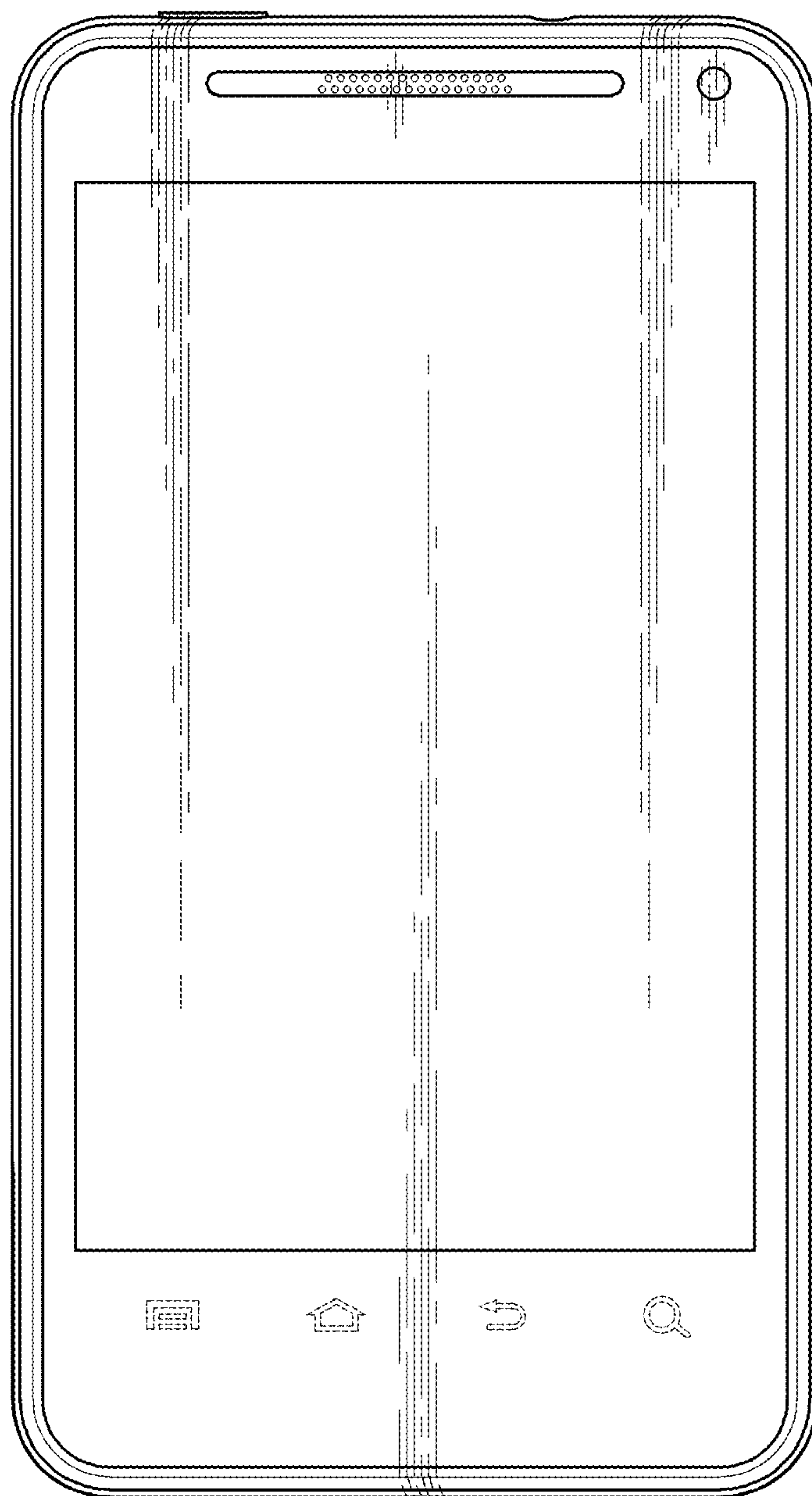

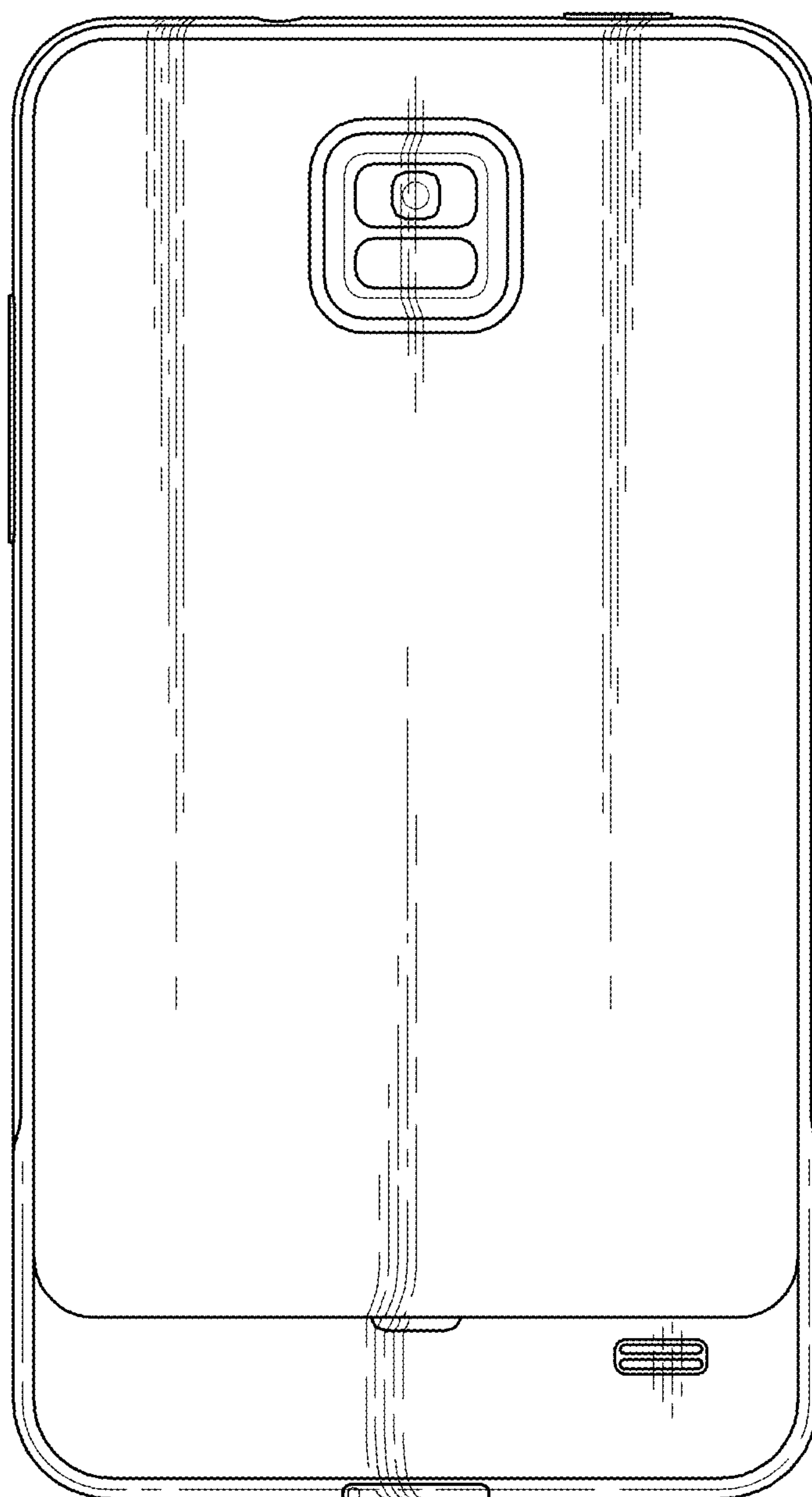

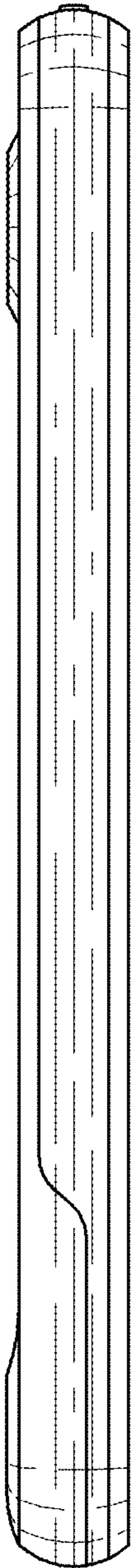

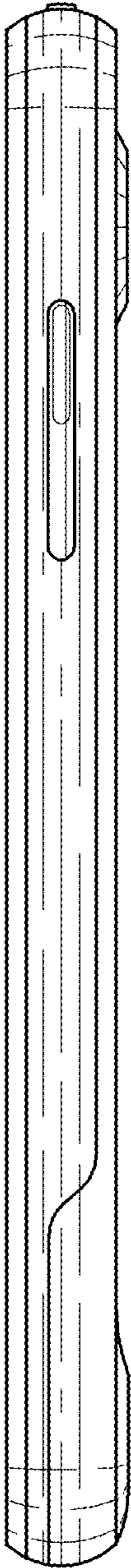

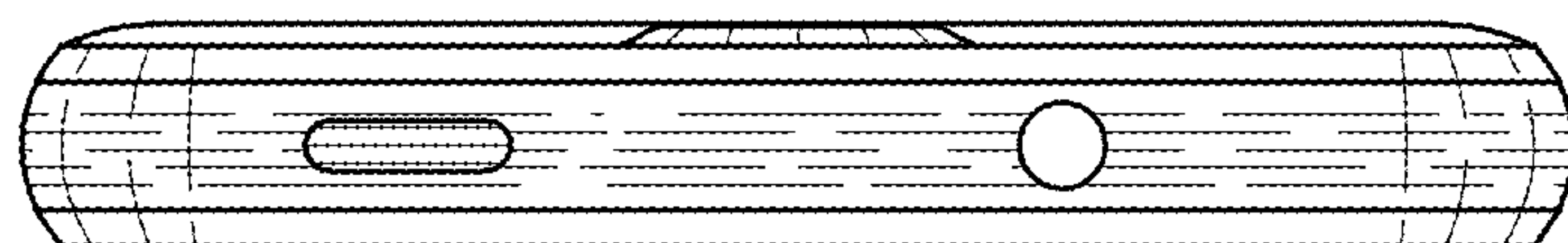
