The ornamental design for a mobile data terminal stand, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the design for a mobile data terminals stand;

FIG. 2 is a rear view thereof;

FIG. 3 is a right side view thereof (the left side view being a mirror image of the right side view);

FIG. 4 is a top view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a front view thereof, shown with a sectional line A-A; and,

FIG. 7 is a cross-sectional view taken along line A-A of FIG. 6.

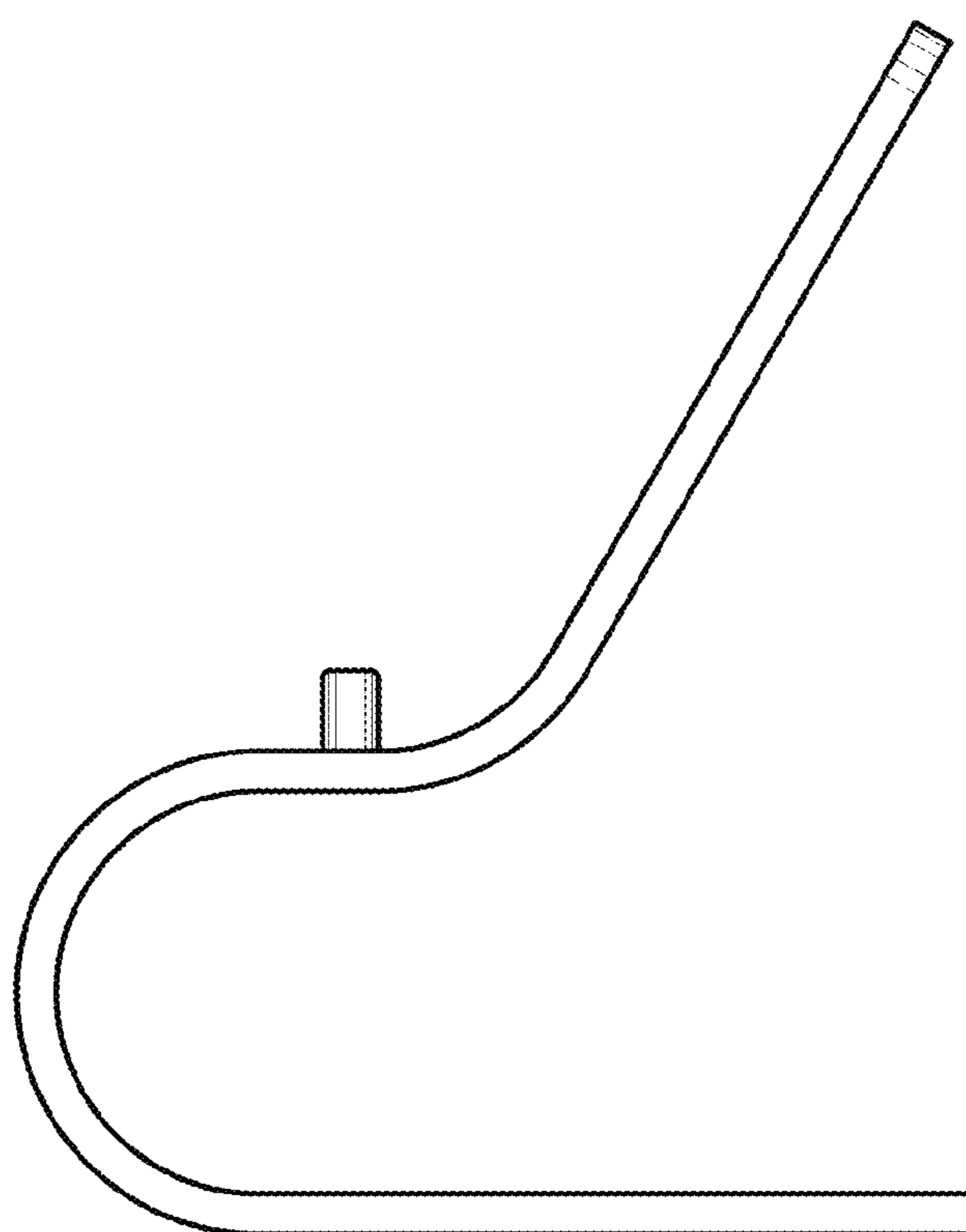
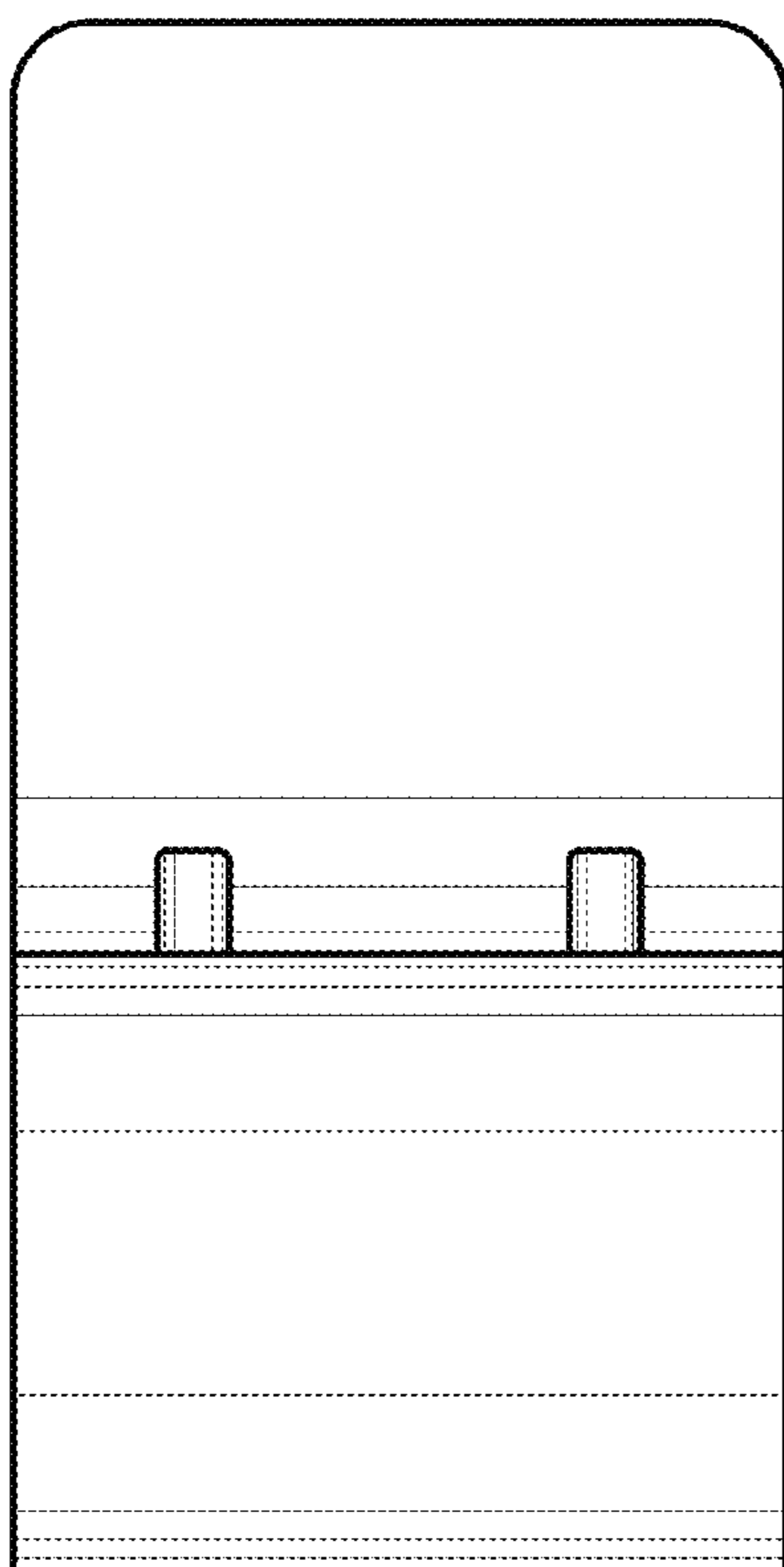

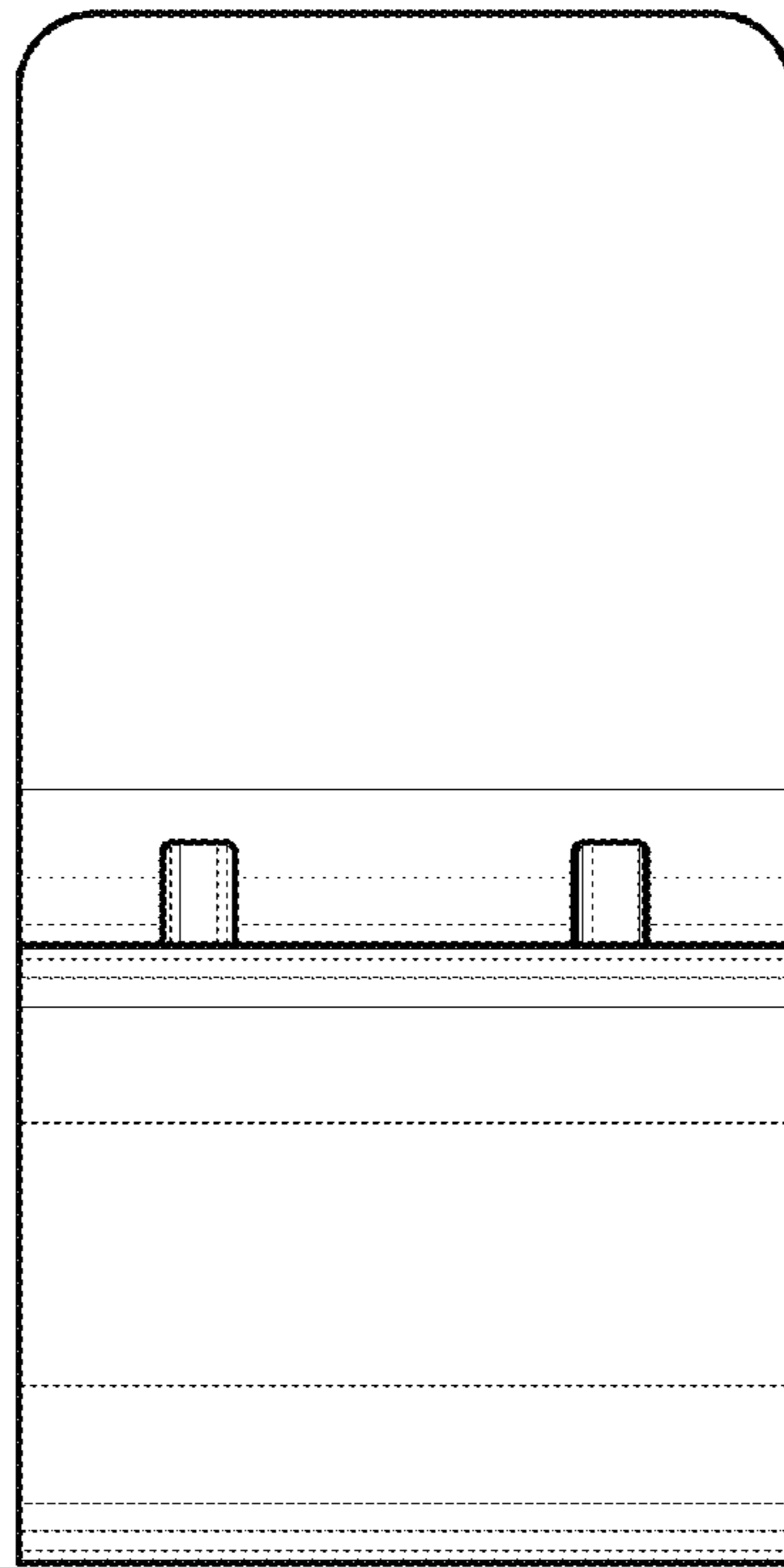

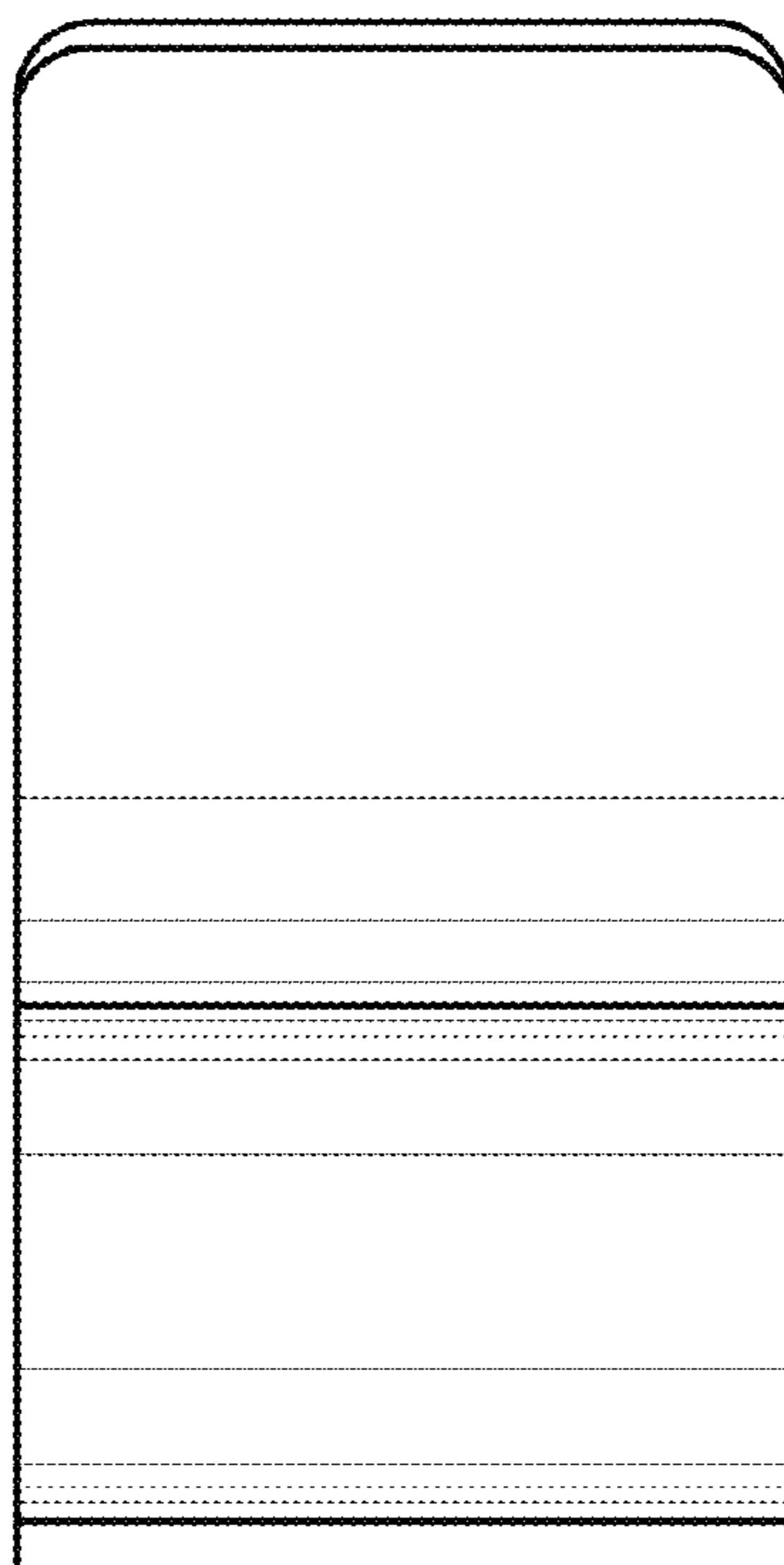

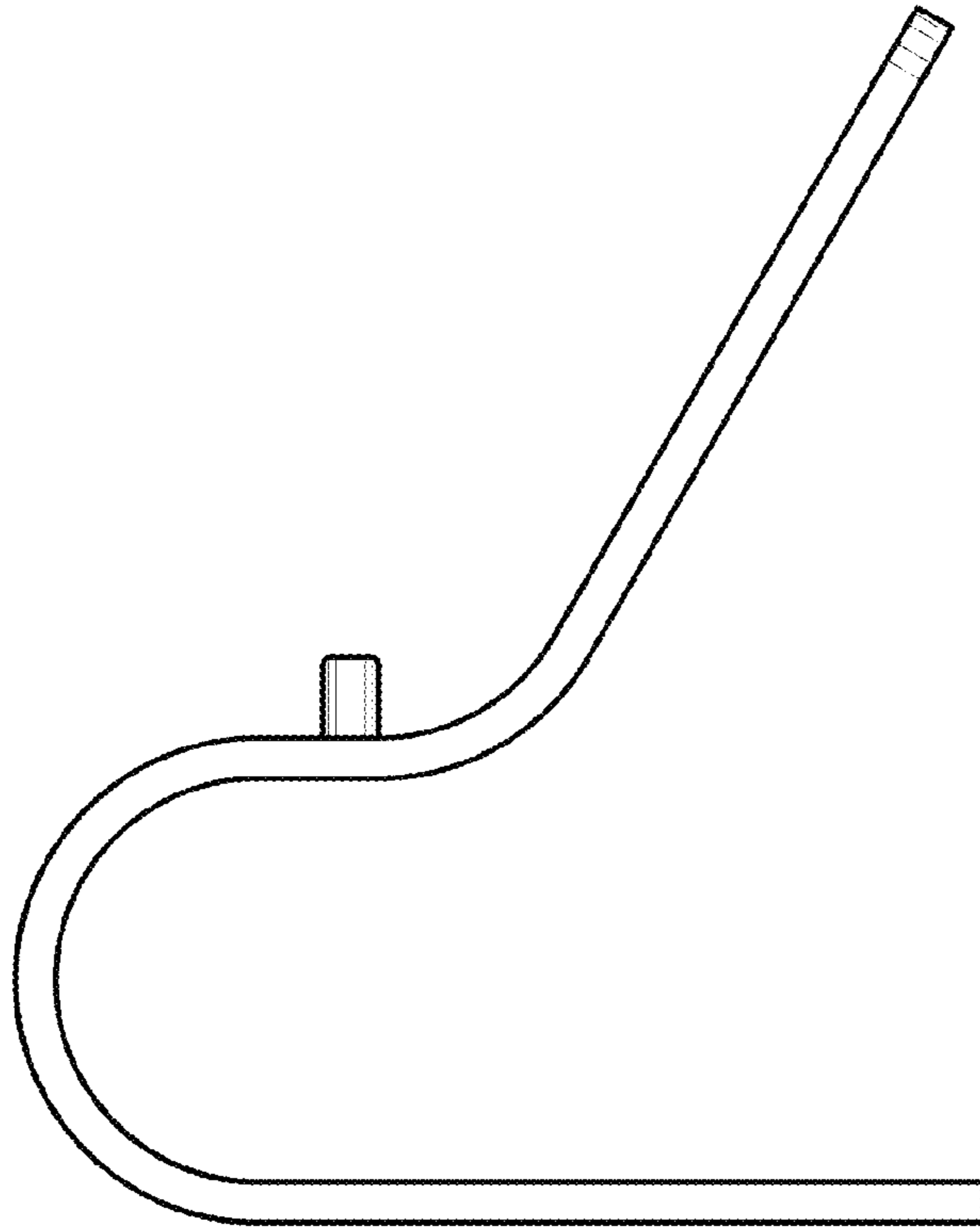

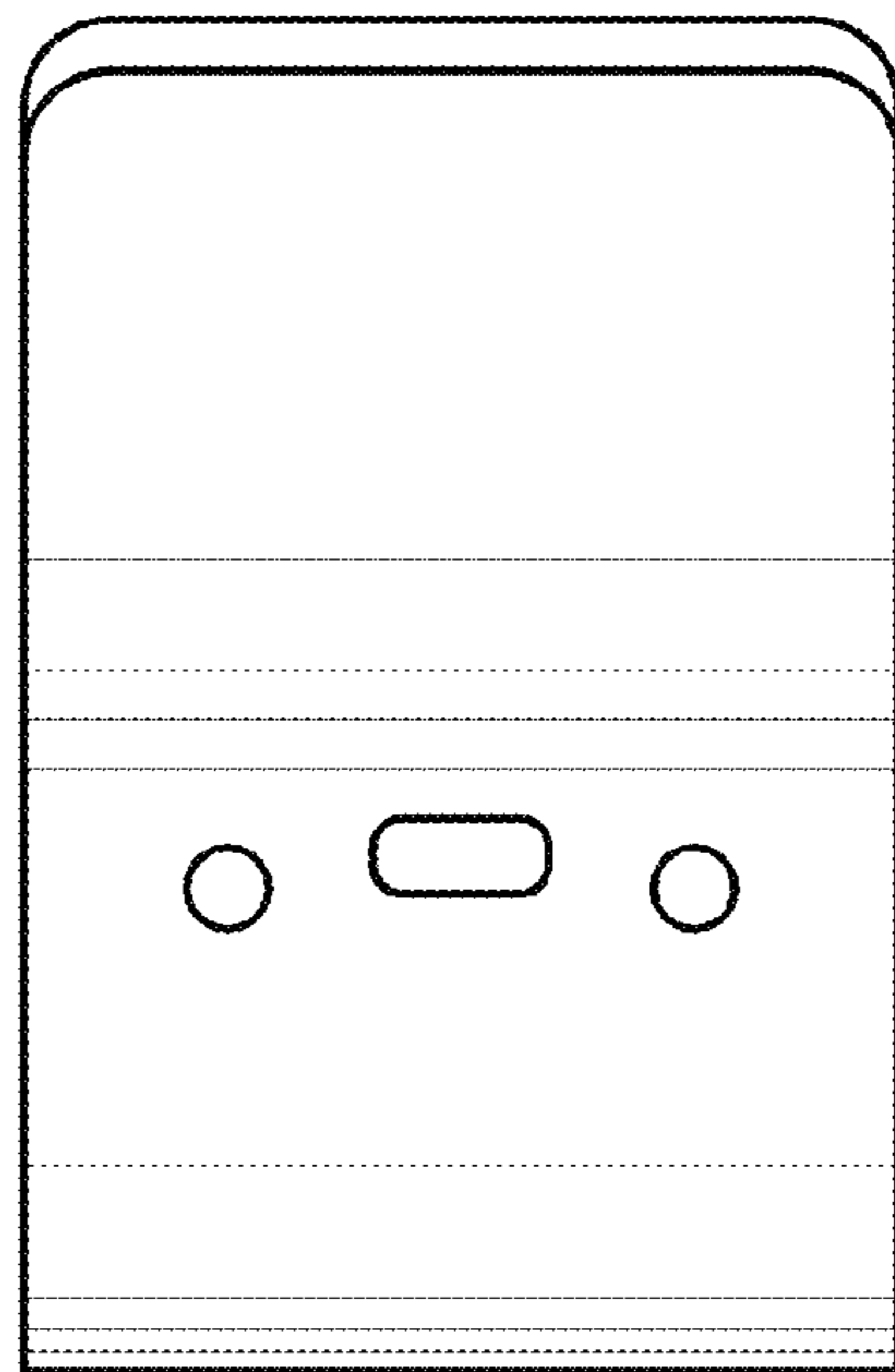

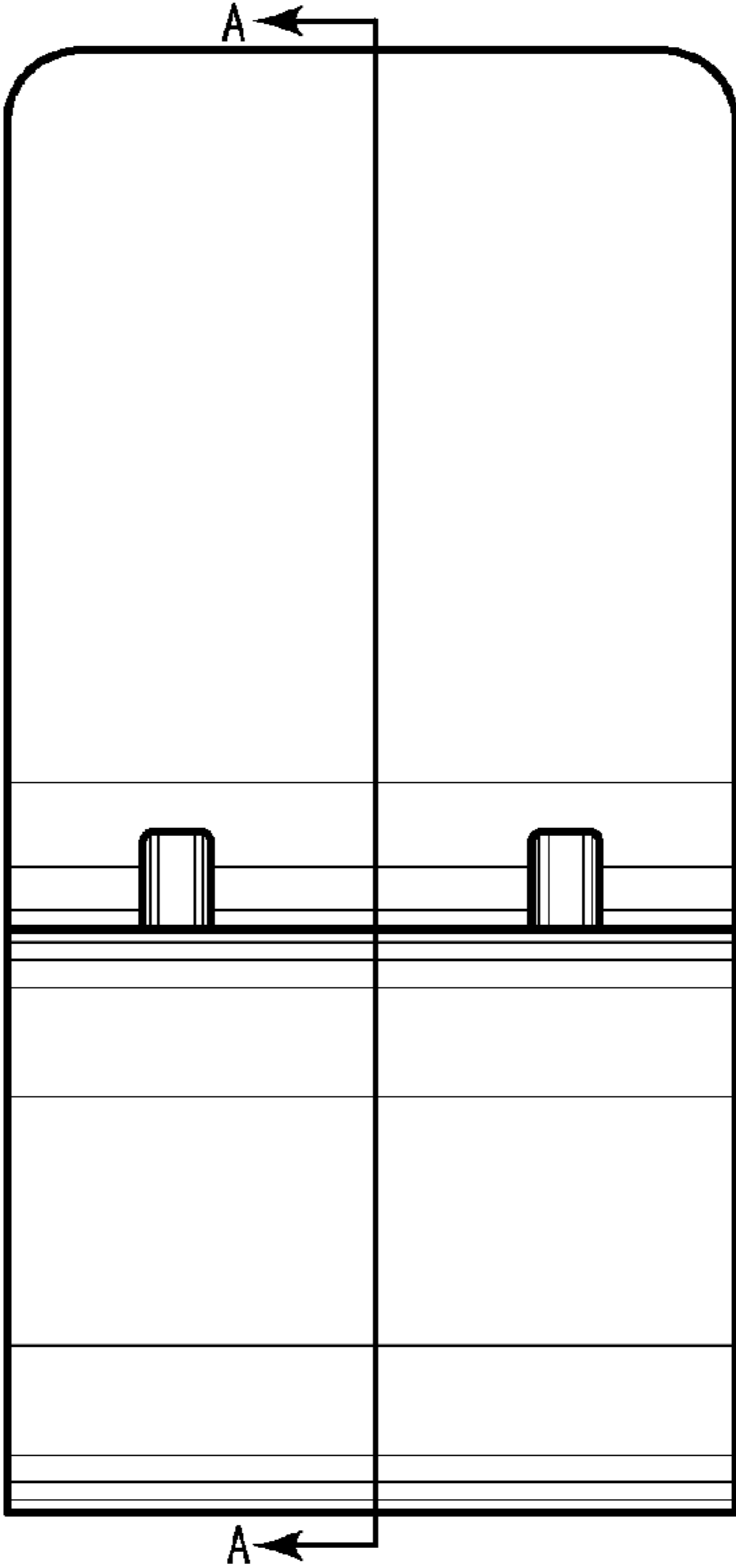
