The ornamental design for a stand for a monitor, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of a stand for a monitor showing my new design;

FIG. 5 is a right side elevational view thereof;

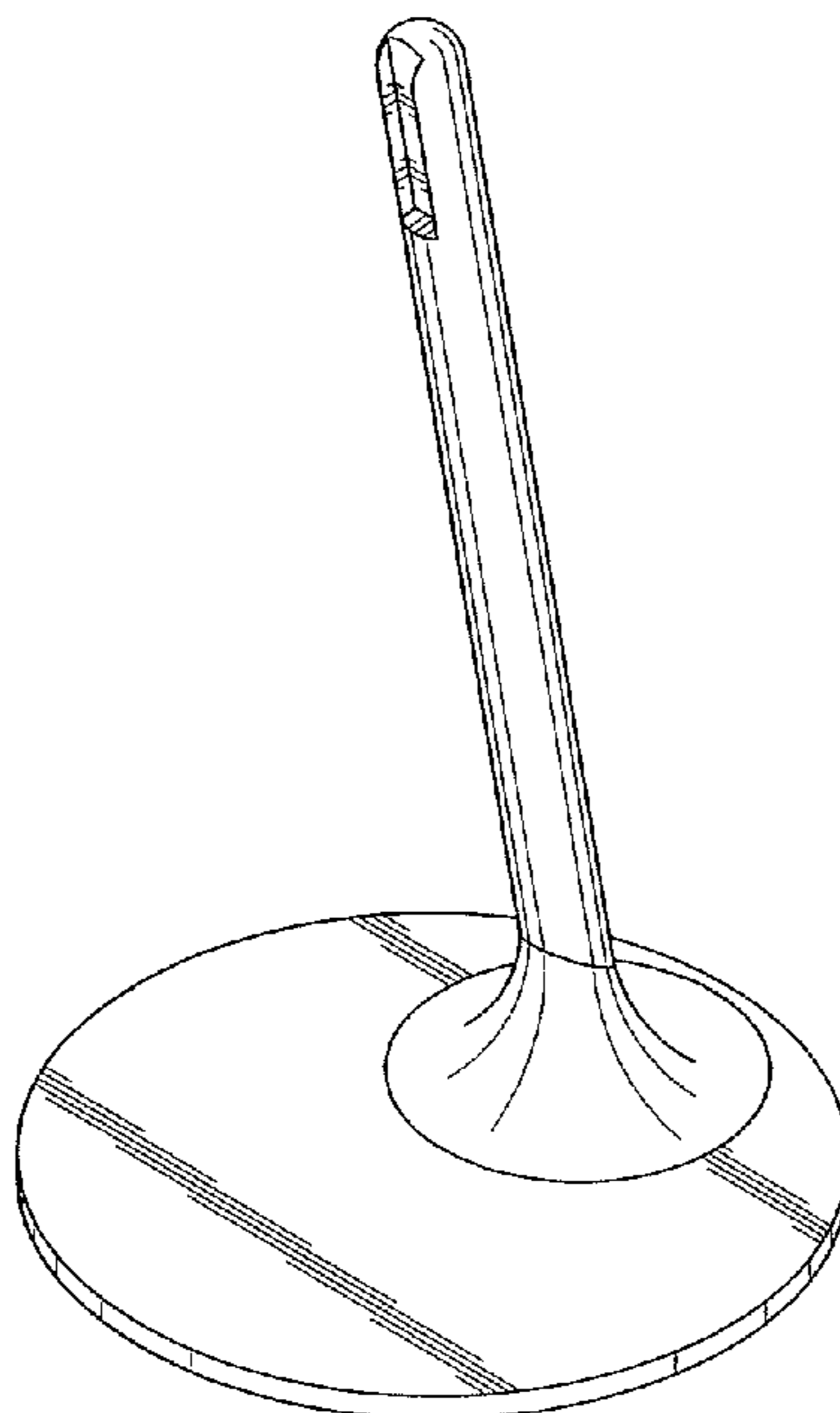
FIG. 6 is a top plan view thereof;

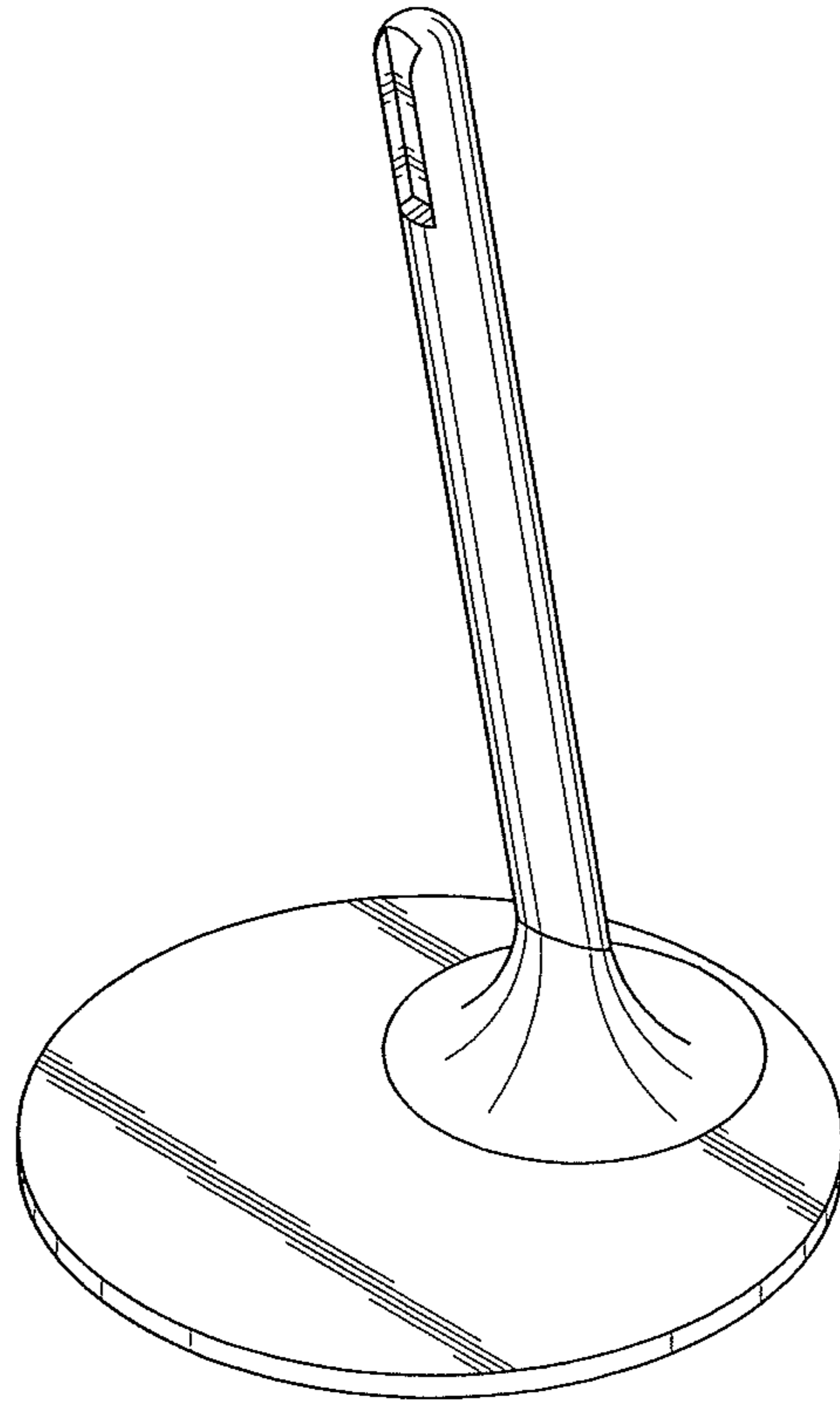

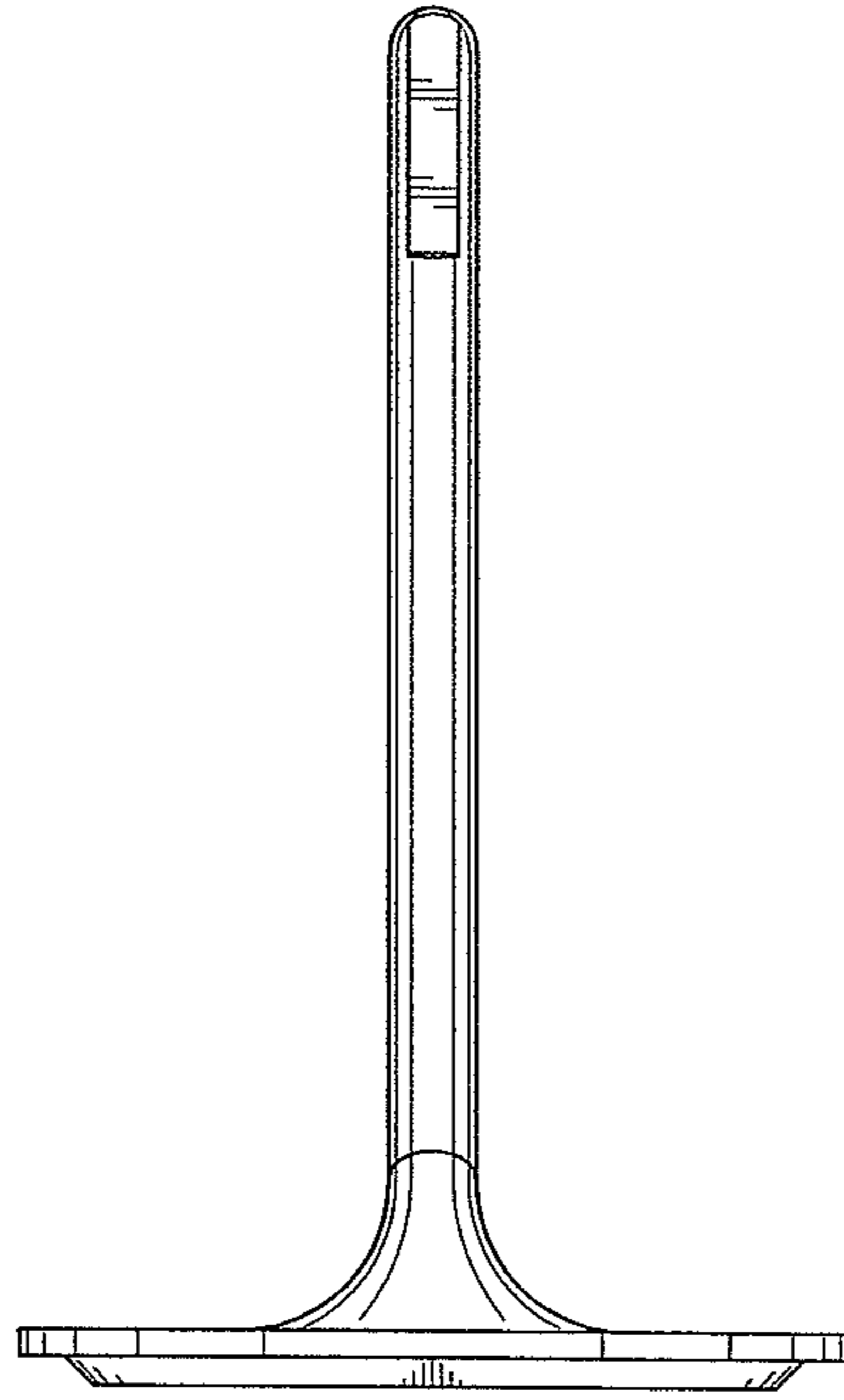

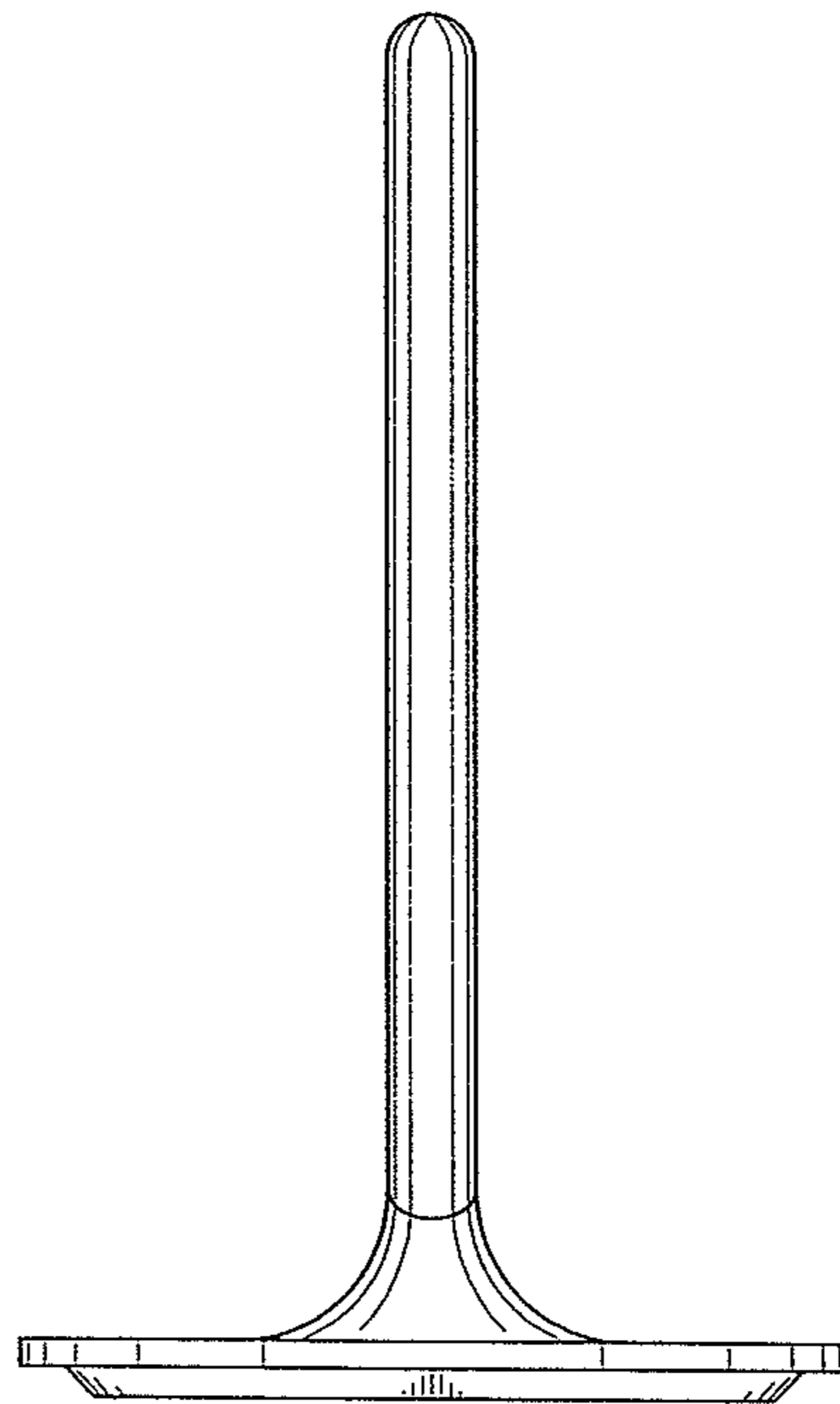

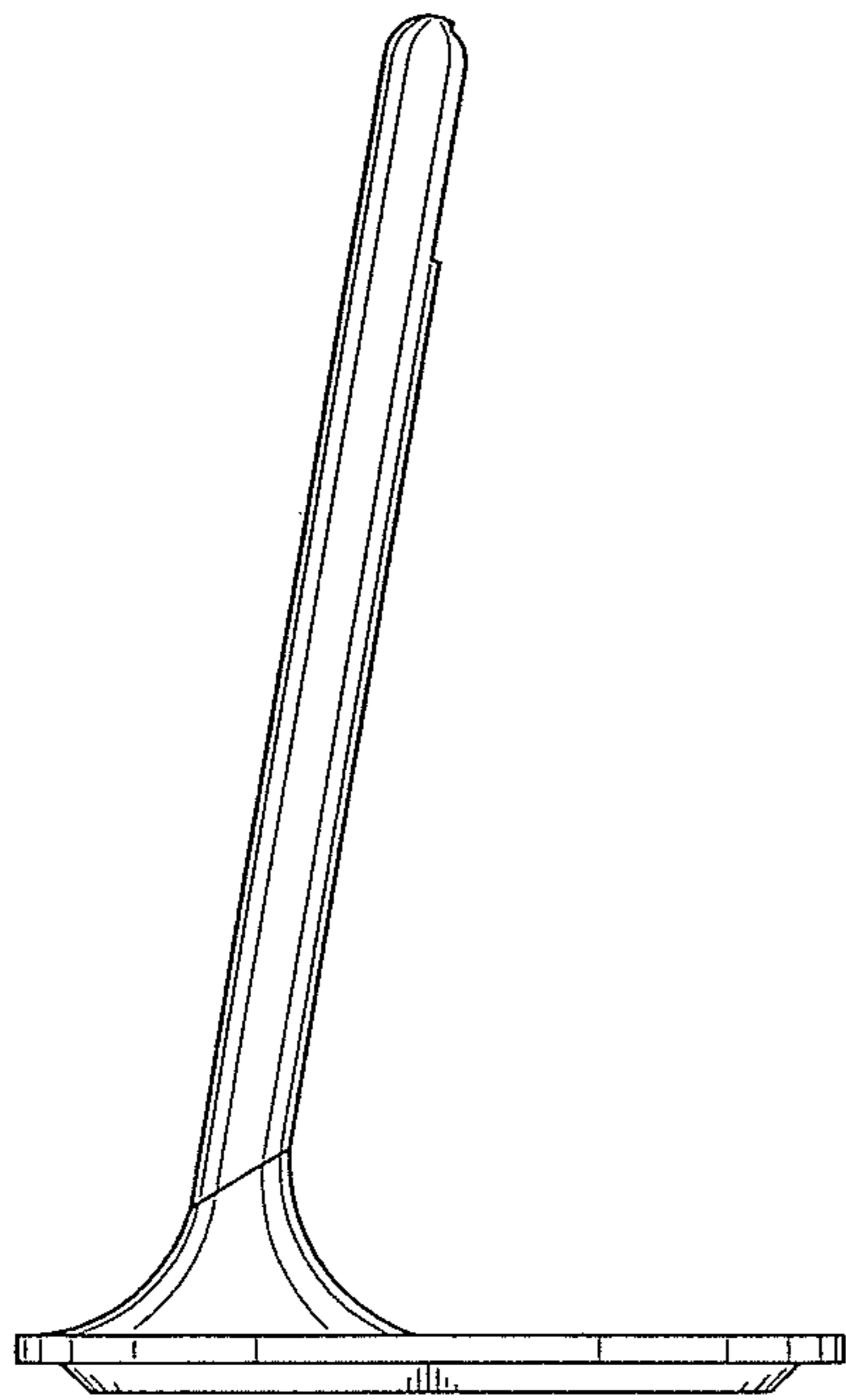

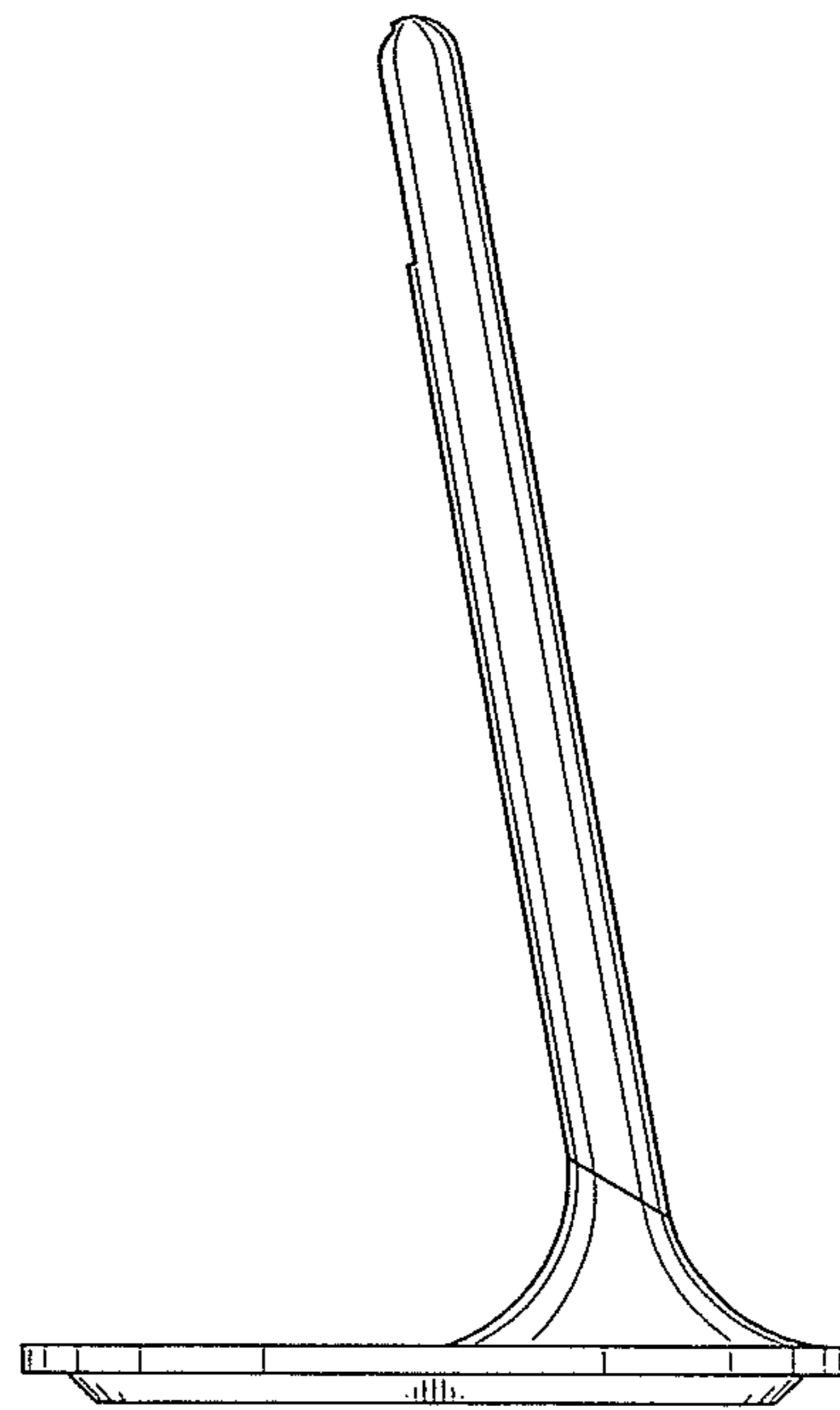

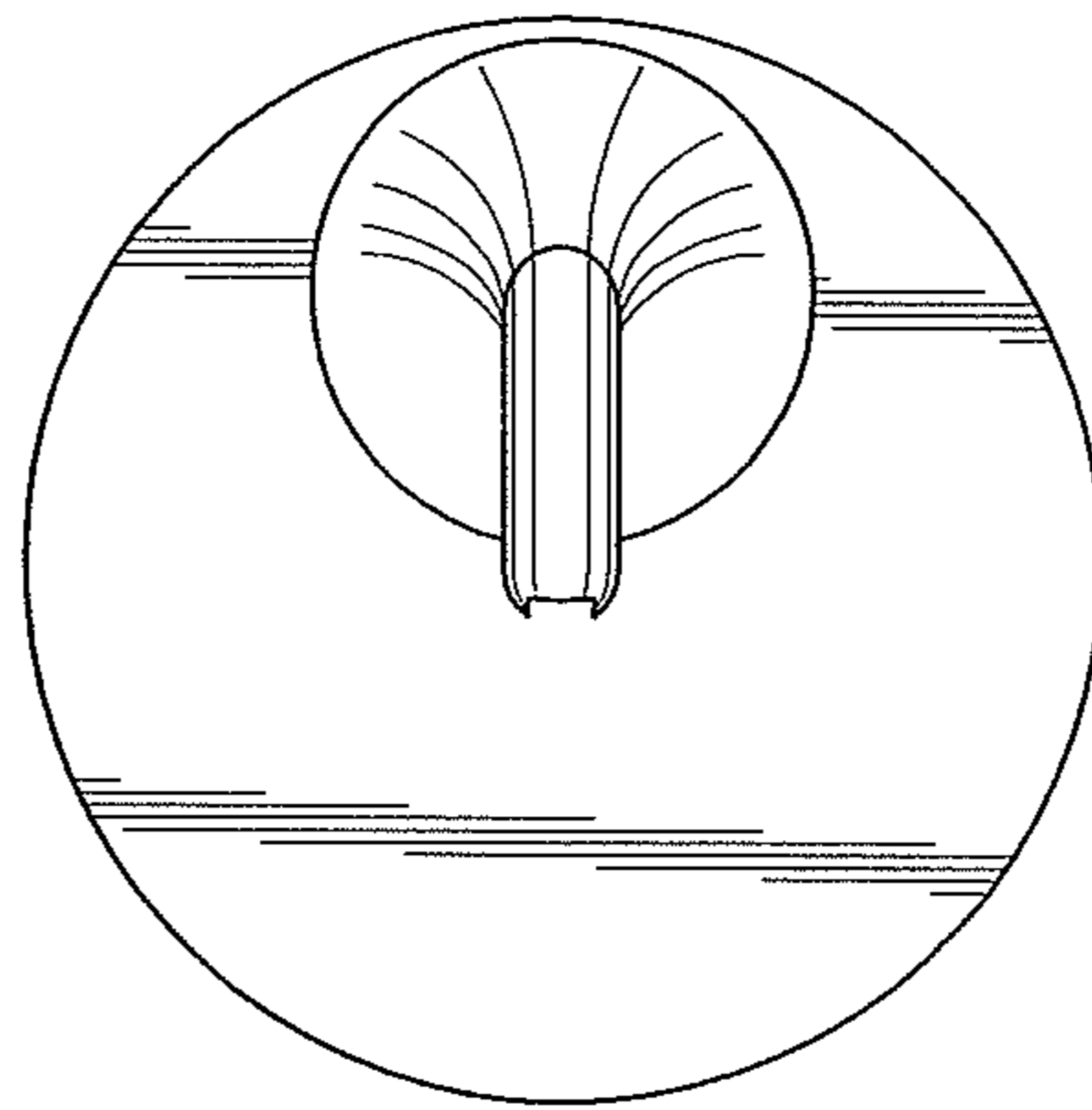

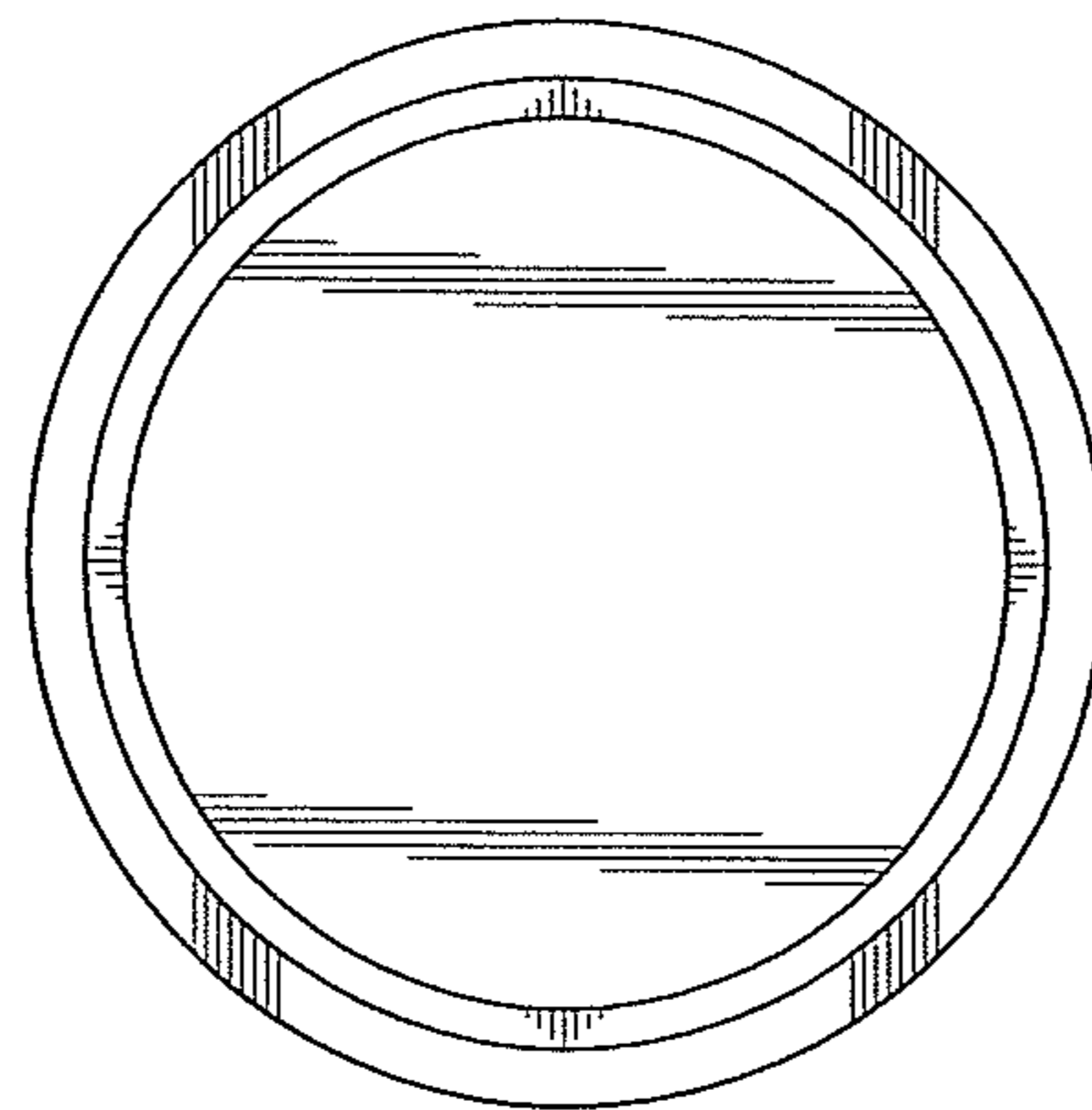

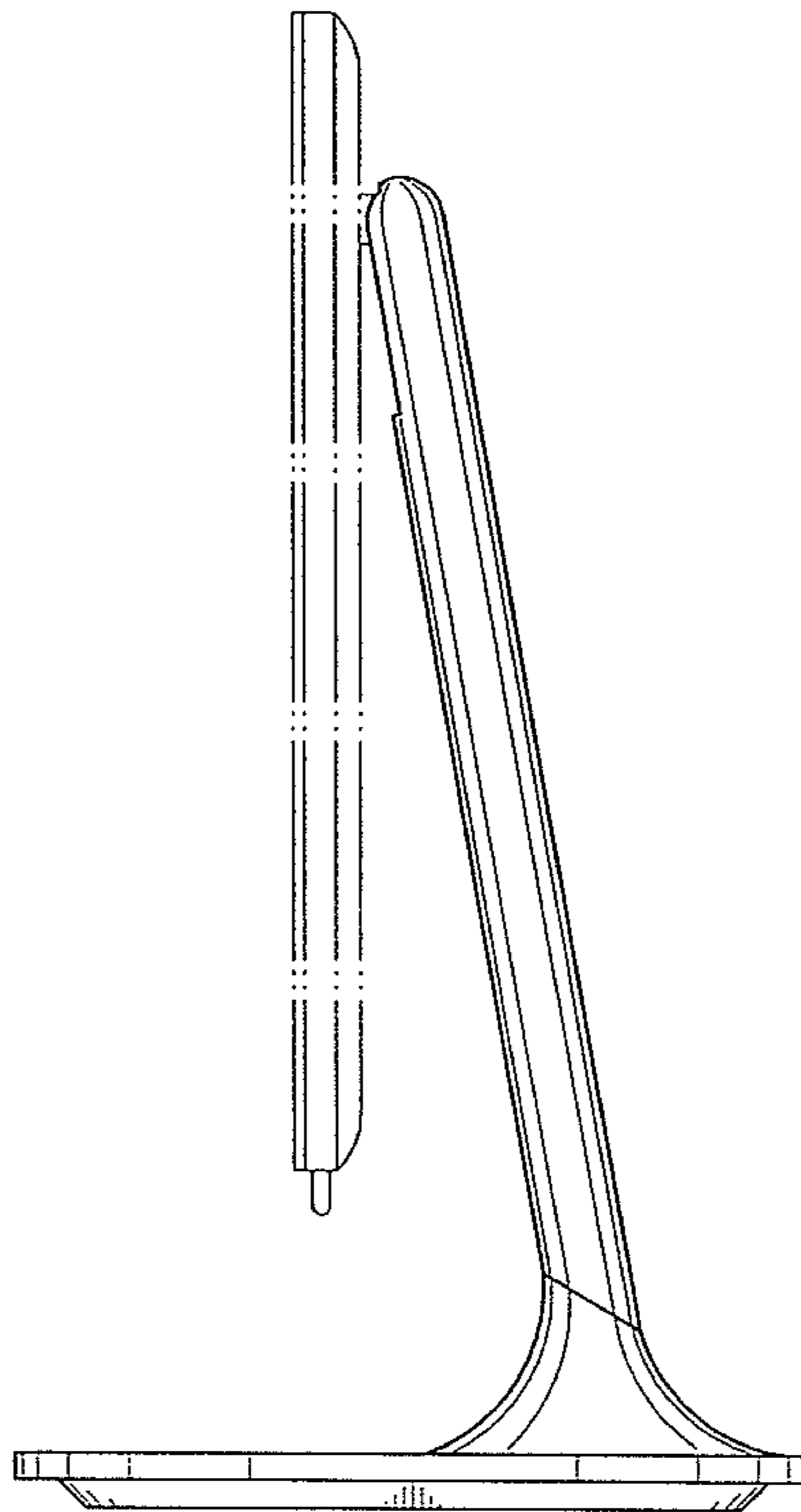
