DESCRIPTION

FIG. 11 is a rear view of the cassette of FIG. 8;

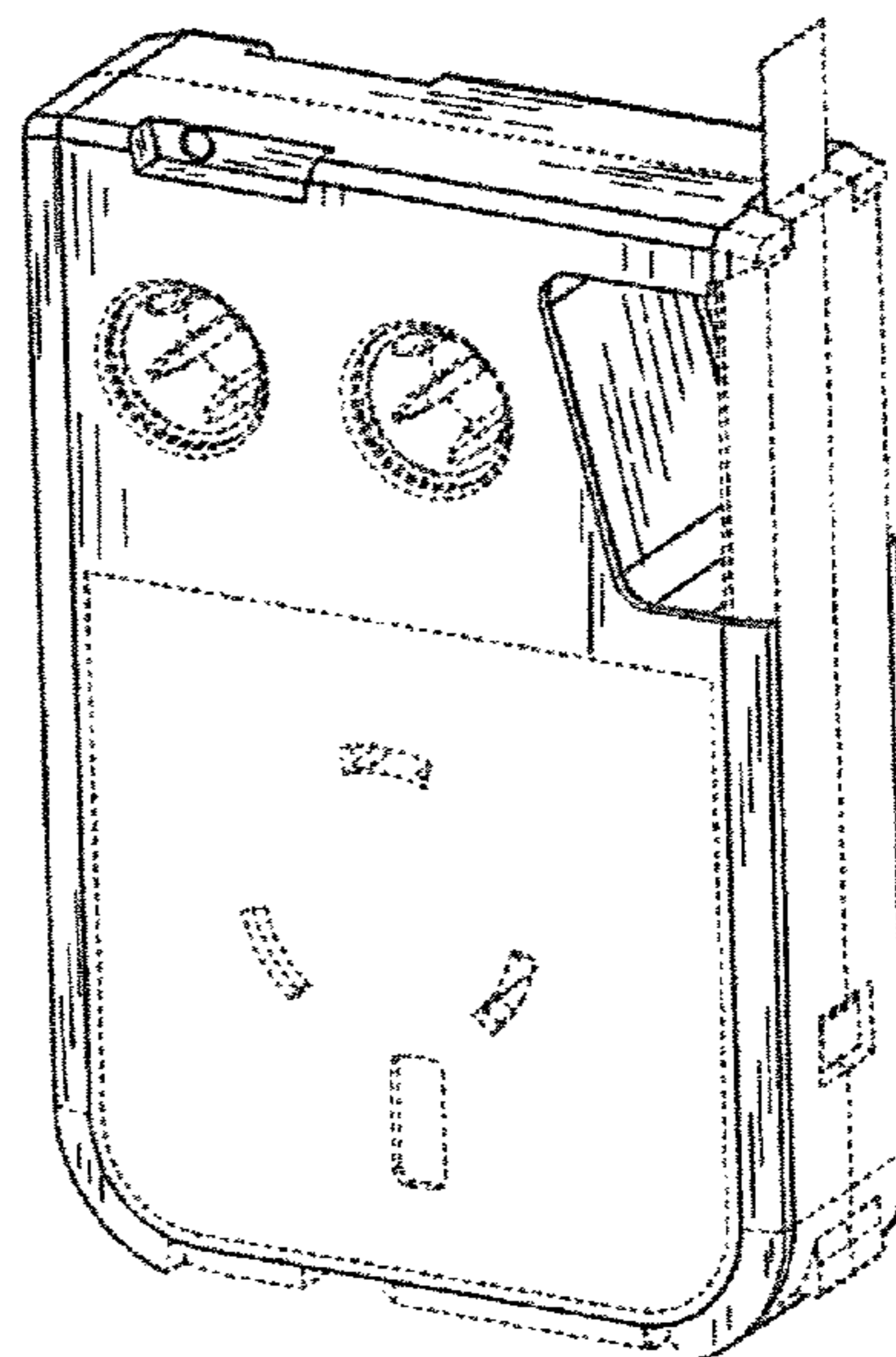
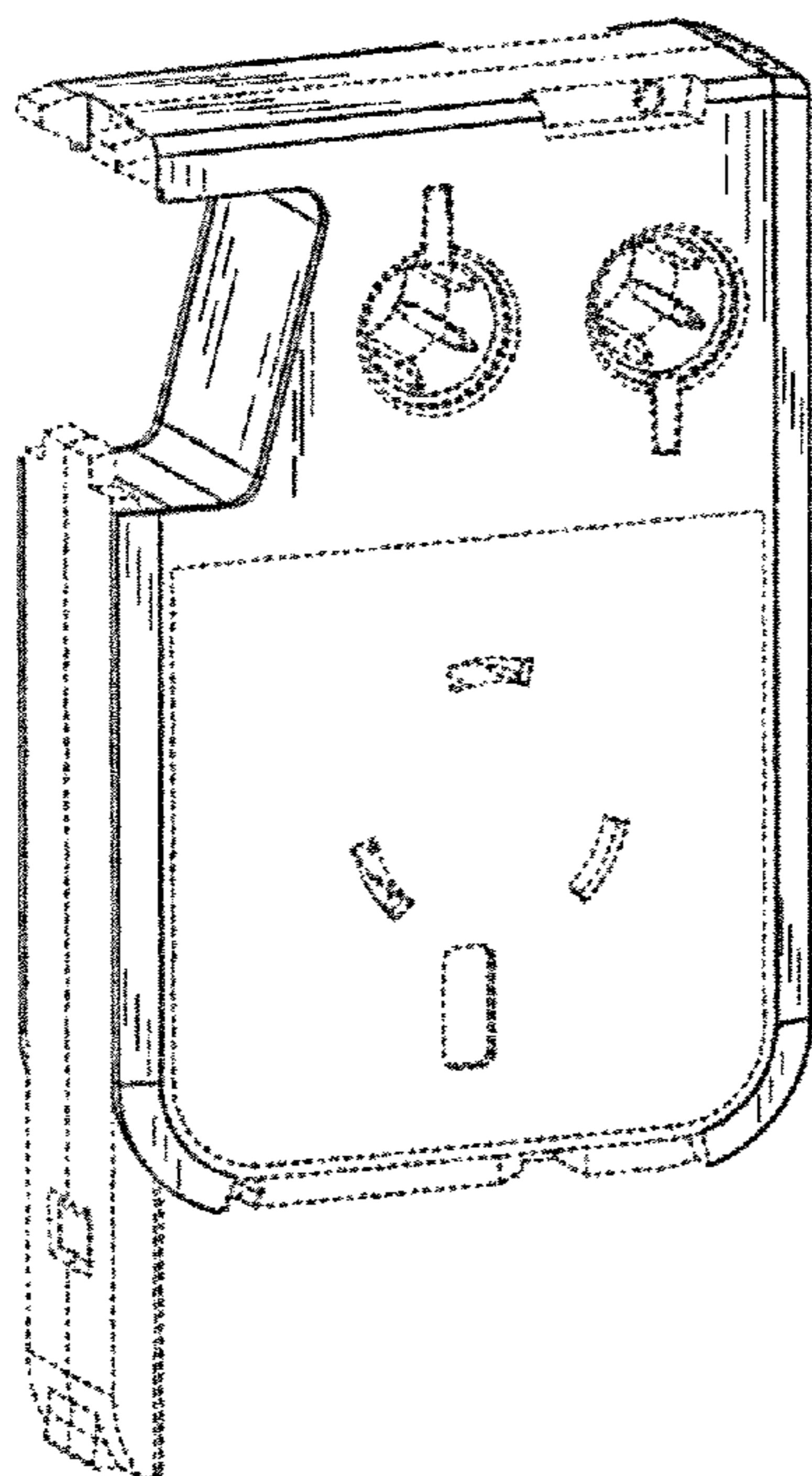
FIG. 12 is a right side view of the cassette of FIG. 8;

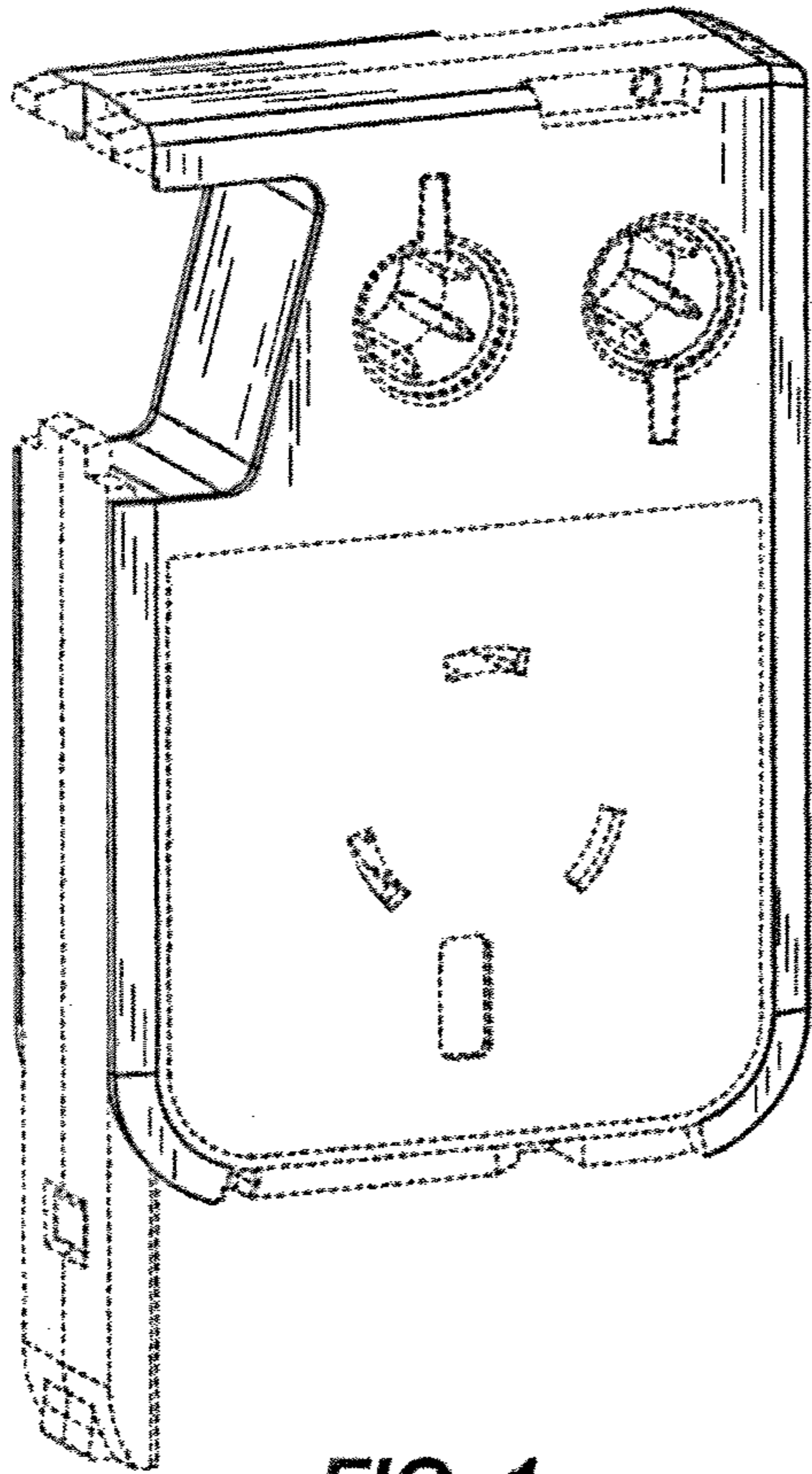

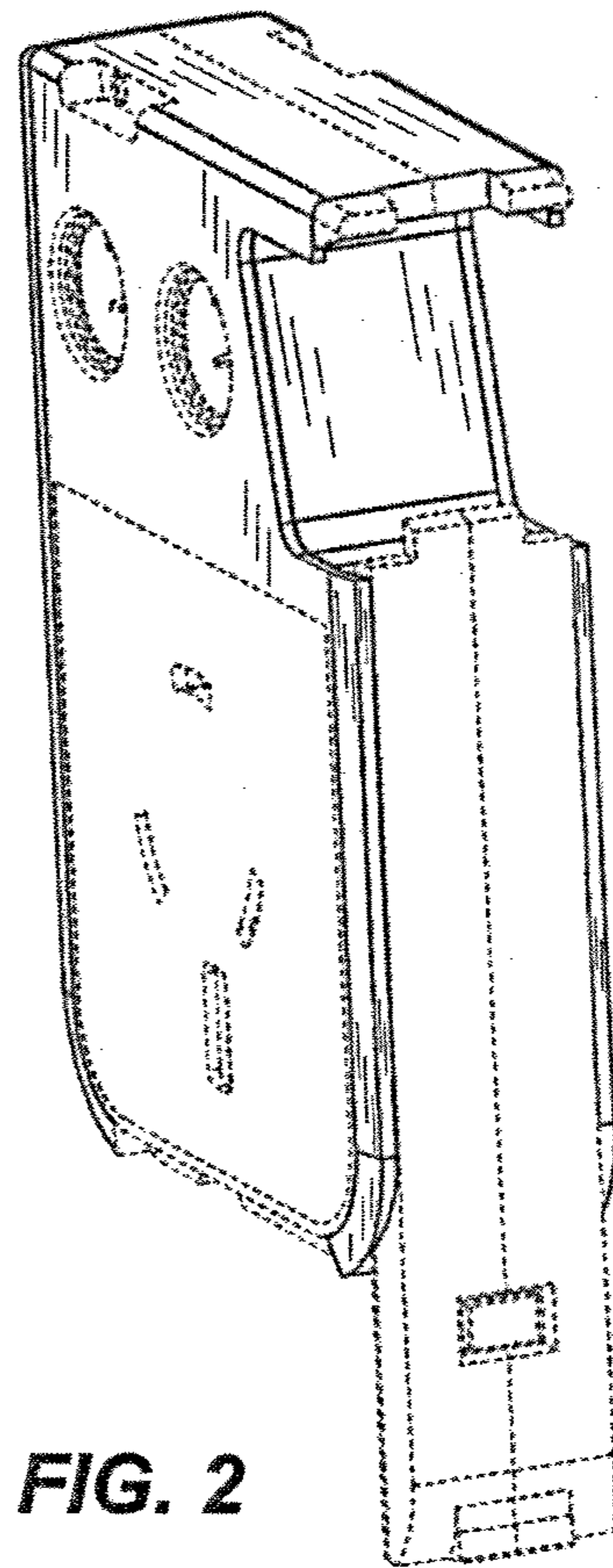

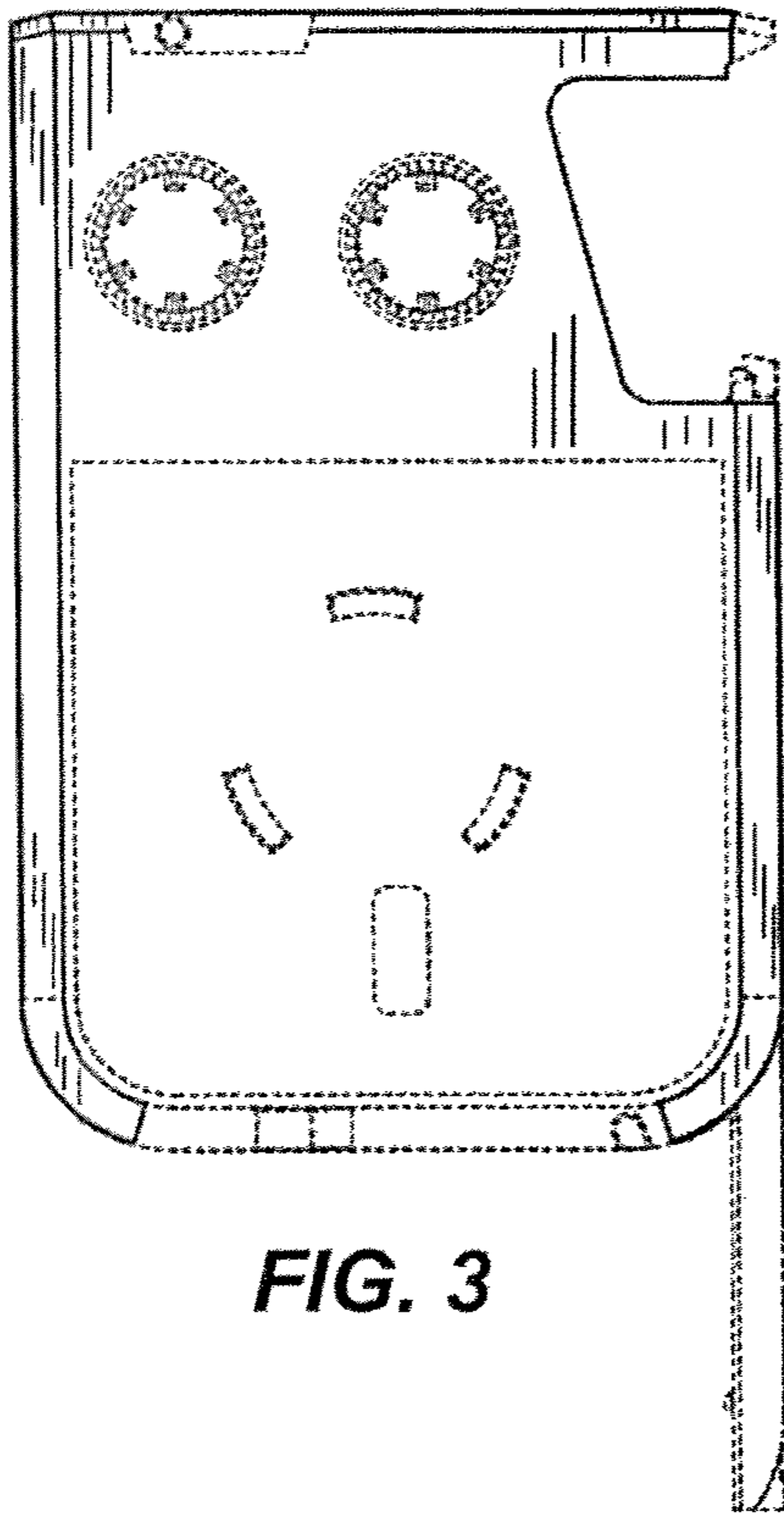

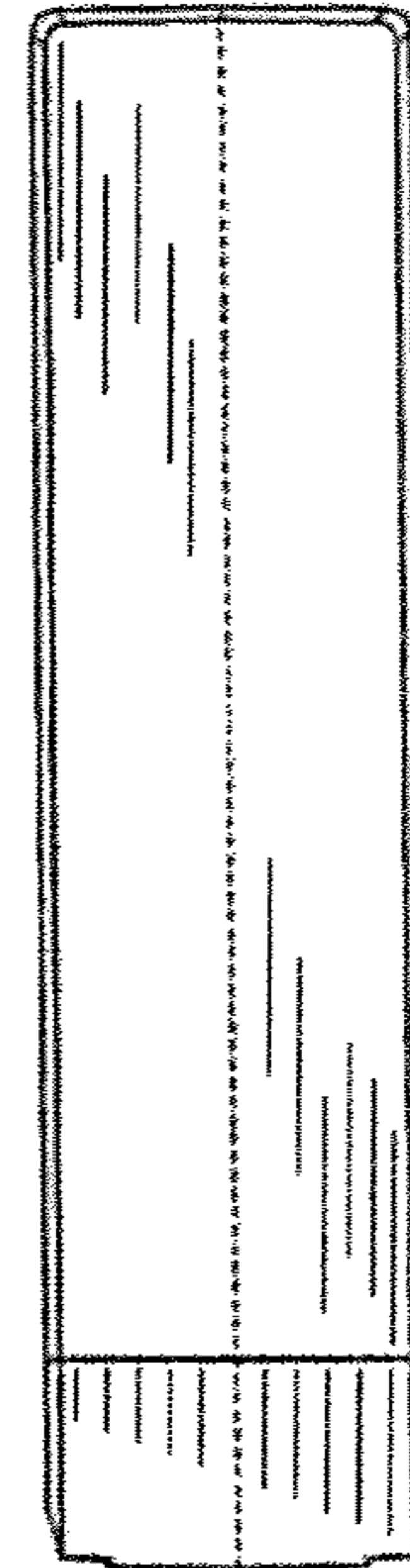

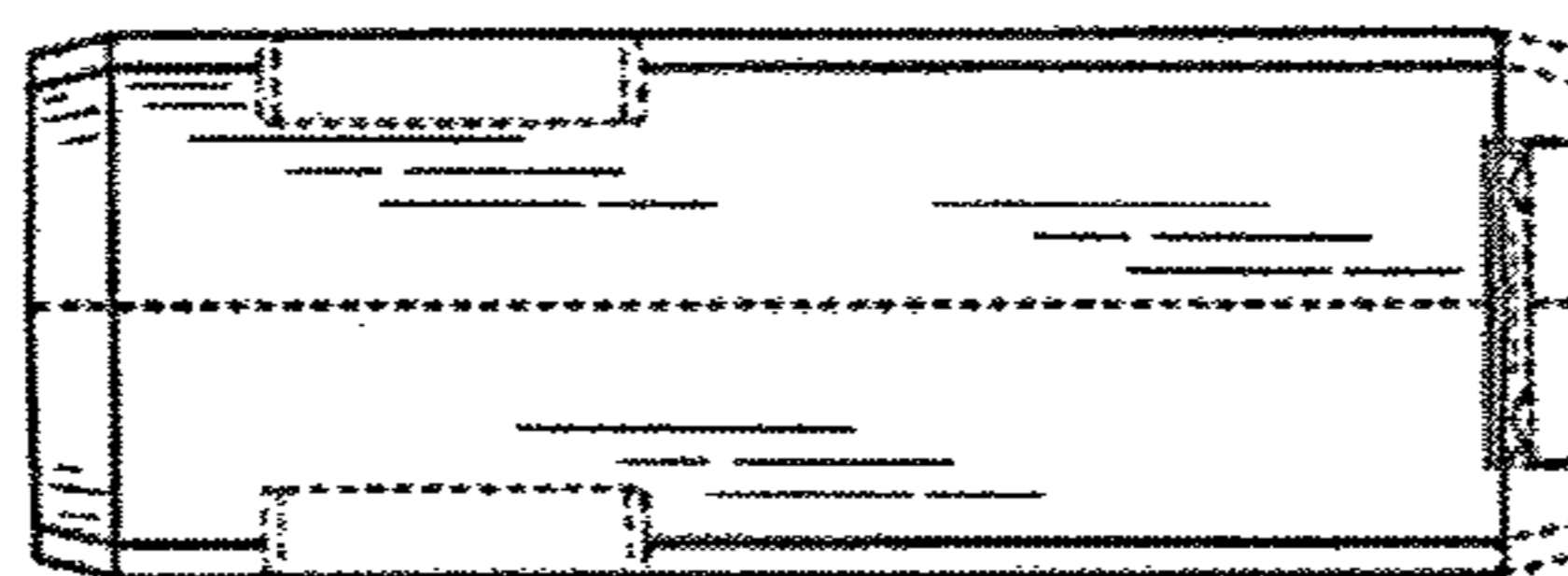

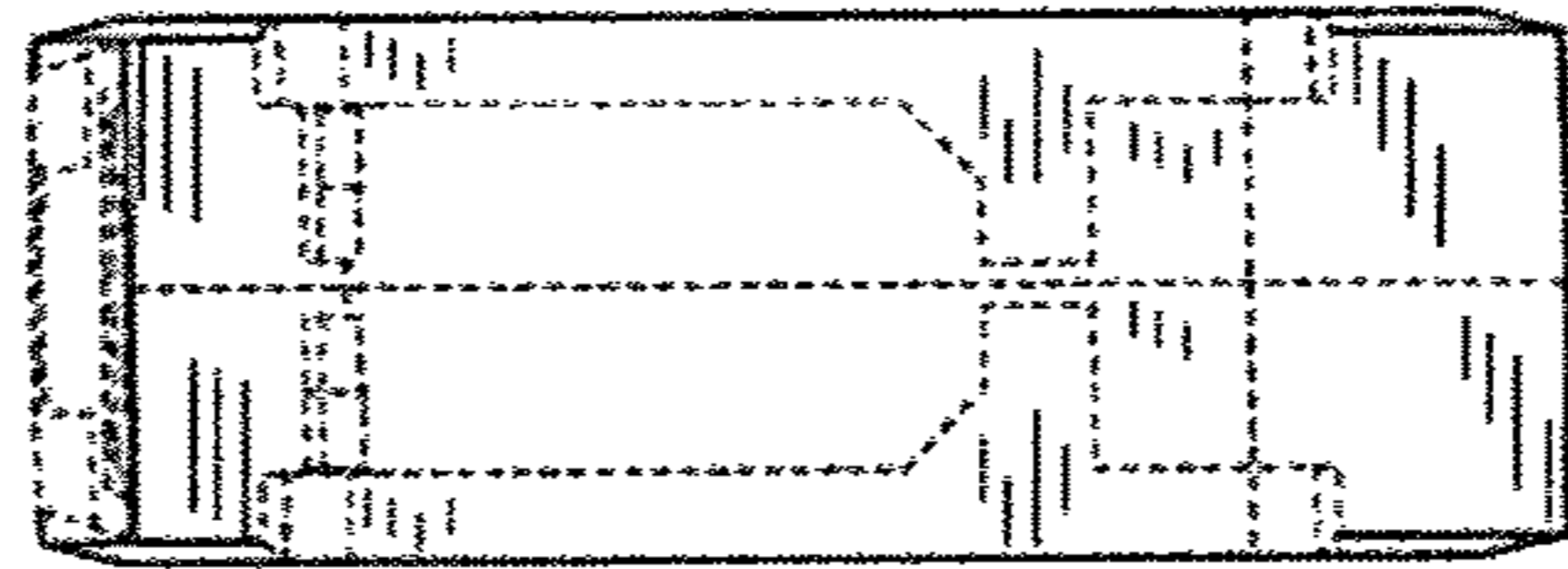

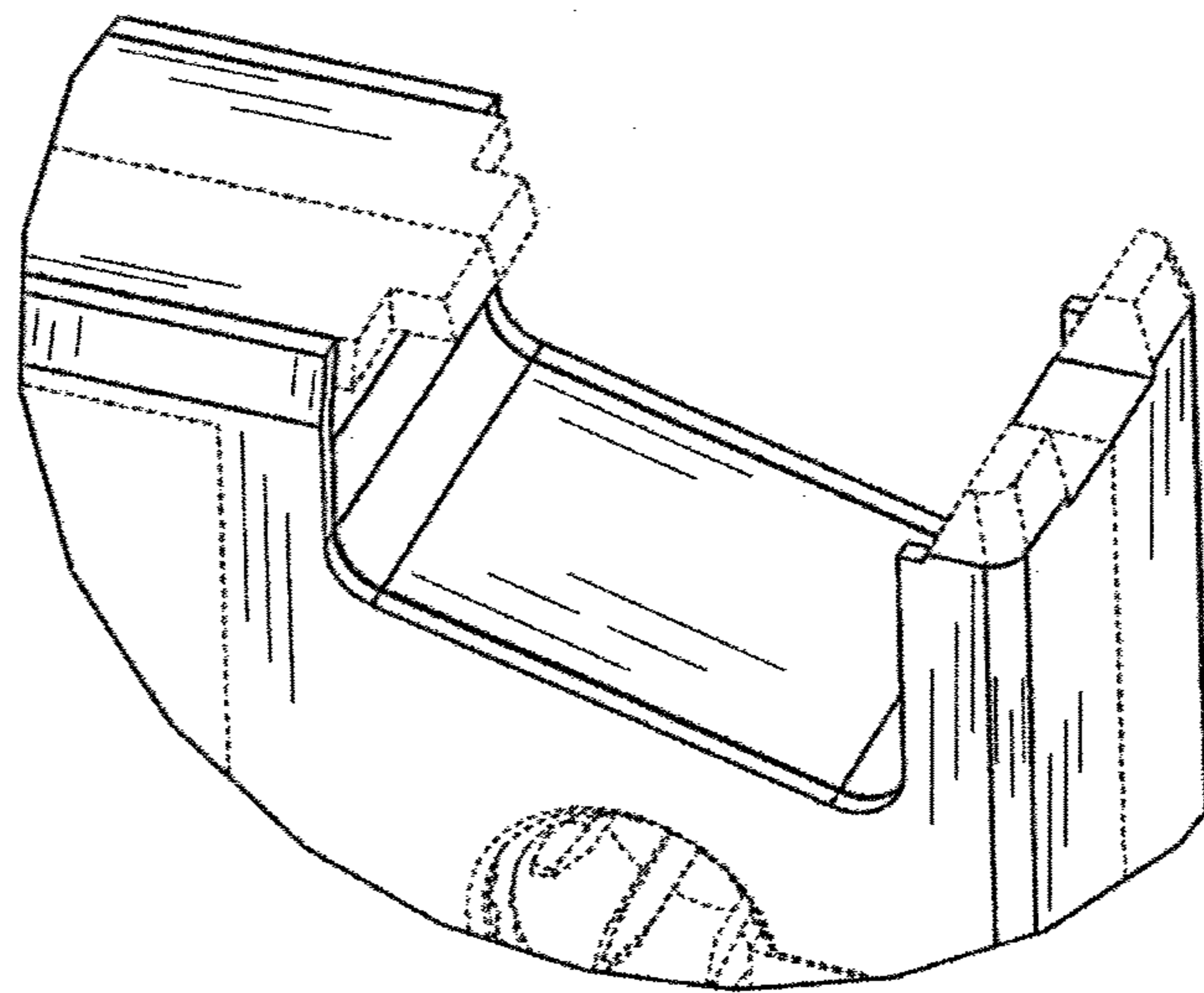

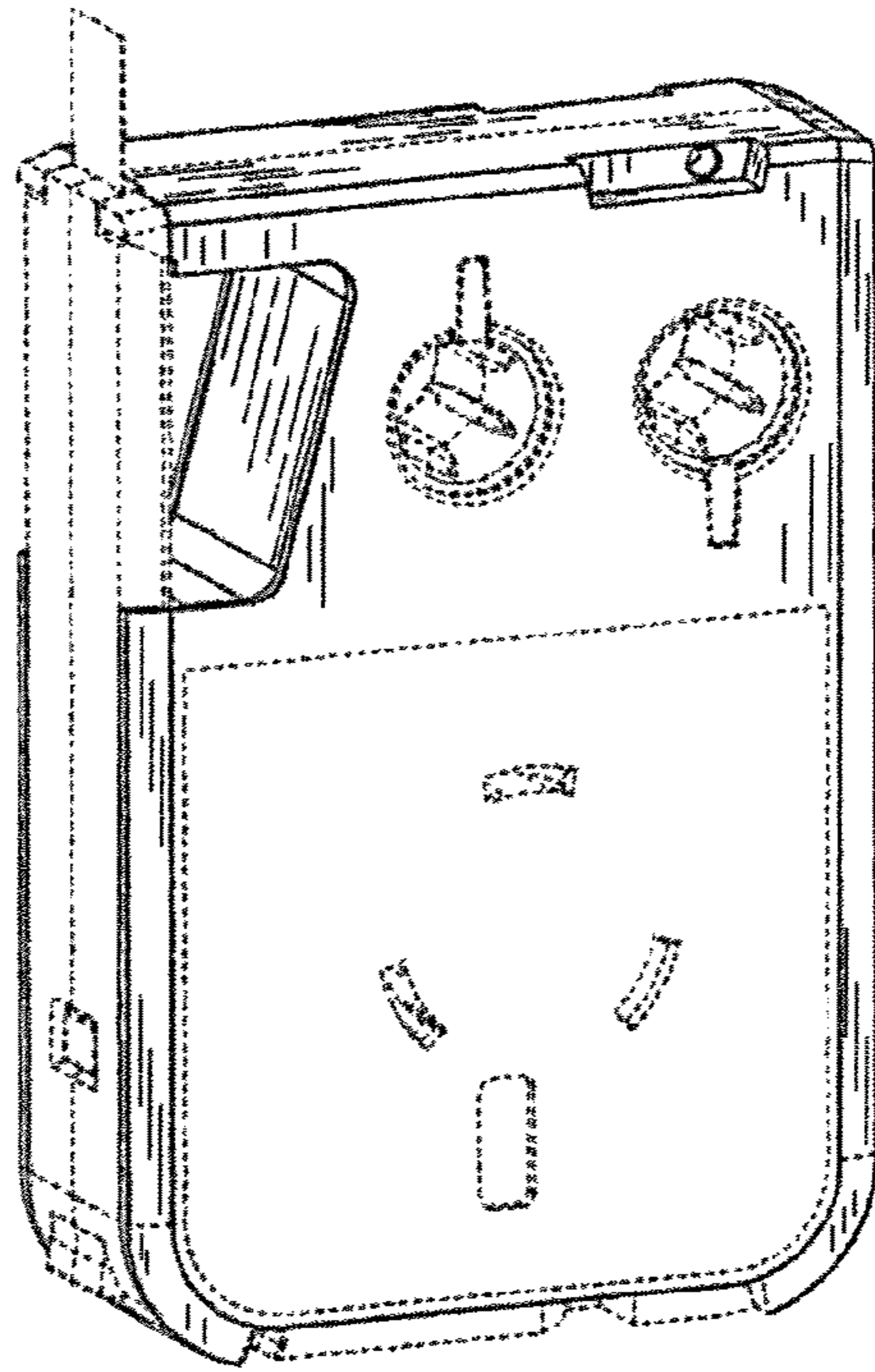

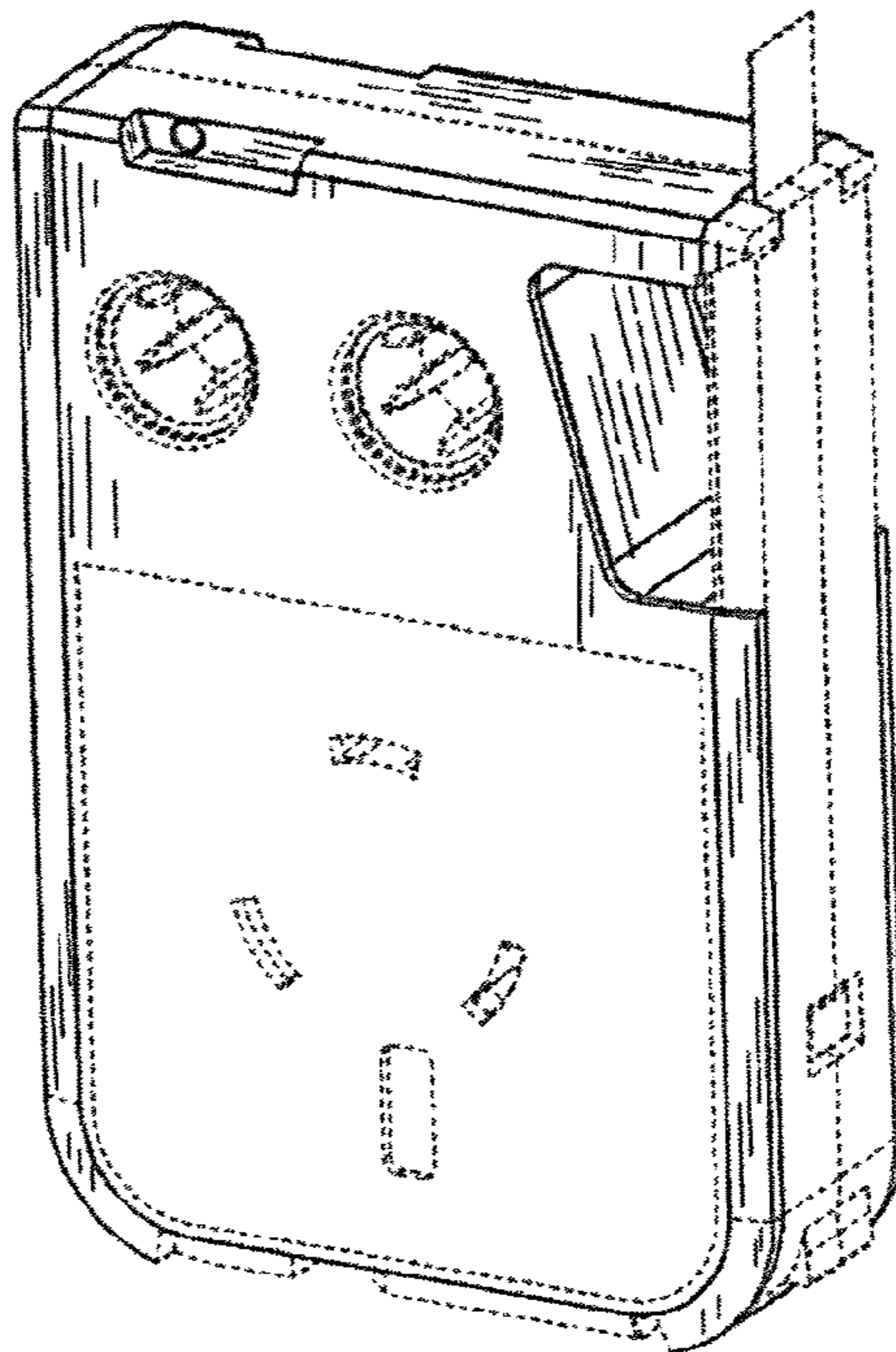

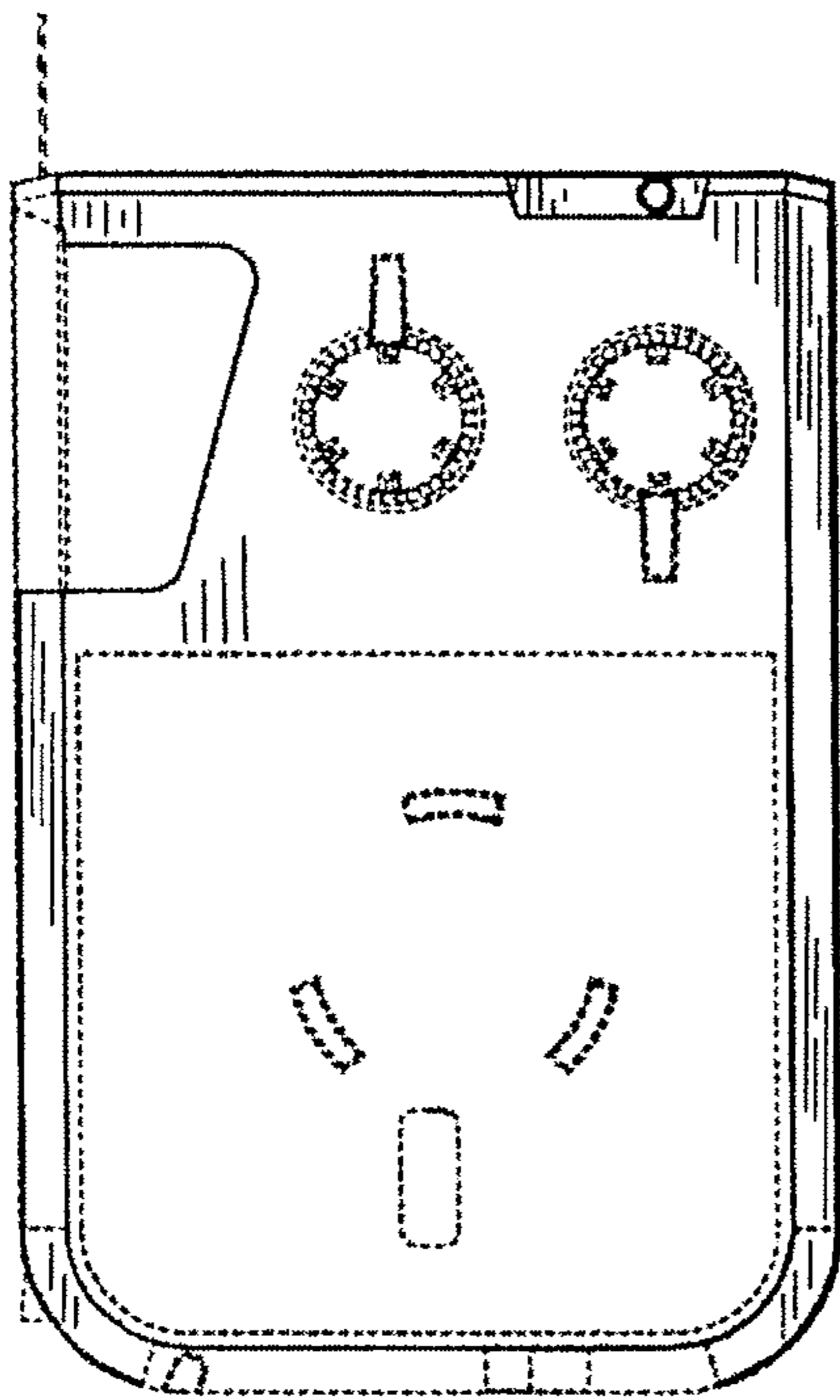

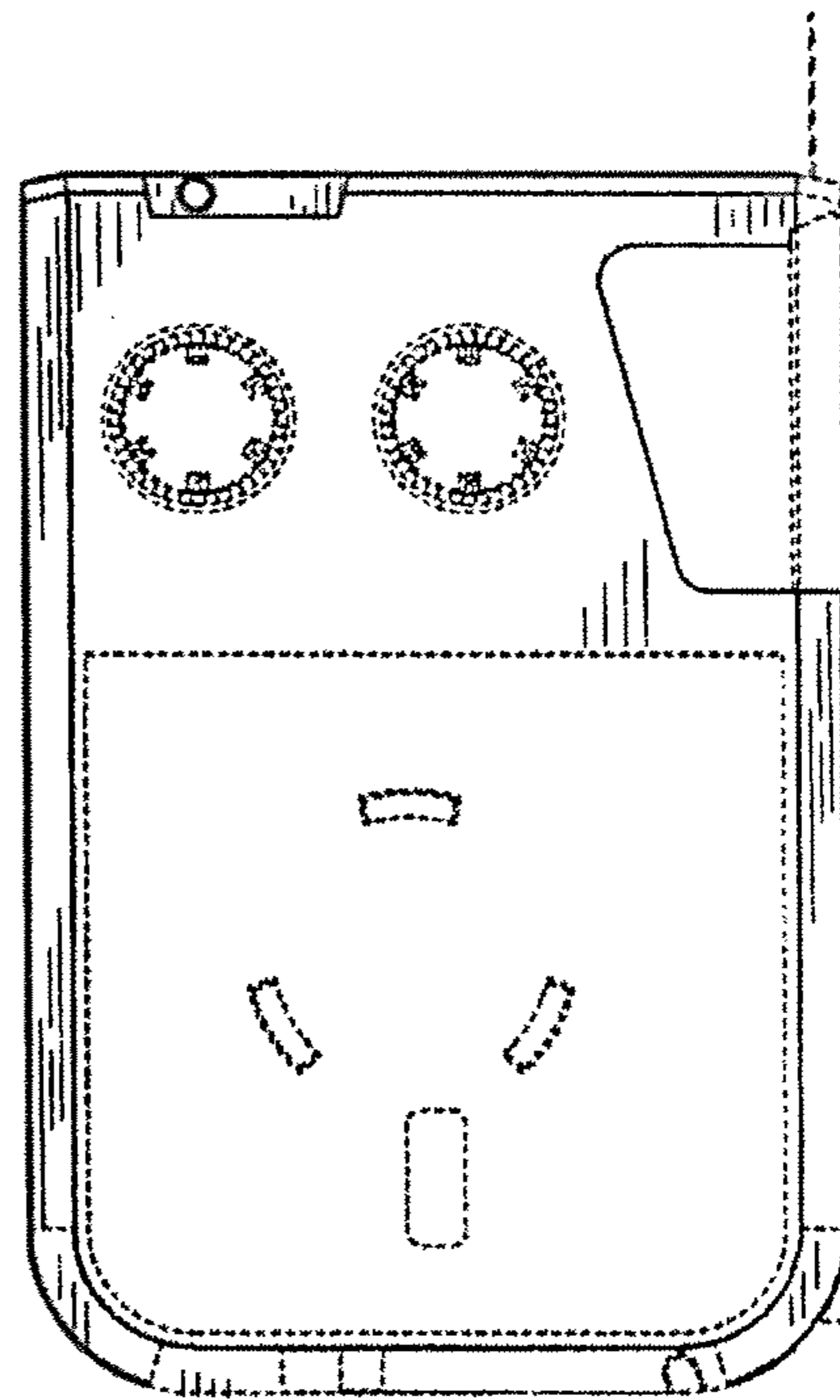

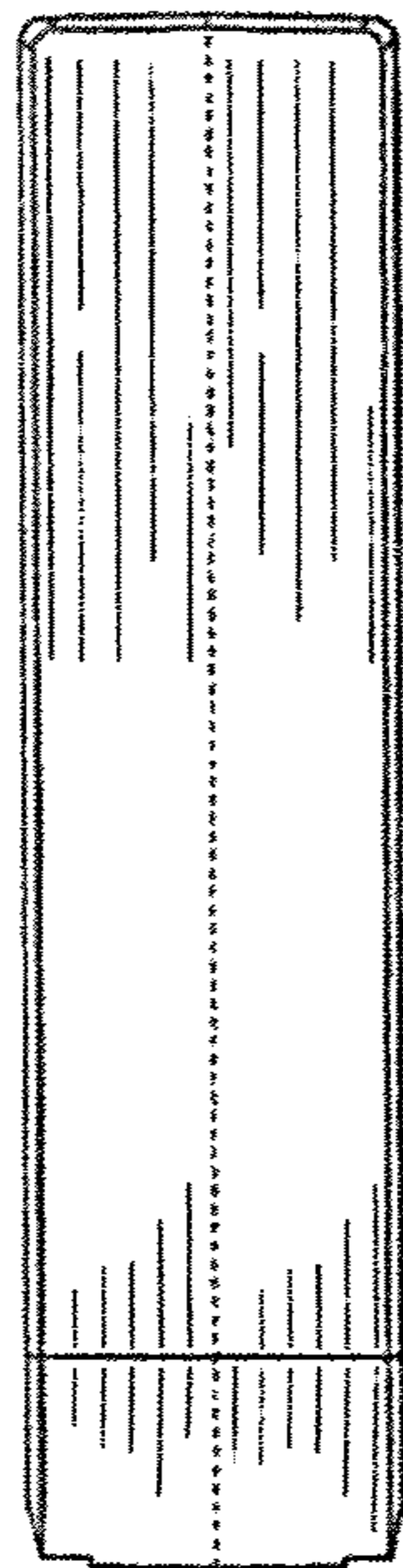

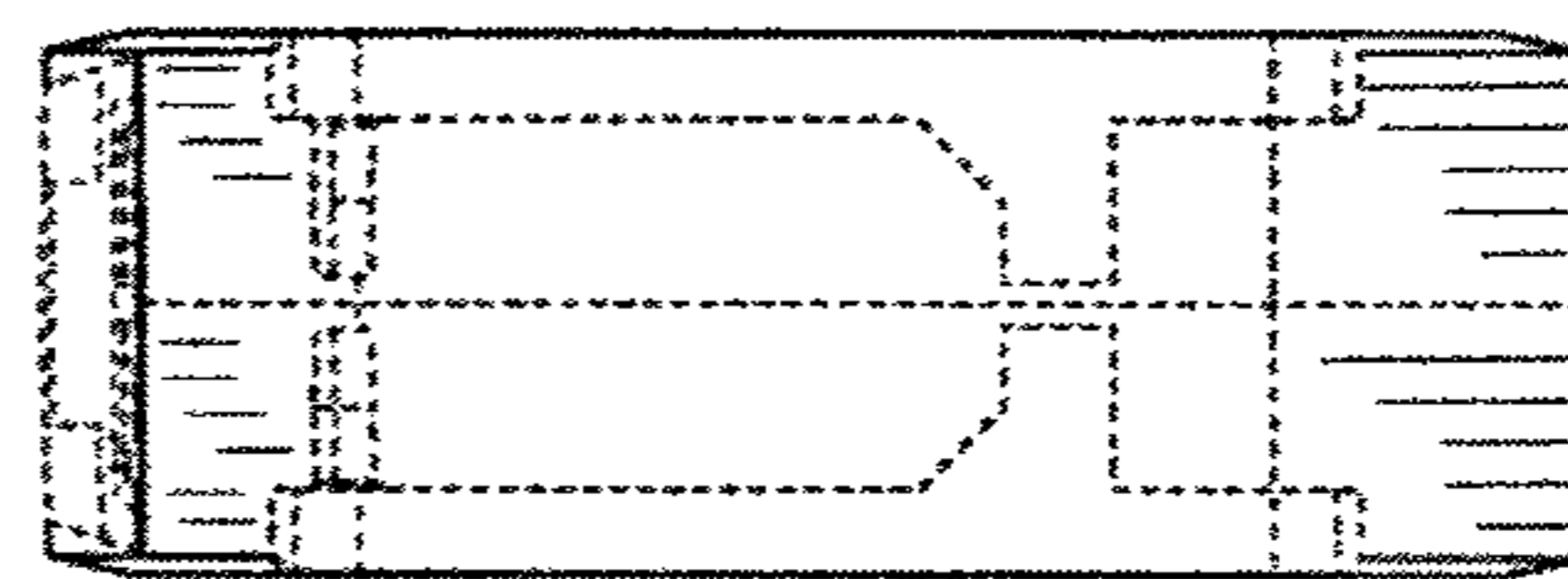
