device of FIG. 1;

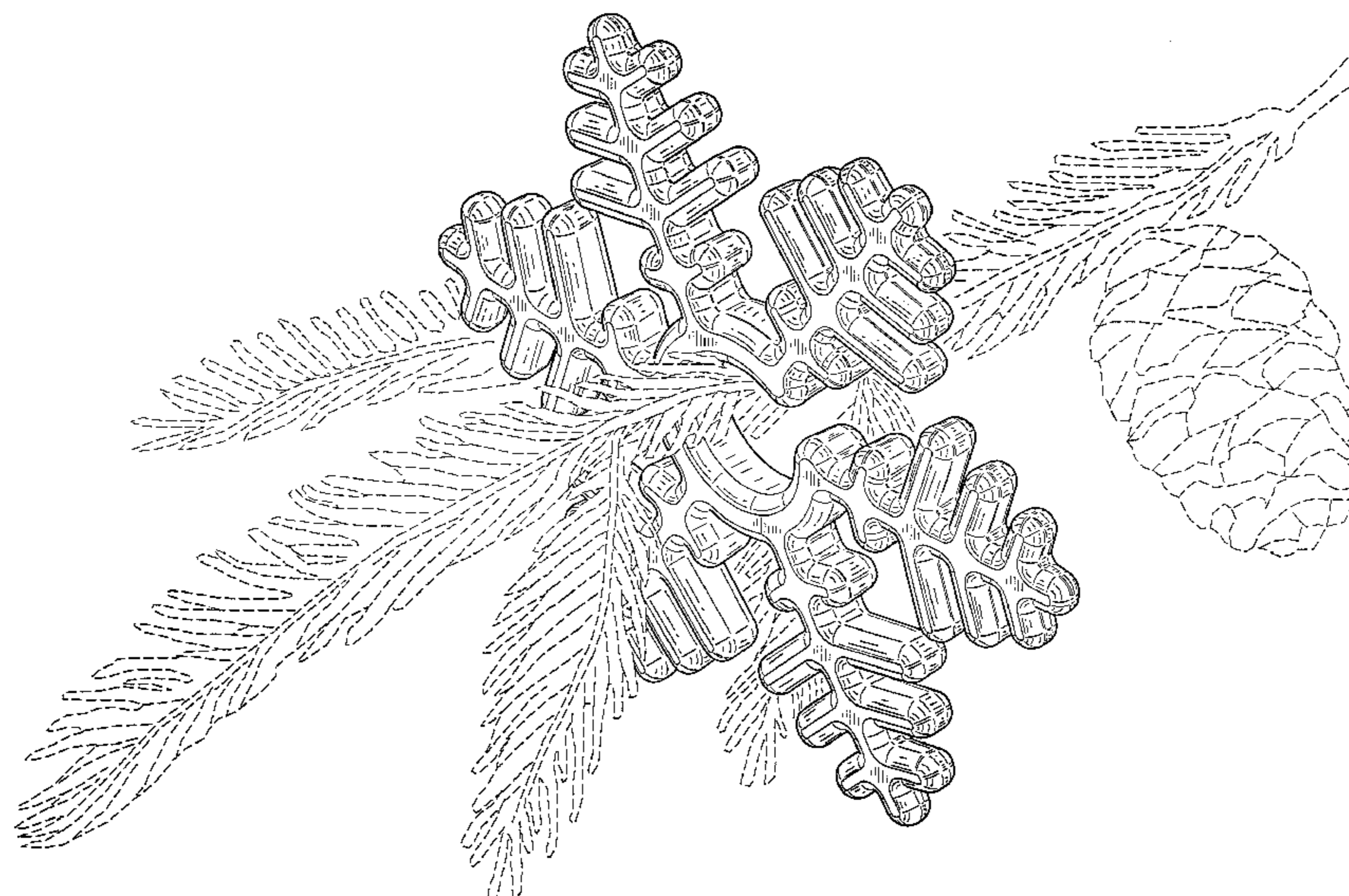
FIG. 5 is a left side elevational view of the air freshener device

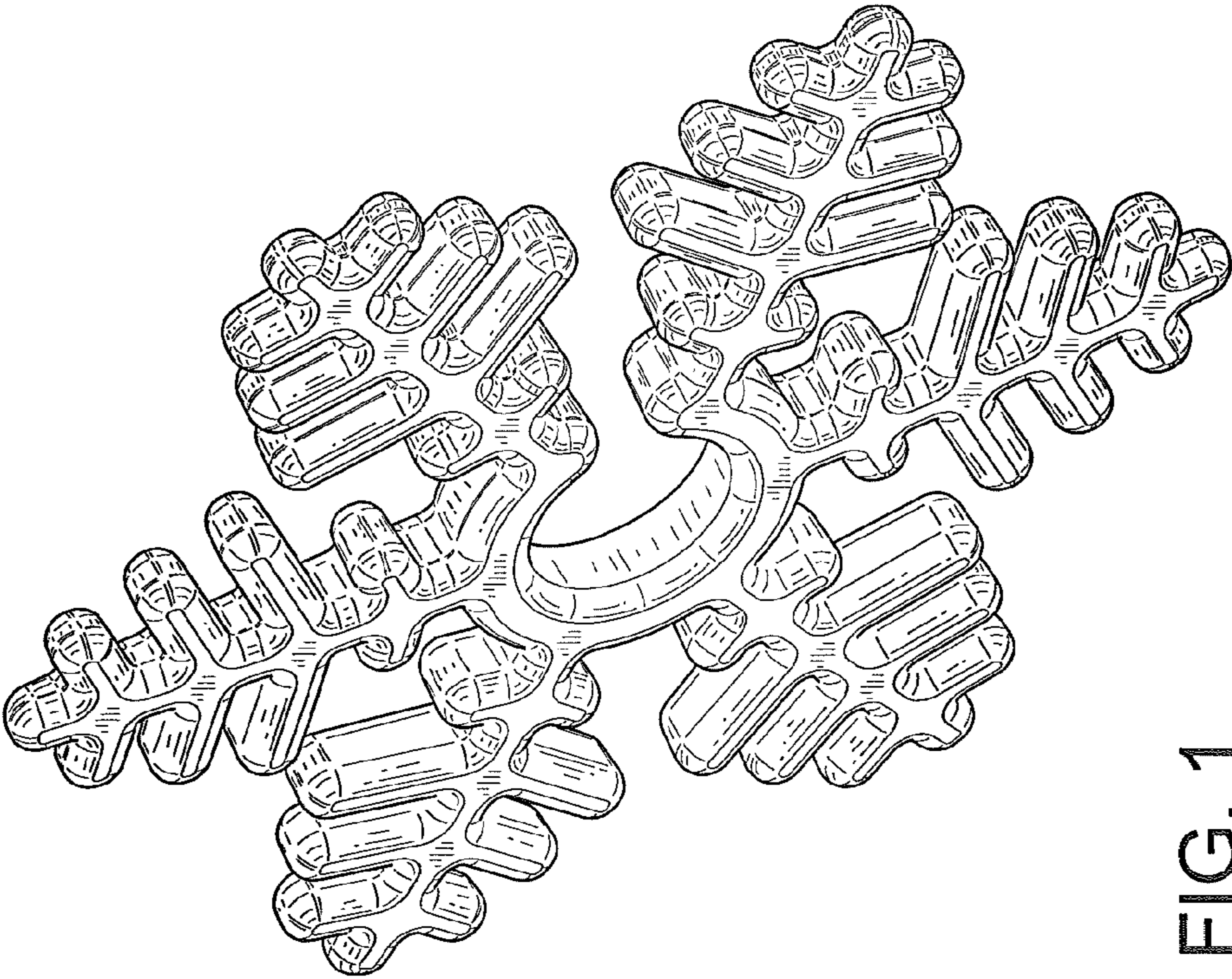

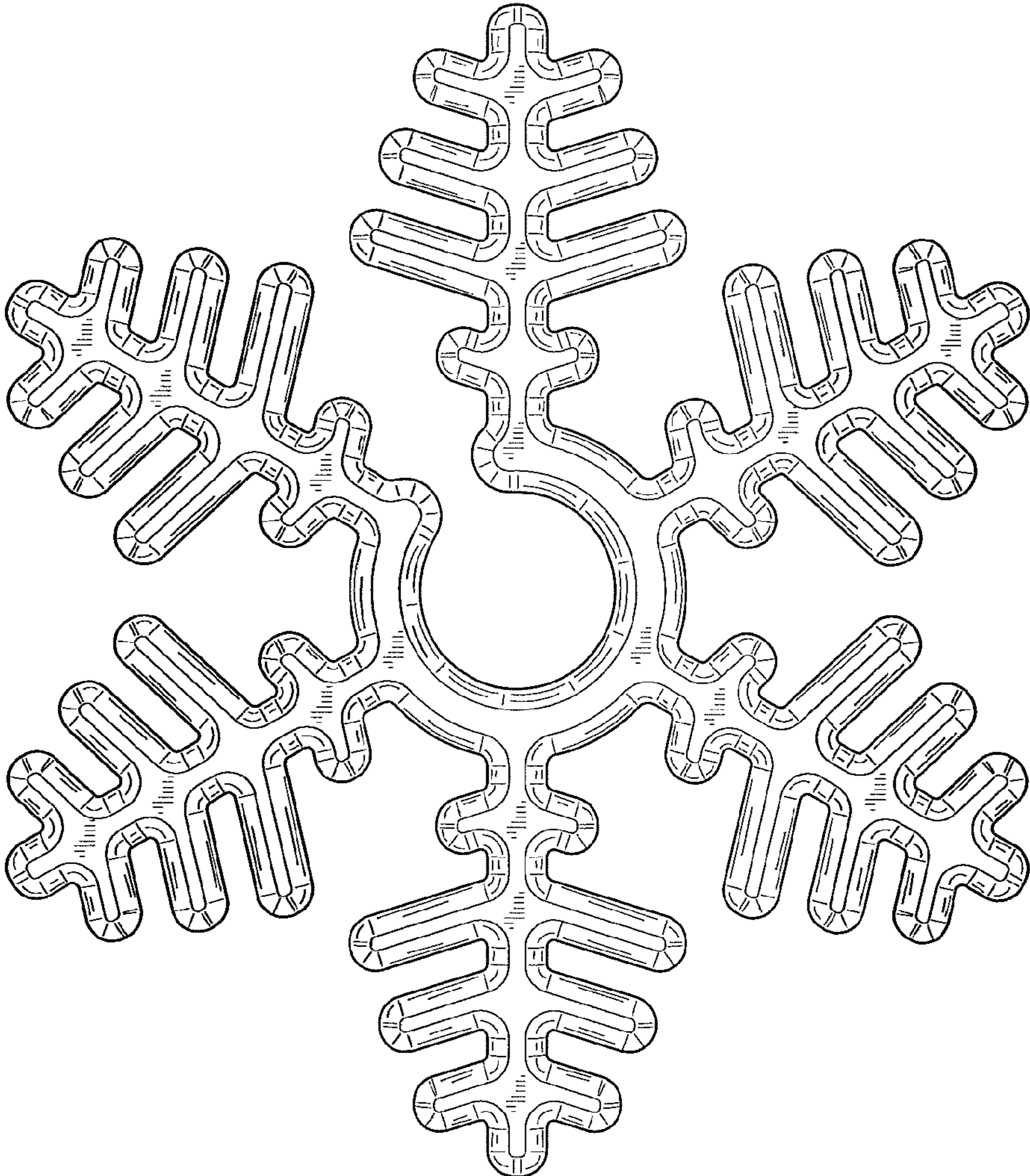

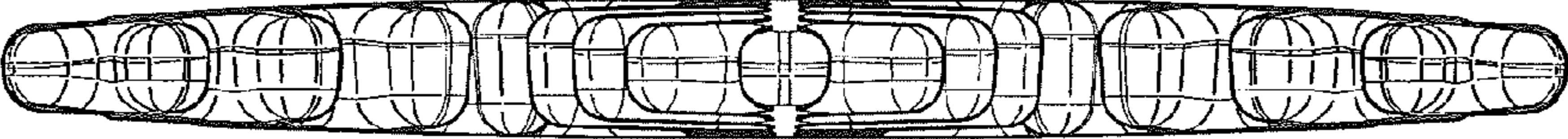

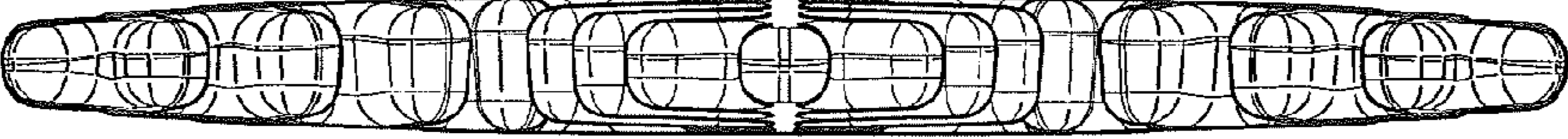

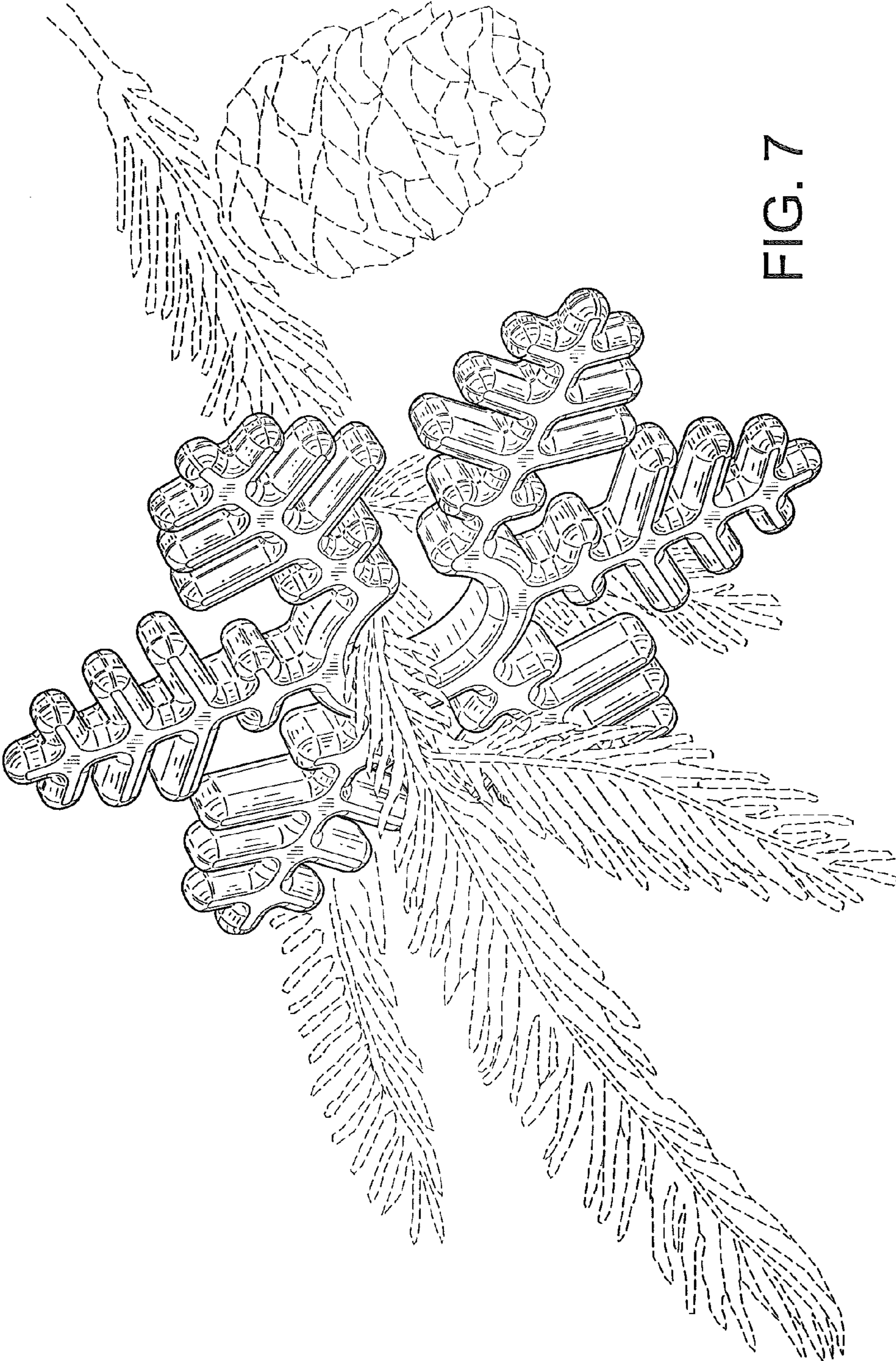
