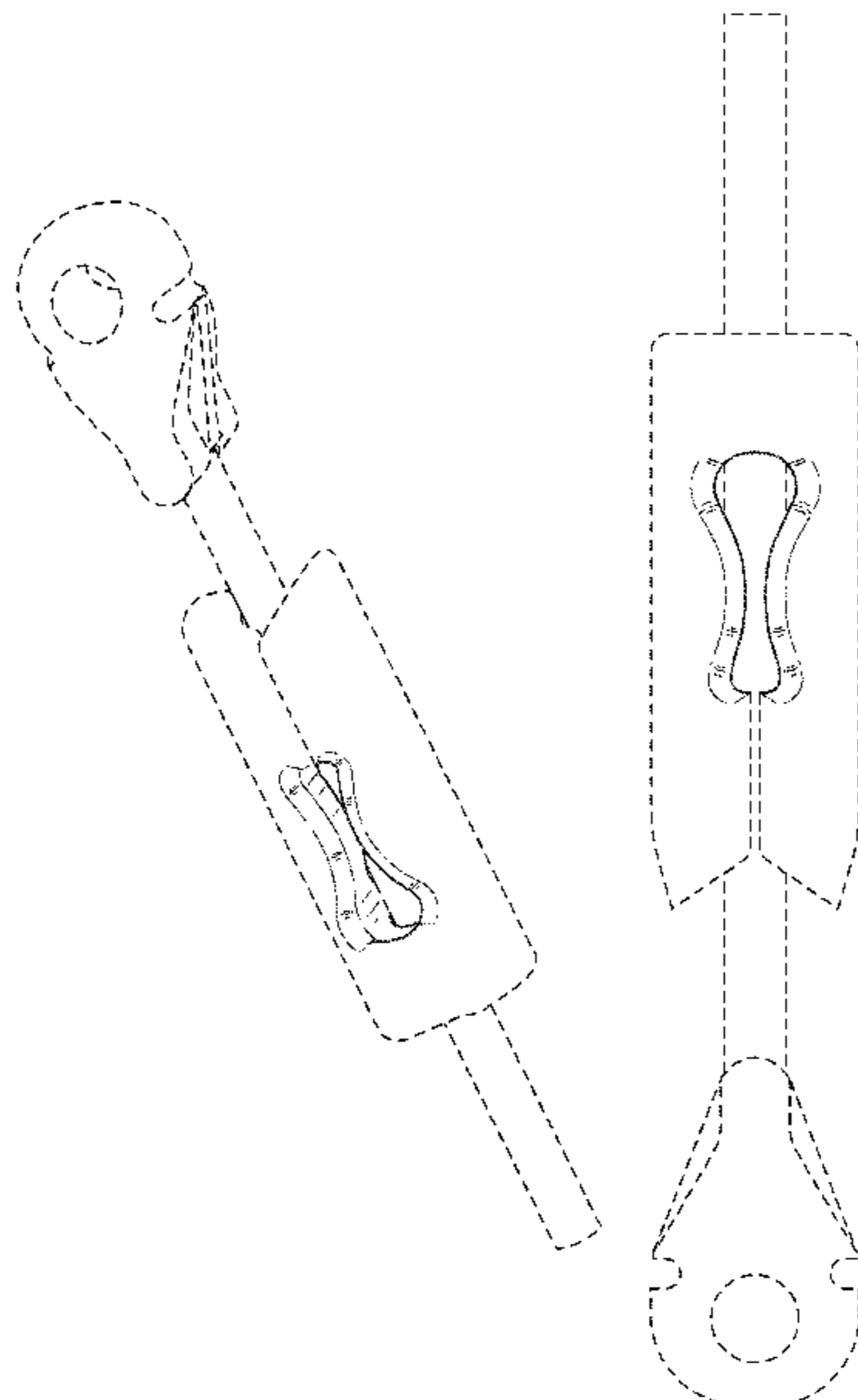
(57) **CLAIM**

The ornamental design for a suture anchor device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a new design for a suture anchor device;
 FIG. 2 is a second perspective view thereof;
 FIG. 3 is a front side view thereof, the rear side view thereof being identical in appearance;
 FIG. 4 is a right side view thereof, the left side view thereof being identical in appearance;
 FIG. 5 is an enlarged top view thereof; and,
 FIG. 6 is an enlarged bottom view thereof.
 Any broken lines immediately adjacent to the shaded areas represent the bounds of the claimed design while all other broken lines represent environmental structure and are for illustrative purposes only; the broken lines form no part of the claimed design.

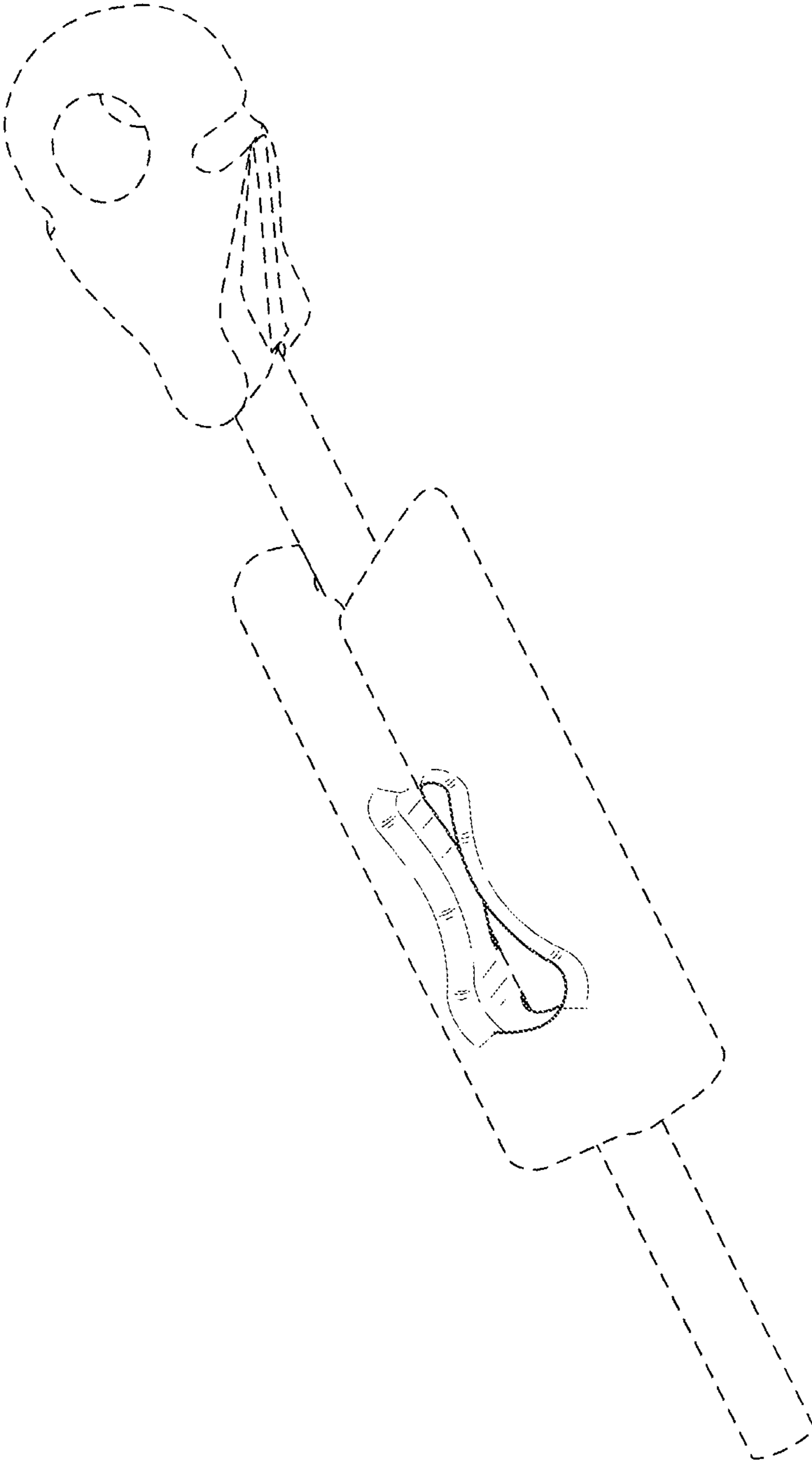

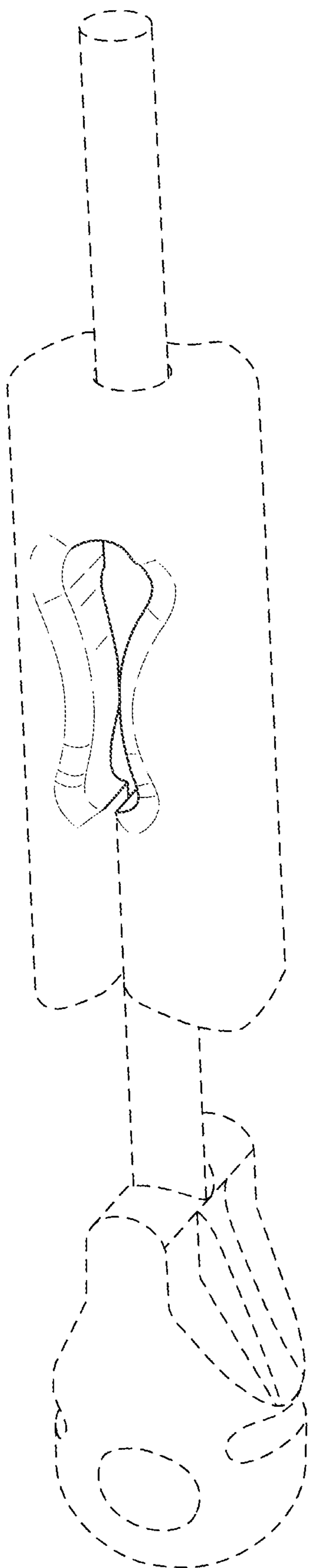

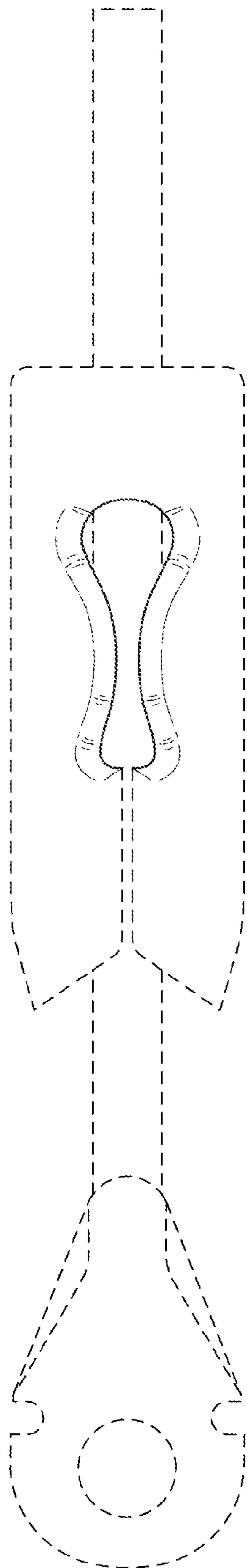

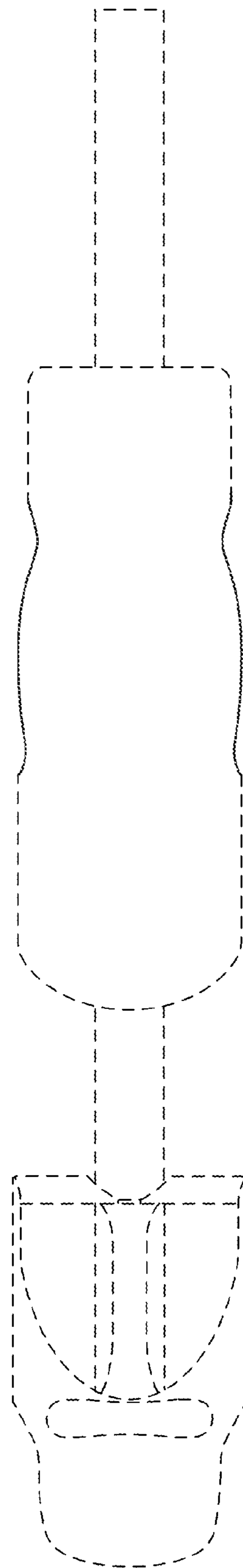

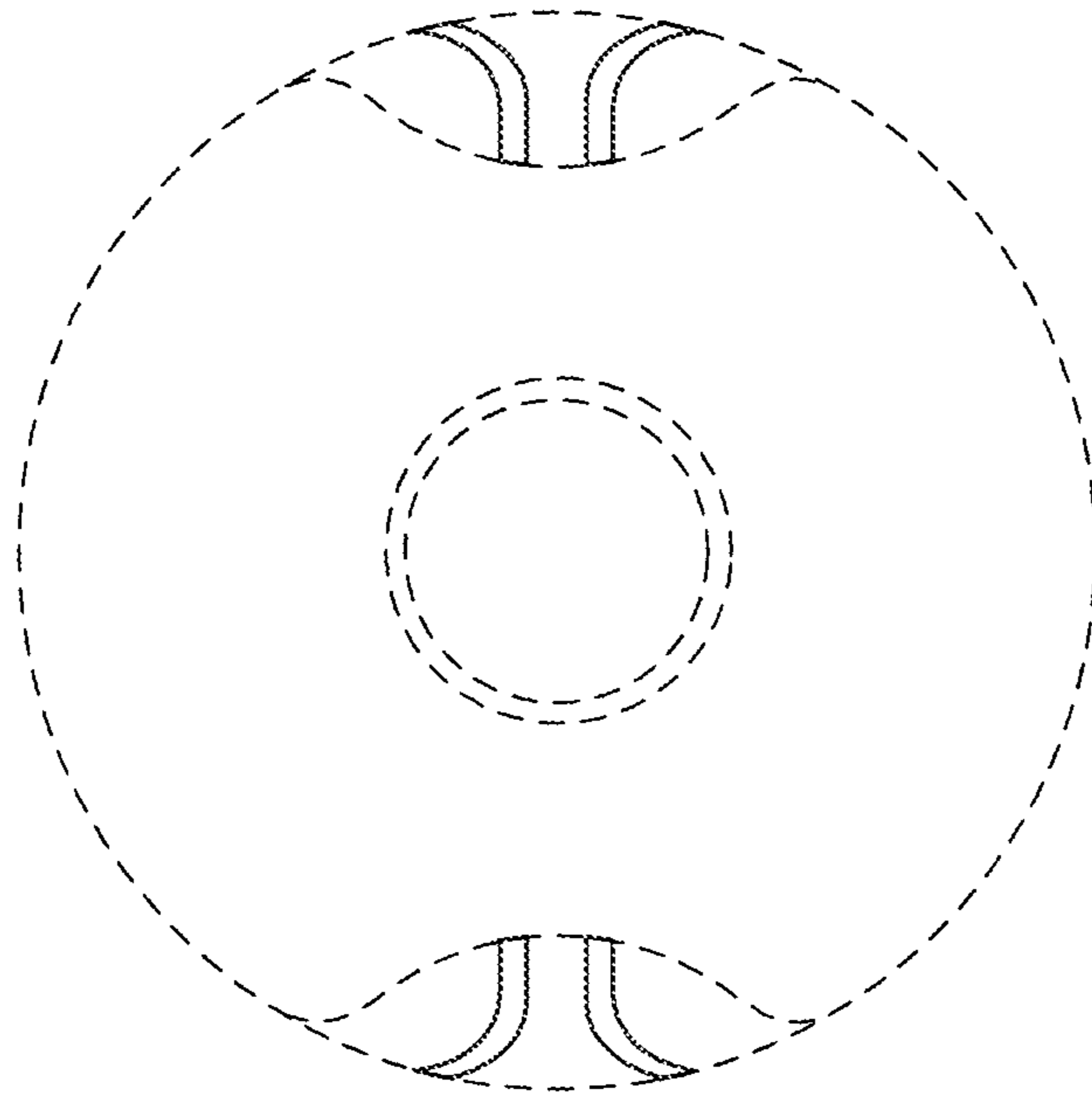

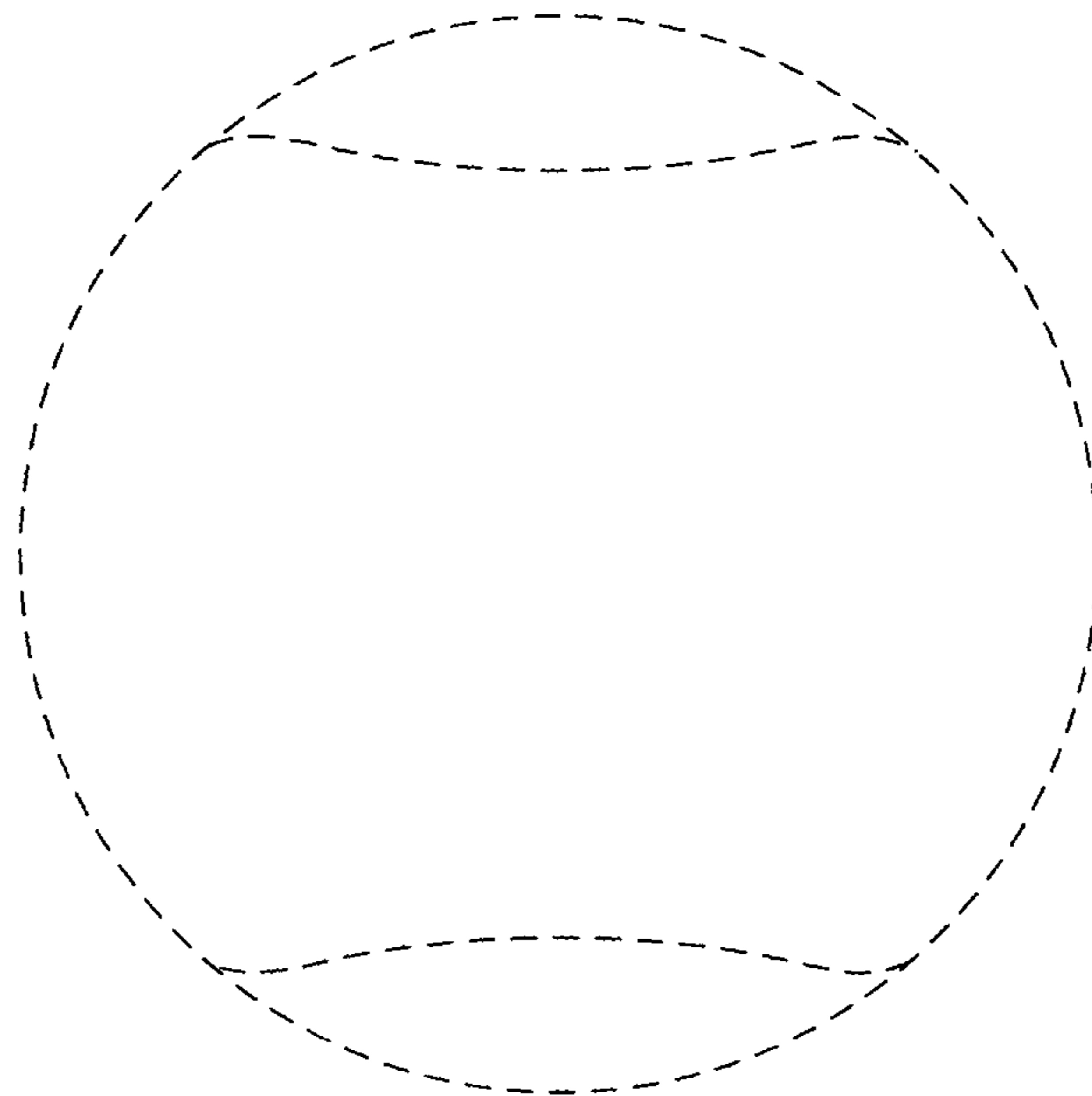
