(57) **CLAIM**

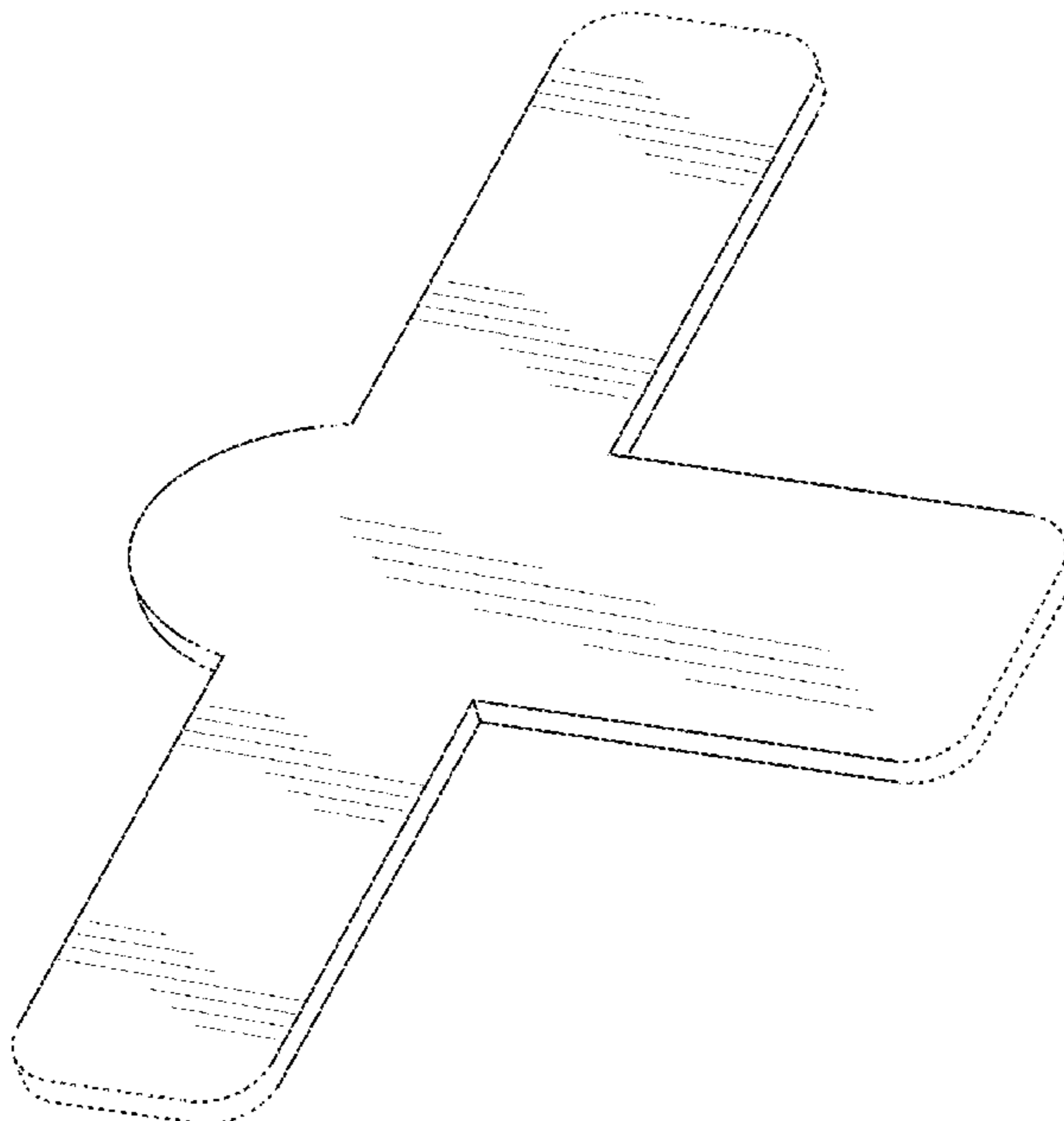
The ornamental design for a specially shaped bandage for treating warts on human digits, as shown and described.

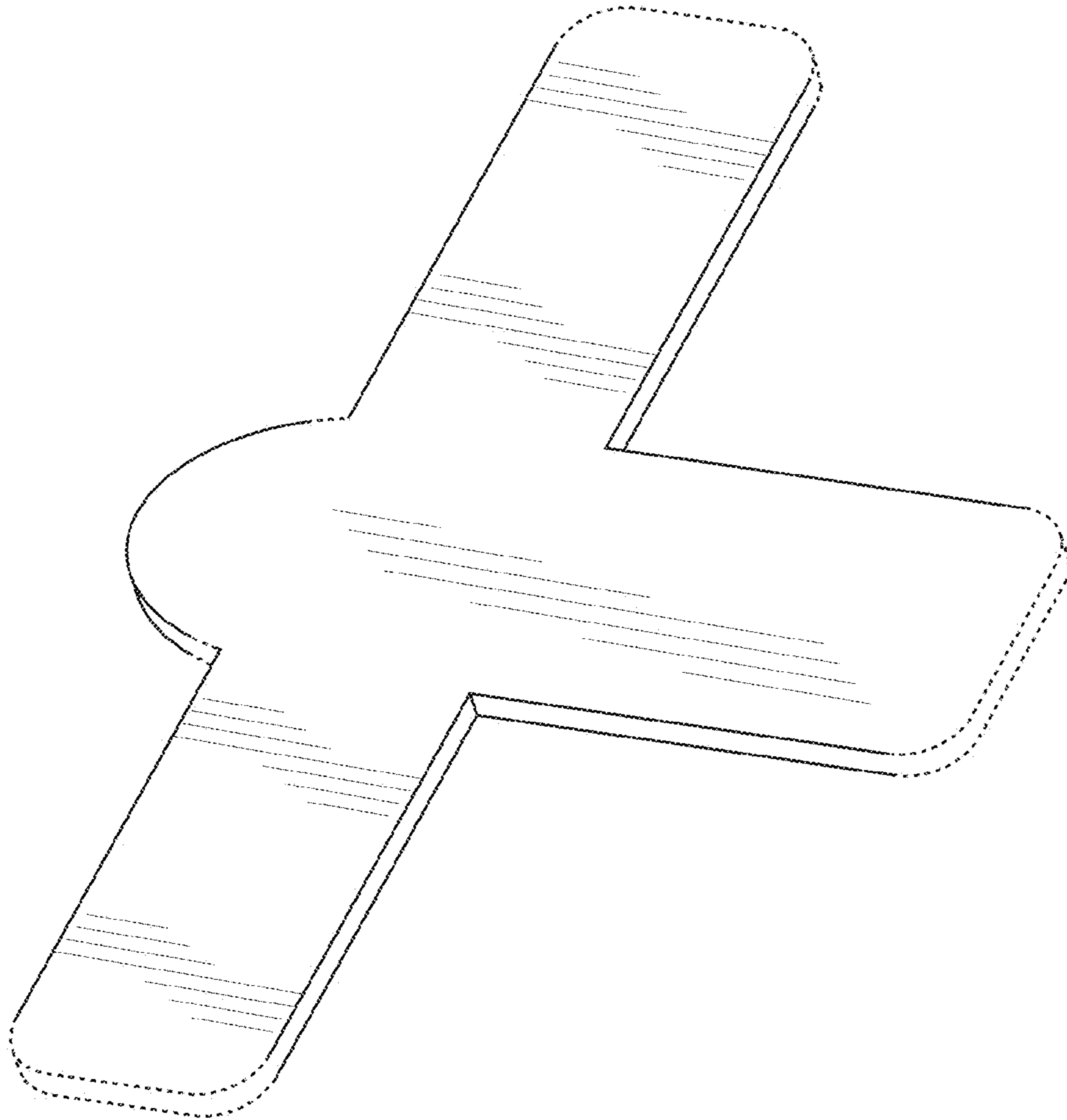
**DESCRIPTION**

FIG. 1 is a perspective view of a specially shaped bandage for treating warts on human digits;

FIG. 7 is a rear elevation view thereof.

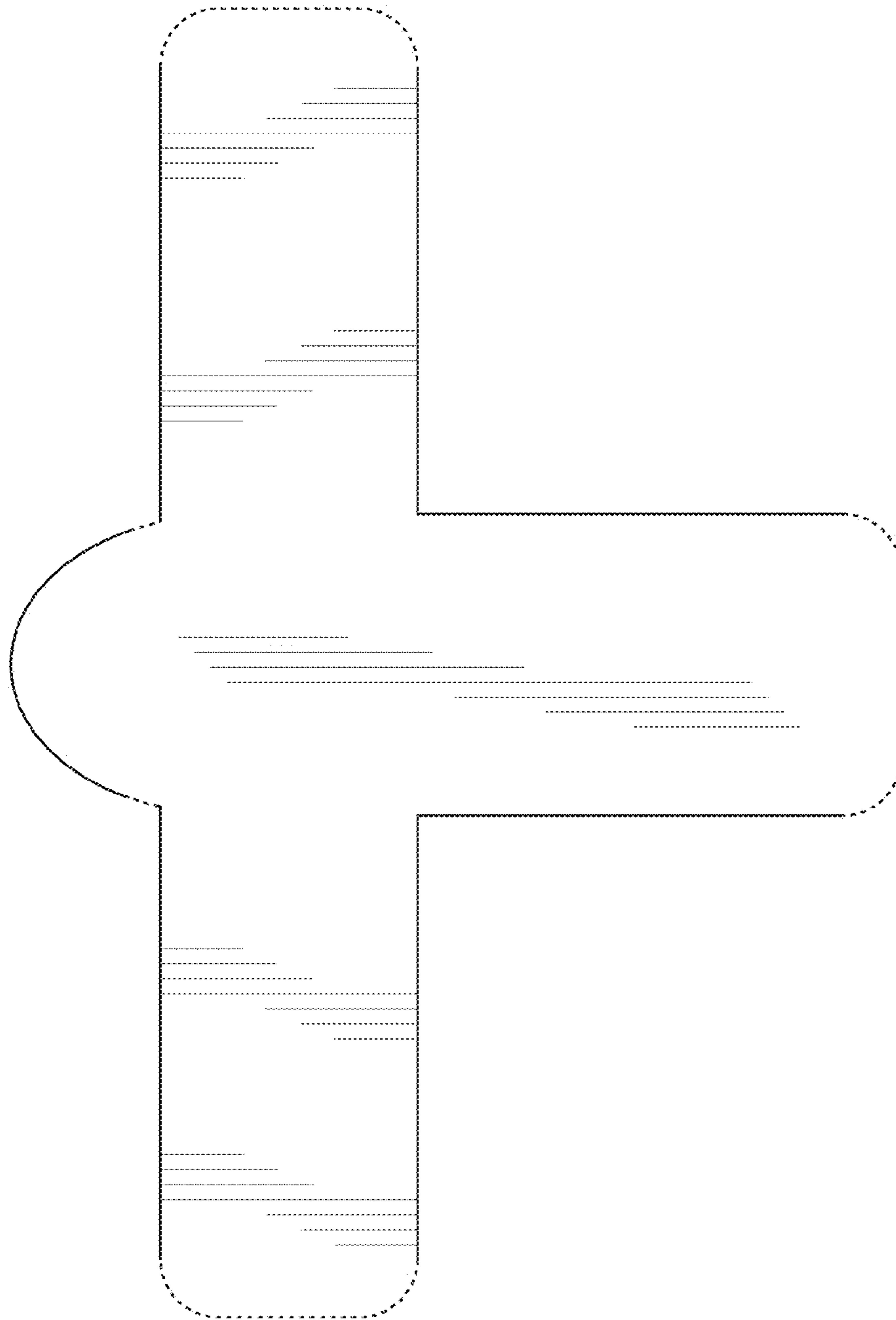
The broken lines illustrate environmental elements of the bandage which form no part of the claimed design.

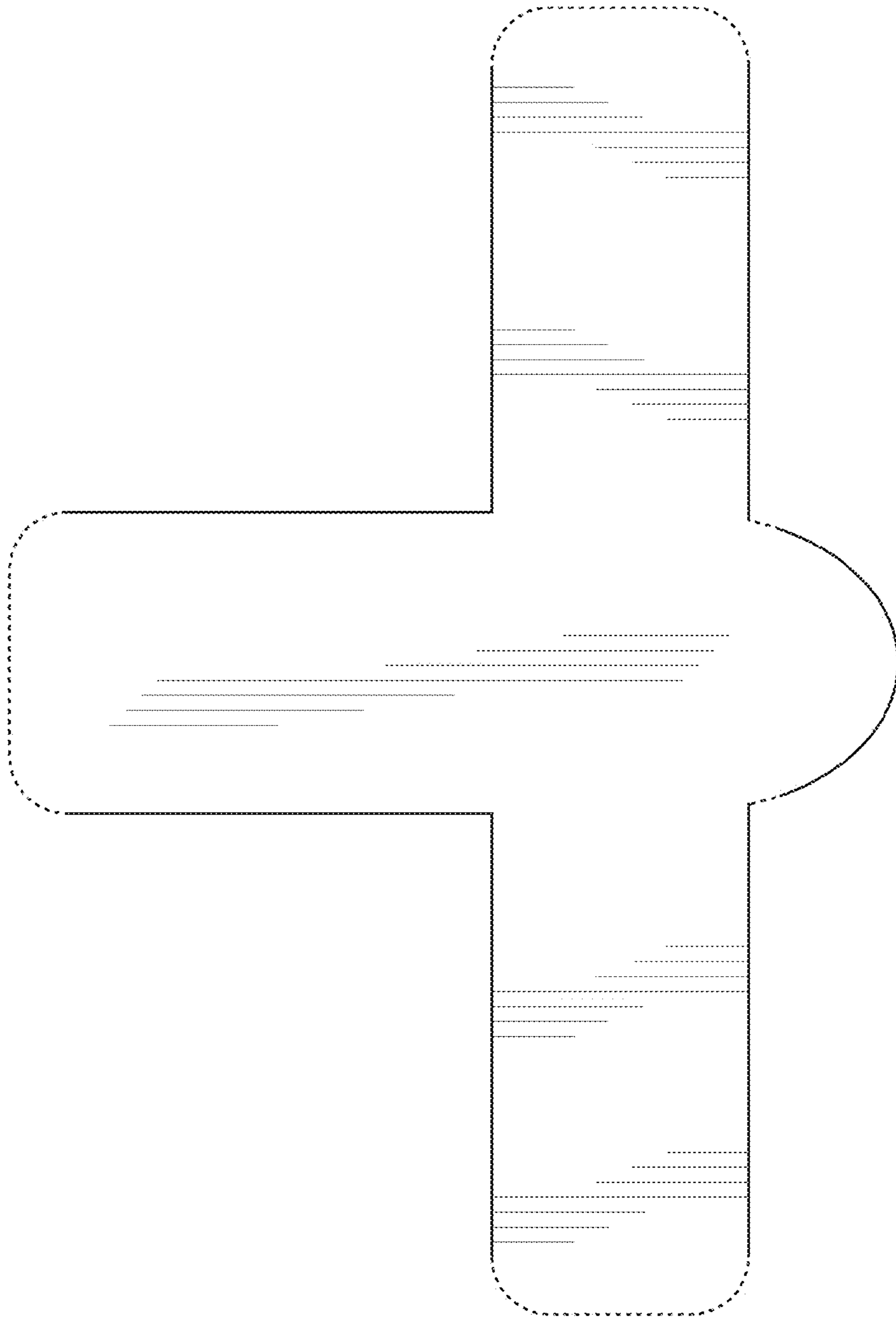
